## DESCRIPTION

FIG. 1 is a left side view of a passenger car embodying said new design;  
FIG. 2 is a right side view thereof;  
FIG. 3 is a front view thereof;

FIG. 12 is a perspective view, as seen from the front, top and left side thereof.

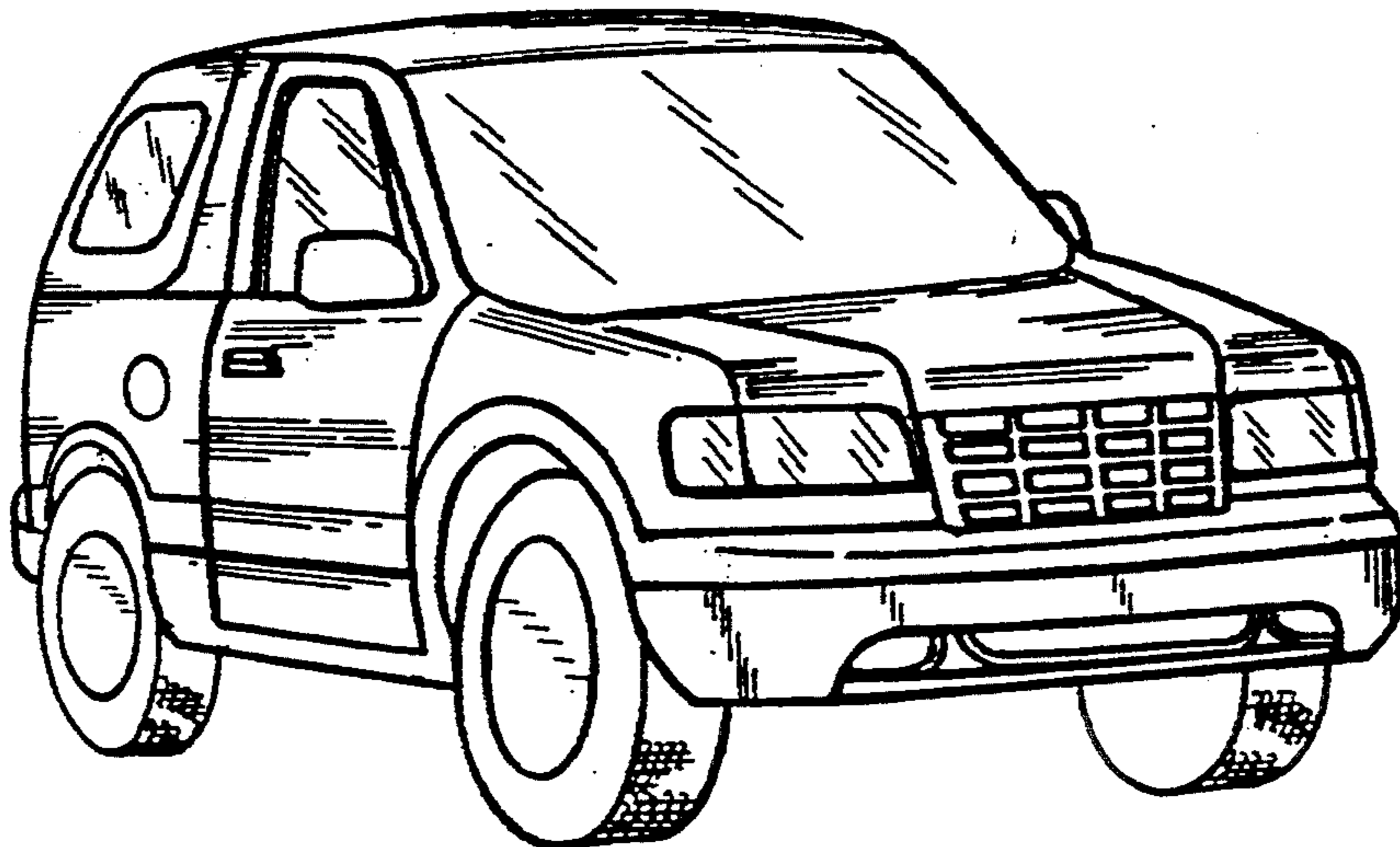

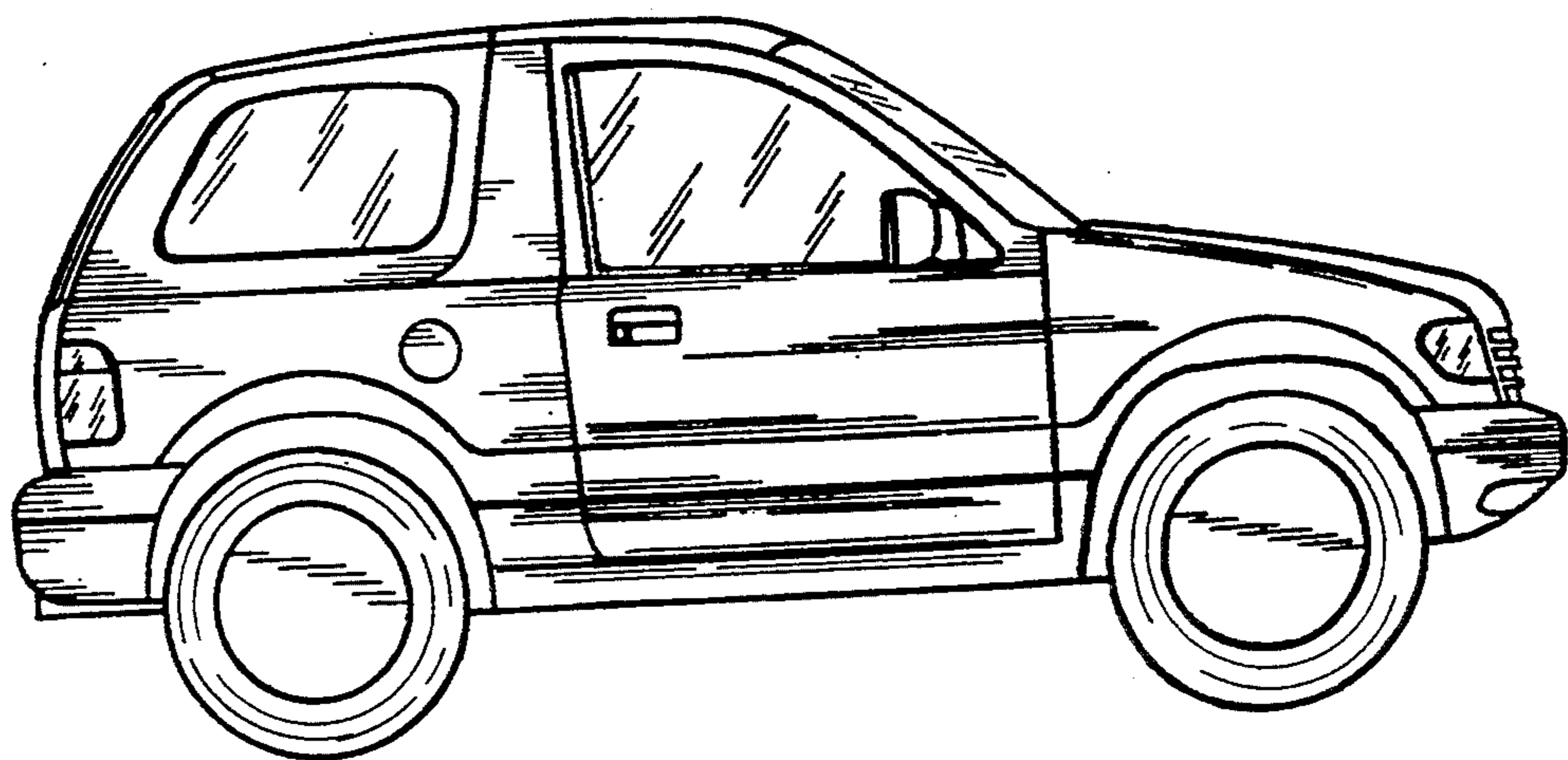

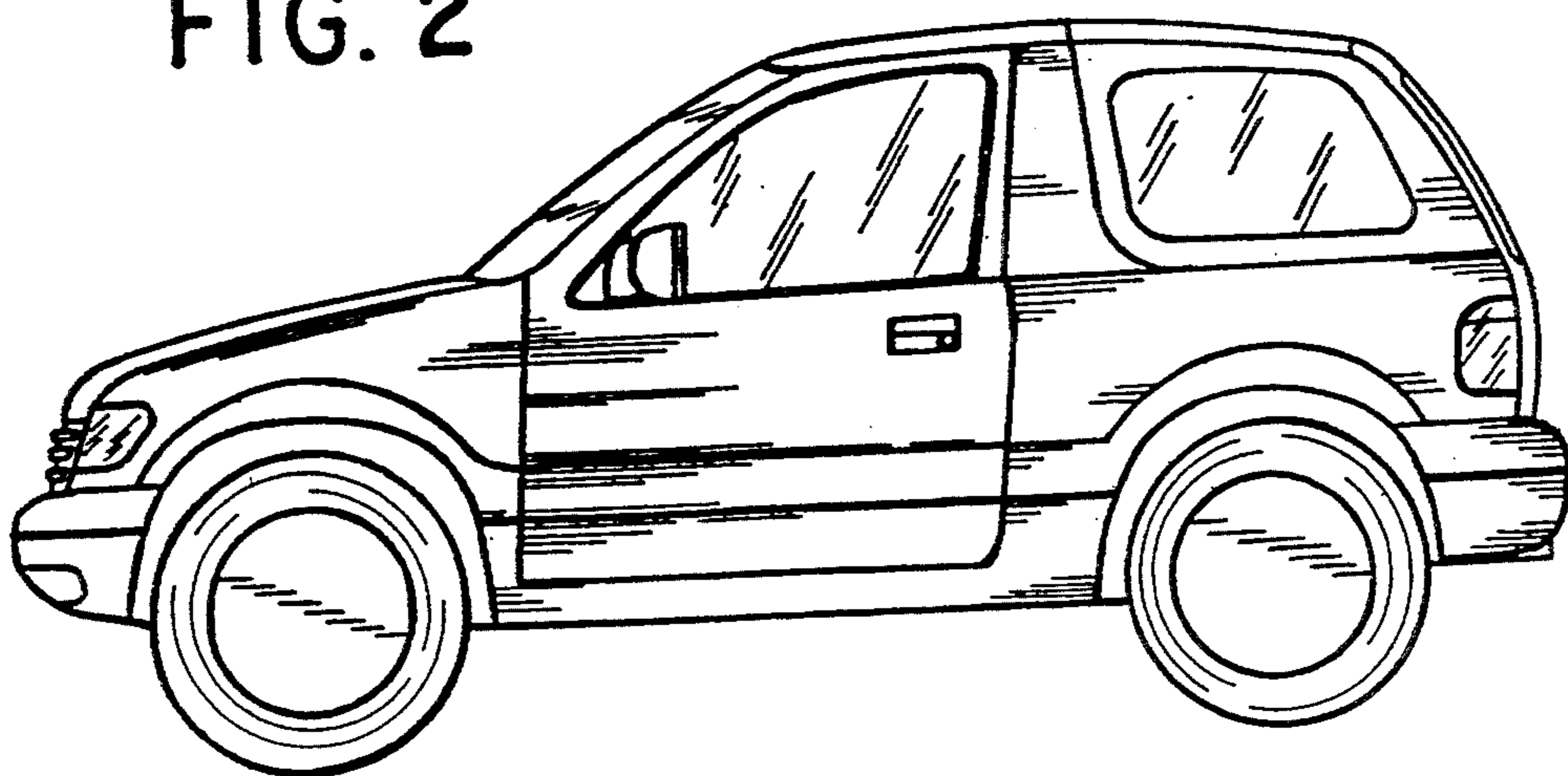

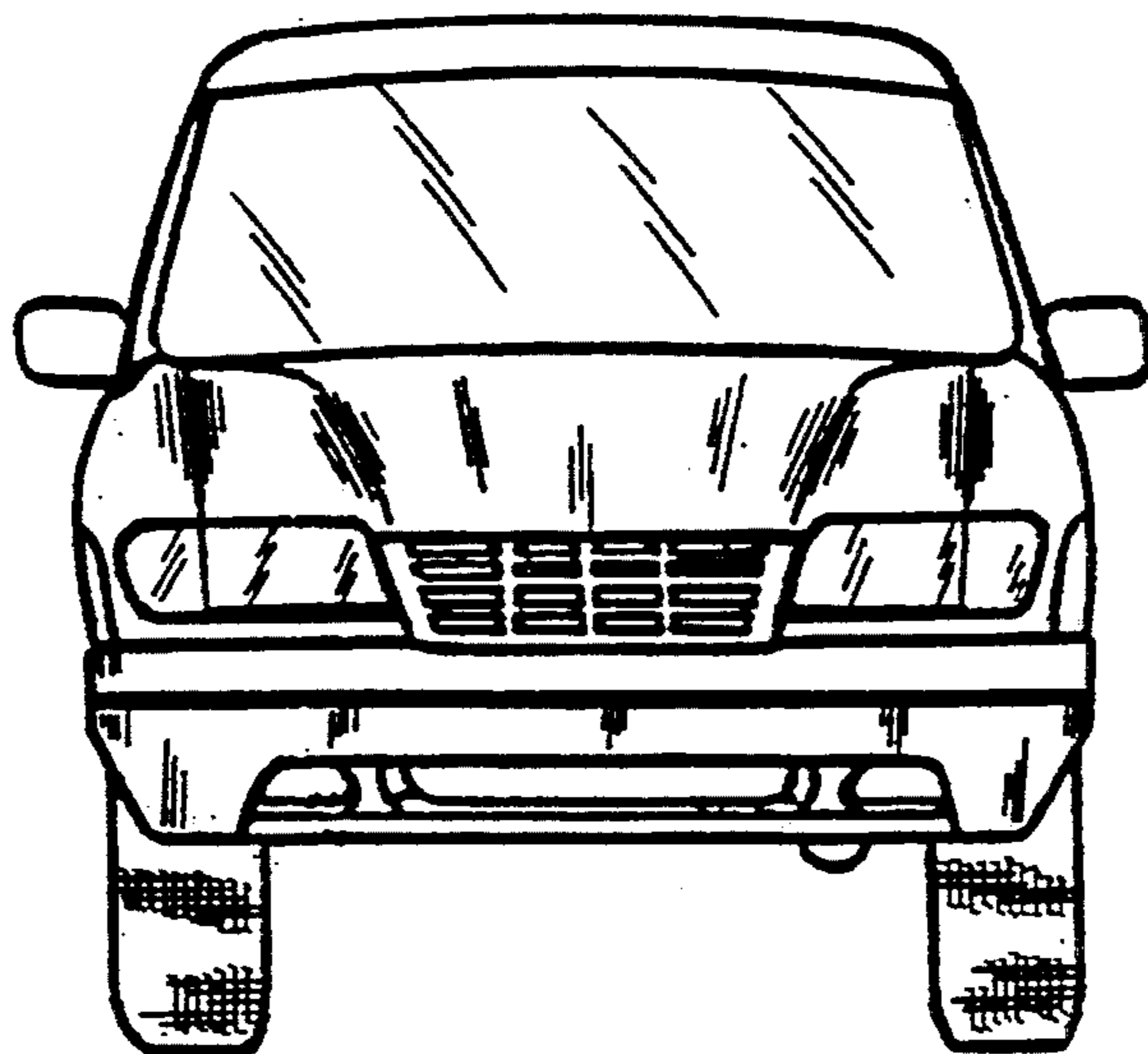

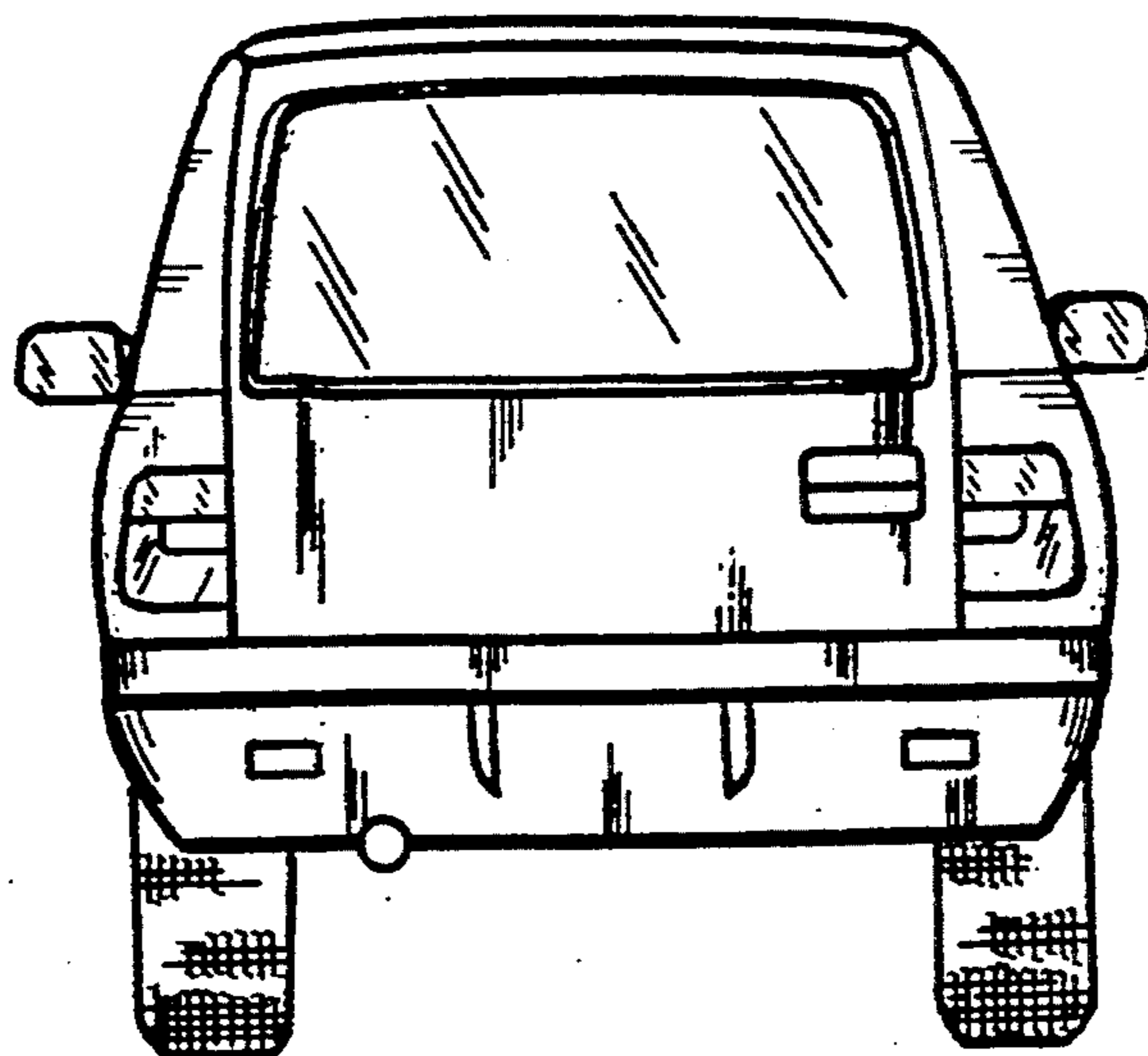

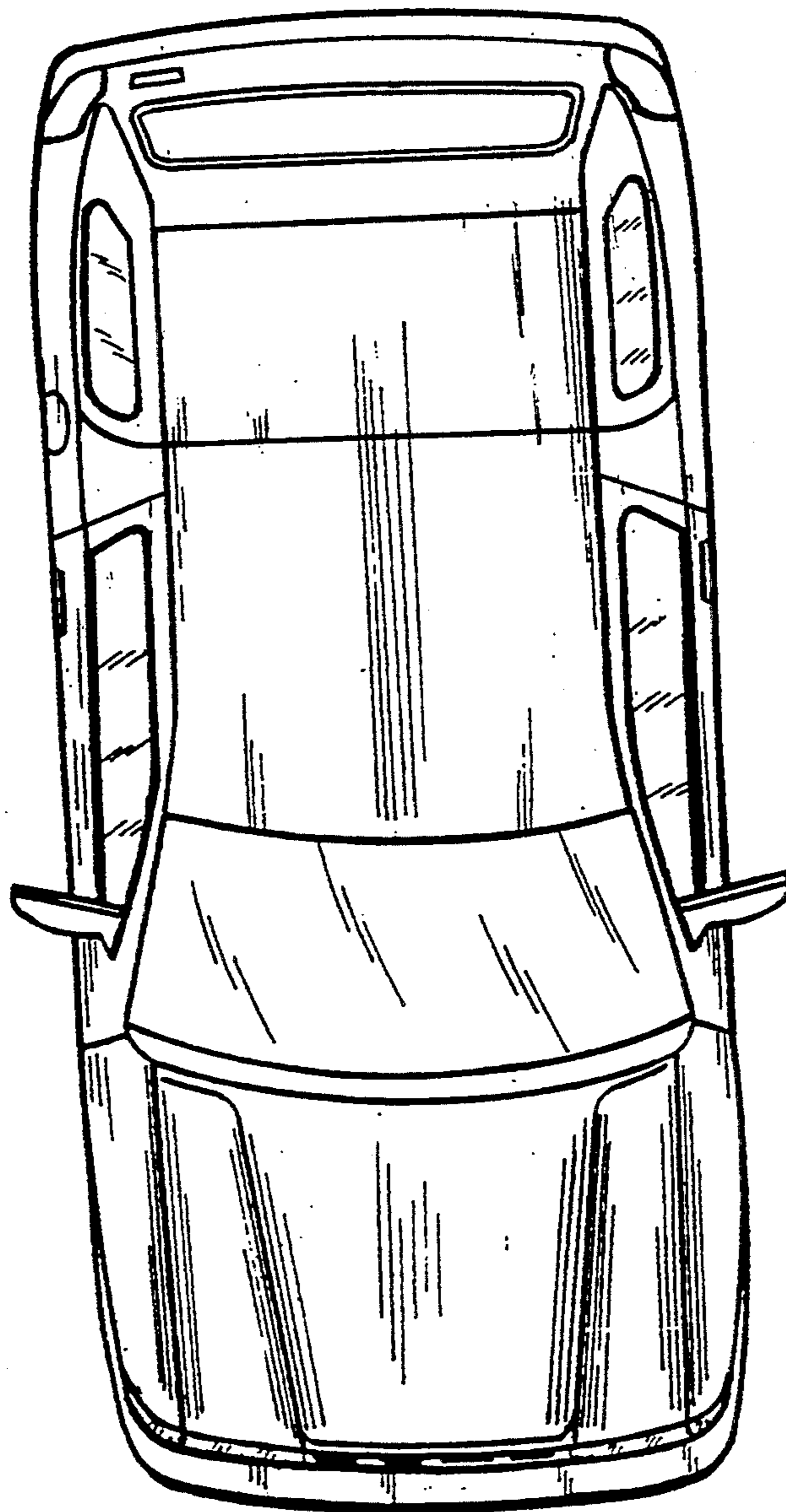

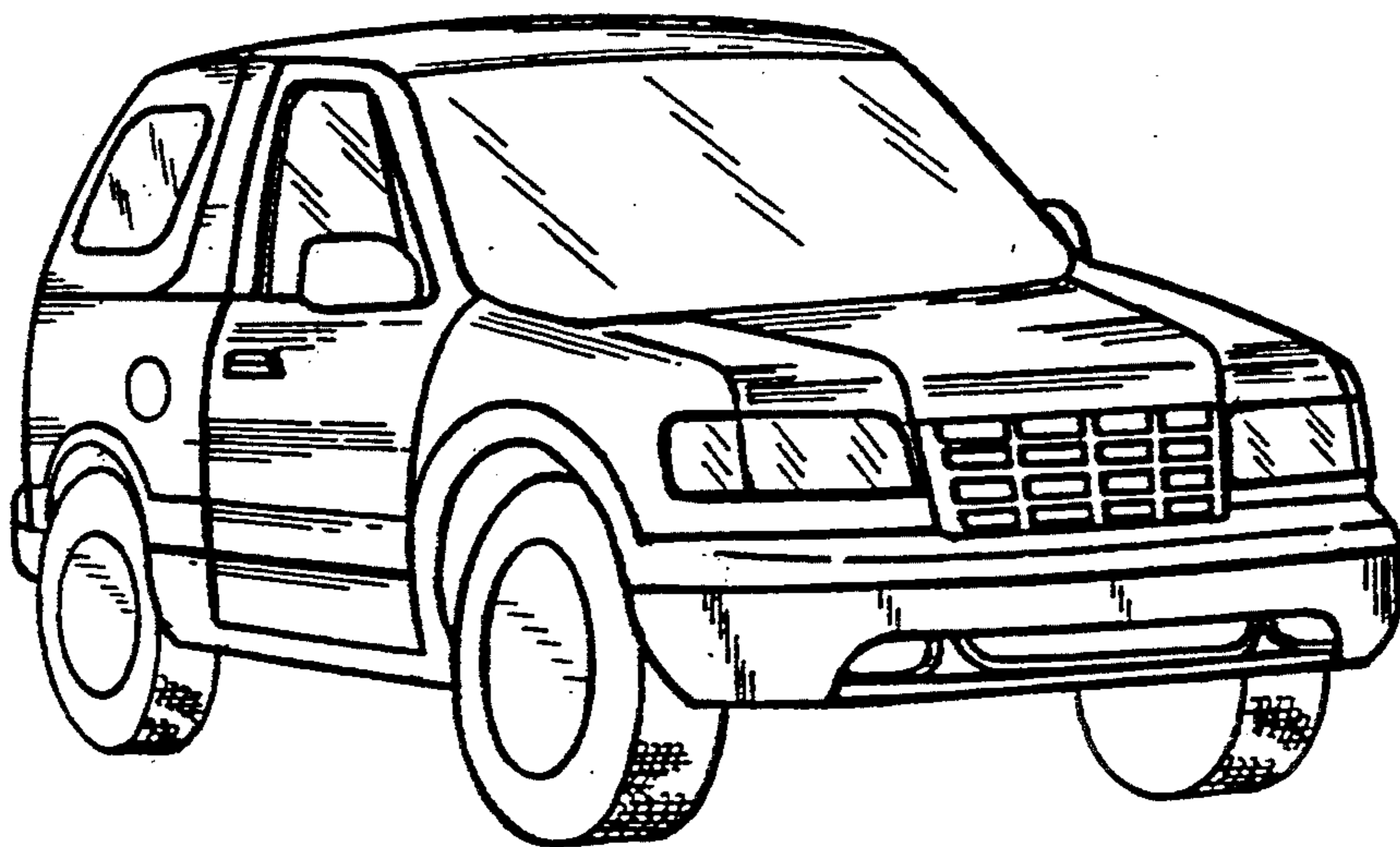

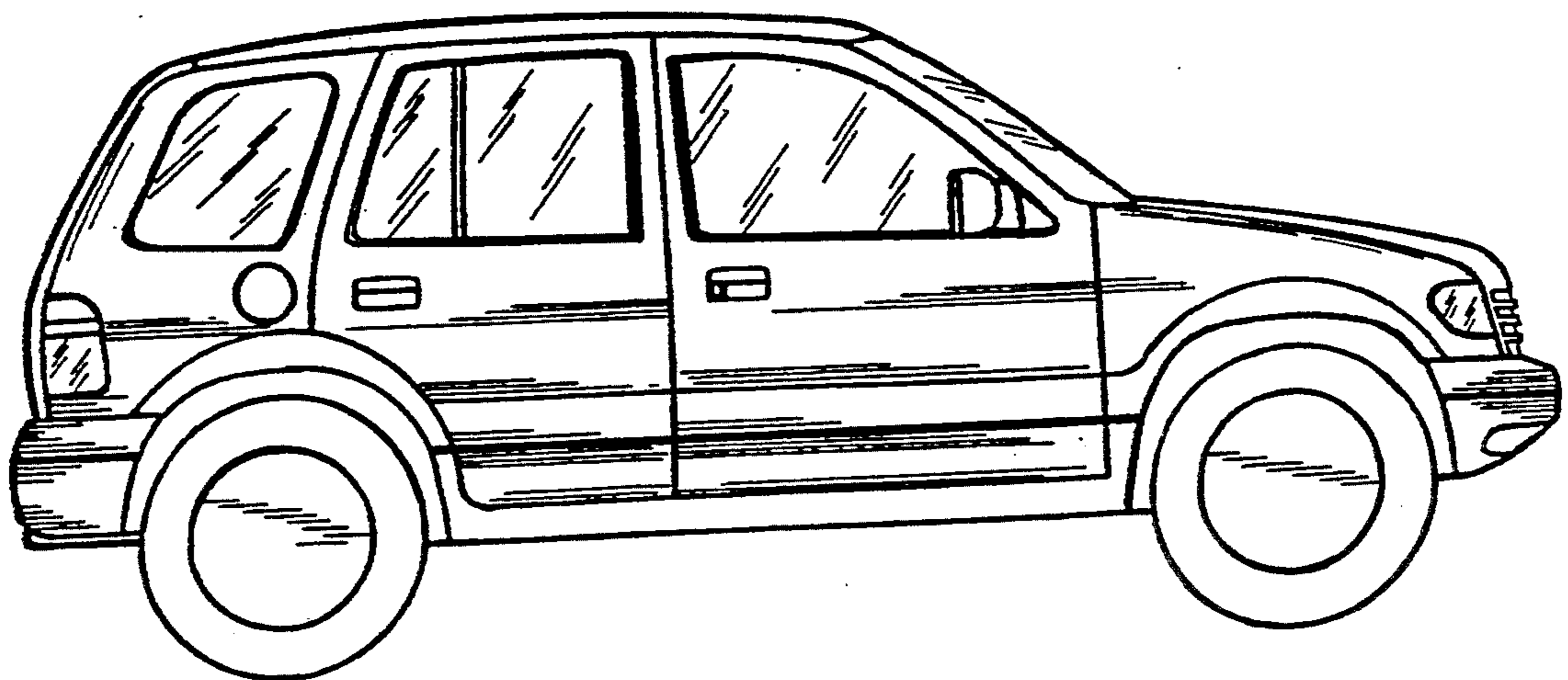

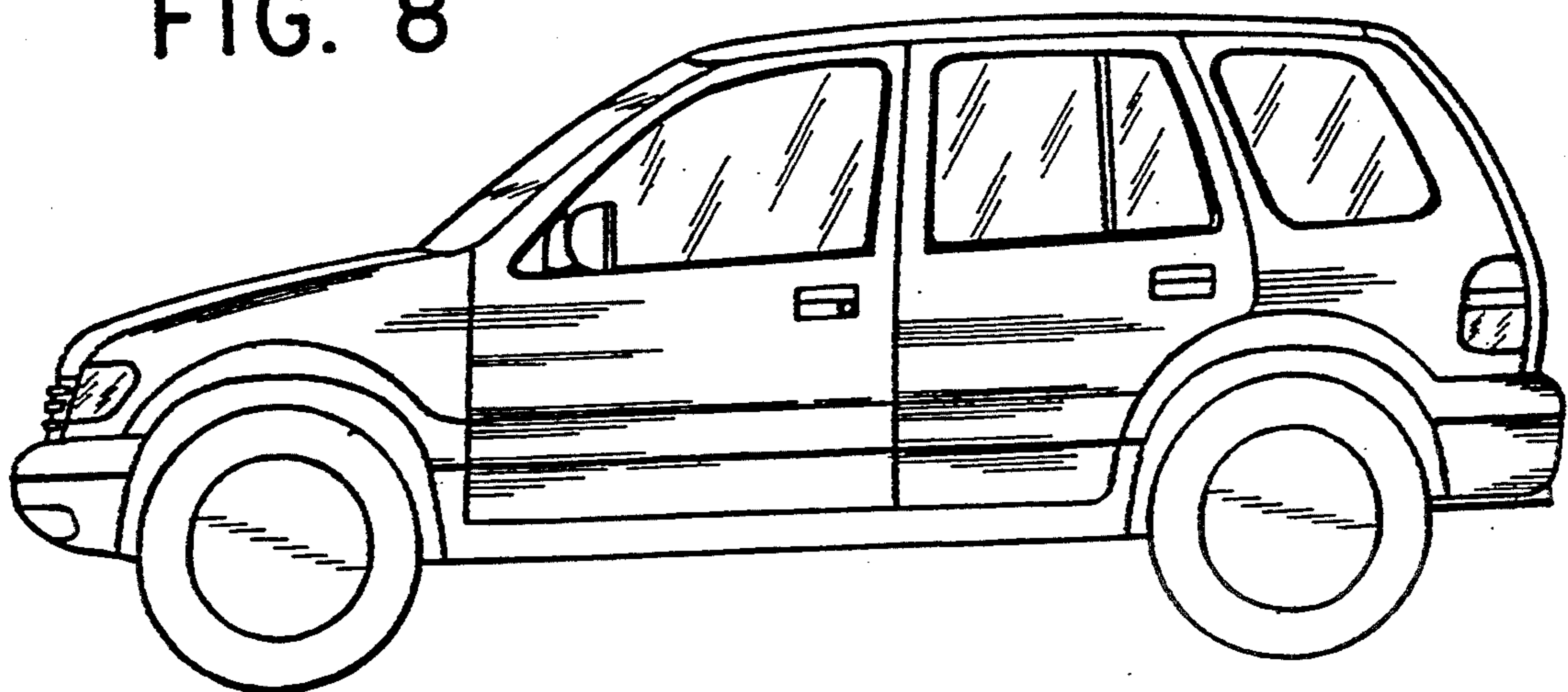

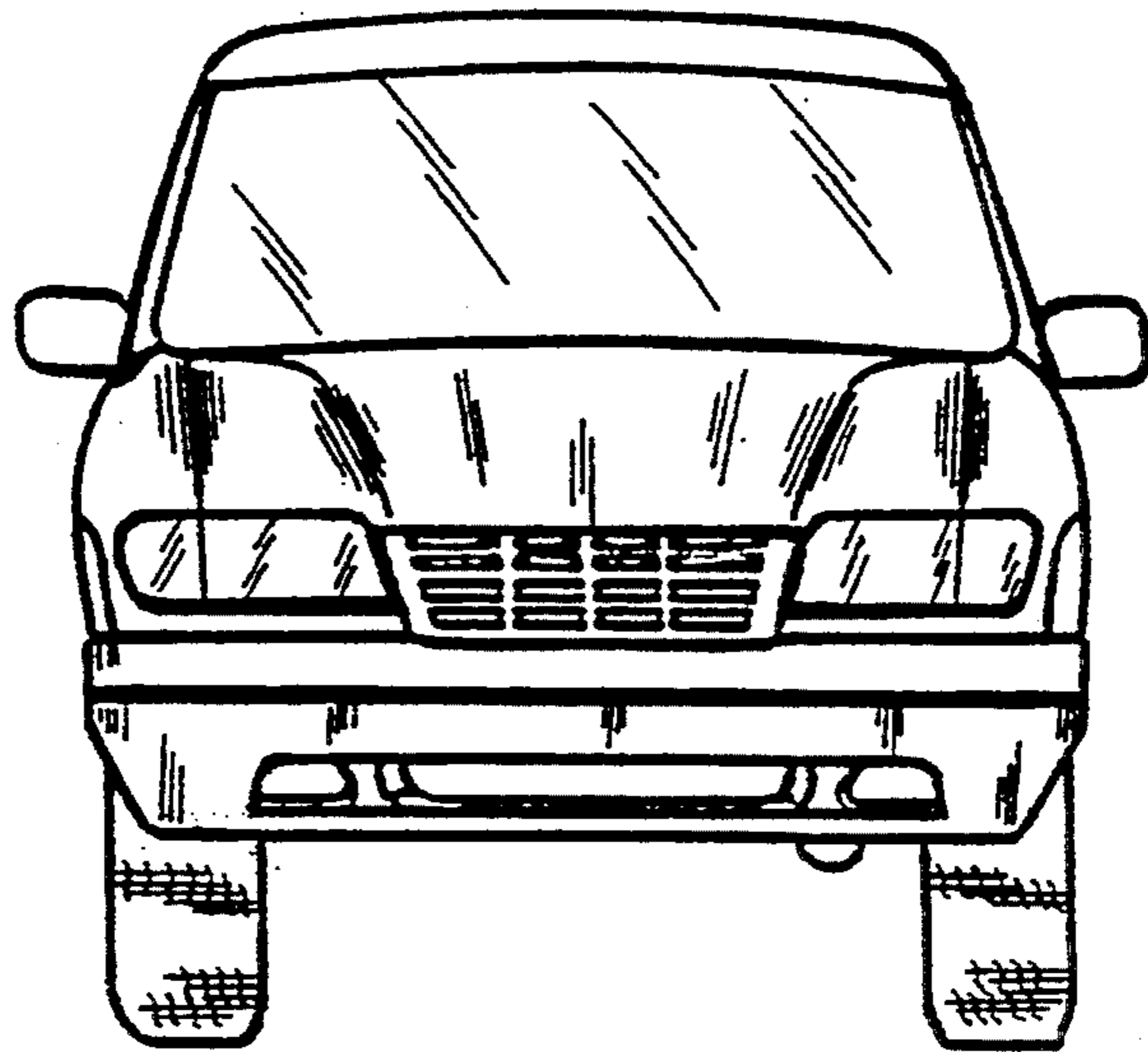

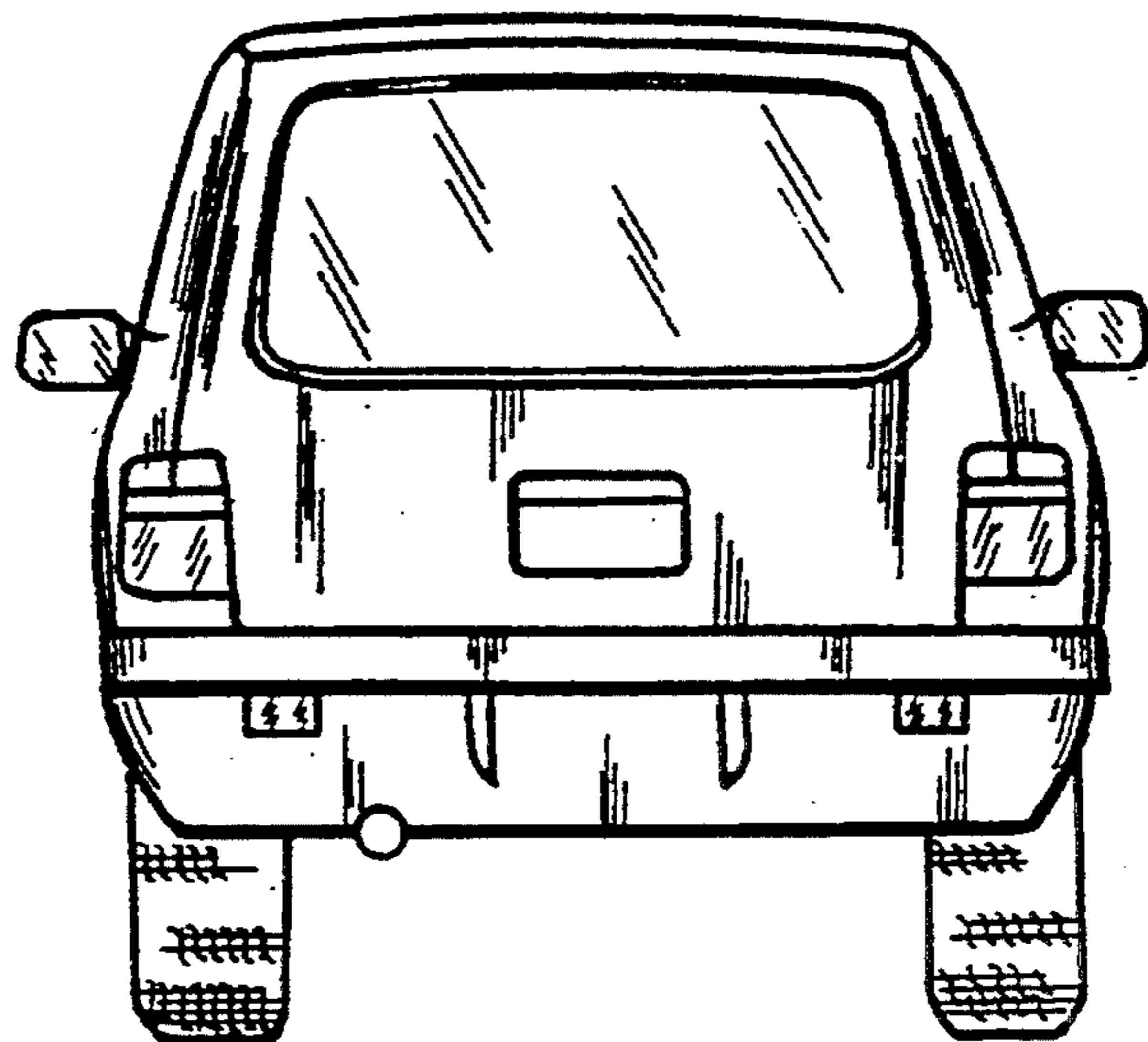

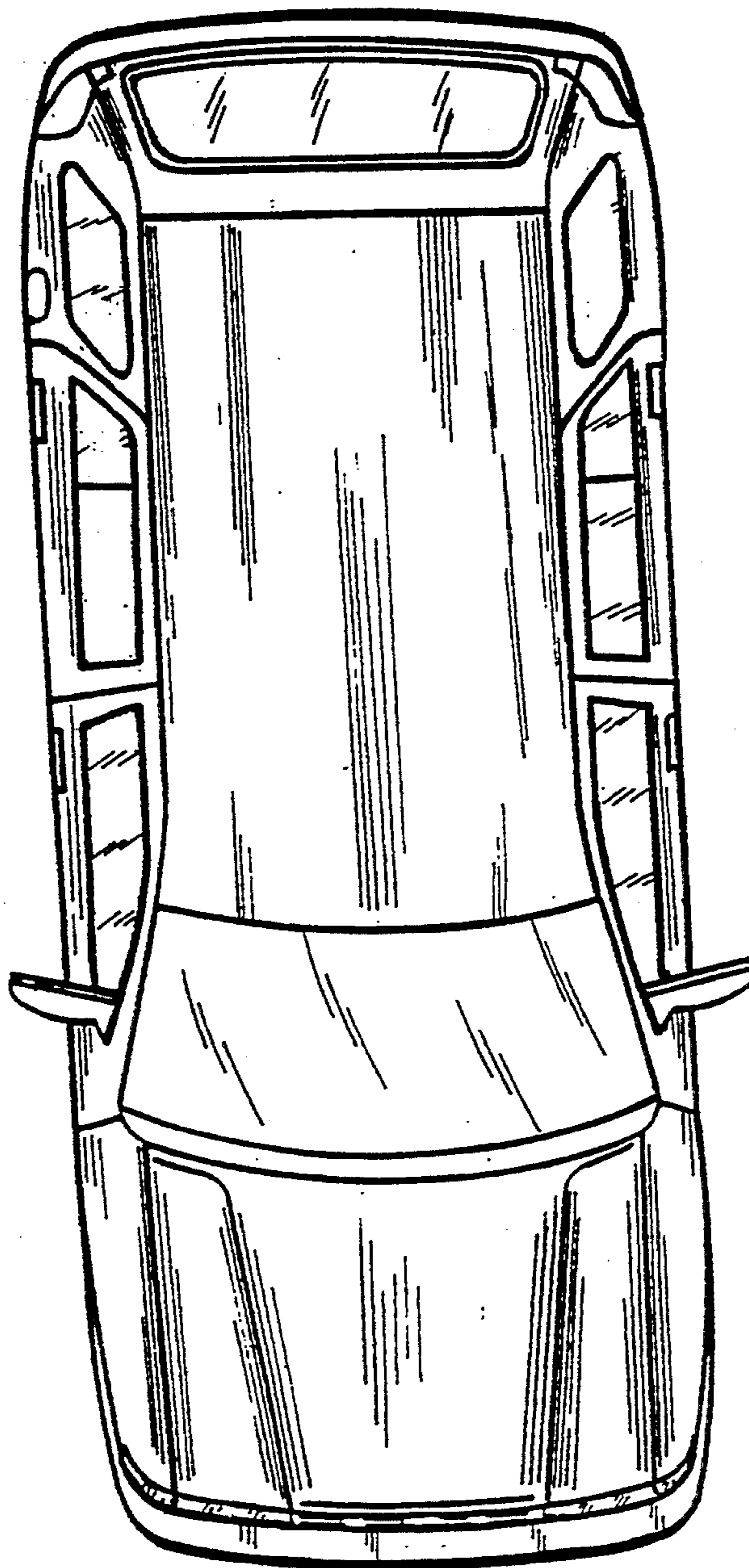
