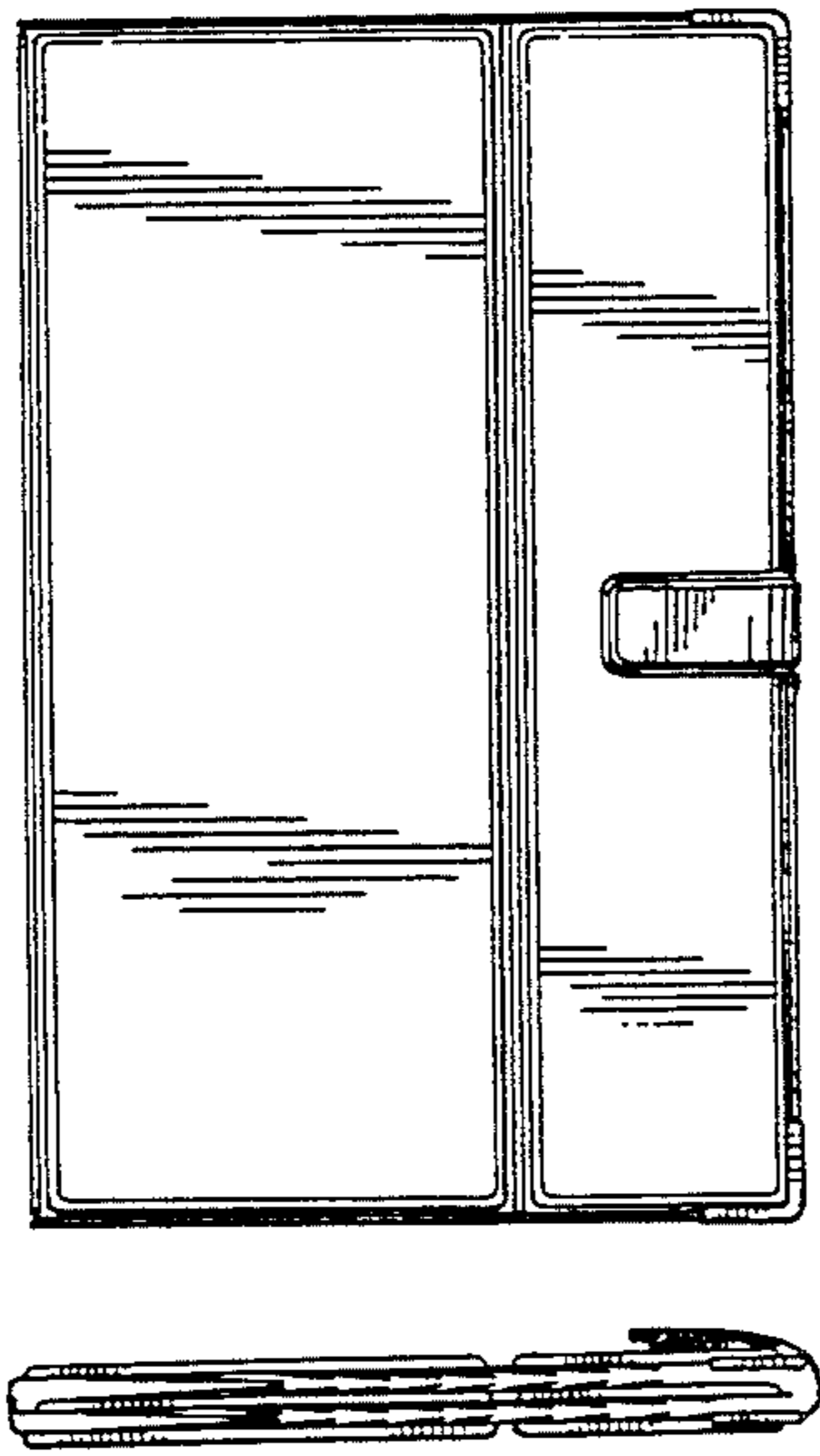

[57] CLAIM

The ornamental design for a card holder, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the card holder; FIG. 2 is a bottom plan view of the card holder of FIG. 1; FIG. 3 is a side plan view of the card holder of FIG. 1; FIG. 4 is a plan view of the other side of the card holder of FIG. 1; FIG. 5 is a side plan view of a second embodiment of FIG. 1, it being understood that the top and bottom are the same as in FIG. 1; FIG. 6 is a plan view of the other side of the card holder of FIG. 5; FIG. 7 is a side plan view of a third embodiment of FIG. 1, it being understood that the top and bottom are the same as in FIG. 1; FIG. 8 is a plan view of the other side of the card holder of FIG. 7; FIG. 9 is an end view of the card holder of FIG. 1; FIG. 10 is an end view of the card holder of FIG. 5; FIG. 11 is an end view of the card holder of FIG. 7; FIG. 12 is a perspective view of the interior of the card holder of FIG. 1 when the card holder is in the open position; FIG. 13 is a plan view of the interior of the card holder of FIG. 1 when the card holder is in the open position, with the verticle center broken away for ease of illustration only; FIG. 14 is a plan view of the exterior of the card holder of FIG. 1 when the card holder is in the open position, with the verticle center broken away for ease of illustration only; FIG. 15 is an end view of the card holder of FIG. 1 when the card holder is in the open position; FIG. 16 is an end view of the card holder of FIG. 5 when the card holder is in the open position; and, FIG. 17 is an end view of the card holder of FIG. 7 when the card holder is in the open position.



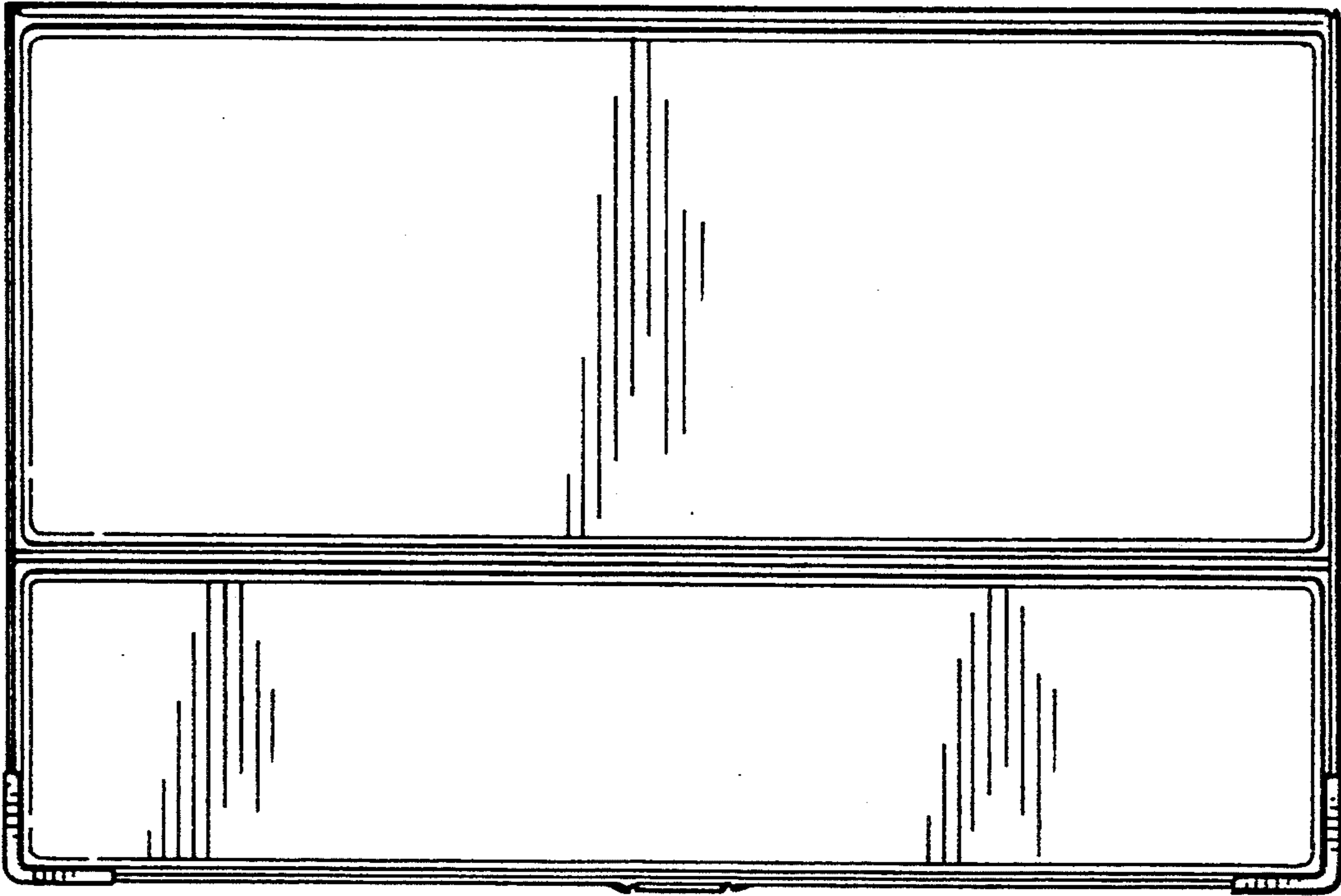

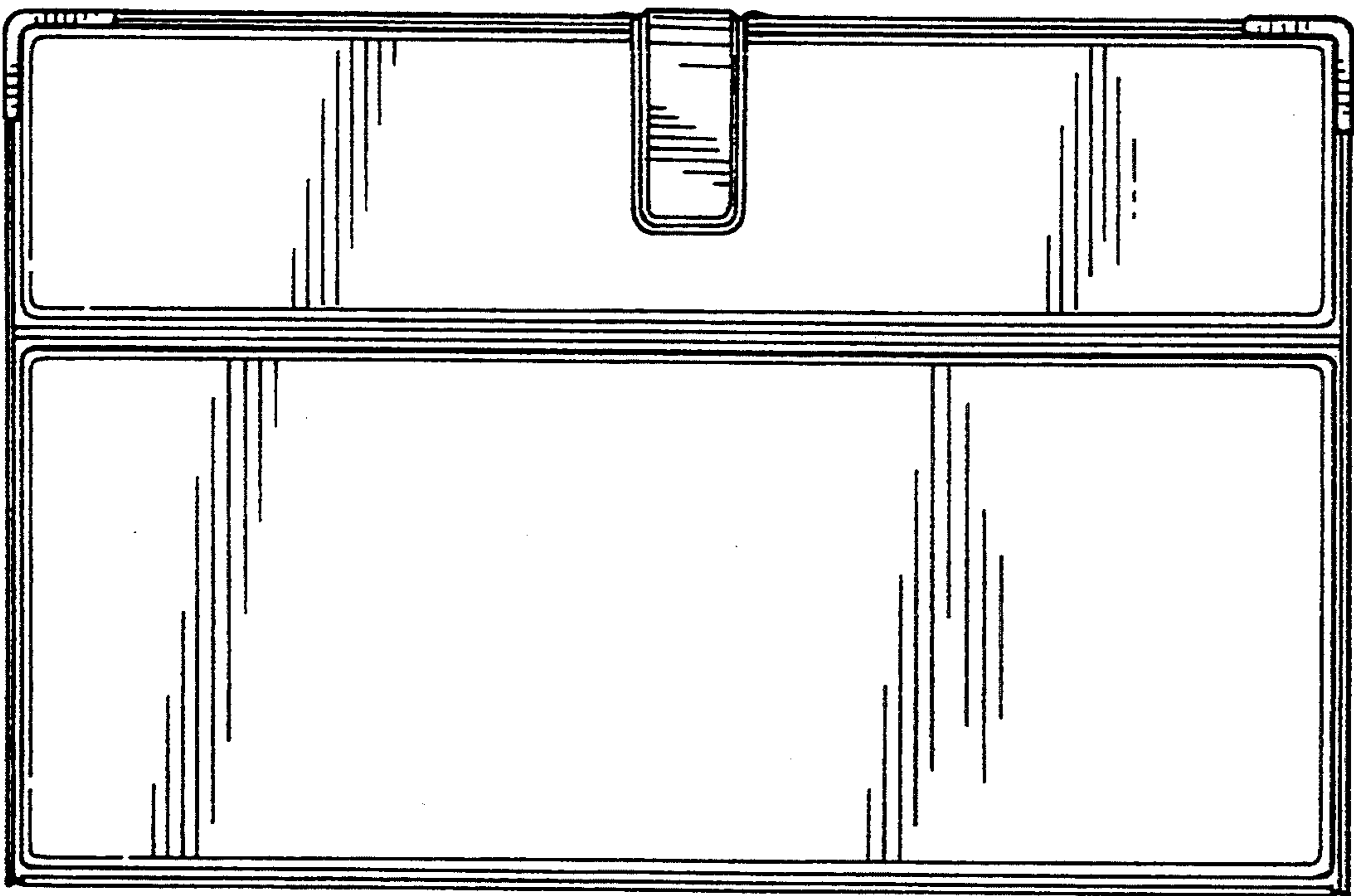

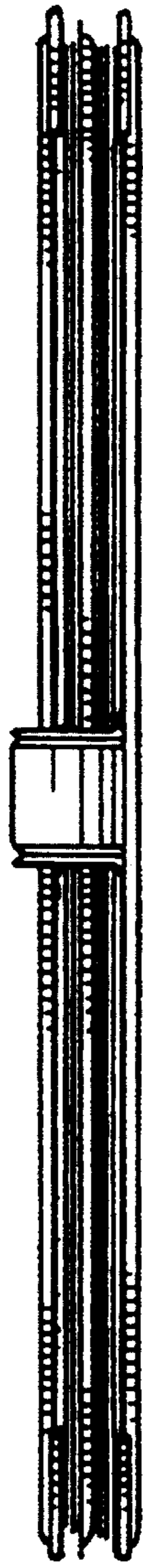

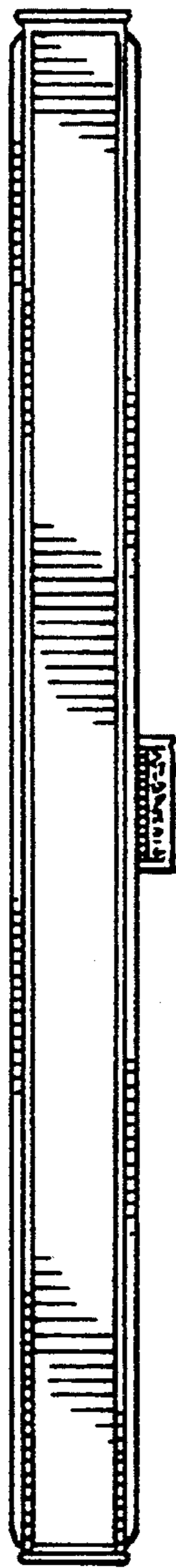

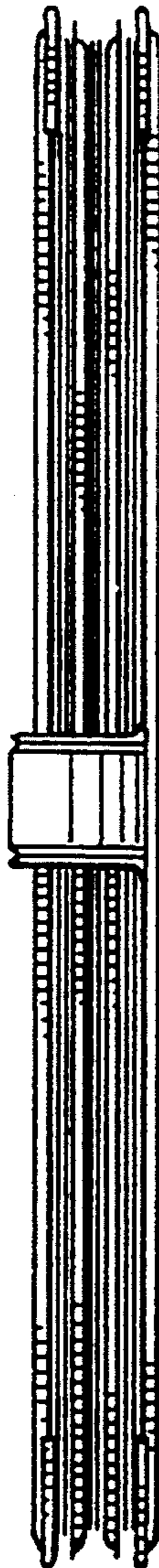

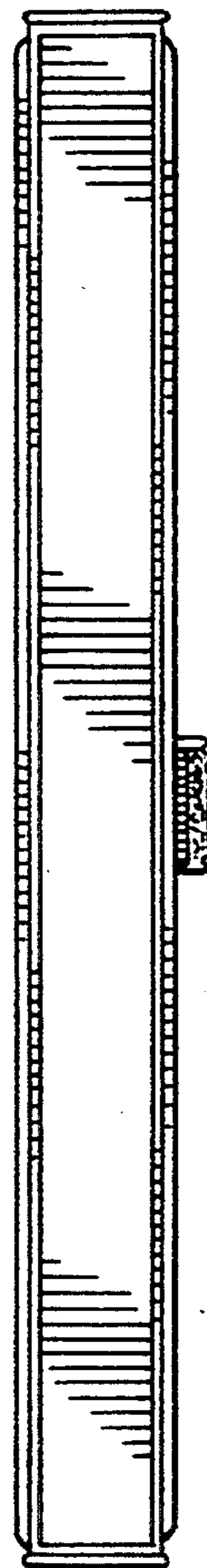

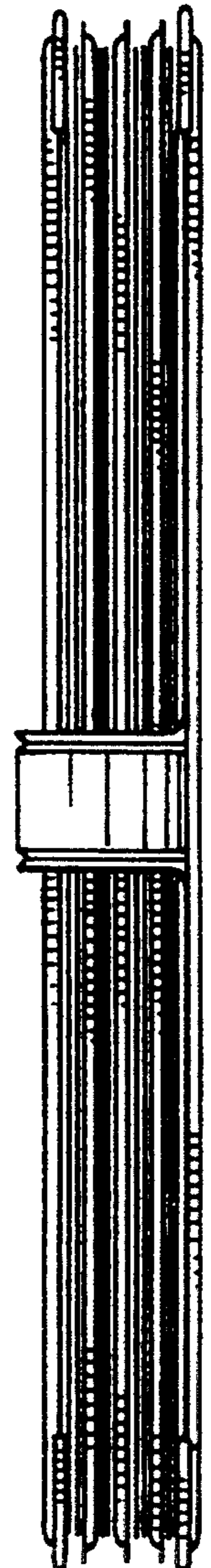

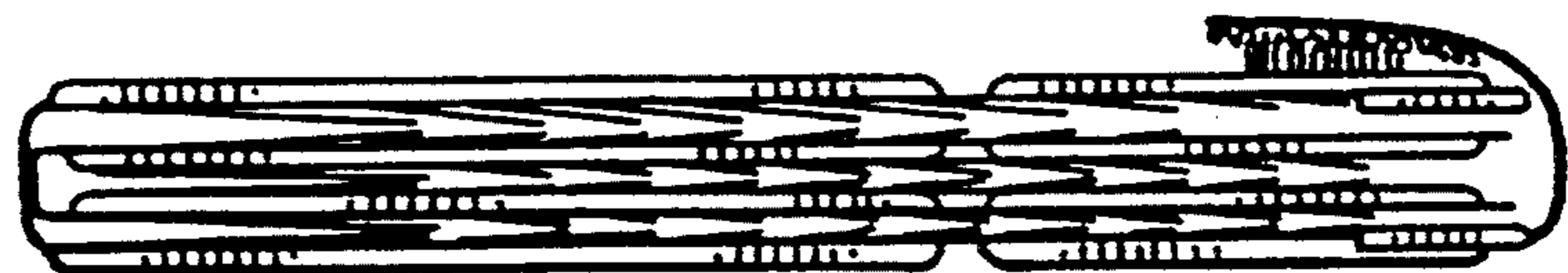

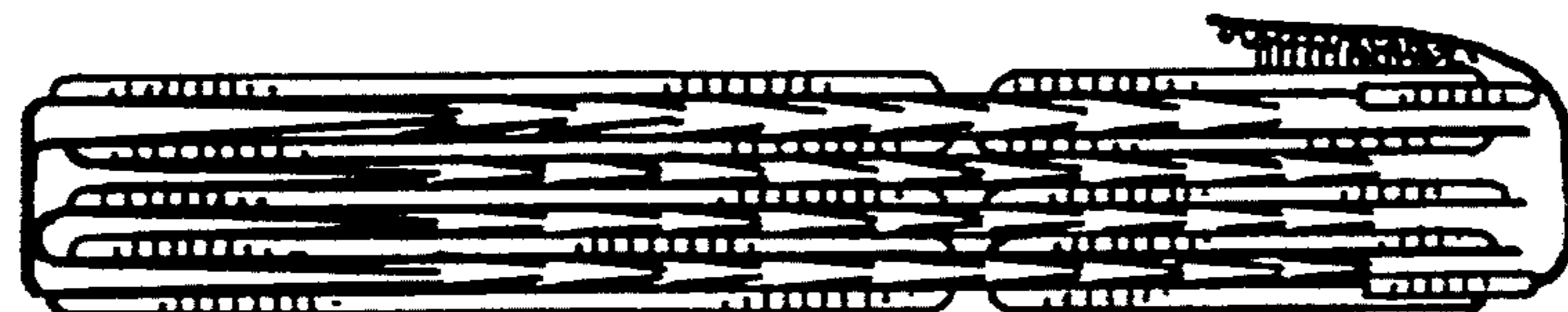

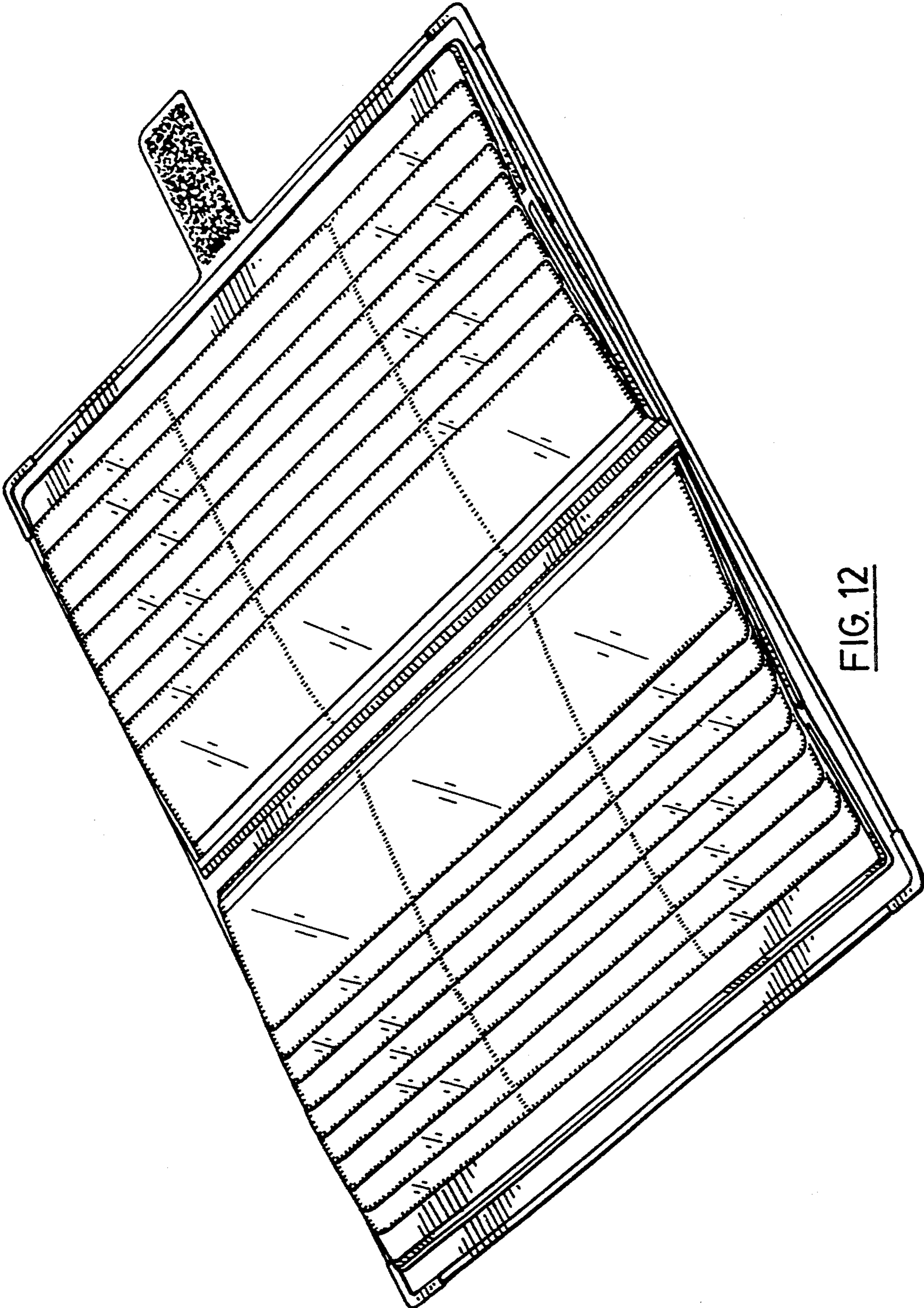

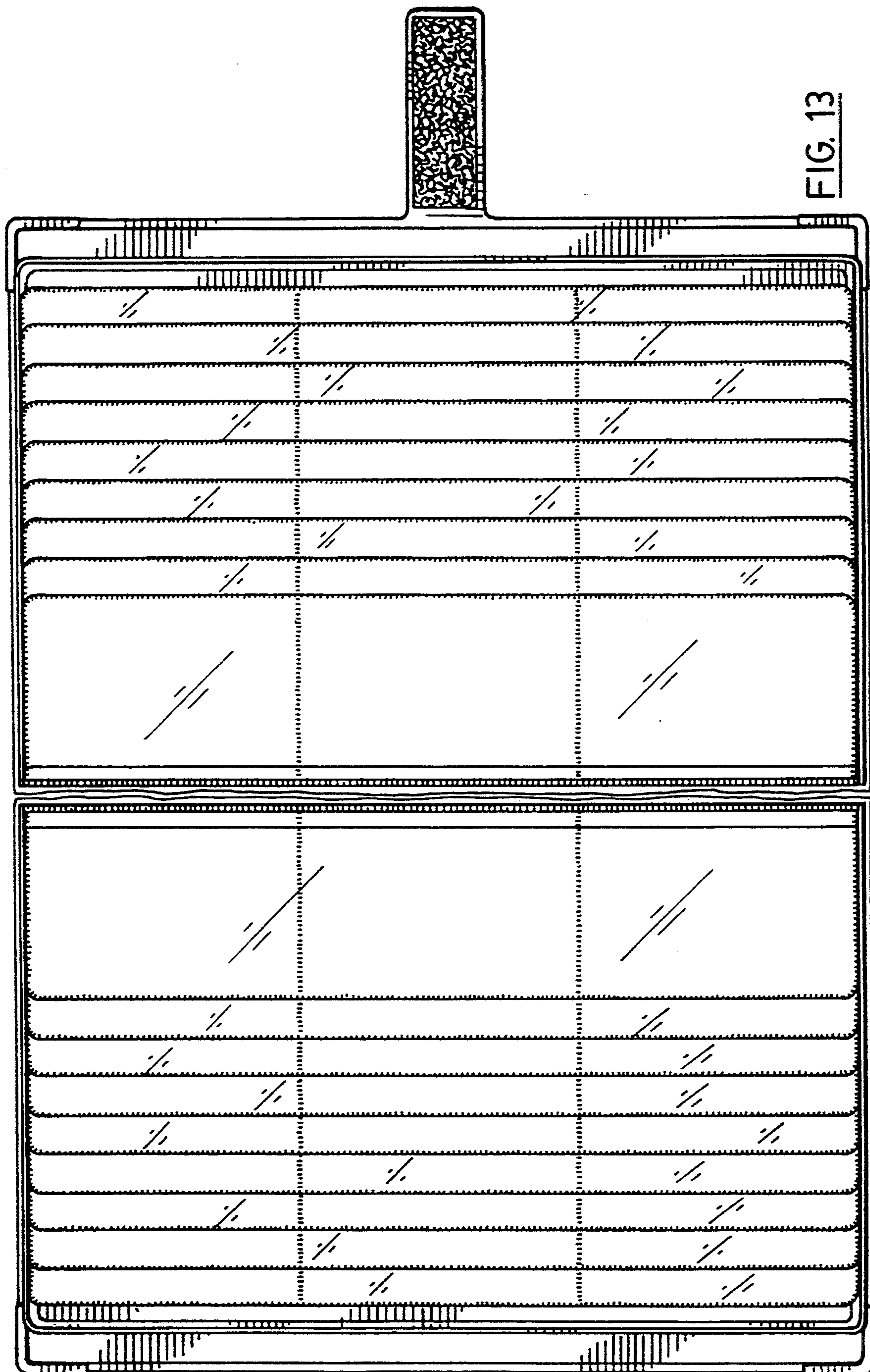

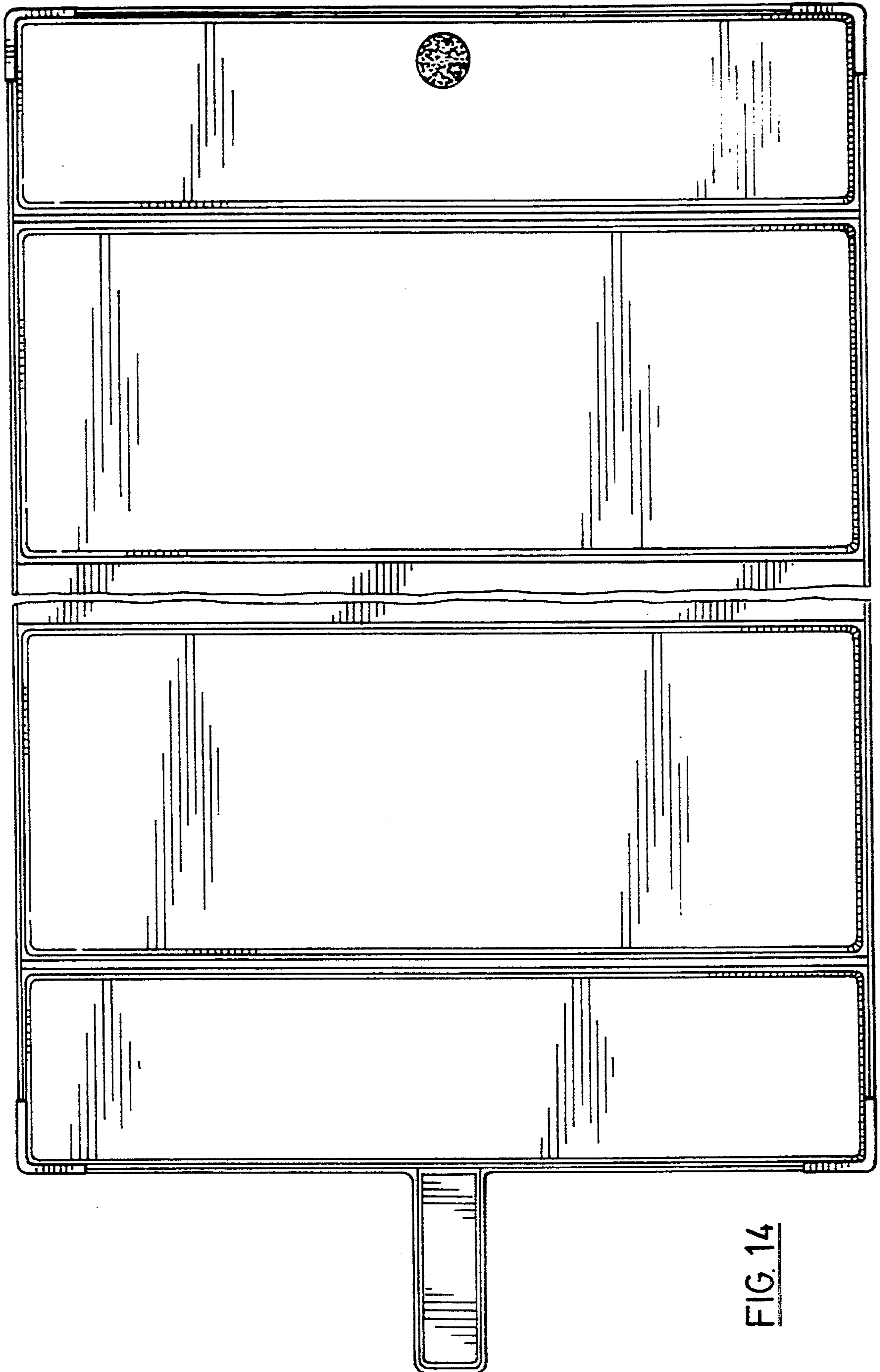

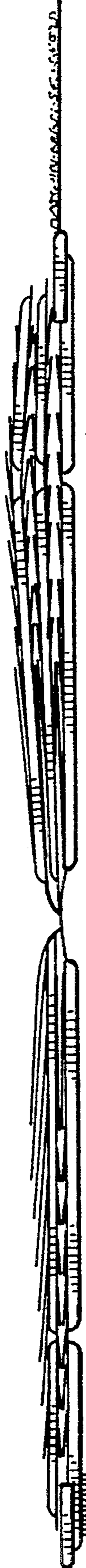
