The ornamental design for an “advertising display”, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an advertising display showing my new design; FIG. 2 is a side elevational view thereof; FIG. 3 is a perspective view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view thereof, with the broken line showing for illustrative purposes only and forming no part of the claimed design; and, FIG. 7 is a perspective view of FIG. 6.

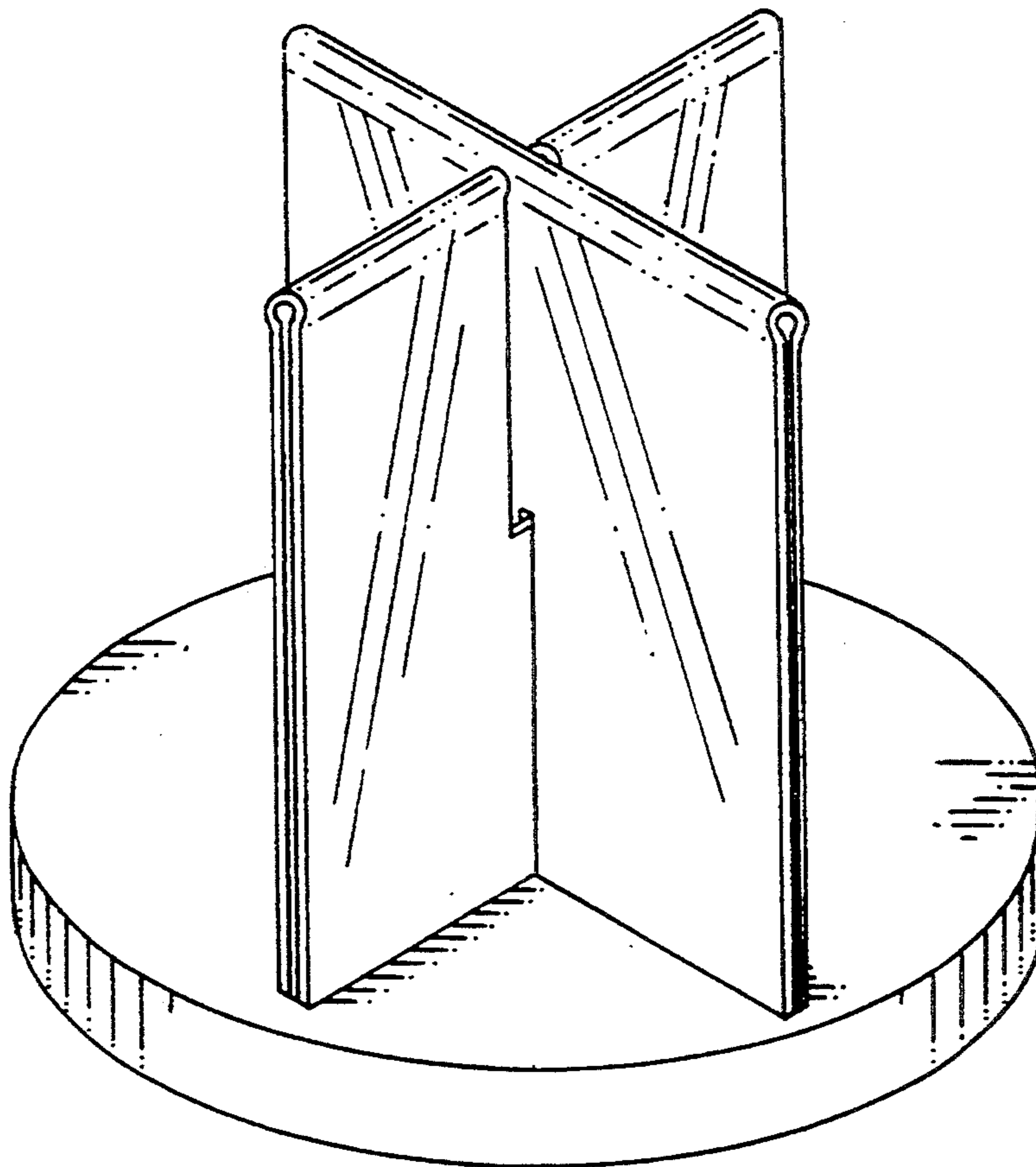

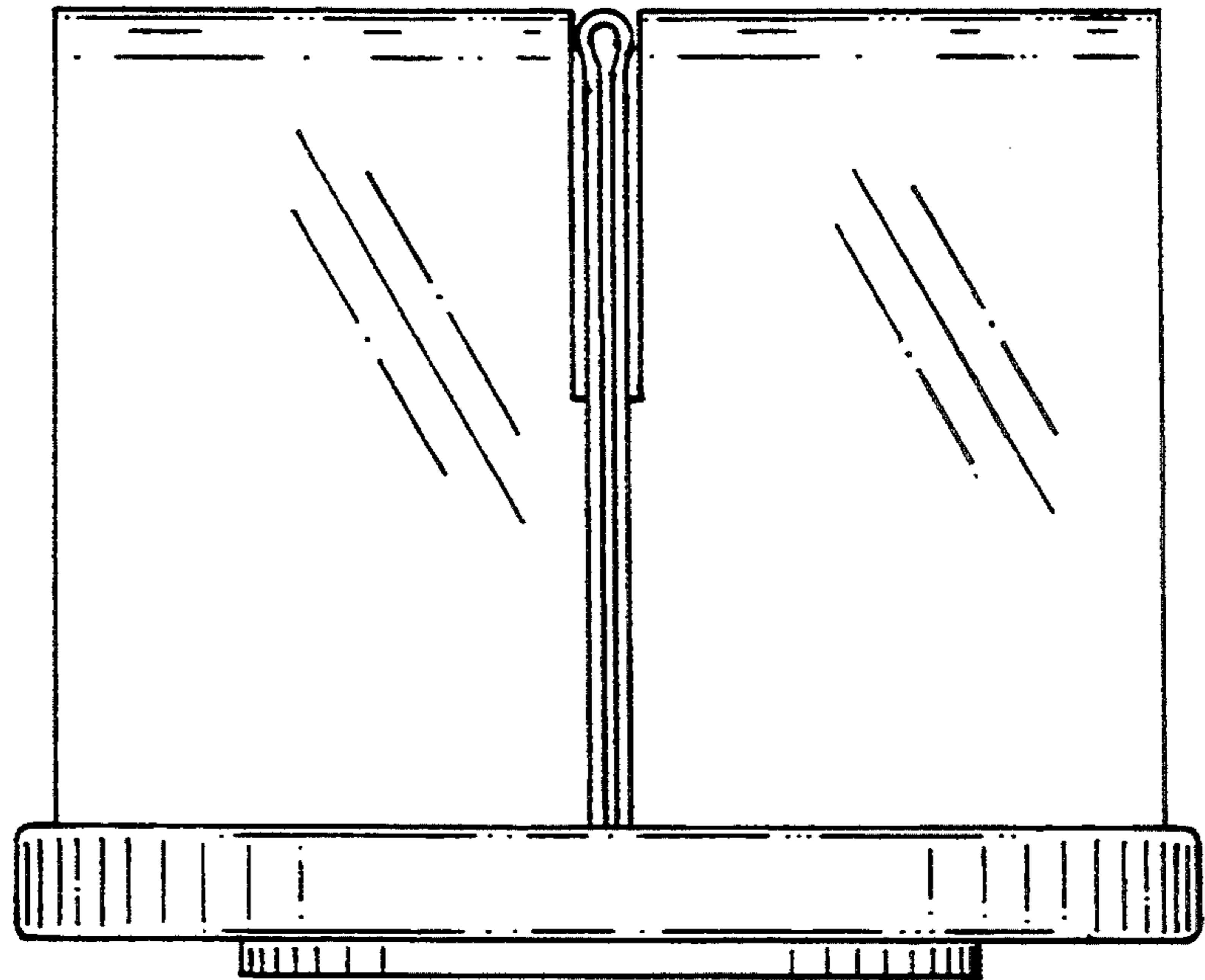

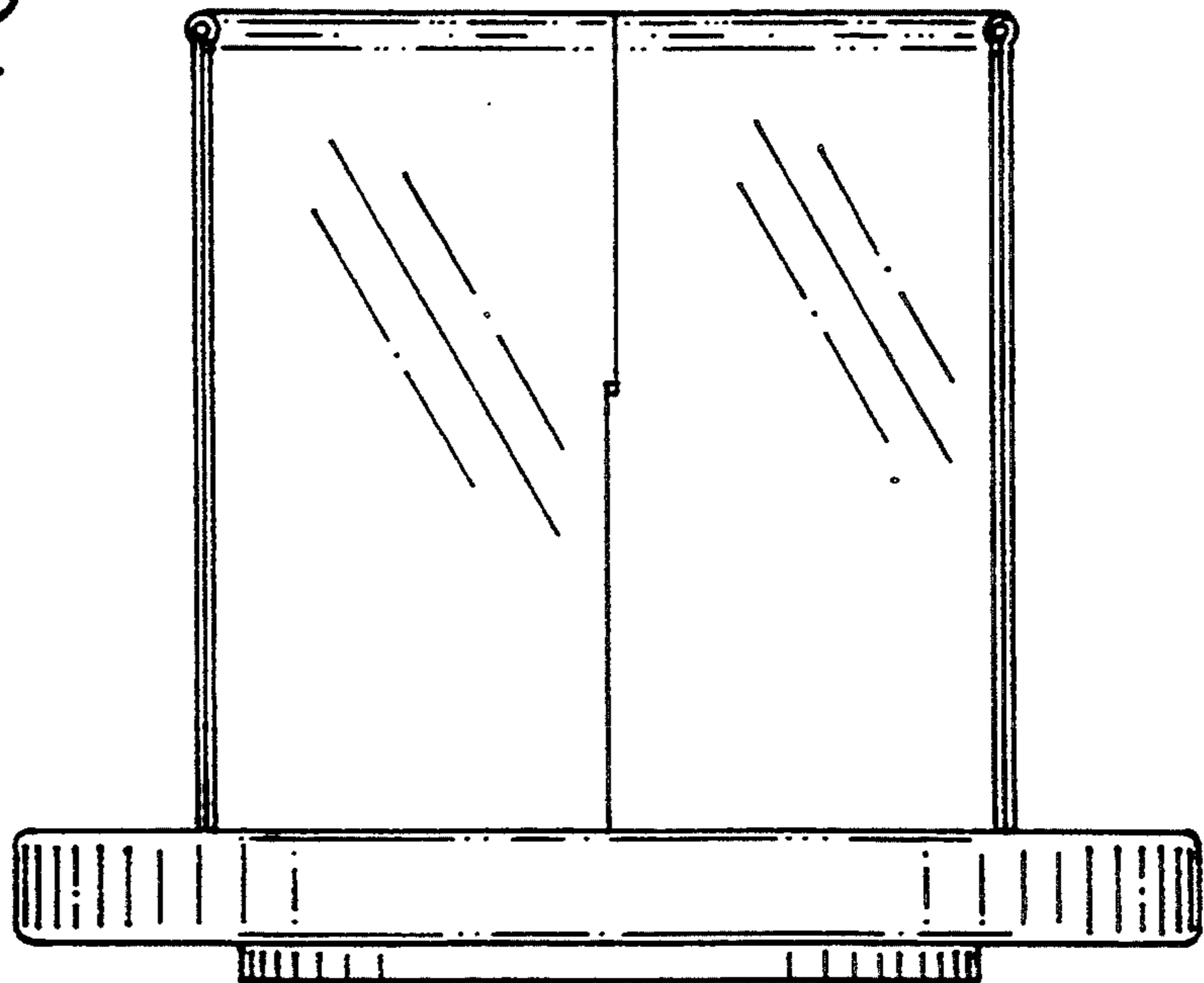

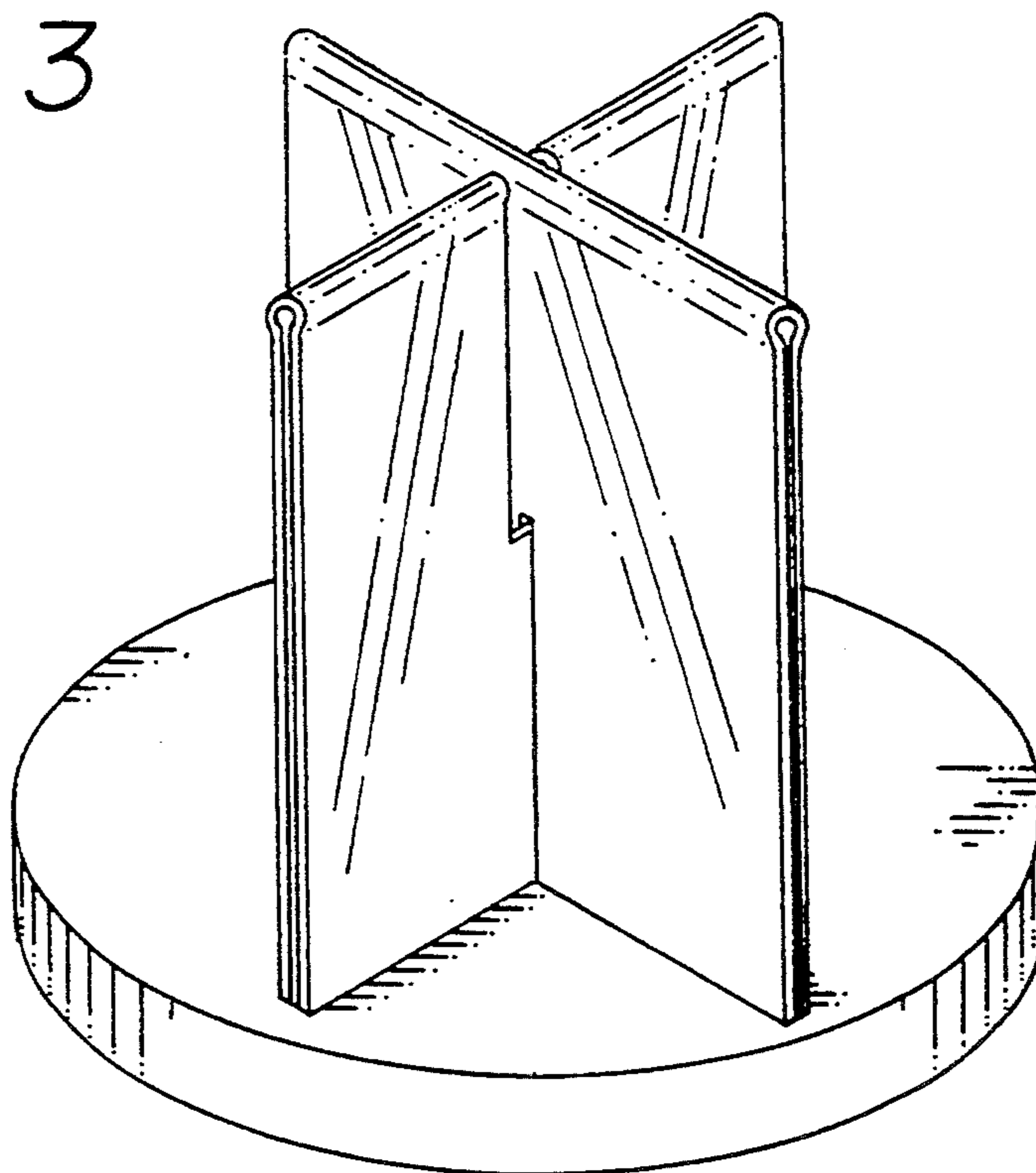

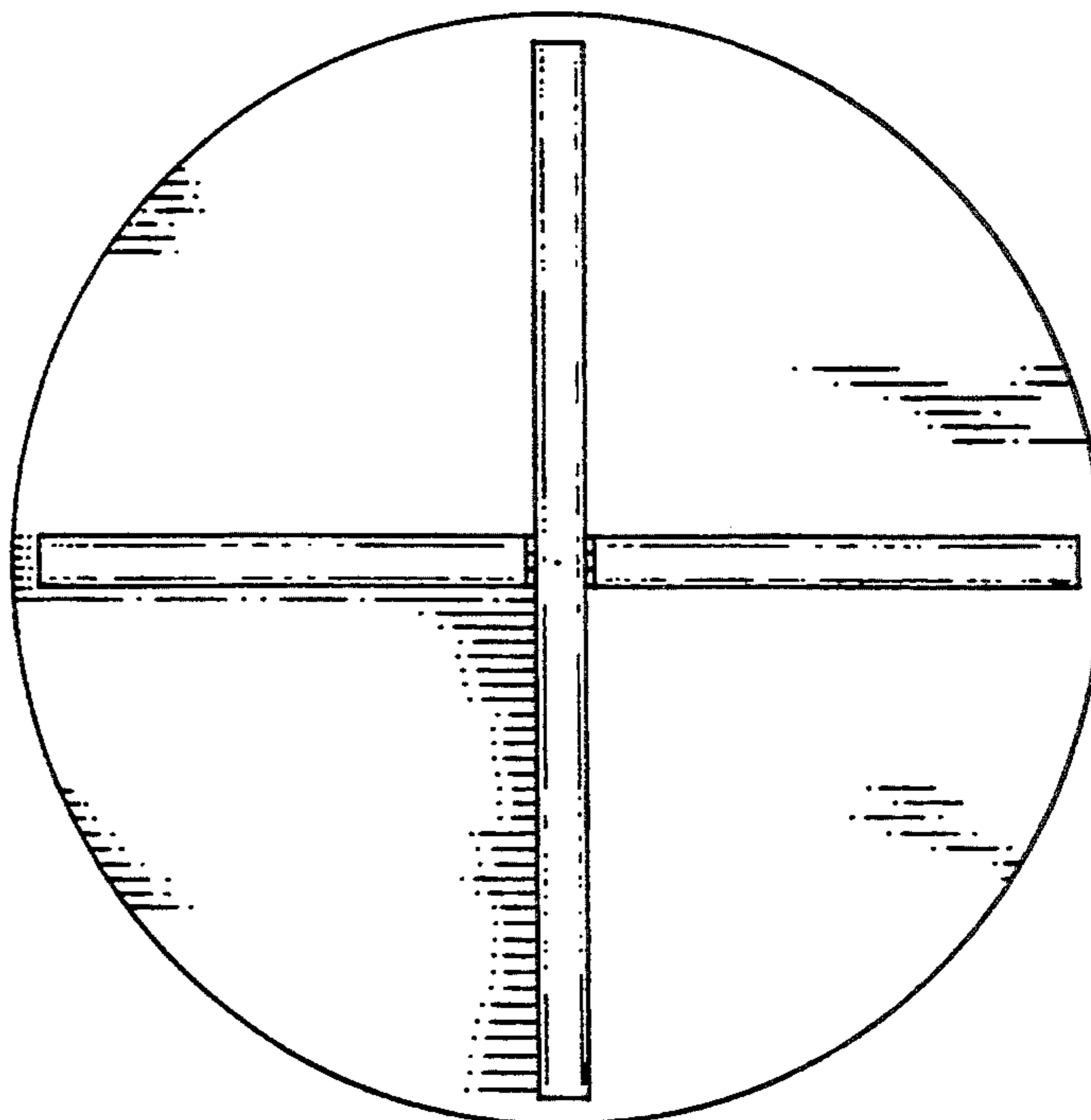

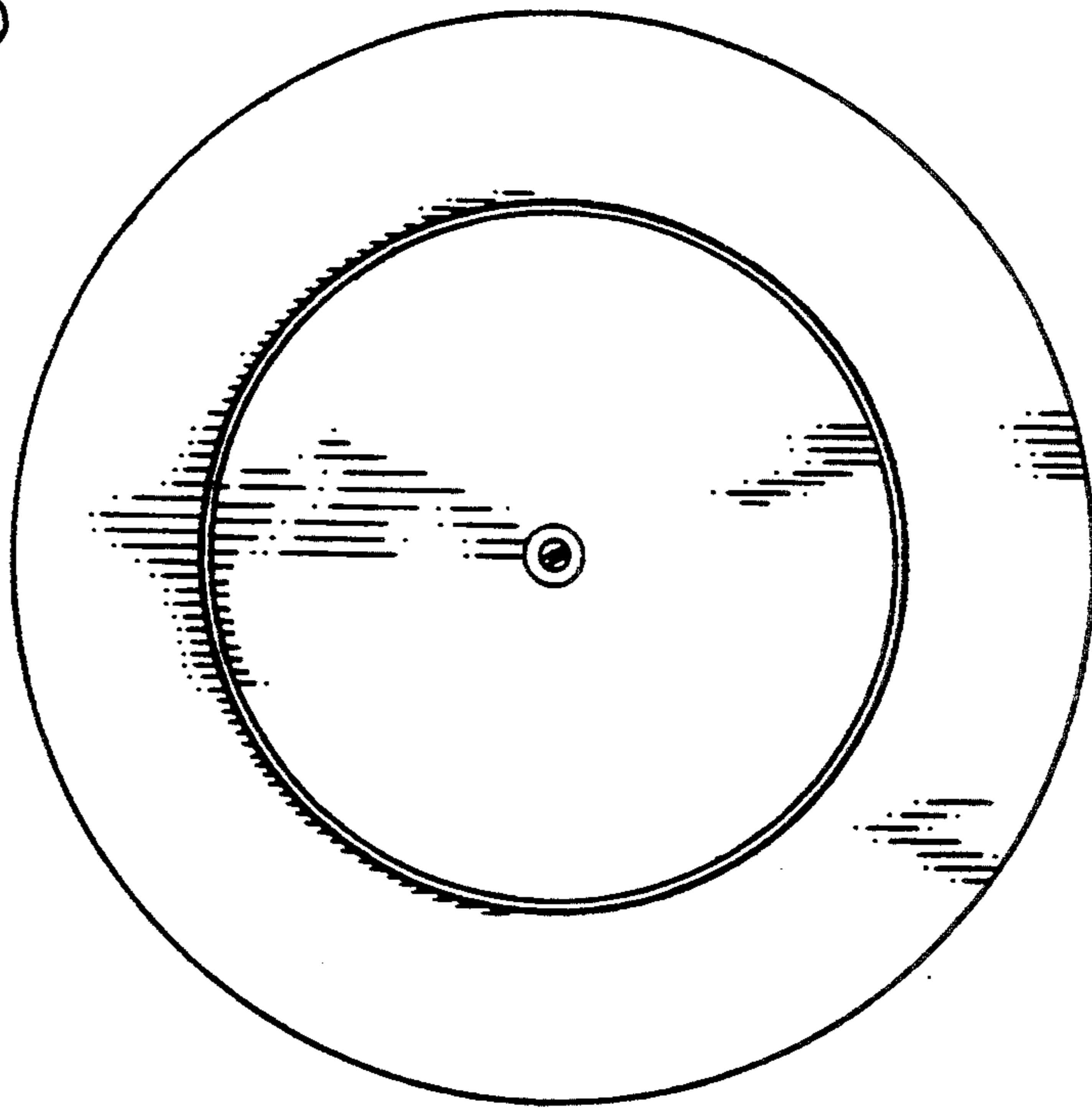

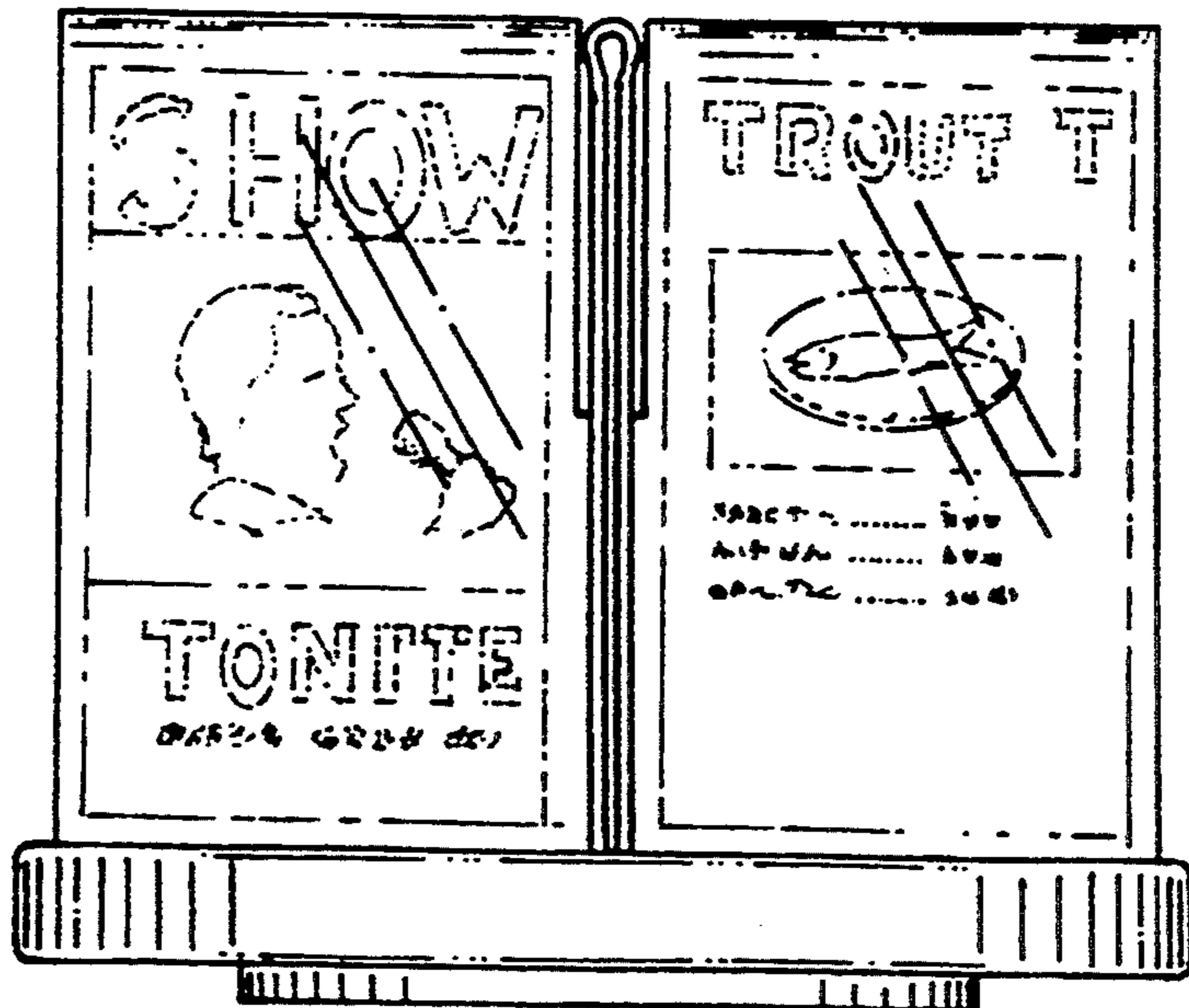
