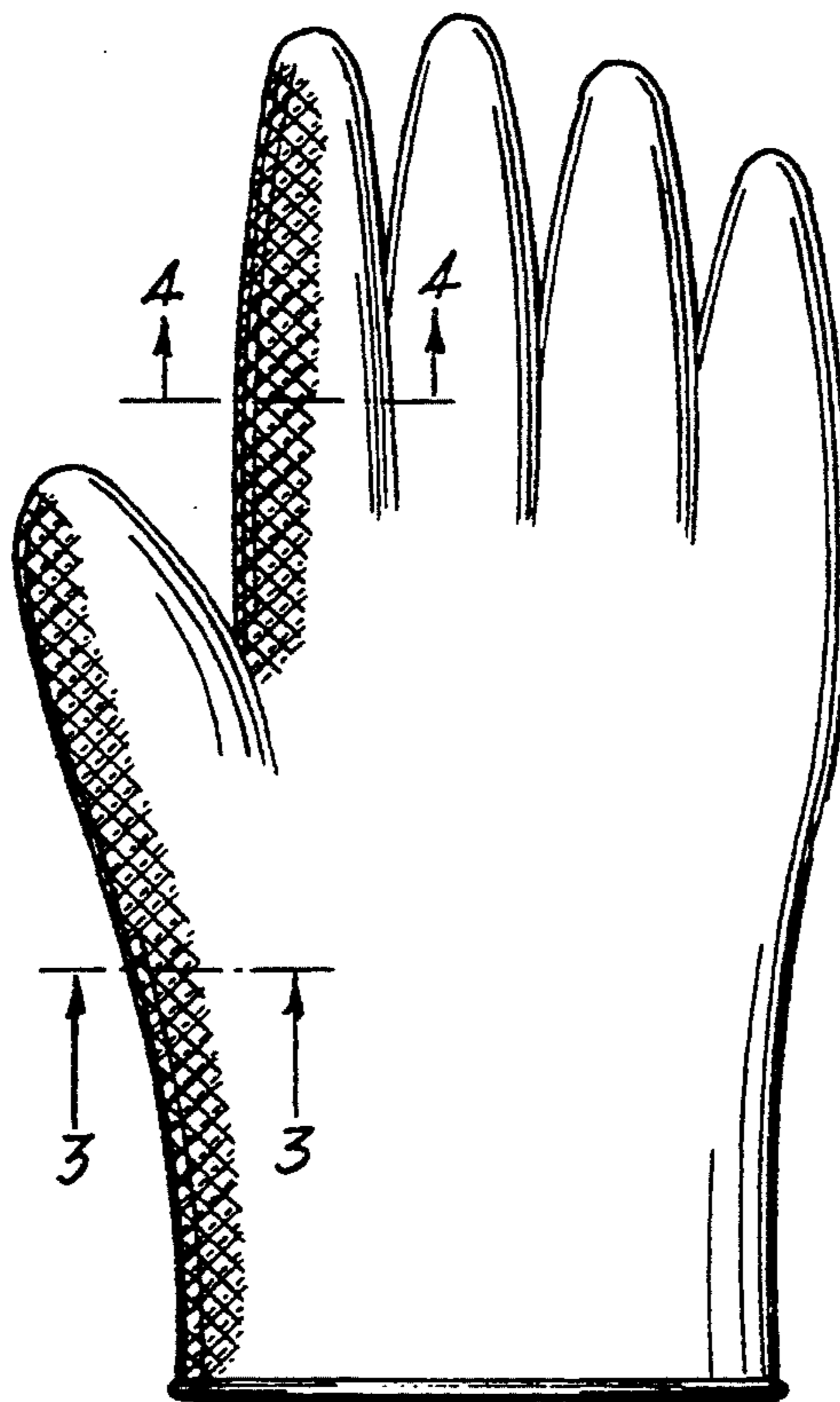

[57] **CLAIM**

The ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a glove showing my new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a fragmentary sectional view taken along line 3—3 of FIG. 1;
 FIG. 4 is a sectional view taken along line 4—4 of FIG. 1;
 FIG. 5 is a fragmentary sectional view taken along line 5—5 of FIG. 2;
 FIG. 6 is a sectional view taken along line 6—6 of FIG. 2; and,
 FIG. 7 is an enlarged partial fragmentary sectional view of FIG. 5.



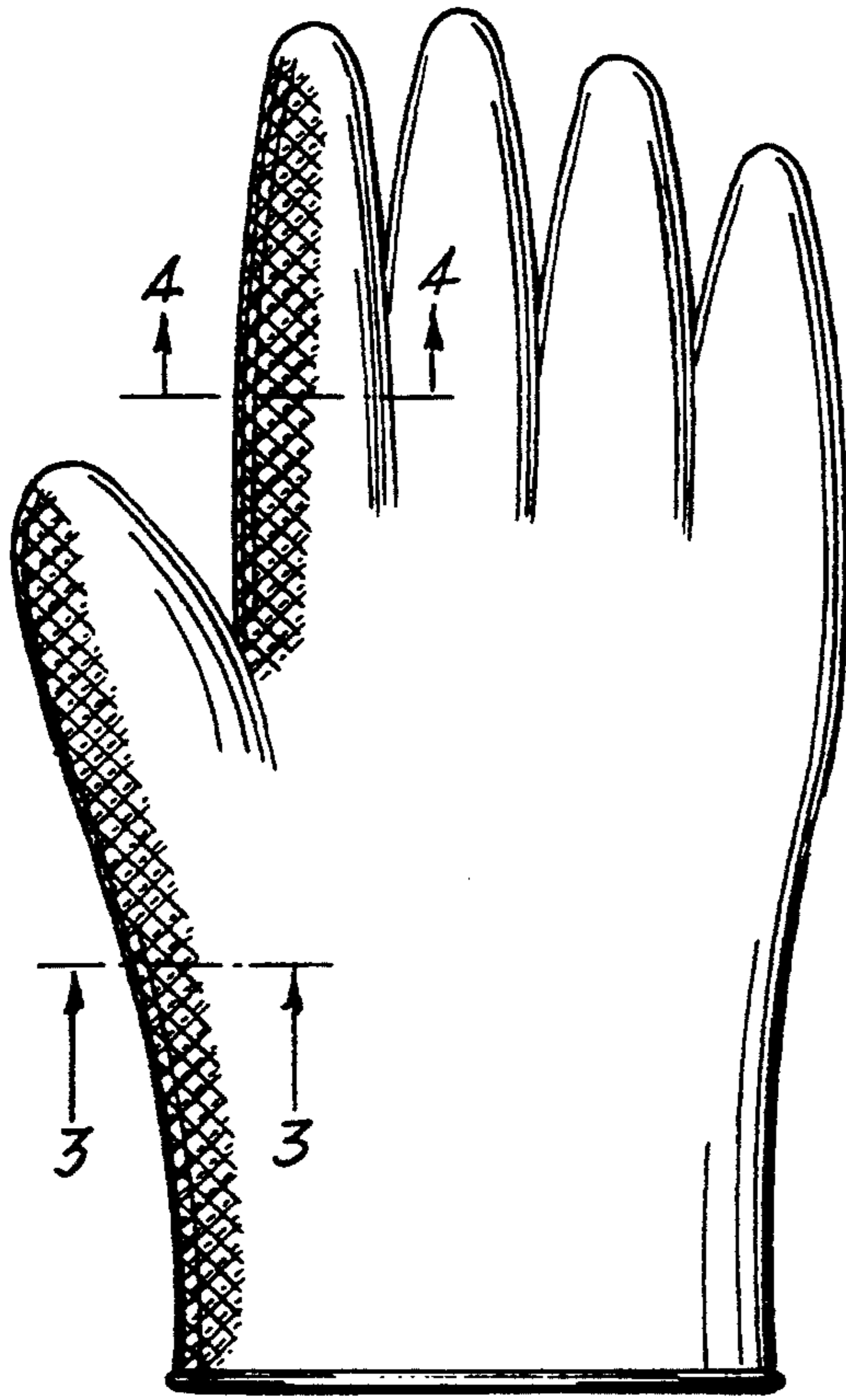

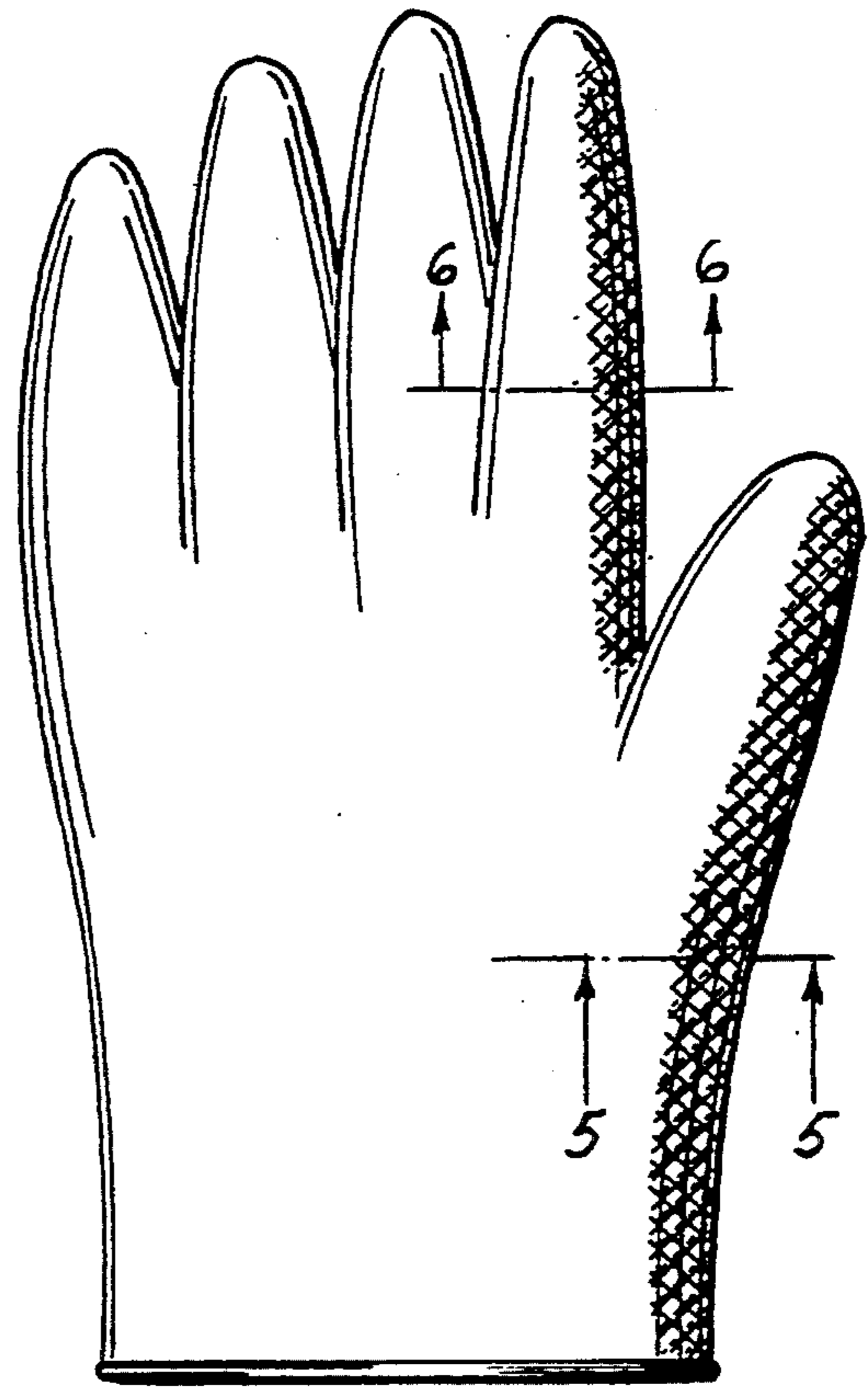

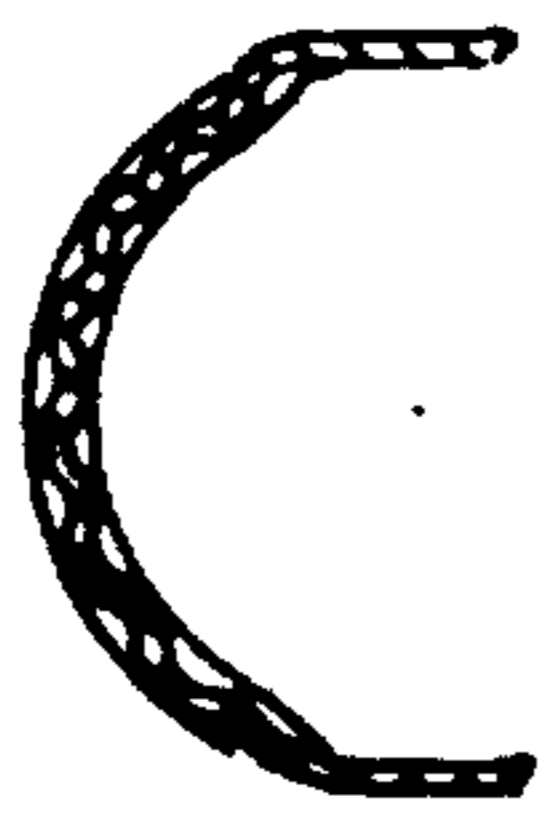

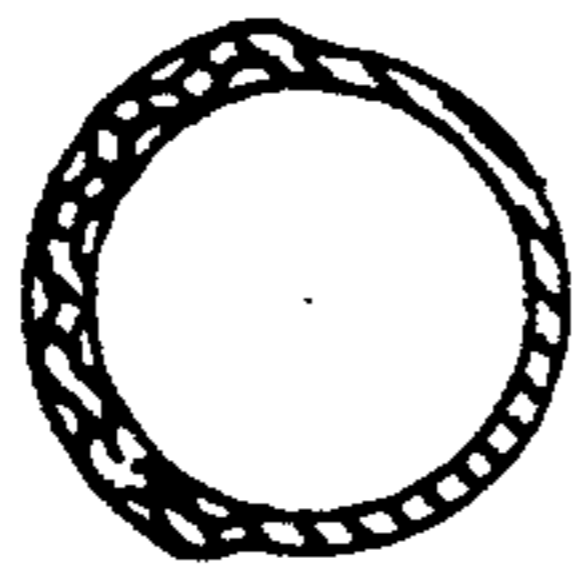

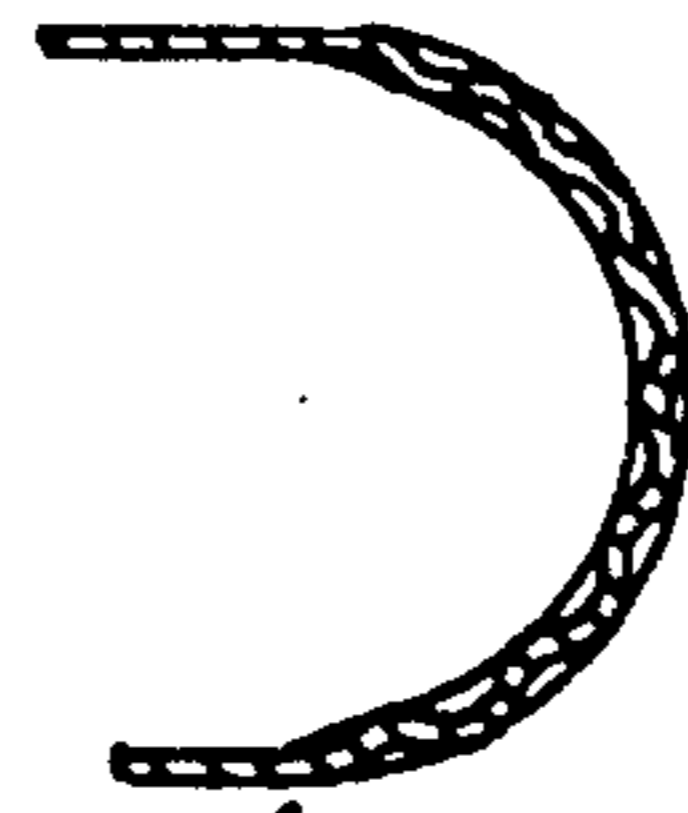

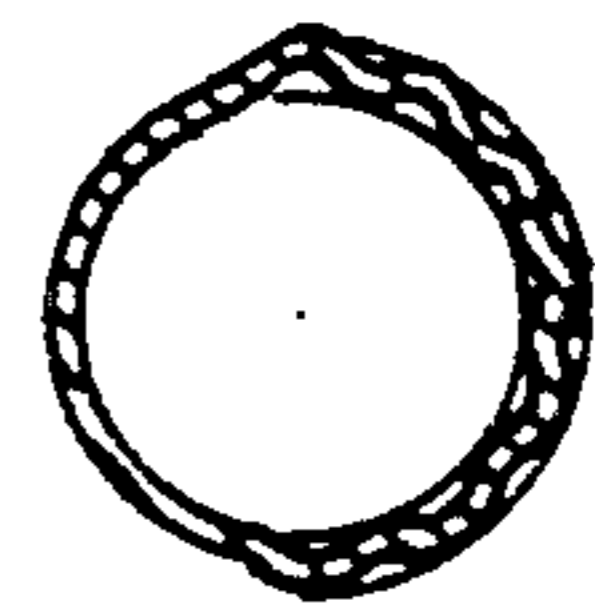
