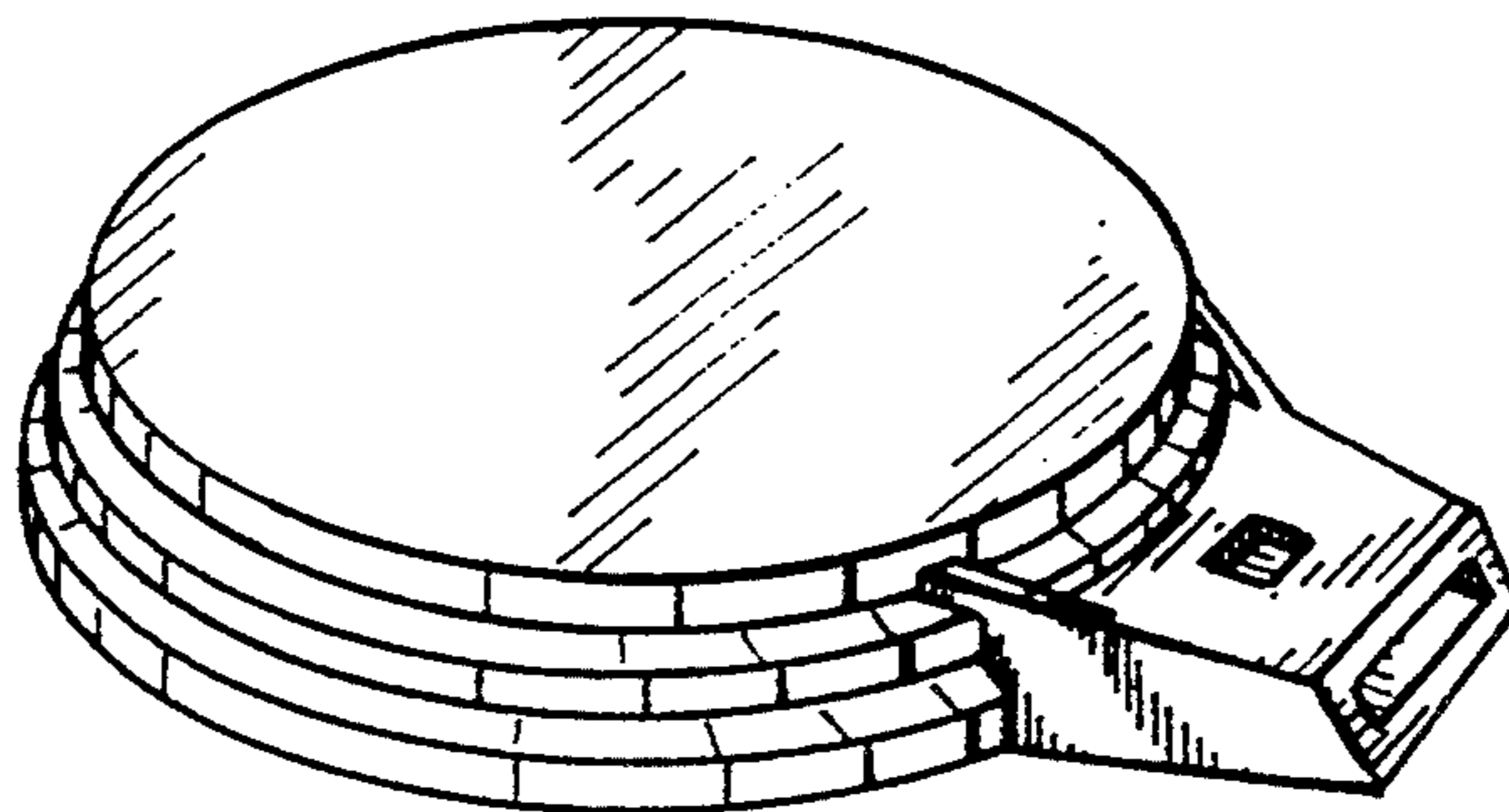

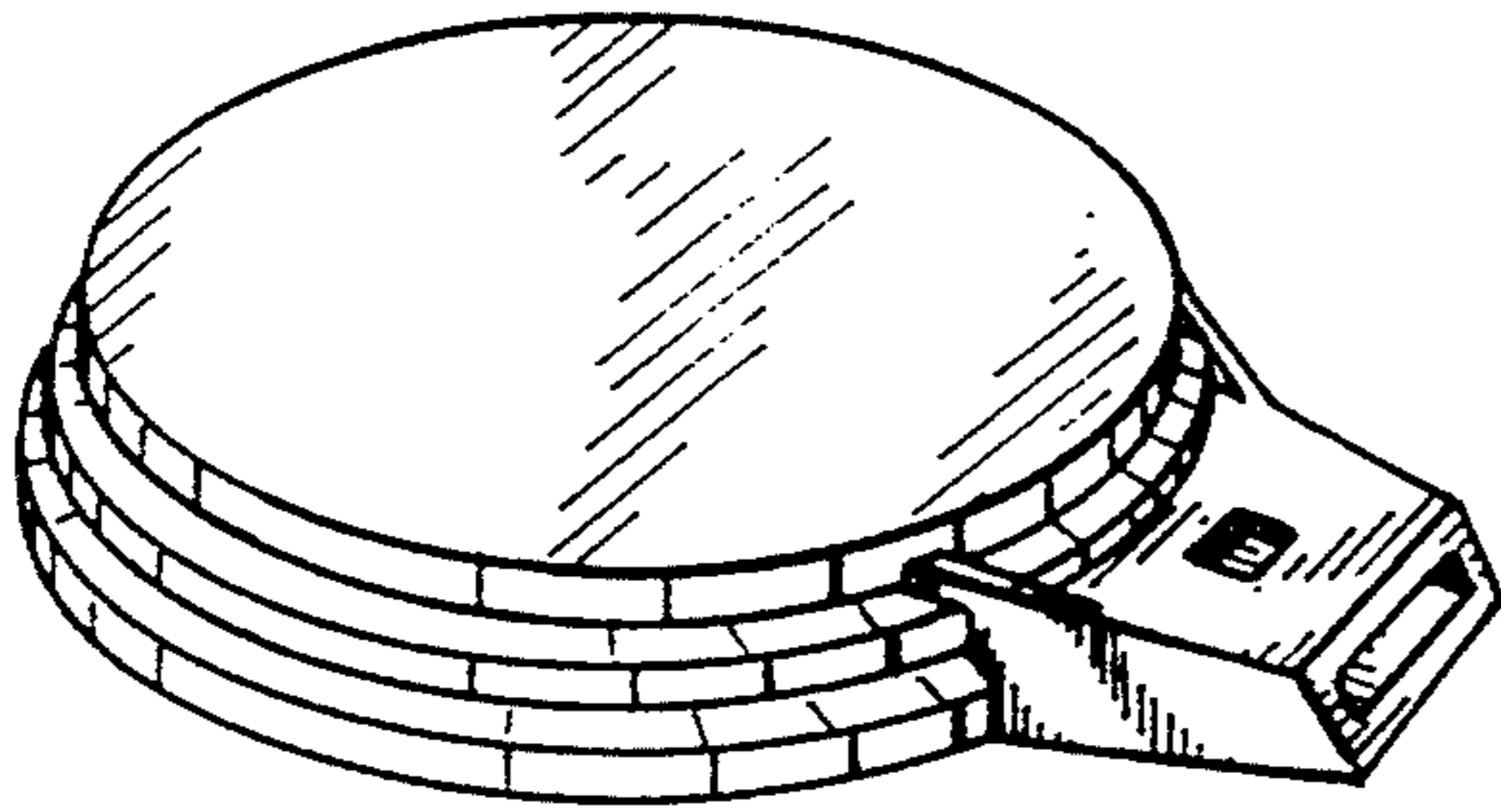
The ornamental design for a combined beverage can opener and cover, as shown and described.

**DESCRIPTION**

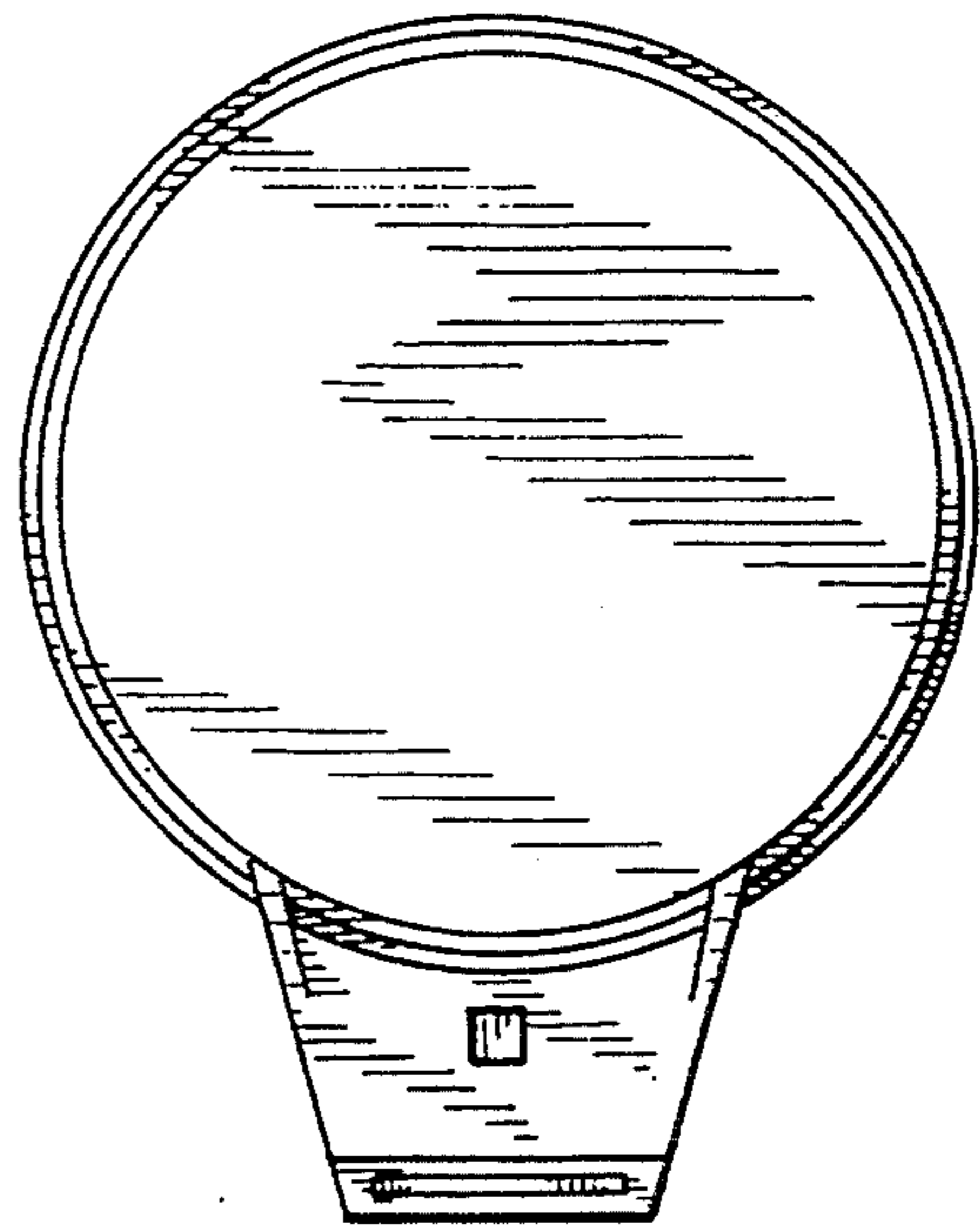
FIG. 1 is a top perspective view of a combined beverage can opener and cover showing my new design; FIG. 2 is a top plan view of FIG. 1; FIG. 3 is a rear elevational view of FIG. 1; FIG. 4 is a front elevational view of FIG. 1; FIG. 5 is a side elevational view of FIG. 1, of which the other side elevational view is a mirror image; and, FIG. 6 is a bottom plan view of FIG. 1.



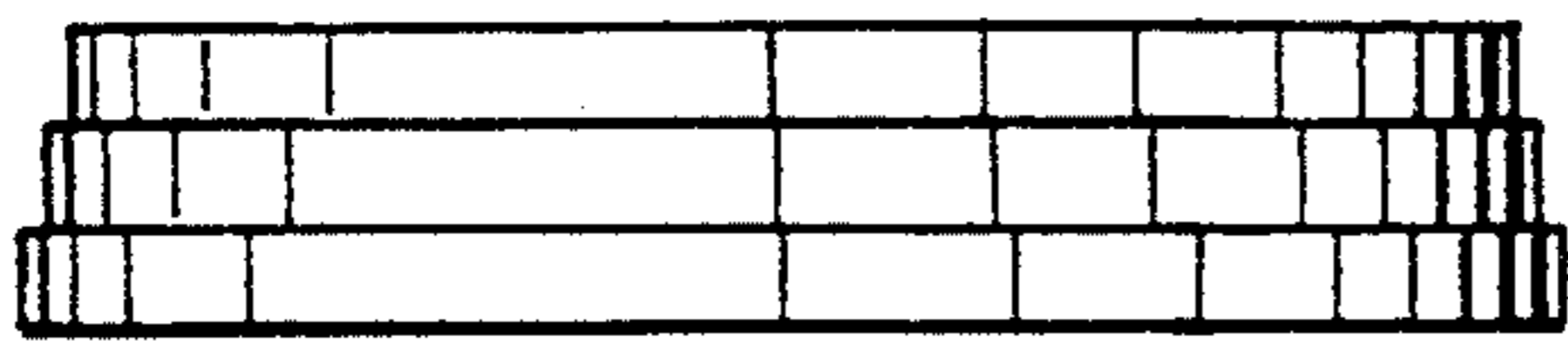

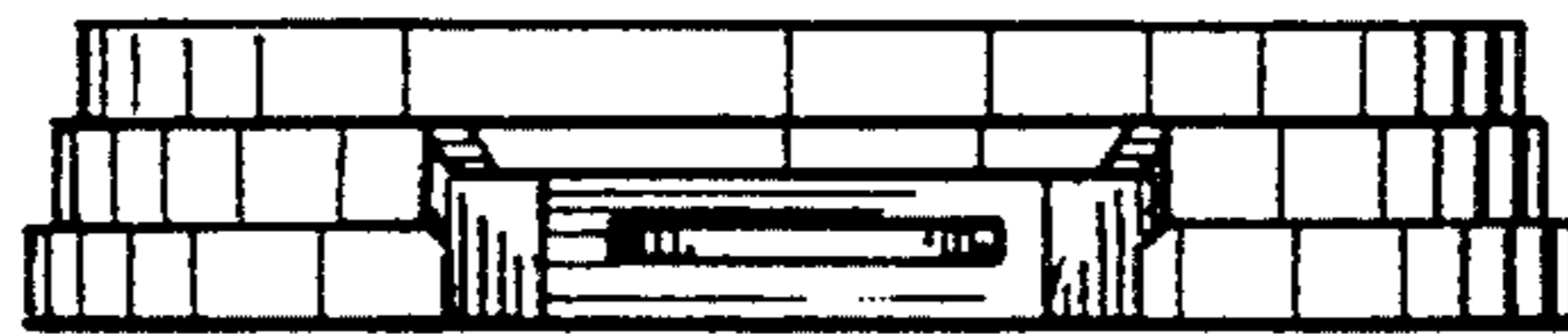
