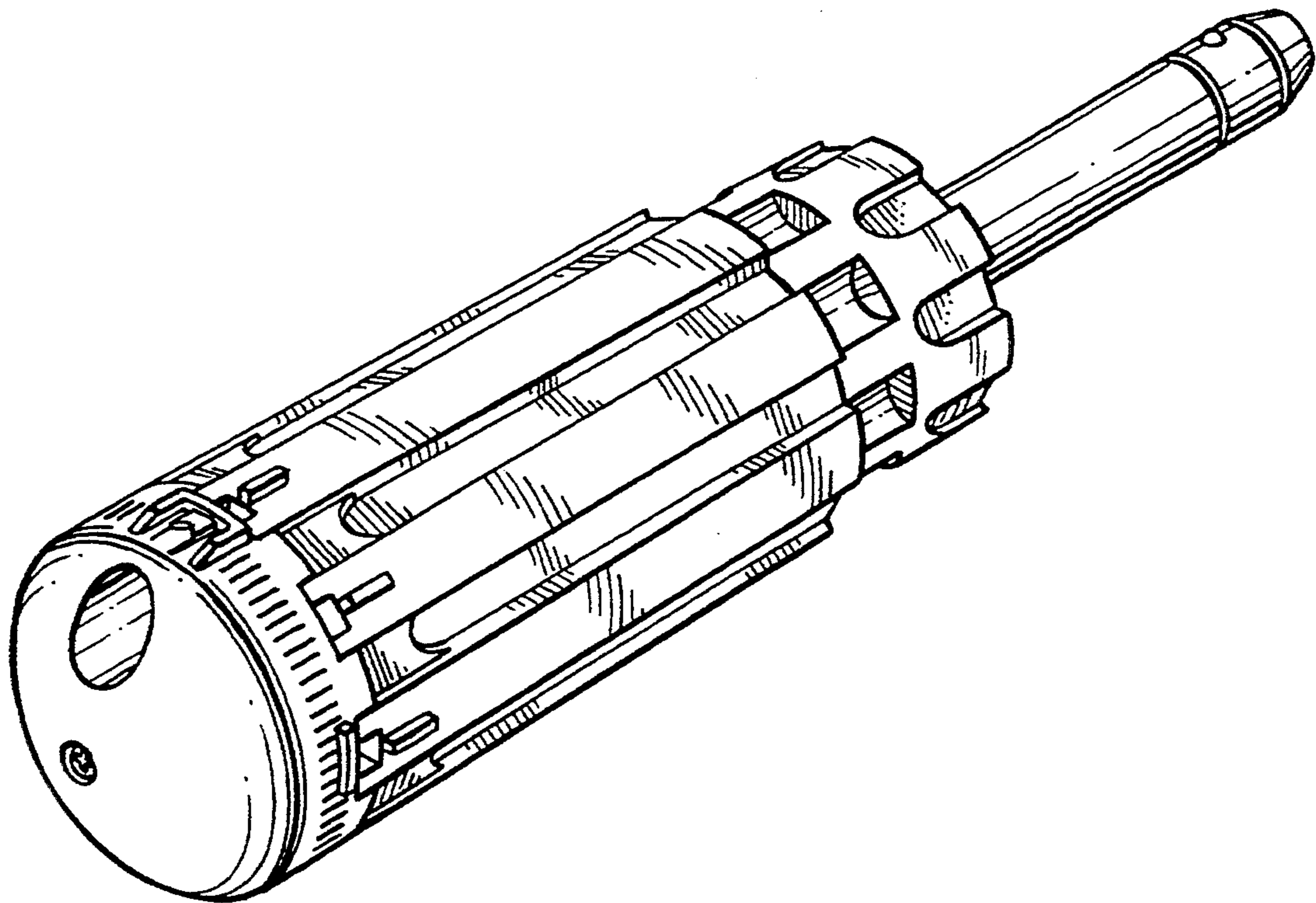

The ornamental design for a screwdriver, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front elevation view of the design;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a rear elevation view thereof;  
 FIG. 6 is a right side elevation view thereof;  
 FIG. 7 is a left side elevation view thereof;  
 FIG. 8 is a front elevation view of a modified embodiment of the design shown in FIGS. 1-7;  
 FIG. 9 is a front elevation view of yet another modified embodiment of the design shown in FIGS. 1-7;  
 FIG. 10 is a right side elevation view of the modified embodiment of FIG. 8;  
 FIG. 11 is a left side elevation view of the modified embodiment of FIG. 8;

 FIG. 15 is a rear elevation view of the modified embodiment of FIG. 9.



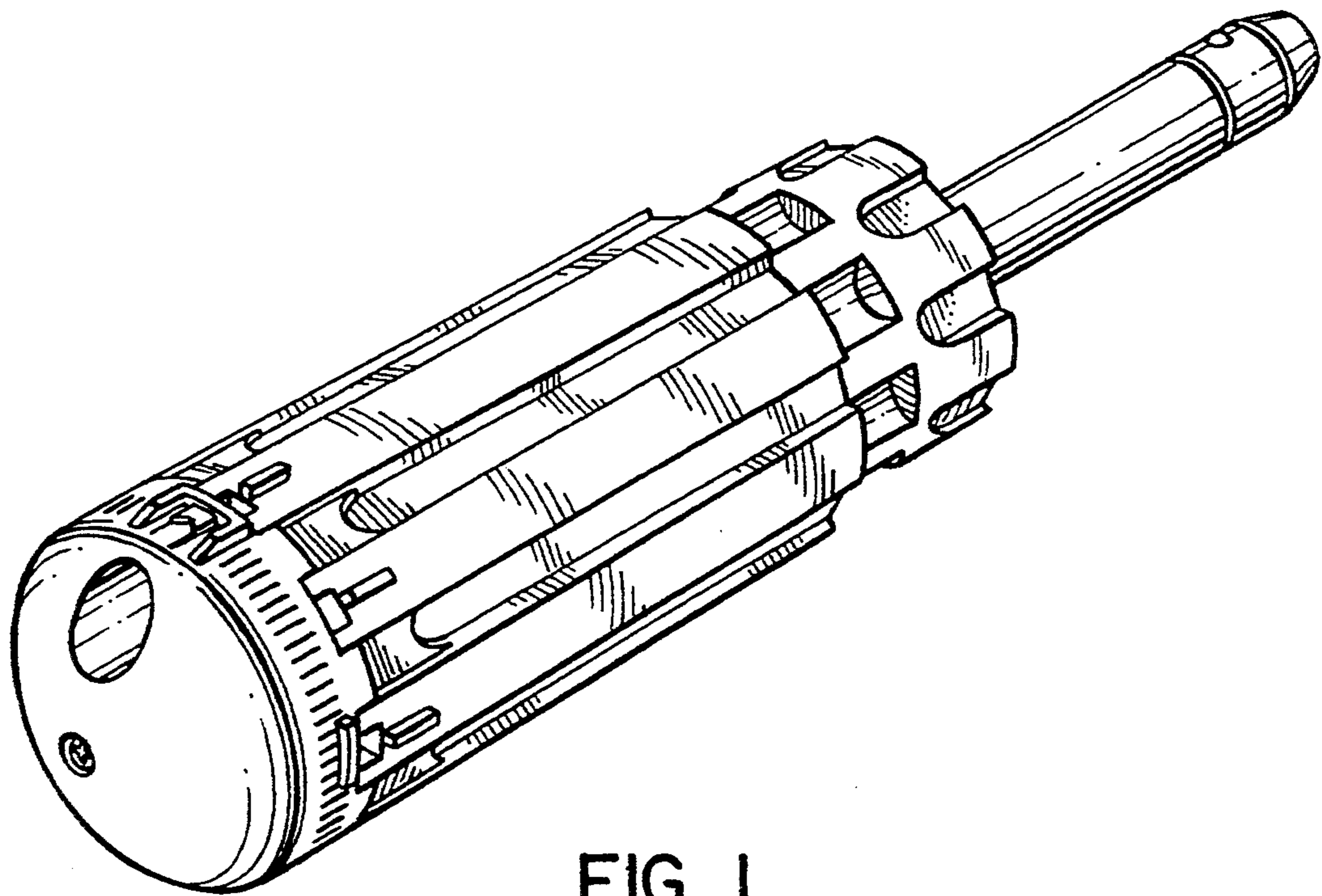

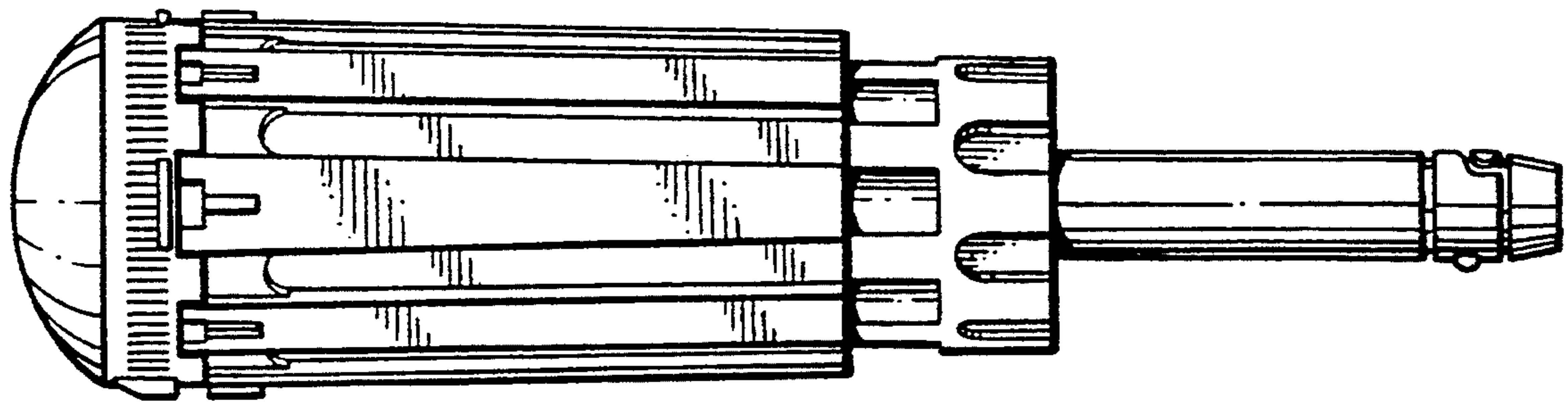

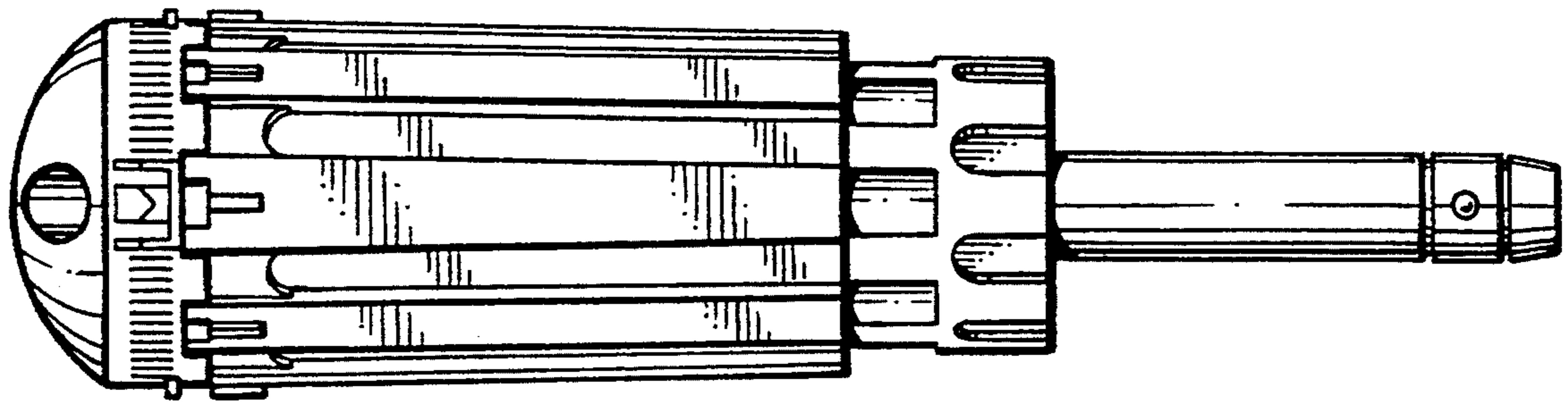

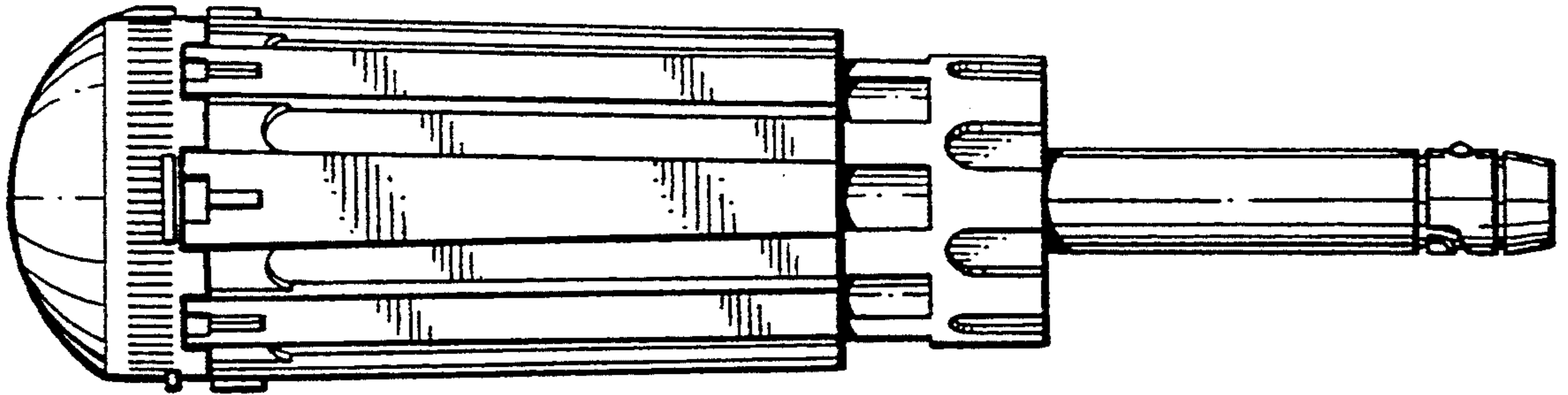

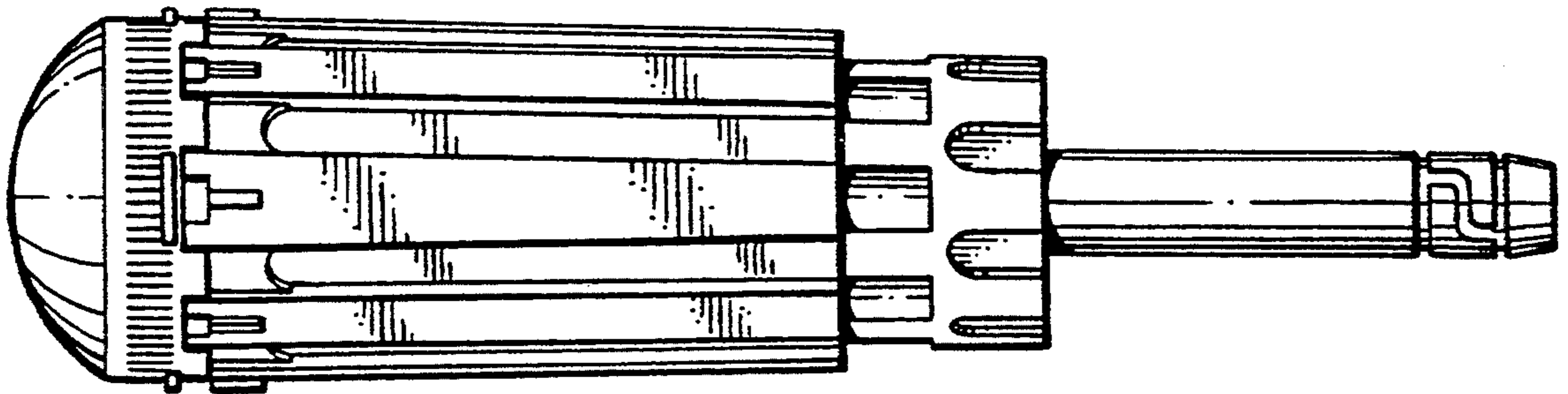

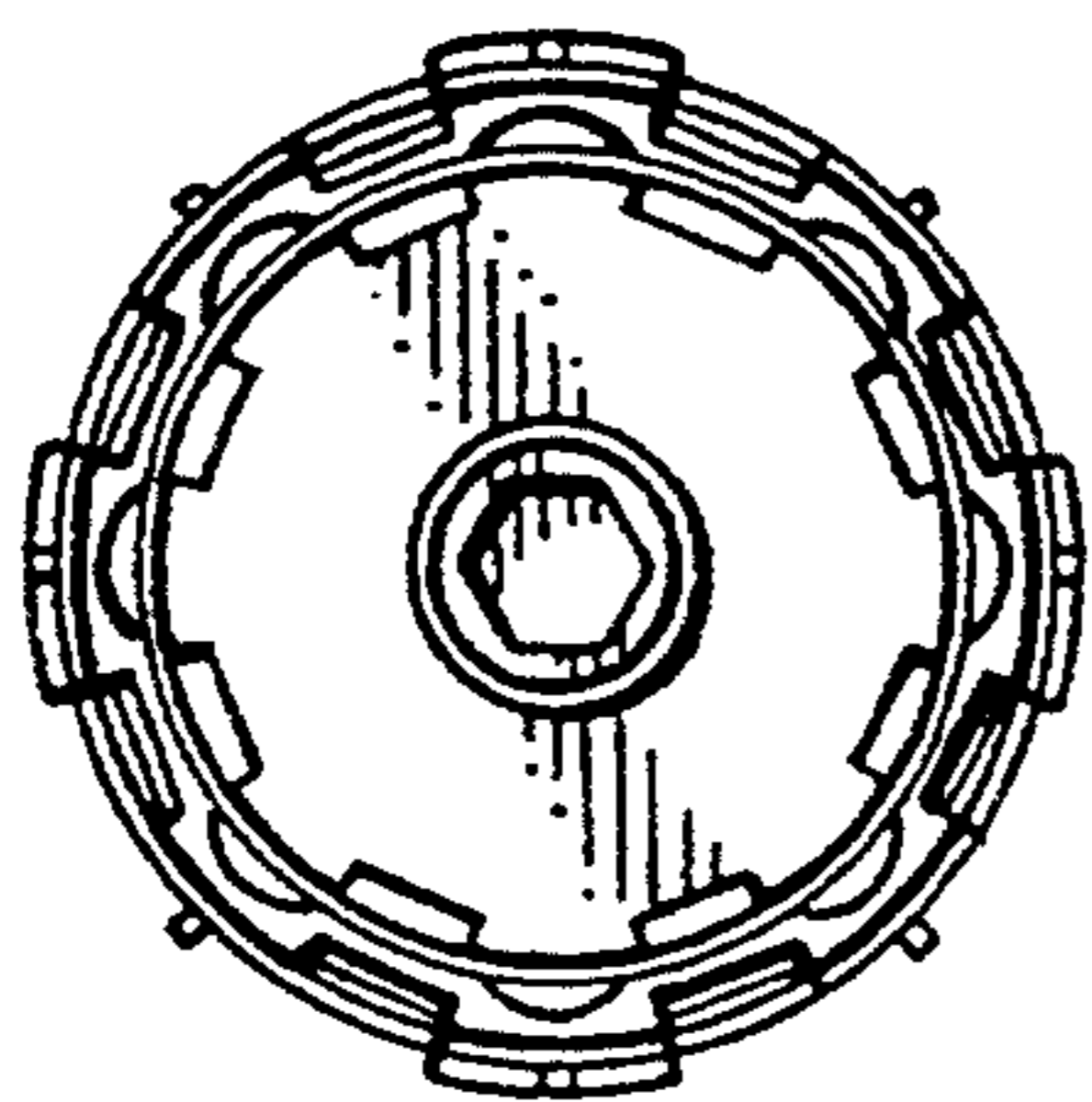

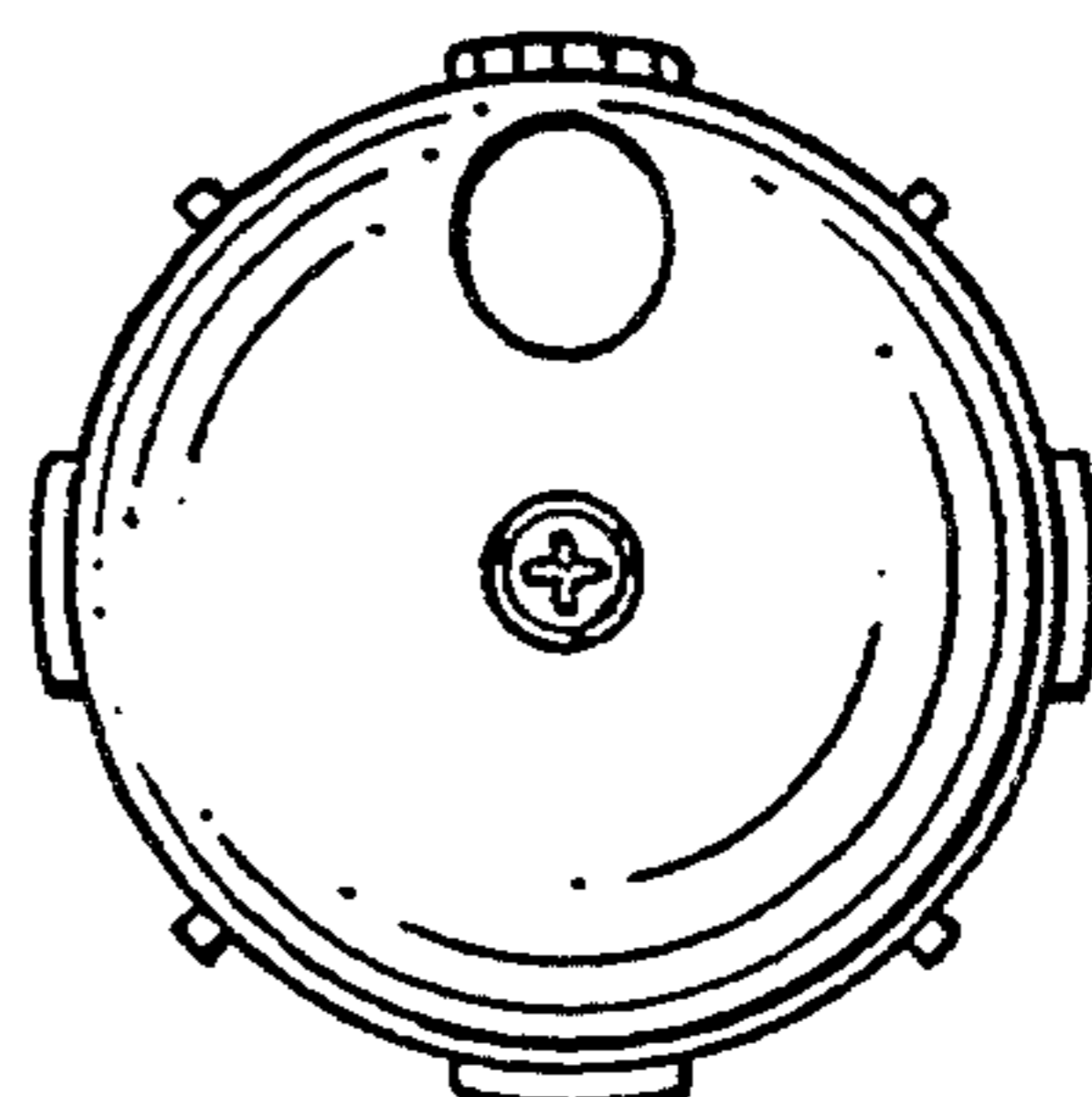

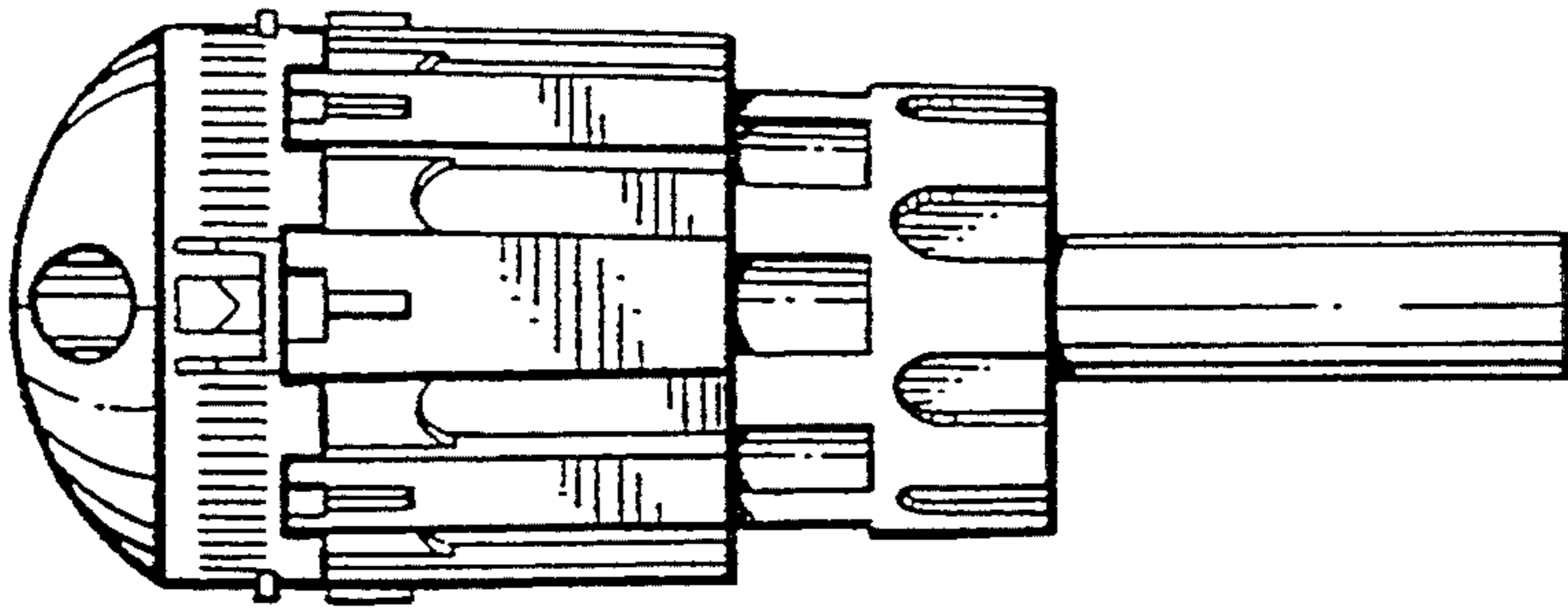

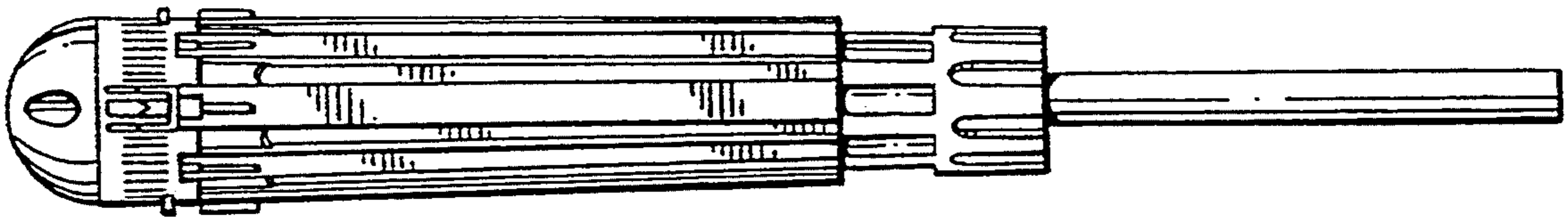

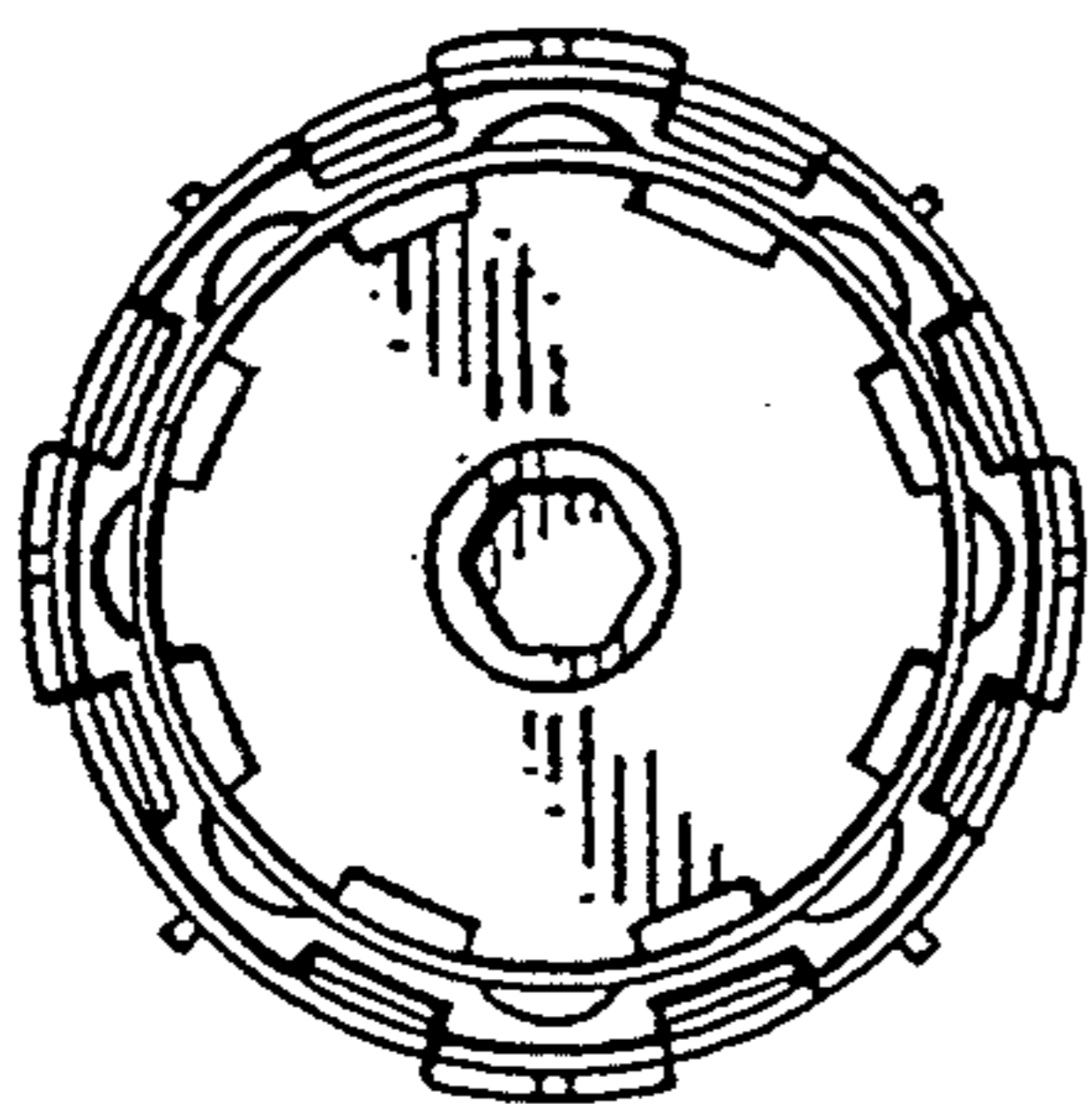

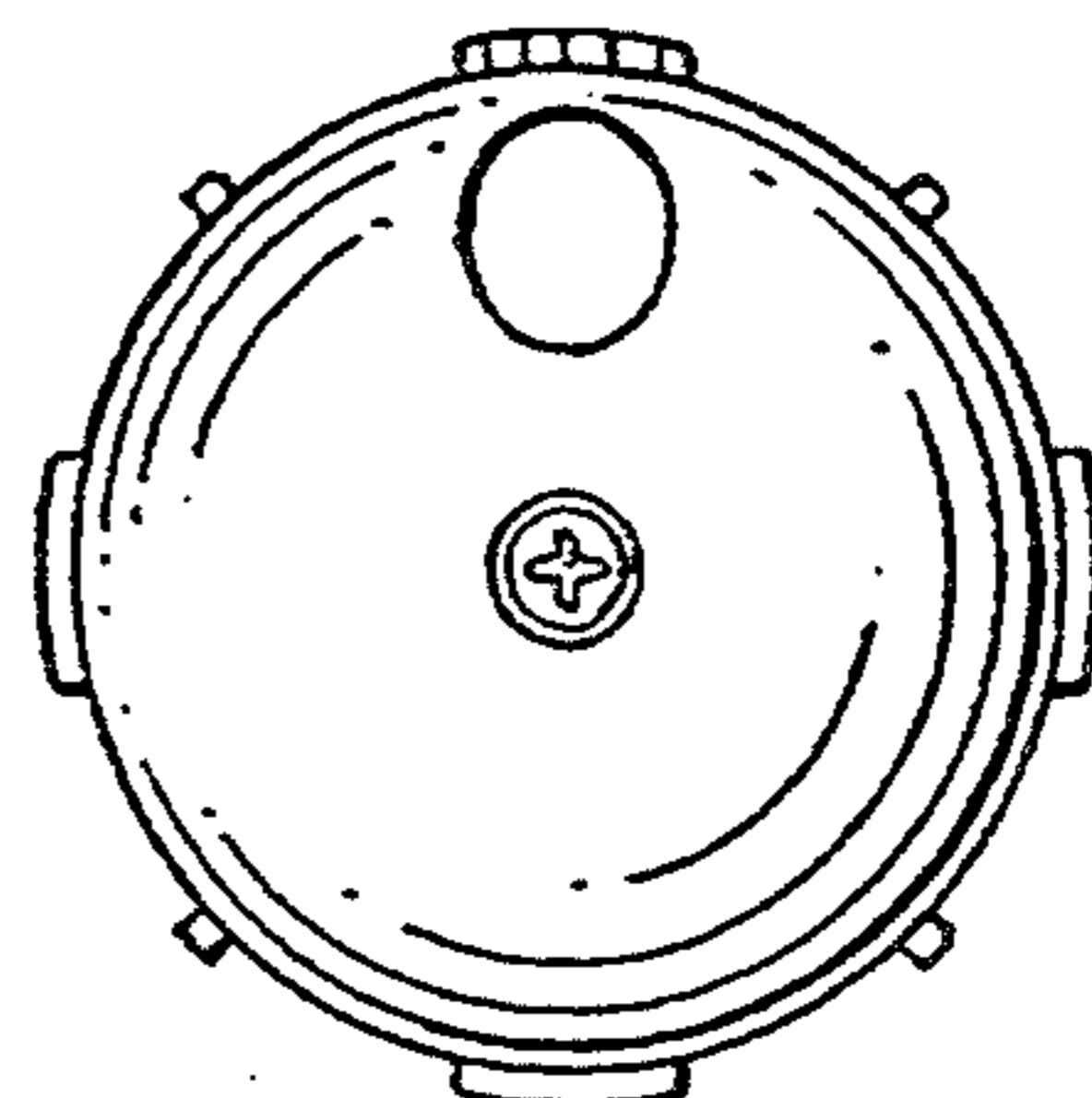

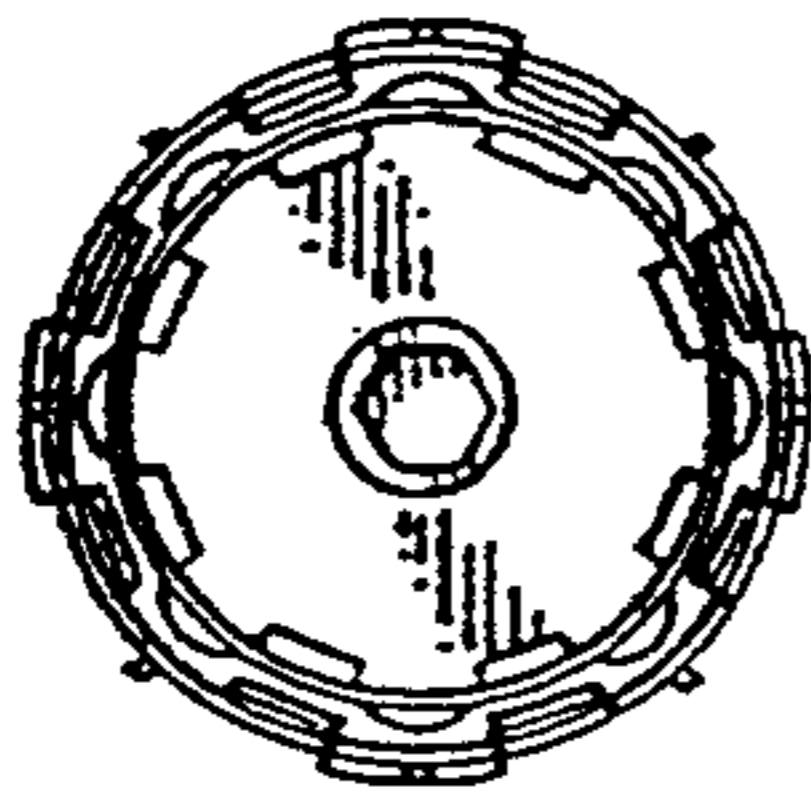

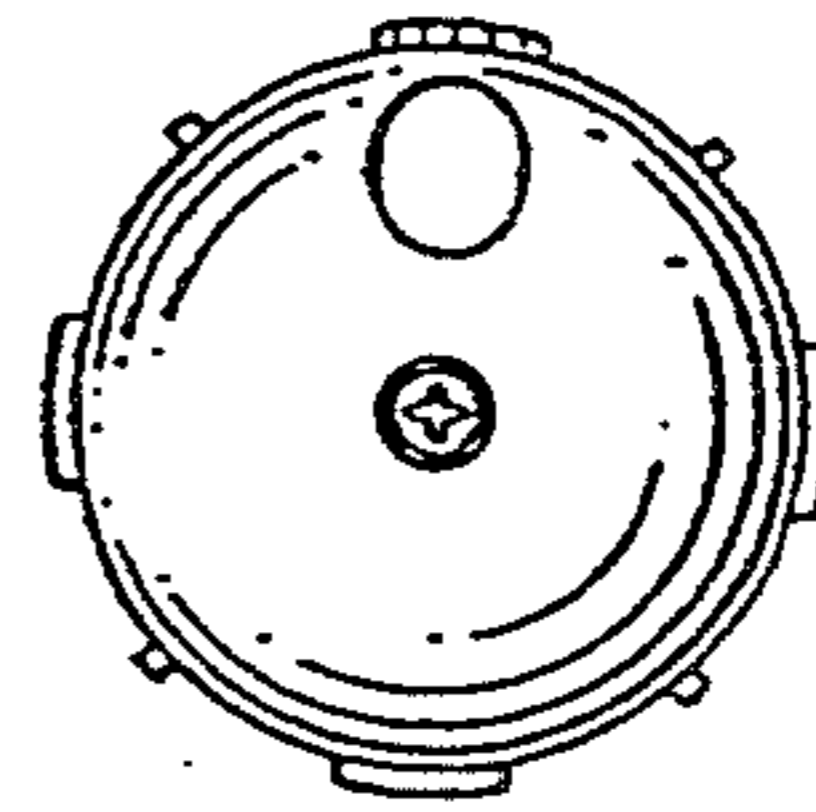

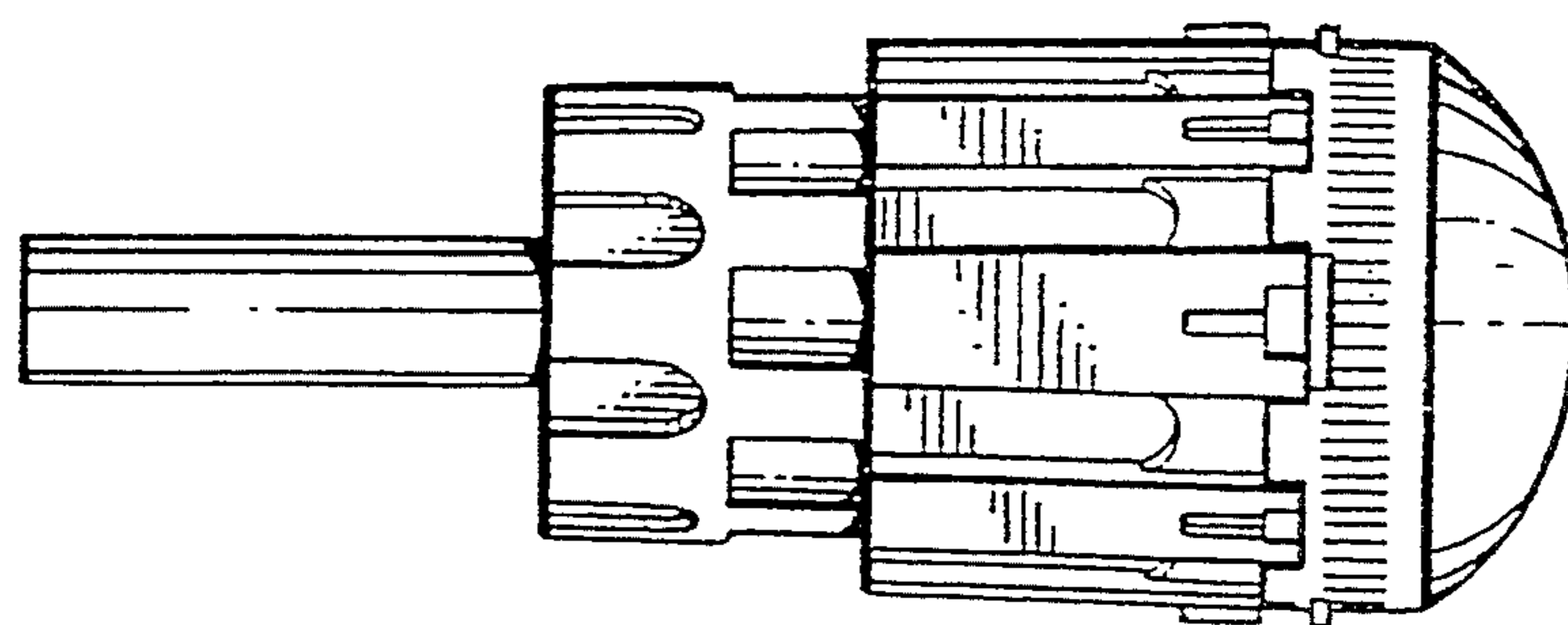

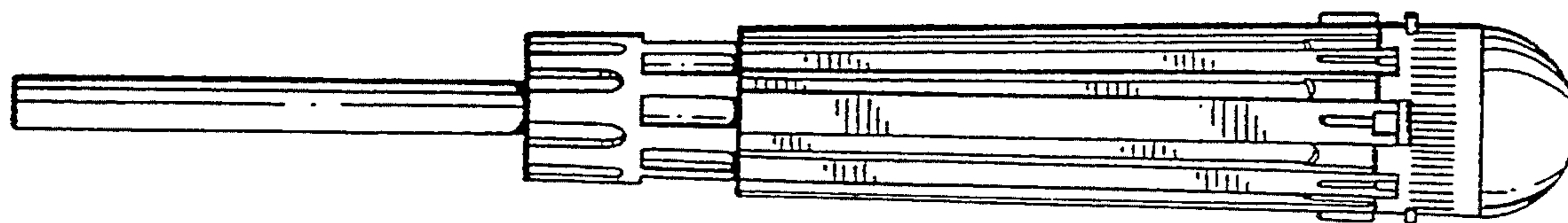
