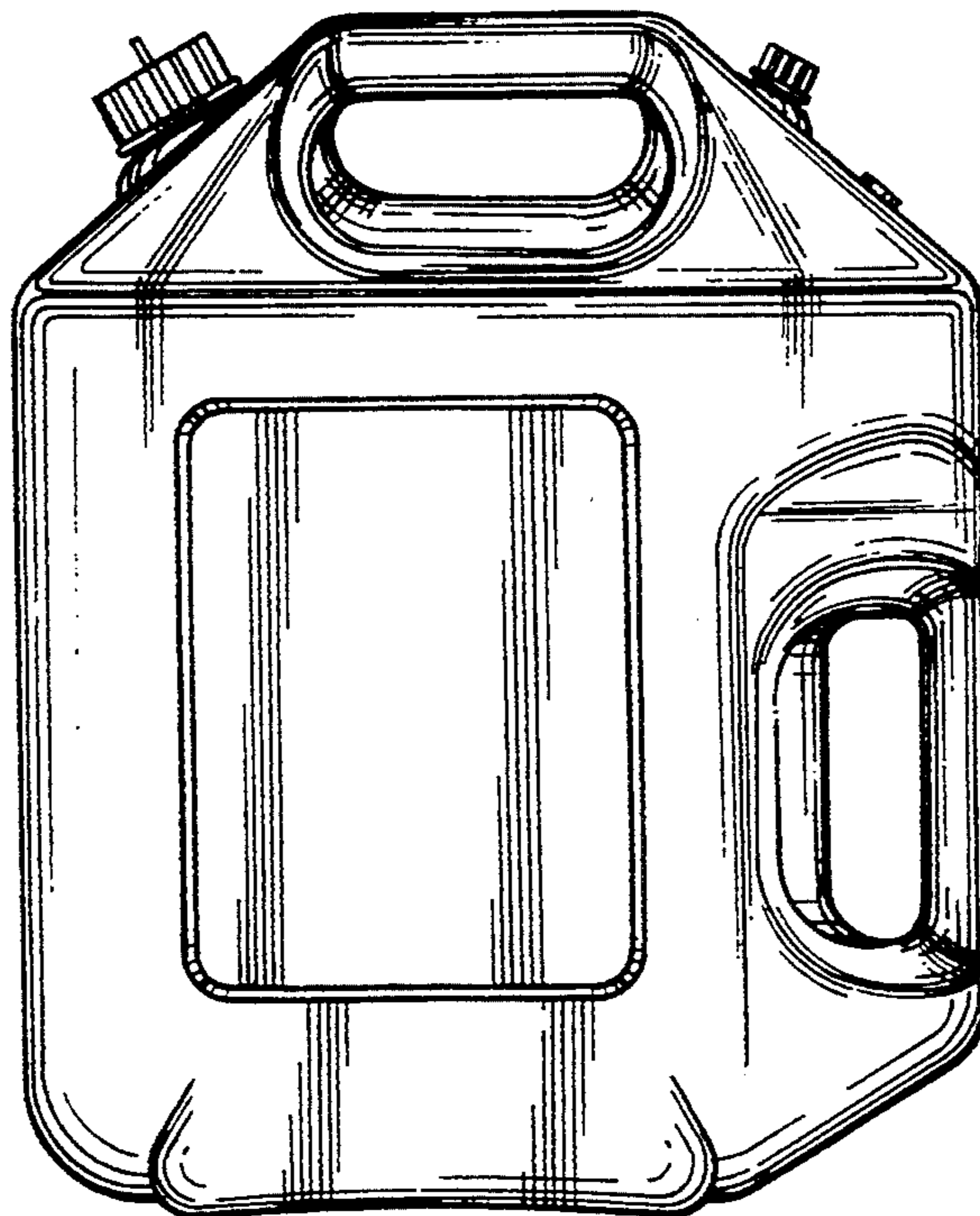

The ornamental design for a container for gasoline, as shown and described.

### DESCRIPTION

FIG. 1 is a right side and rear perspective view of a container for gasoline showing my new design;  
 FIG. 2 is a right side elevation, the left side elevation is a mirror image thereto;  
 FIG. 3 is a rear elevation thereof;  
 FIG. 4 is a front elevation thereof;  
 FIG. 5 is a top plan view thereof; and,  
 FIG. 6 is a bottom plan view thereof.



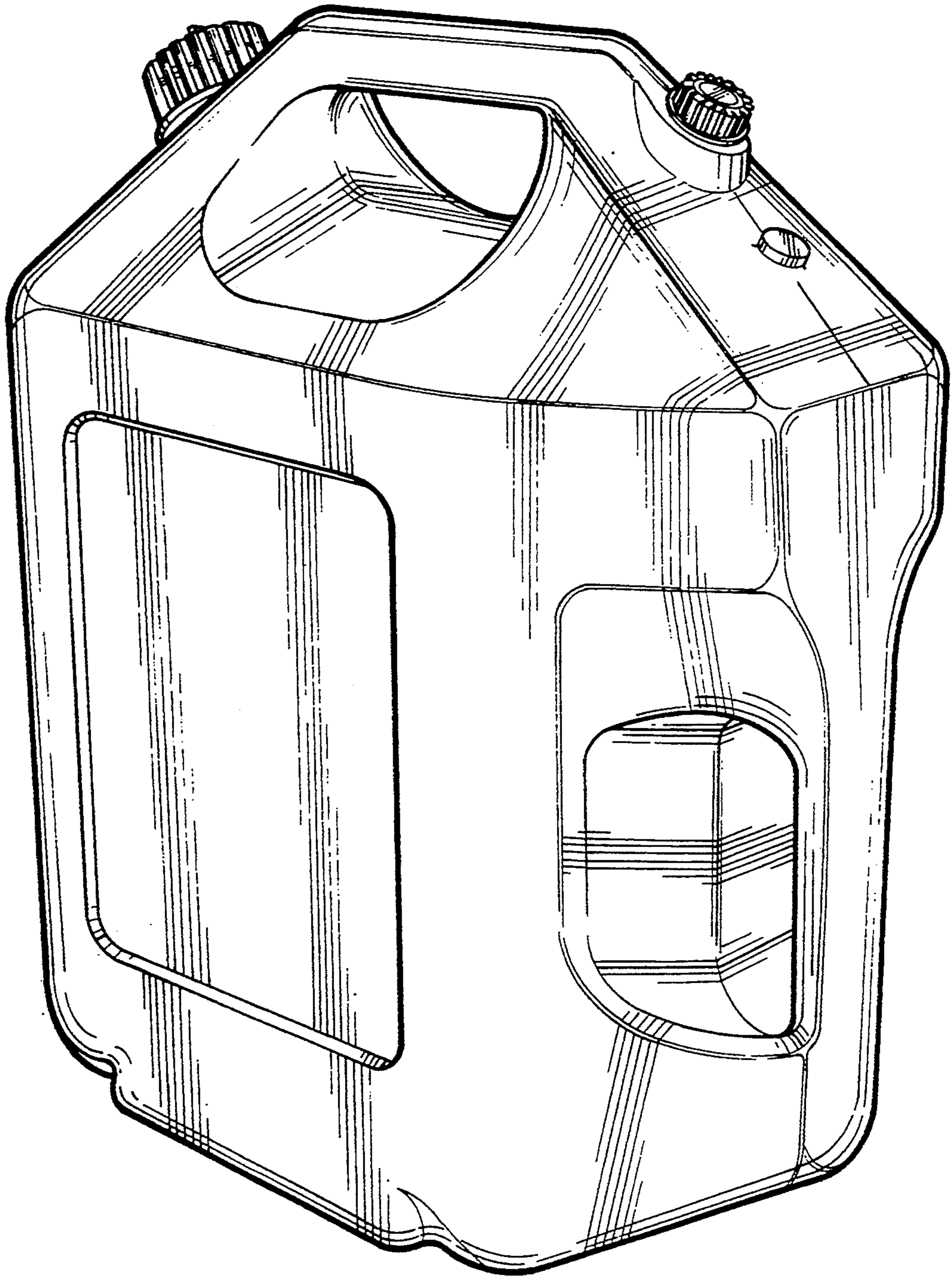

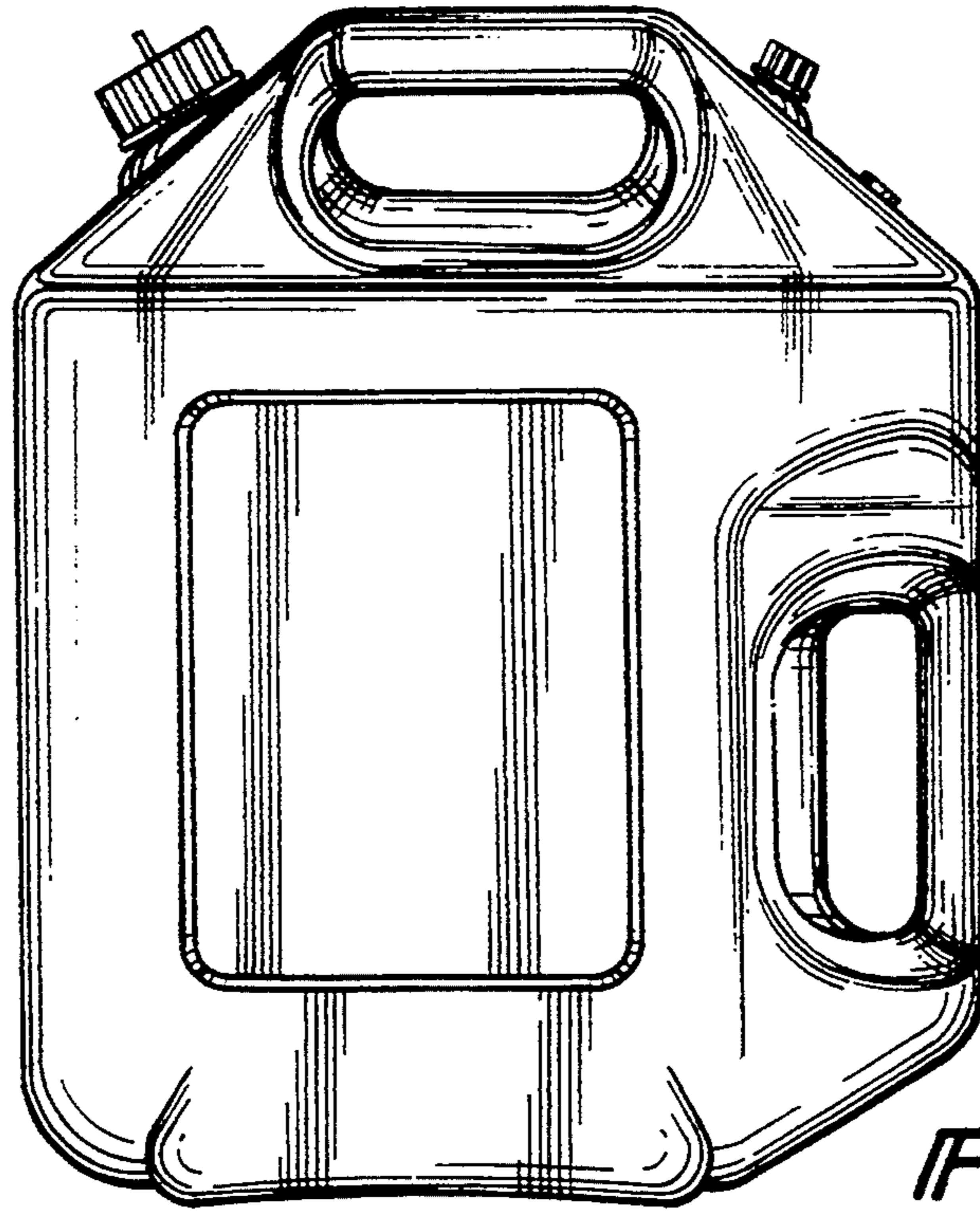

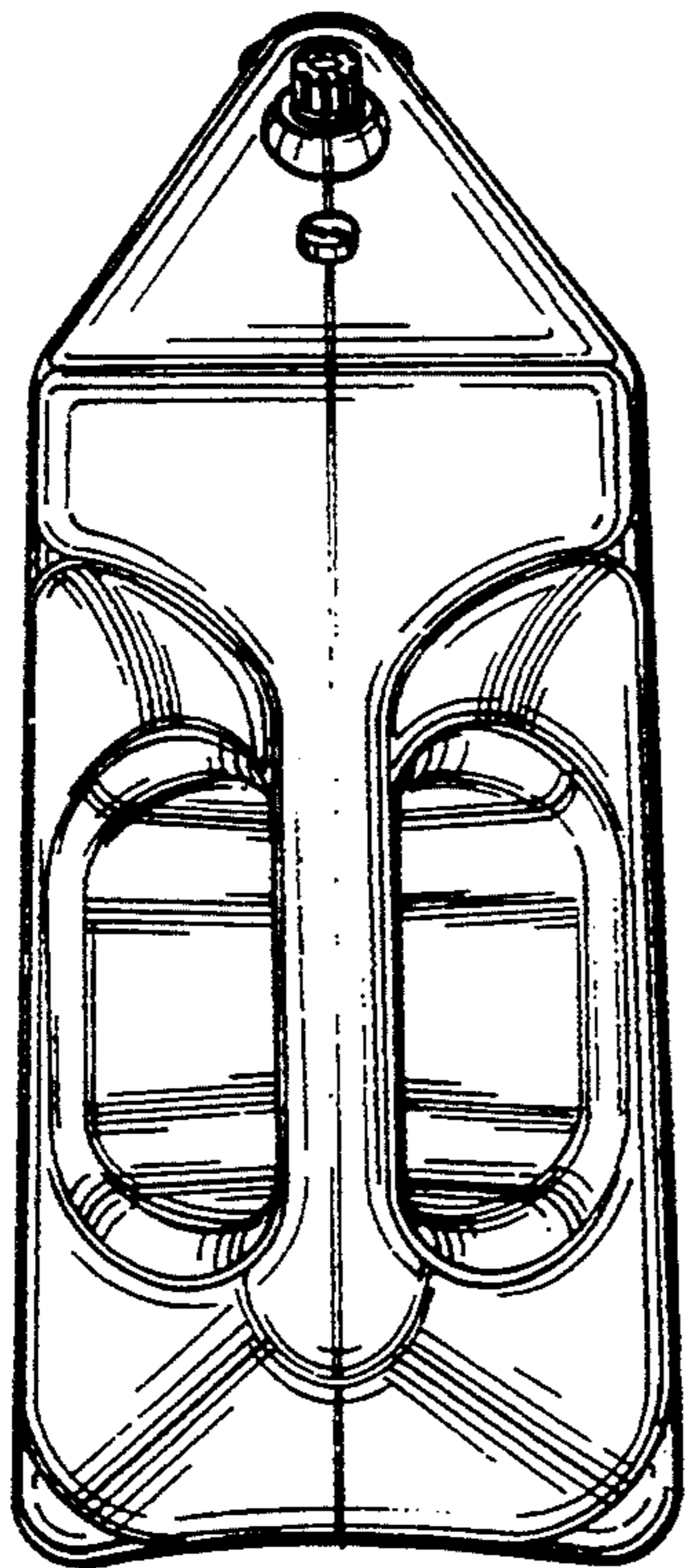

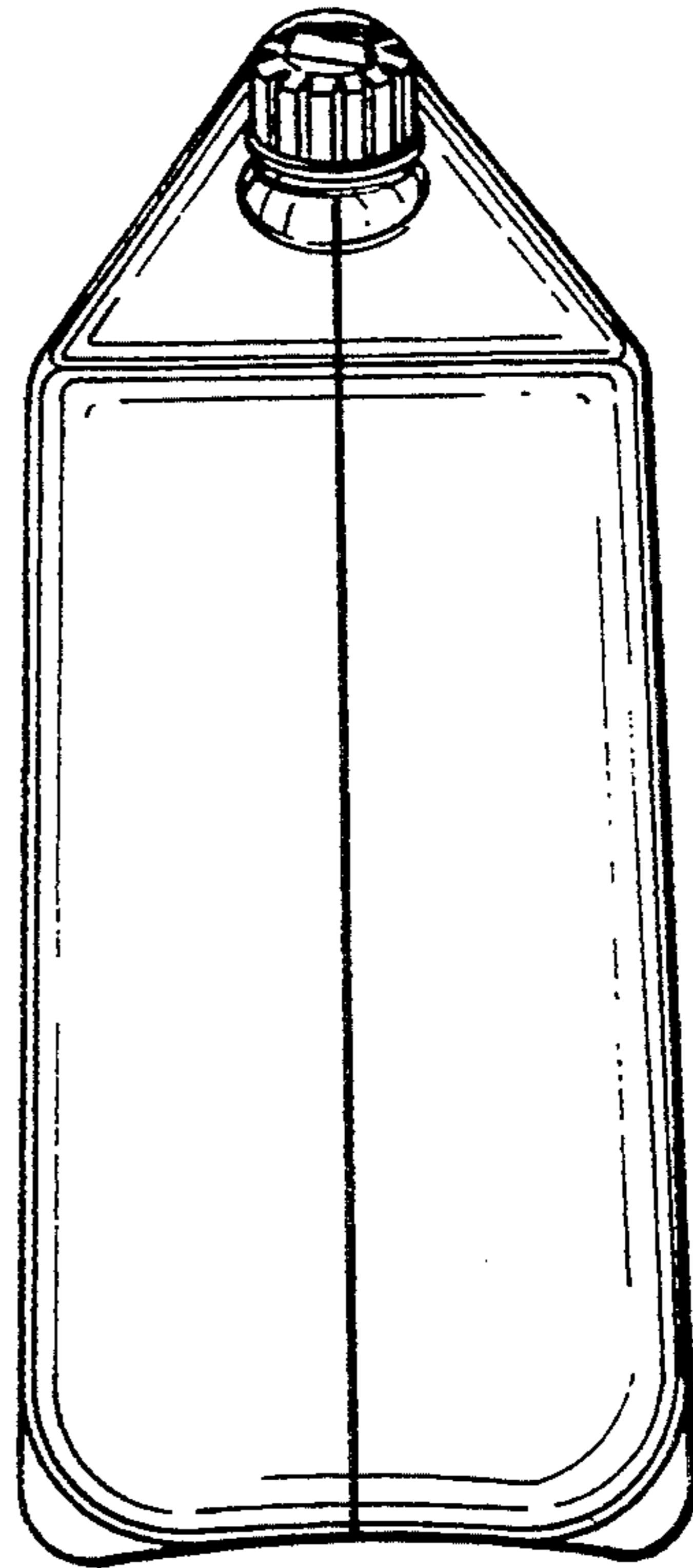

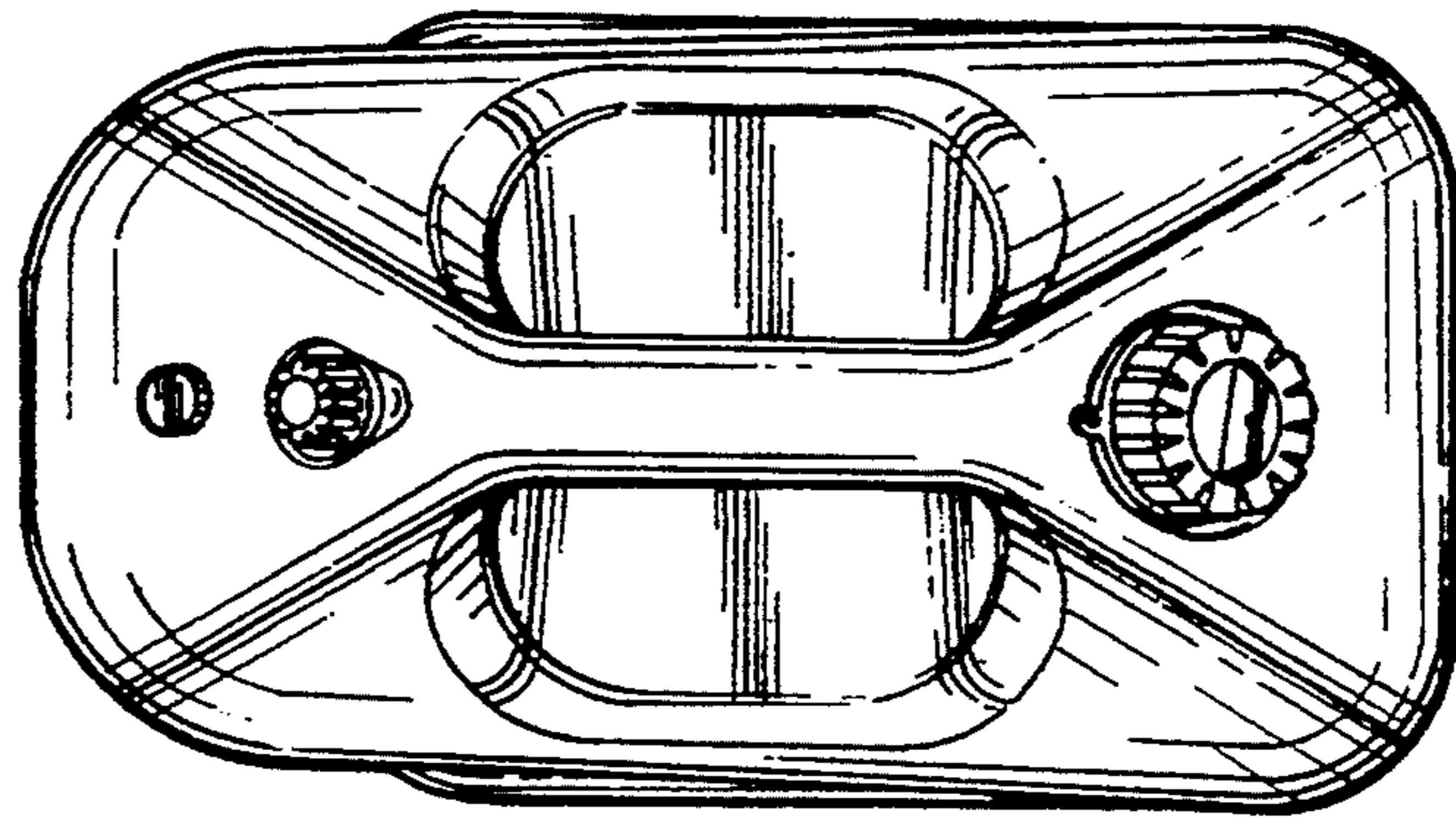

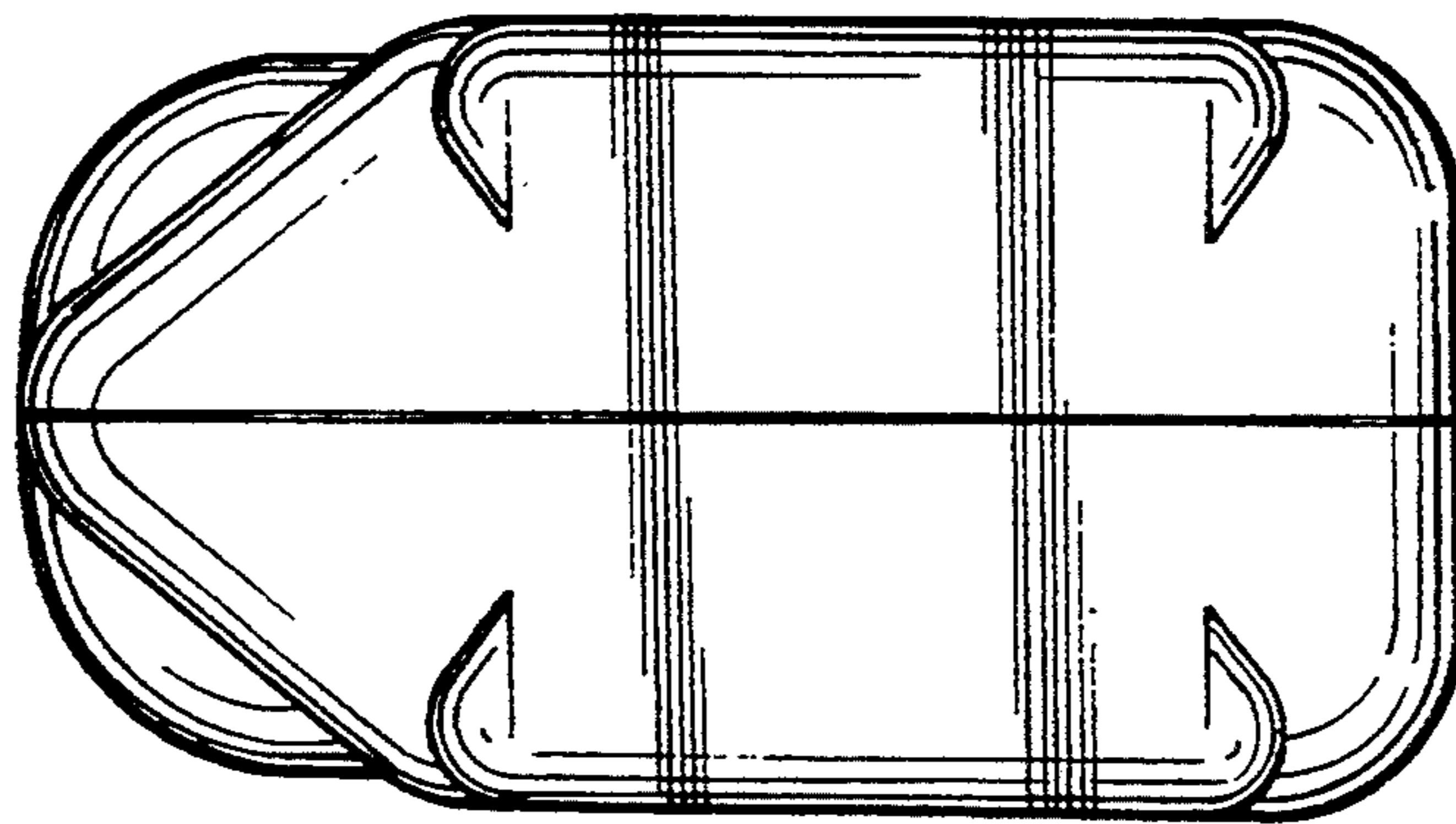
