[57] CLAIM

The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a seat showing our new design in the form of a sofa;

FIG. 2 is a left side elevational view thereof on a smaller scale, the right side being a mirror image thereof;

FIG. 3 is a top plan view thereof on a smaller scale;

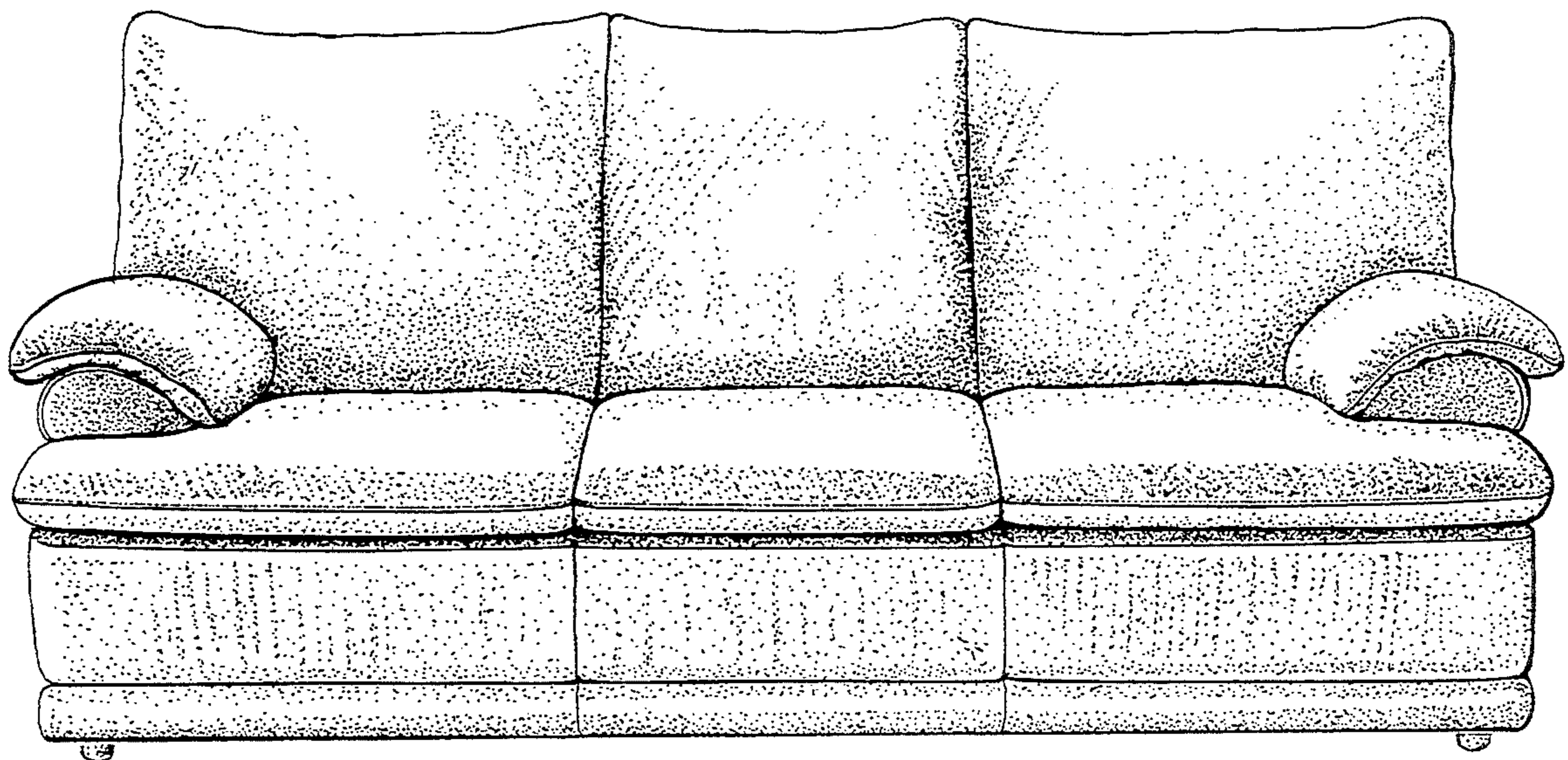
FIG. 4 is a perspective view of a seat showing our new design in the form of a chair;

FIG. 5 is a left side elevational view on a smaller scale, the right side being a mirror image thereof; and,

FIG. 6 is a top plan view thereof on a smaller scale.

The rear view of the present design is plain and unornamental.

The characteristic feature of our design resides in the appearance of the armrest which in front elevation appears oval and in side elevation appears wedge-shaped and which cooperates with overlying arm cushions so that the armrest has an upward and forward incline from the backrest when viewed from the side.



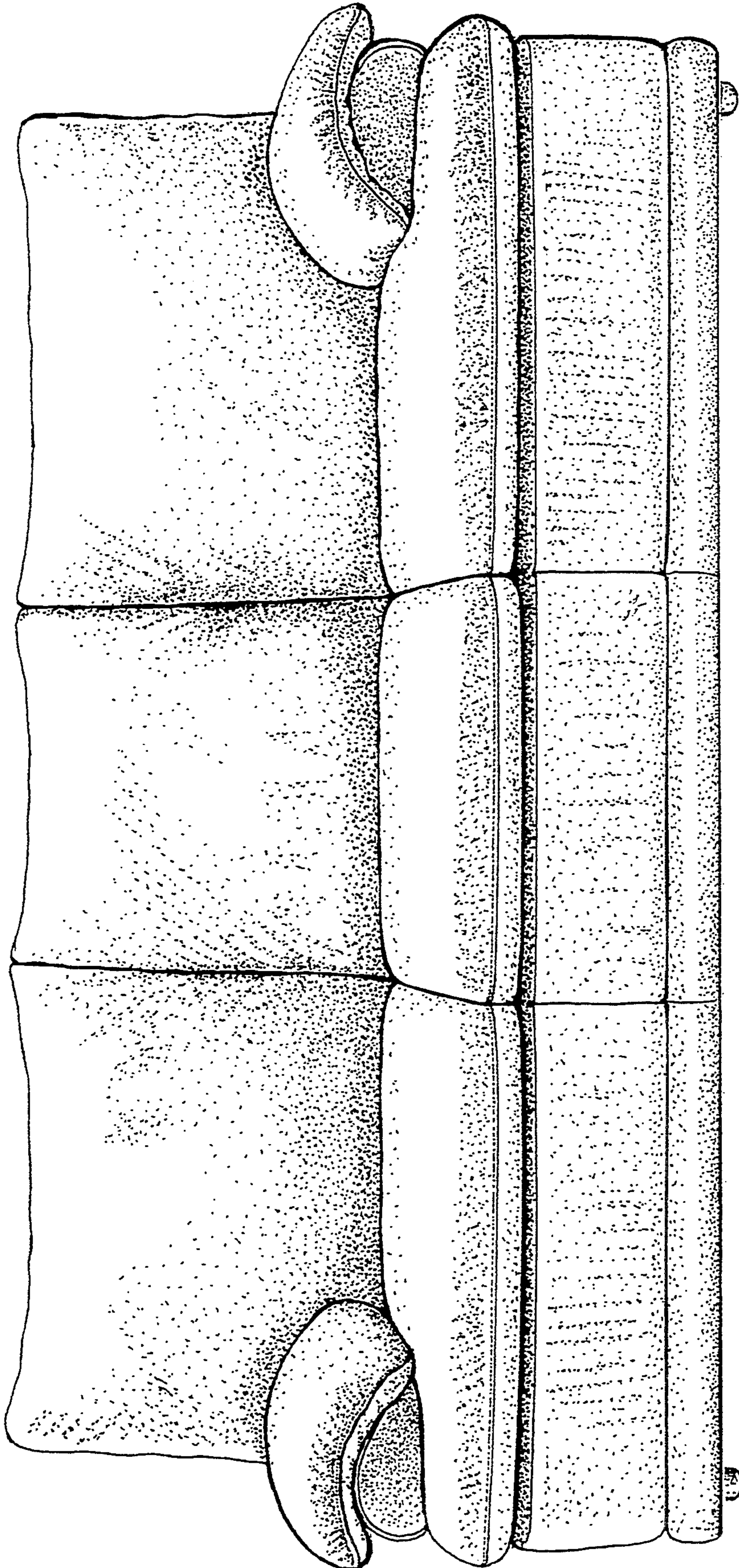

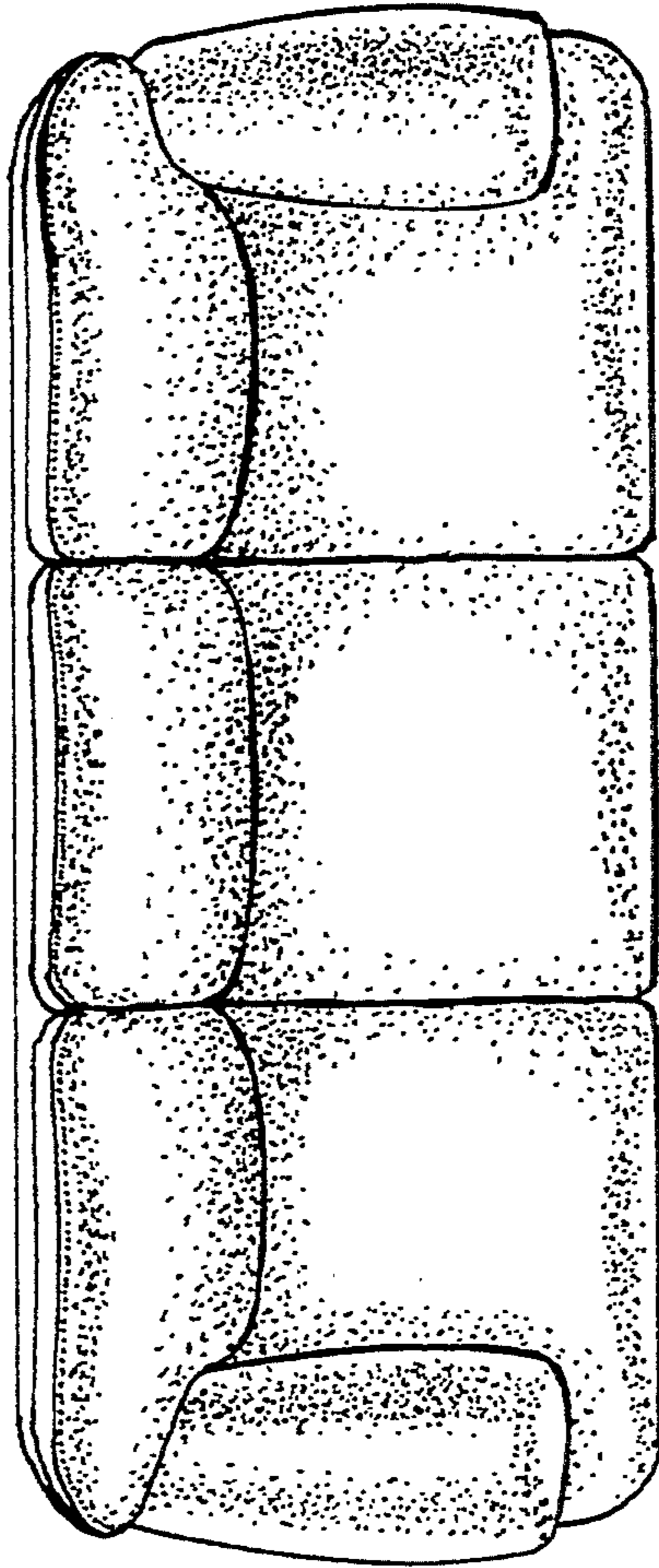

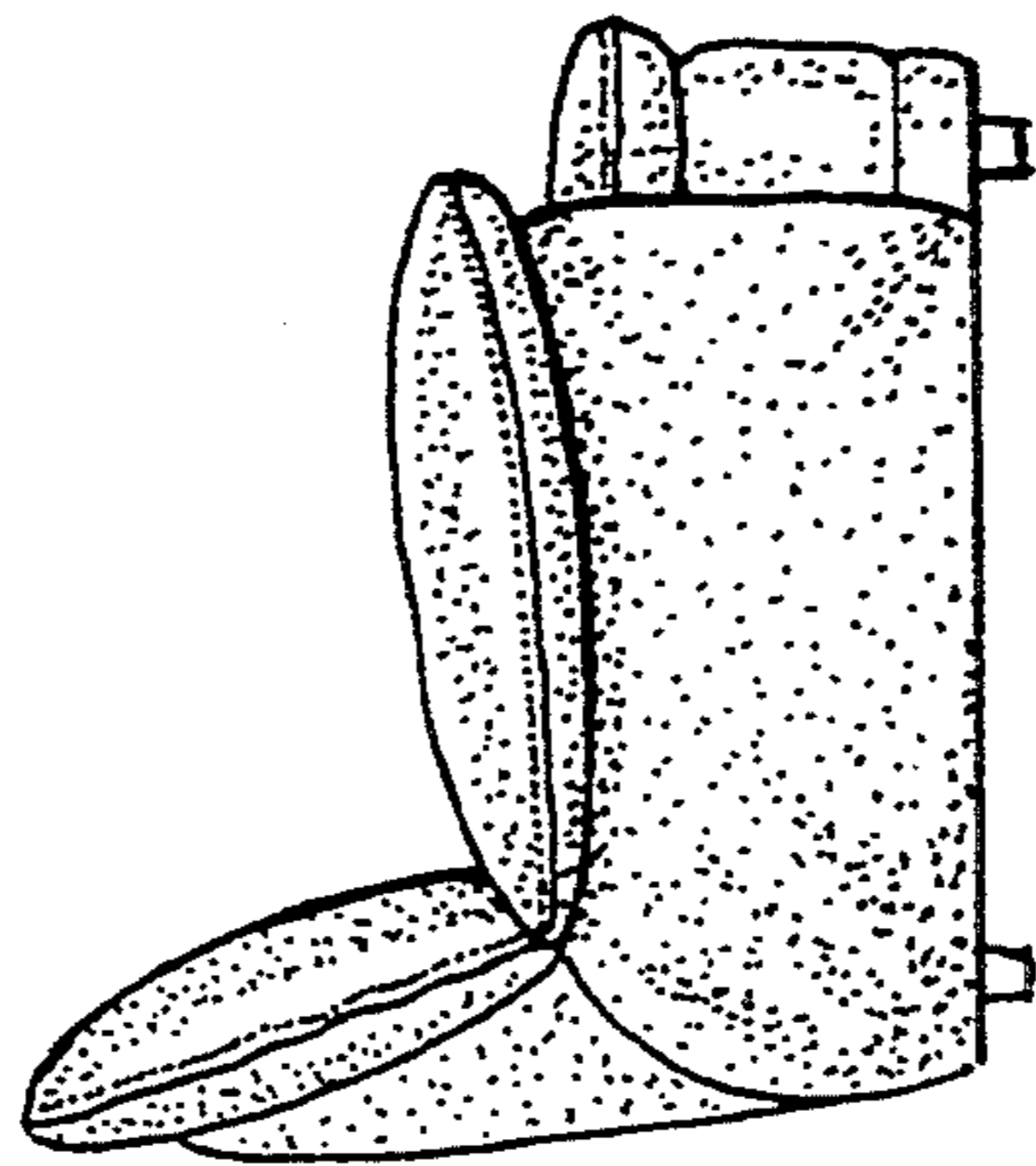

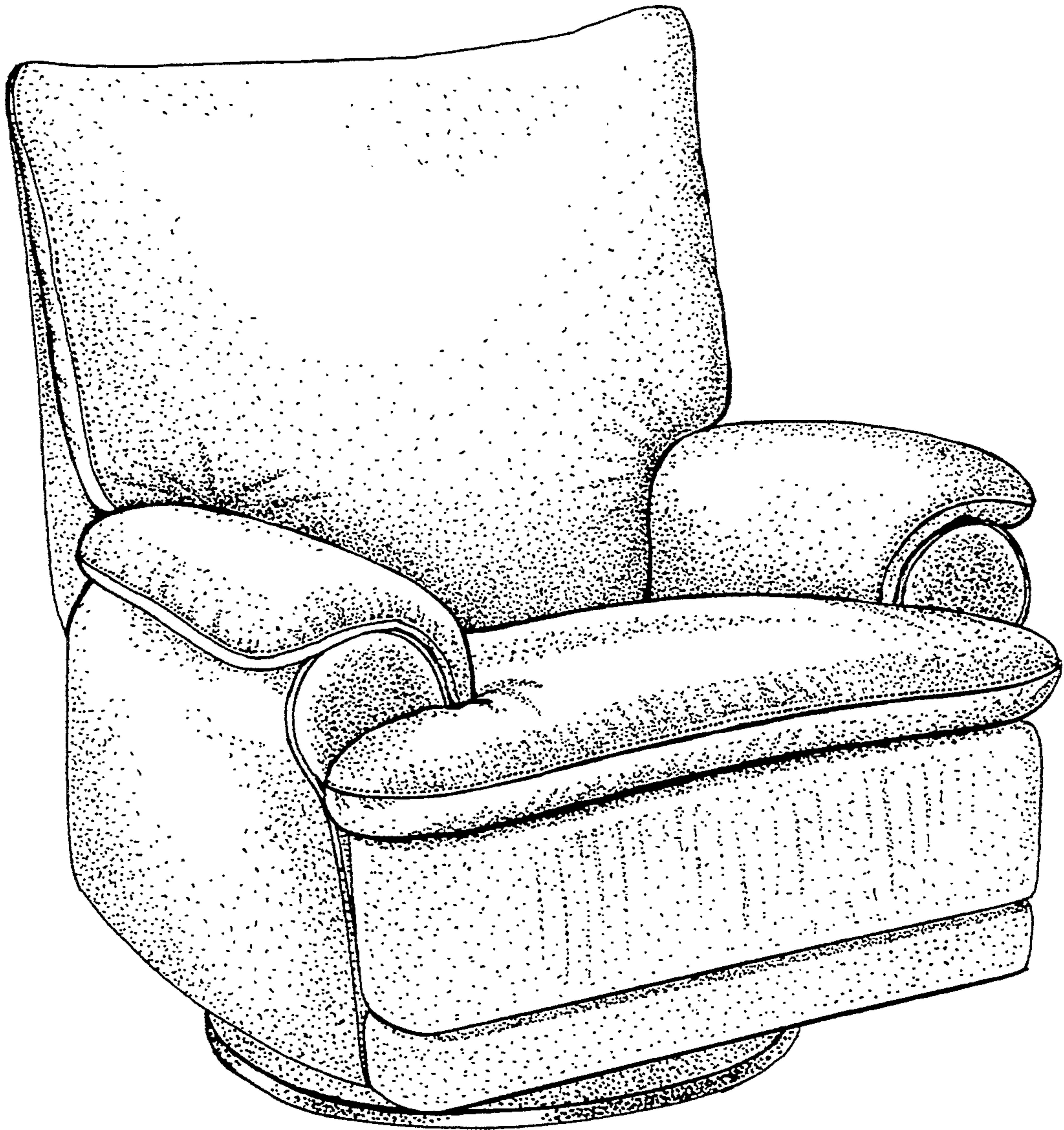

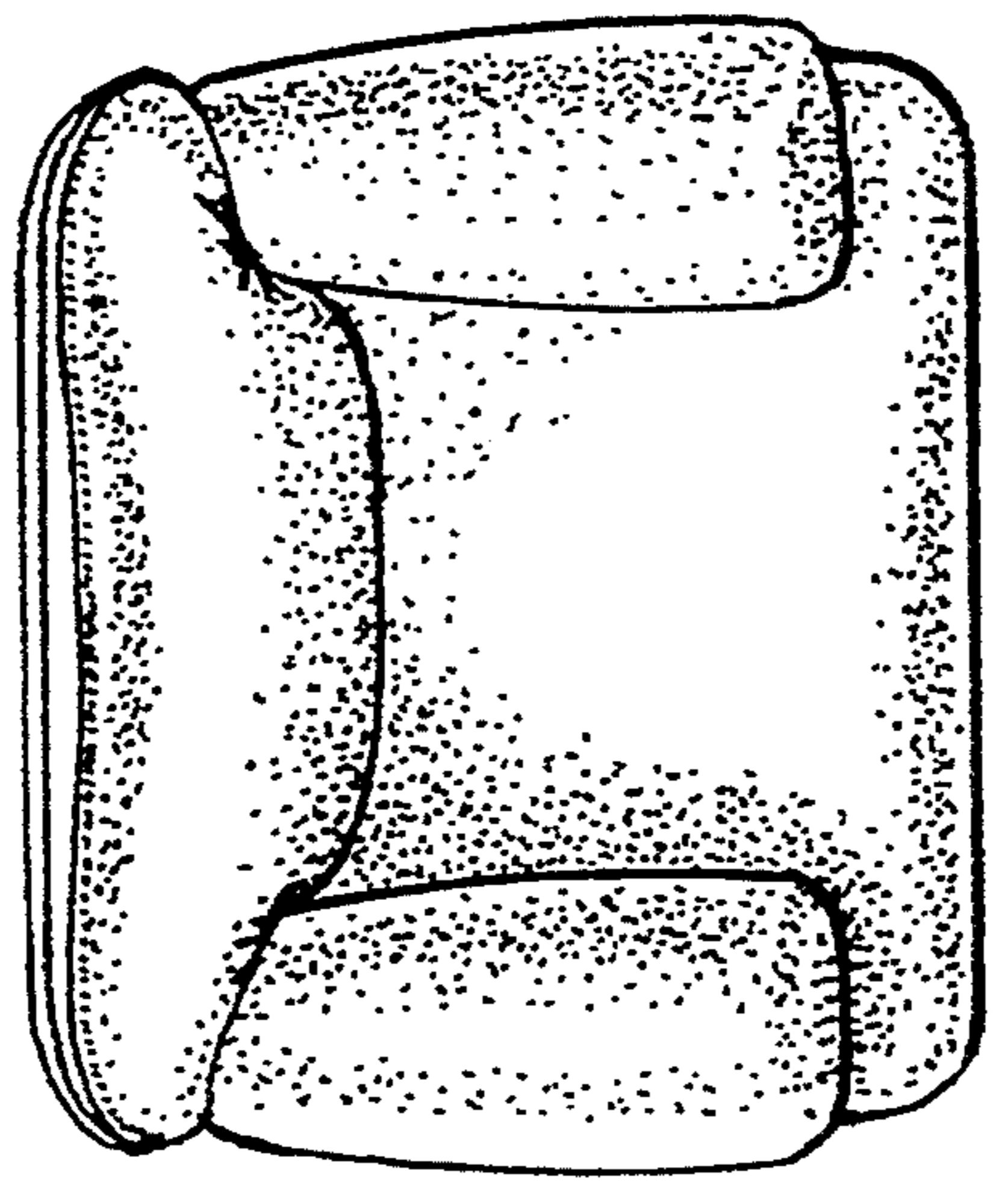

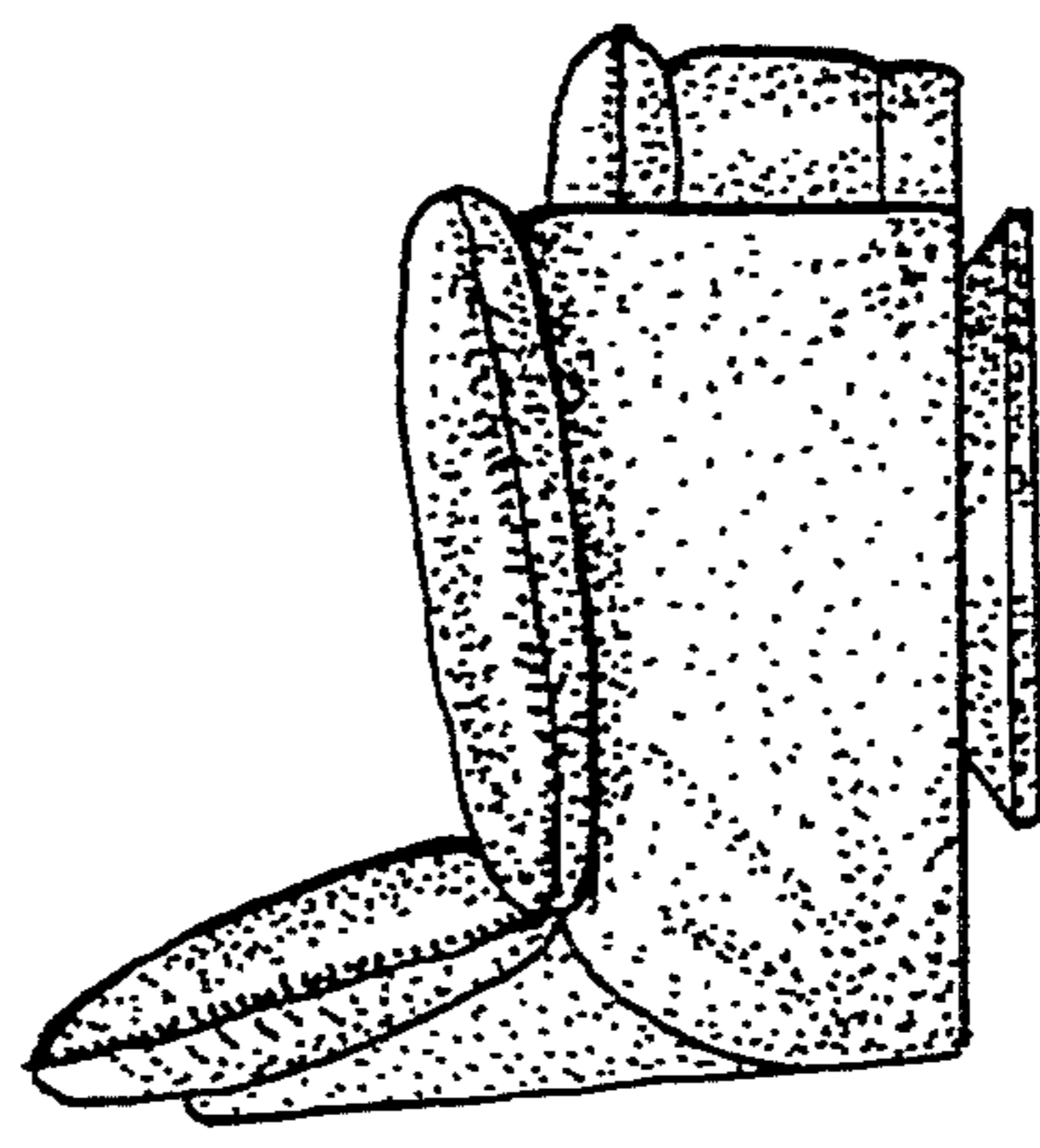
