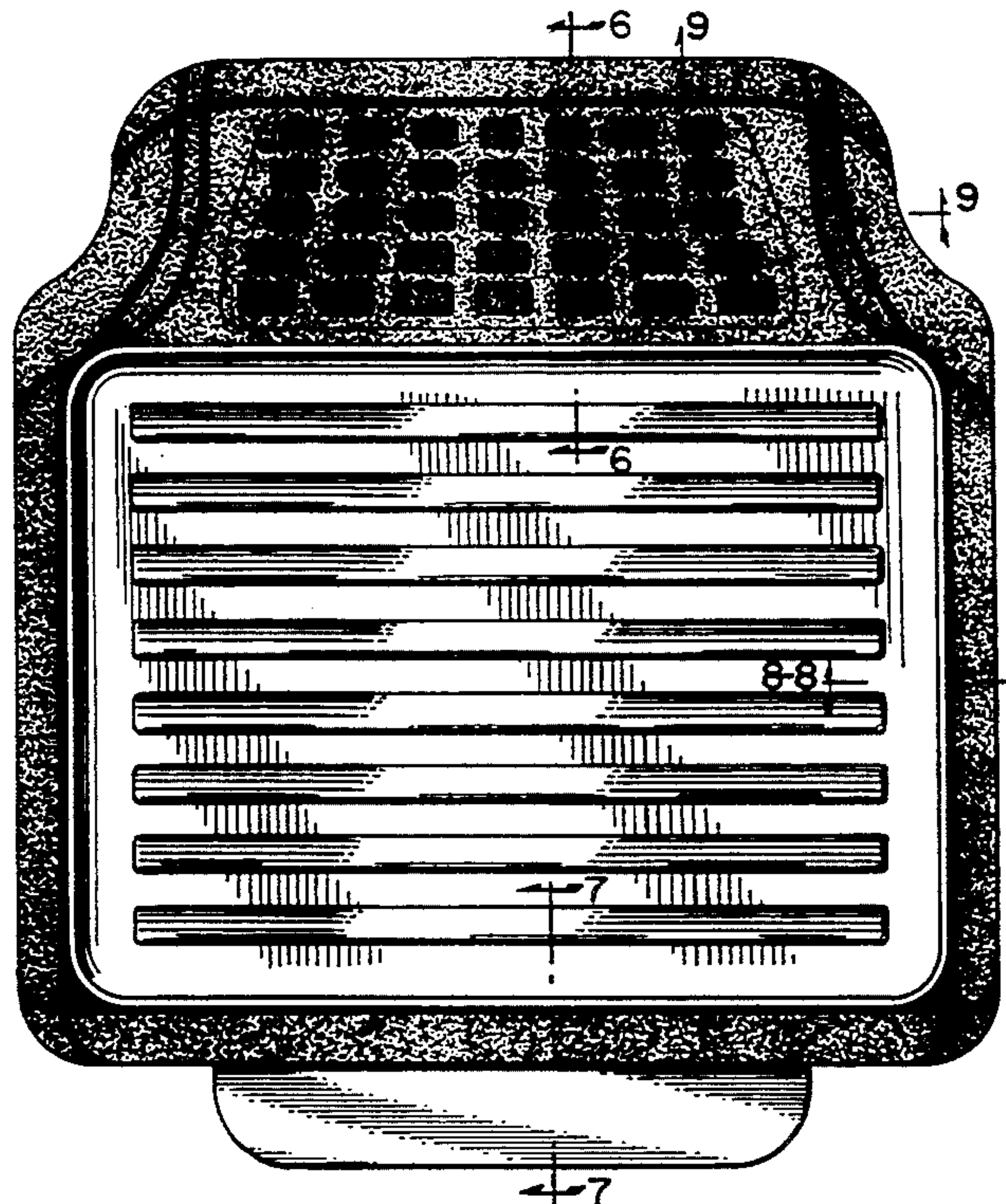

[57] **CLAIM**  
 The ornamental design for a vehicle rear floor mat, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view of a vehicle rear floor mat incorporating my invention;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a left side elevational view thereof, with the right side elevation view being a mirror image;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a cross-sectional view along line 6—6 of FIG. 1;  
 FIG. 7 is a cross-sectional view along line 7—7 of FIG. 1;  
 FIG. 8 is a cross-sectional view along line 8—8 of FIG. 1; and,  
 FIG. 9 is a cross-sectional view along line 9—9 of FIG. 1.





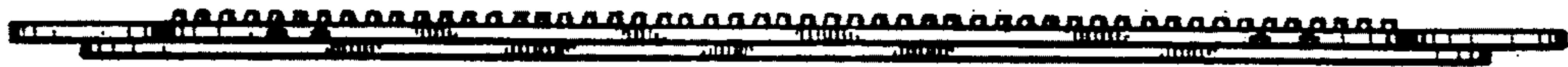

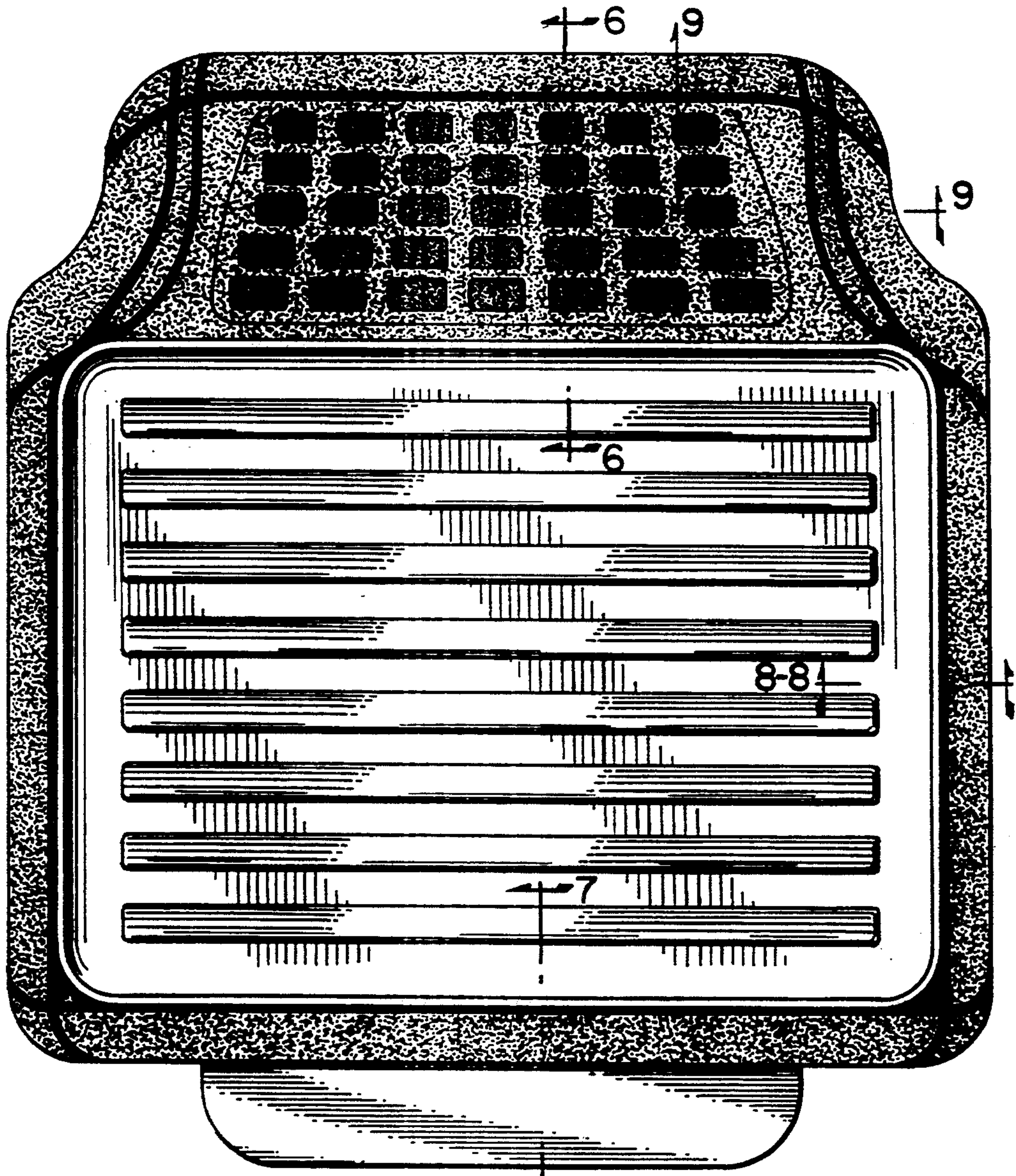

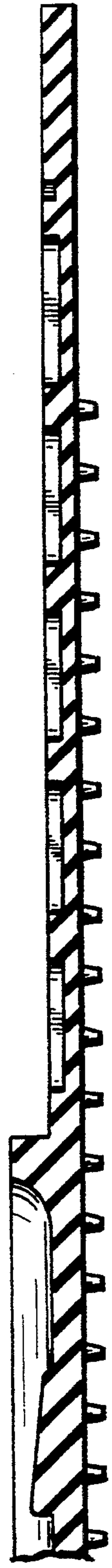

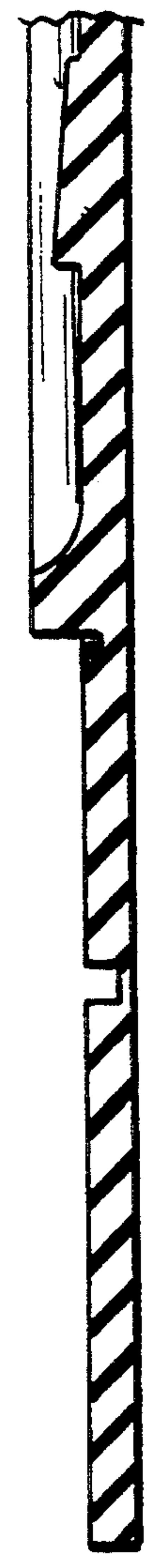

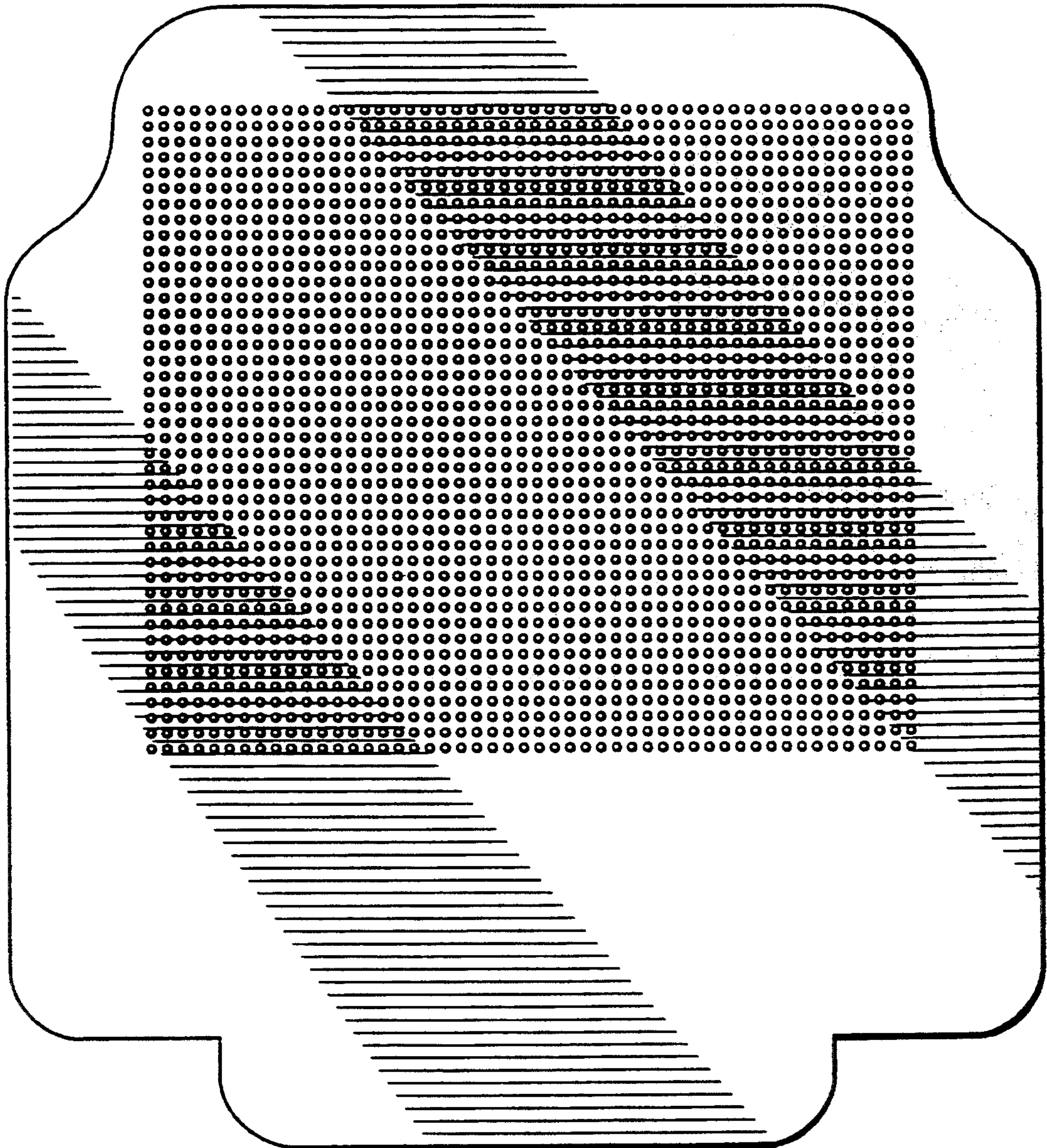
