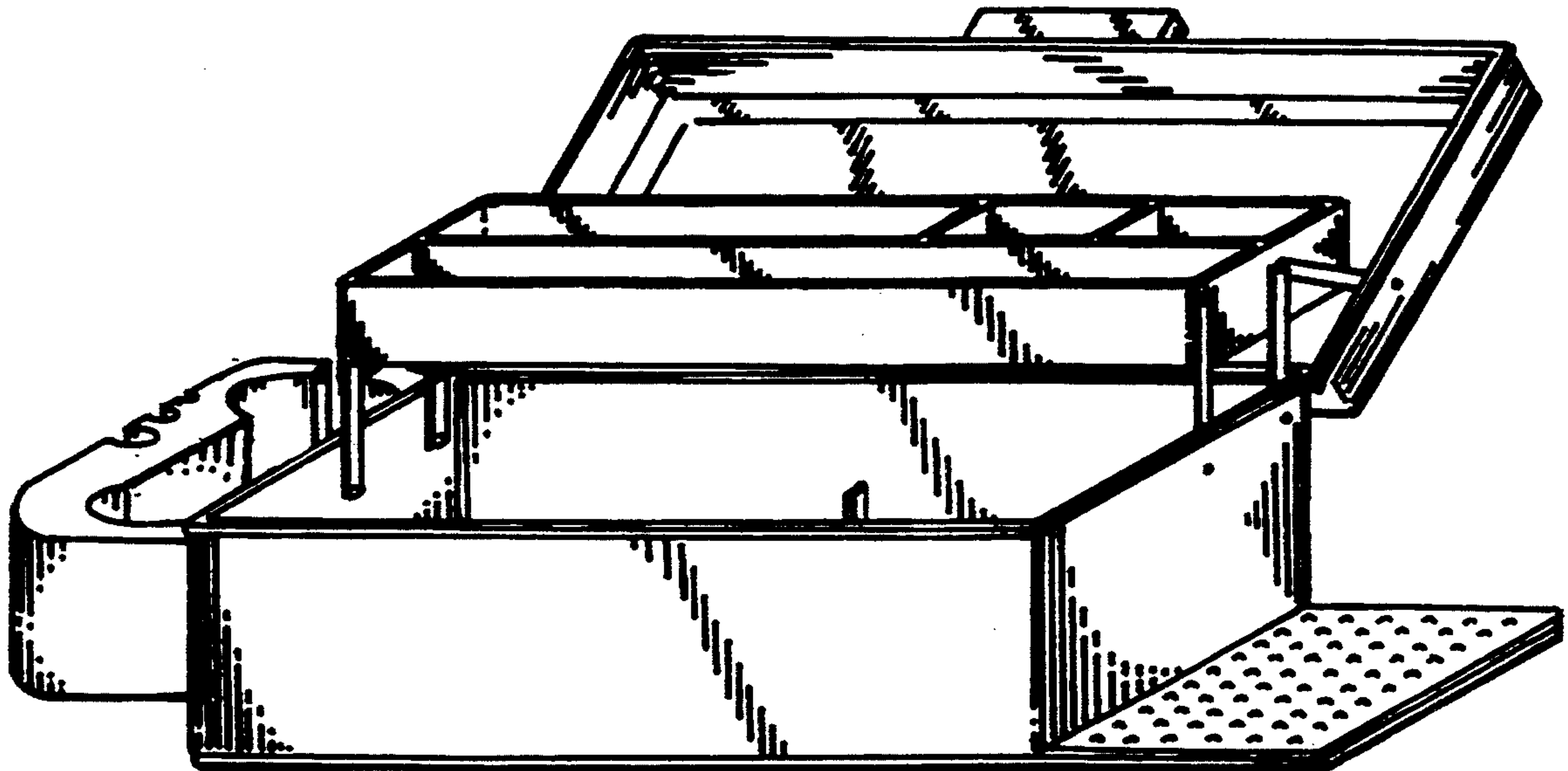

[57] **CLAIM**

The ornamental design for a combination arm rest and storage container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combination arm rest and storage container, showing my new design; FIG. 2 is a rear elevational view thereof in the closed position; FIG. 3 is a cross-sectional view taken along lines 3—3 of FIG. 2; FIG. 4 is a front elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a left side elevational view thereof; FIG. 8 is a right side elevational view thereof; and, FIG. 9 is a top plan view in the open position.



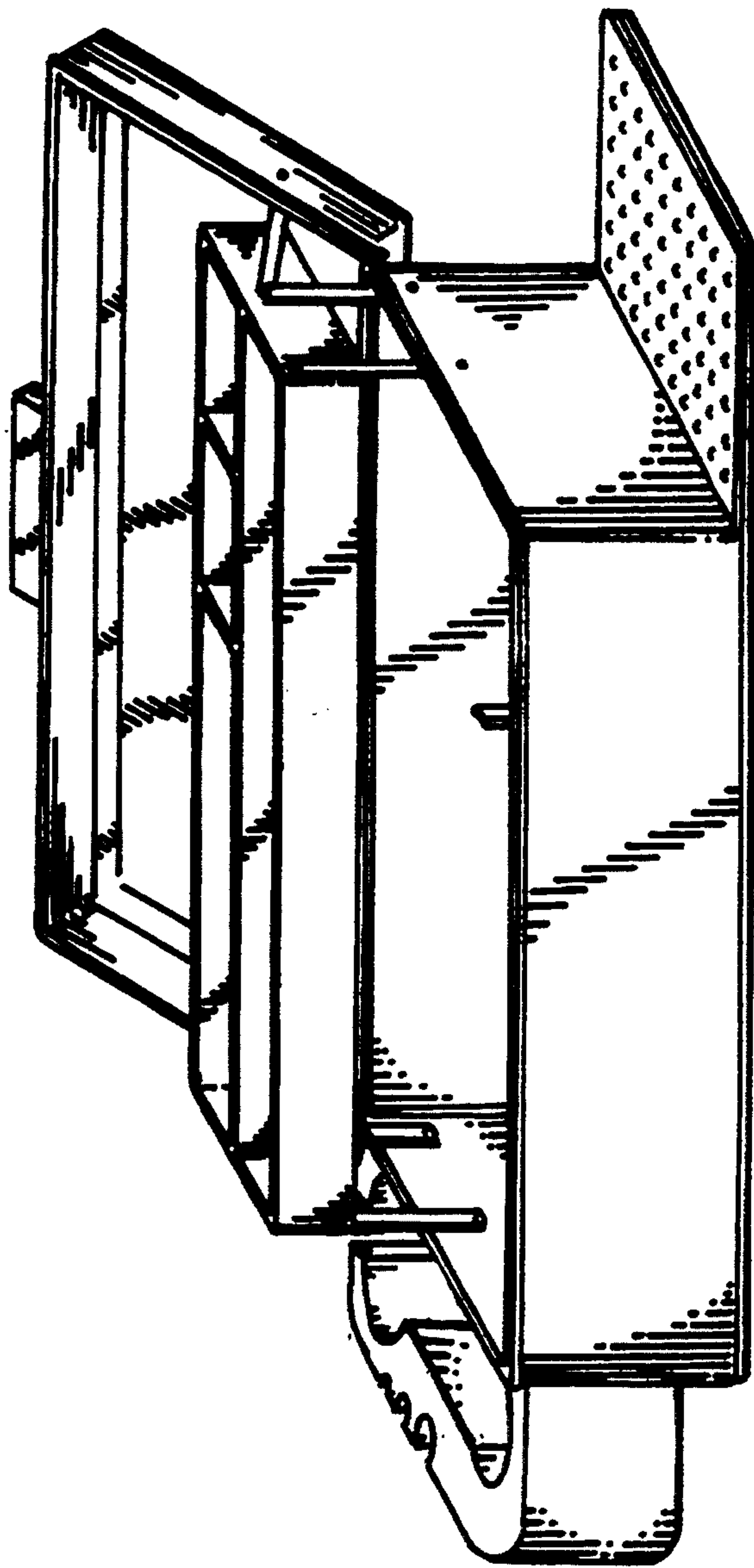
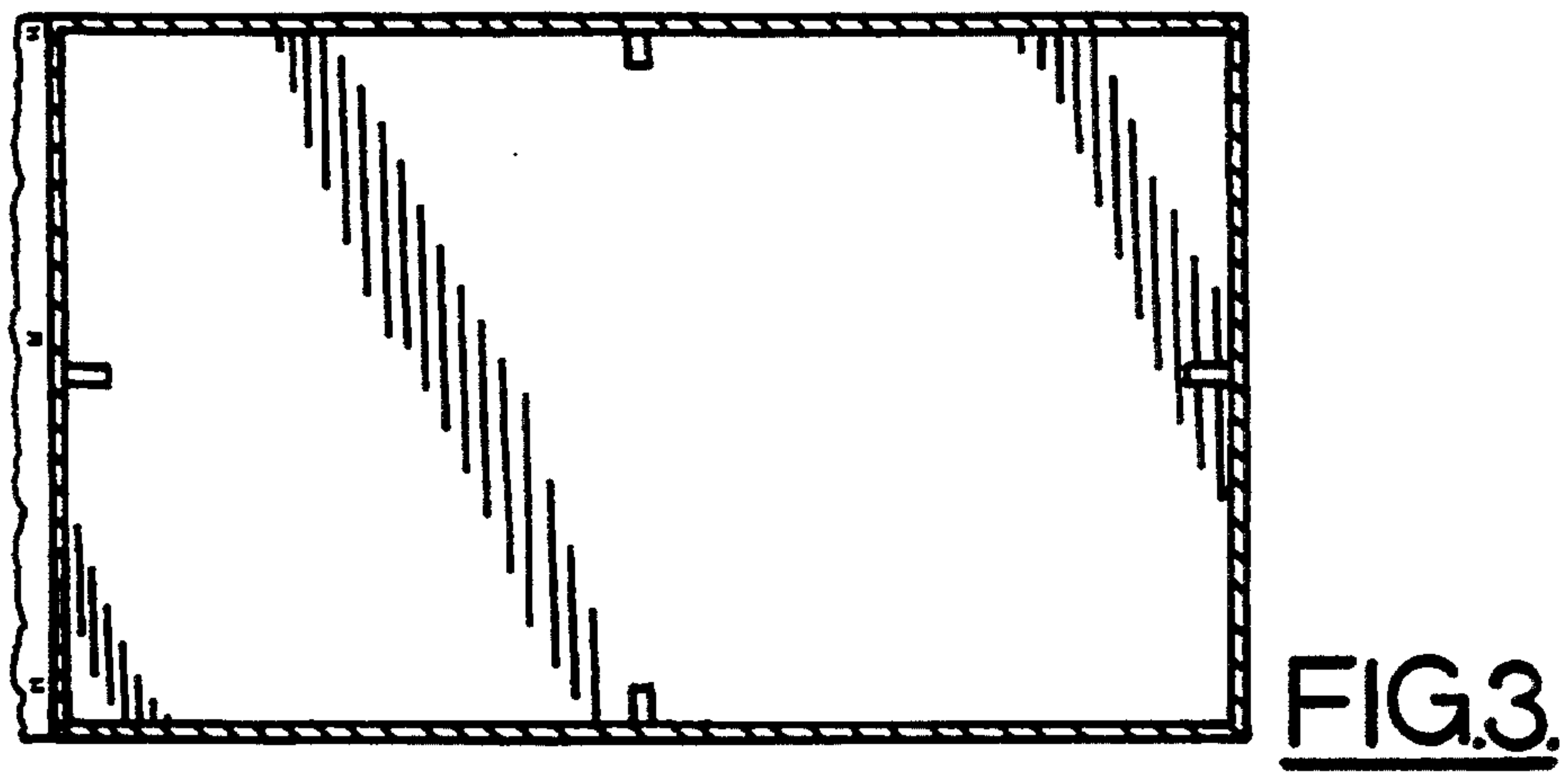
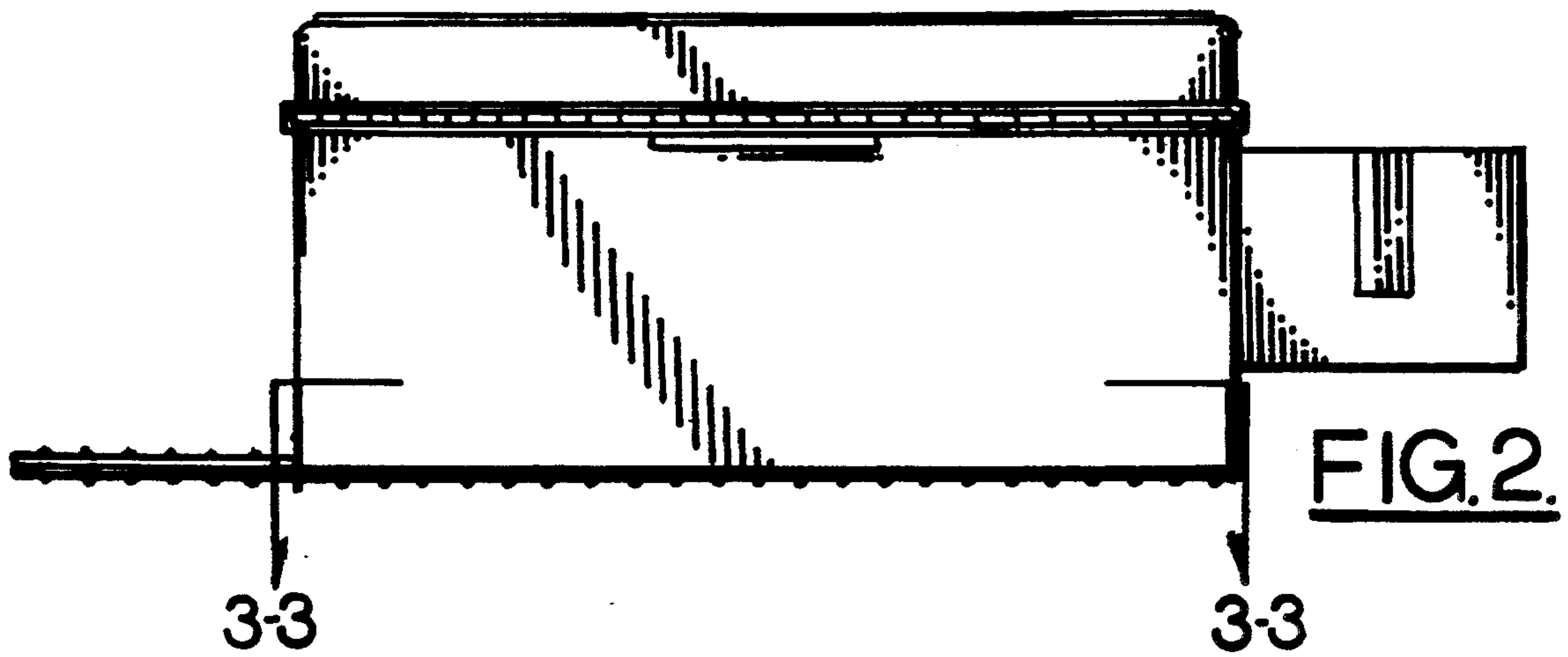

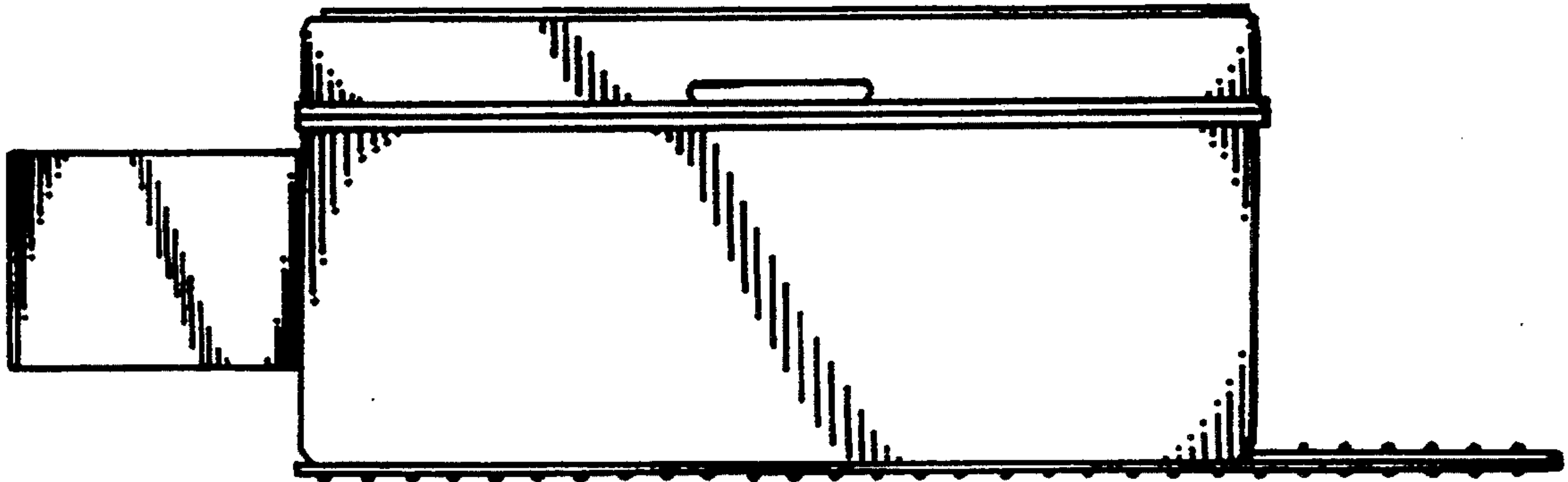

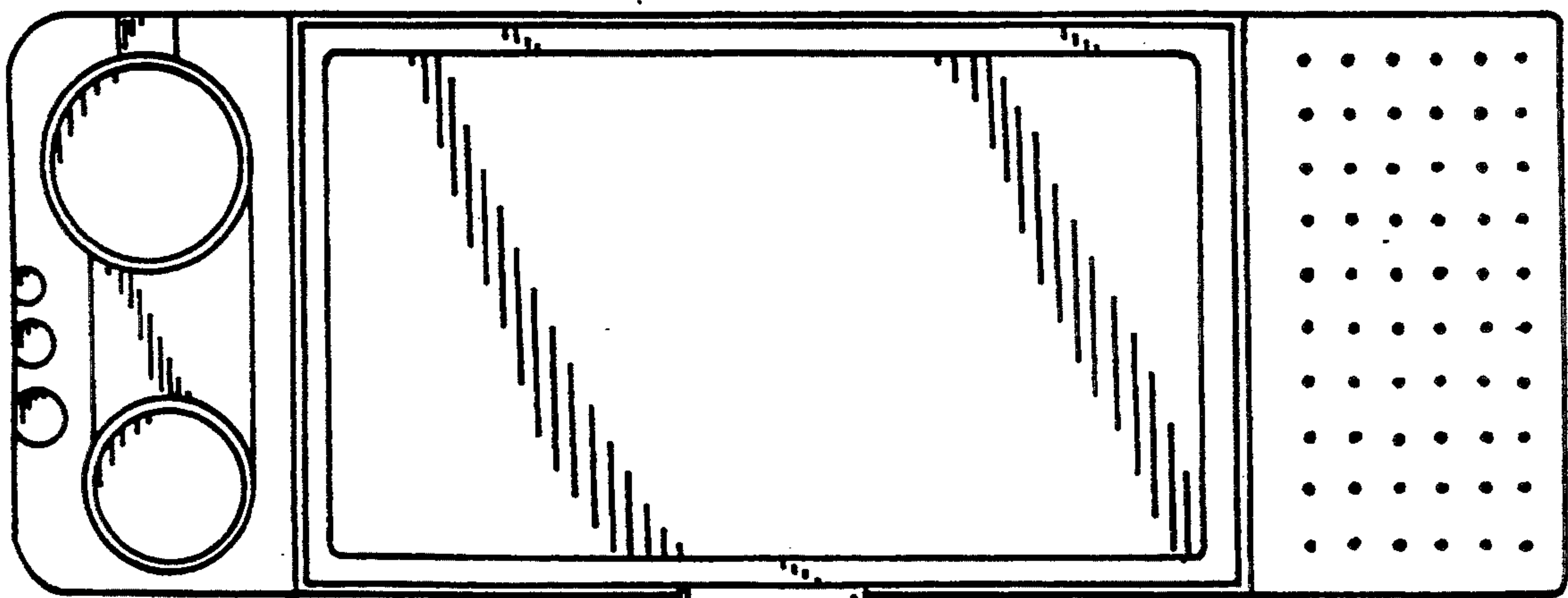

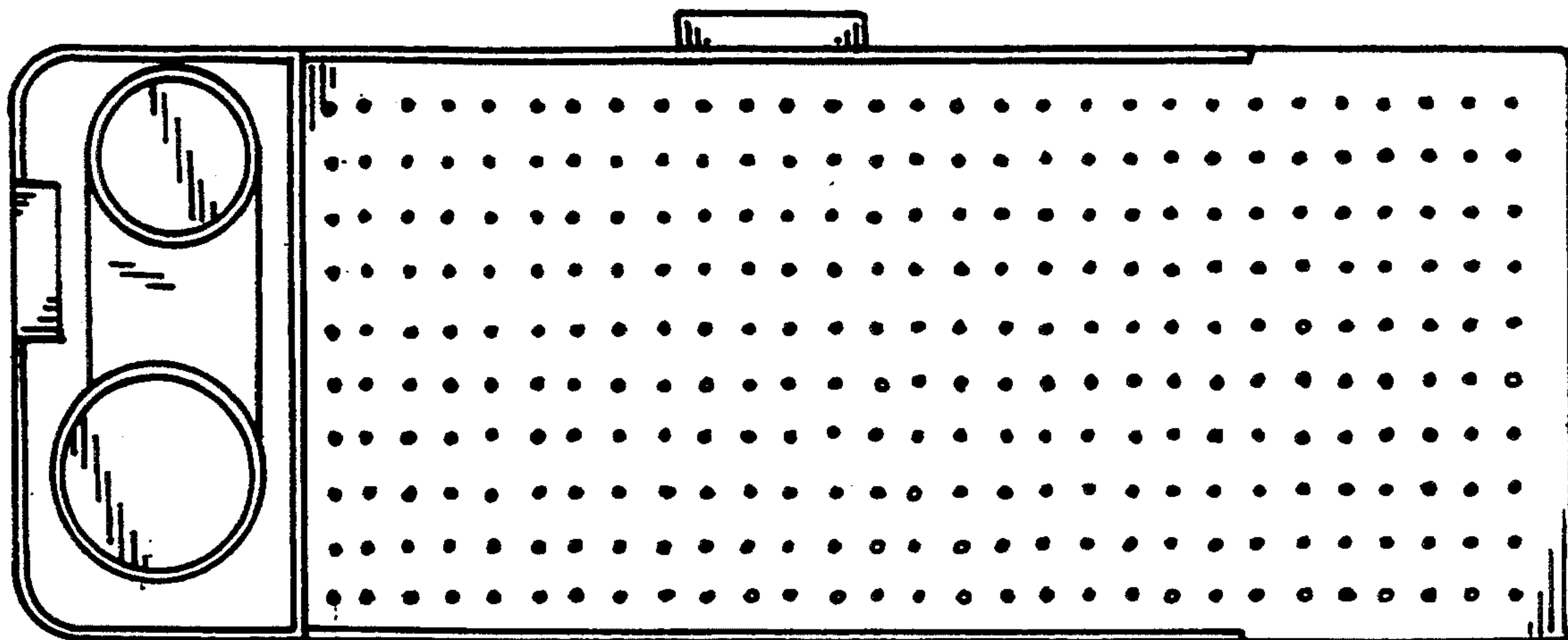

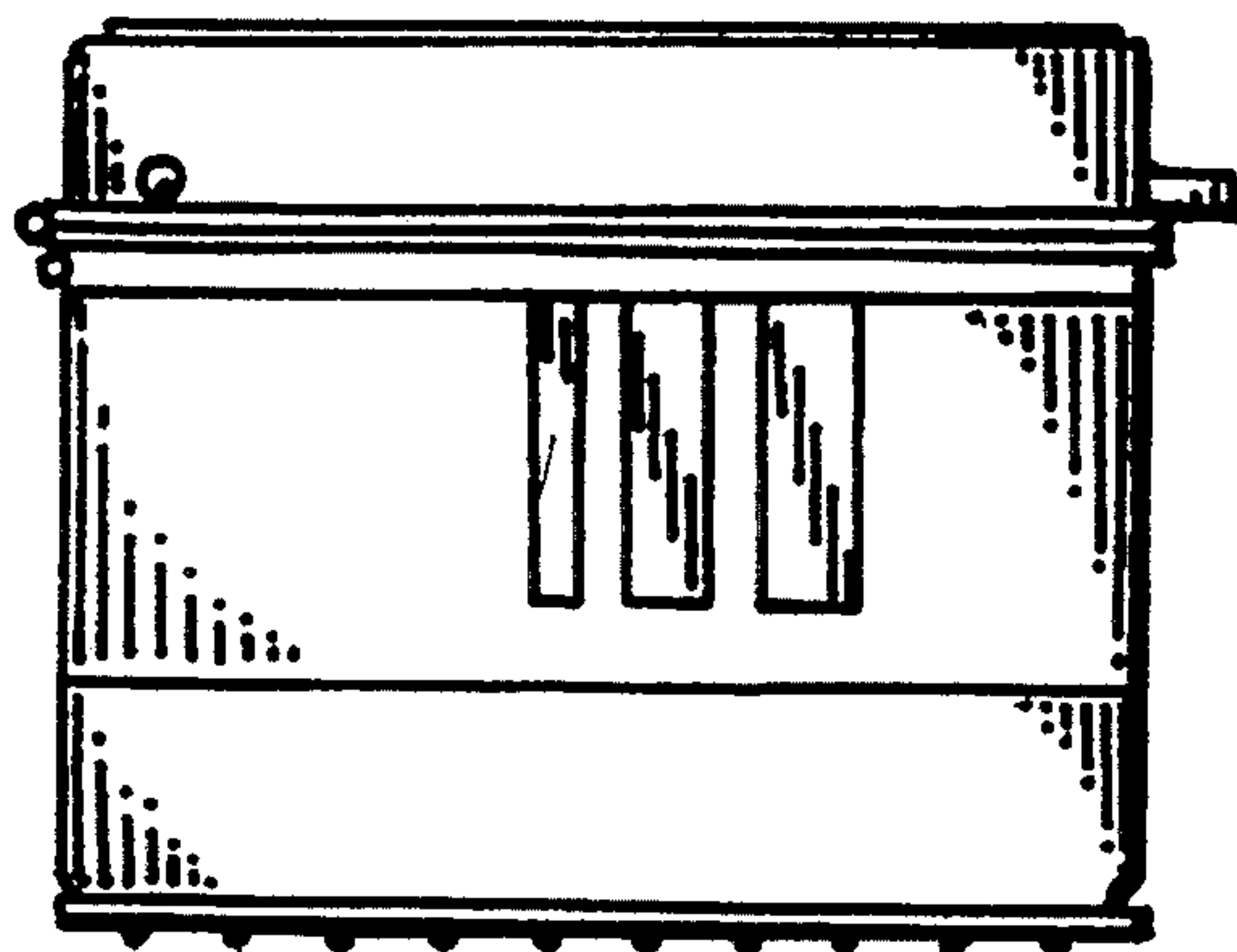

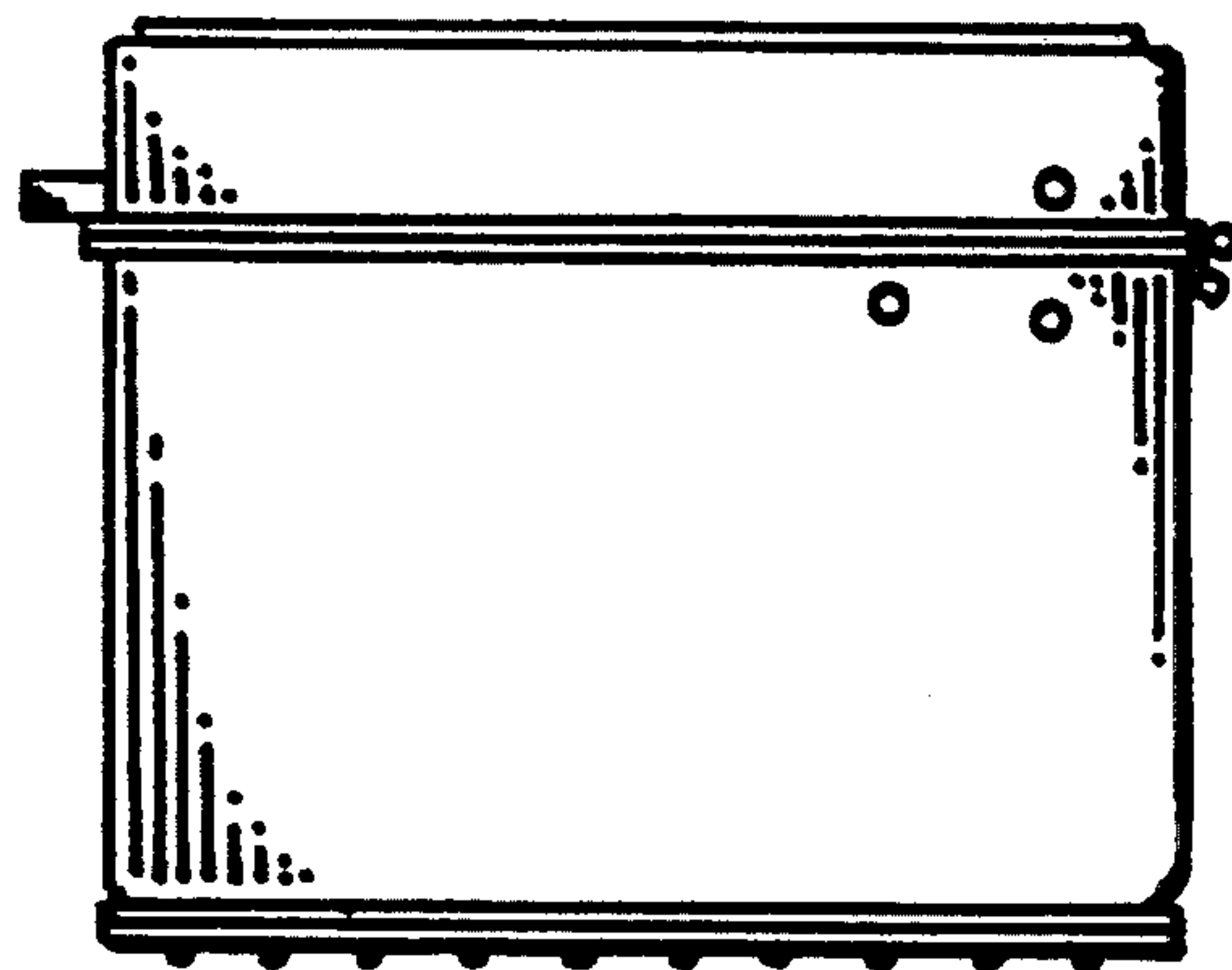

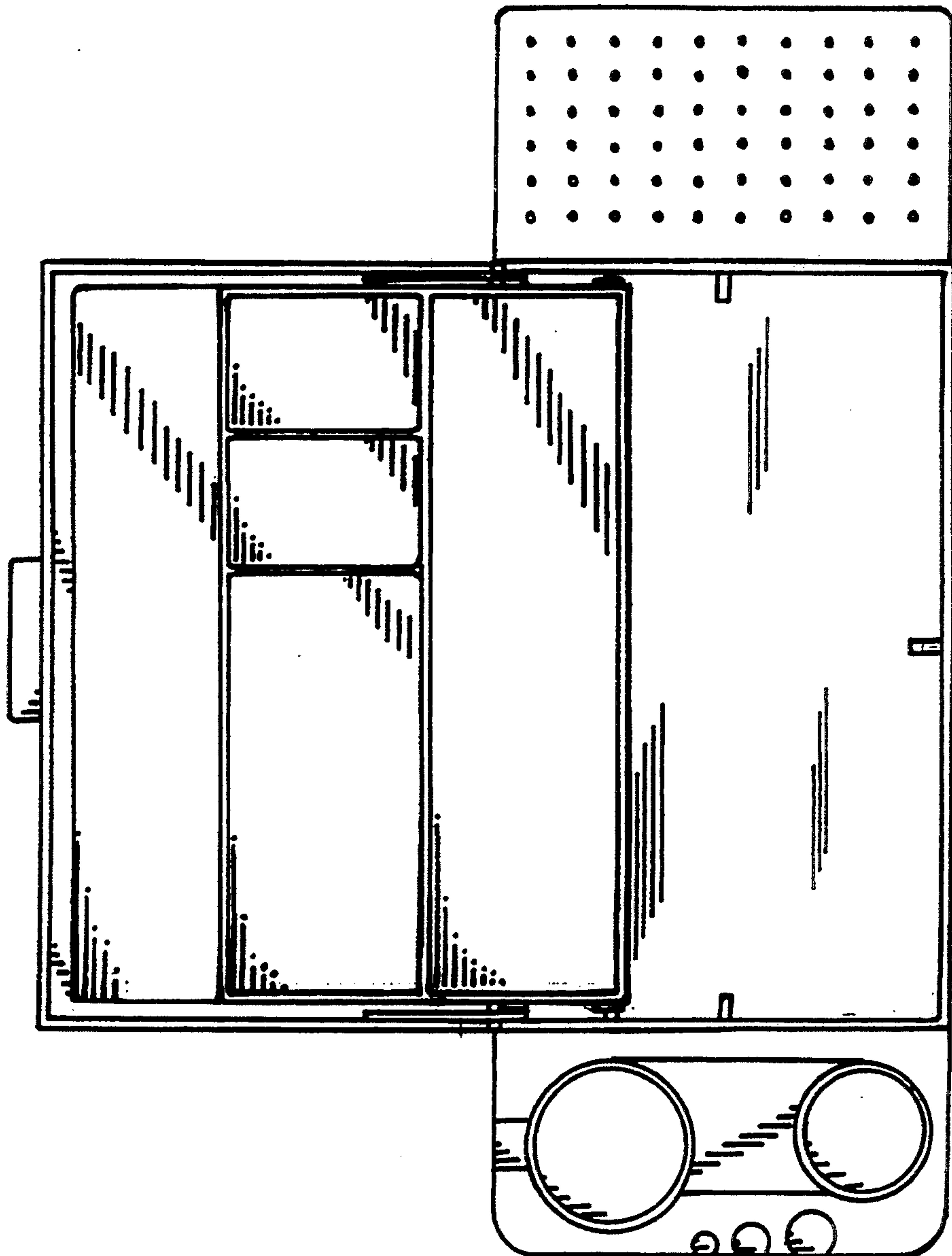
