**DESCRIPTION**

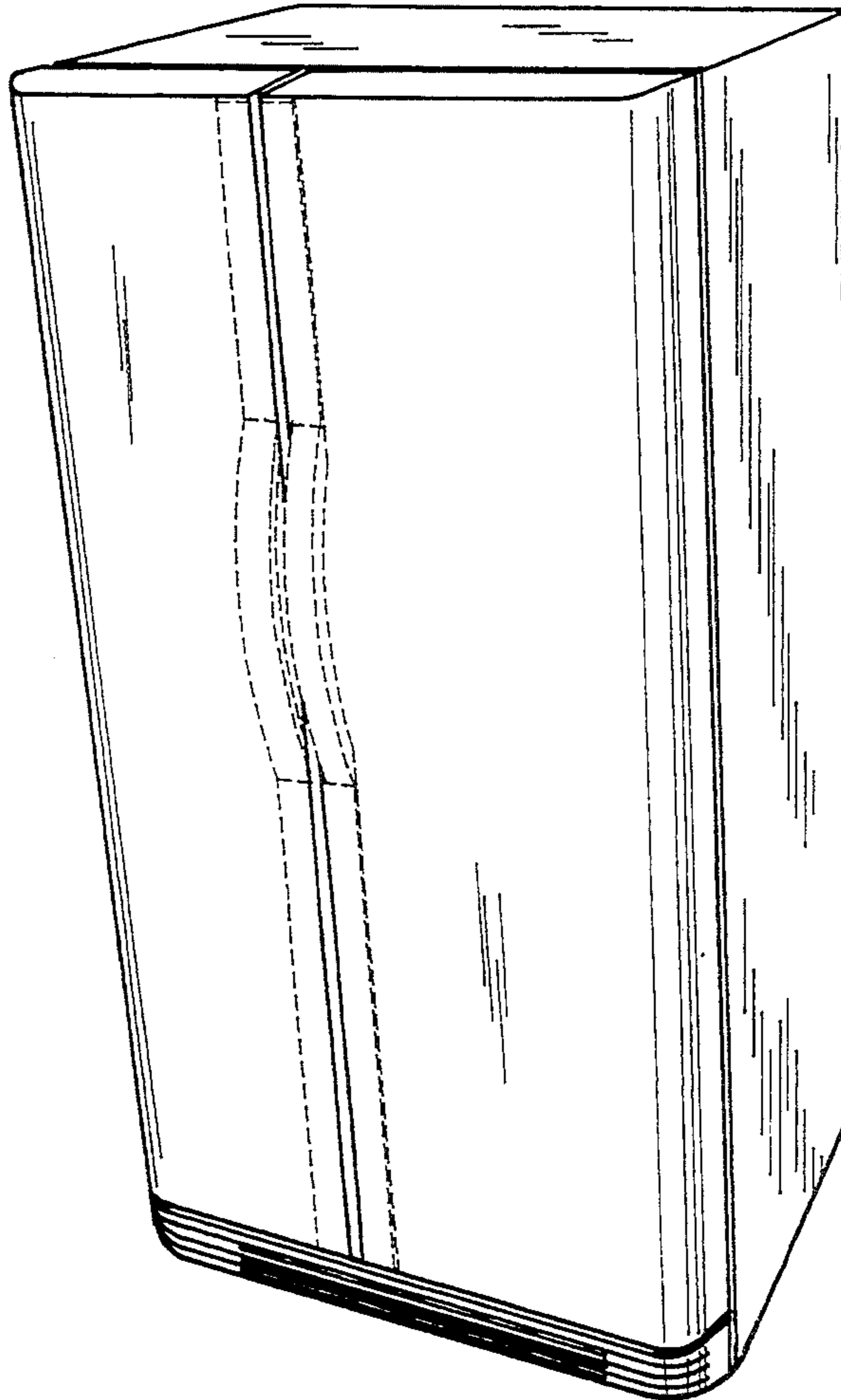

FIG. 5 is a right side elevational view.



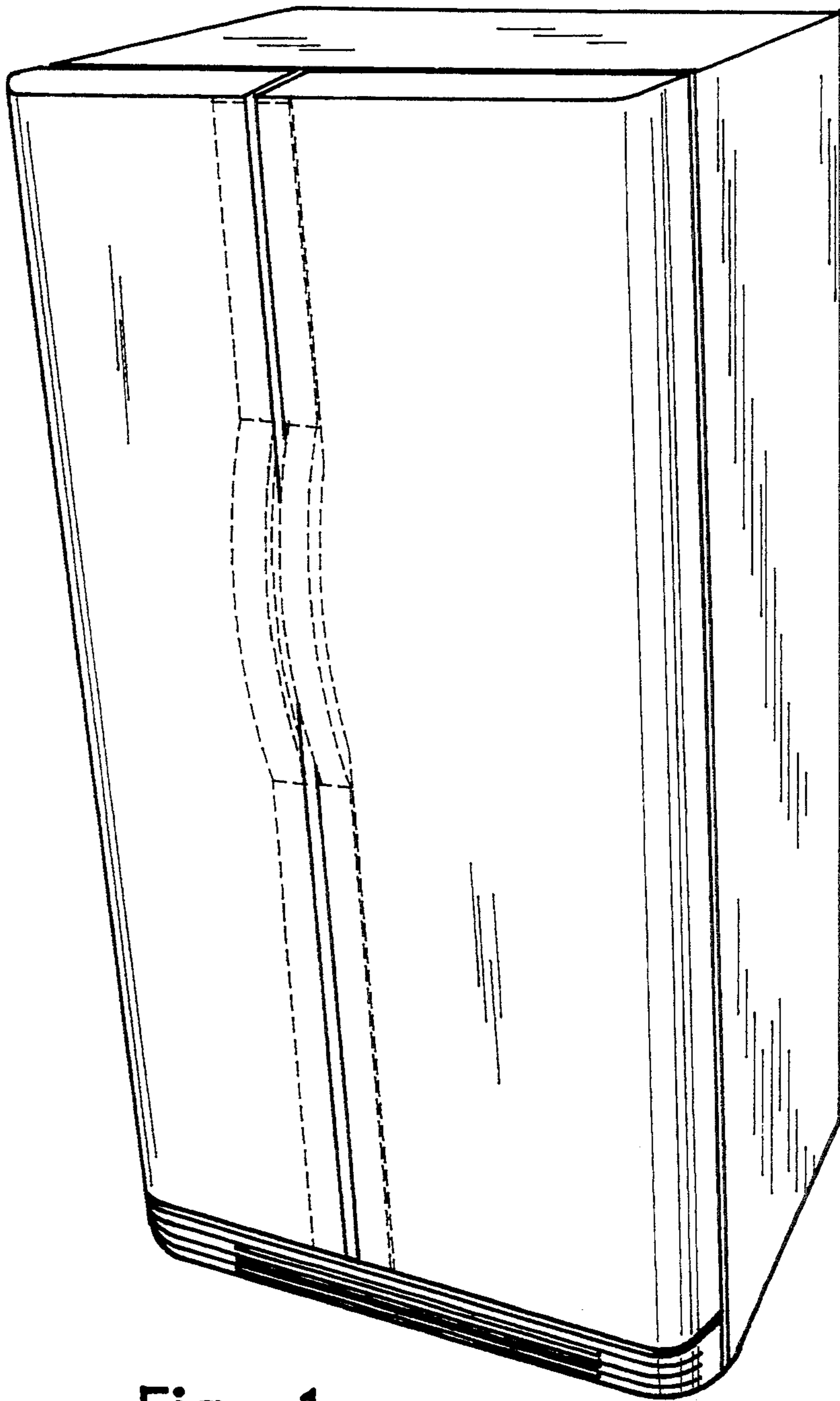

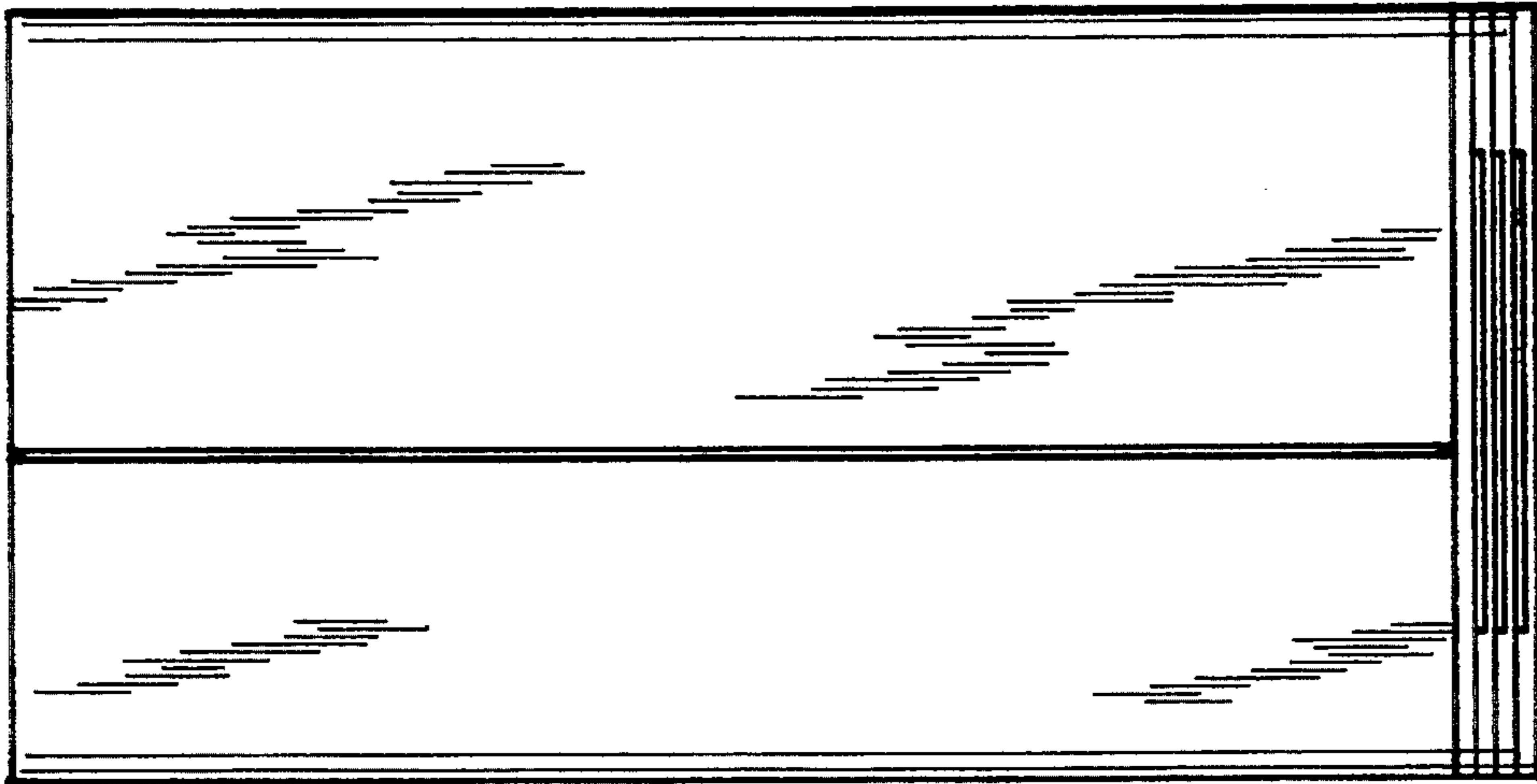

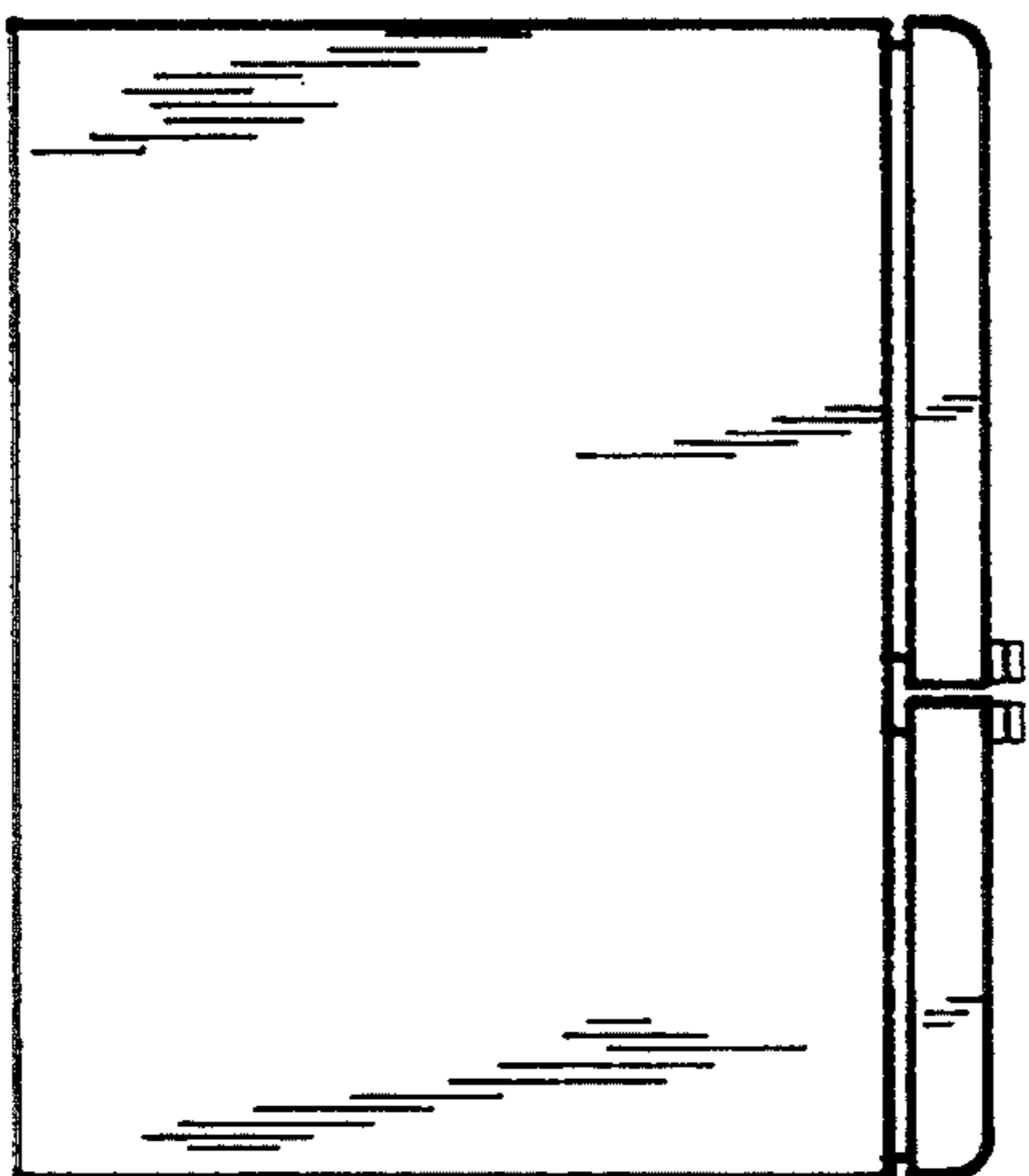

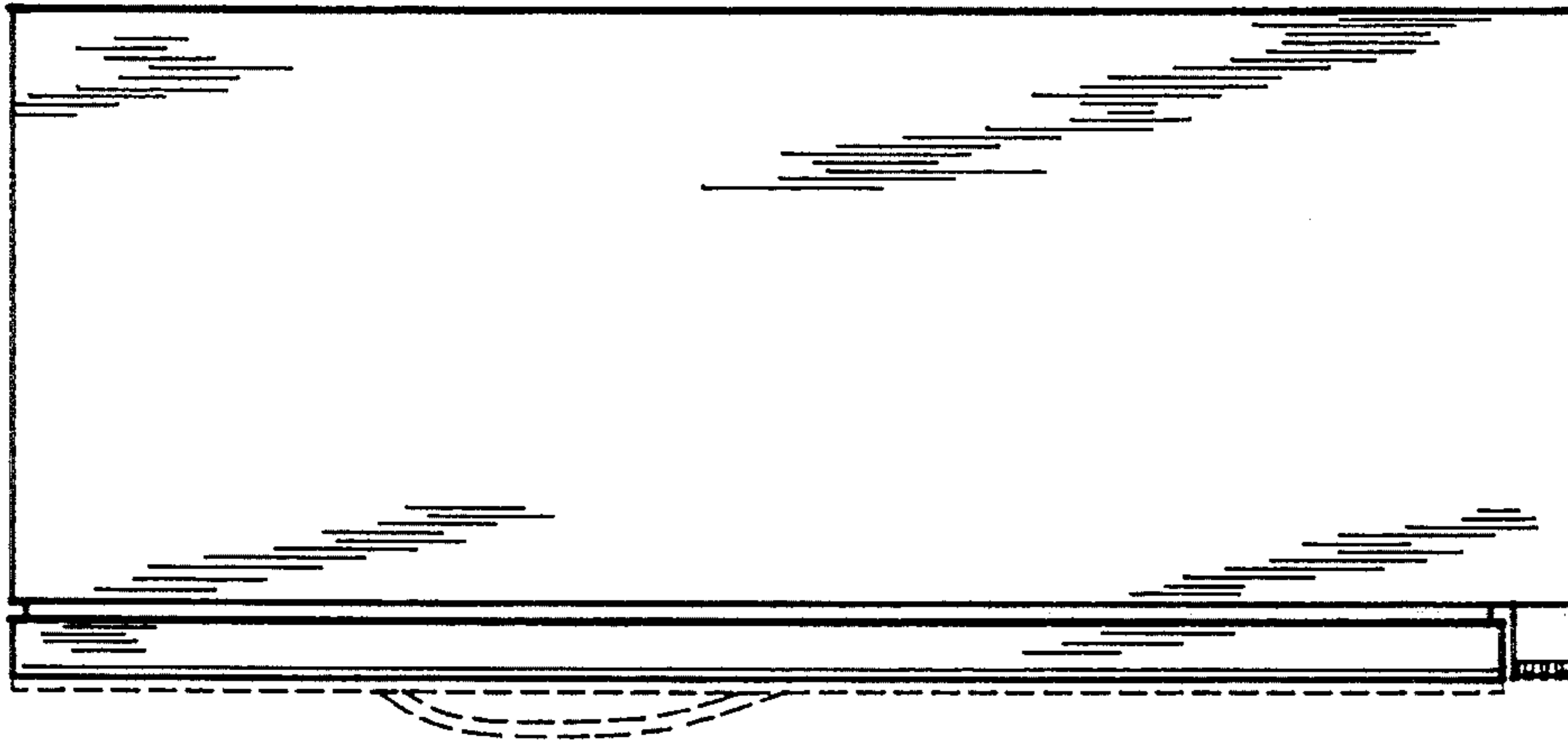

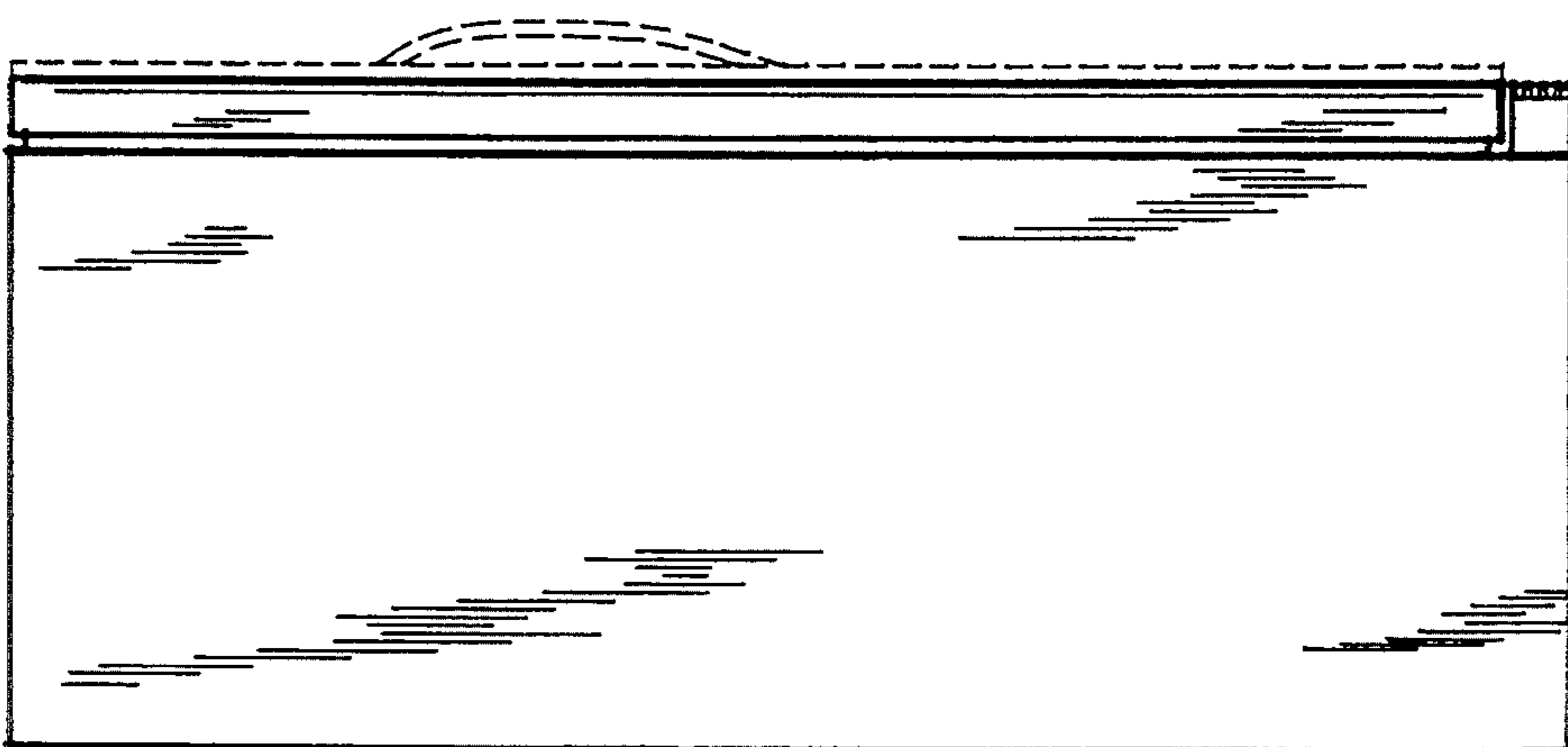
