#### DESCRIPTION

FIG. 1 is a perspective view of a folding clubhouse showing our new design in an opened position;

FIG. 9 is a front elevational view of the folding club-house of FIG. 8;


FIG. 10 is a right side elevational view of the folding clubhouse of FIG. 8;


FIG. 11 is a back elevational view of the of folding clubhouse of FIG. 8;

FIG. 14 is a bottom view of the folding clubhouse of FIG. 8.



























