DESCRIPTION

FIG. 1 is a top plan view of a toothbrush showing our
new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a bottom elevational view thereof;
FIG. 4 is an enlarged end elevational view from the
handle end;
FIG. 5 is an enlarged end elevational view from the
head end; and,
FIG. 6 is an enlarged perspective view thereof.

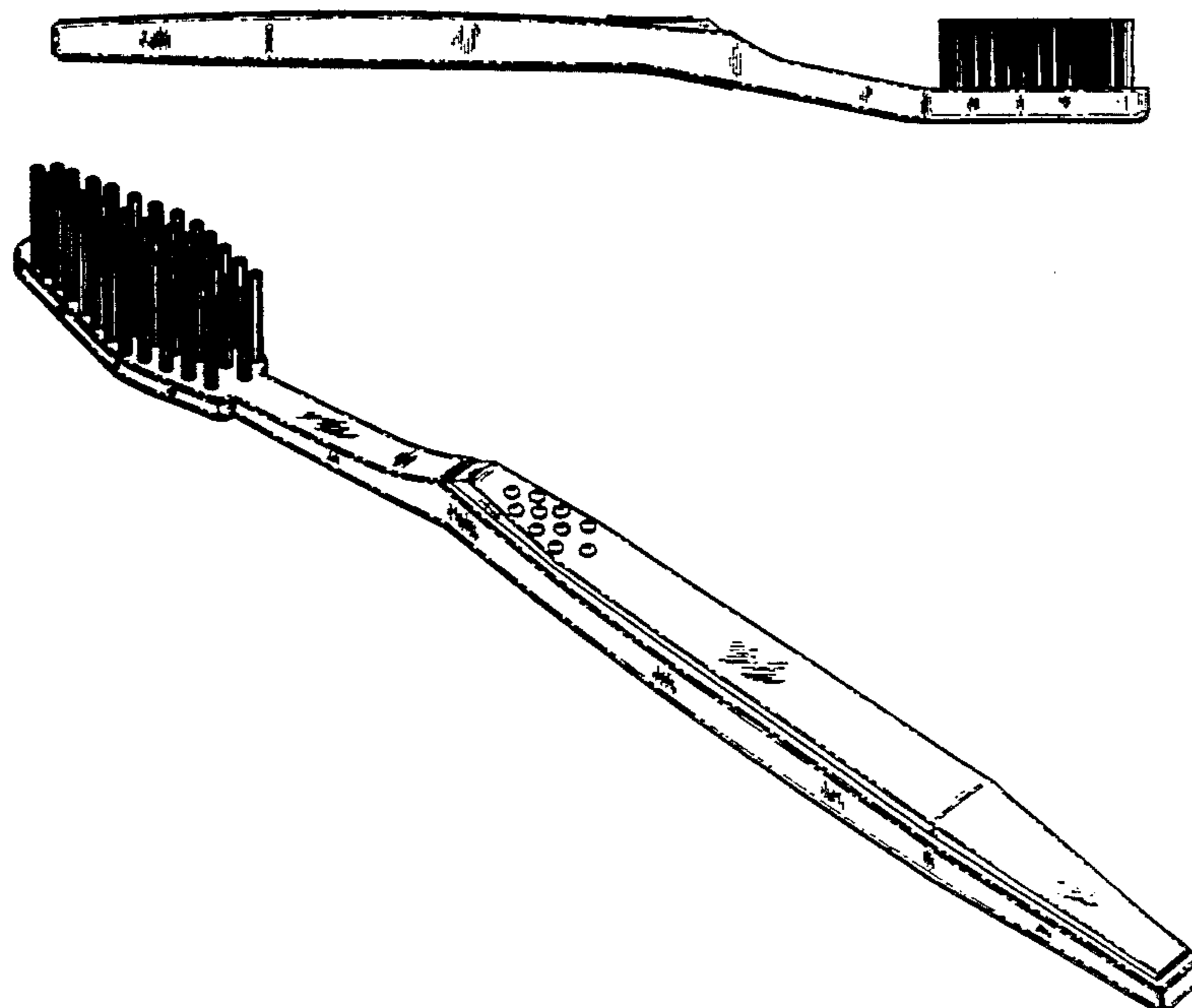

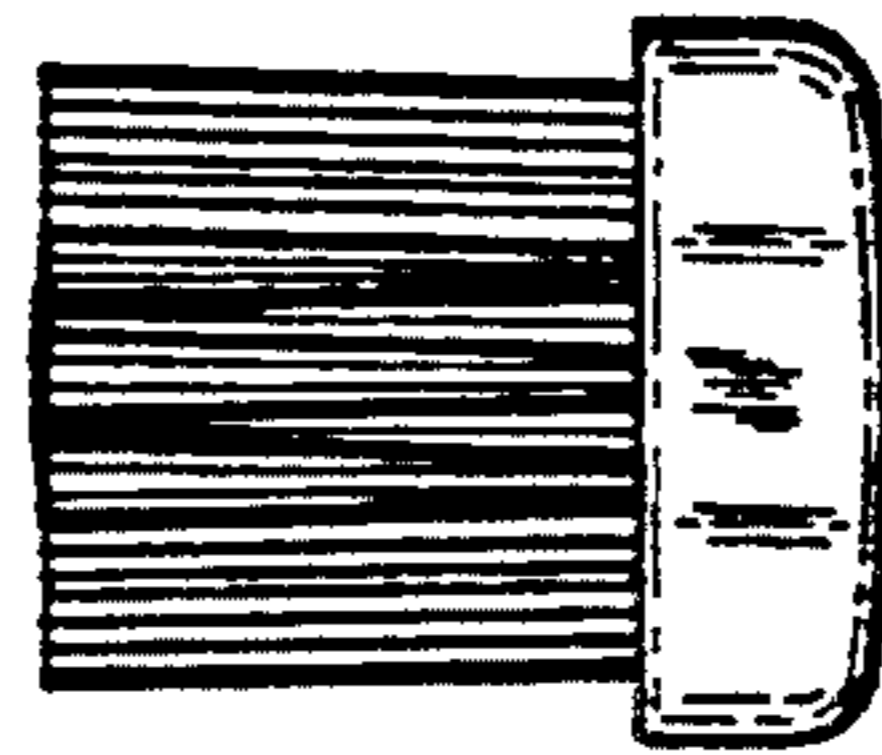

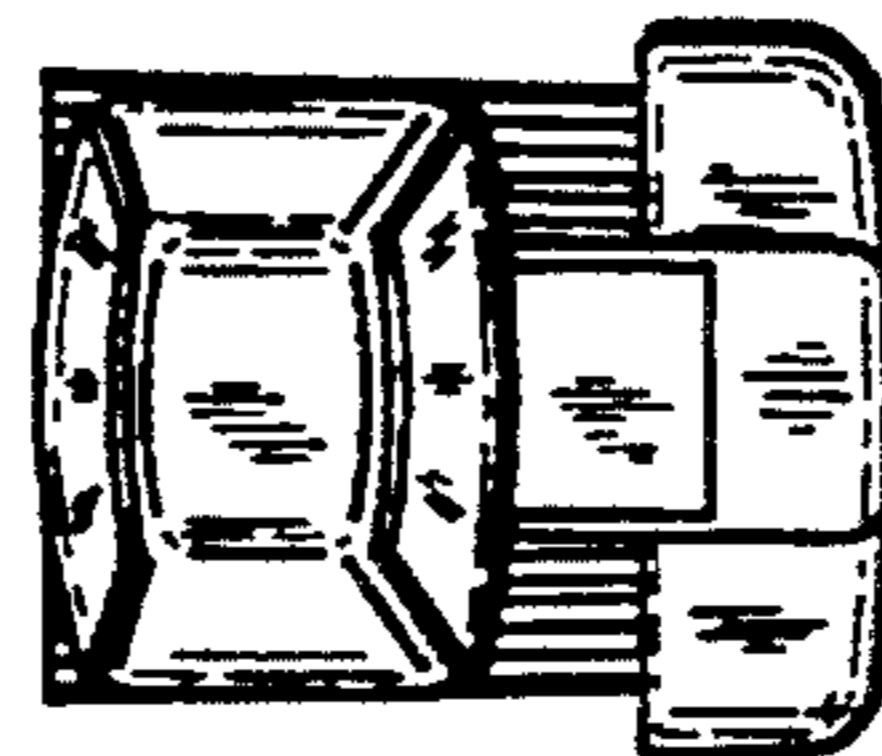

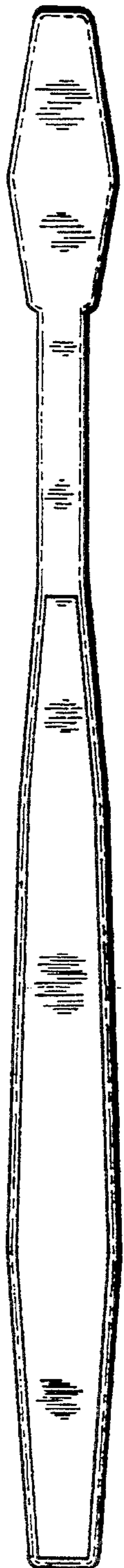
