FIG. 1 is a top left front perspective view of a walrus bowl showing our new design;

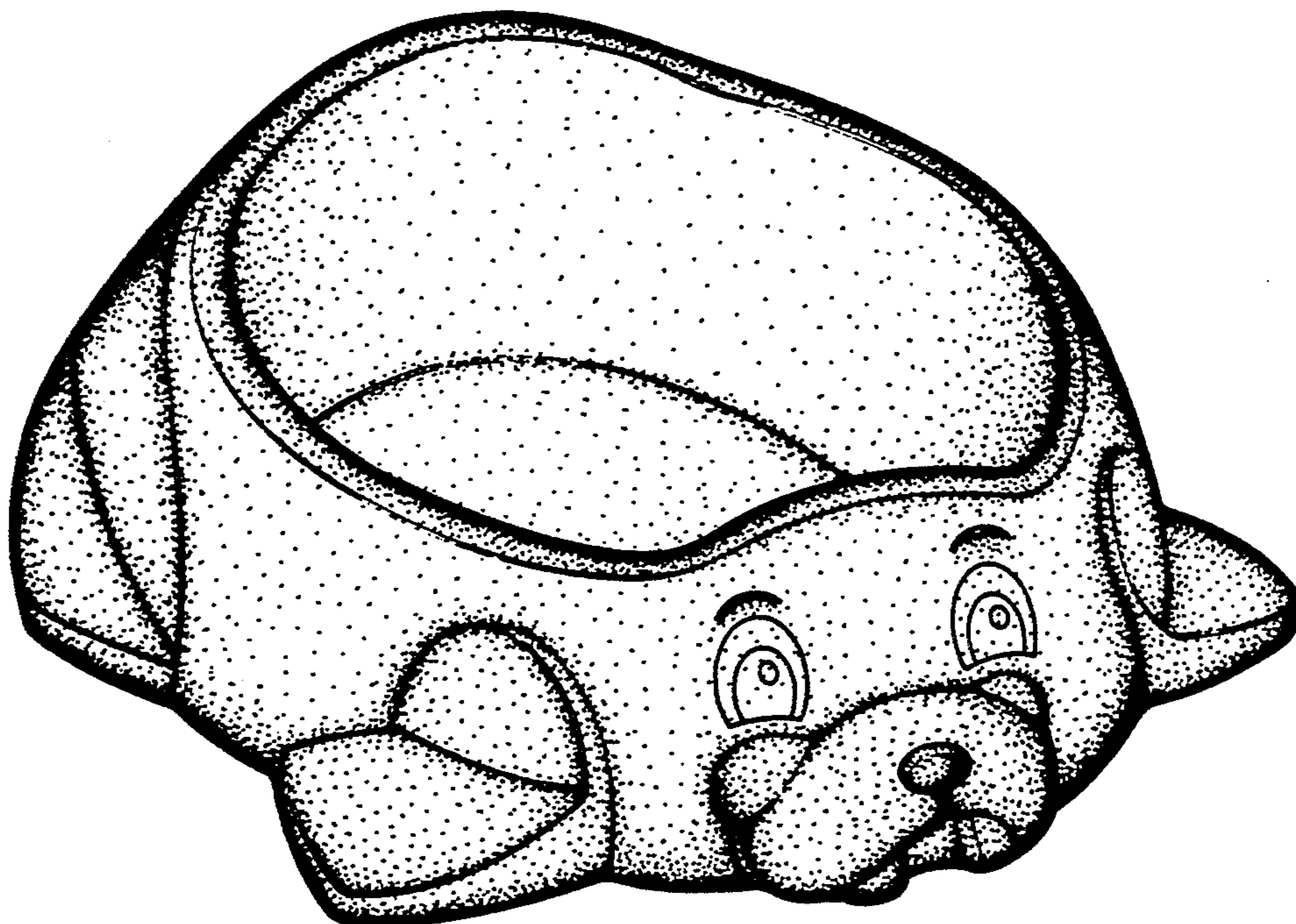
FIG. 2 is a front elevational view thereof;

FIG. 6 is a right side elevational view thereof; the left side elevational view being a mirror image.



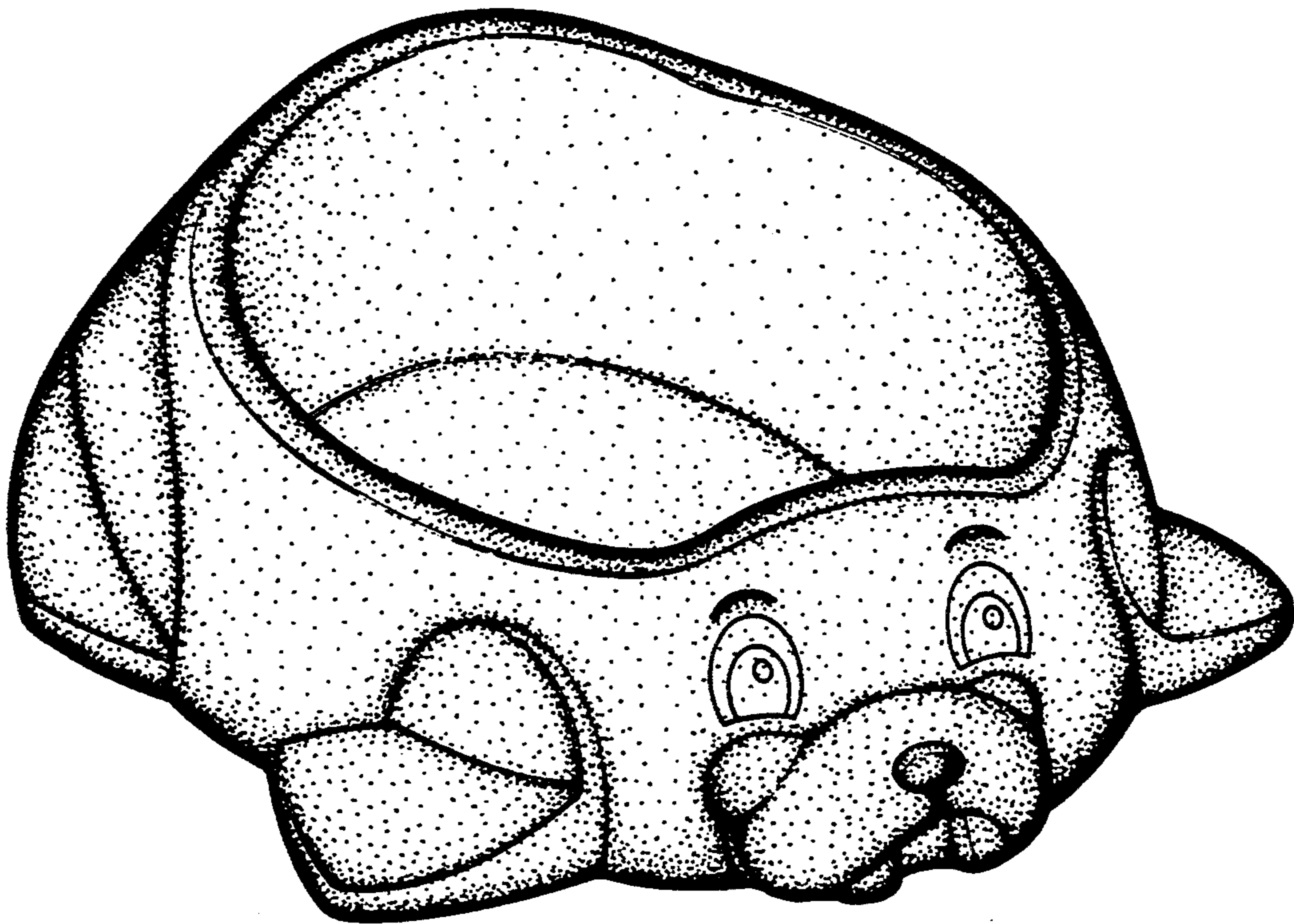

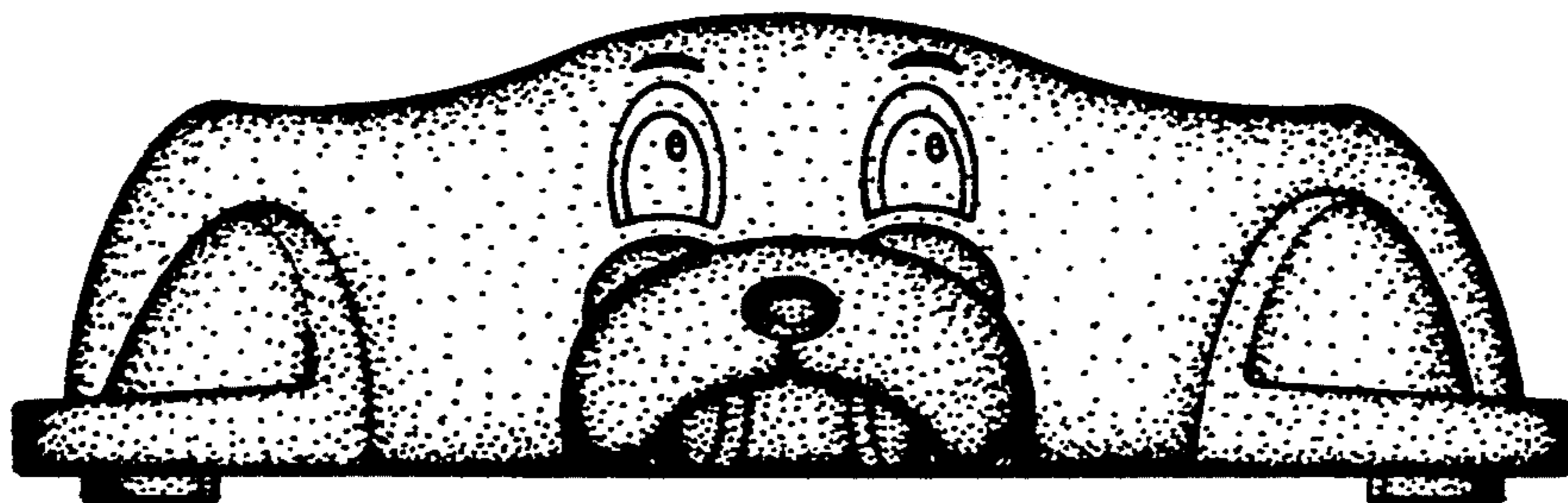

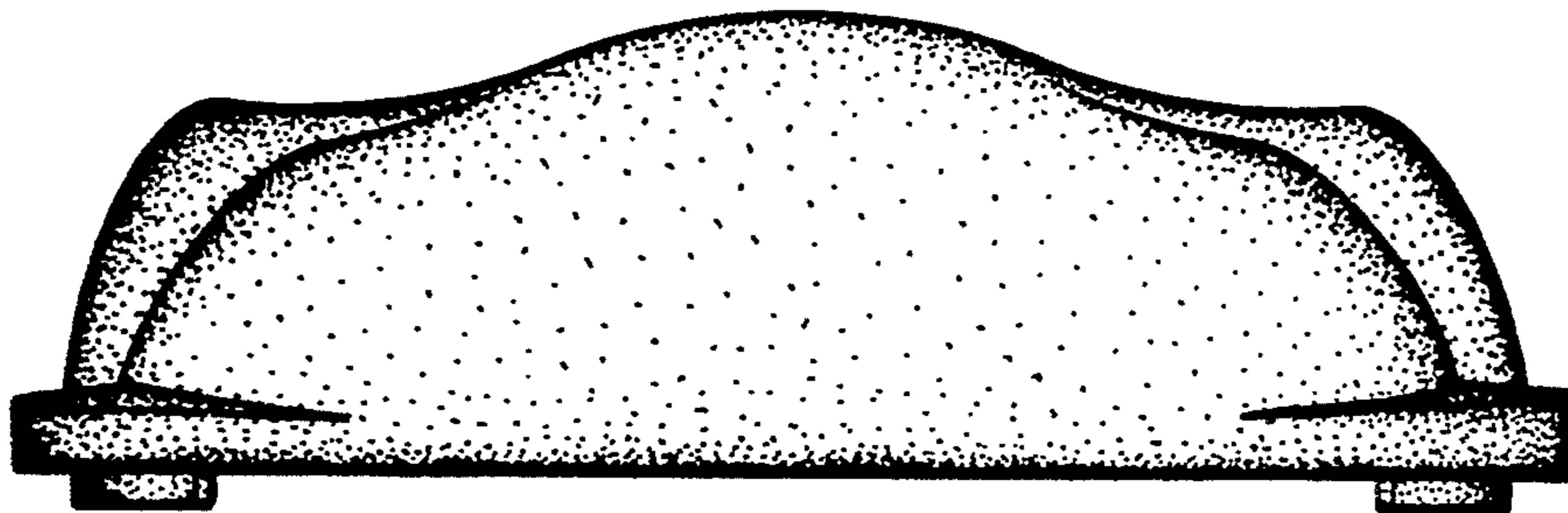

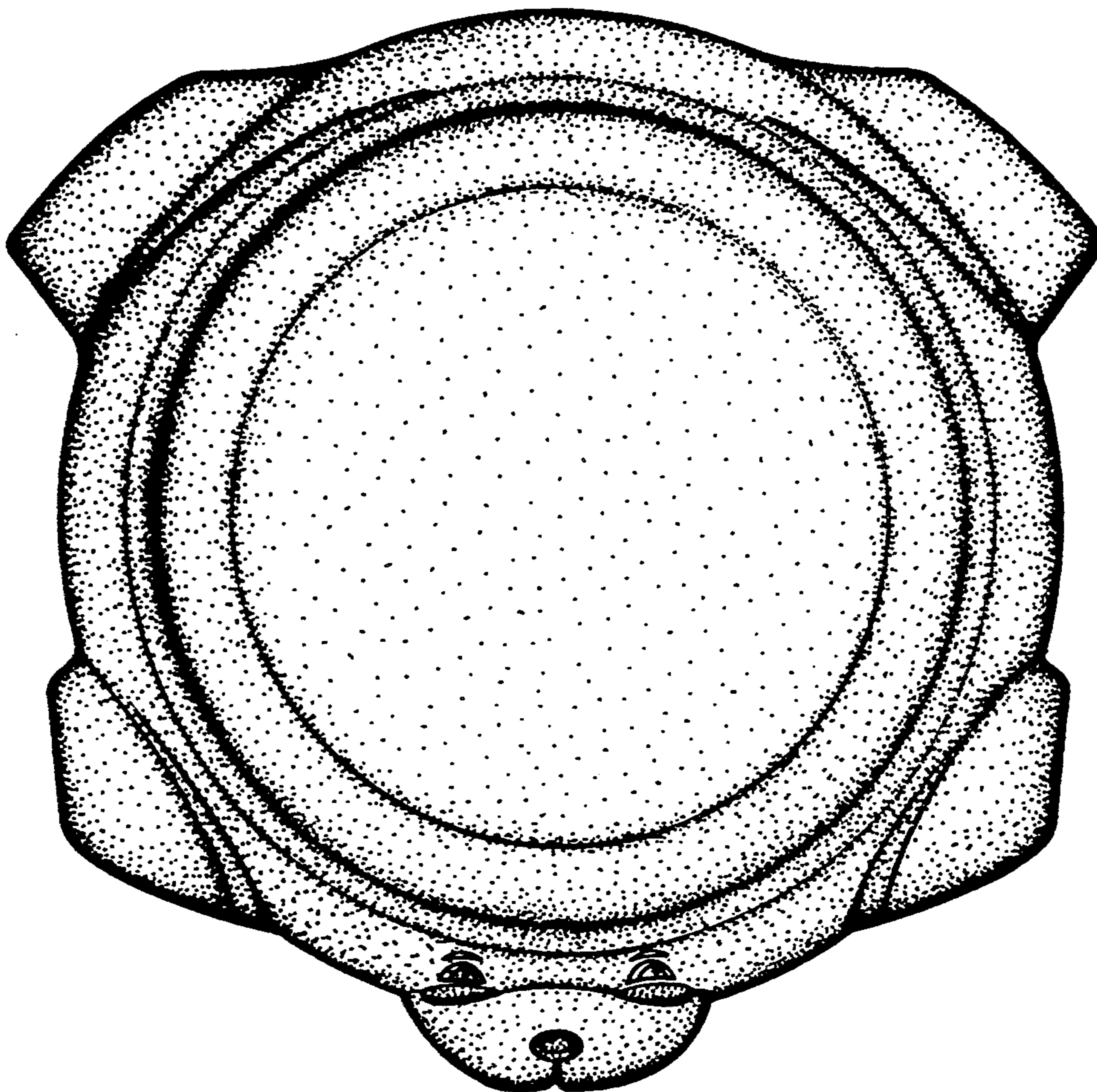

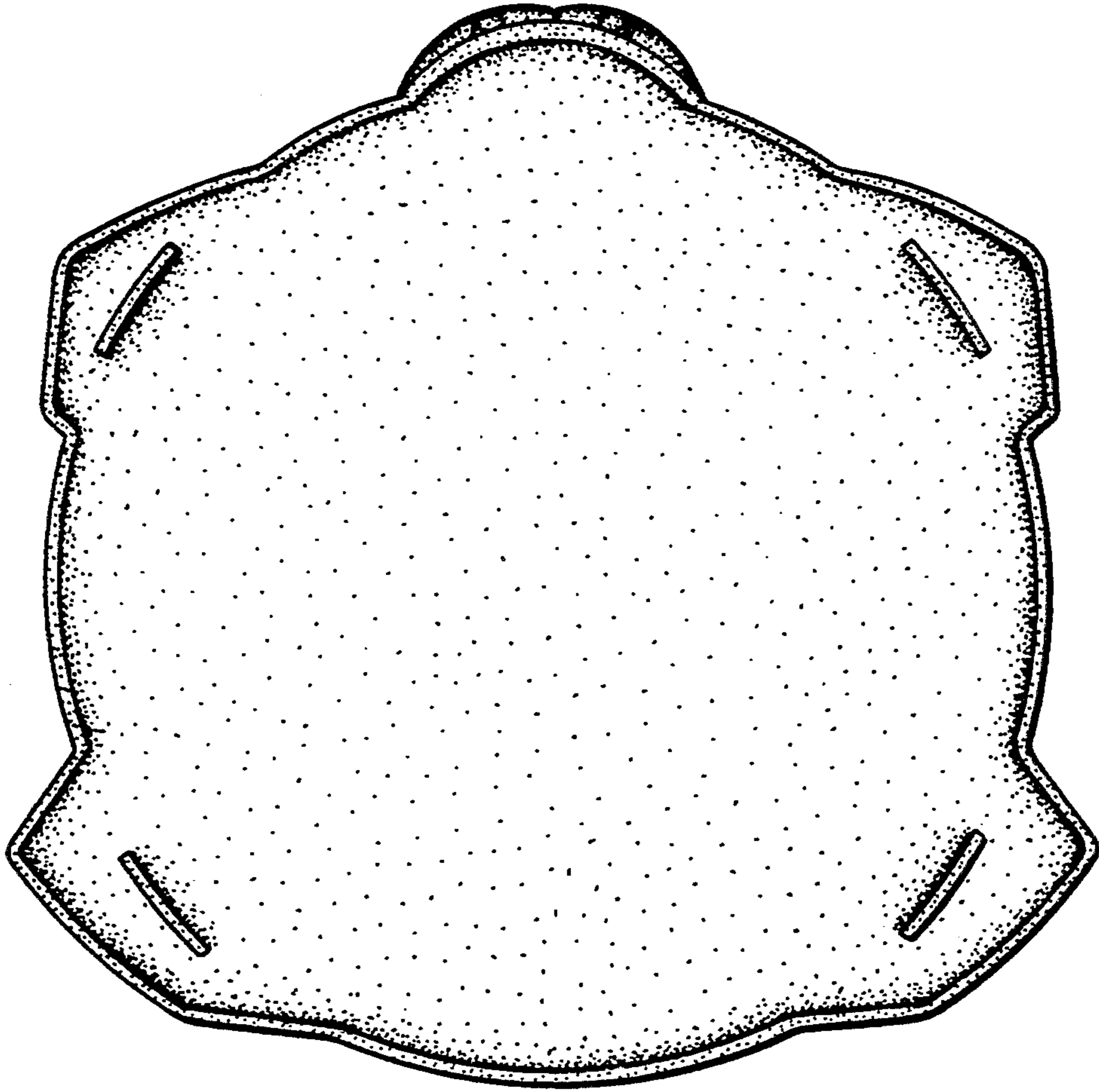

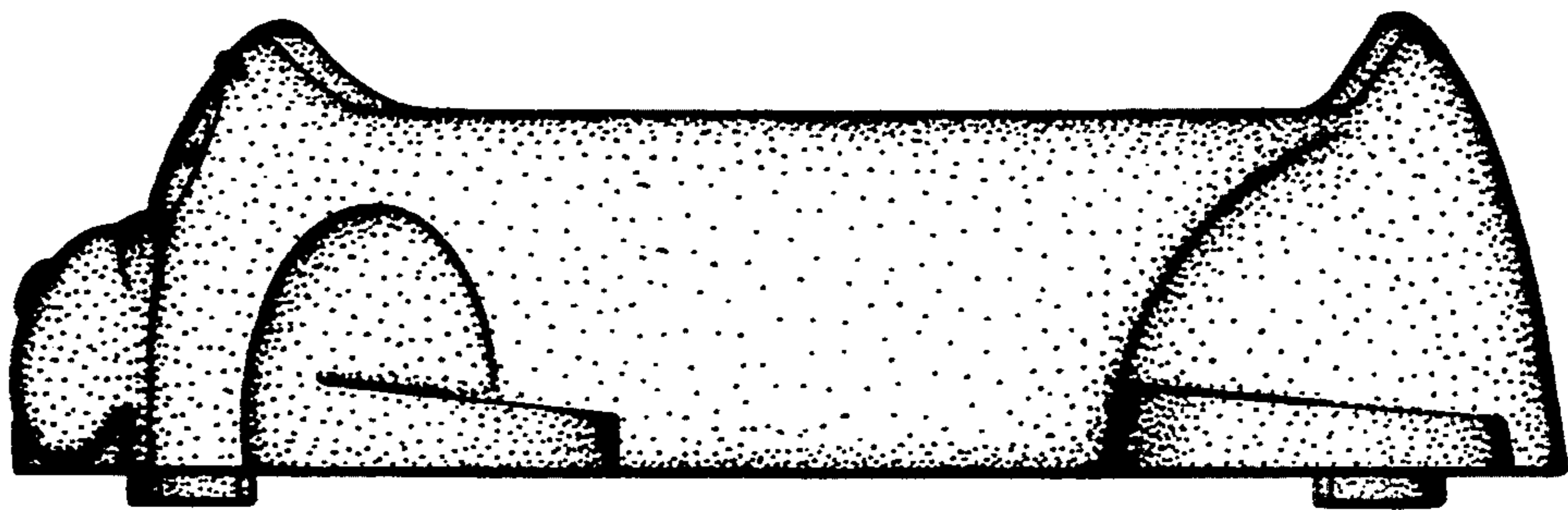
