[57] CLAIM

The ornamental design for a combined multi-page organizer and page marker, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a combined multi-page organizer and page marker showing my new design in an opened position, a booklet and writing instrument shown in phantom;

FIG. 2 is a top perspective view thereof, with a writing instrument shown in phantom;

FIG. 3 is a top perspective view thereof, with the page marker shown in an alternate position for clarity of illustration only;

FIG. 4 is a perspective view of my ornamental design for my combined multi-page organizer and page marker in a closed position;

FIG. 5 is a top plan view thereof, in a fully opened position;

FIG. 6 is a bottom plan view thereof;

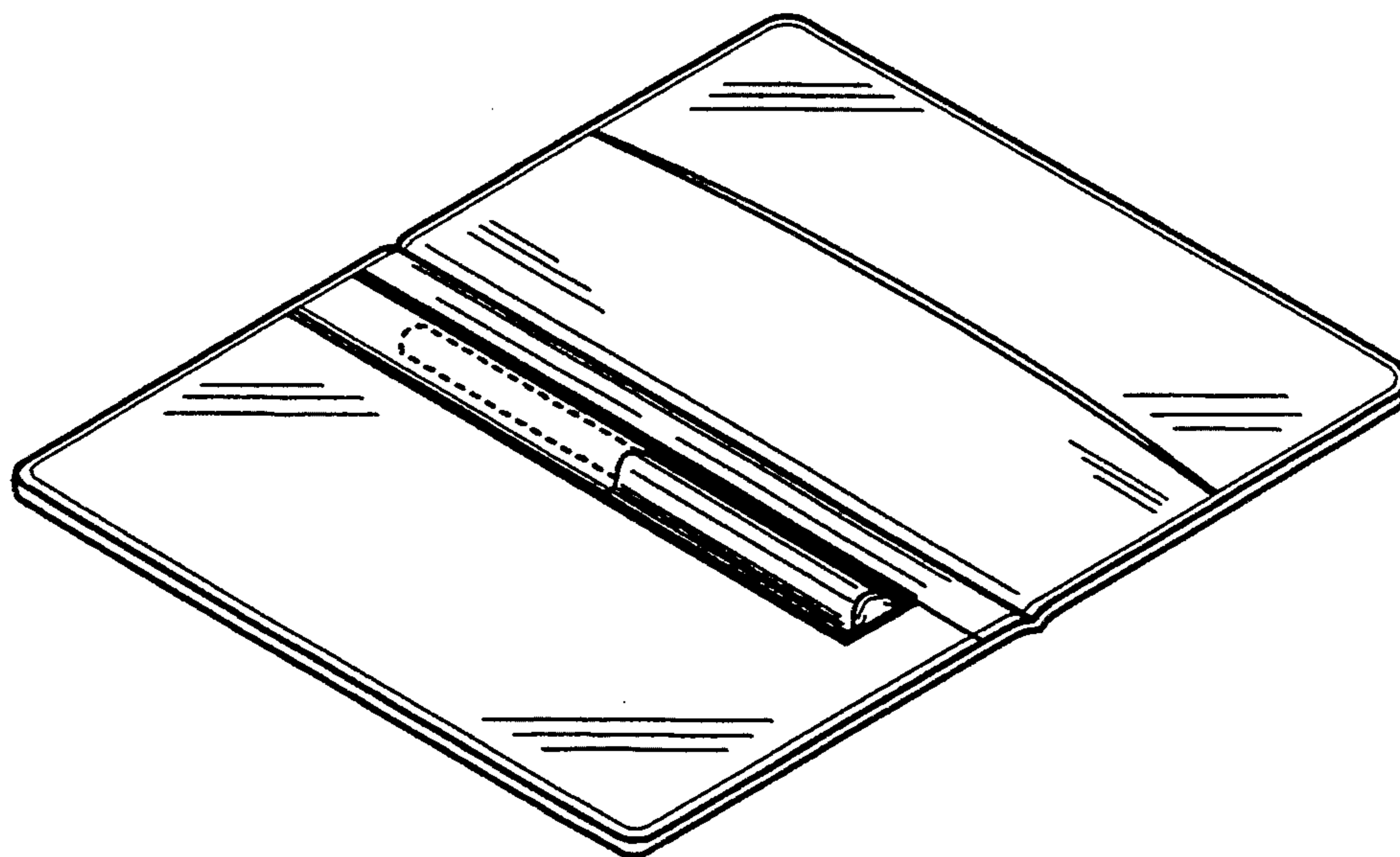
FIG. 7 is a side elevational view thereof;

FIG. 8 is a side elevational view thereof the side opposite that shown in FIG. 7;

FIG. 9 is an end plan view thereof; and,

FIG. 10 is an end plan view thereof the end opposite that shown in FIG. 9.

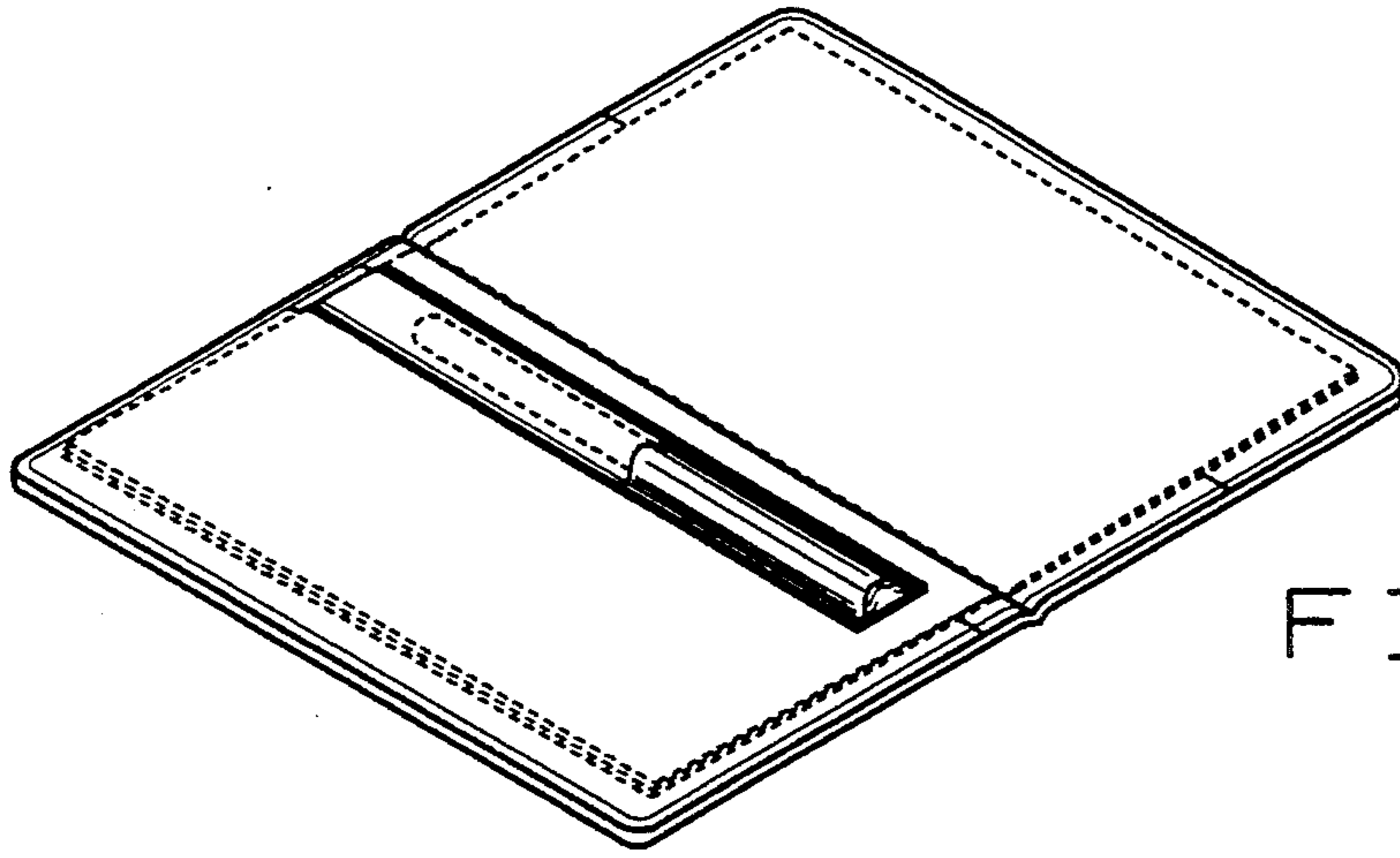

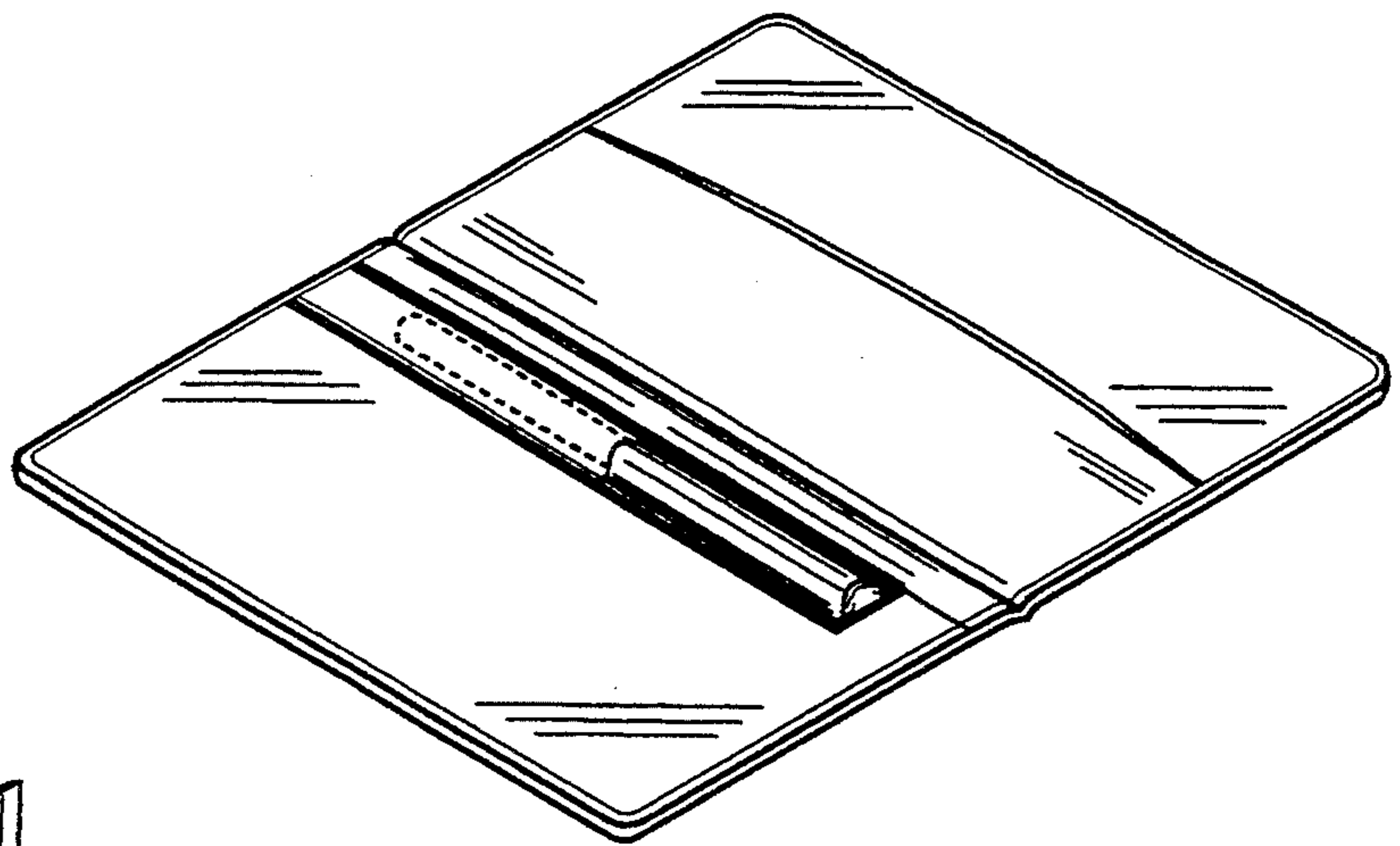

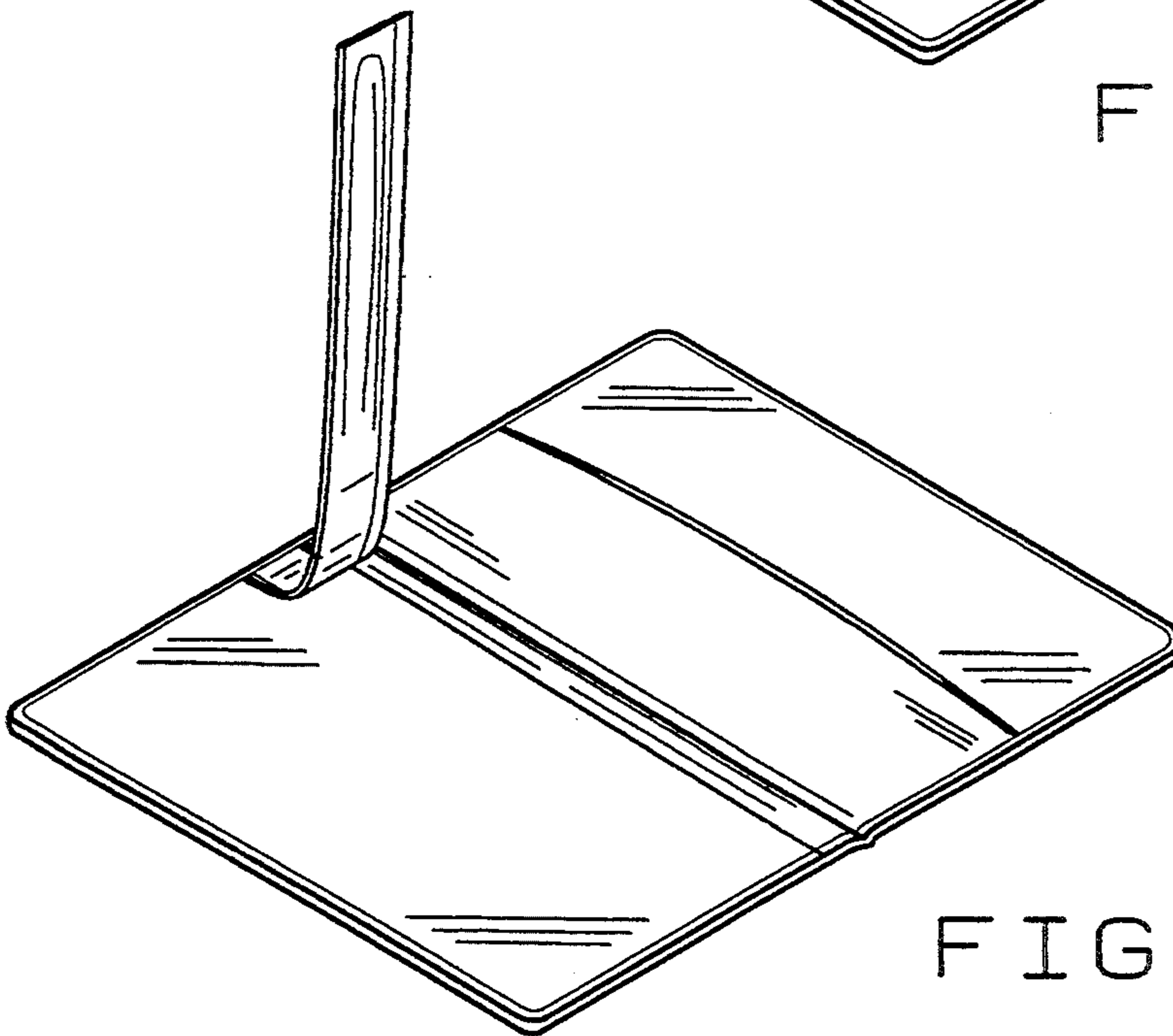

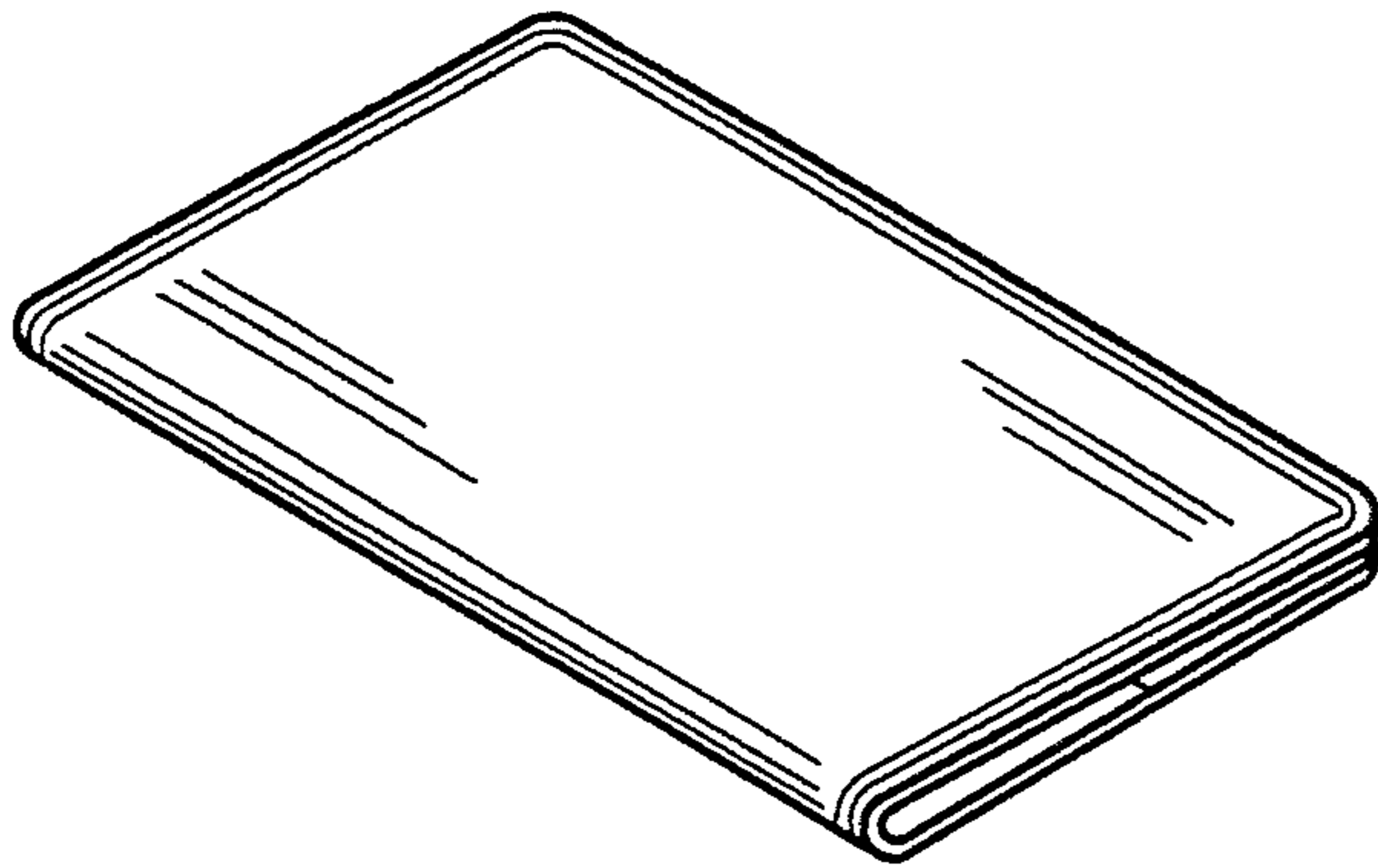

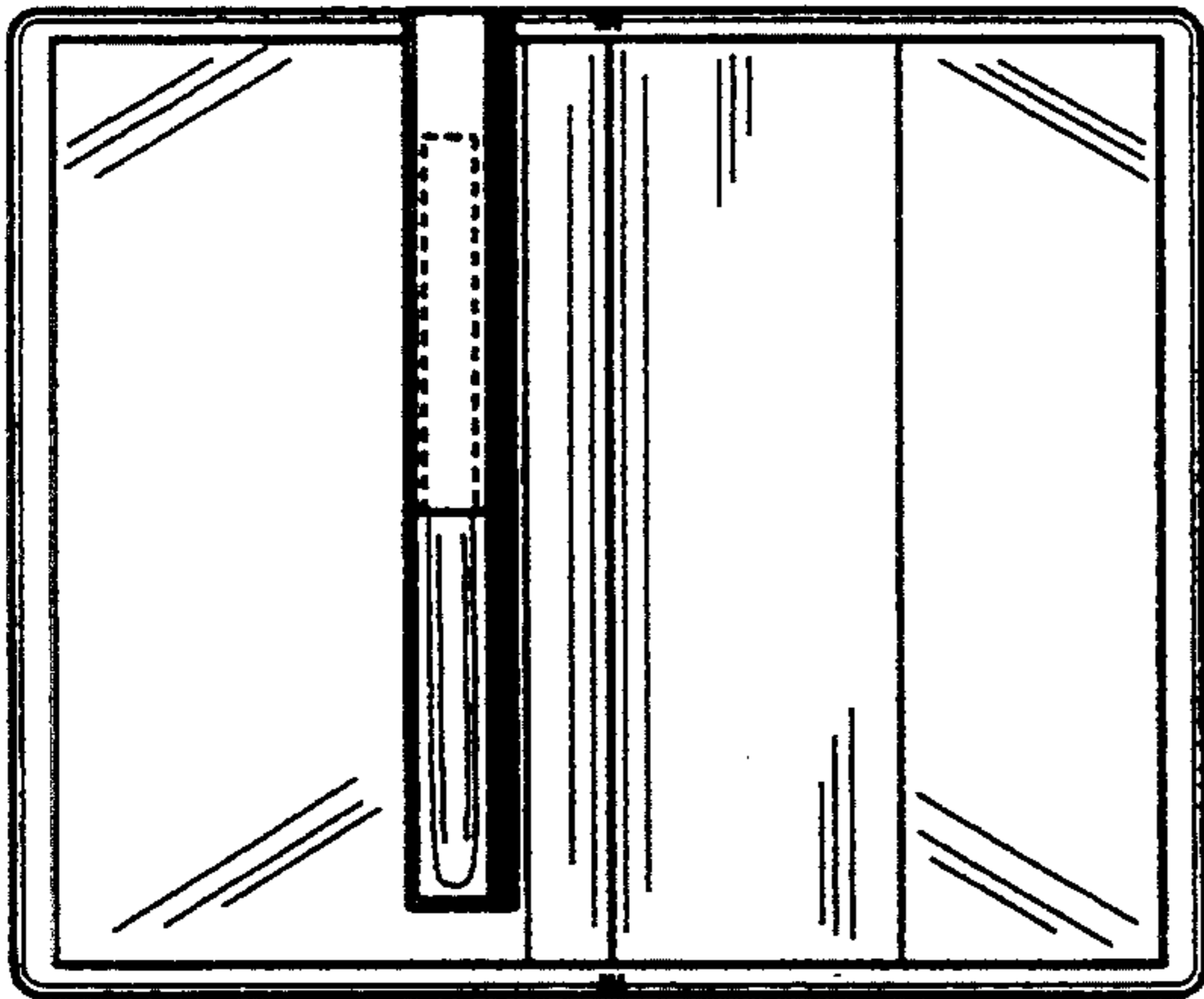

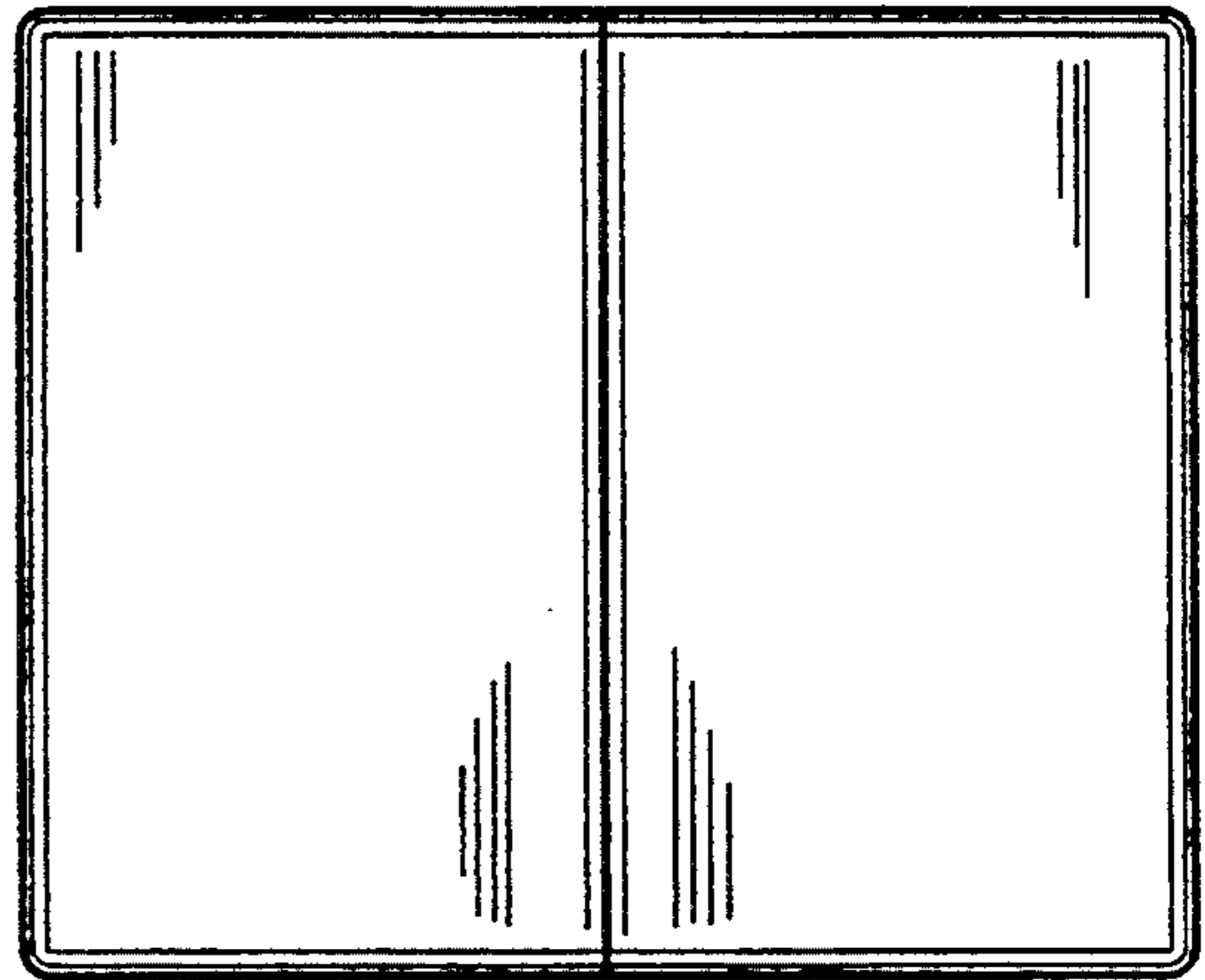
