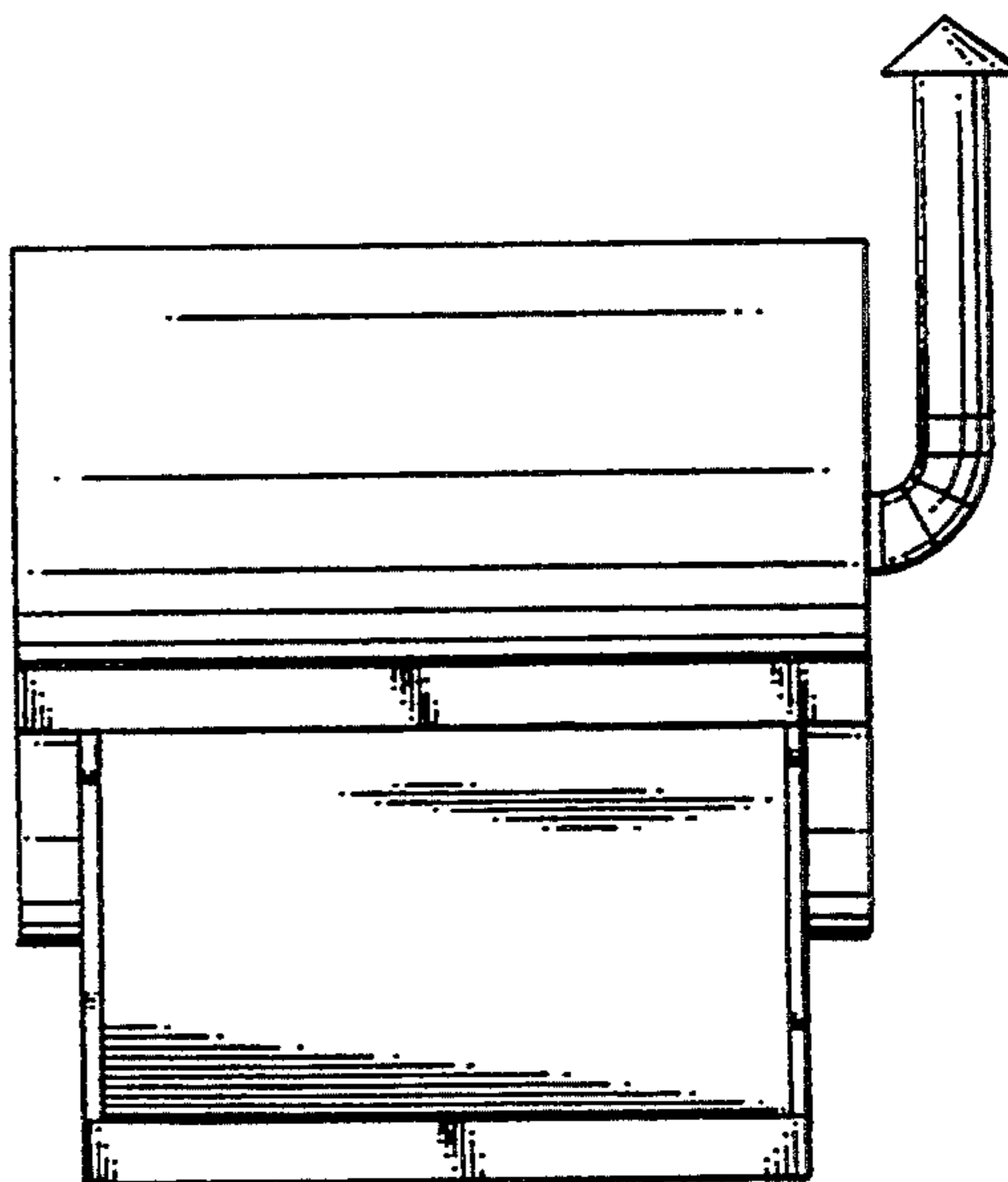
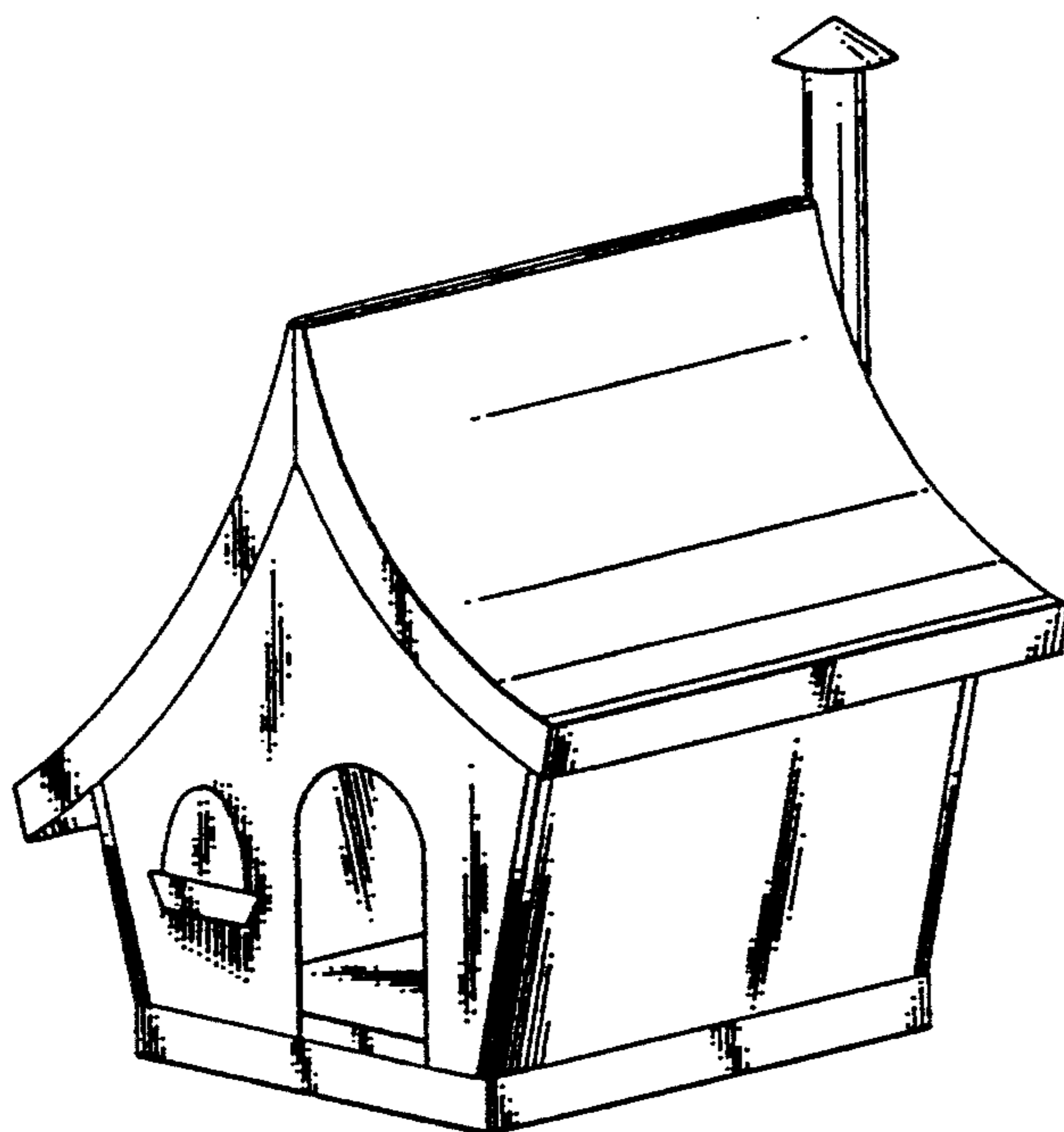

The ornamental design for a dog house, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the dog house of the invention;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a left side elevation view thereof;  
FIG. 4 is a rear perspective view thereof;  
FIG. 5 is a rear elevation view thereof; and,  
FIG. 6 is a right side elevation view thereof.  
The bottom is plain and unornamented.



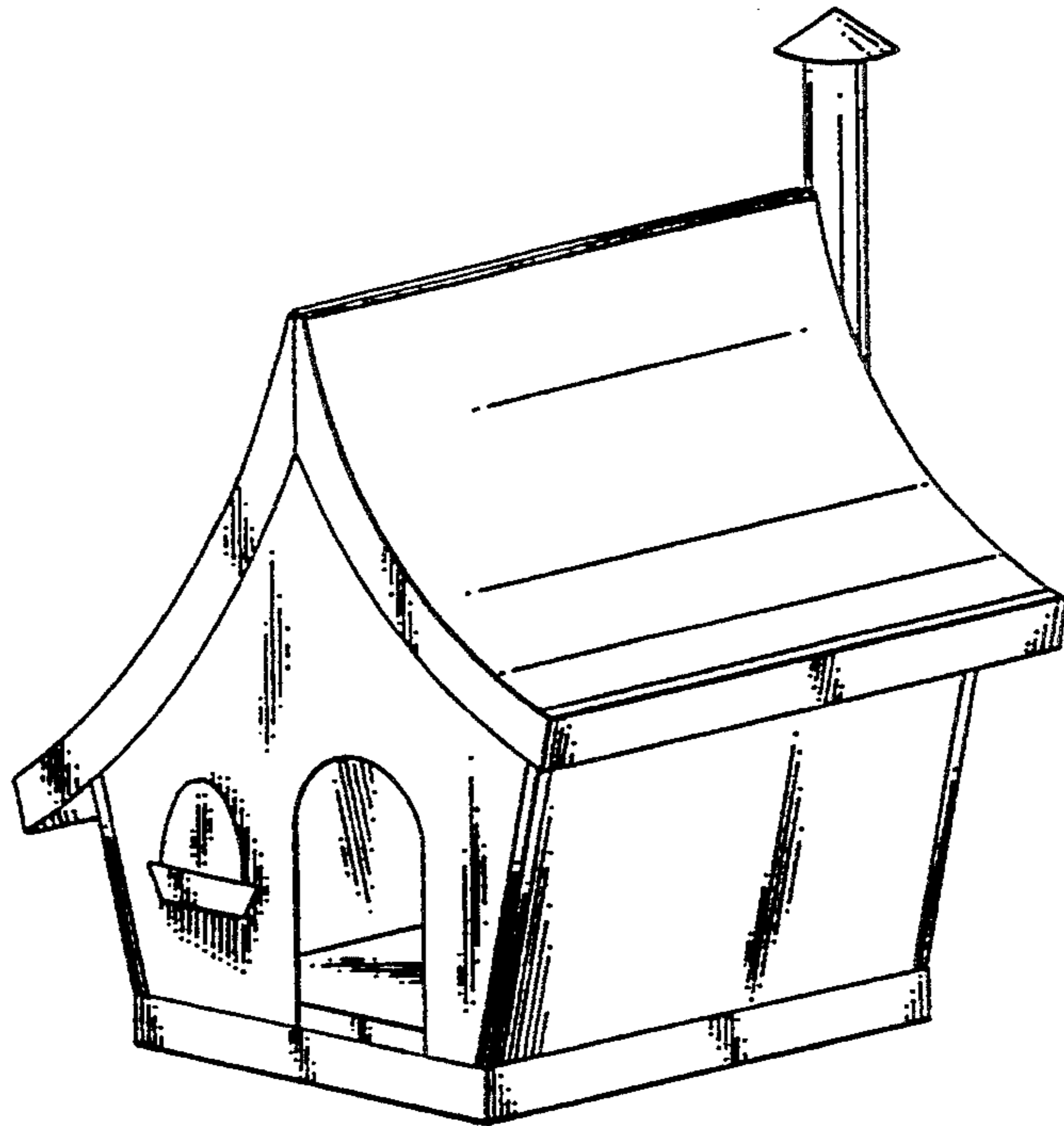

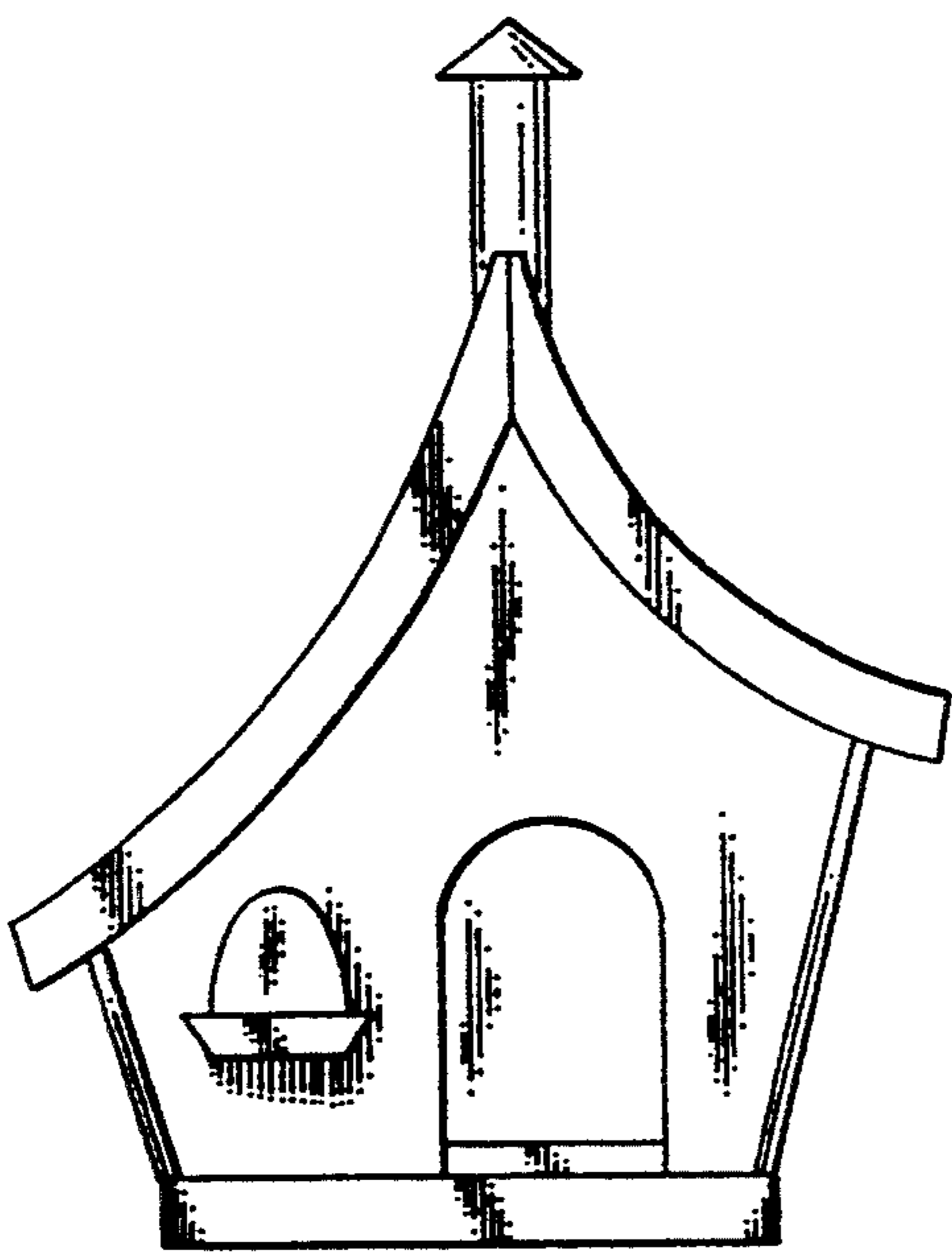

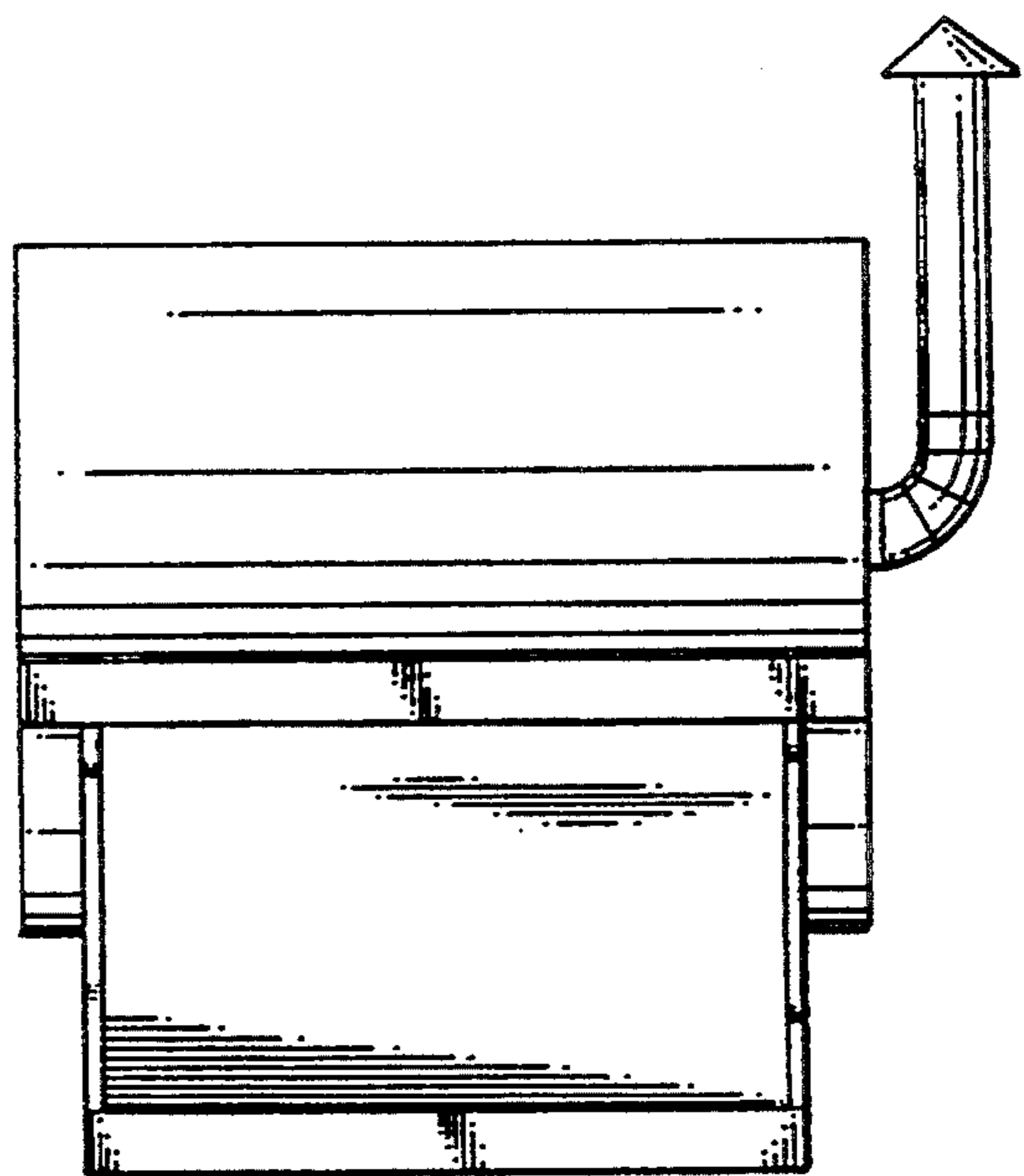

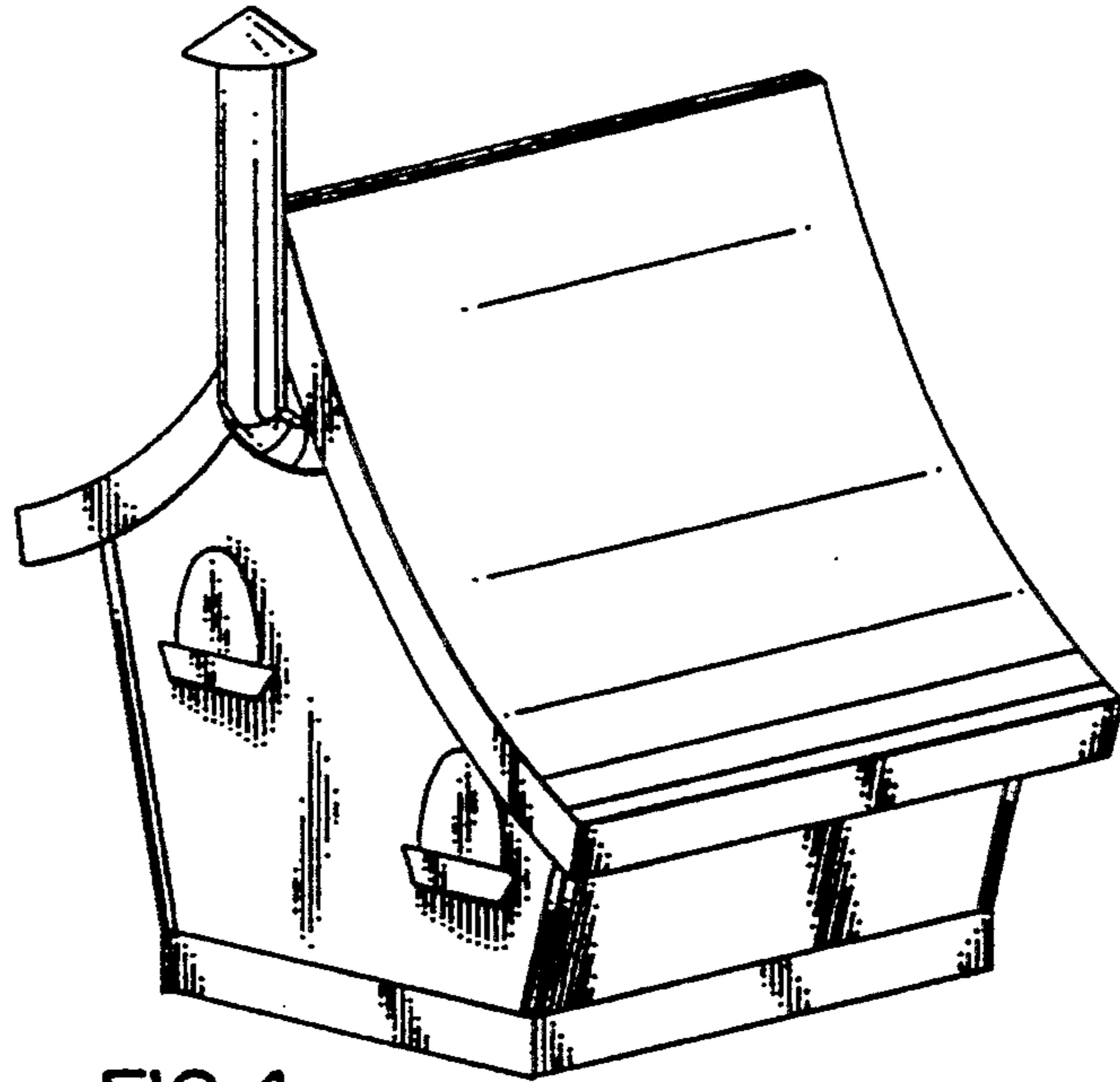

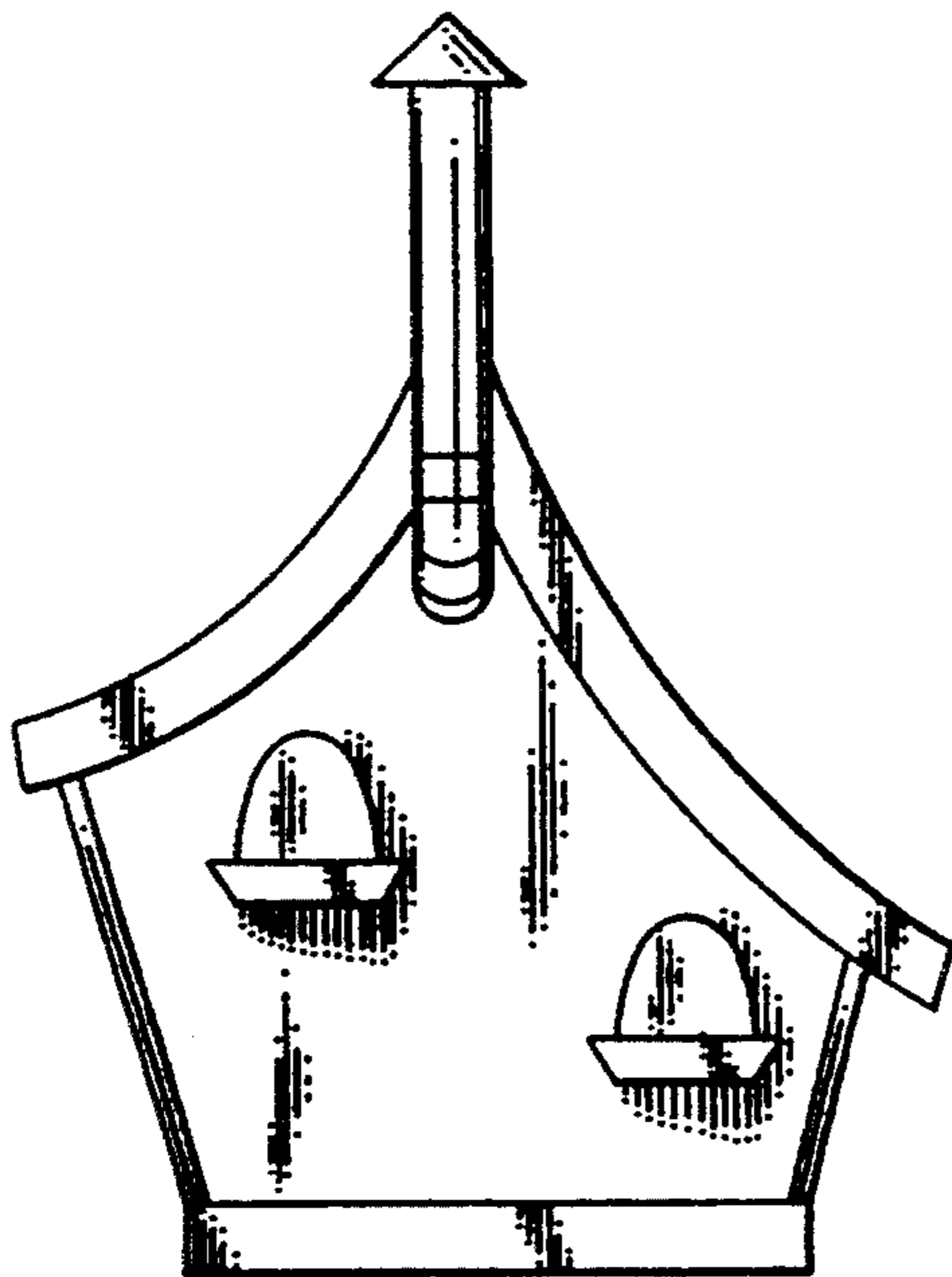

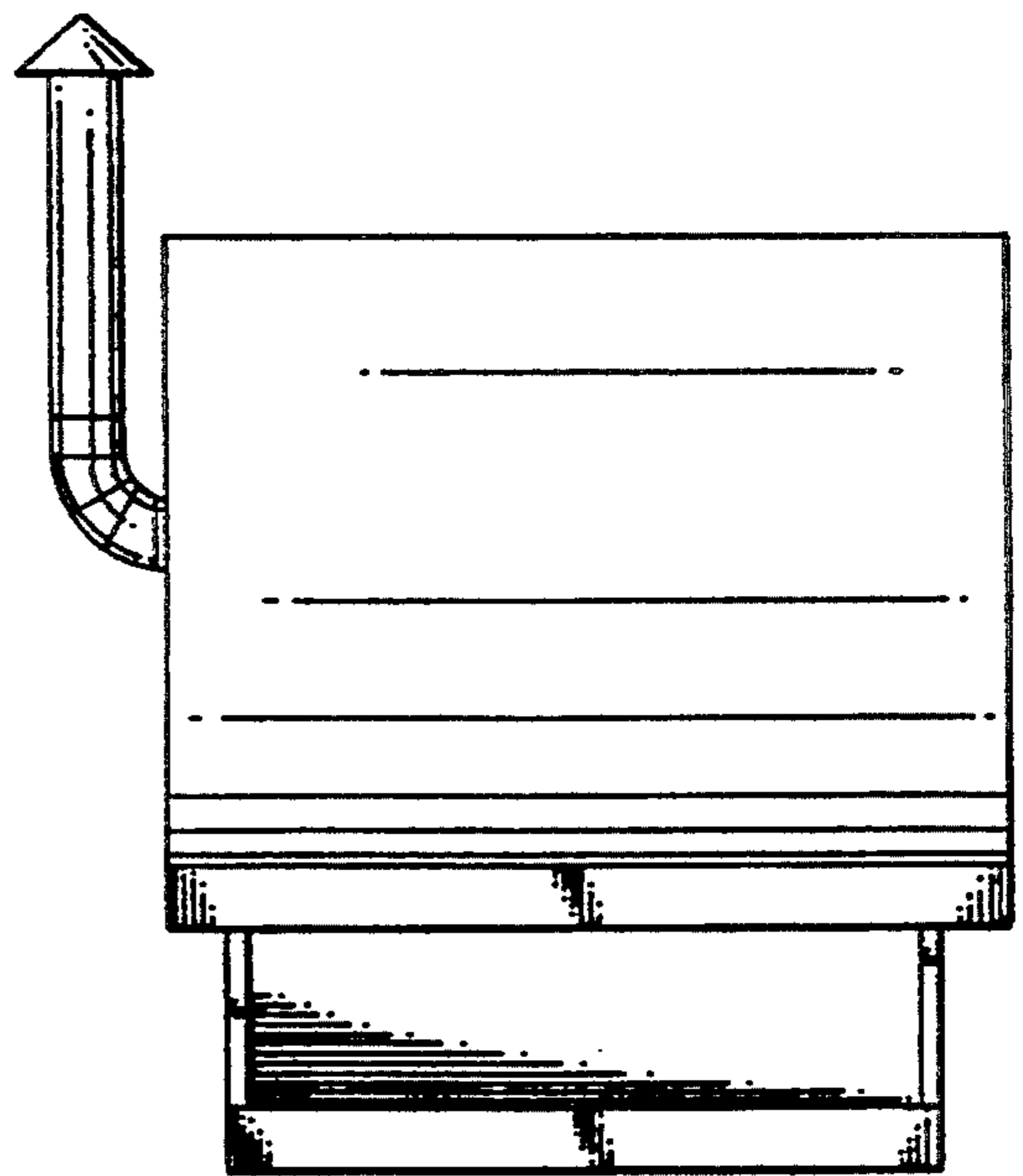
