### [57] CLAIM

The ornamental design for a toothbrush handle, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of the toothbrush handle embodying our design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a side elevational view thereof, the opposite side being a mirror image;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is an elevational view from the handle end thereof; and,  
 FIG. 6 is an elevational view from the brush head end thereof.  
 The broken line showing of bristles is for illustrative purposes only and forms no part of the claimed design.

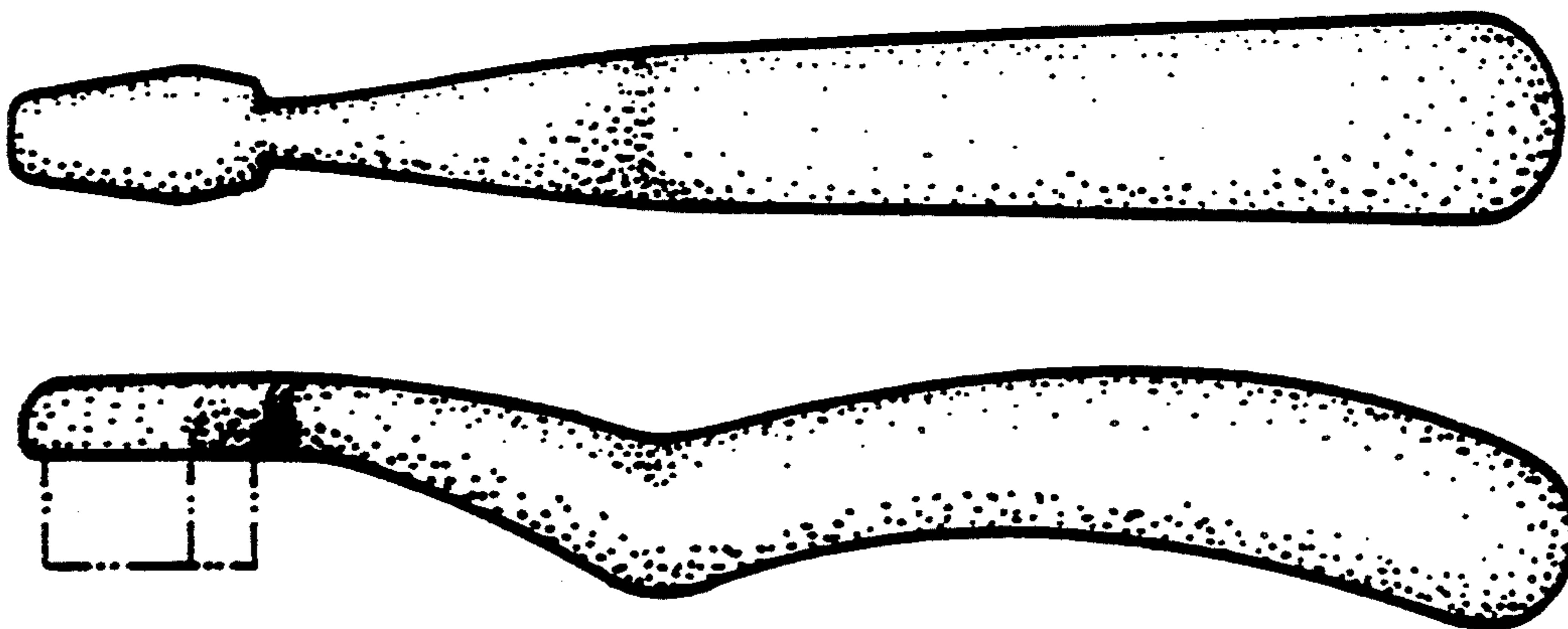

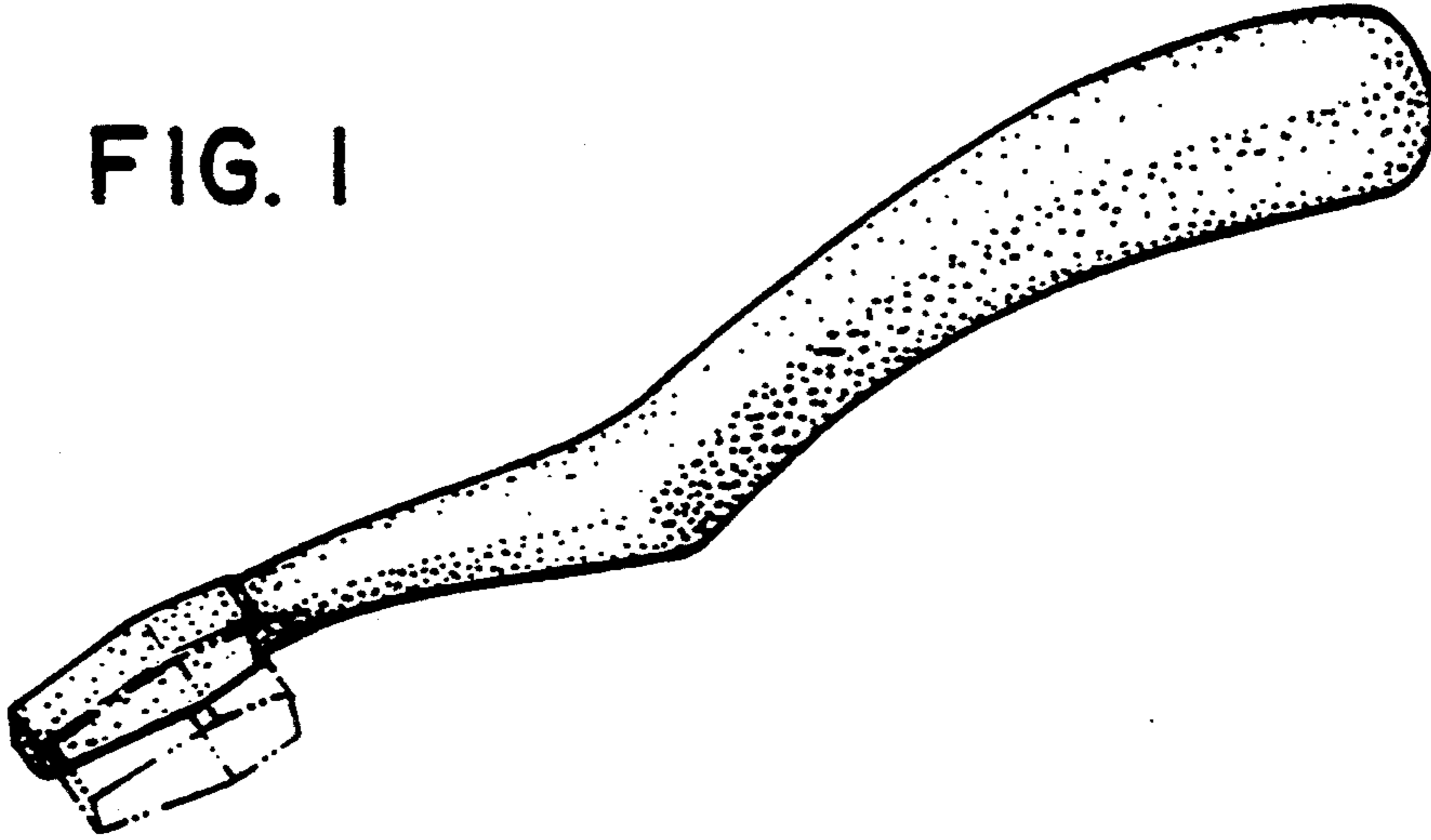

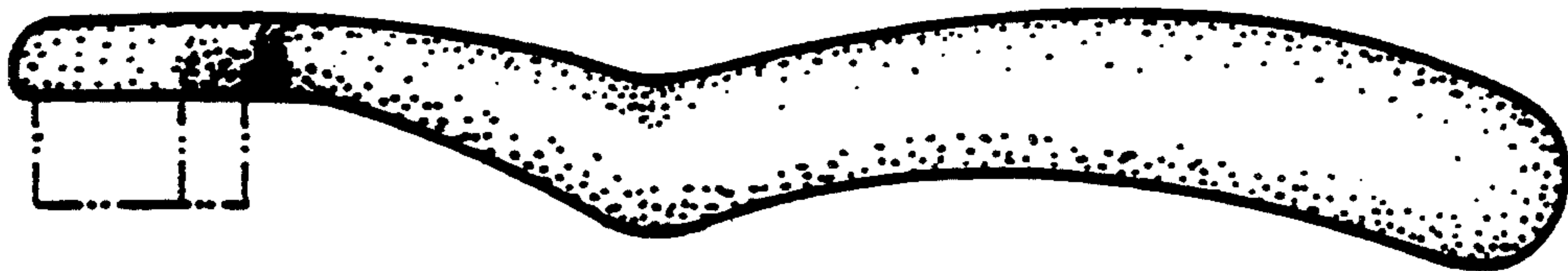

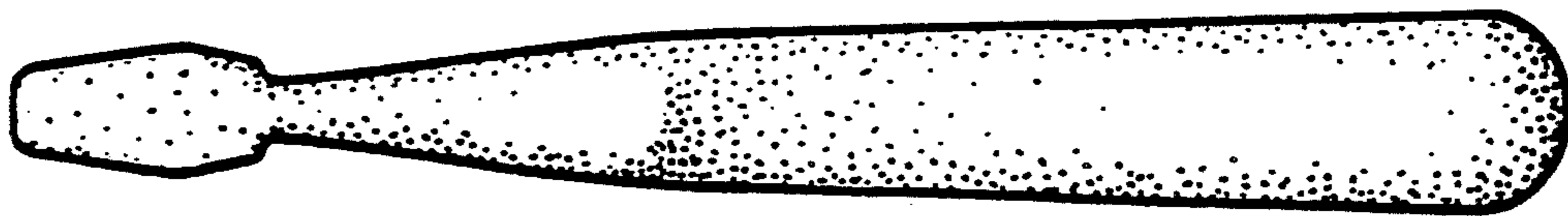

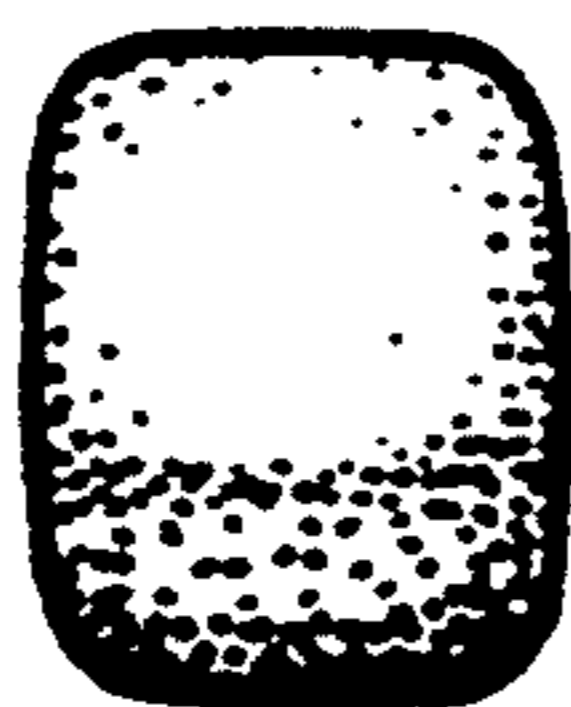
