The ornamental design for a case for a game cartridge or compact disk, as shown and described.

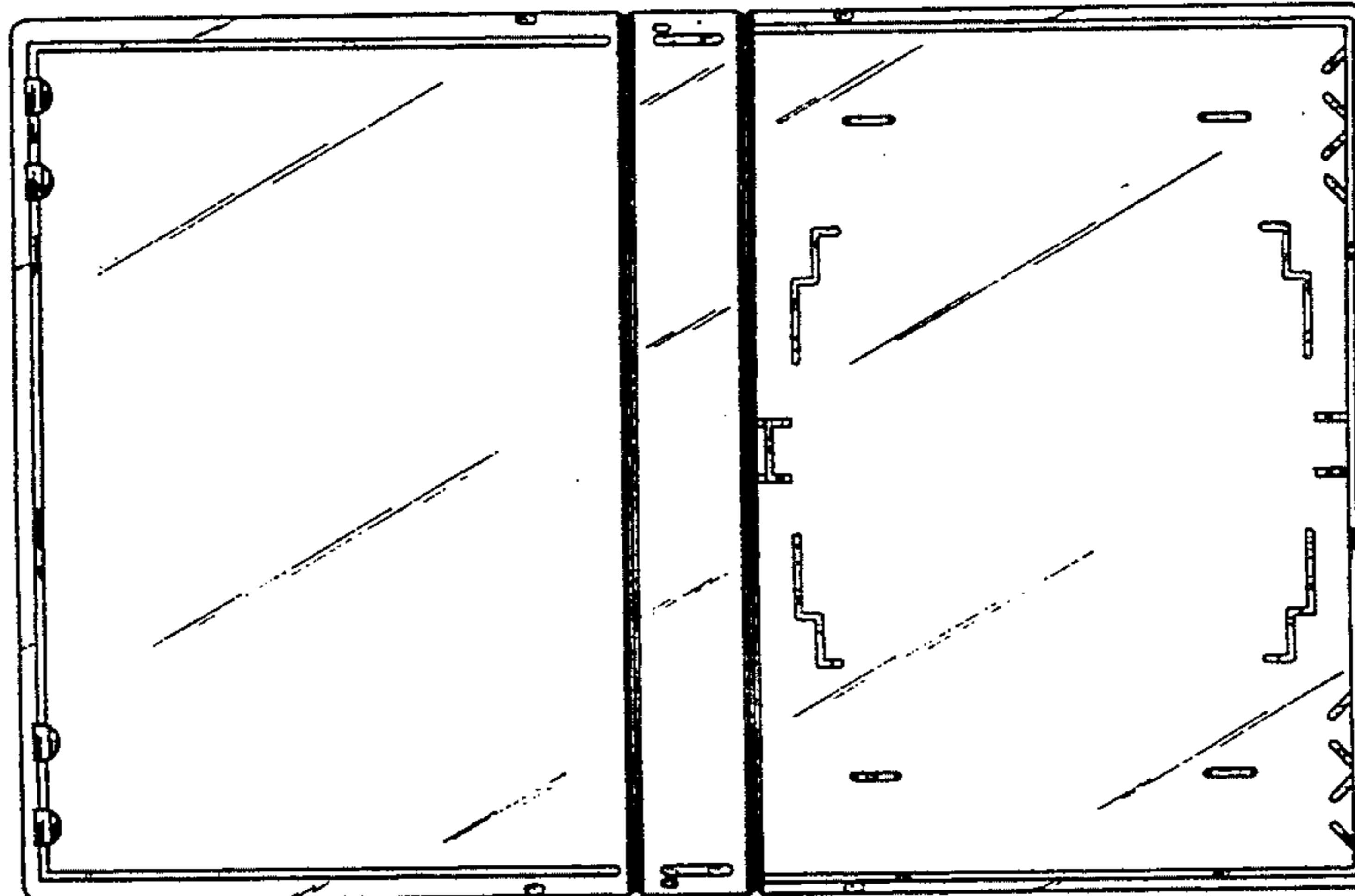
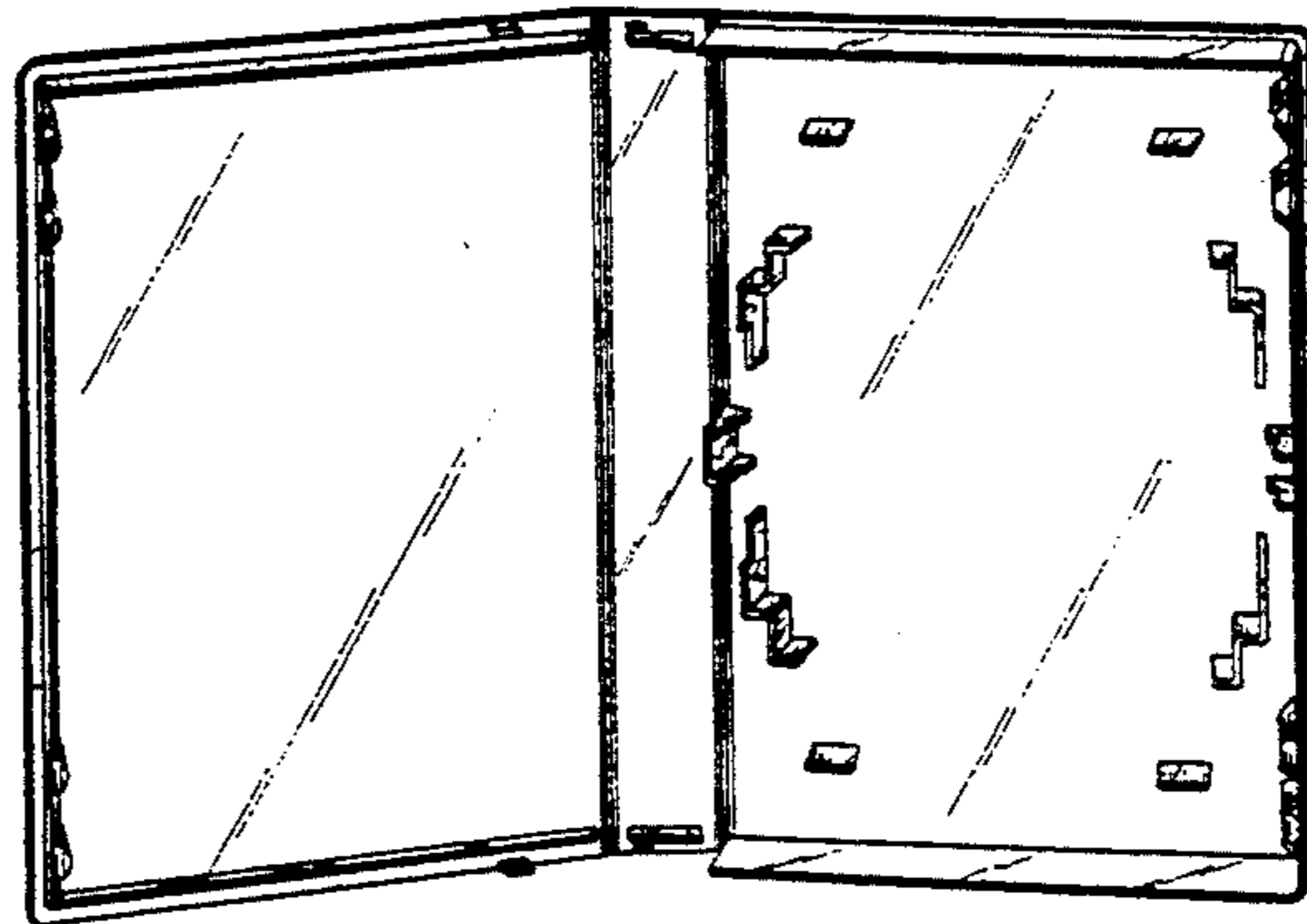
### DESCRIPTION

FIG. 1 is a perspective view of a case for a game cartridge or compact disk, with its two panels pivoted open, showing my new design;  
FIG. 2 is an enlarged front elevational view thereof shown in a closed position;  
FIG. 3 is a right side elevational view of FIG. 2;  
FIG. 4 is a left side elevational view of FIG. 2;  
FIG. 5 is a top plan view of FIG. 2, the bottom plan view being a mirror image thereof;  
FIG. 6 is a rear elevational view of FIG. 2; and,  
FIG. 7 is an enlarged front elevational view of FIG. 1.

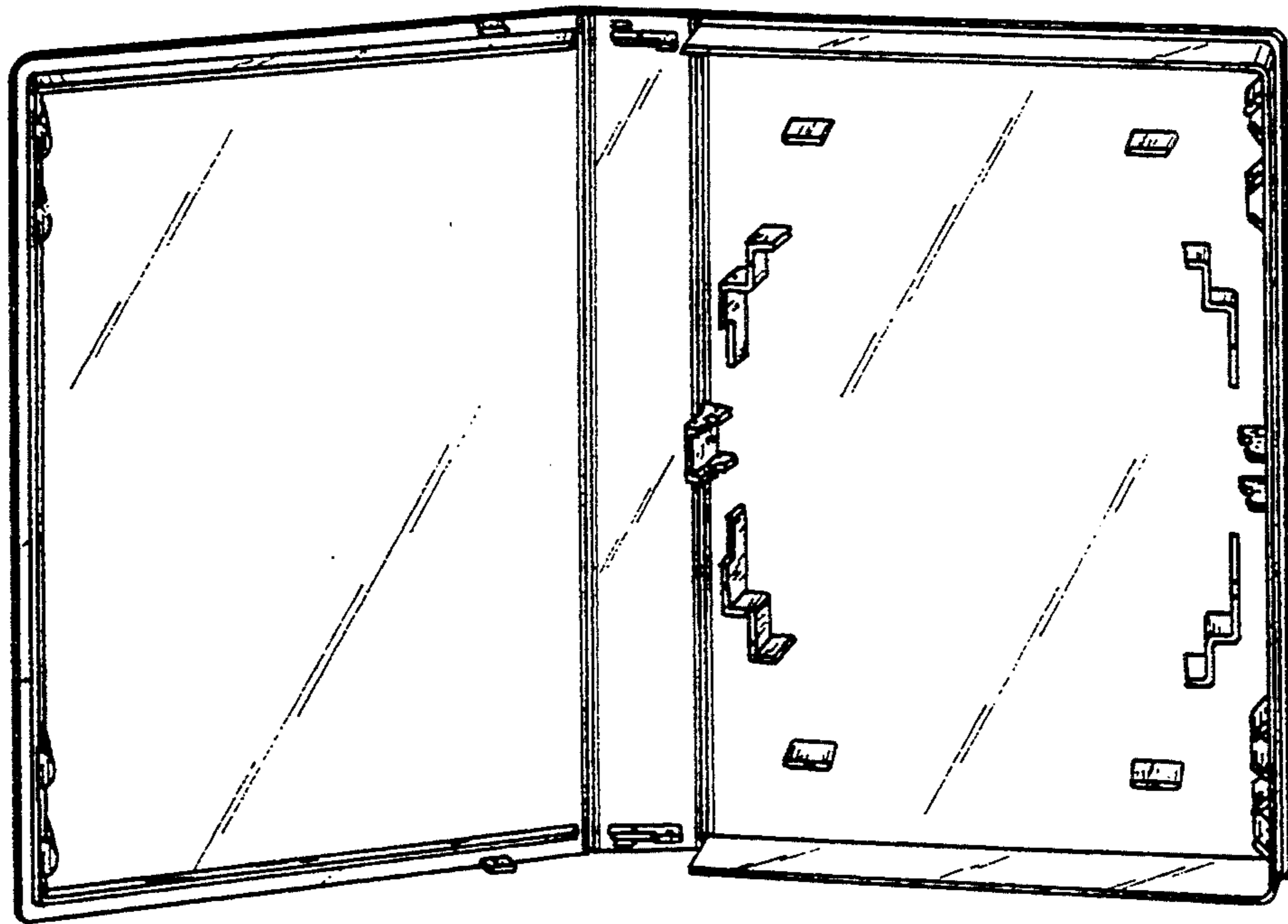

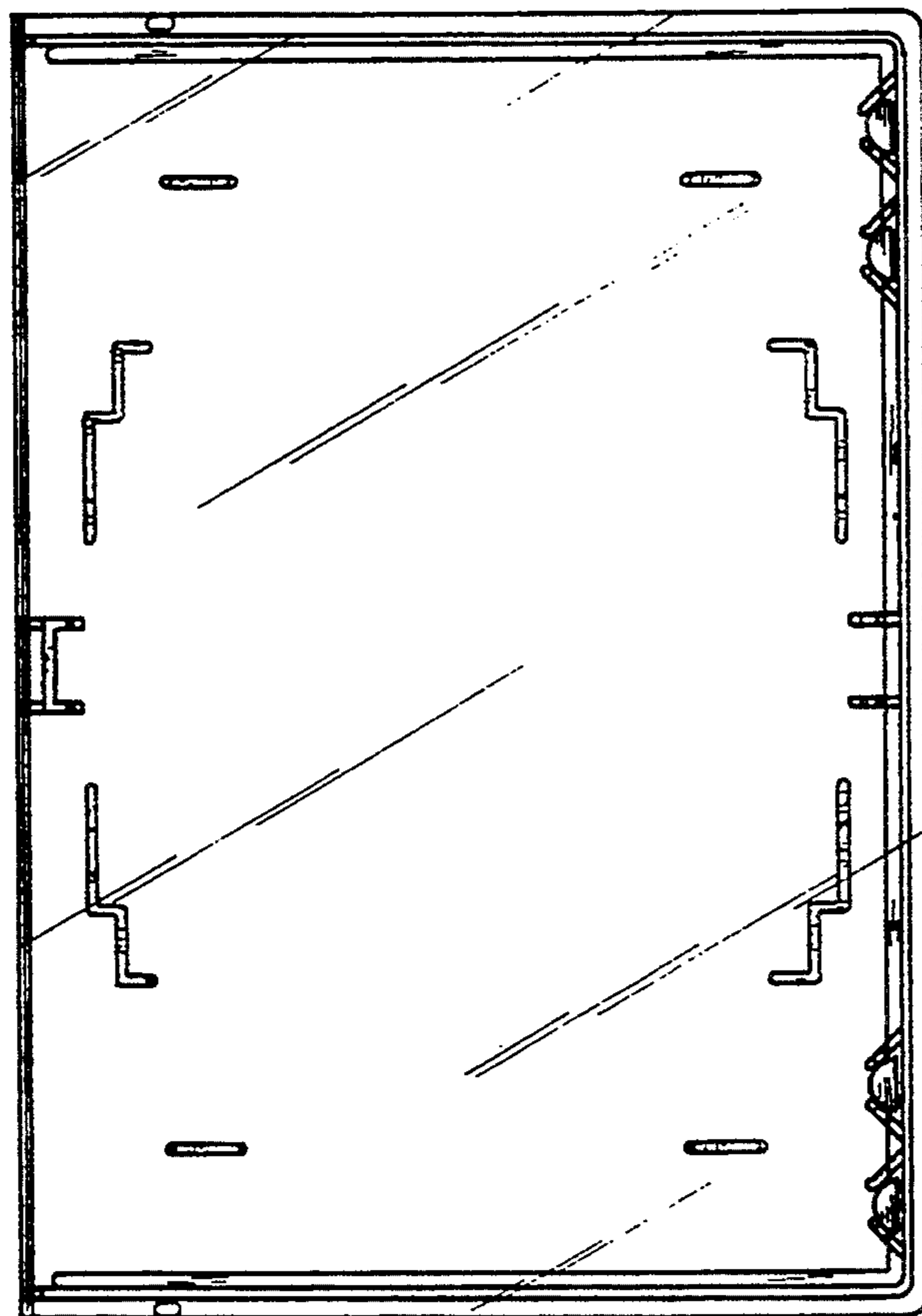

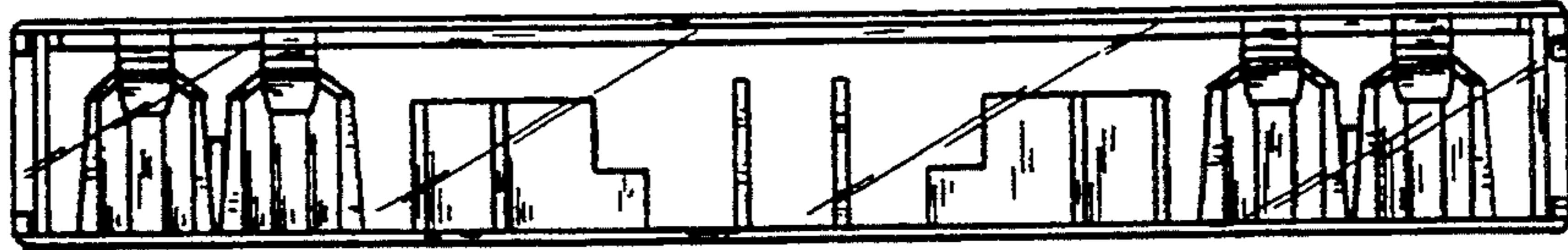

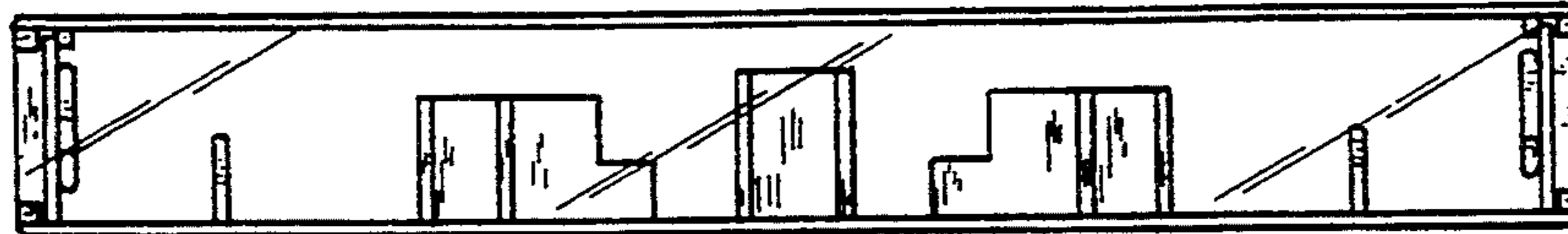

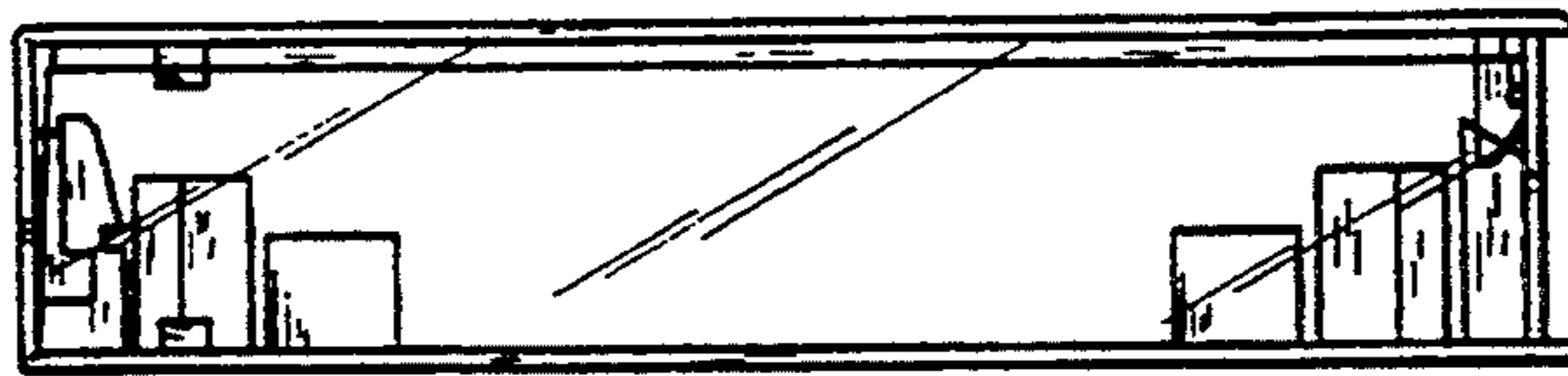

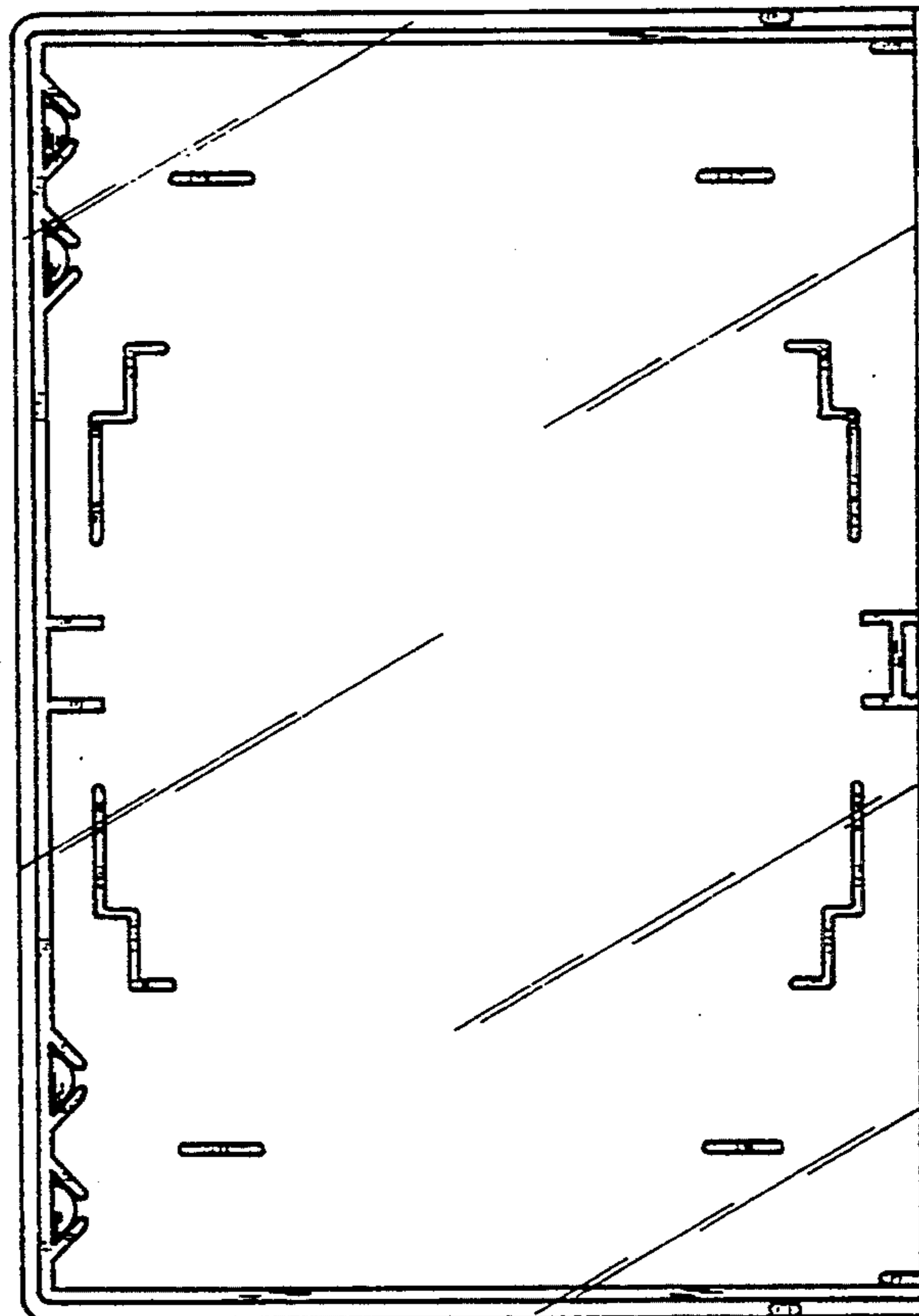

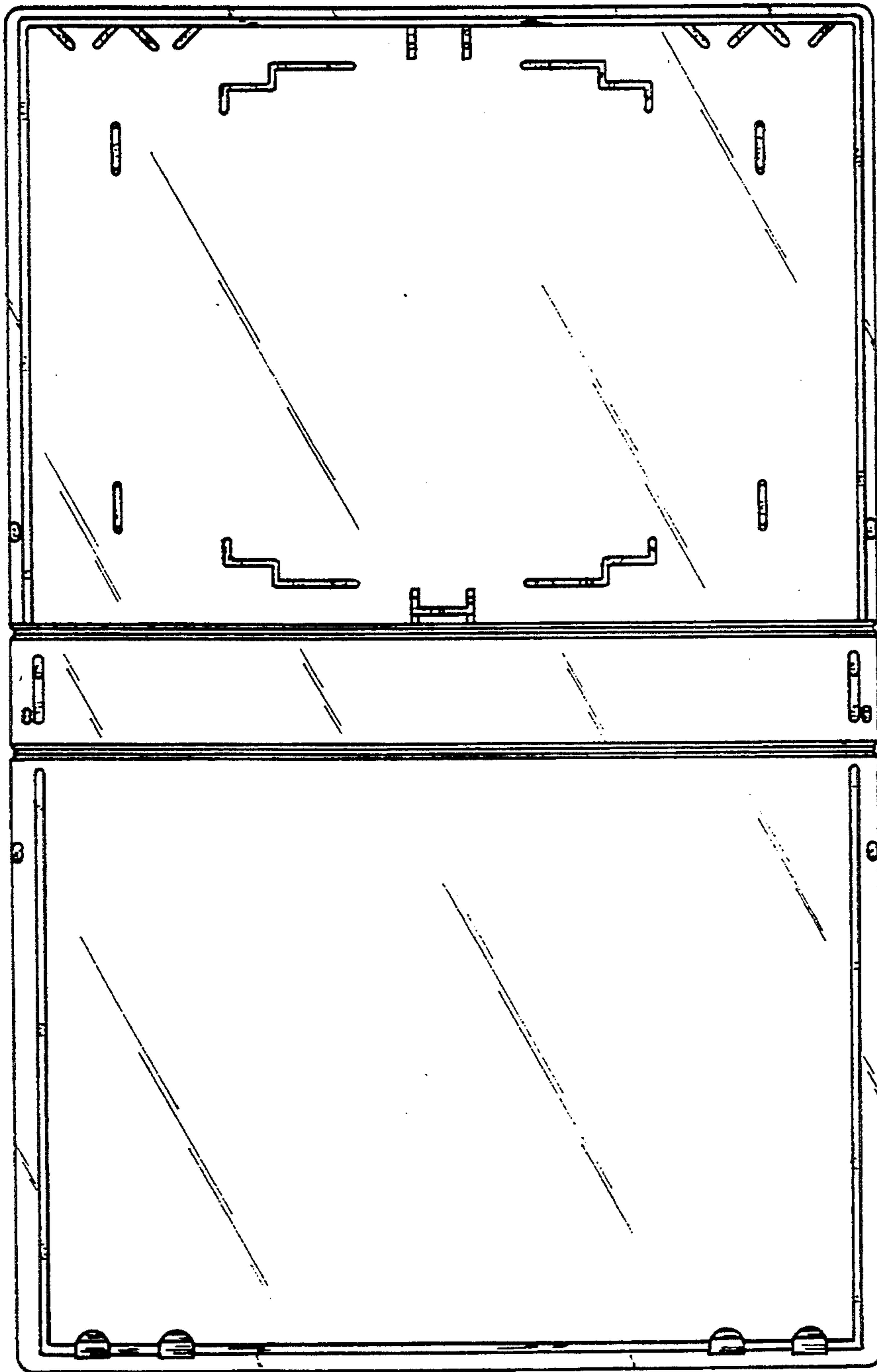
