### [57] CLAIM

The ornamental design for a holder for a drink container or snack food, as shown and described.

### DESCRIPTION

FIG. 1 is a front perspective view of a holder for a drink container or snack food showing my new design;  
FIG. 2 is a front perspective view thereof in an alternate position;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a side elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

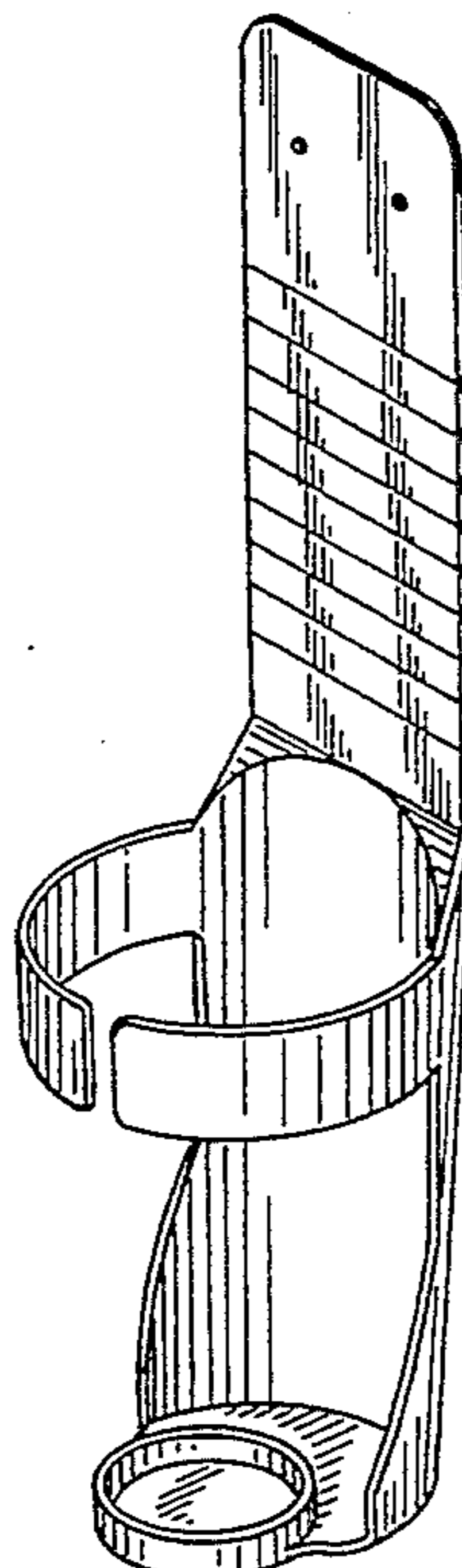

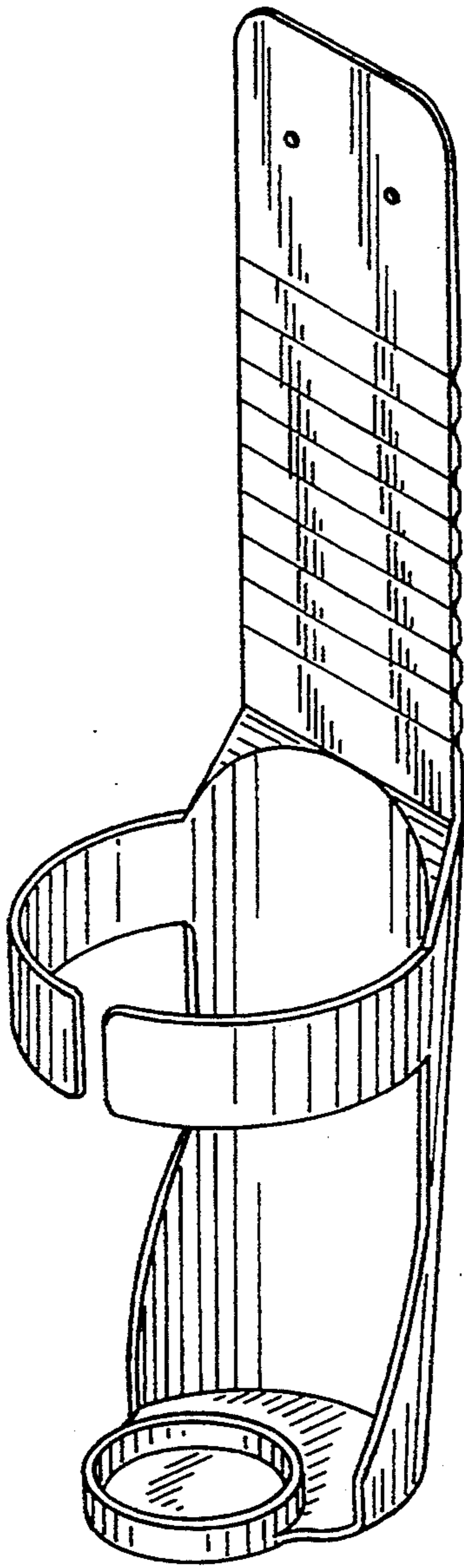

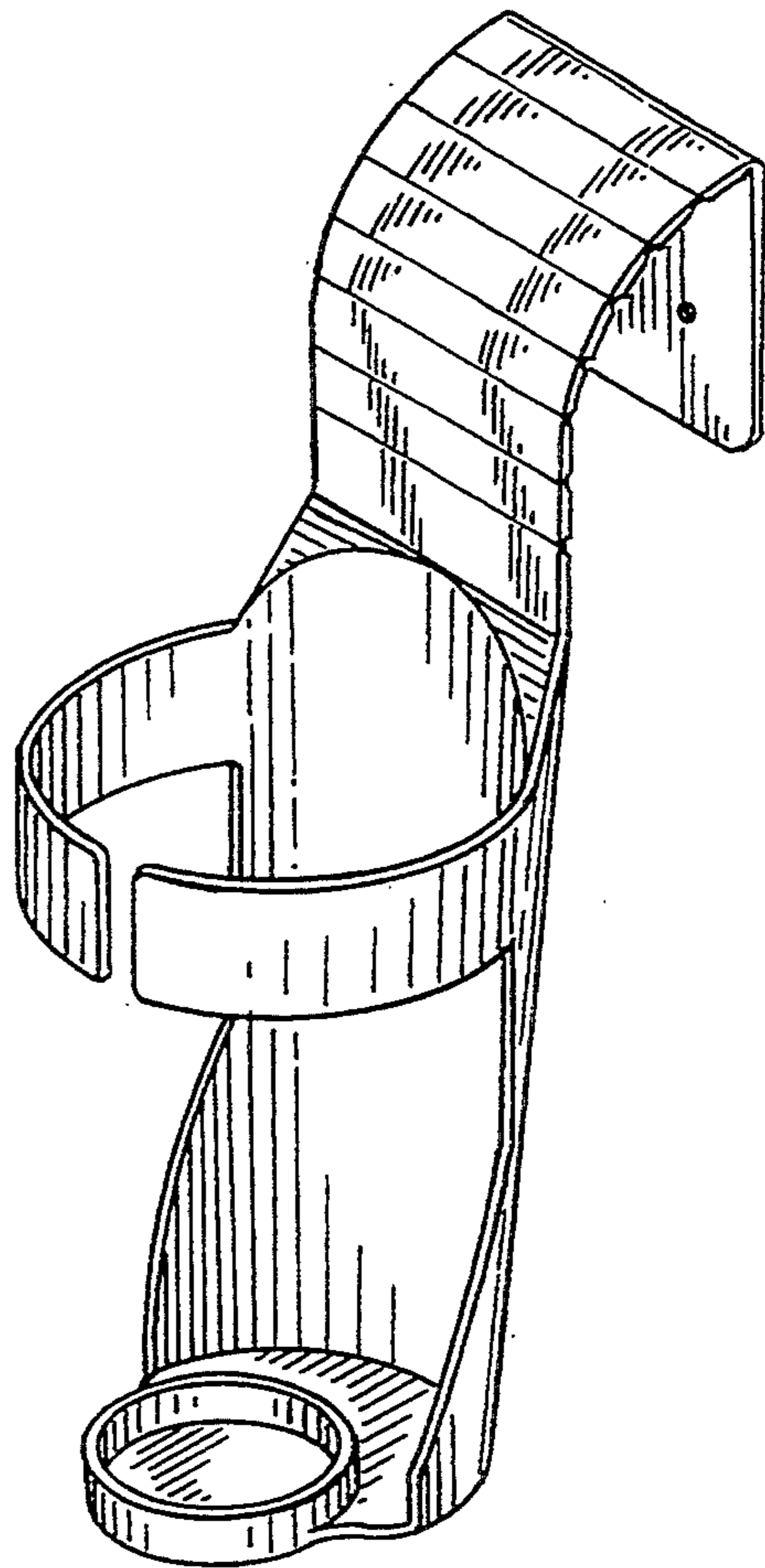

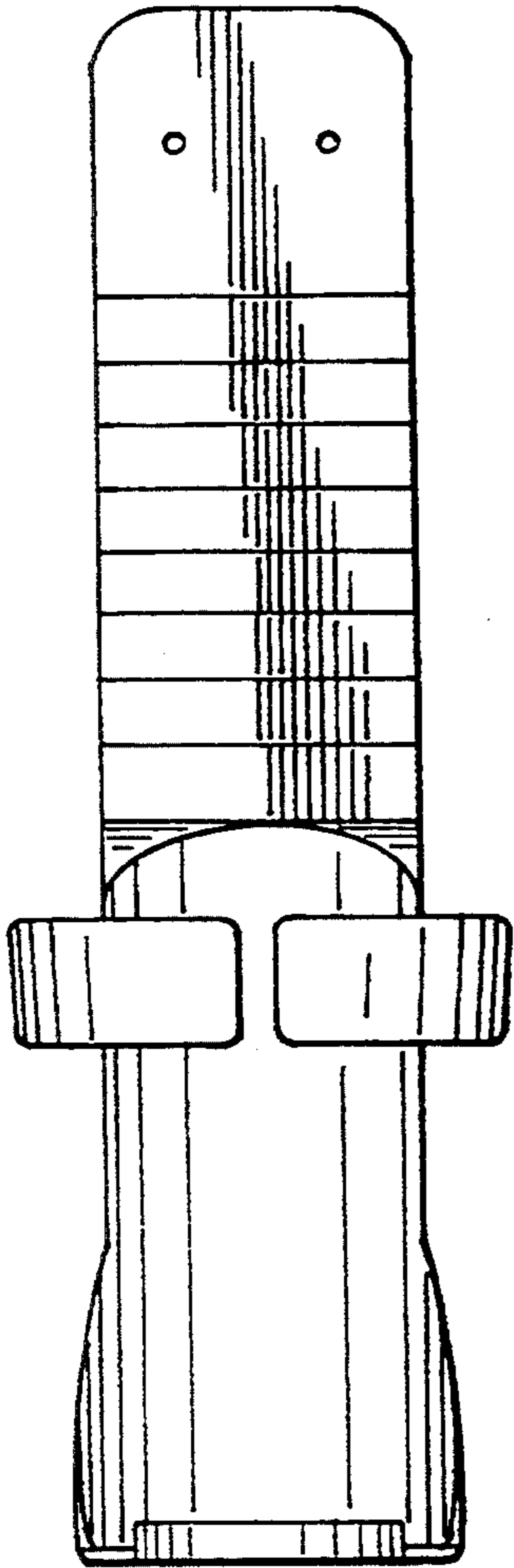

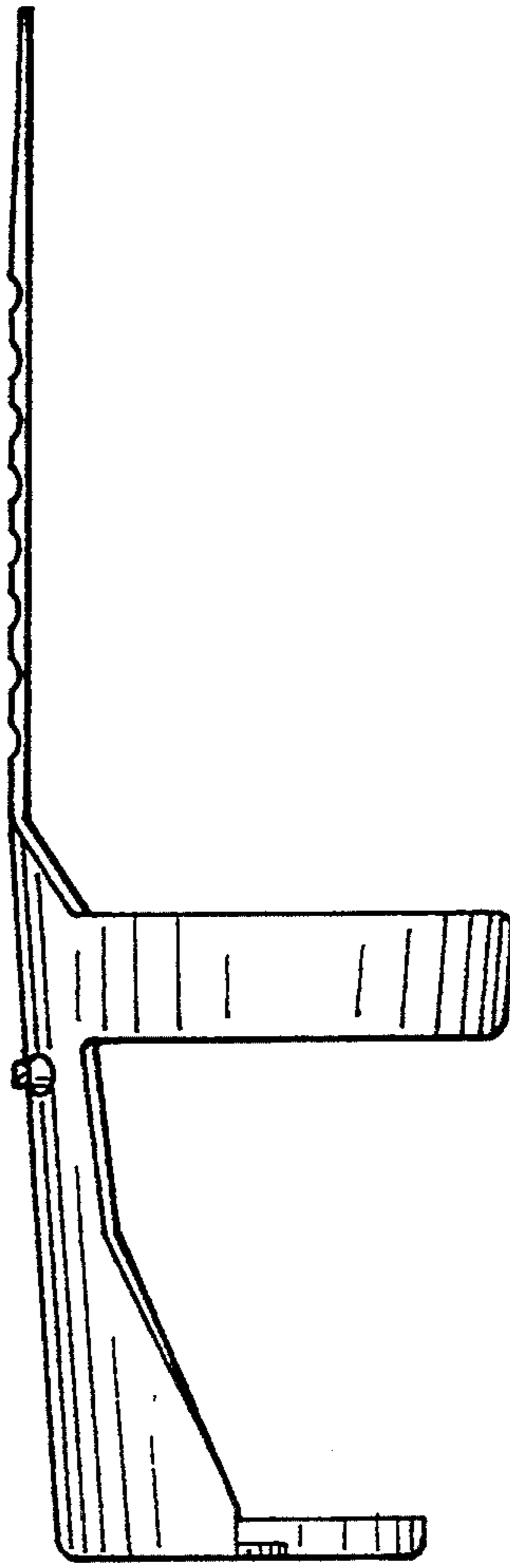

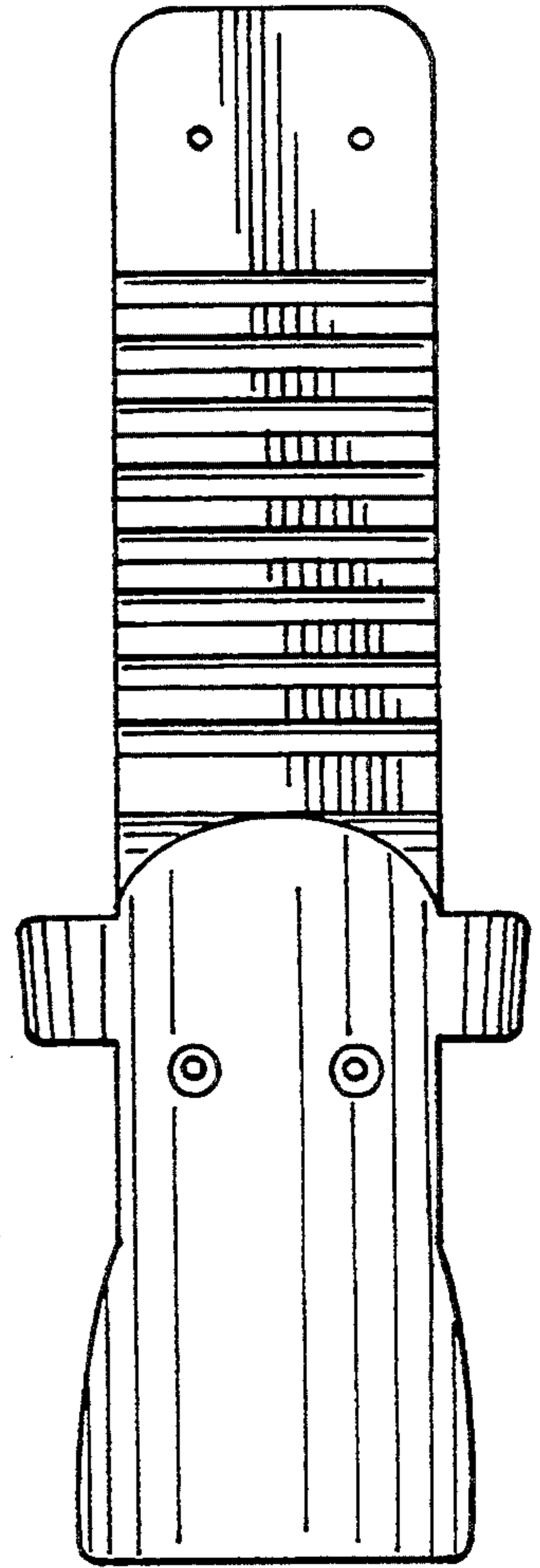

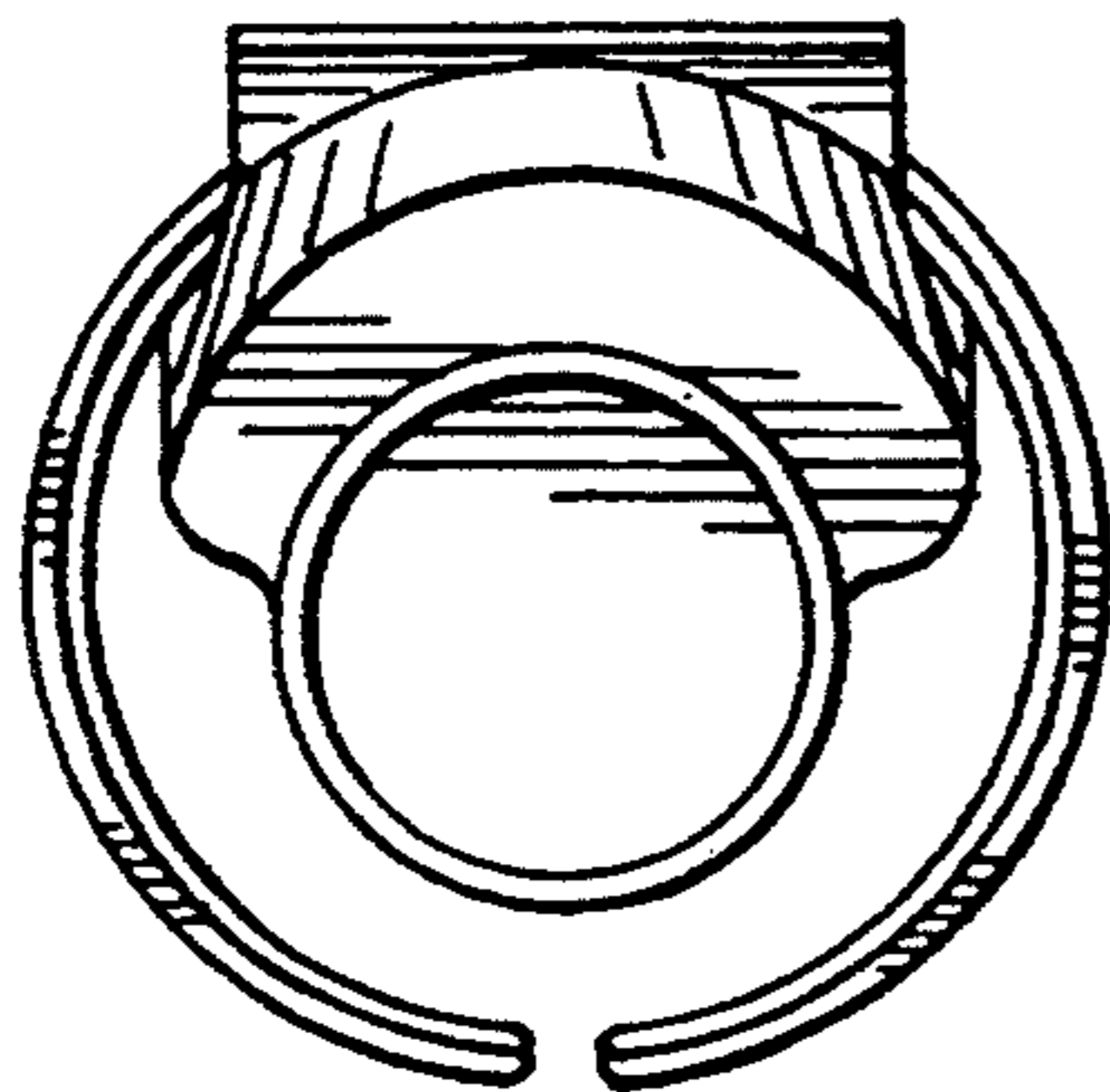
