FIG. 10 is a front end view of the boat fender of FIG. 6.

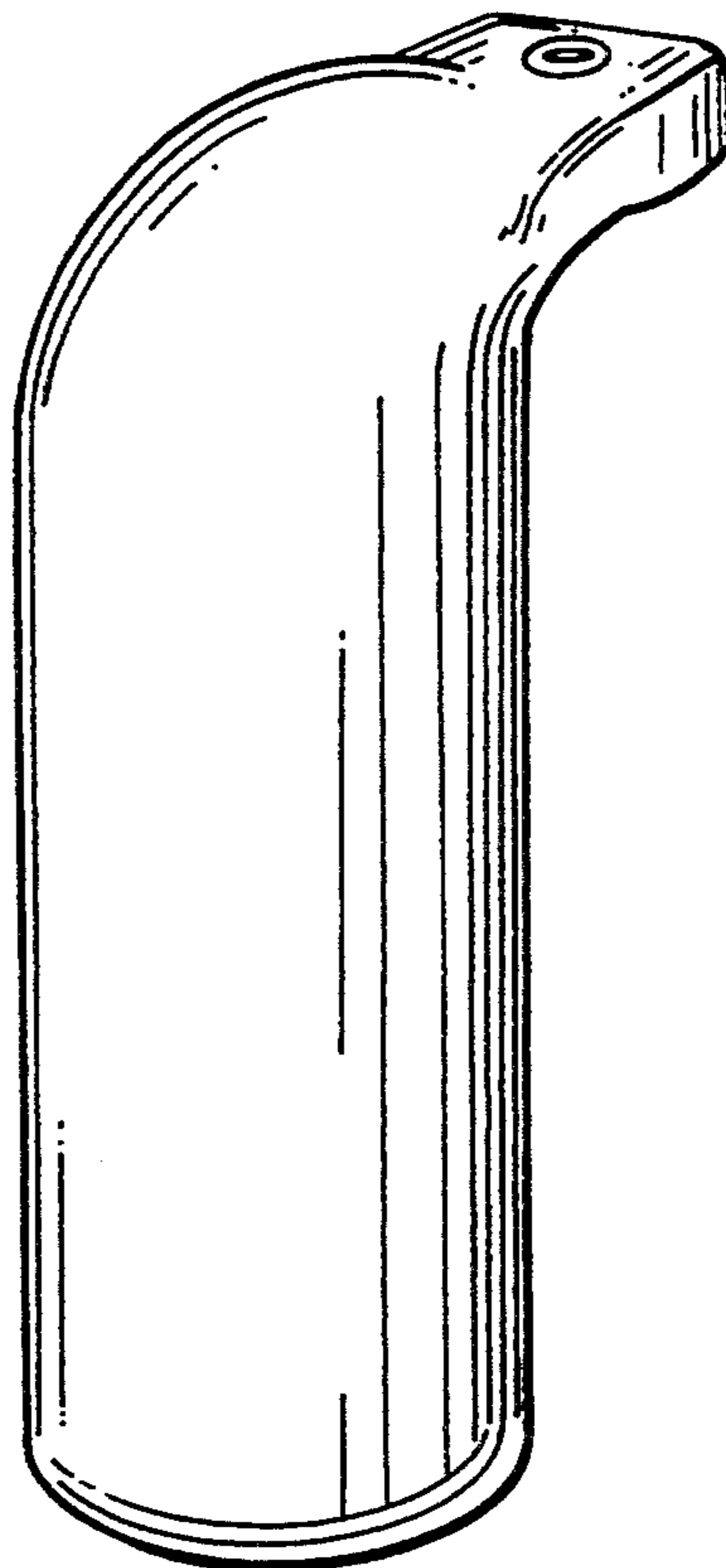

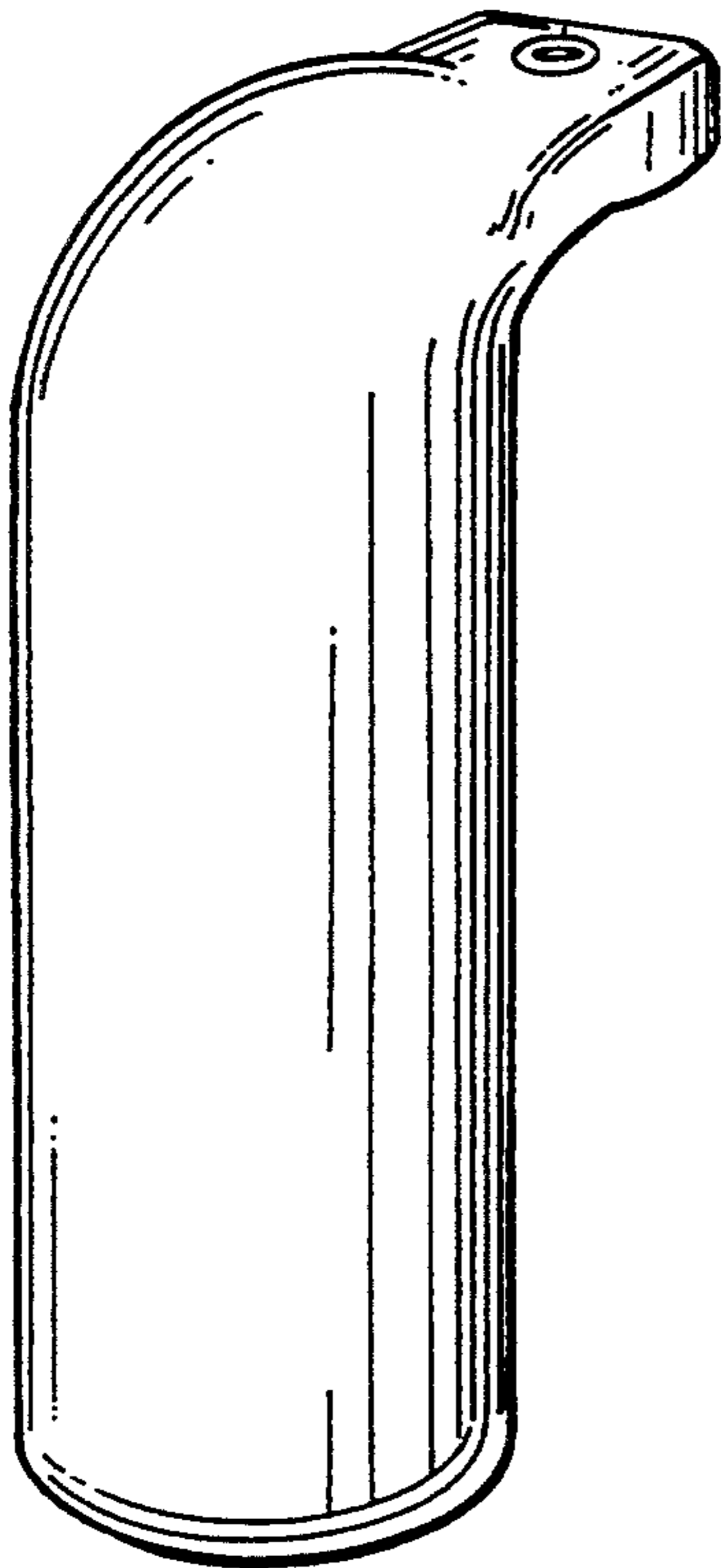

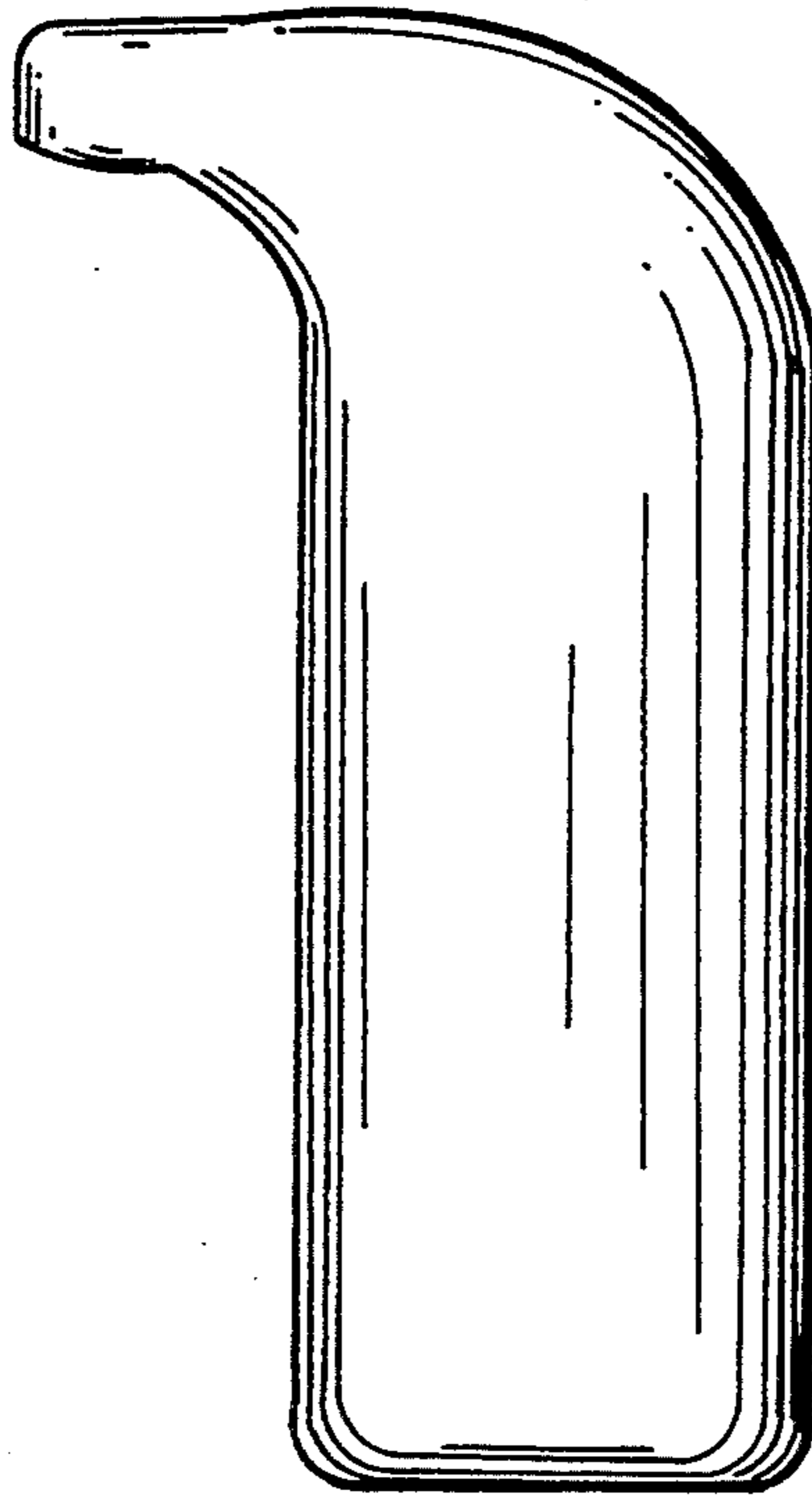

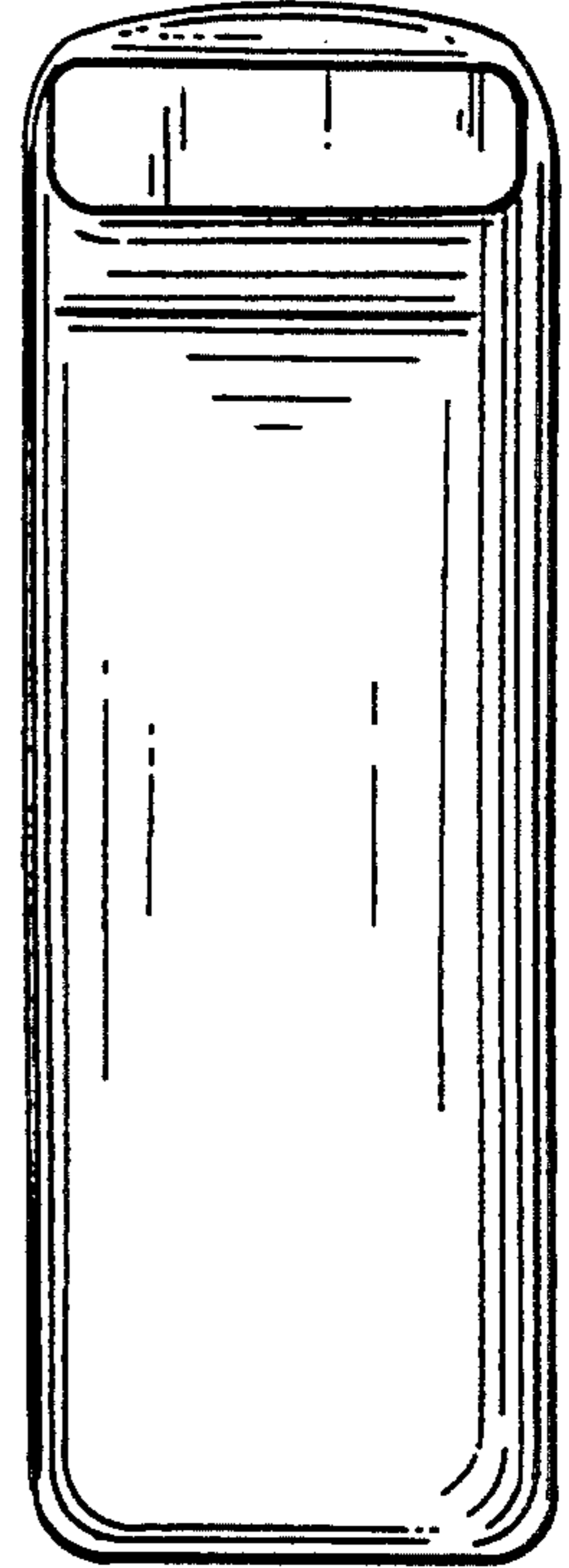




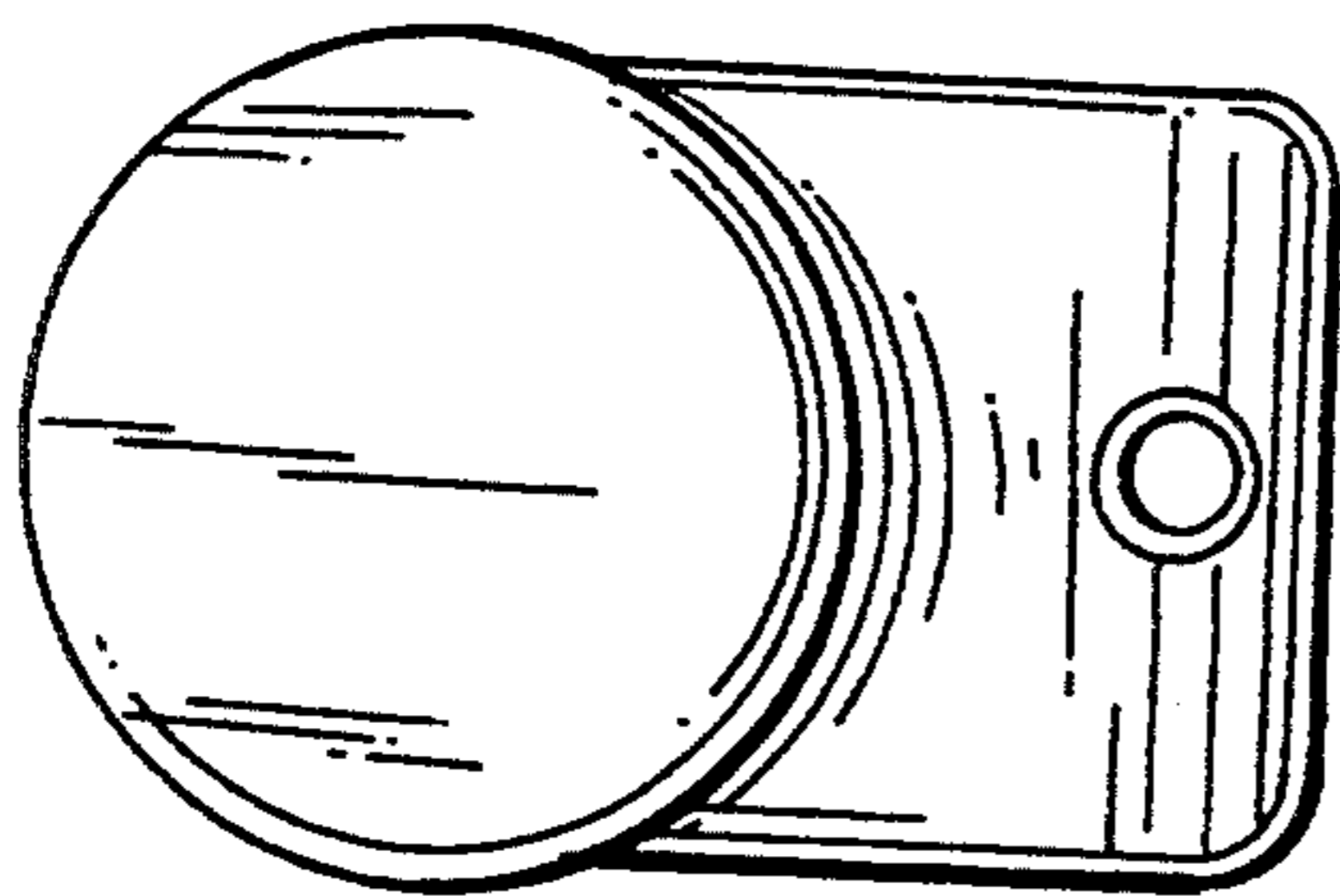

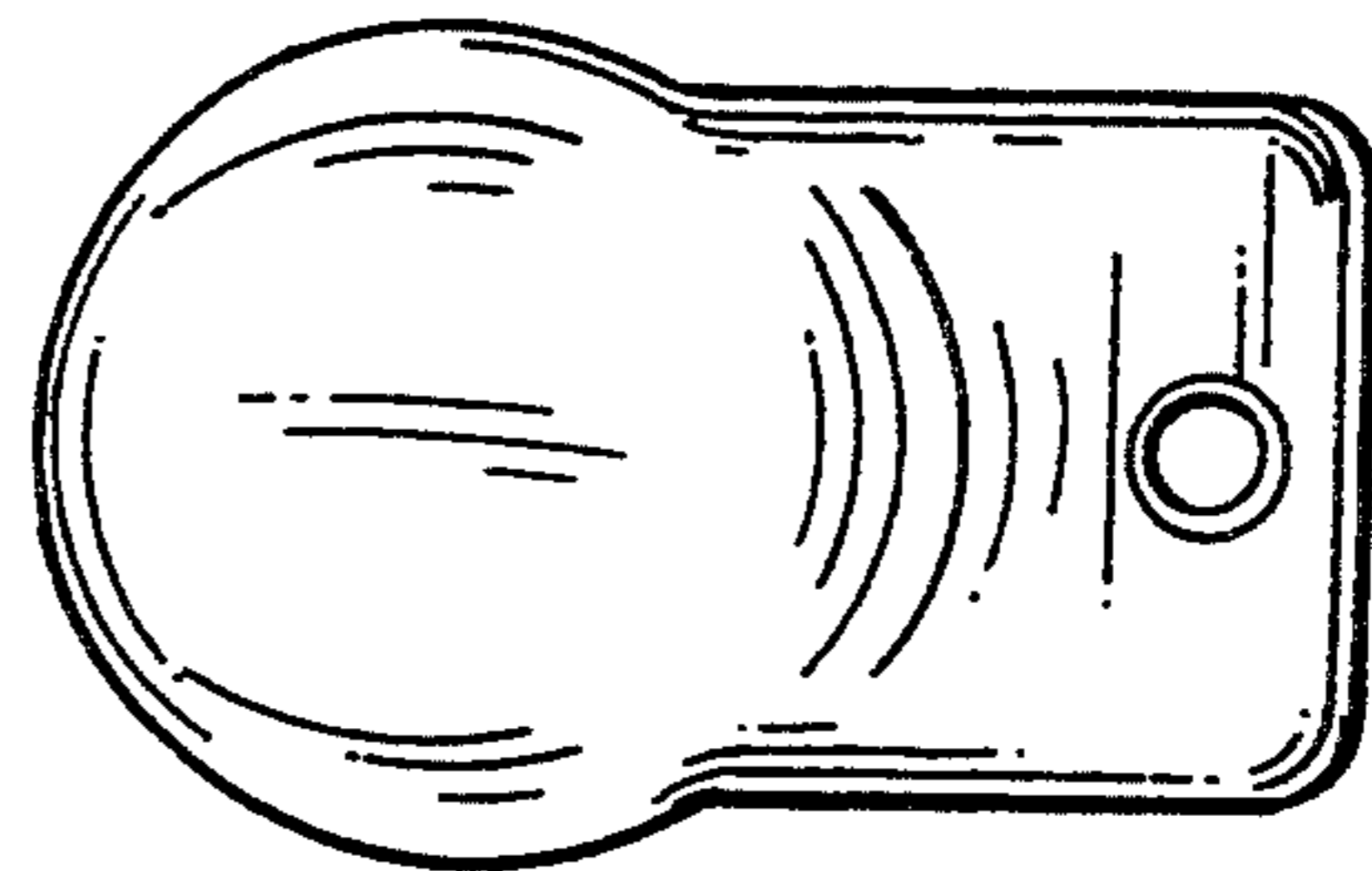

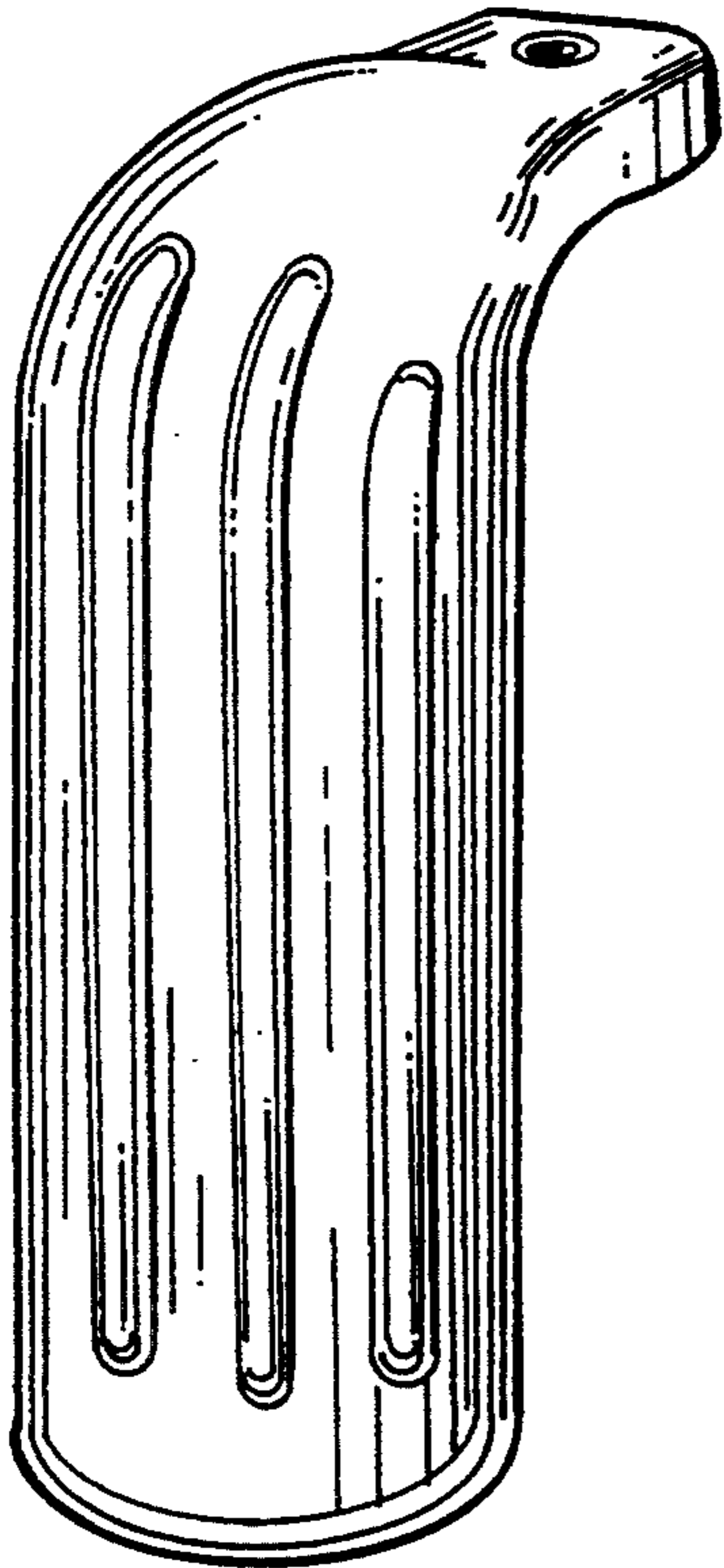

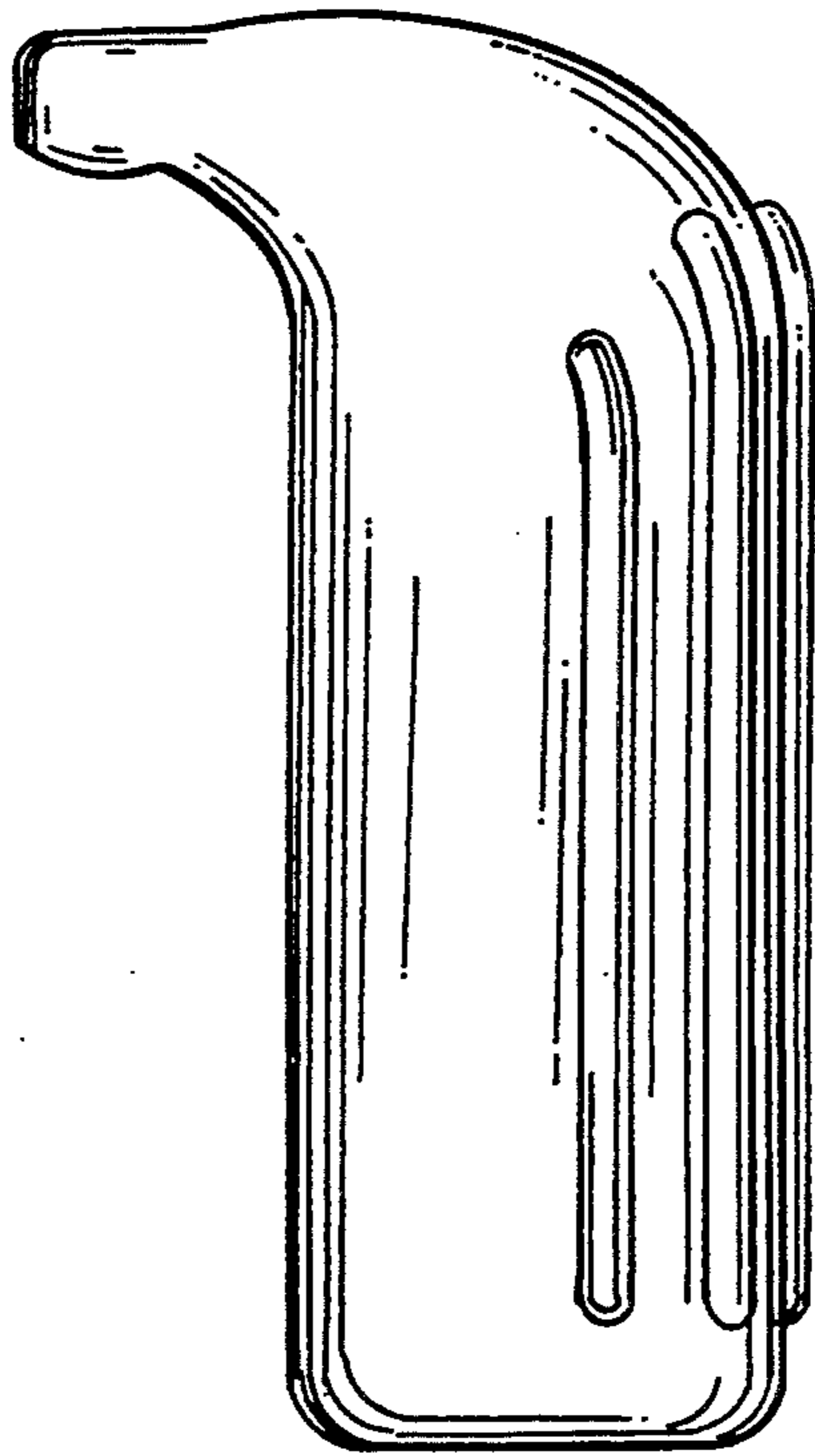

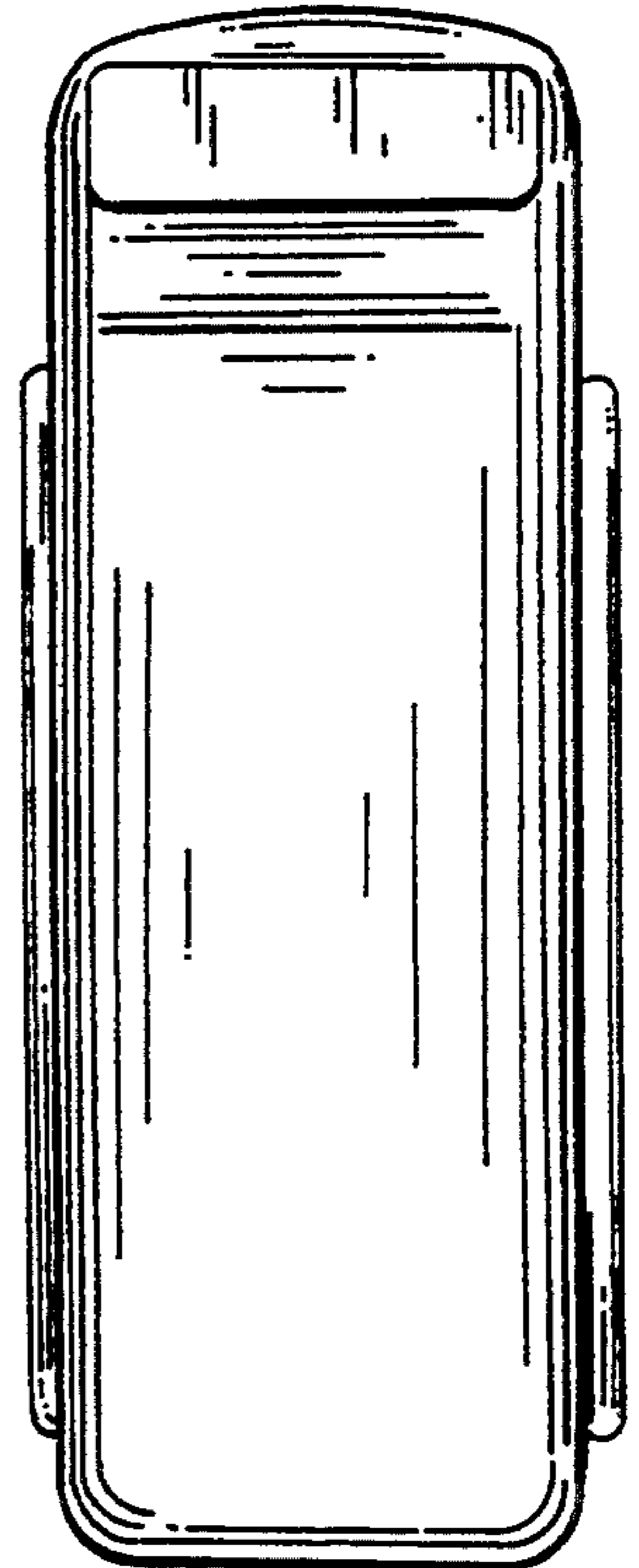

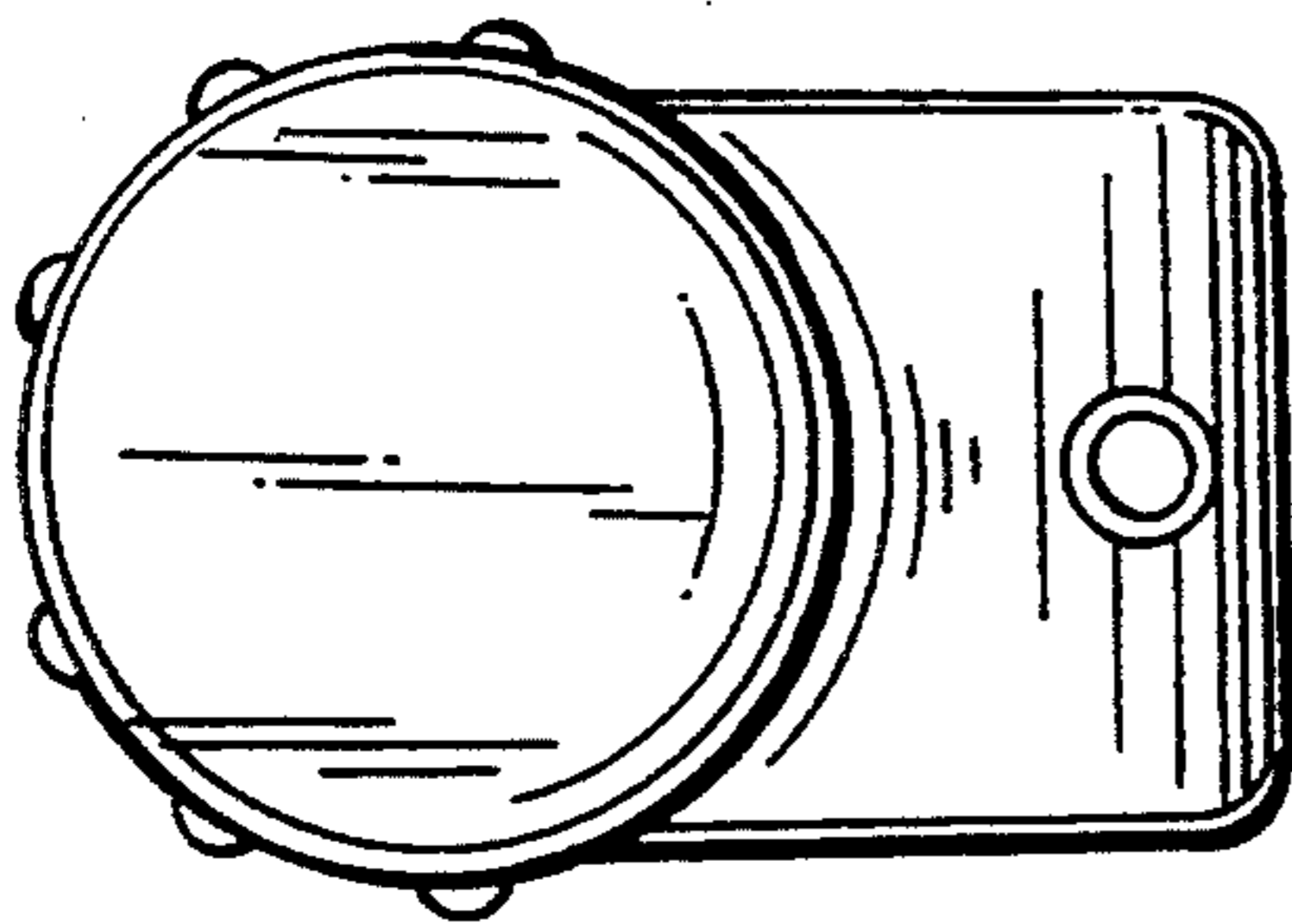

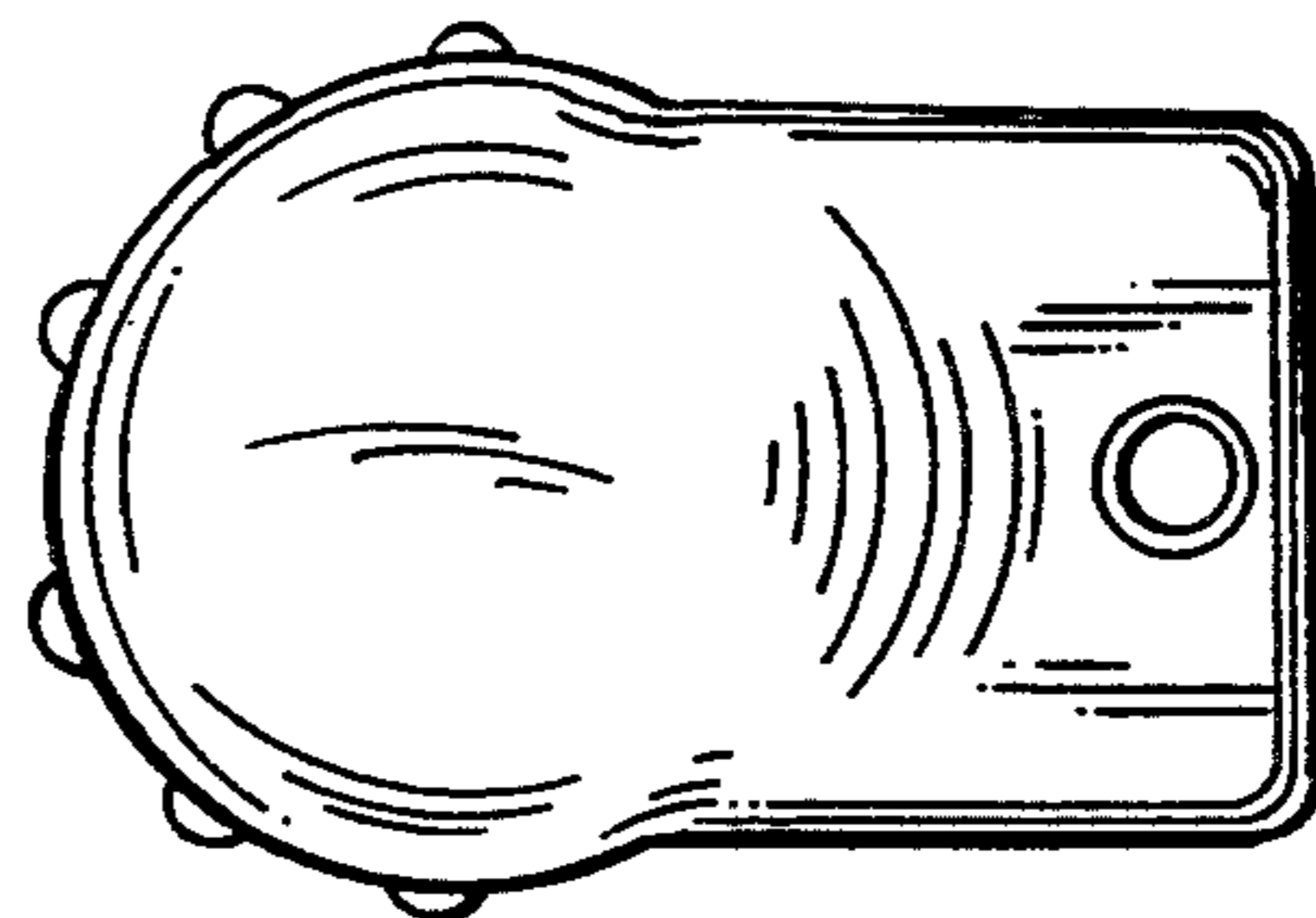
