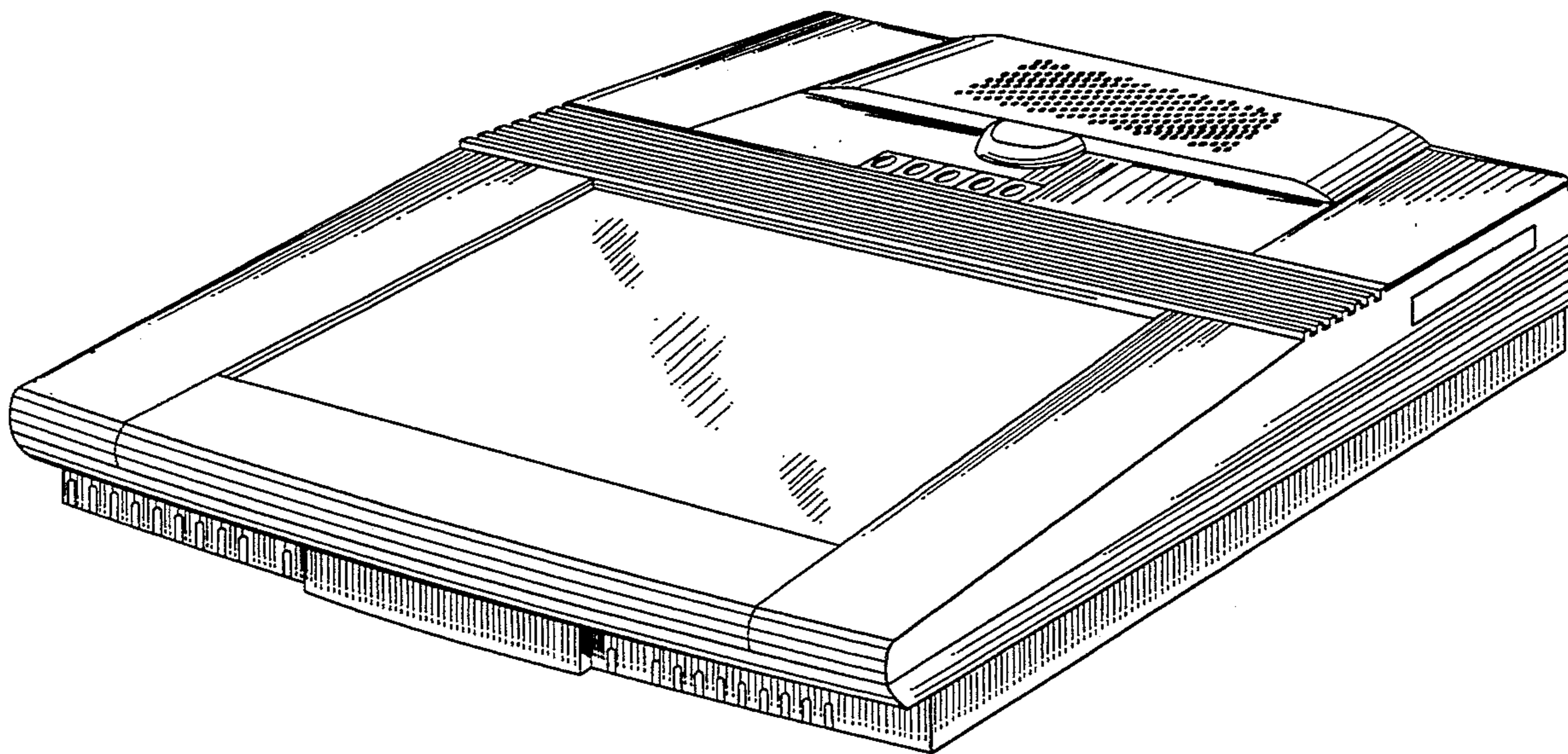

### [57] CLAIM

The ornamental design for a digital presentation system for displaying computer generated images, as shown and described.

### DESCRIPTION

FIG. 1 is an enlarged perspective view of the digital presentation system for displaying computer generated images showing our new design; FIG. 2 is a top view of the digital presentation system for displaying computer generated images; FIG. 3 is a bottom view of the digital presentation system for displaying computer generated images; FIGS. 4 and 5 are side views of the digital presentation system for displaying computer generated images; FIG. 6 is a back view of the digital presentation system for displaying computer generated images; and, FIG. 7 is a front view of the digital presentation system for displaying computer generated images.



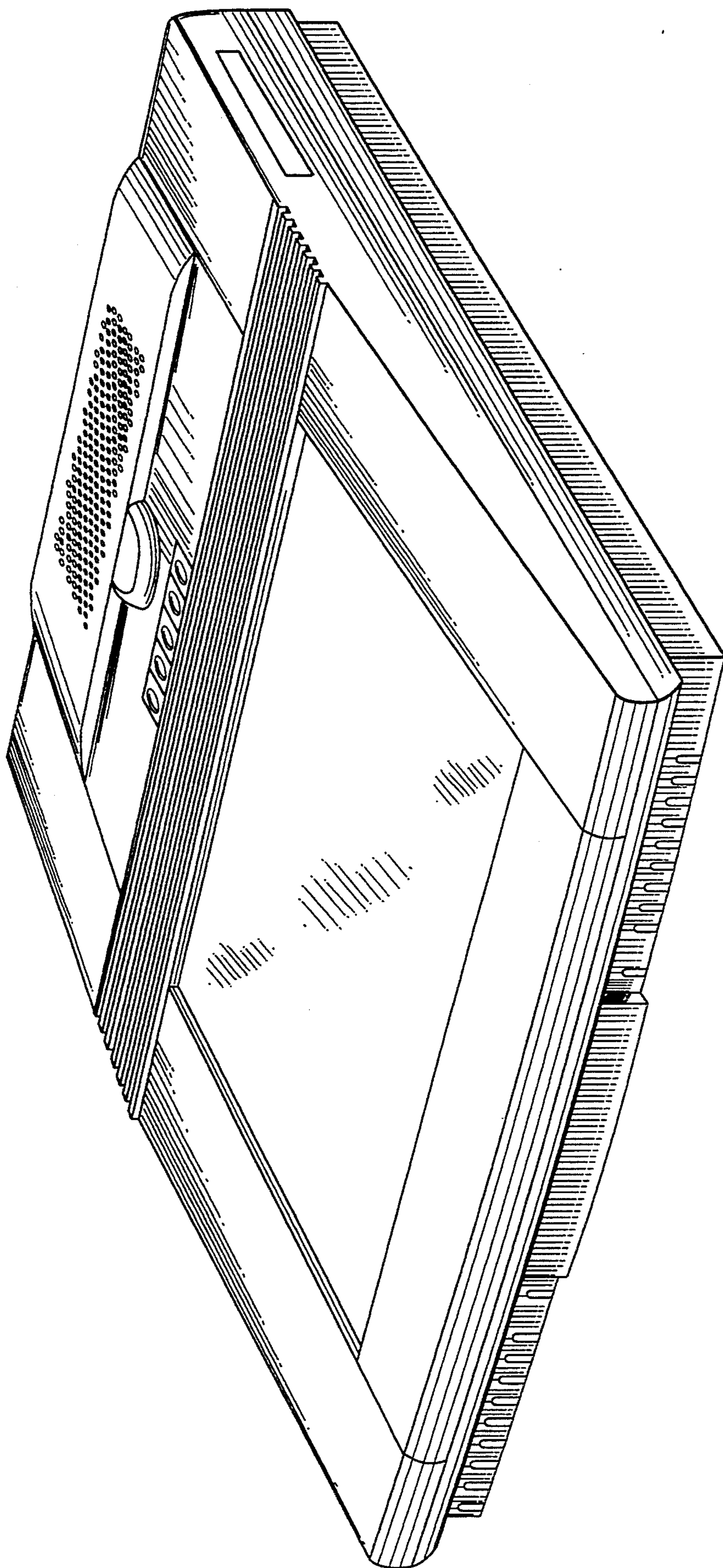

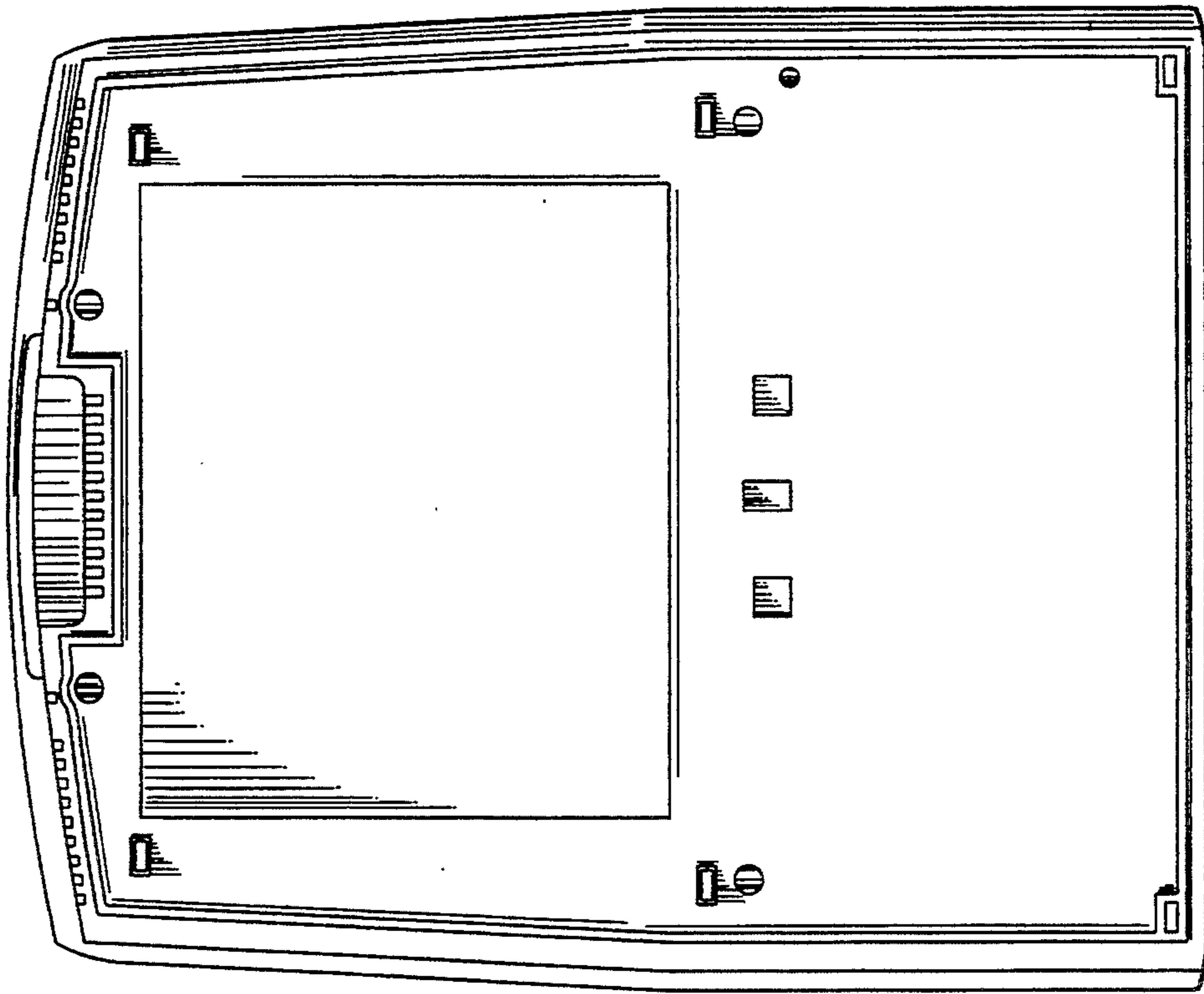

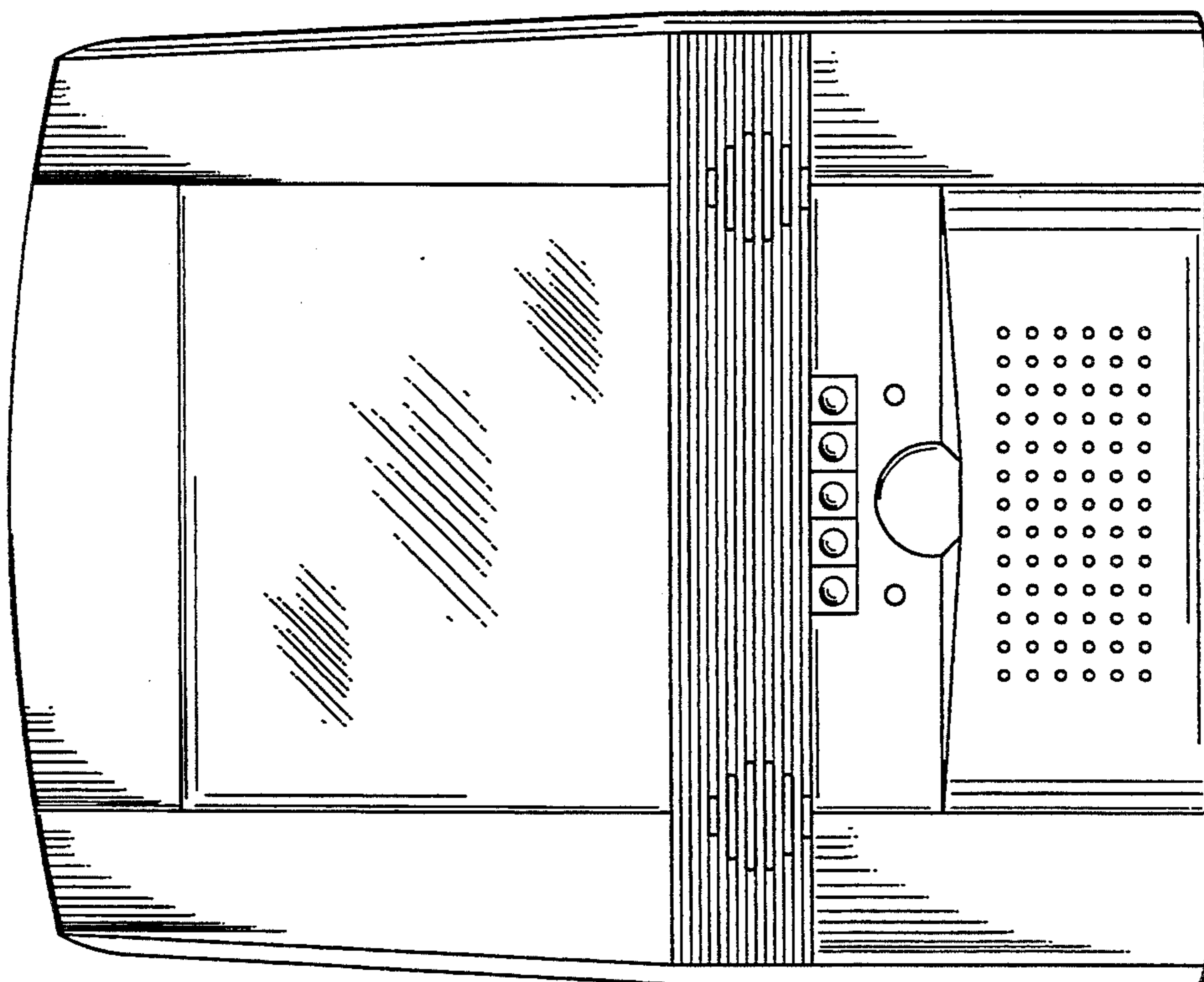
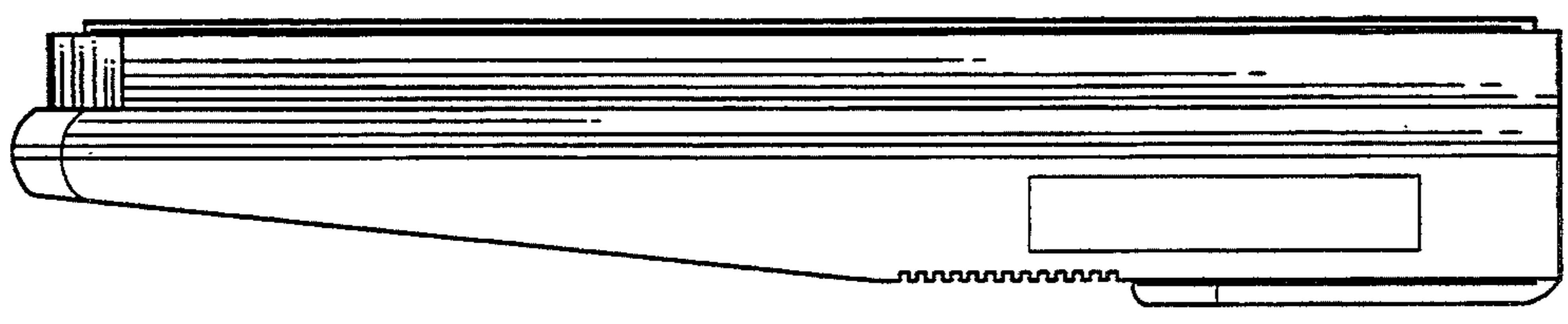
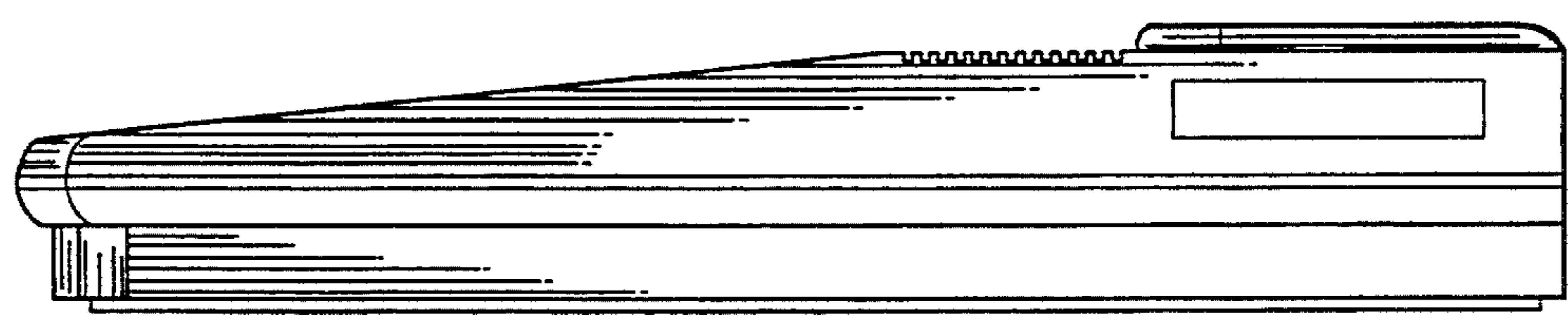


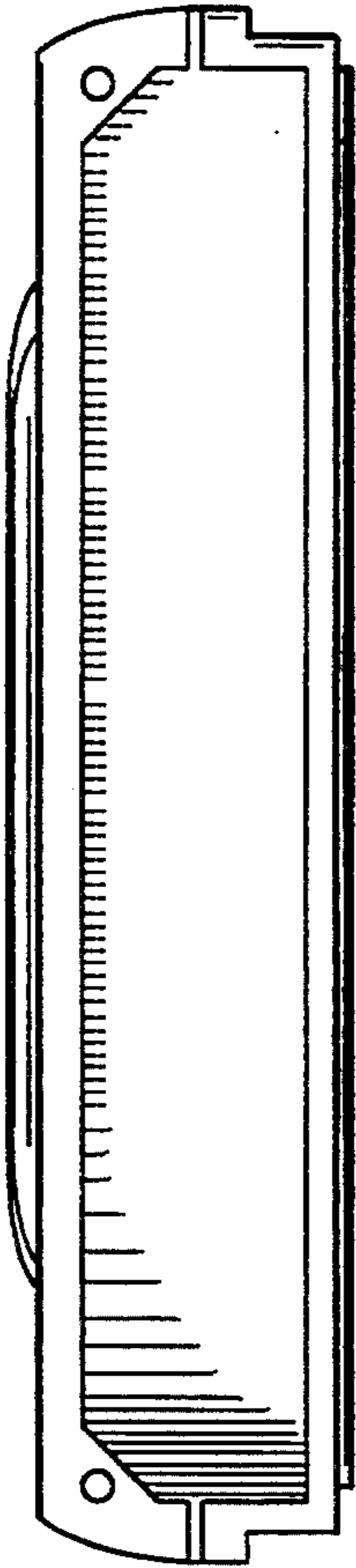

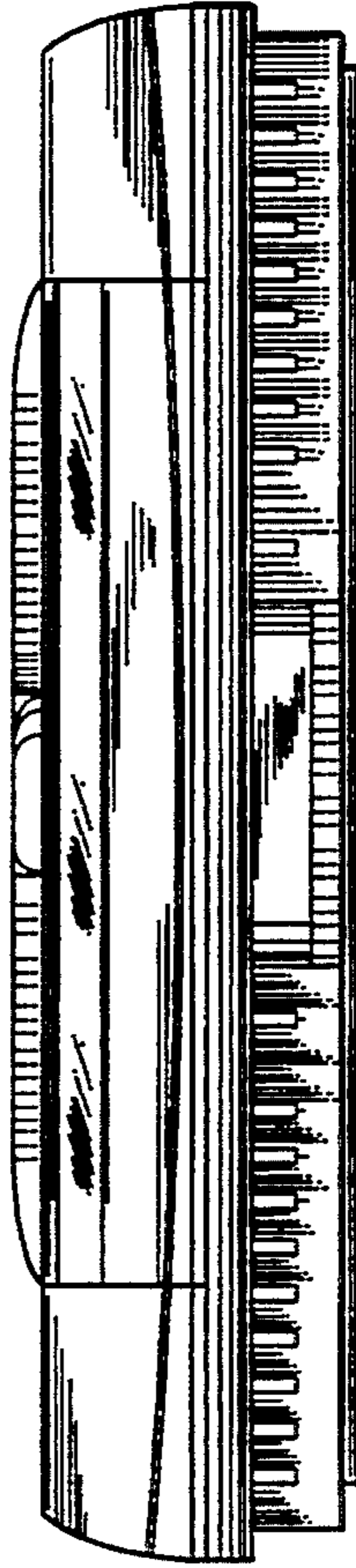
