### [57] CLAIM

The ornamental design for a dental sculpting tool, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of an dental sculpting tool embodying the ornamental concepts of my new invention;

FIG. 2 is an end view of one end of the dental sculpting tool of FIG. 1;

FIG. 3 is an end view of the other end of the dental sculpting tool of FIG. 1;

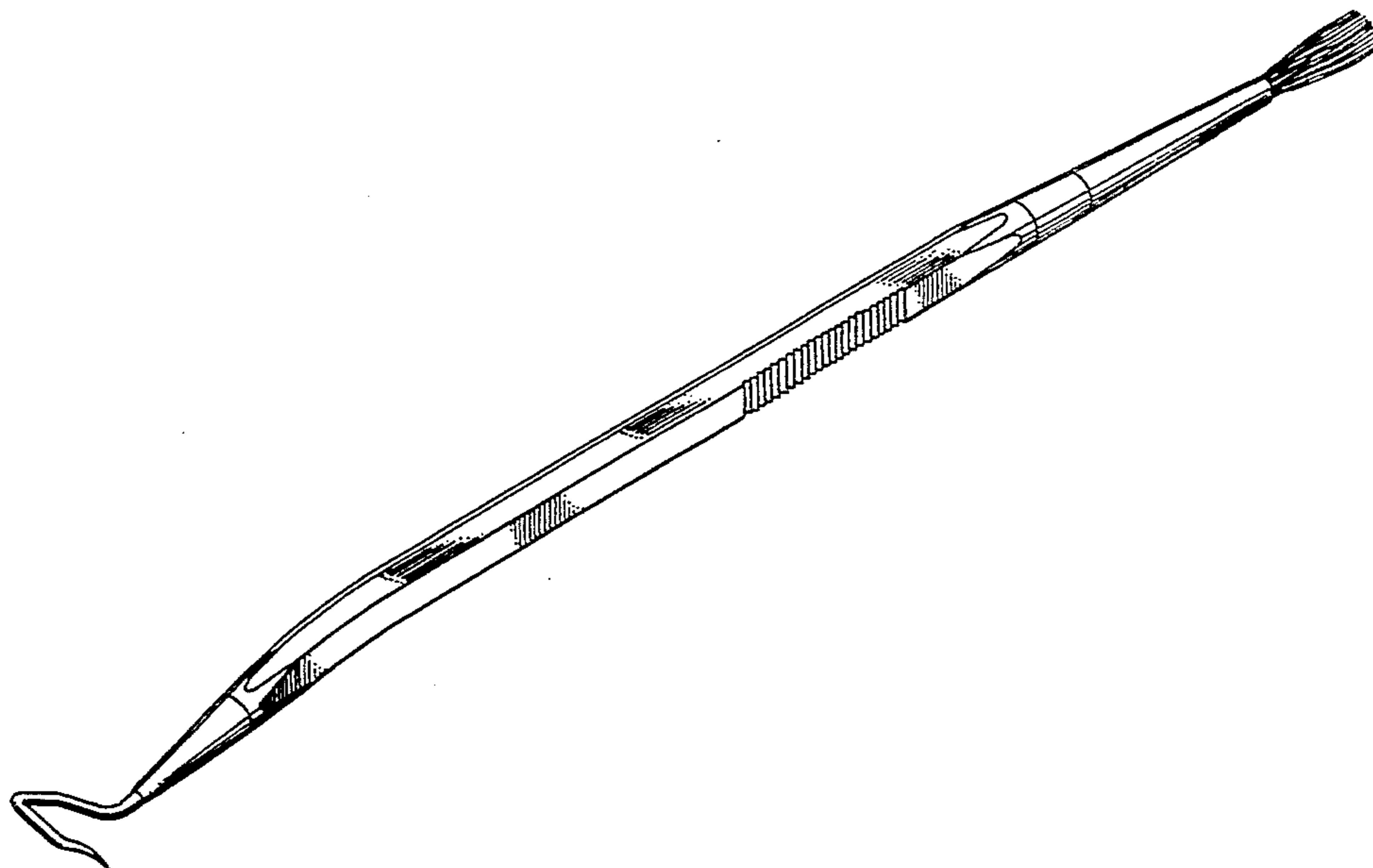
FIG. 4 is a side elevational view of the dental sculpting tool of FIG. 1;

FIG. 5 is a top plan view of the dental sculpting tool of FIG. 1;

FIG. 6 is a bottom plan view of the dental sculpting tool of FIG. 1;

FIG. 7 is a side elevational view, partially shown for clarity of illustration, on an enlarged scale, the broken line drawing of a tooth is for illustrative purposes only and forms no part of the claimed design; and,

FIG. 8 is a partial sectional view thereof, taken on line 8—8 of FIG. 7, on a greatly enlarged scale.



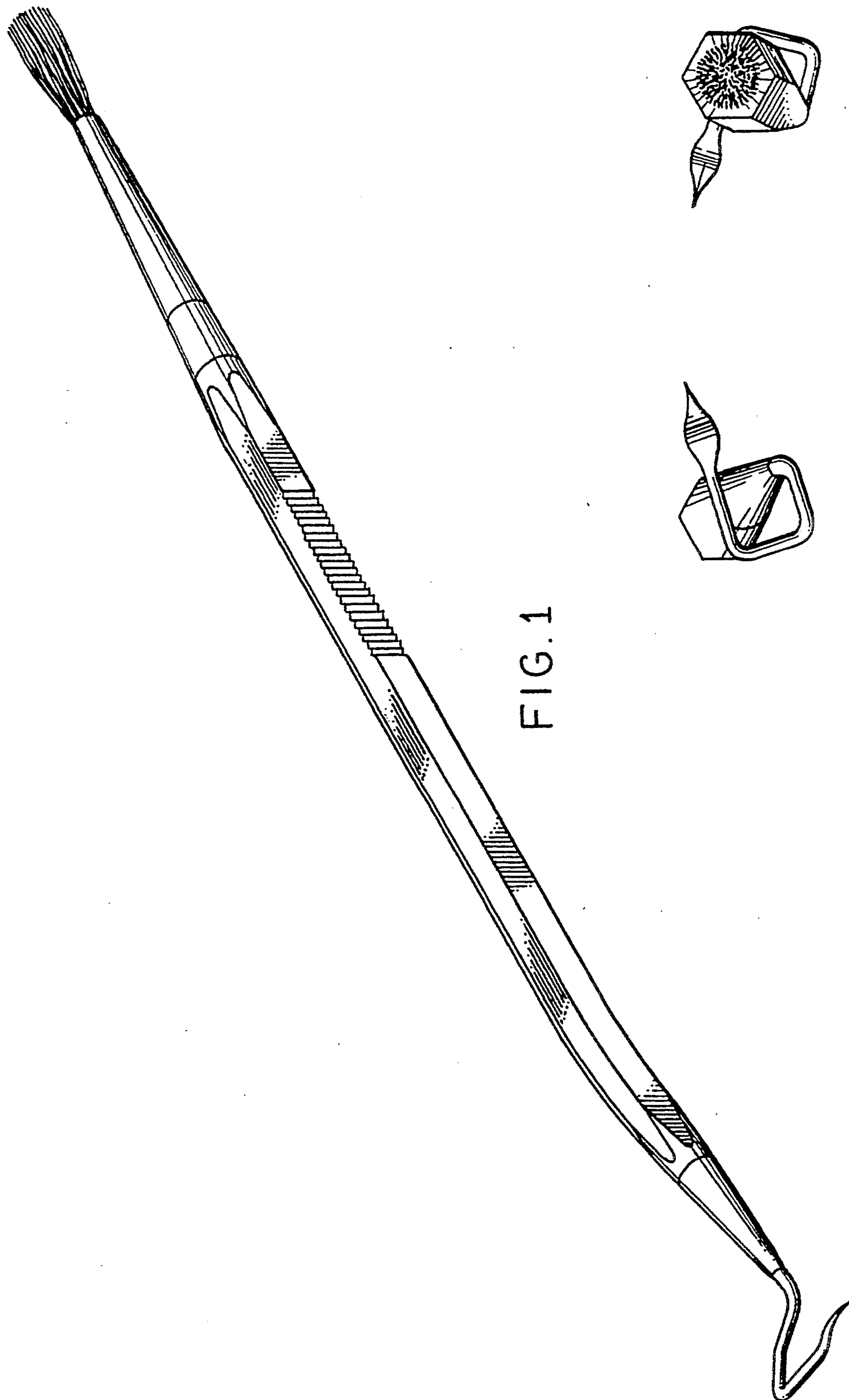

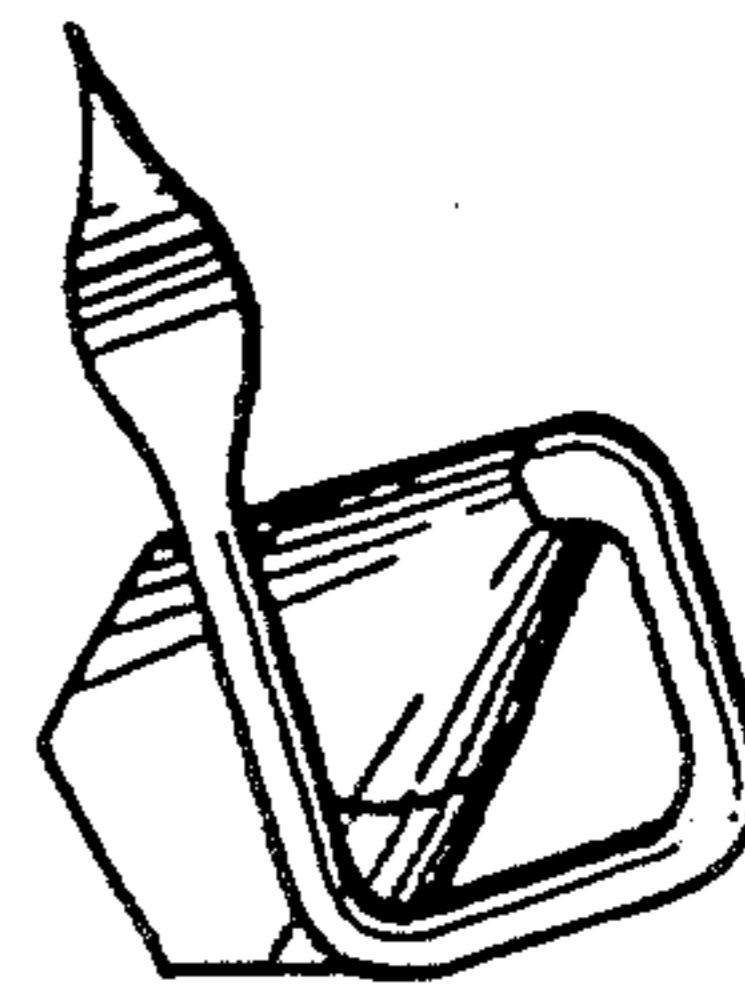

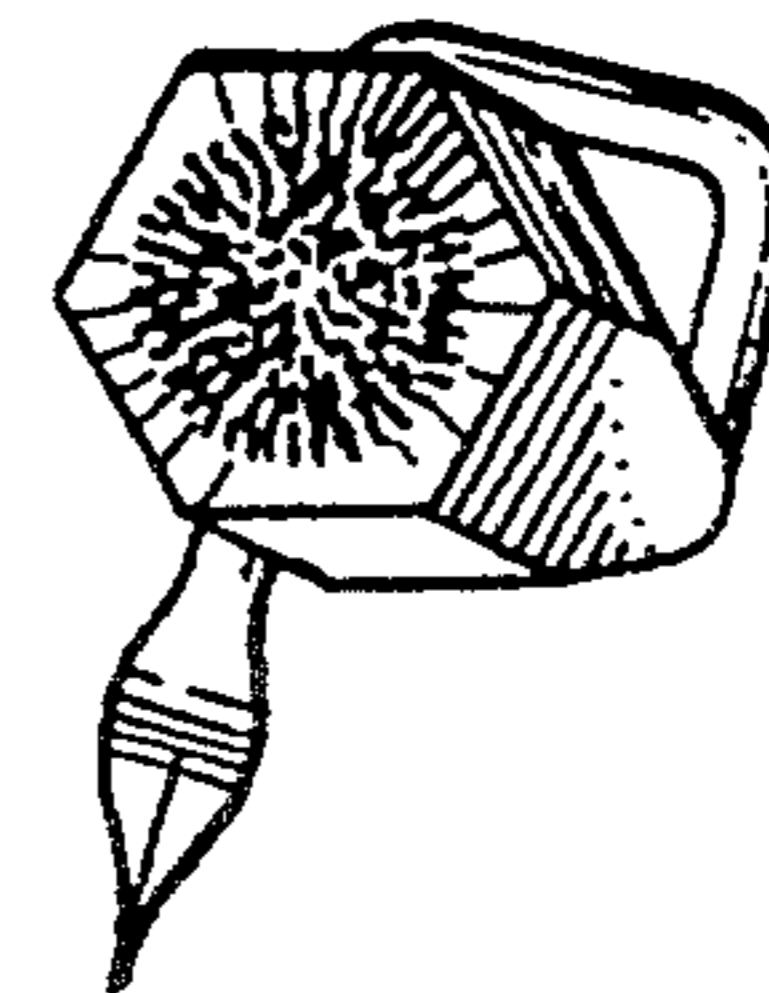

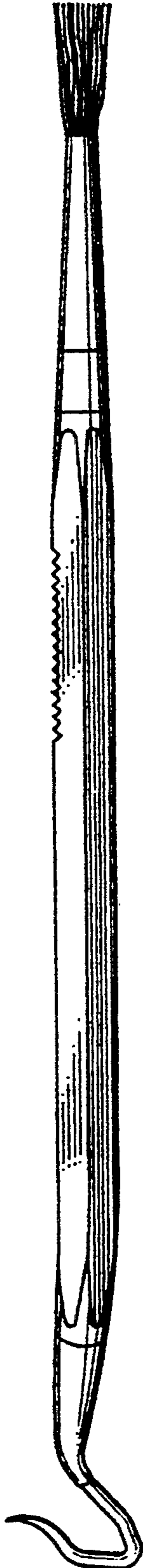

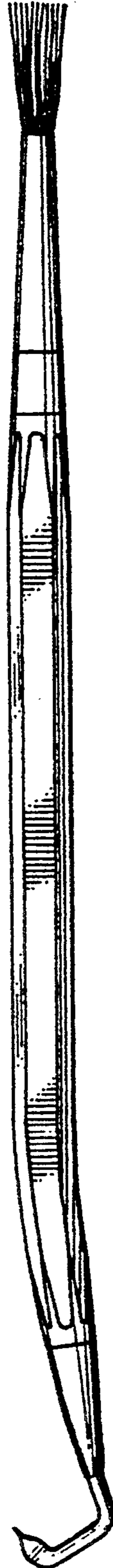

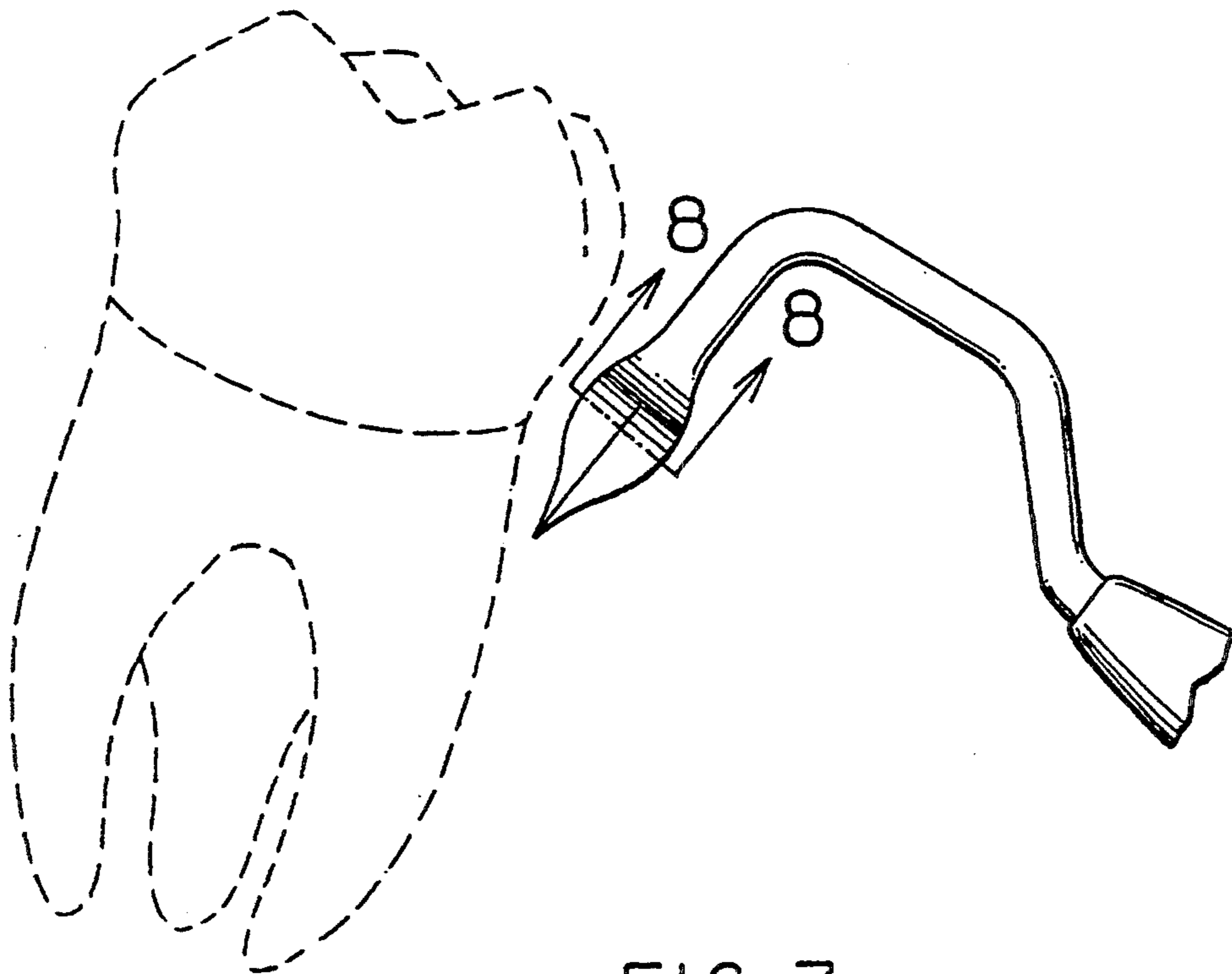
