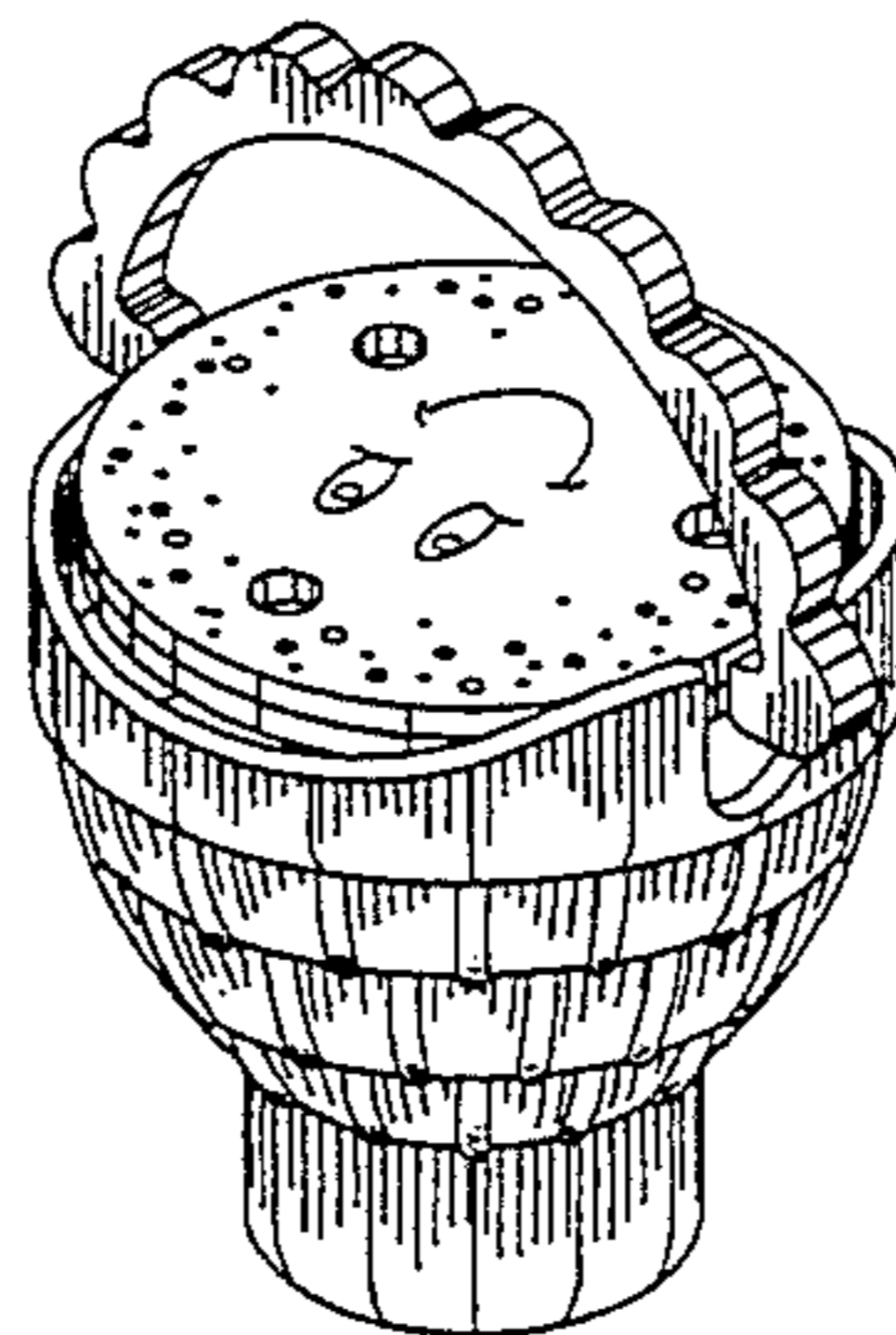
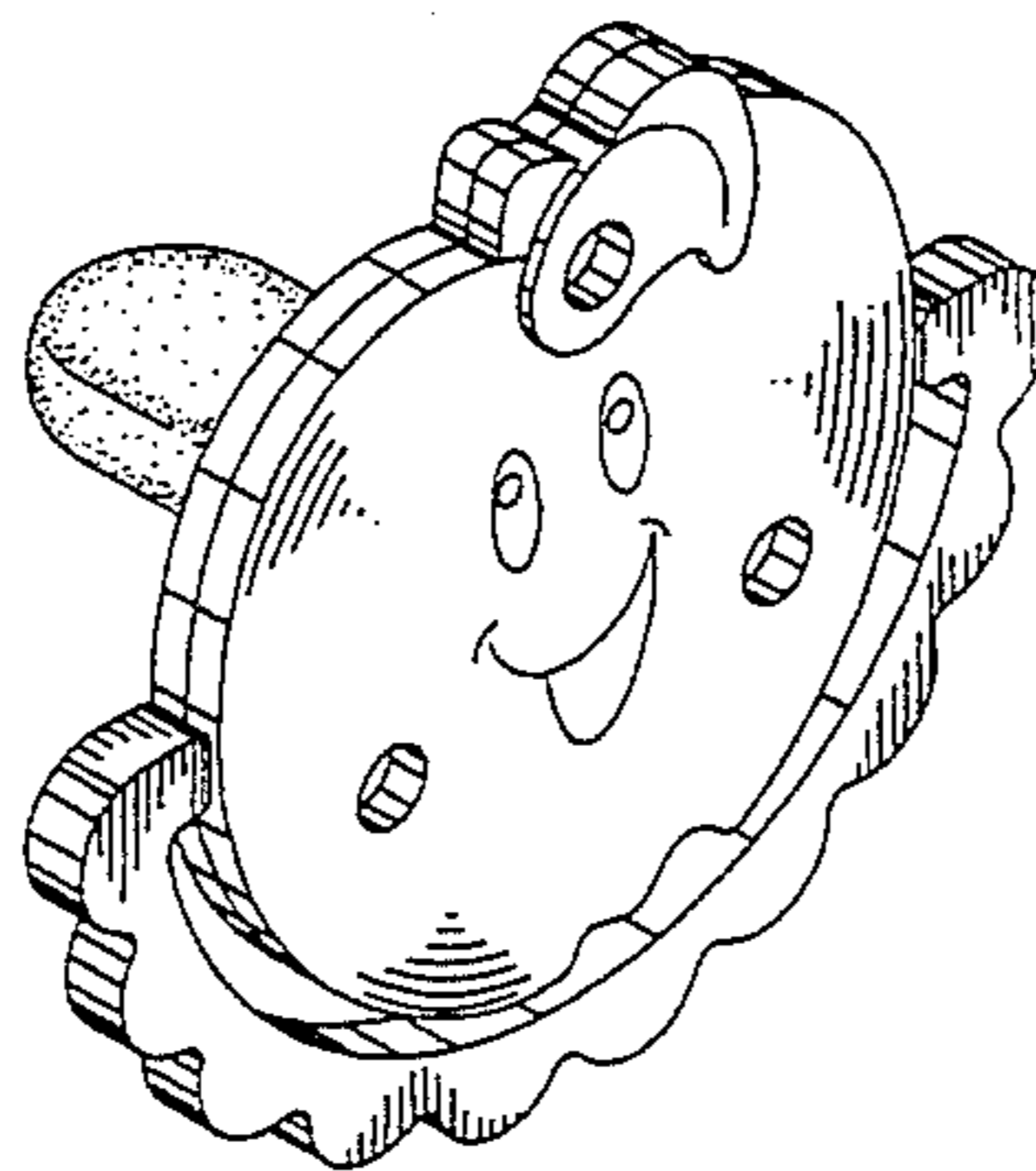
[57] **CLAIM**

 FIG. 34 is an end elevational view thereof.



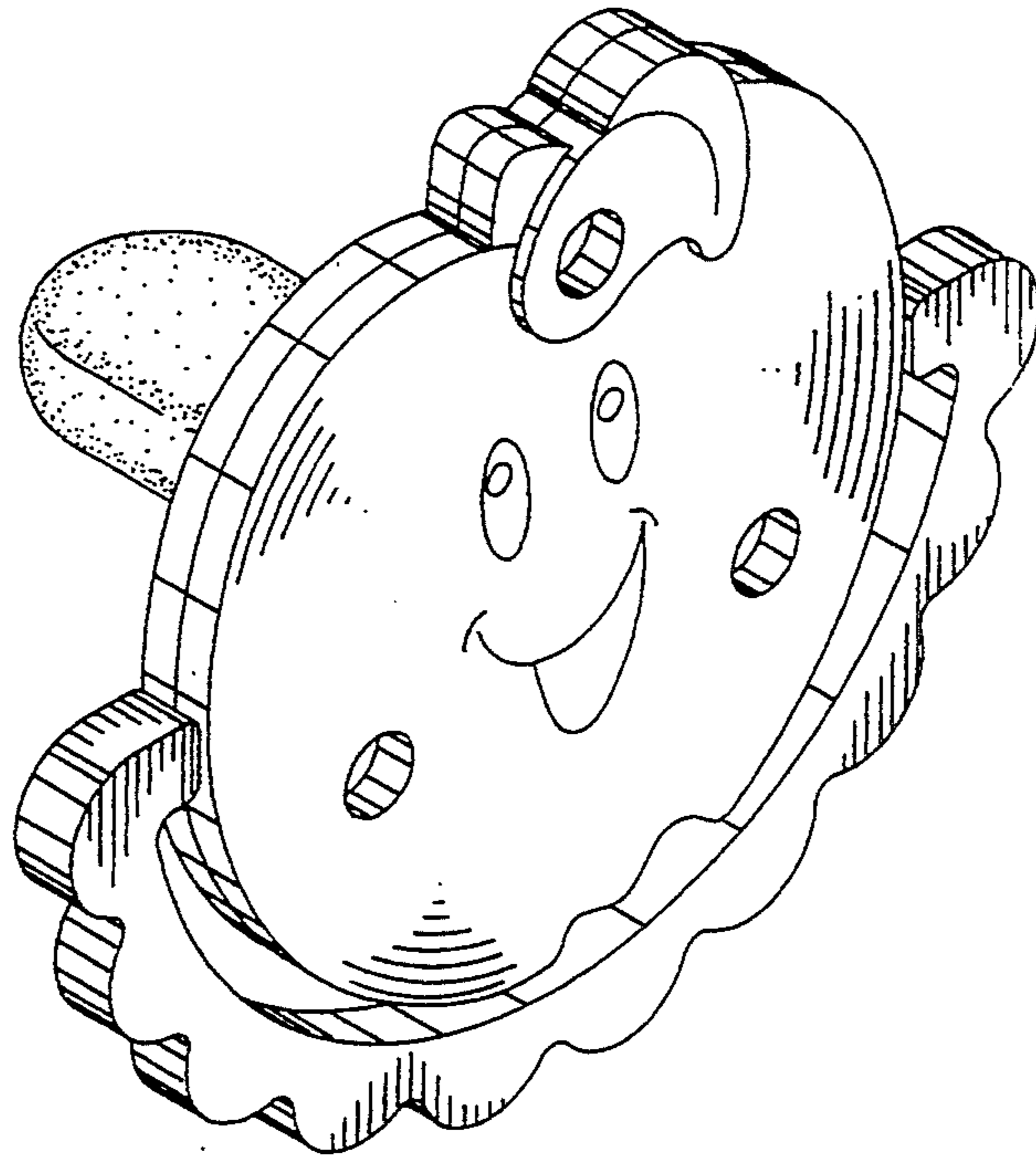

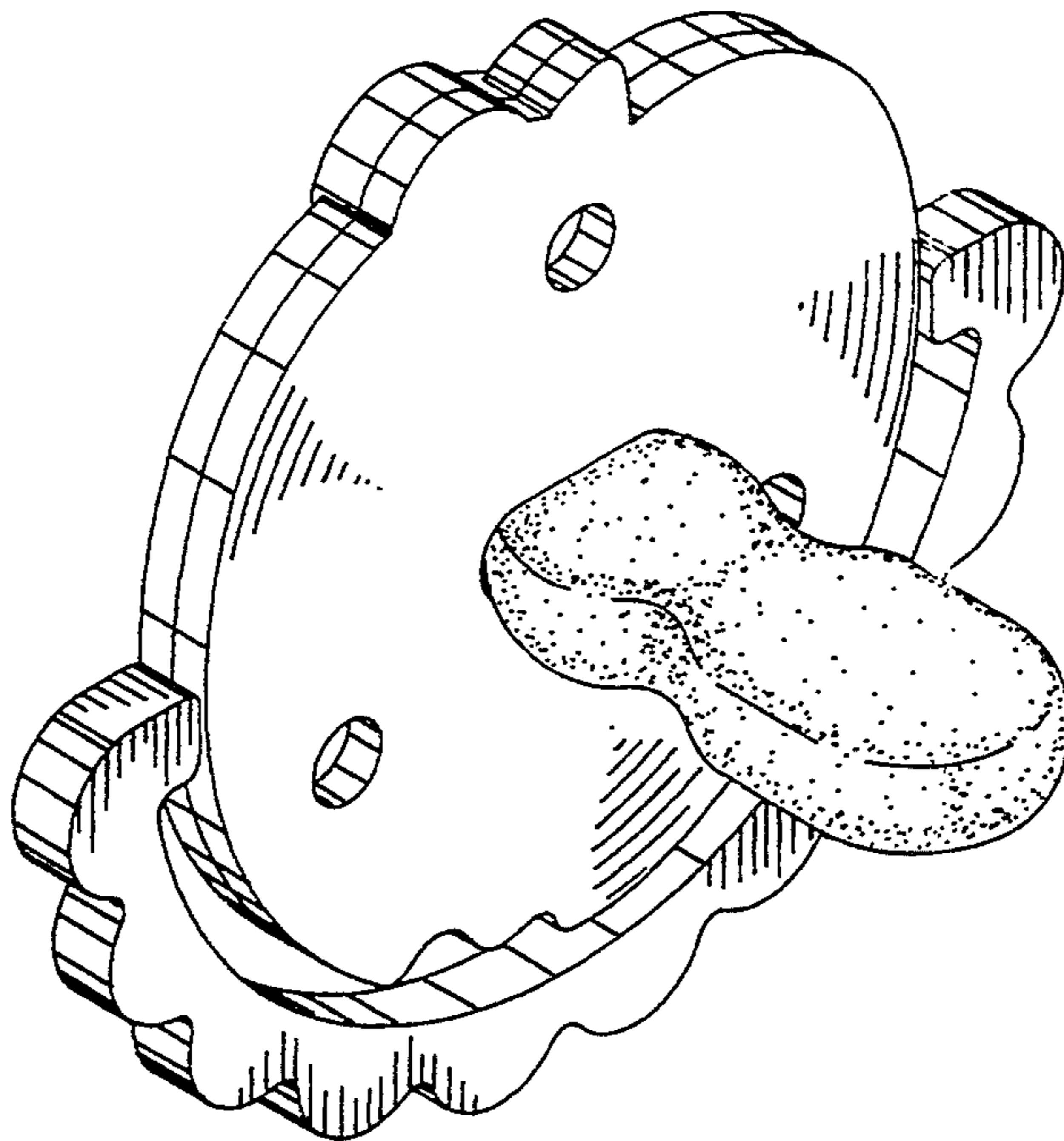

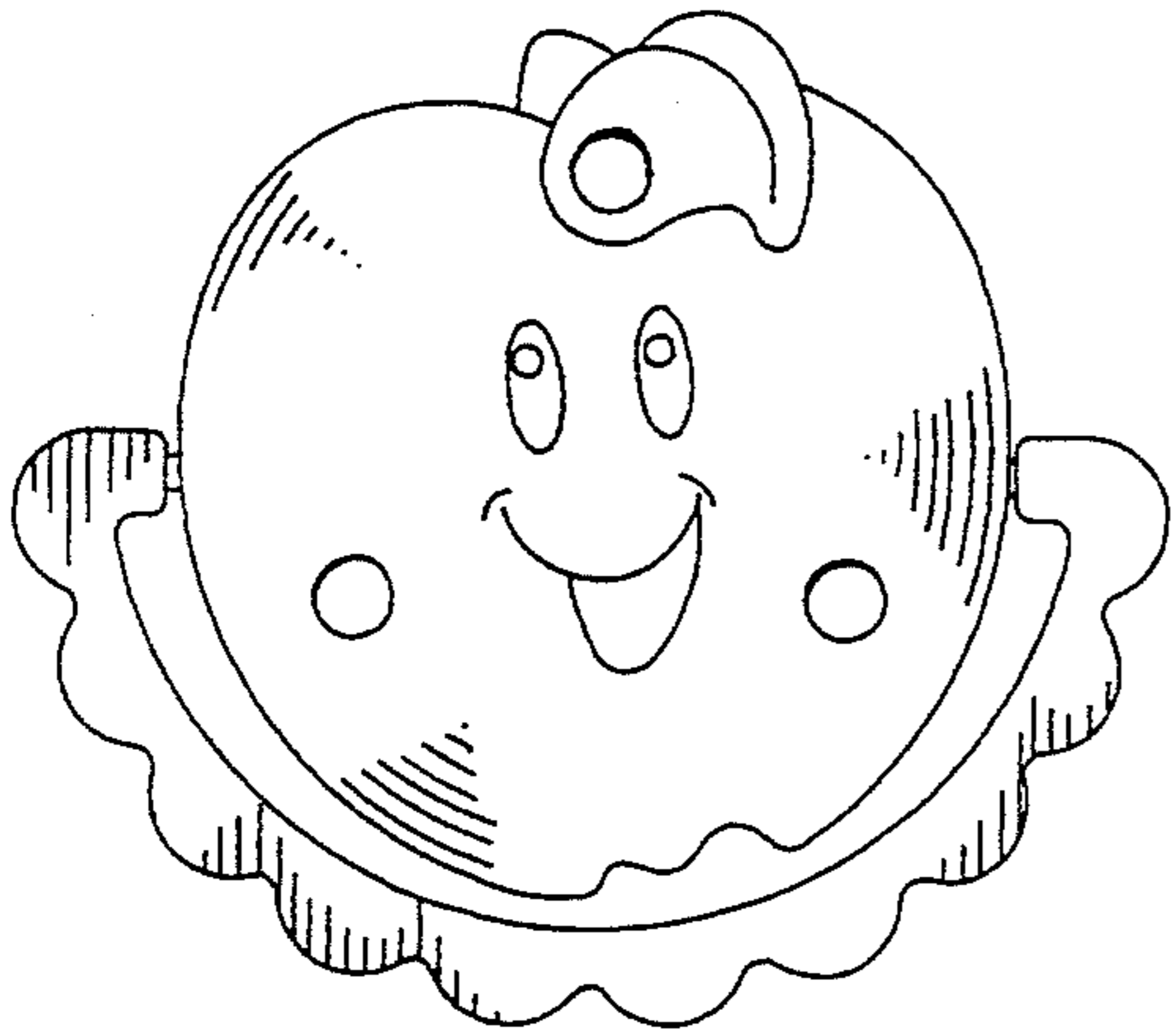

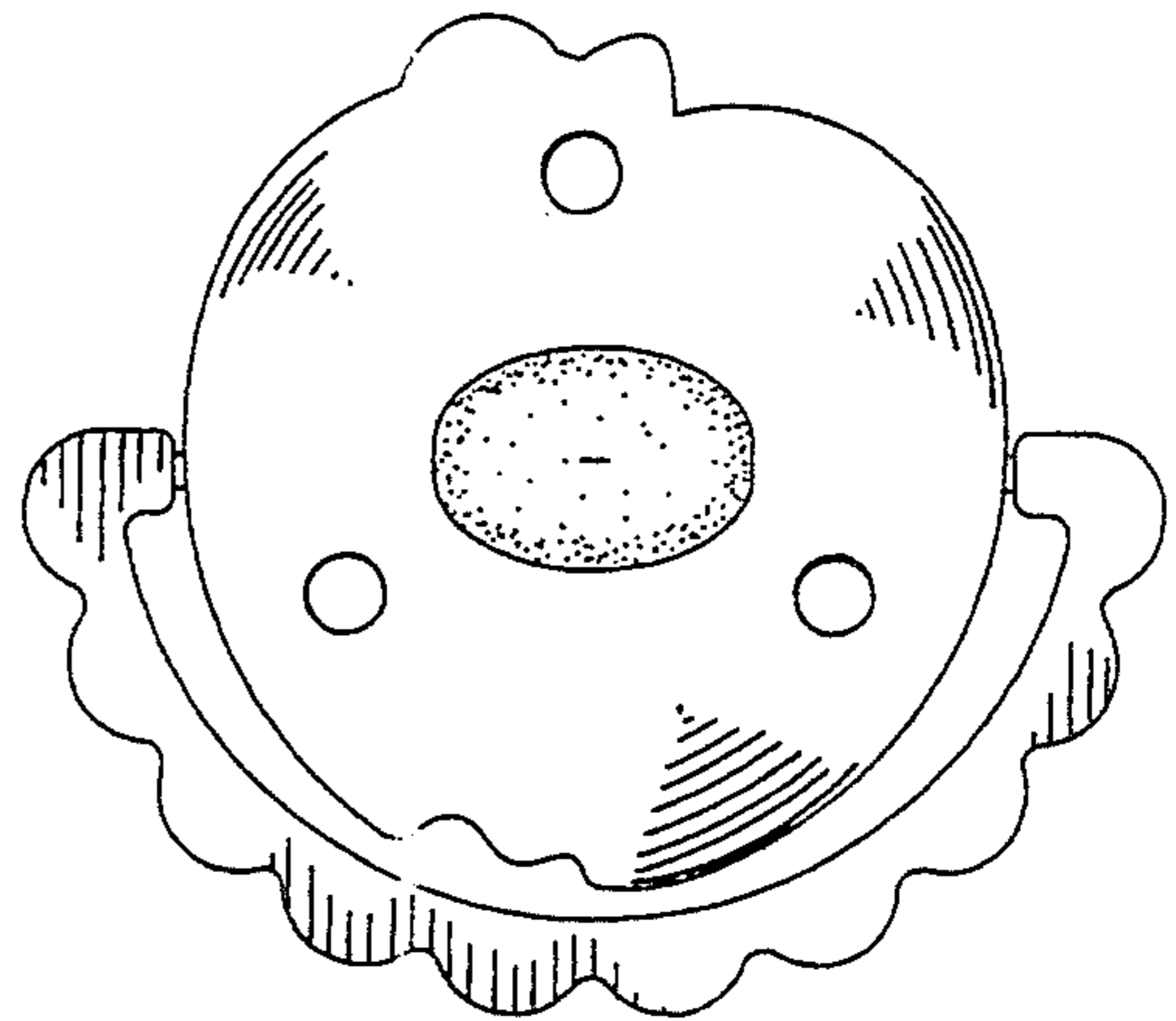

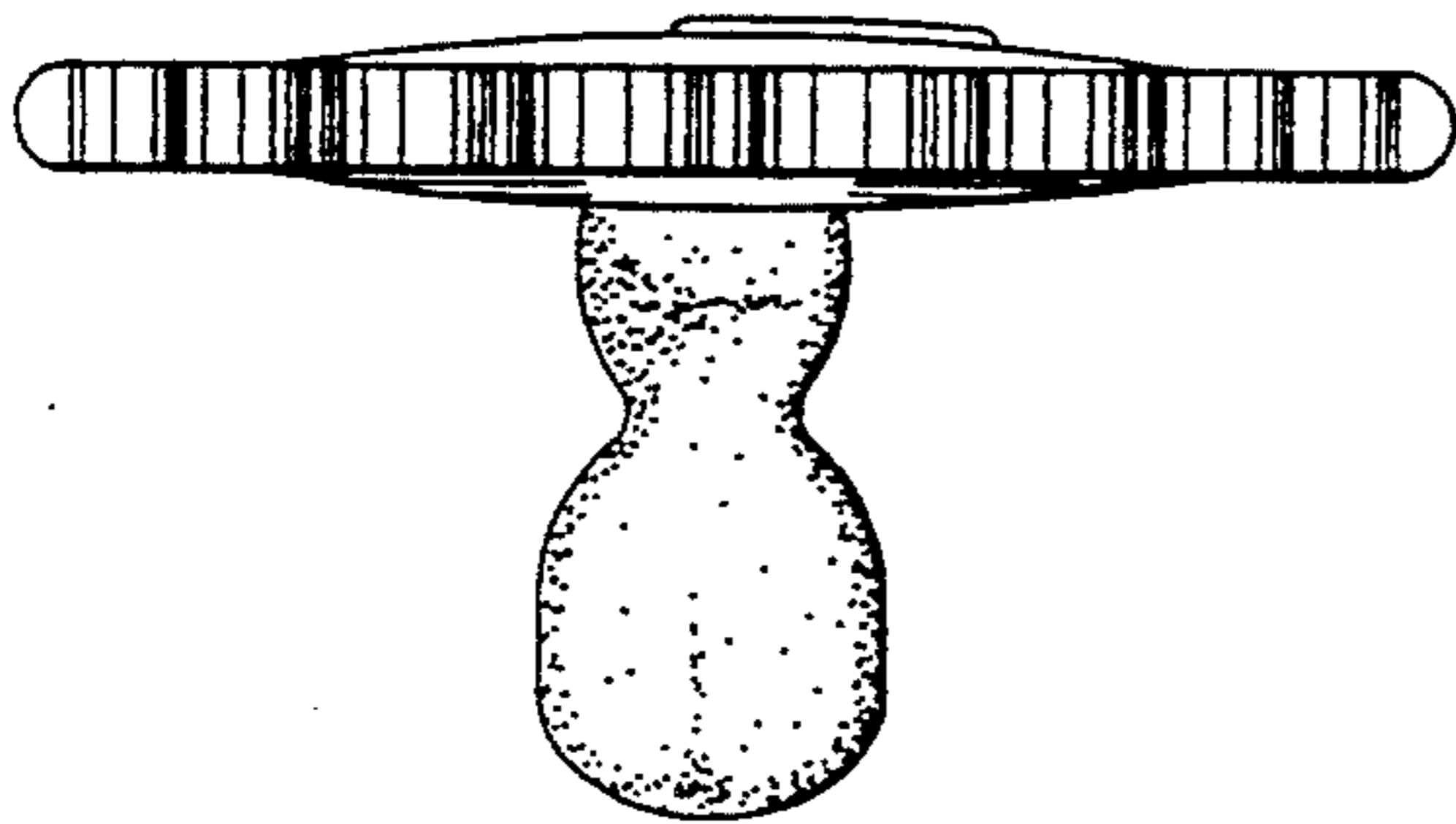

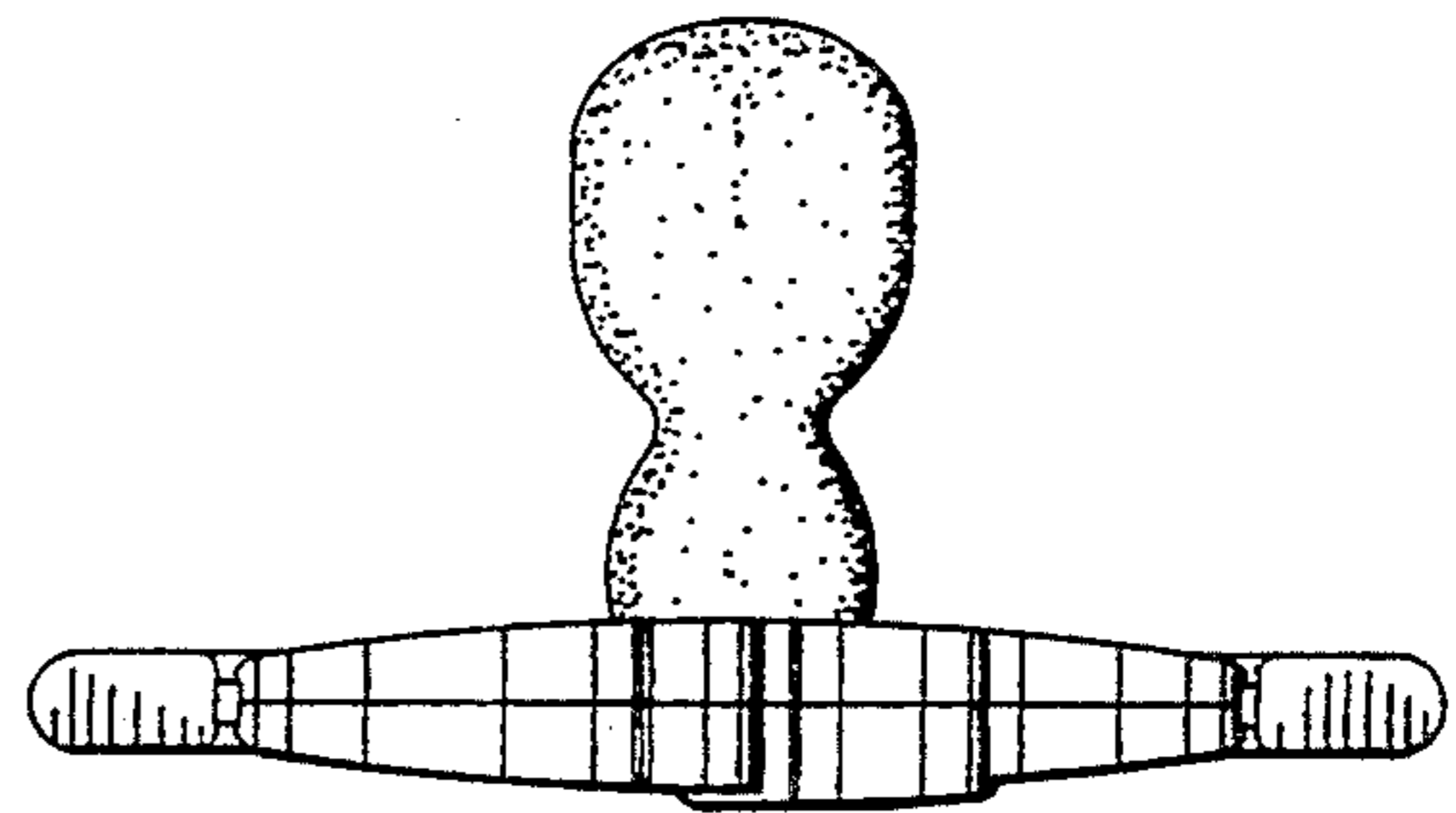

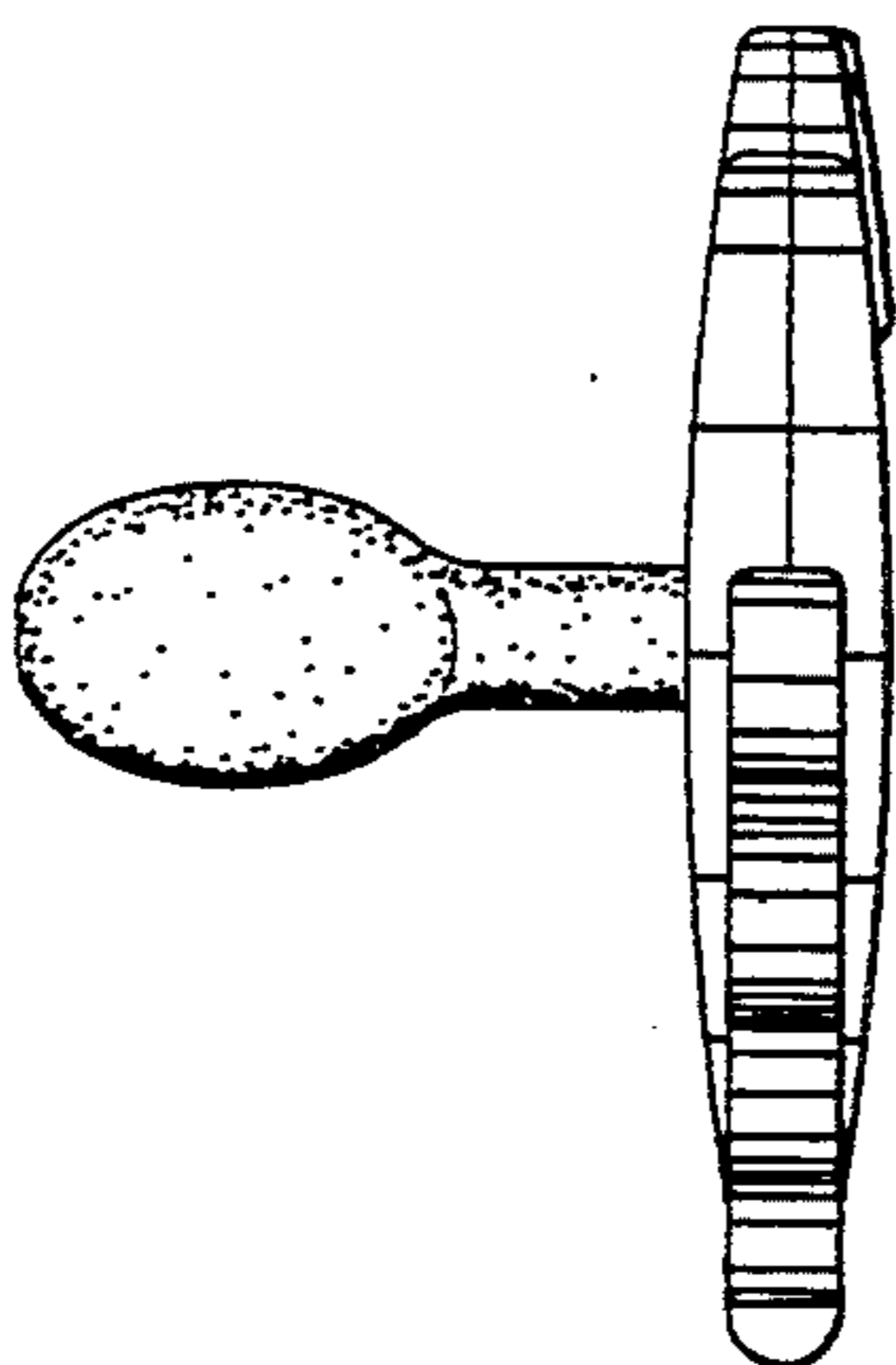

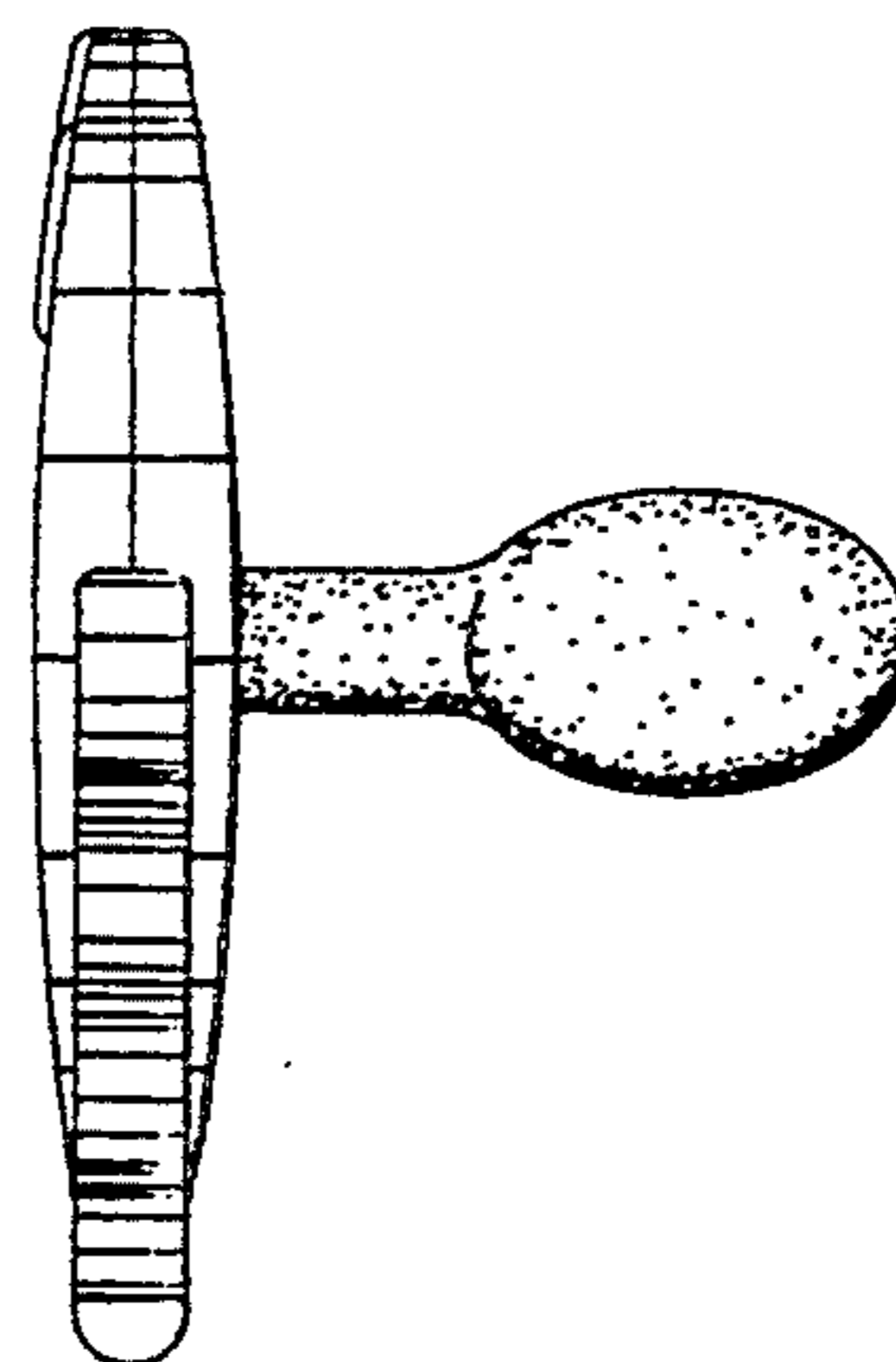

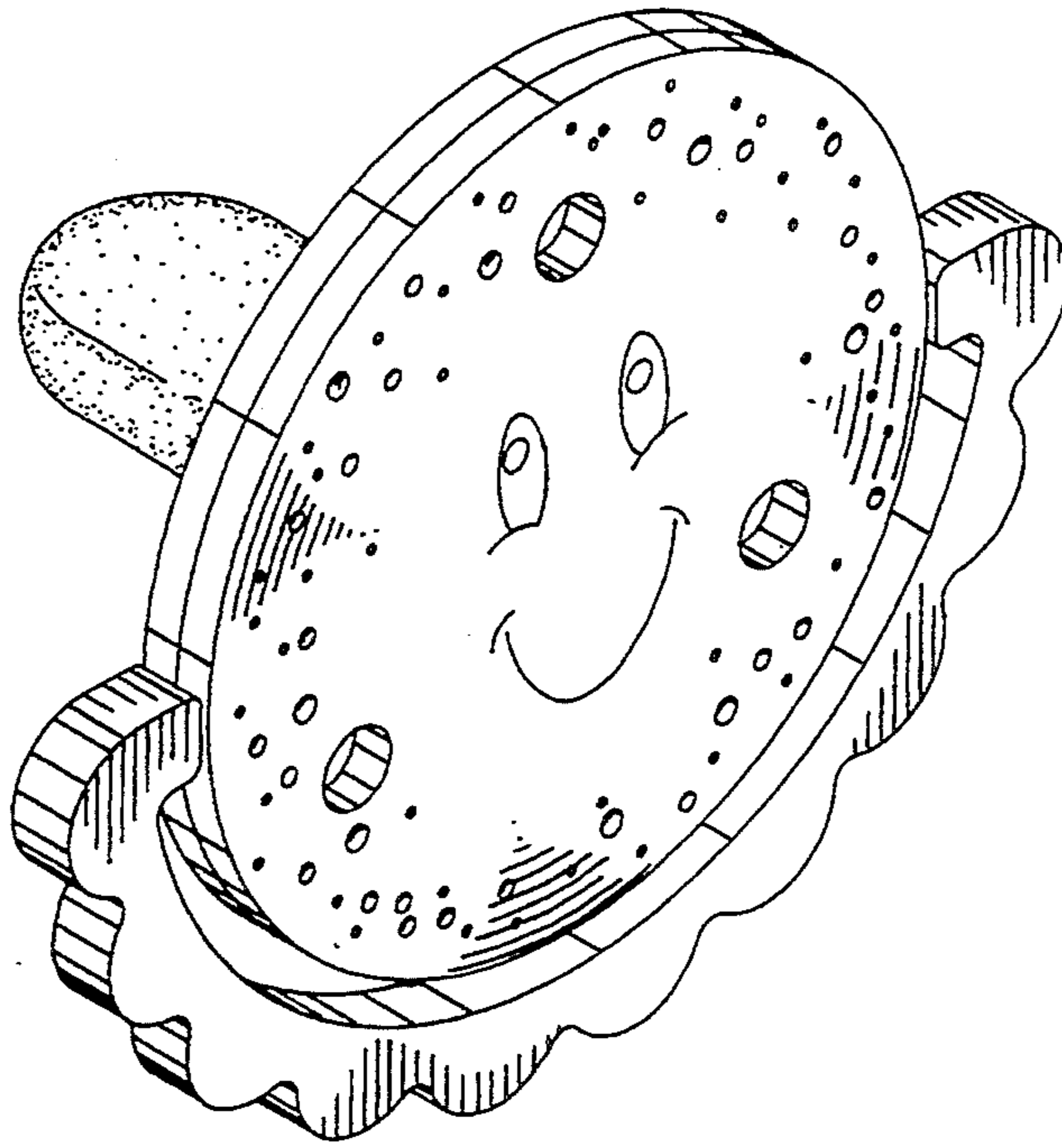

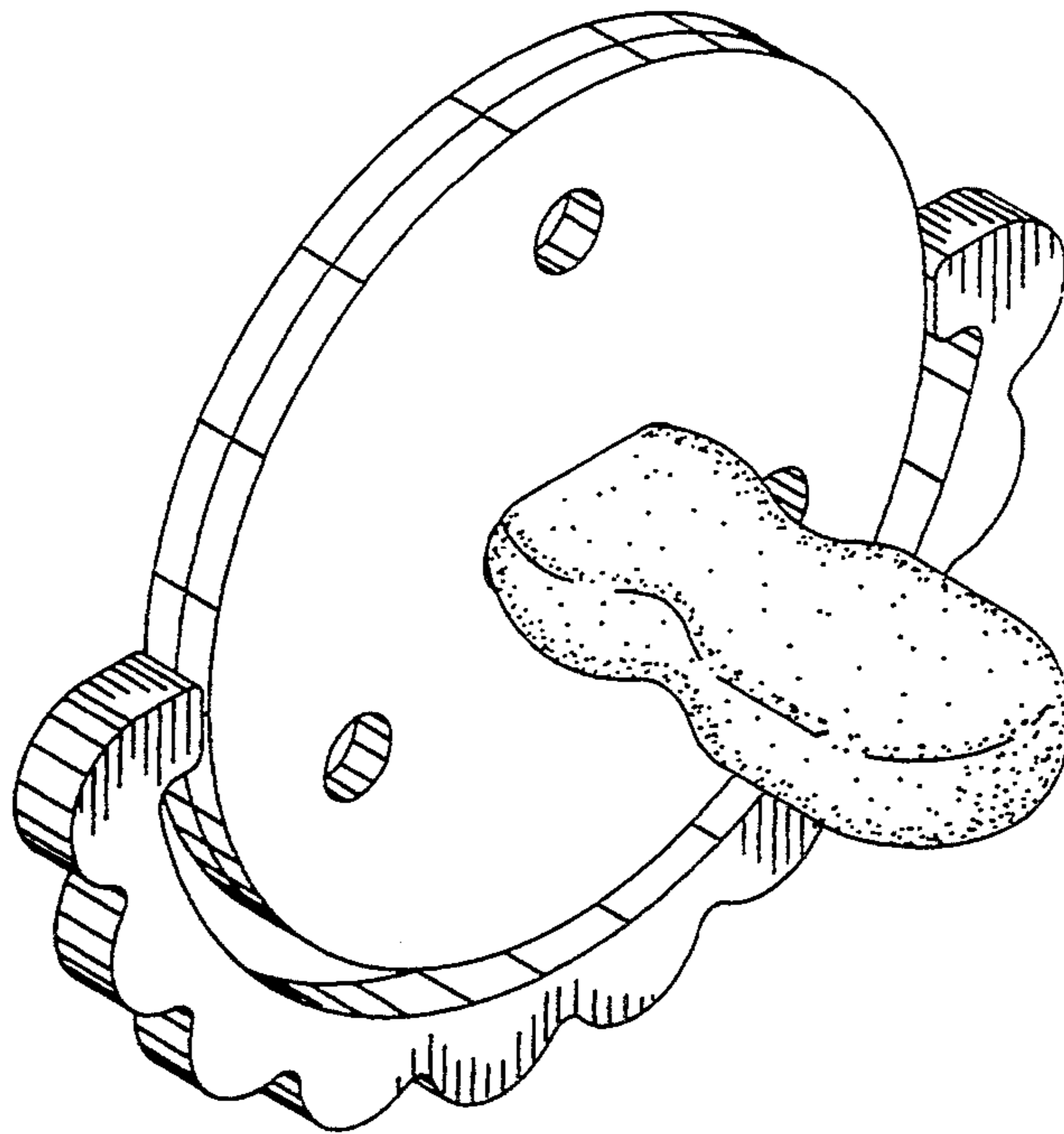

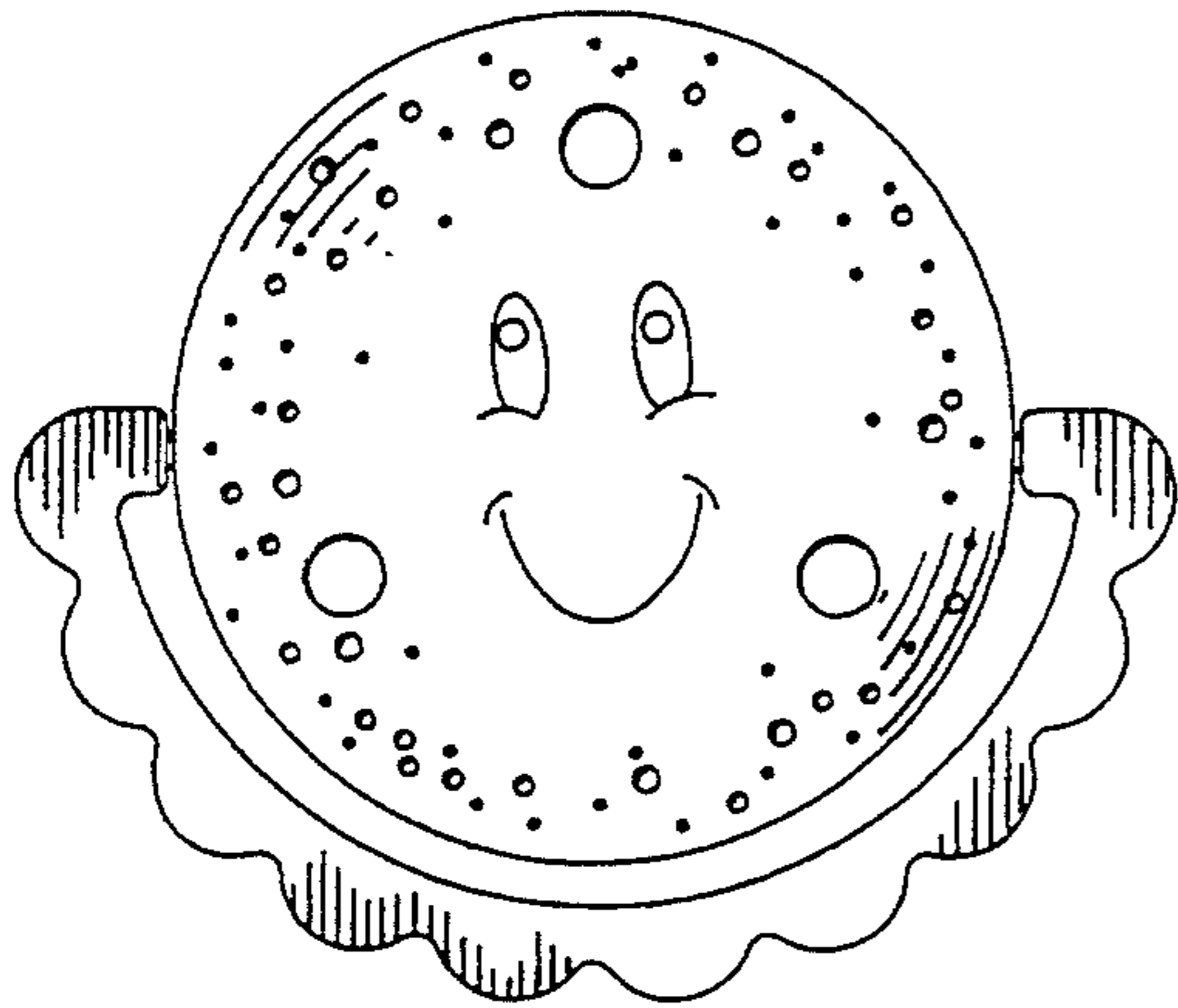

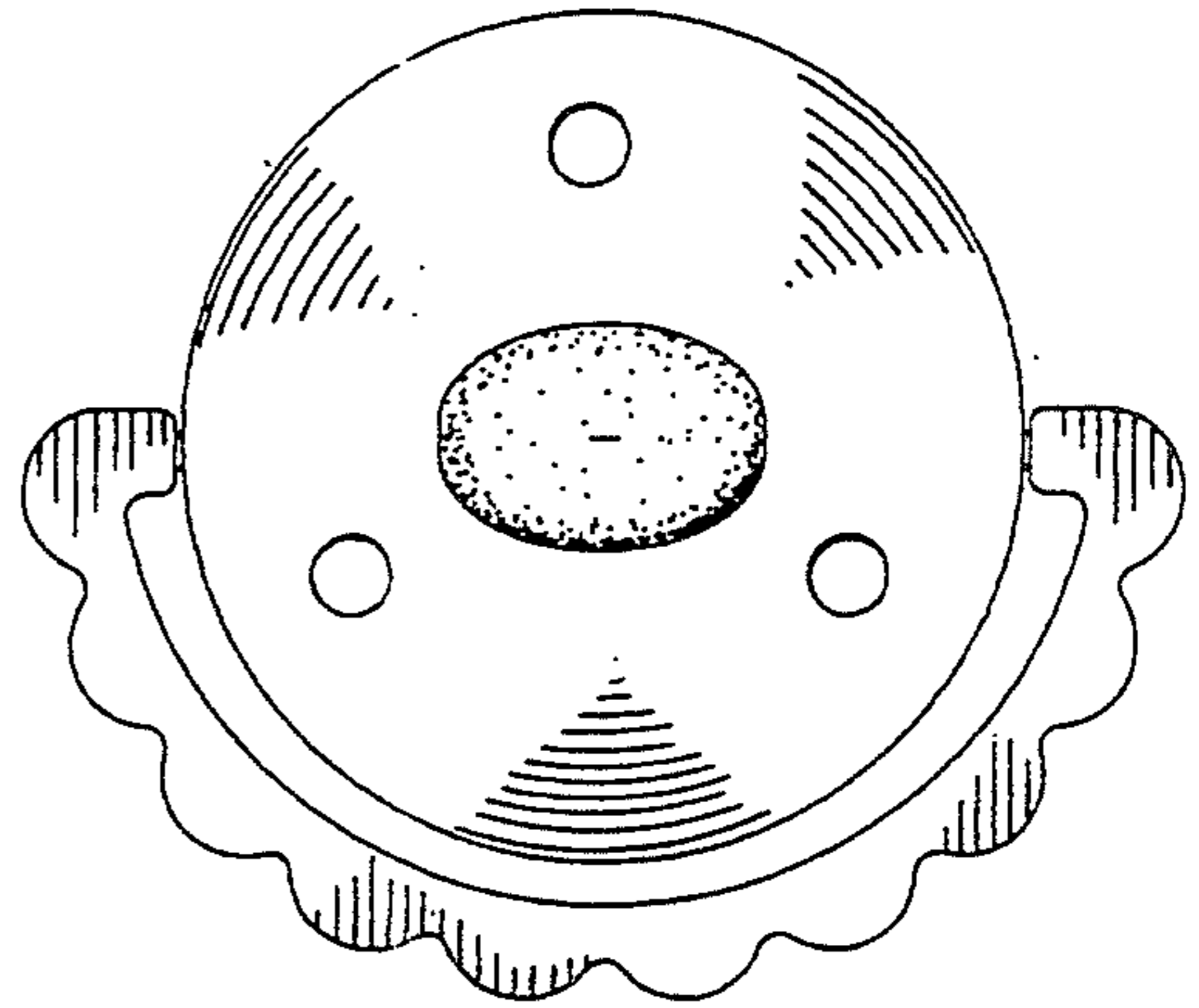

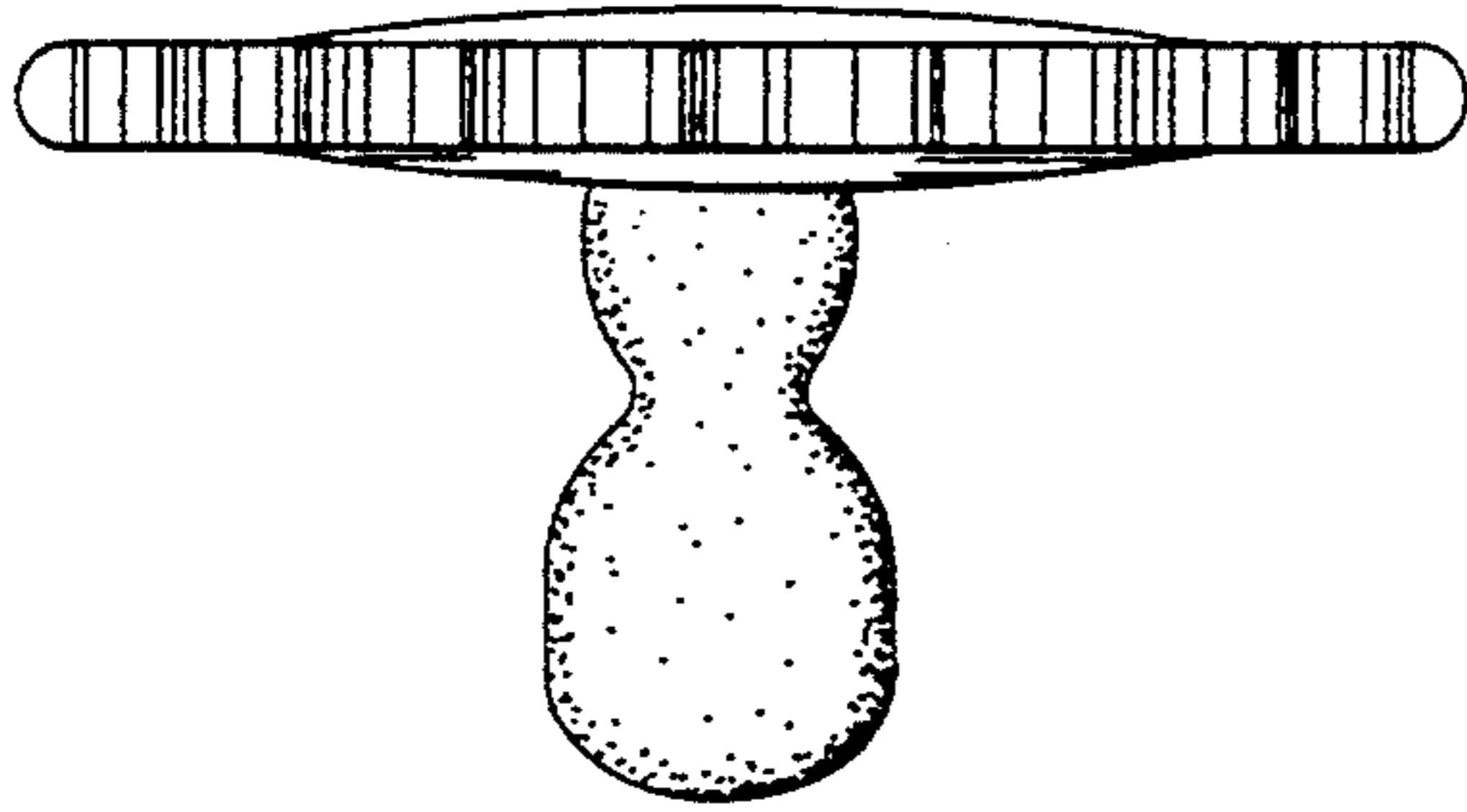

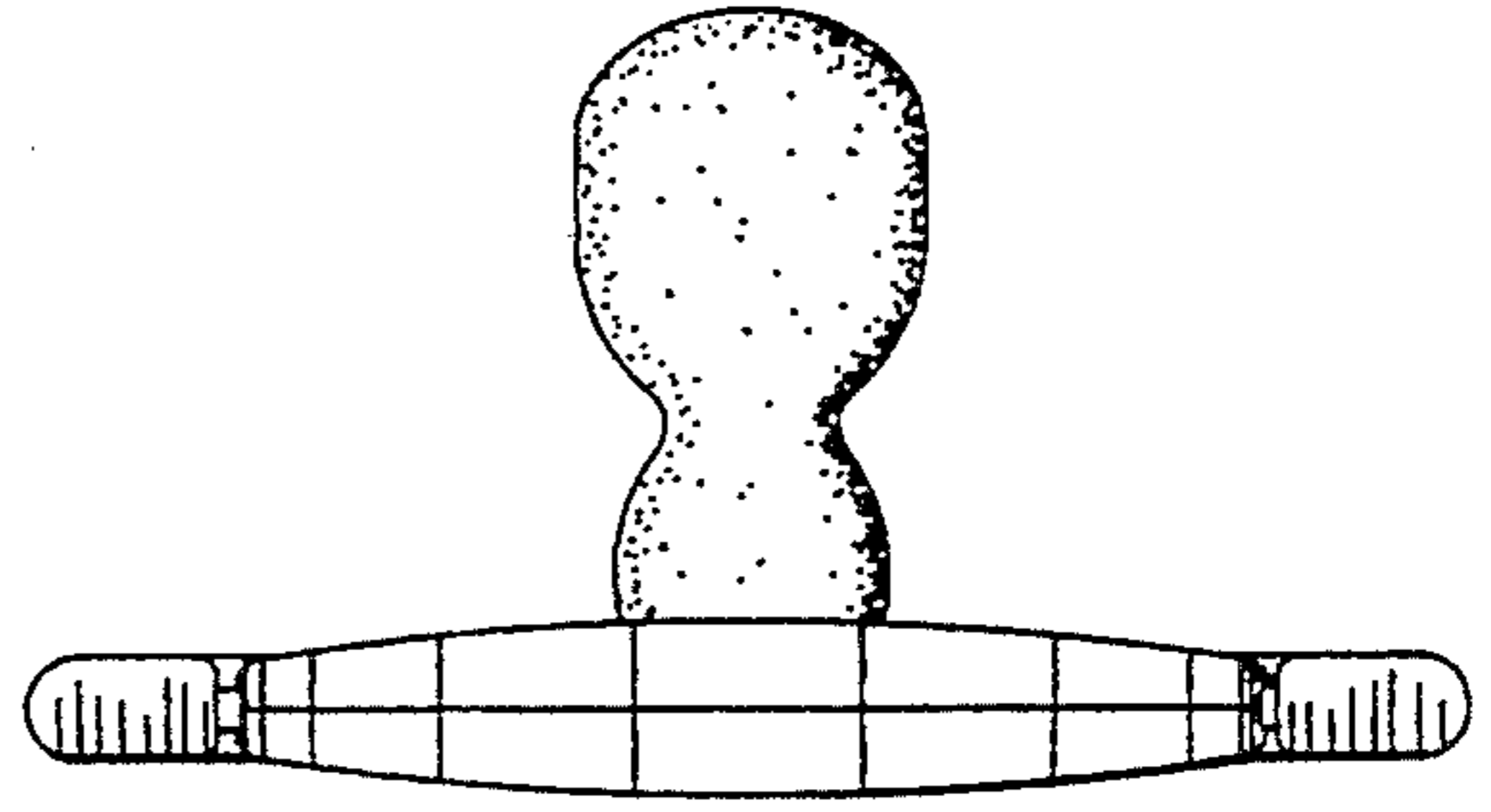

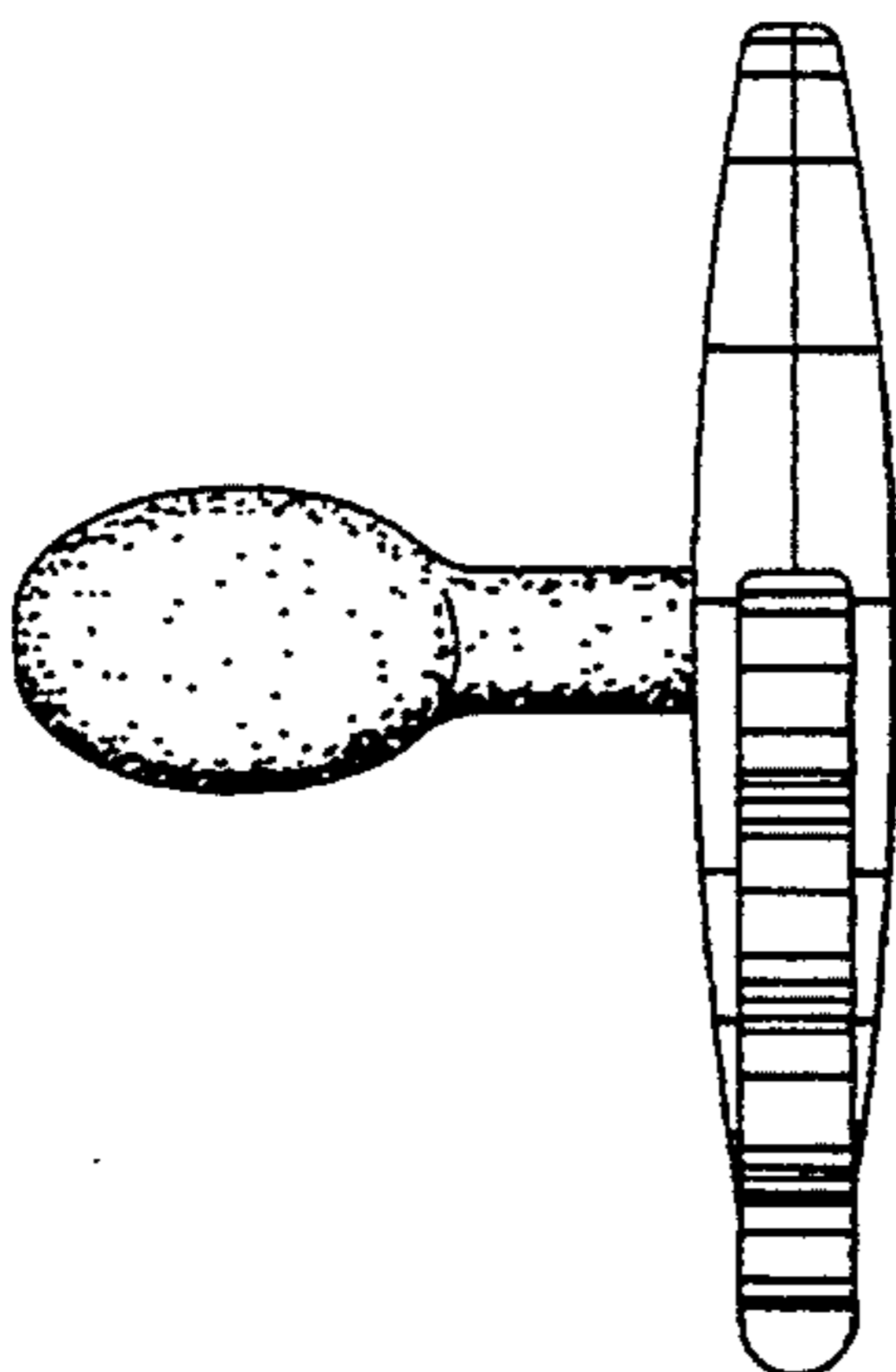

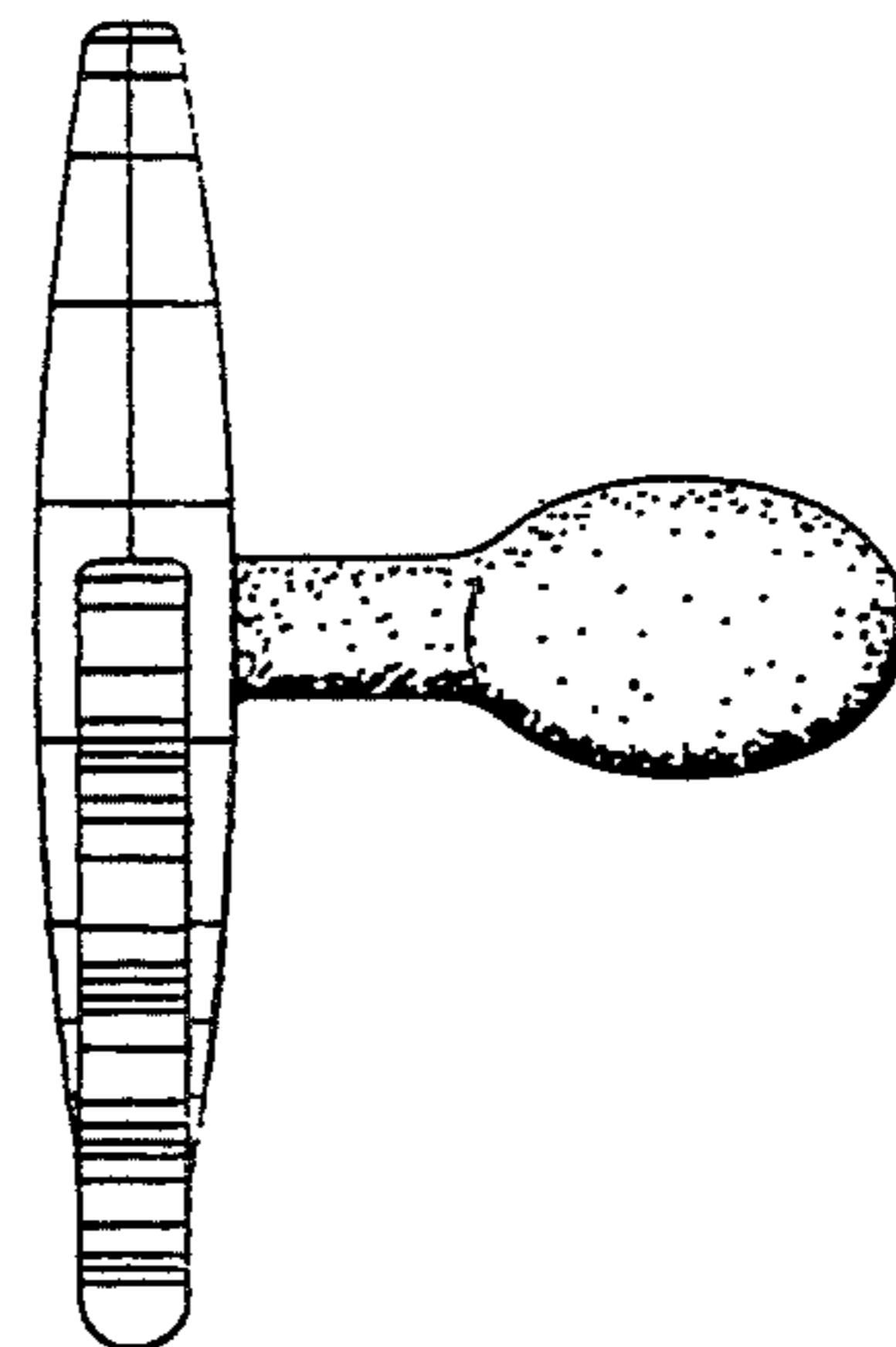

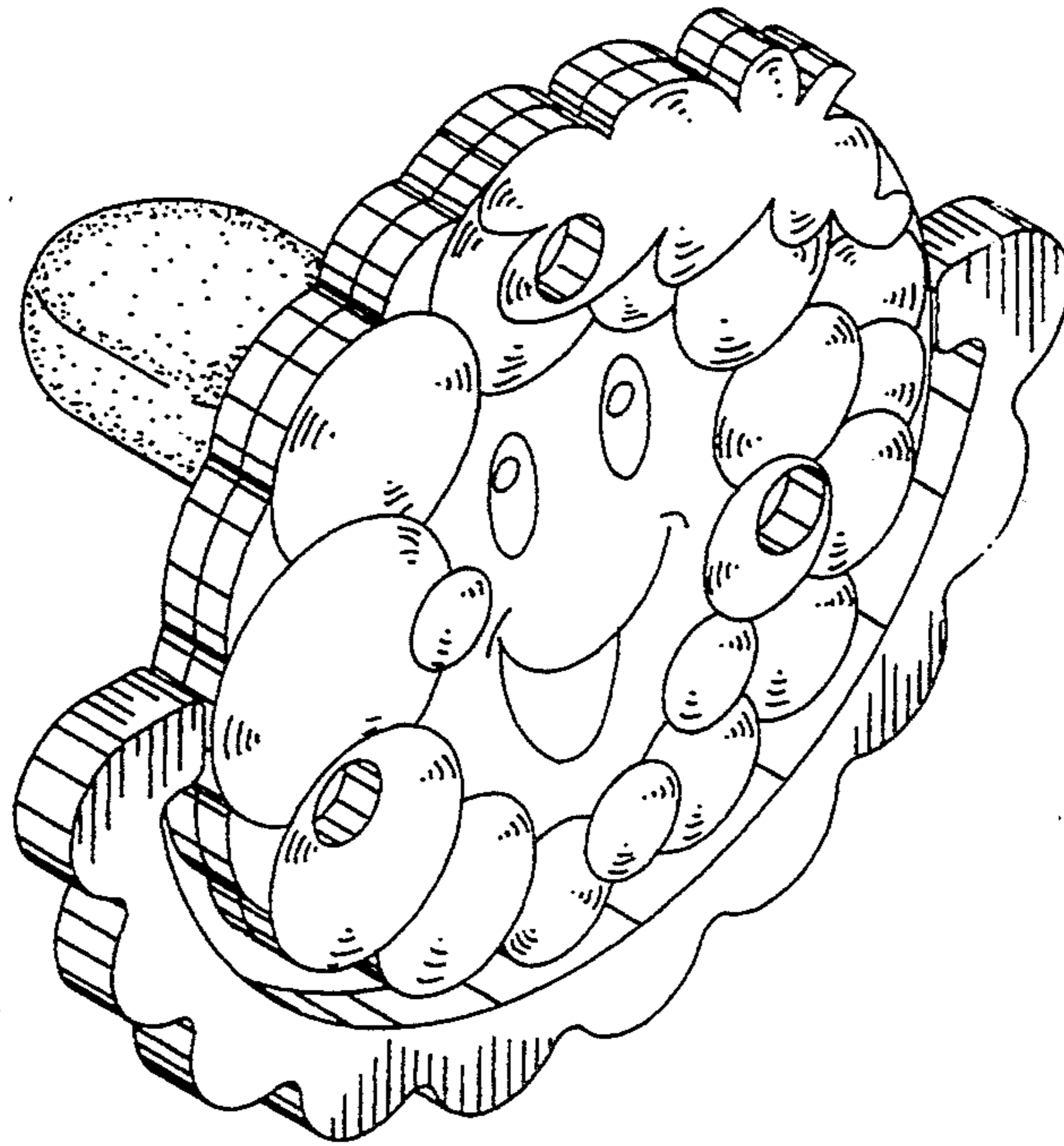

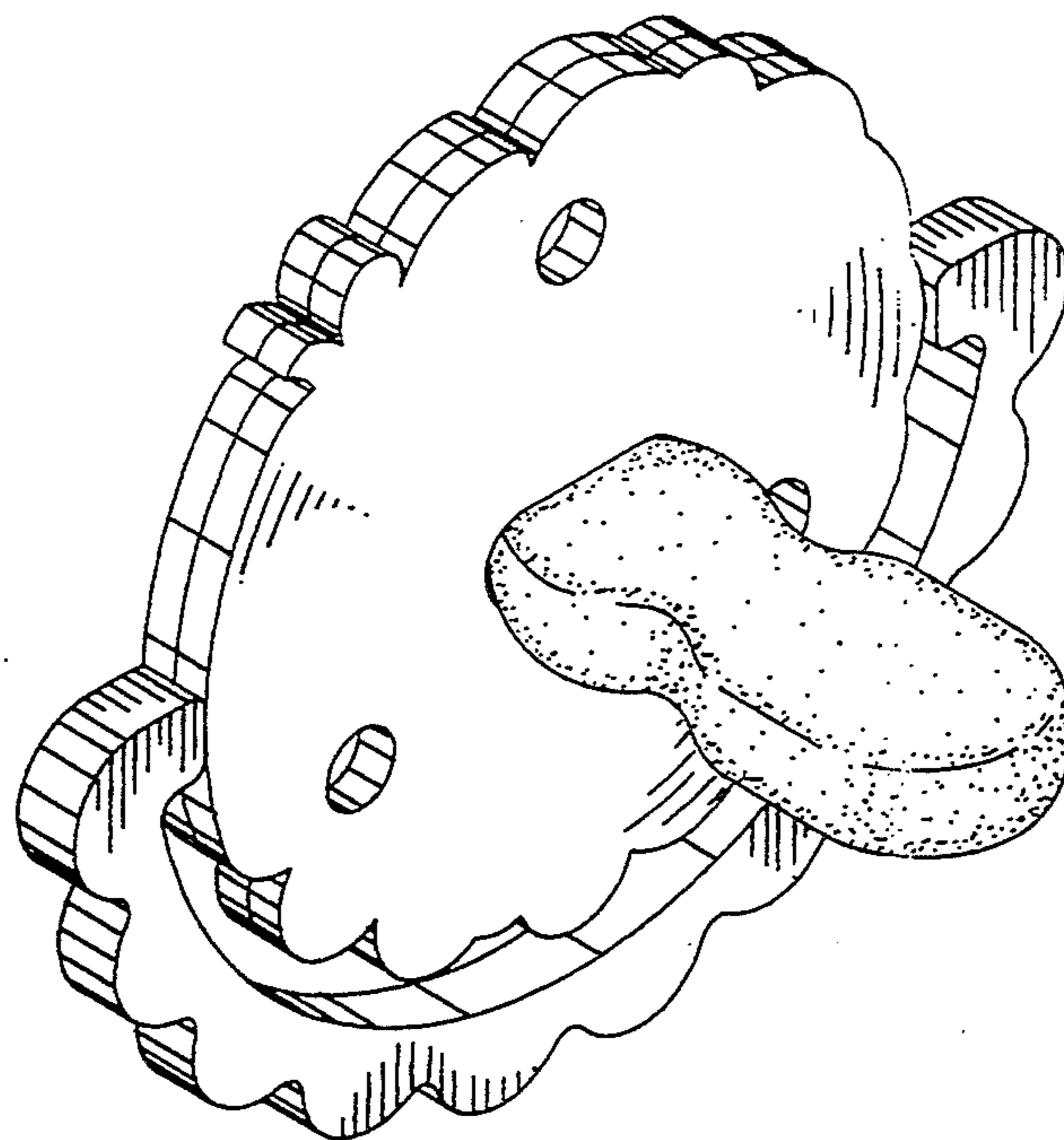

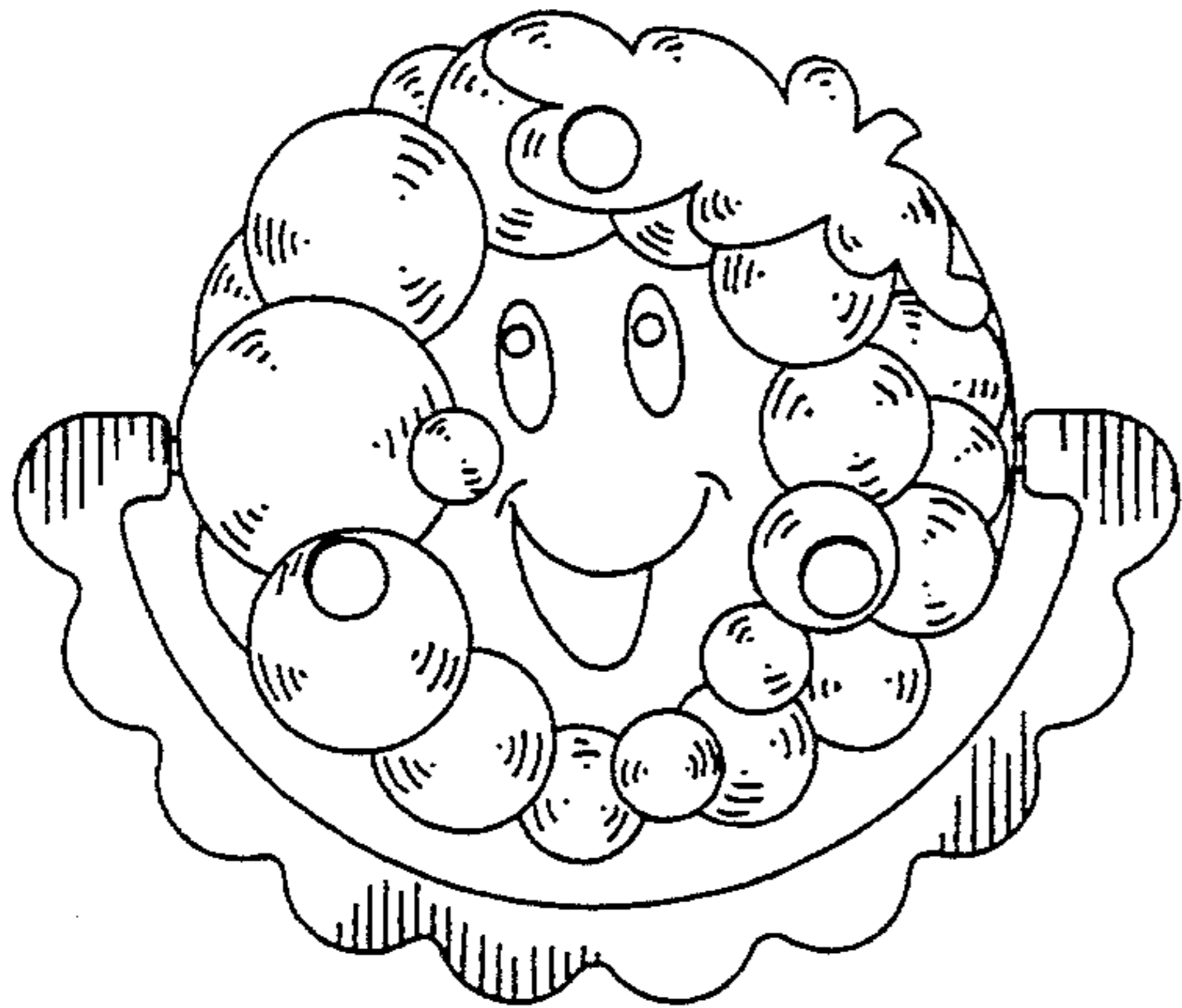

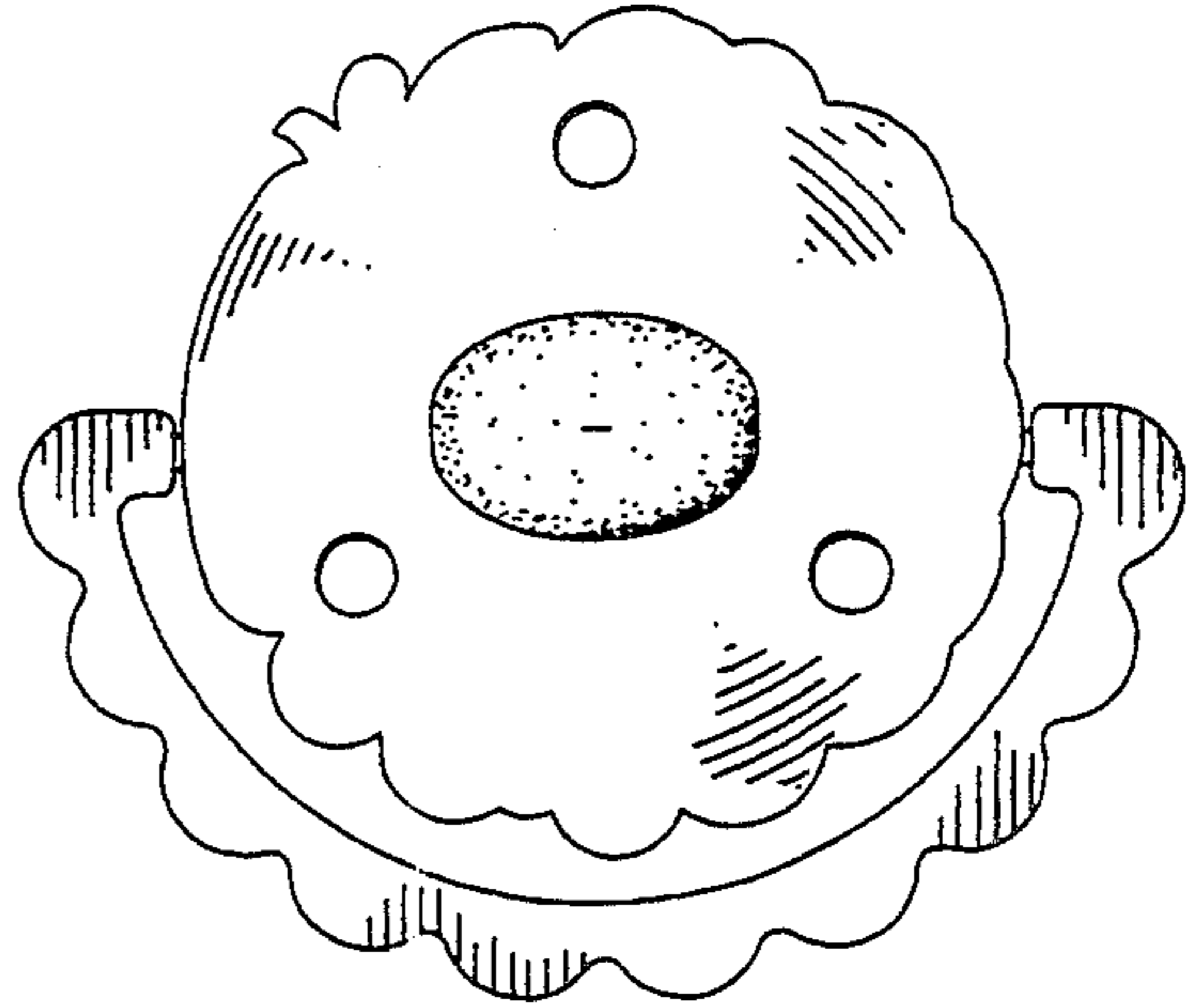

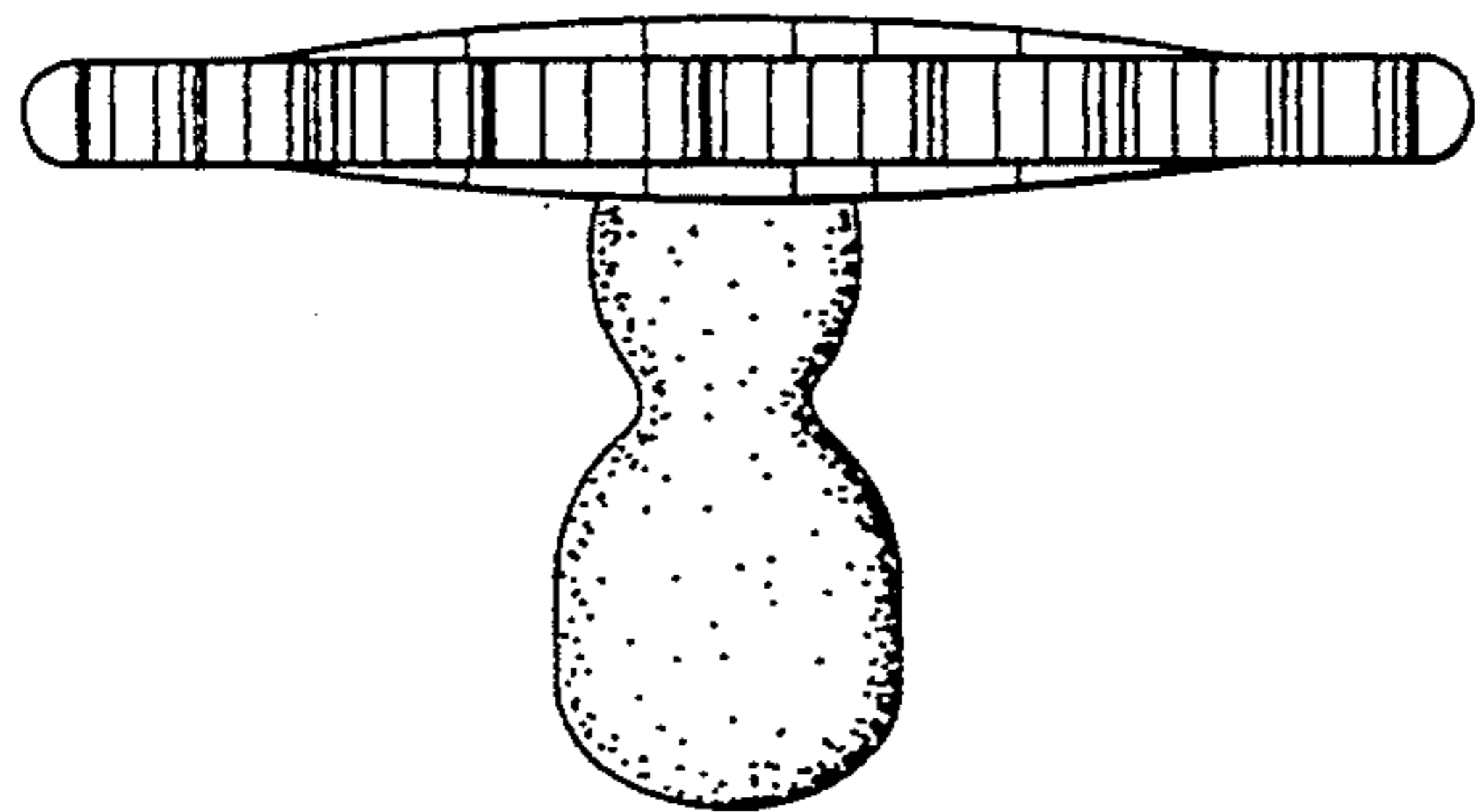

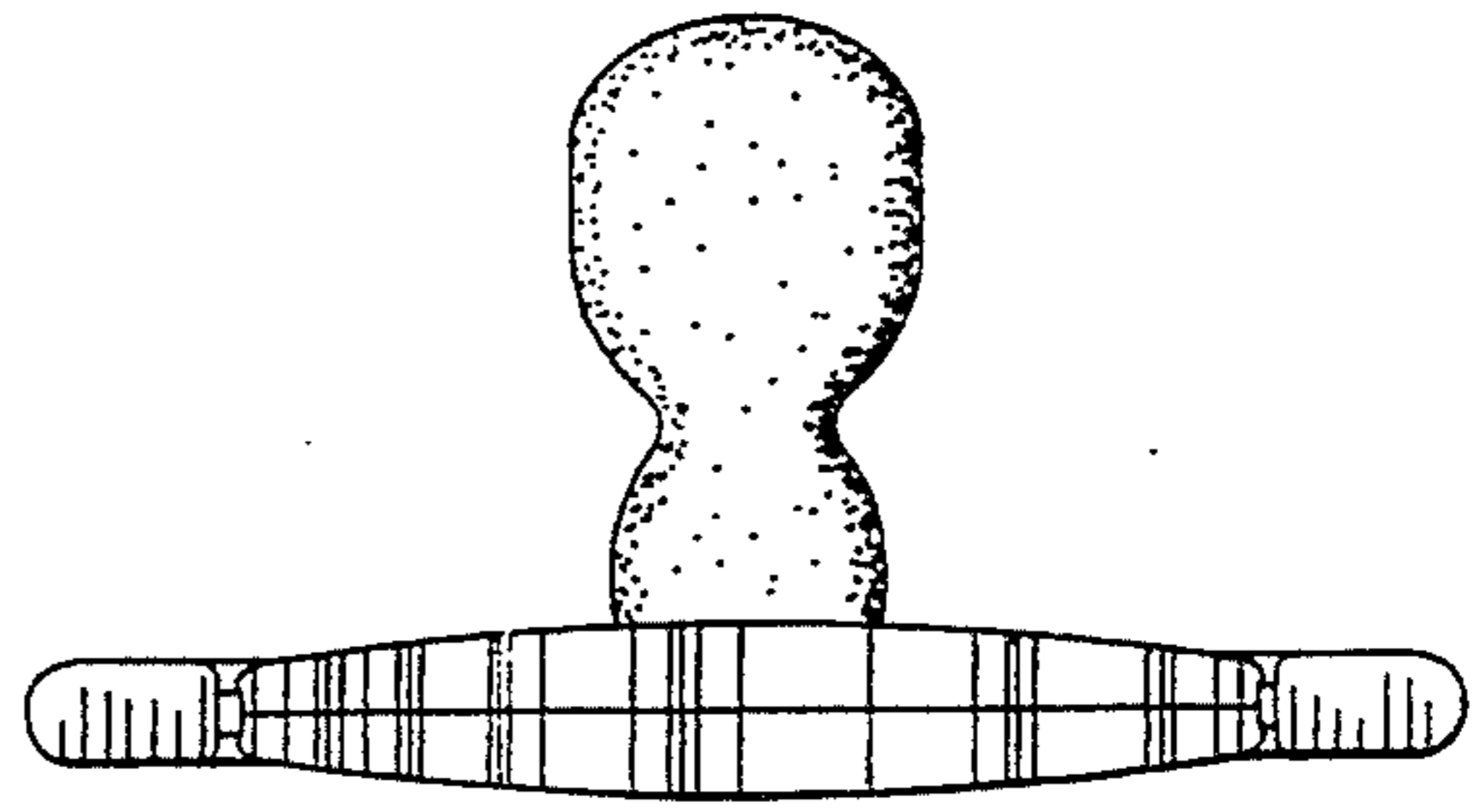

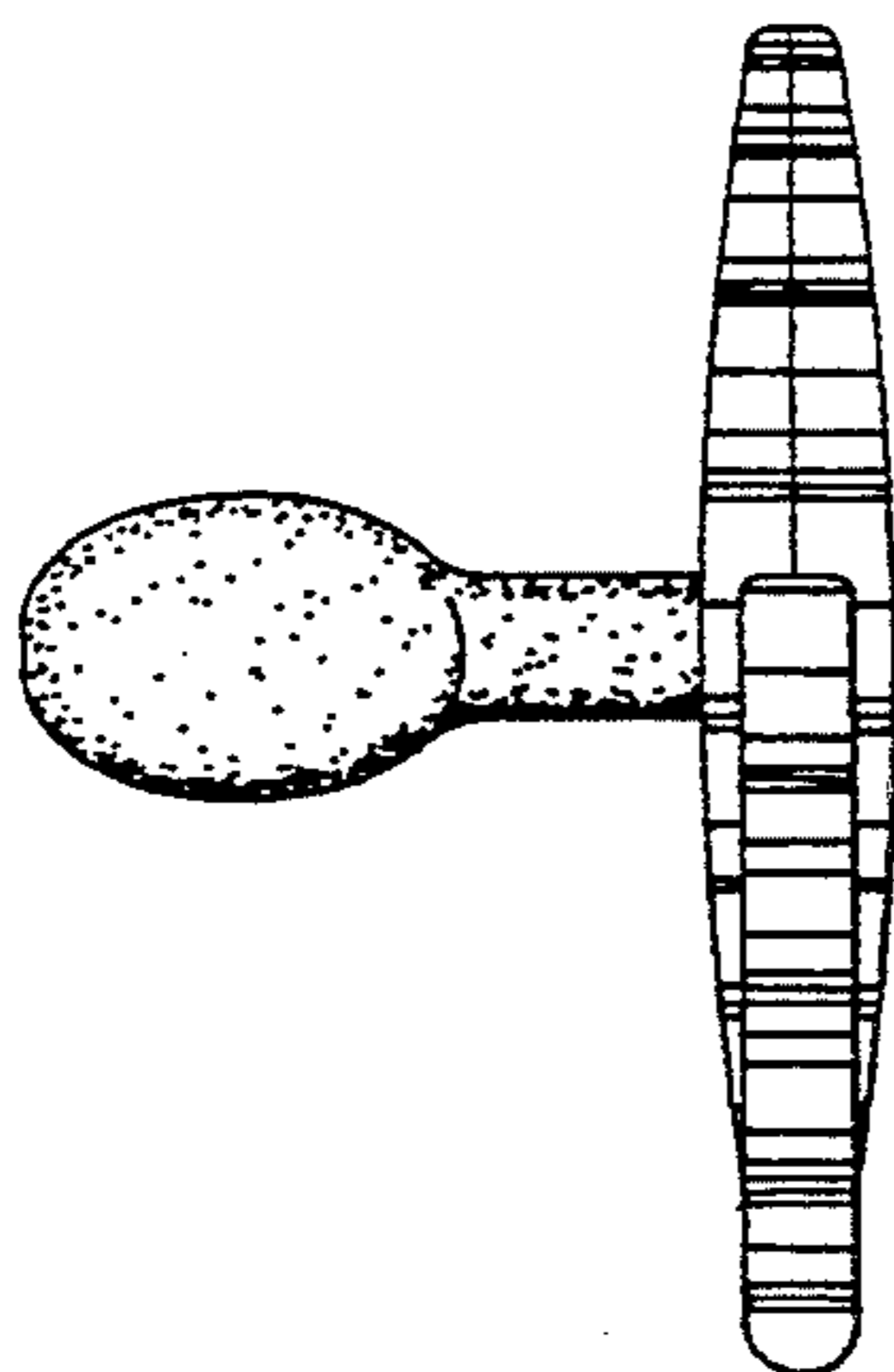

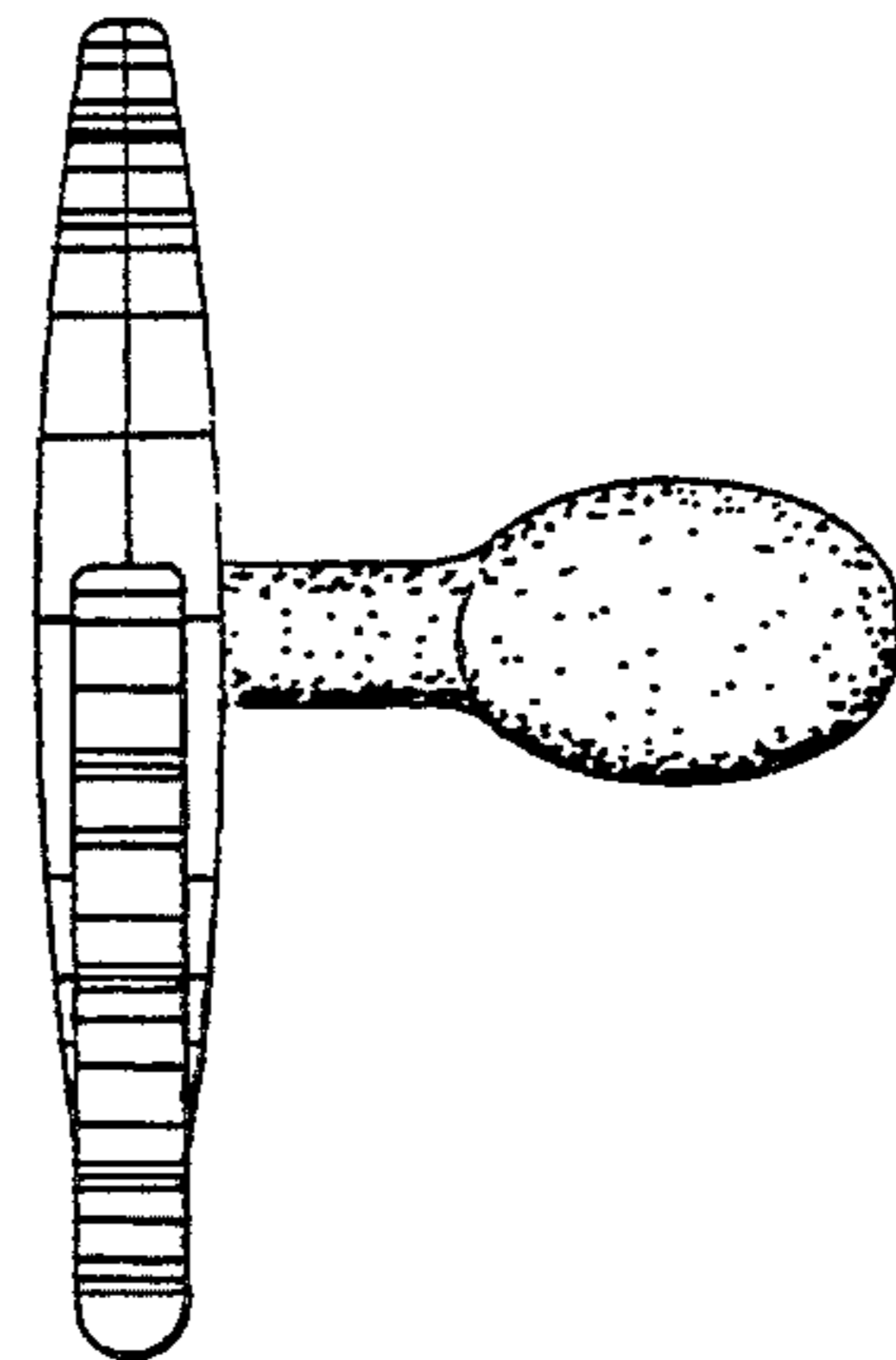

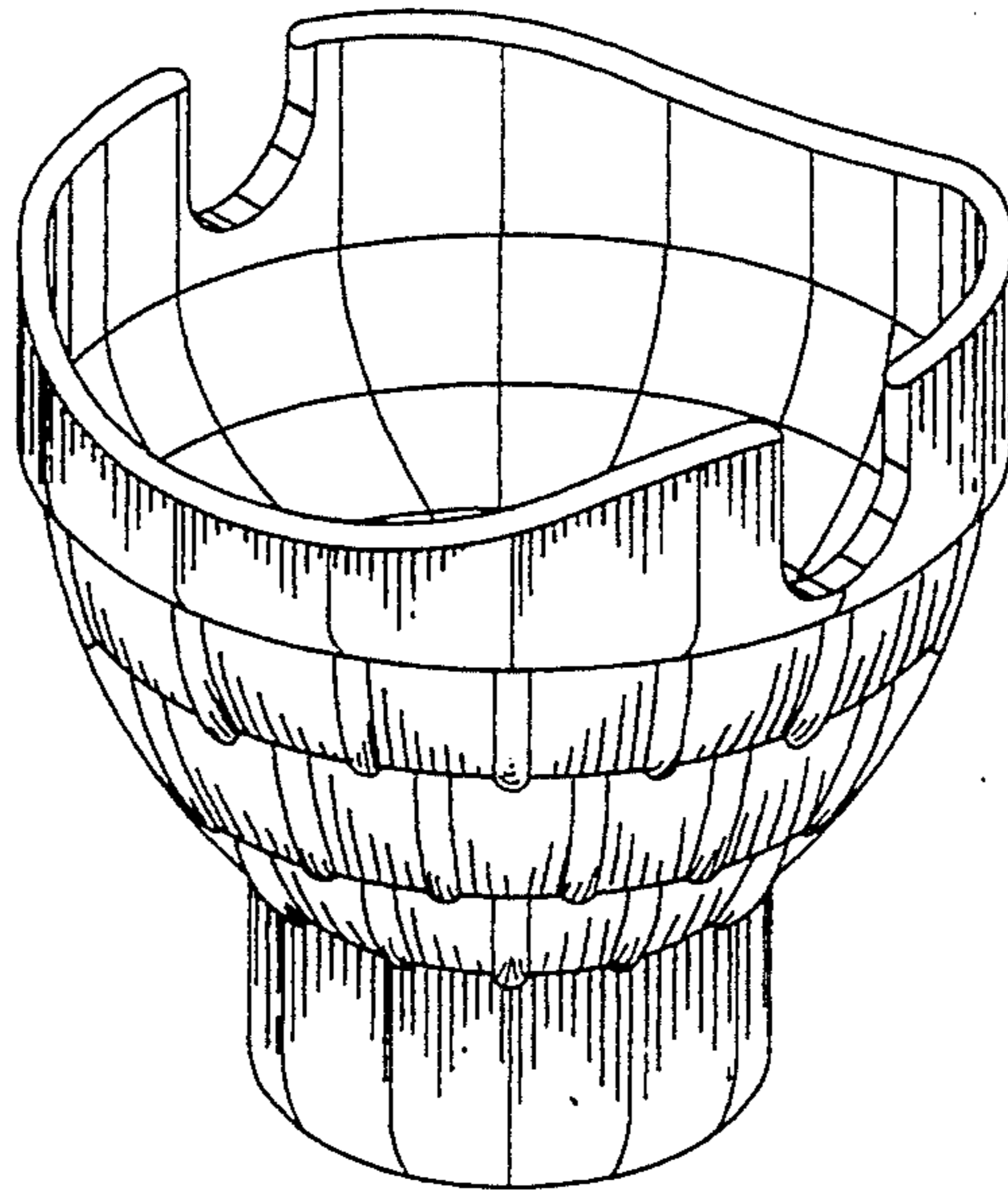

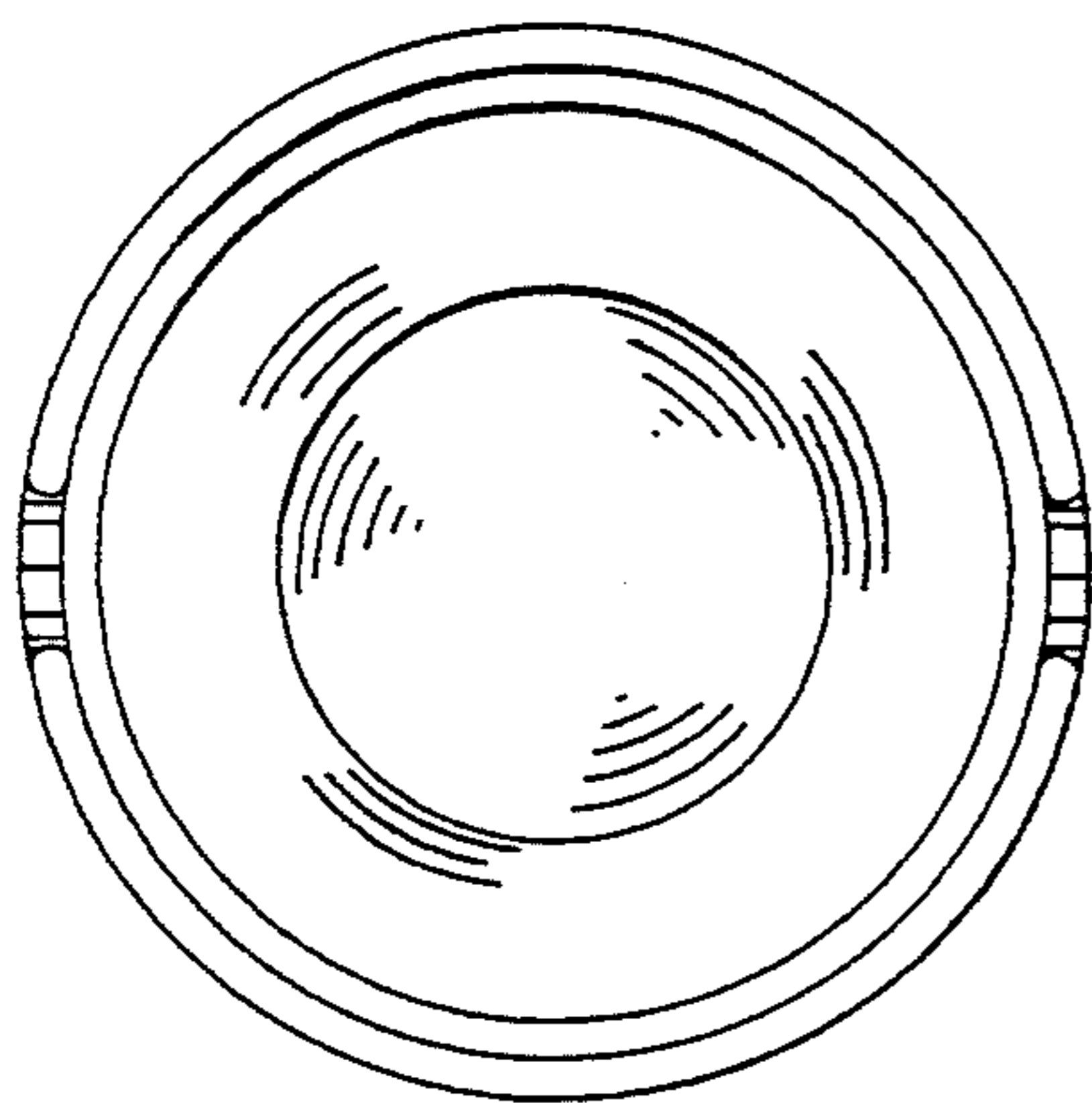

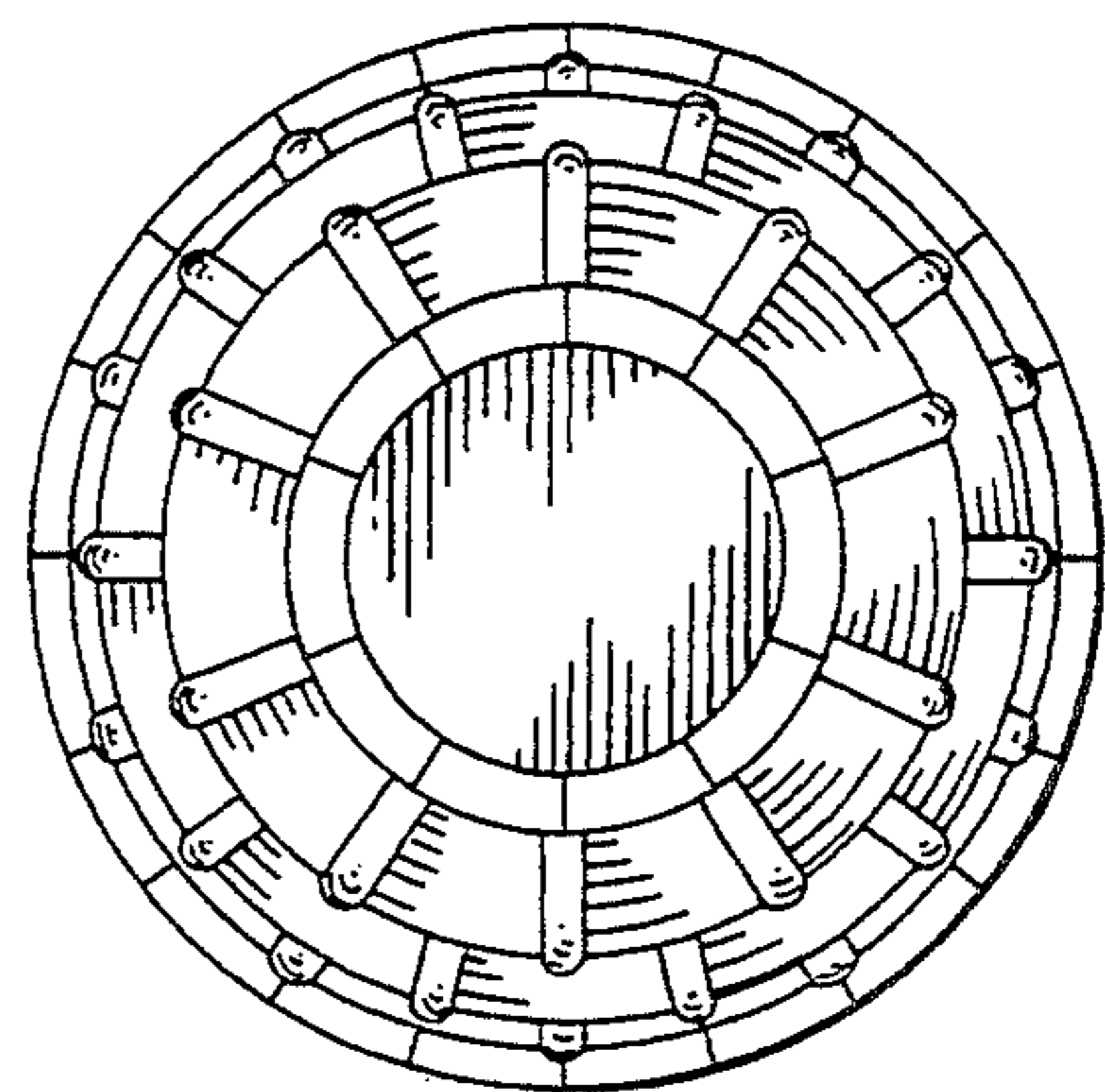

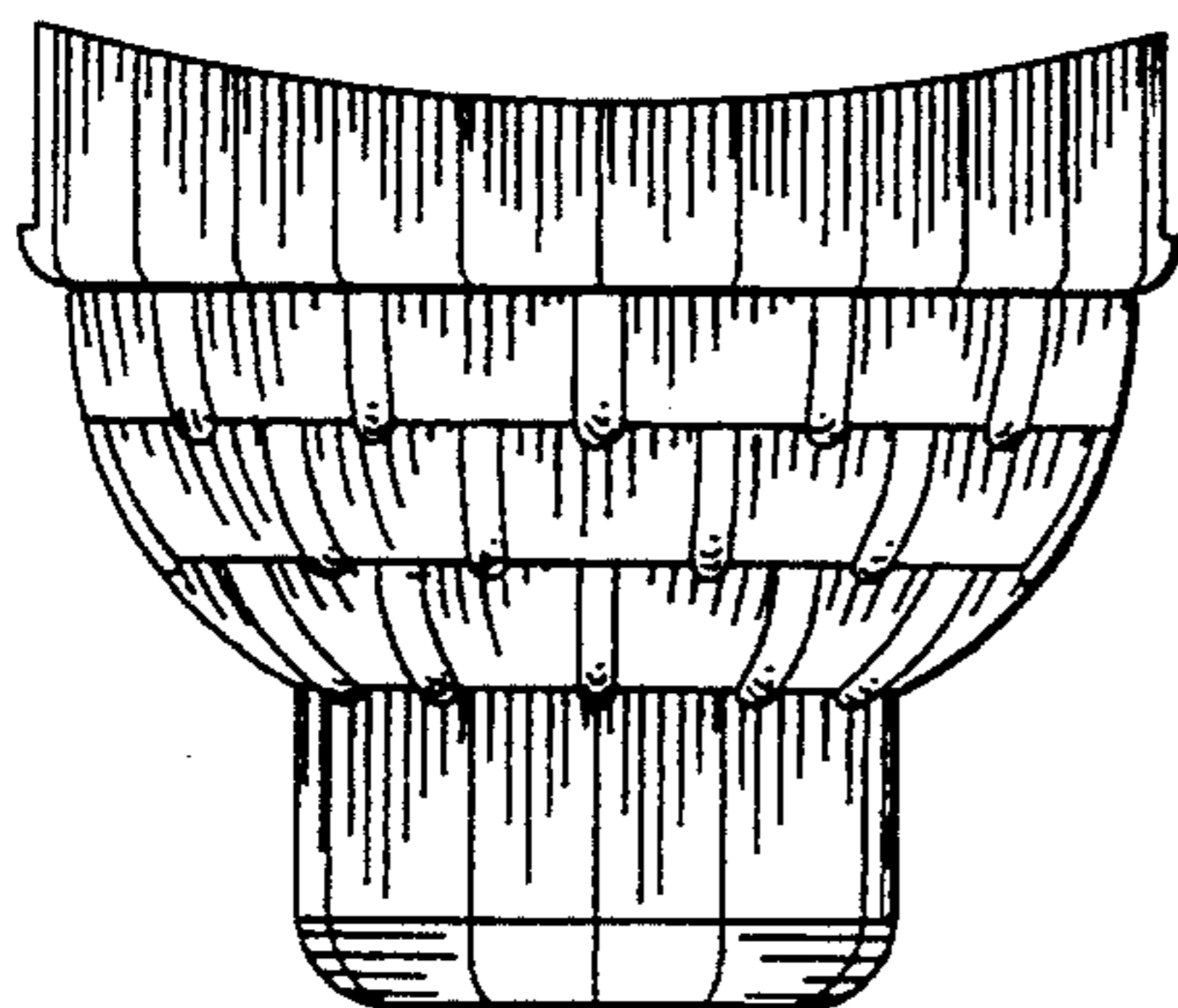

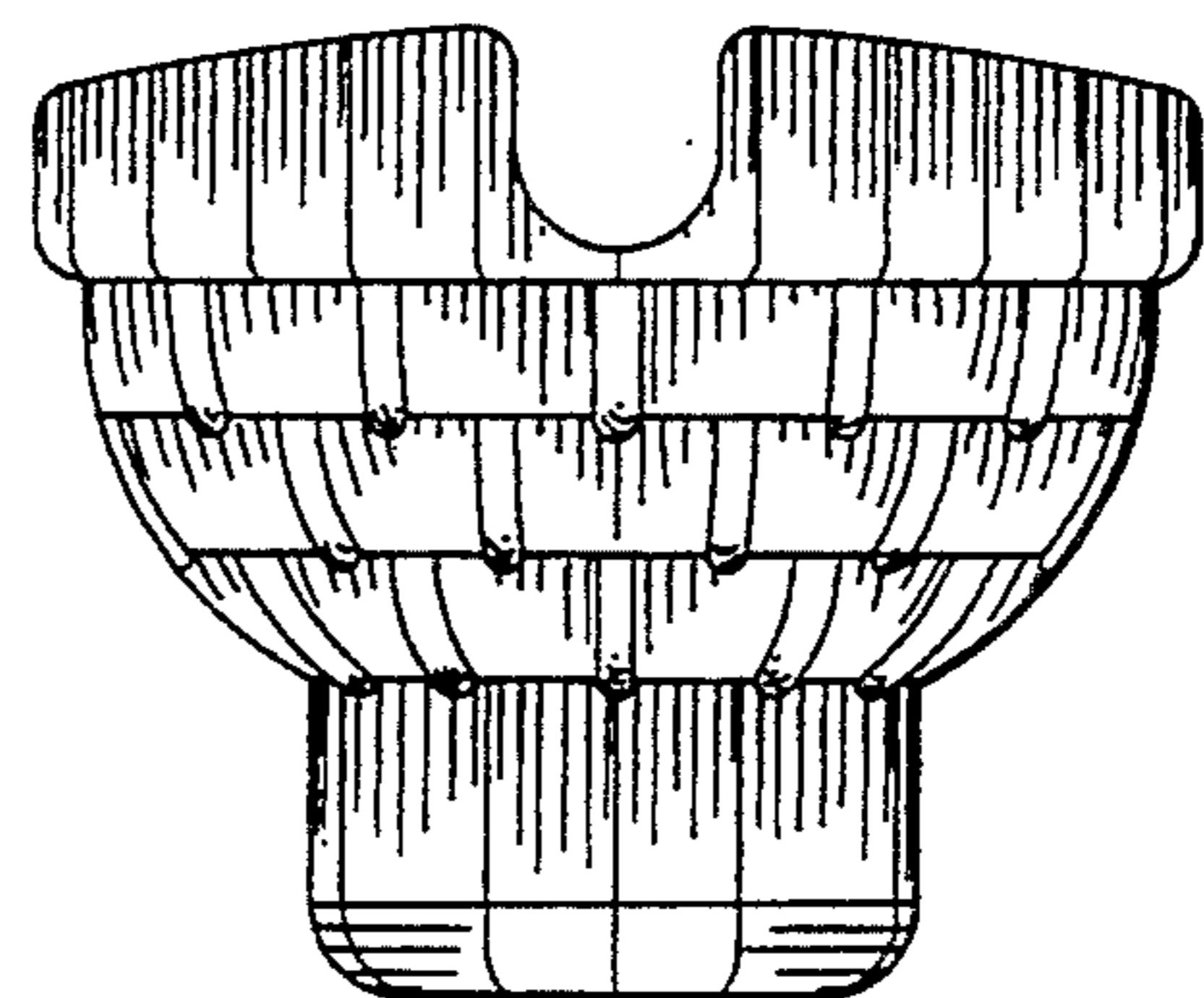

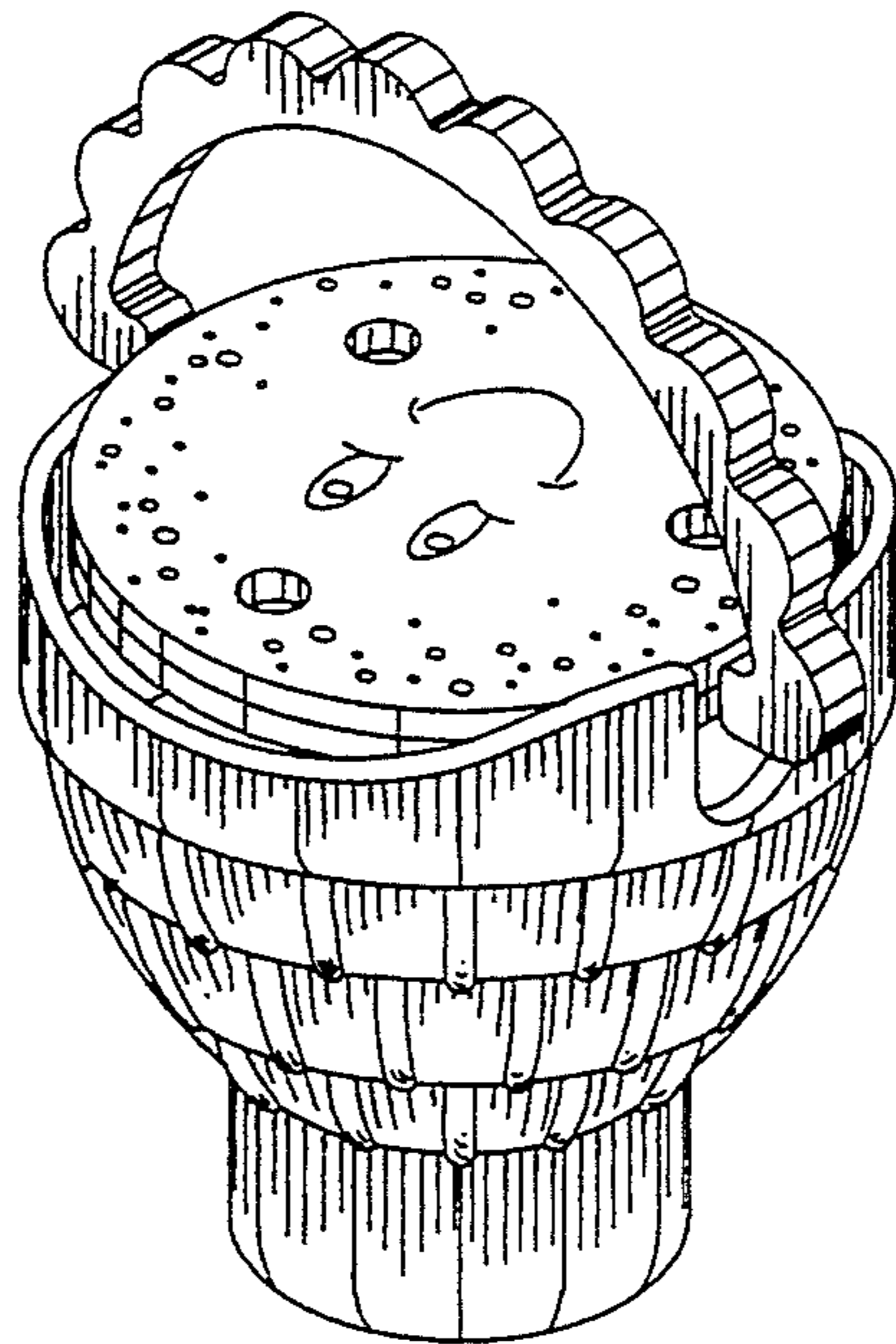

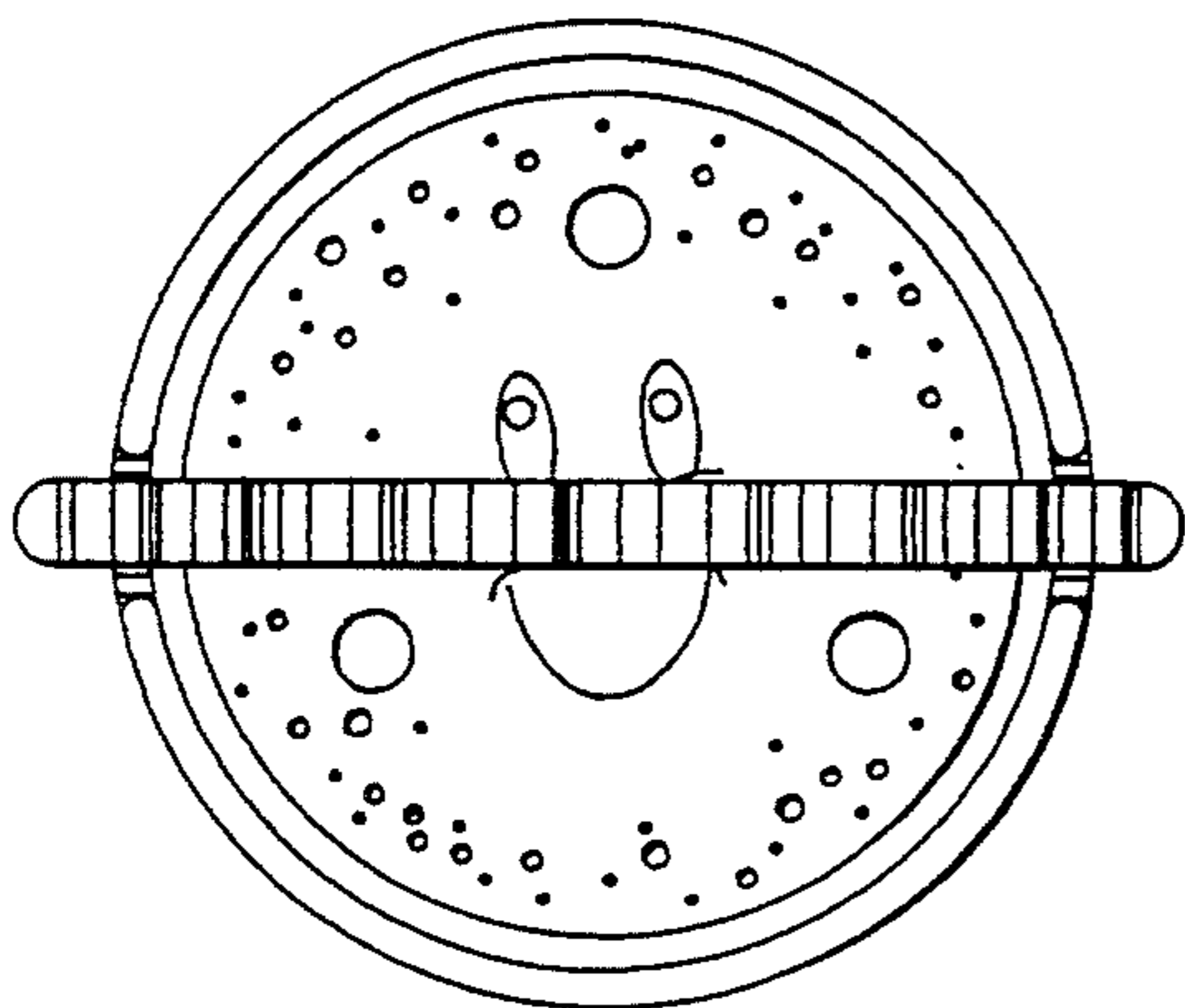

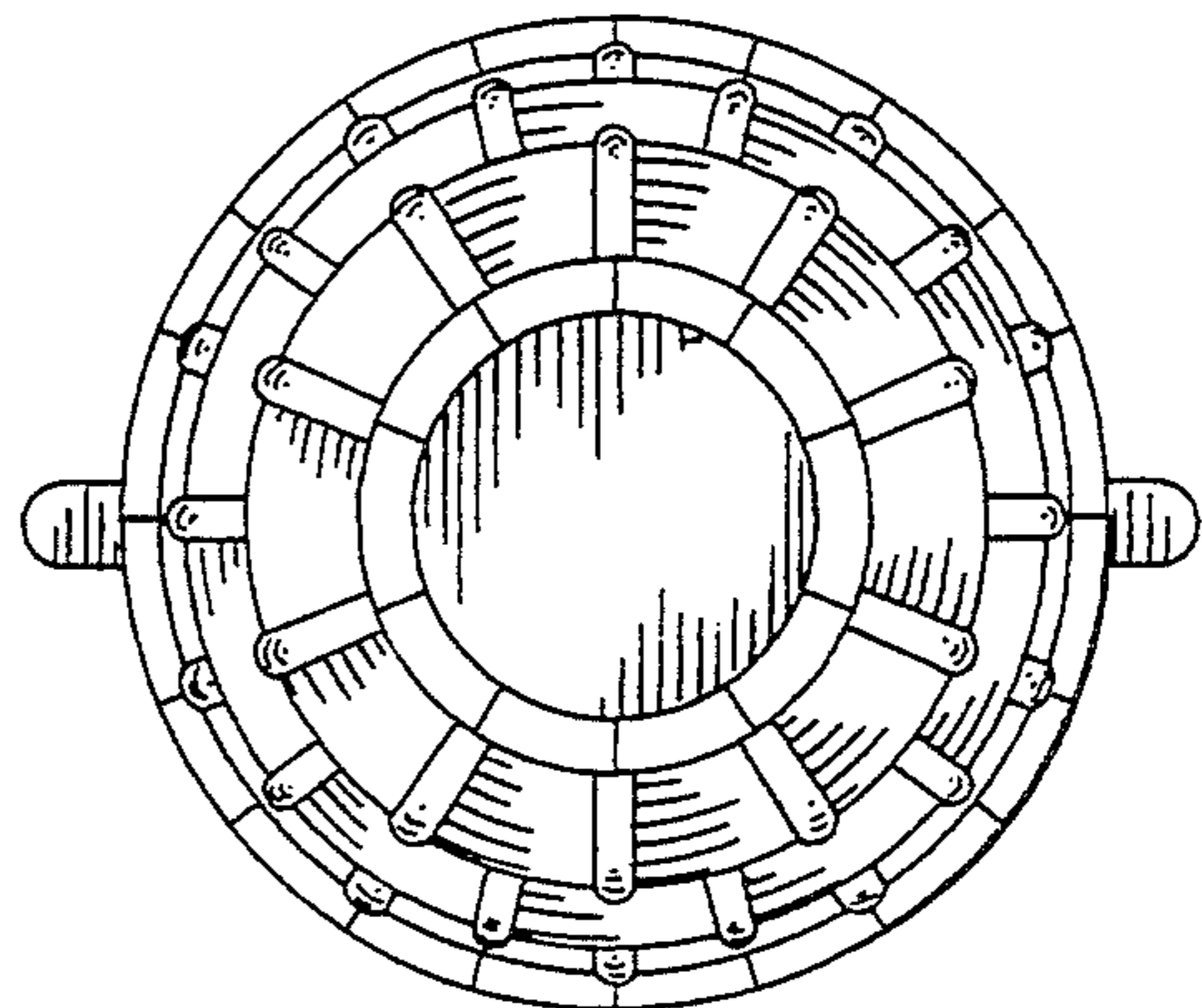

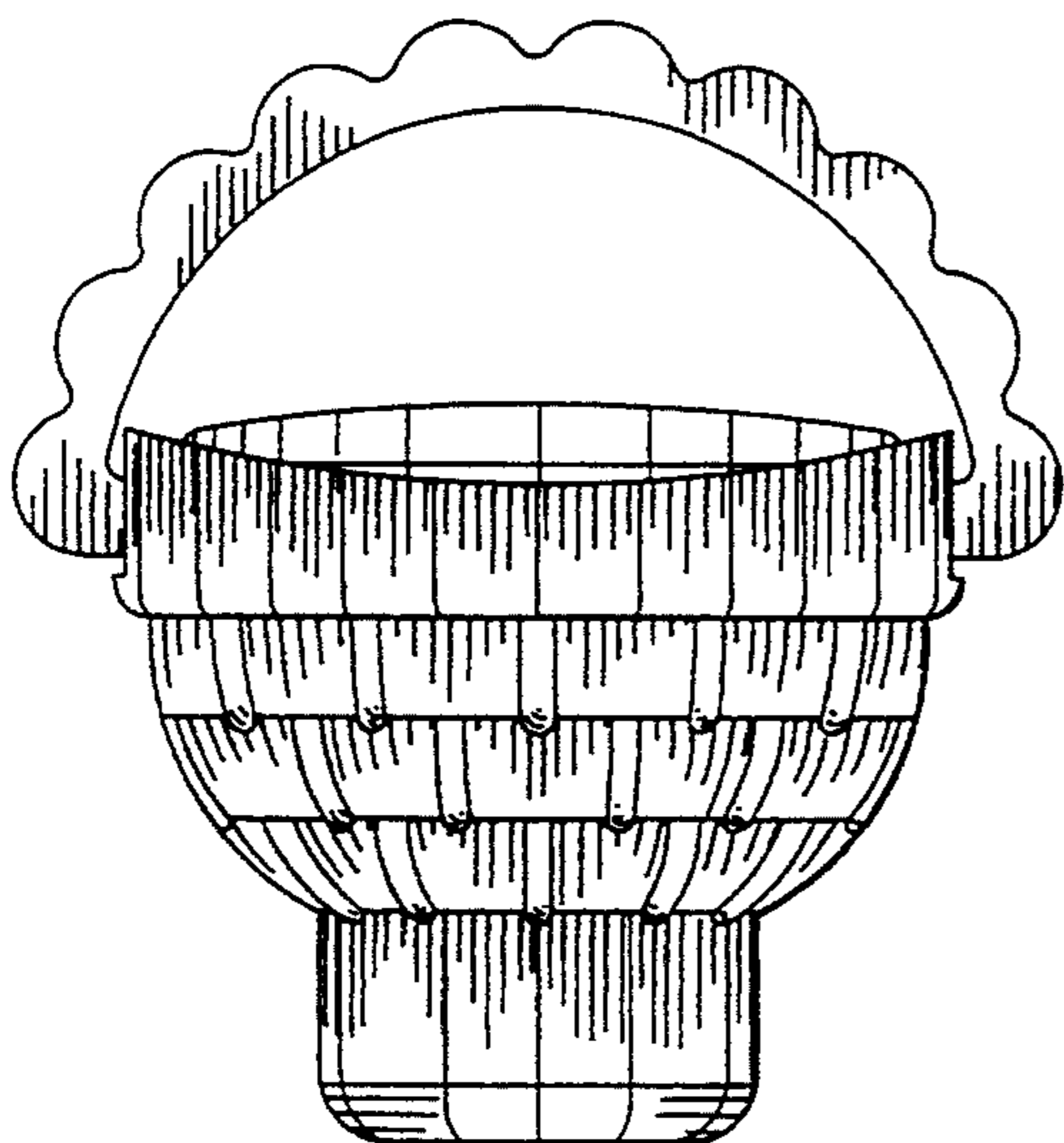

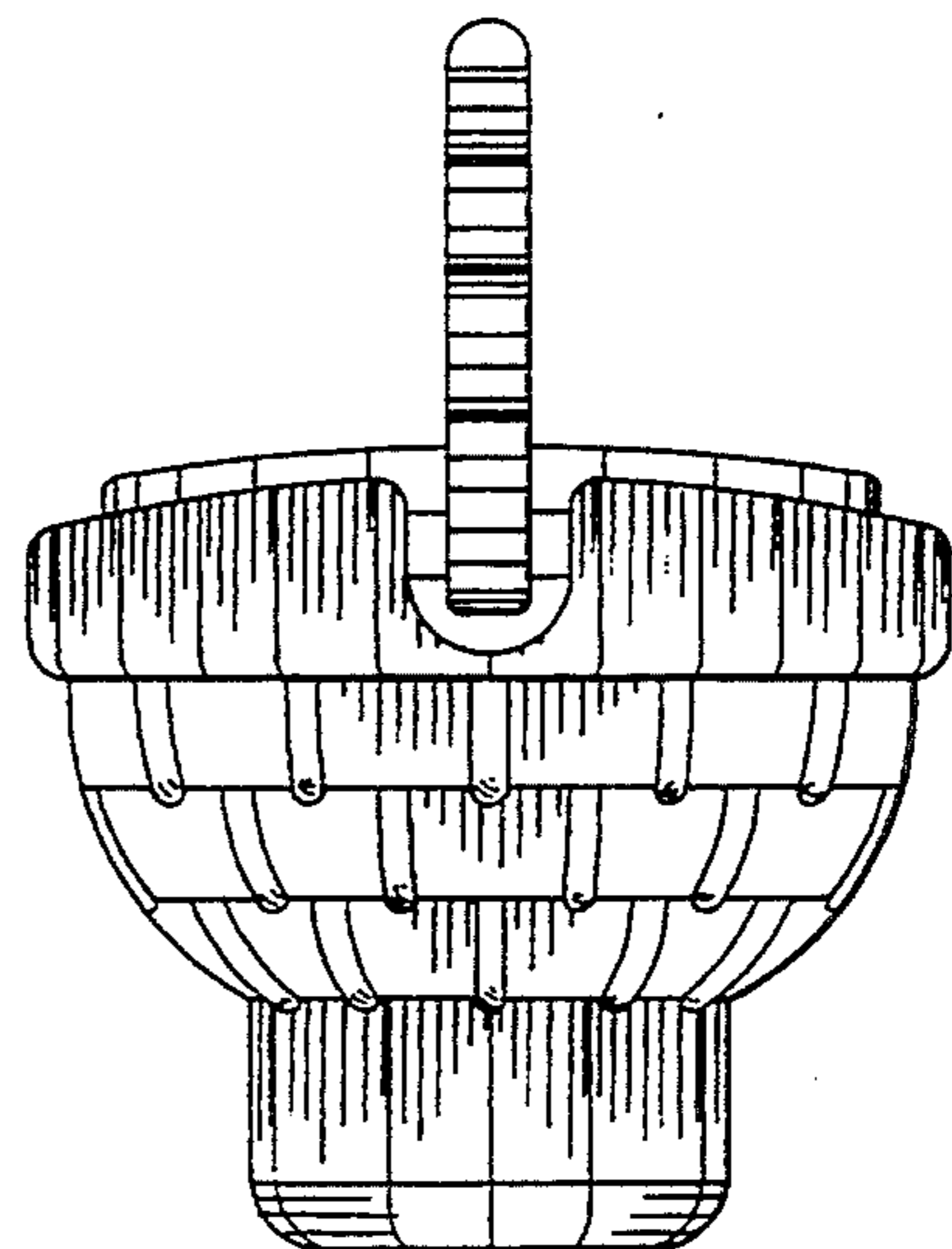
