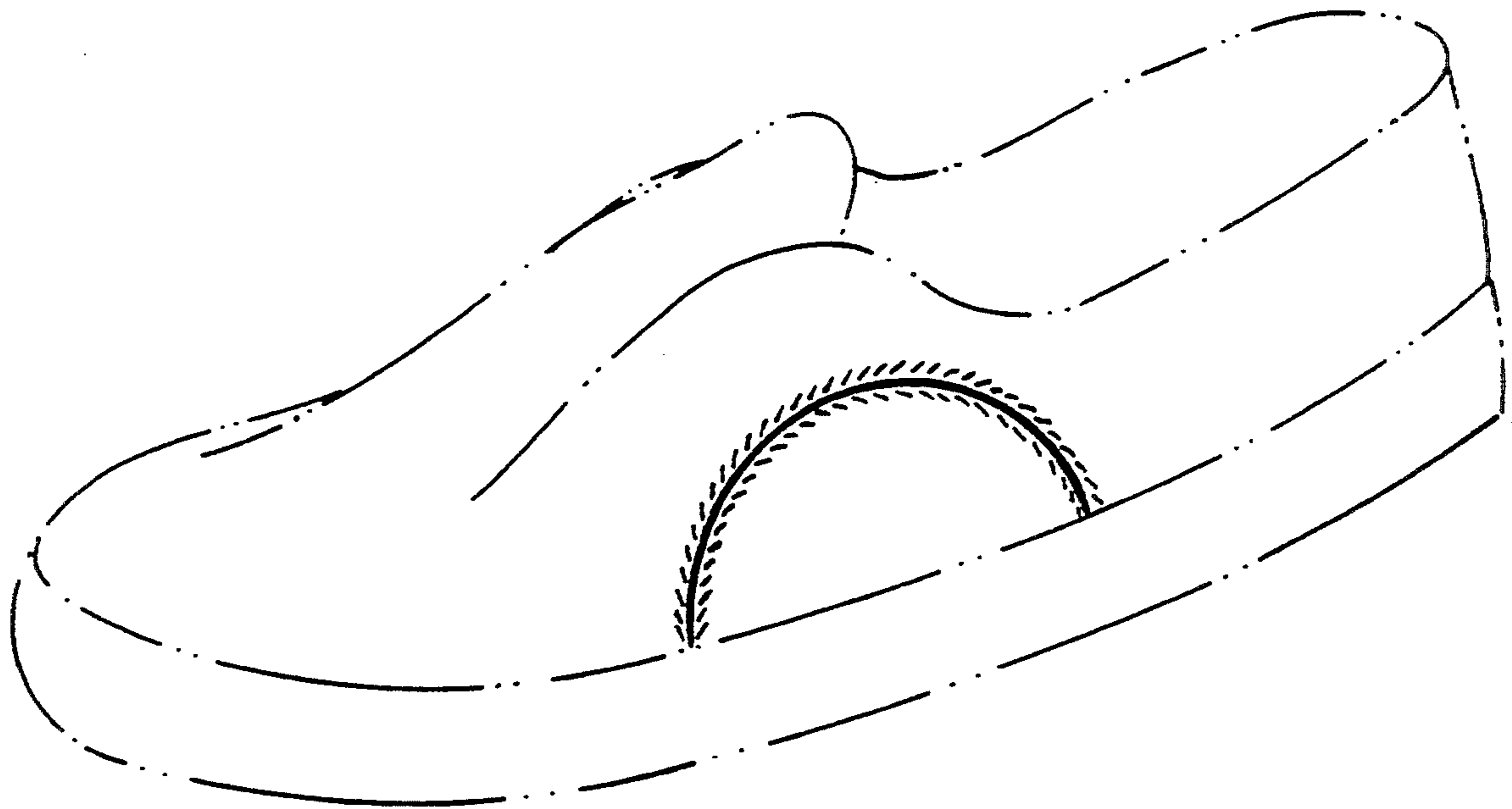

The broken line showing a shoe in FIGS. 1-3 is for illustrative purposes only and forms no part of the claimed design.



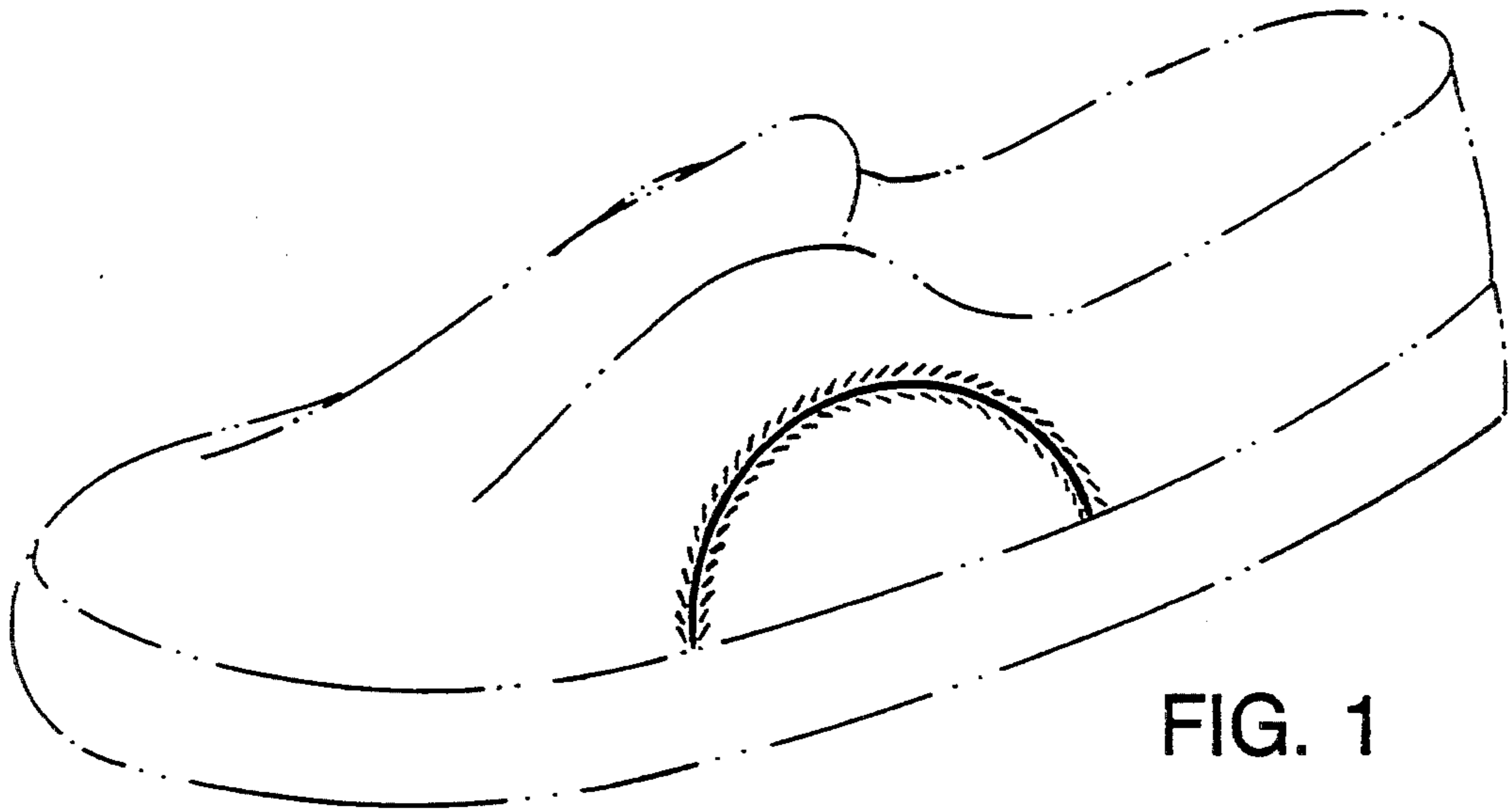

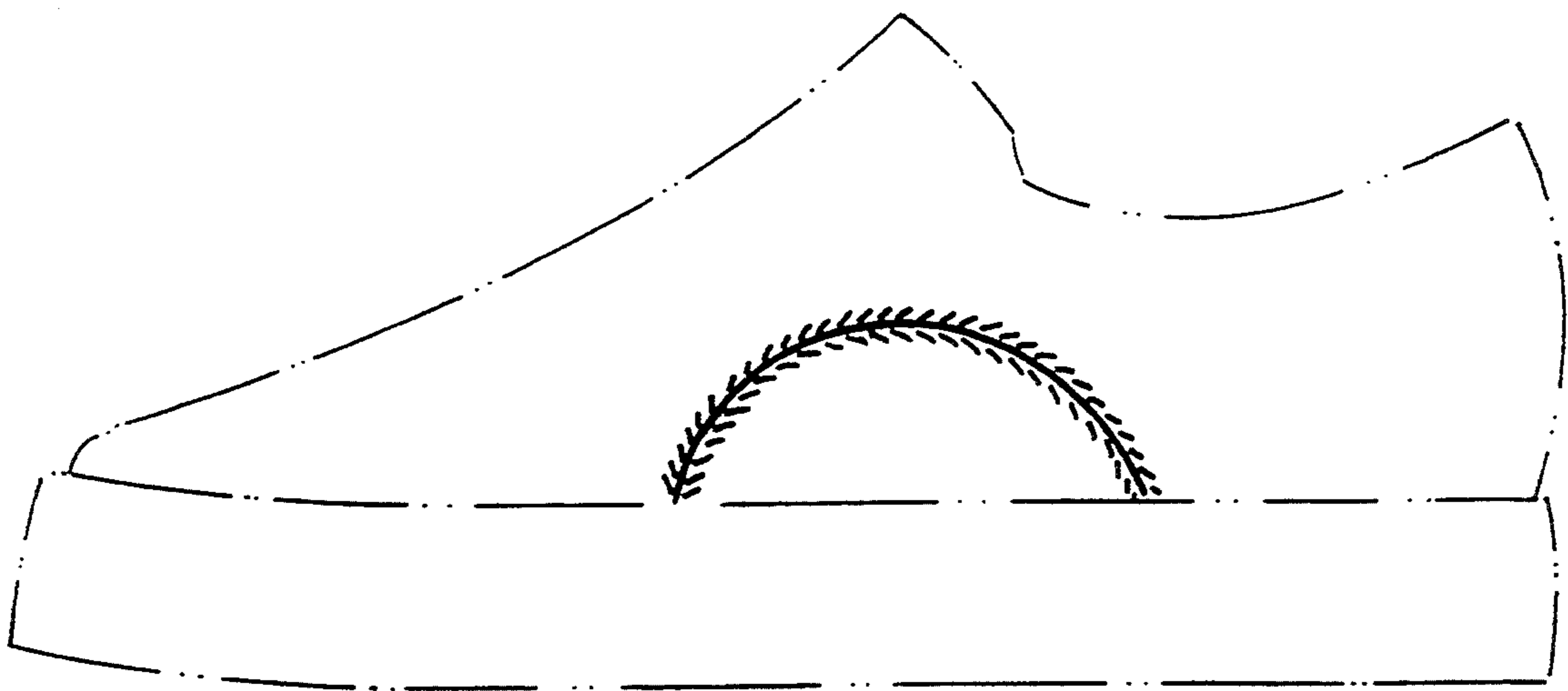

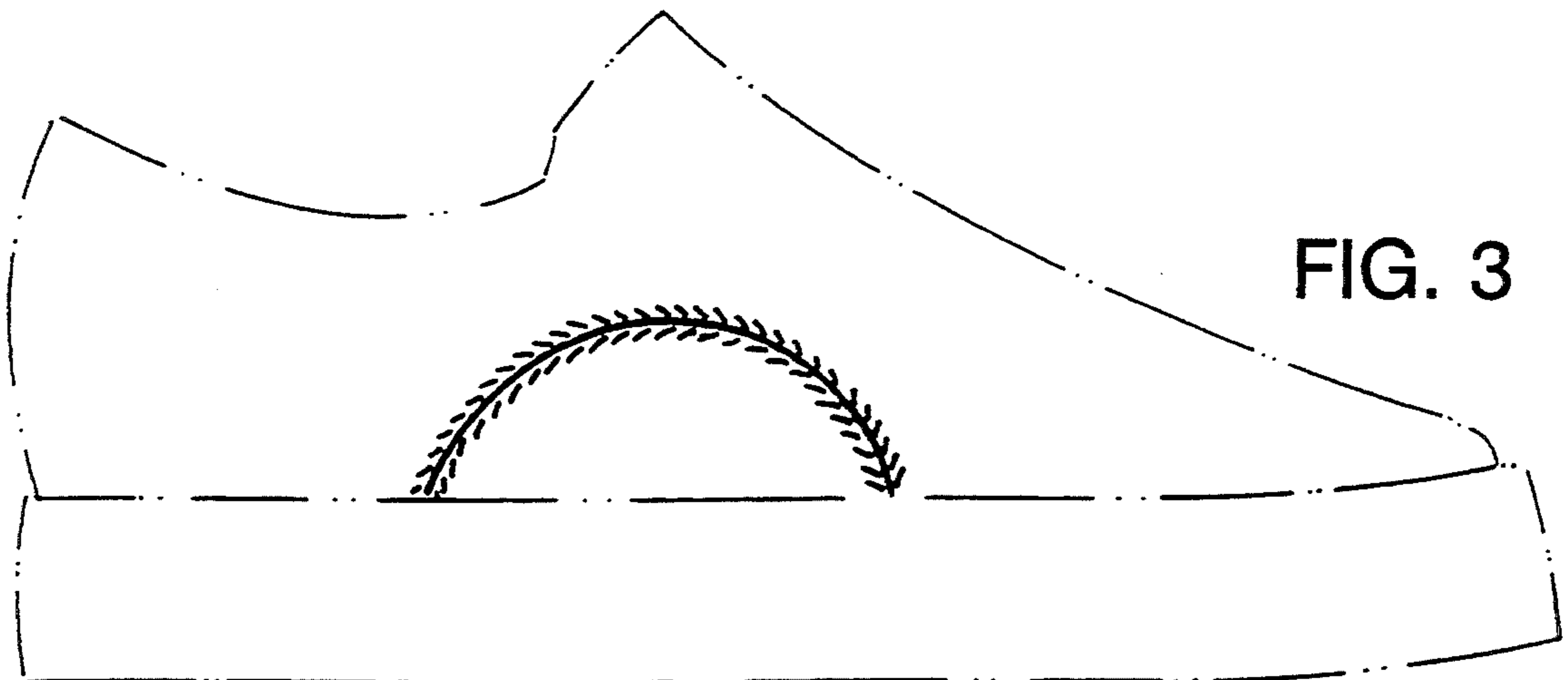
