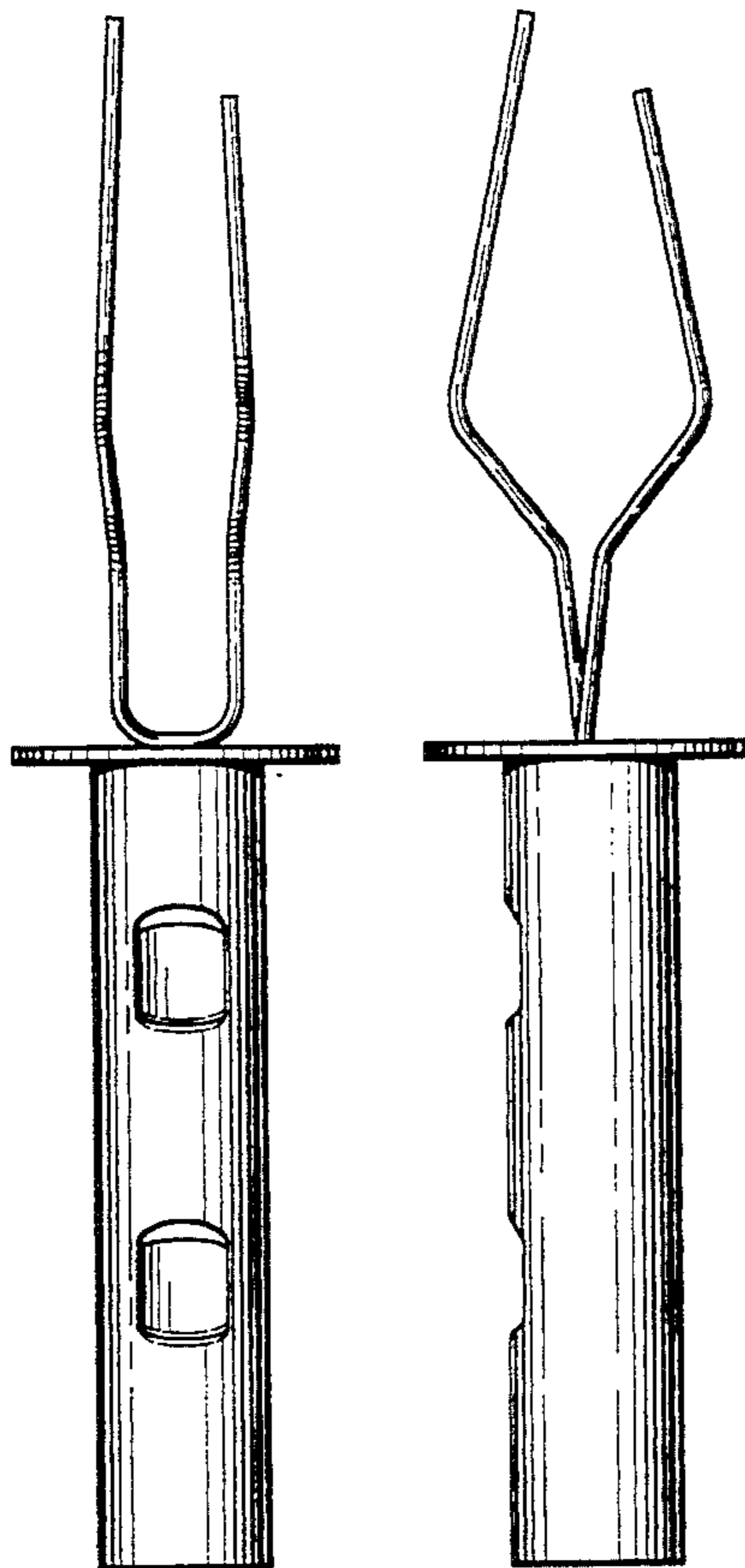

[57] CLAIM

The ornamental design for a cooking utensil, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a cooking utensil showing my new design, the rear view being the same except for removal of the notches;
 FIG. 2 is a right side elevational view thereof, the opposite side being identical;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a perspective view thereof;
 FIG. 6 is a front elevational view of an alternate embodiment of FIG. 1, the rear view being the same except for removal of the notch;
 FIG. 7 is a right side elevational view of FIG. 6, the opposite side being identical;
 FIG. 8 is a top plan view of FIG. 6;
 FIG. 9 is a bottom plan view of FIG. 6;
 FIG. 10 is a perspective view of FIG. 6;
 FIG. 11 is a front elevational view of an alternate embodiment of FIG. 1, the rear view being the same except for the removal of the notch;
 FIG. 12 is a right side elevational view of FIG. 11, the opposite side being identical;
 FIG. 13 is a top plan view of FIG. 11;
 FIG. 14 is a bottom plan view of FIG. 11; and,
 FIG. 15 is a perspective view of FIG. 11.



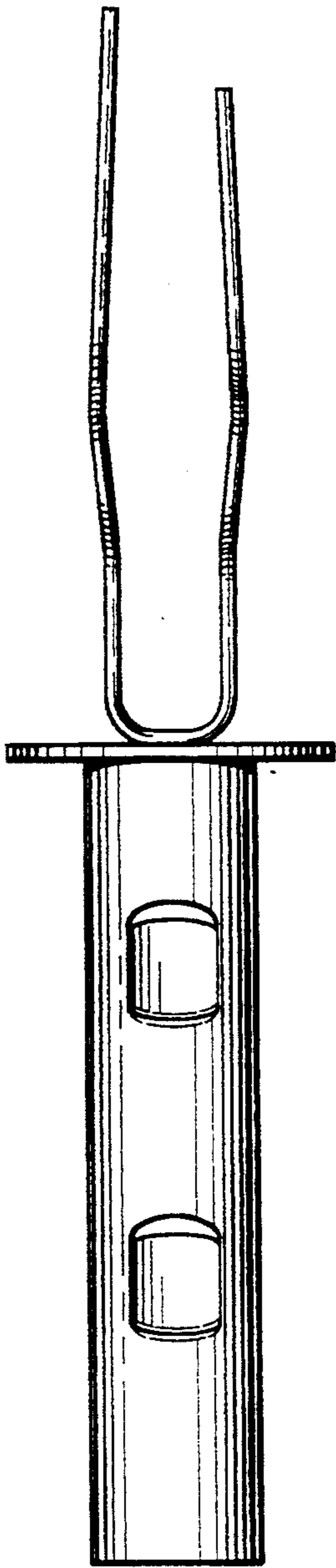

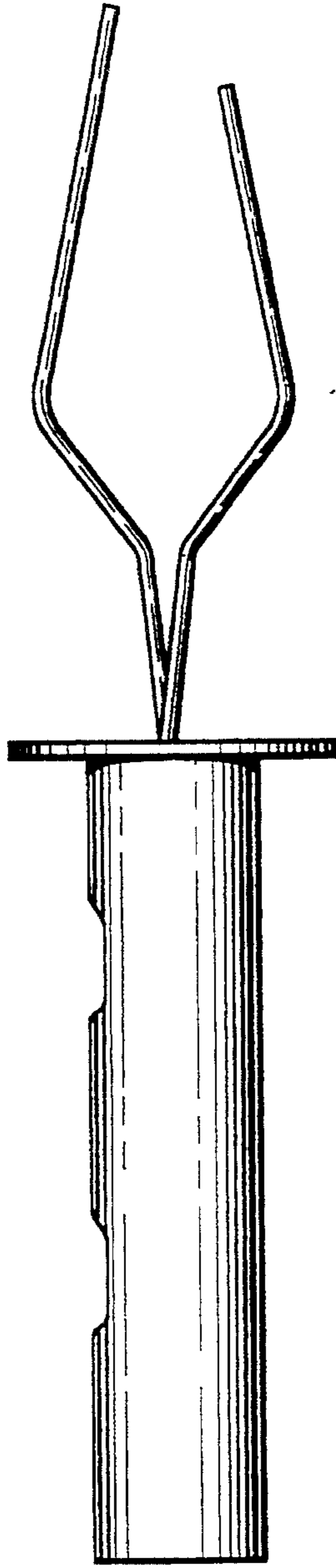

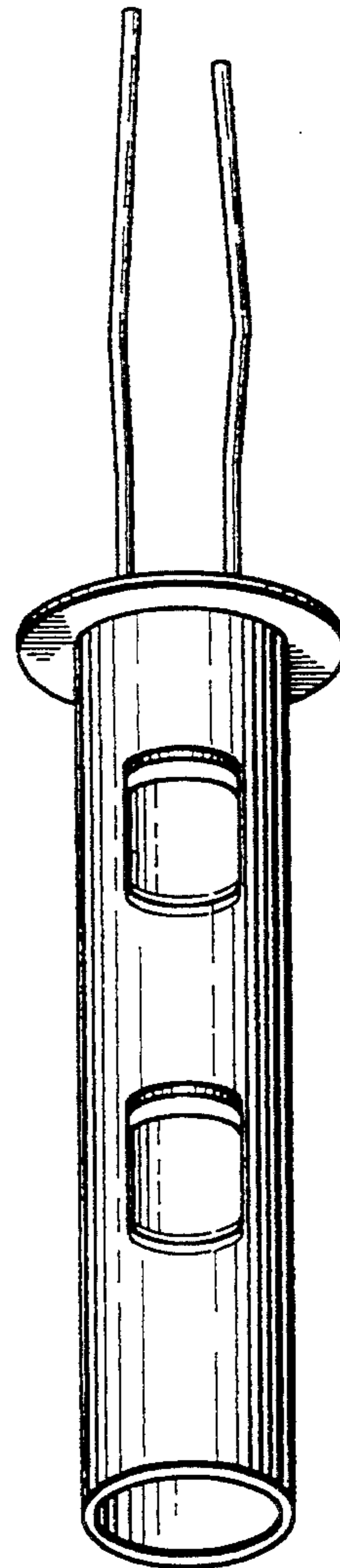

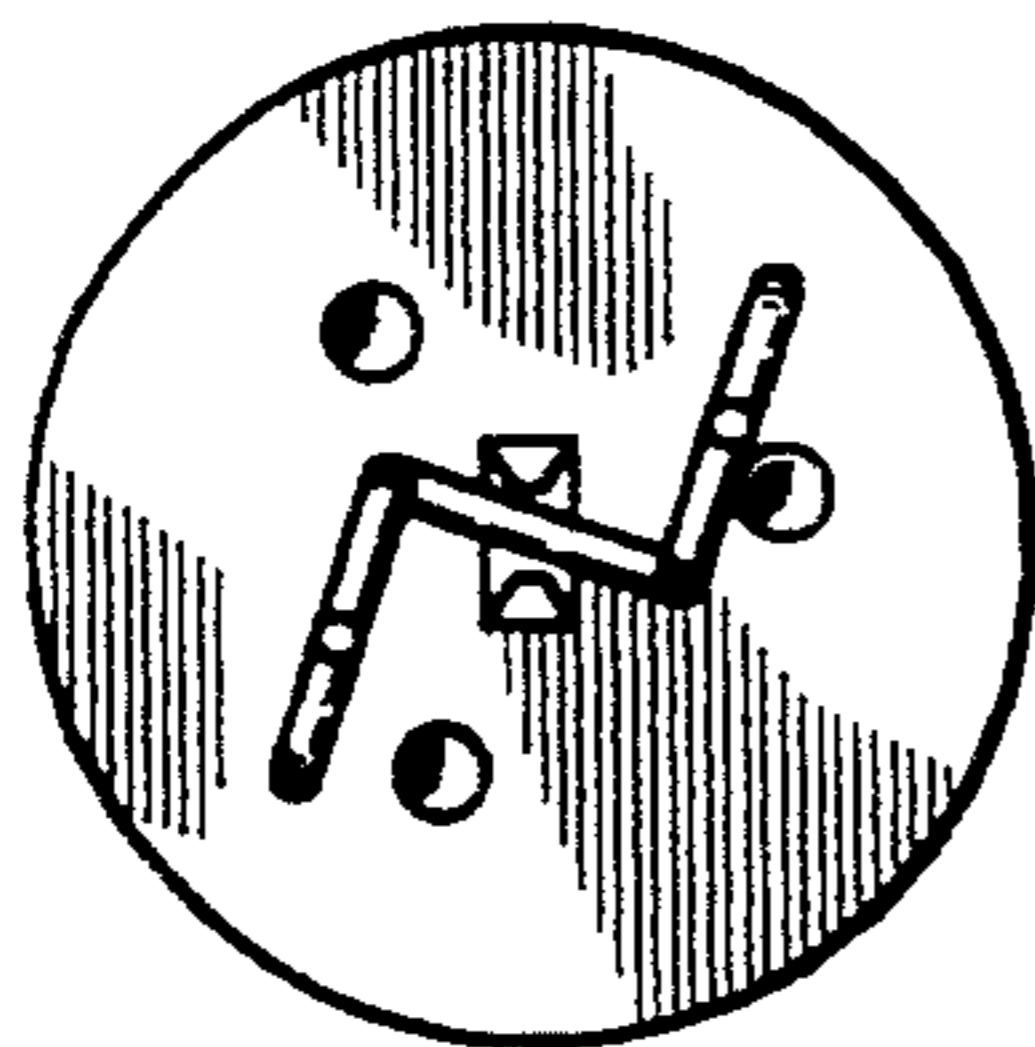

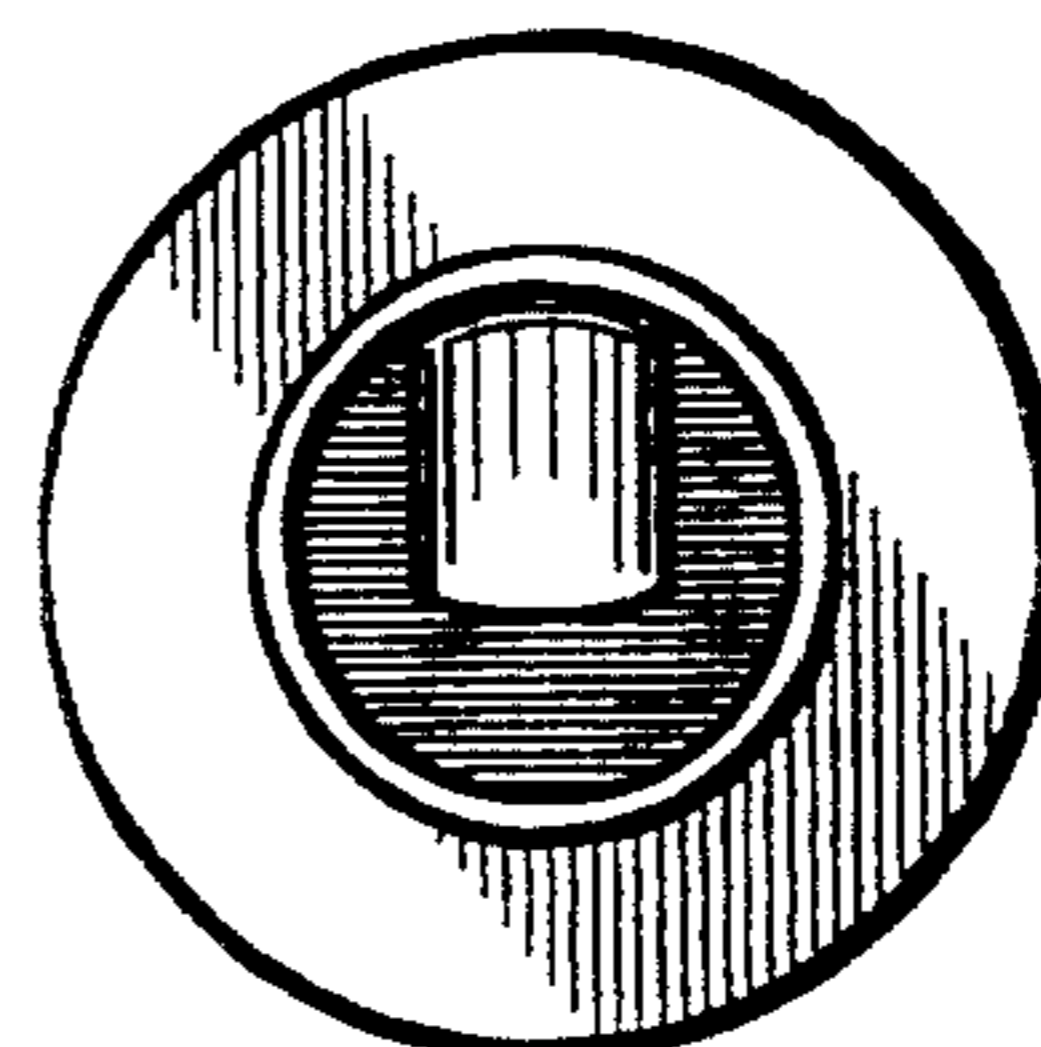

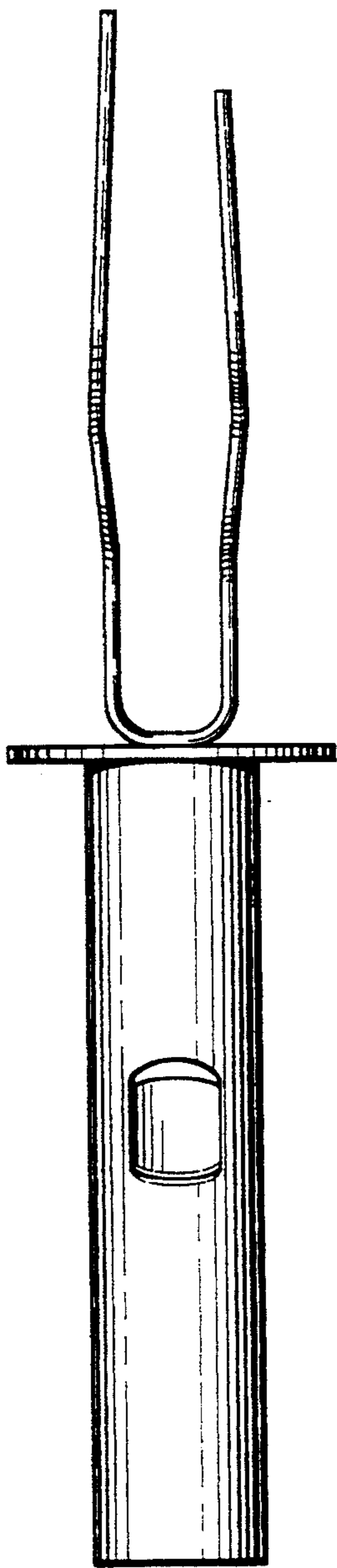

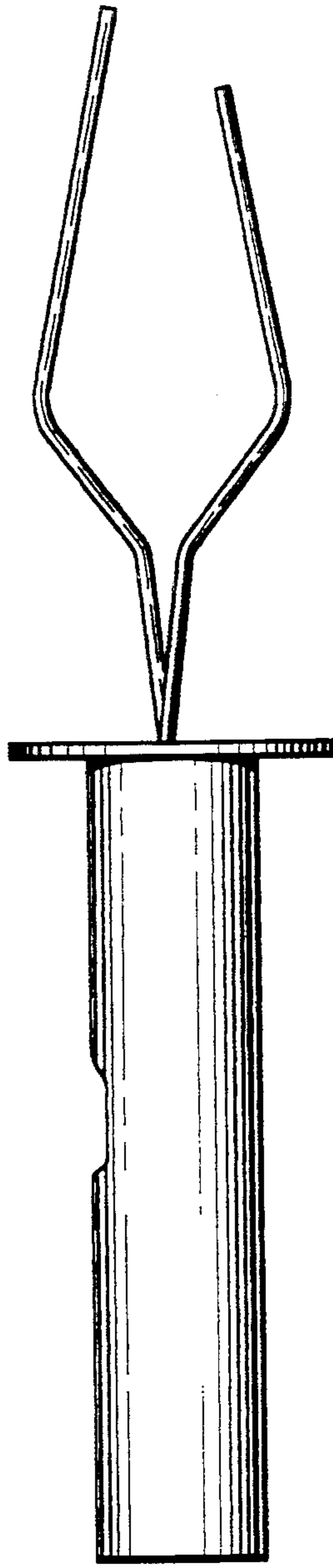

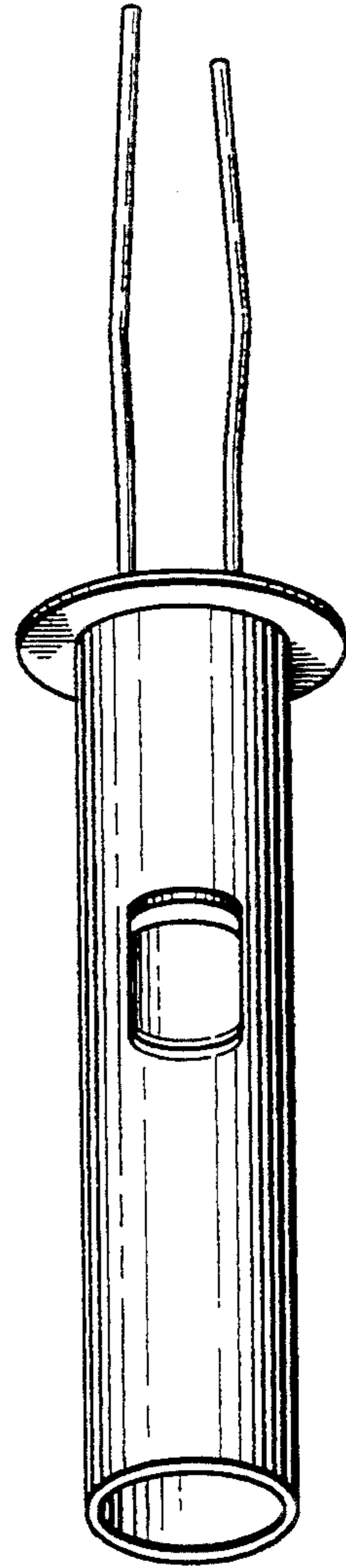

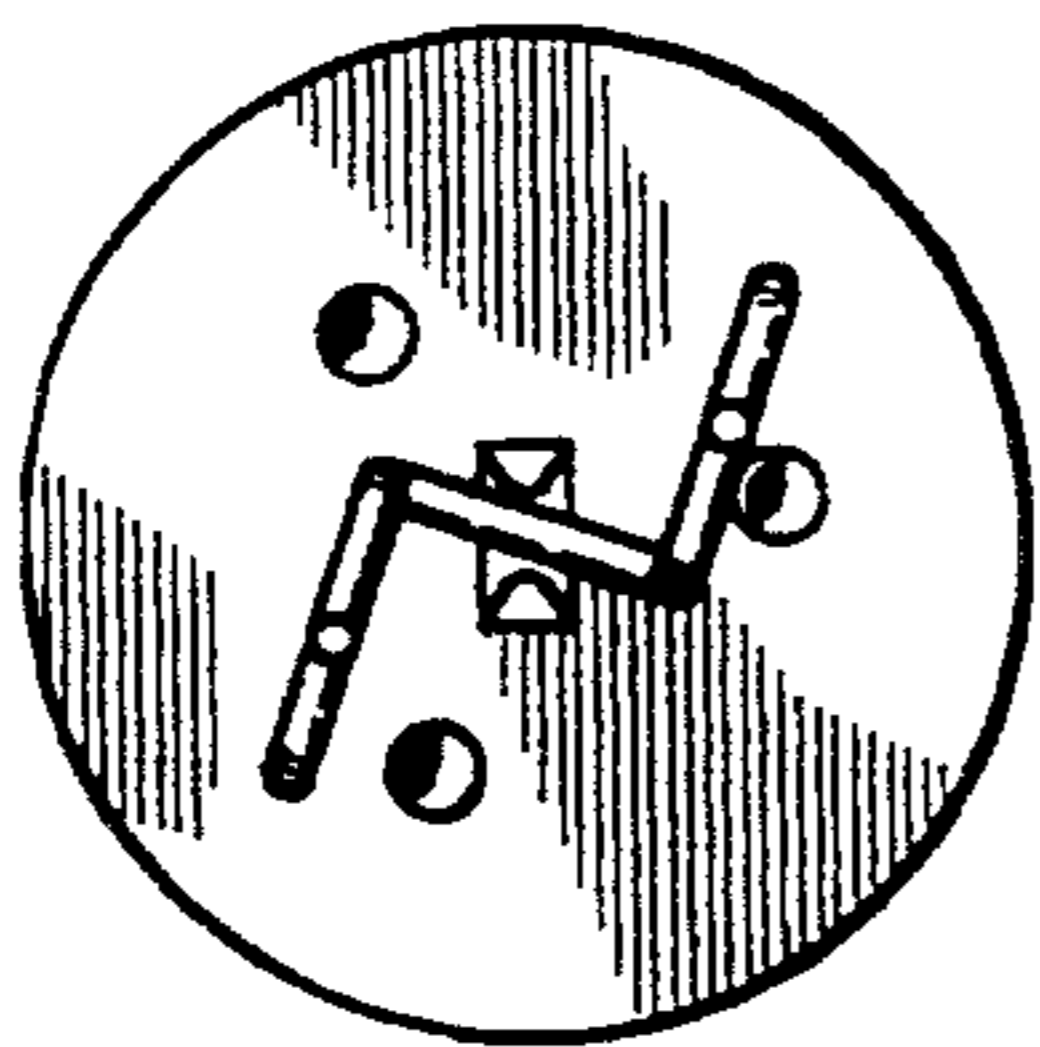

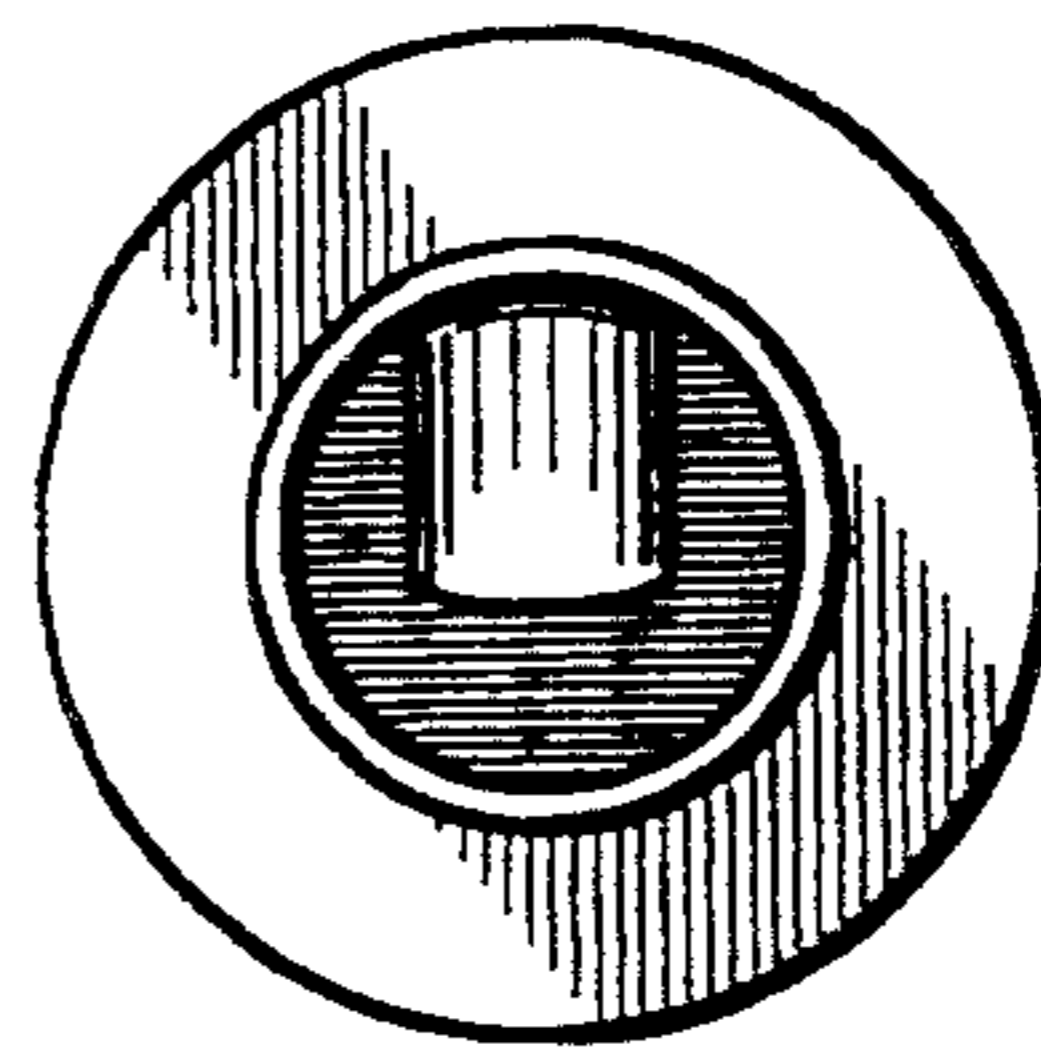

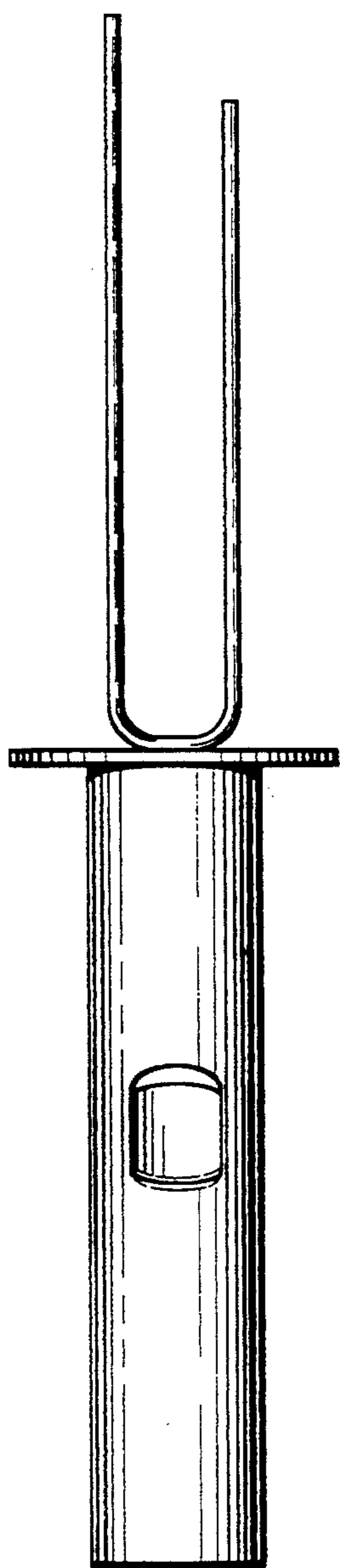

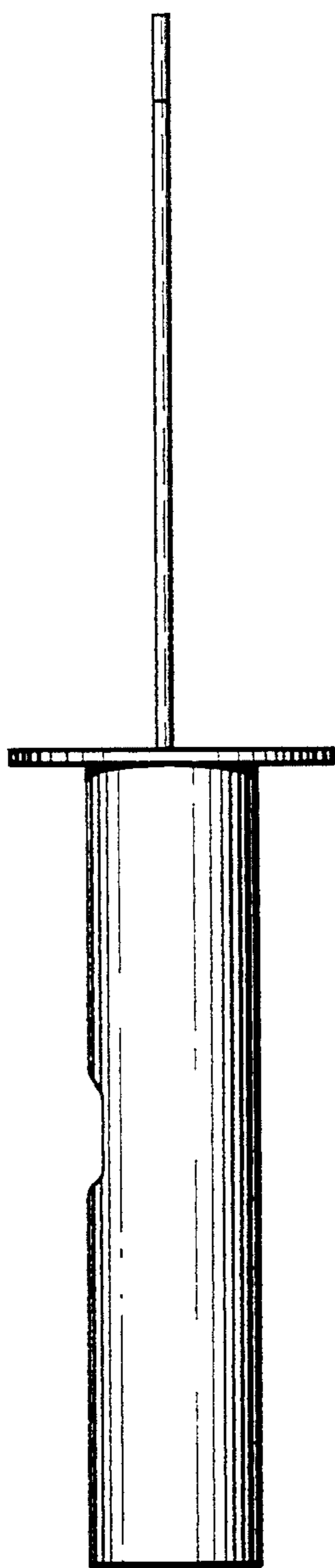

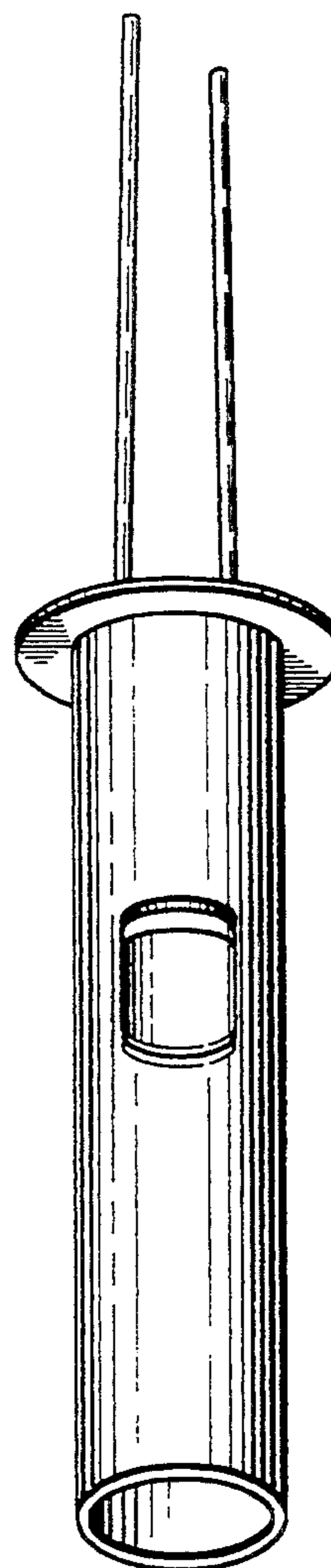

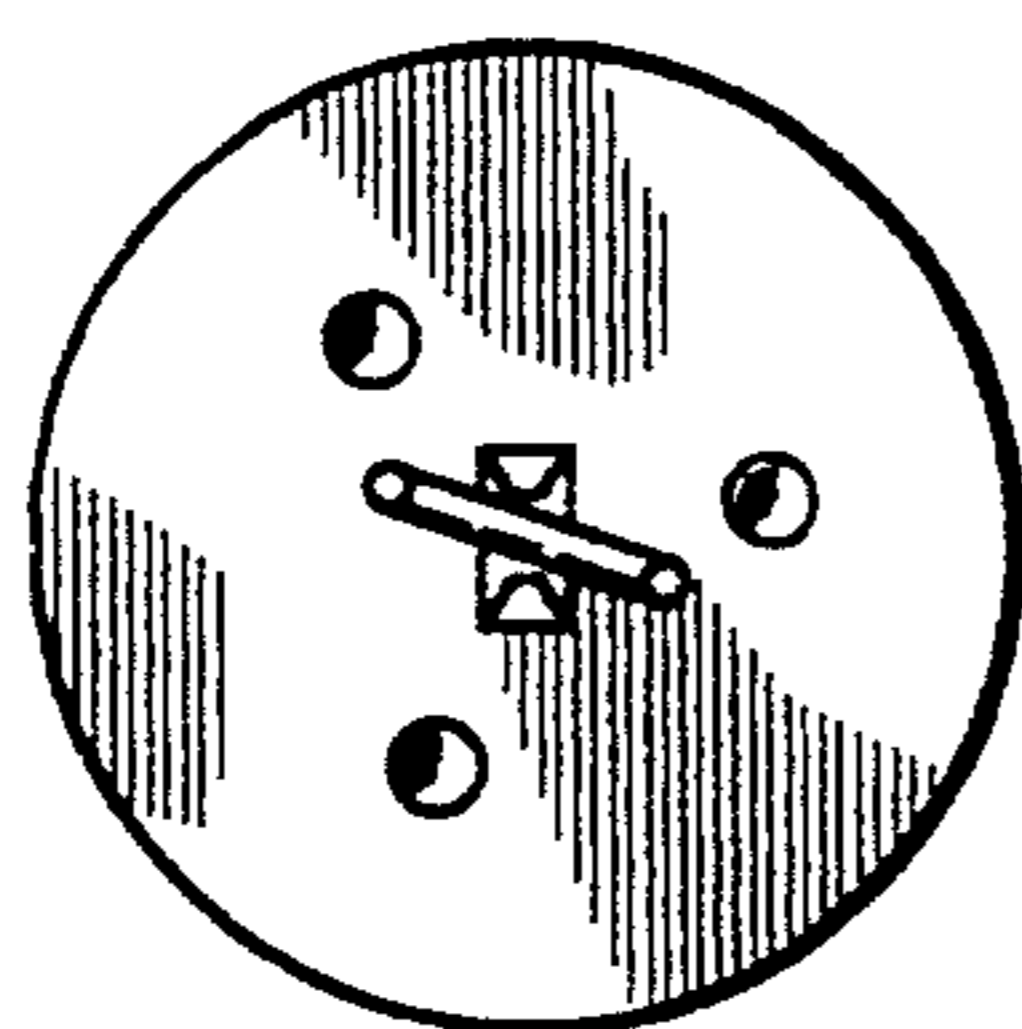

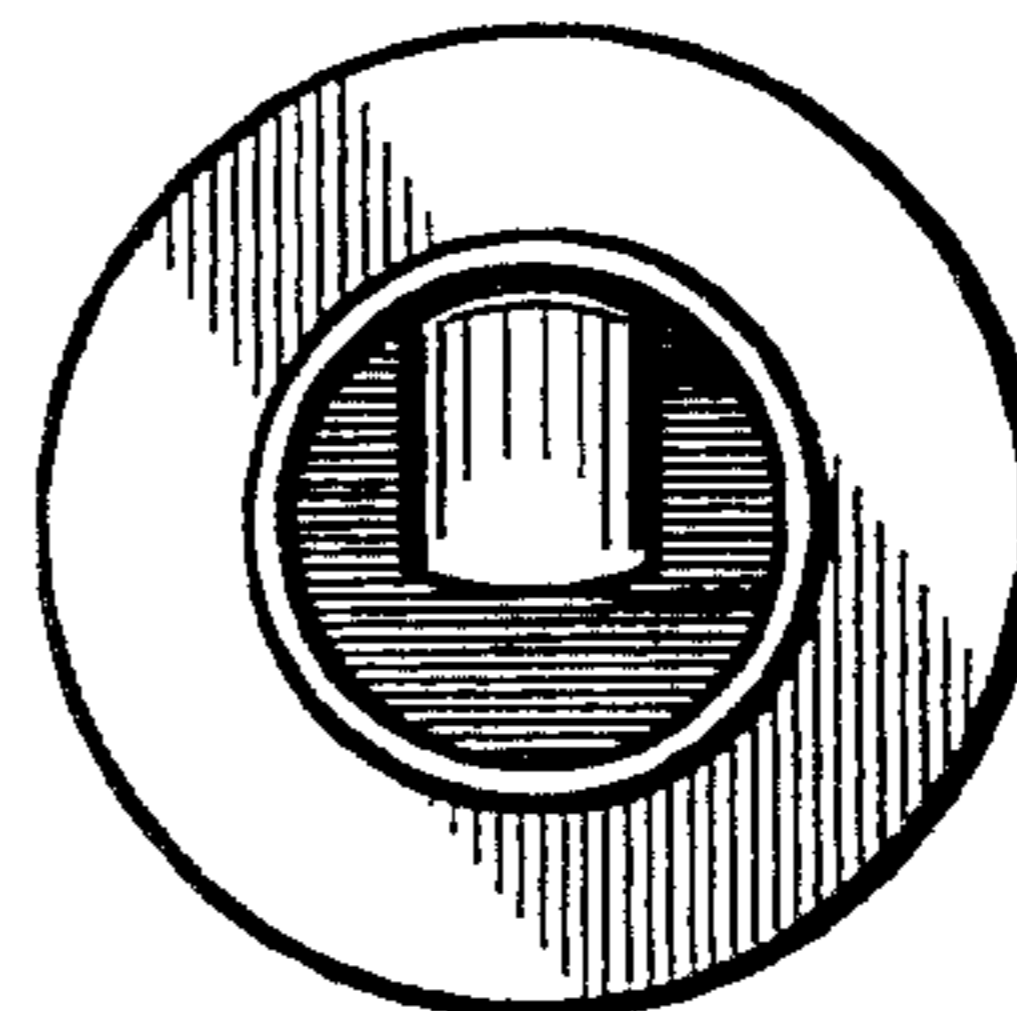
