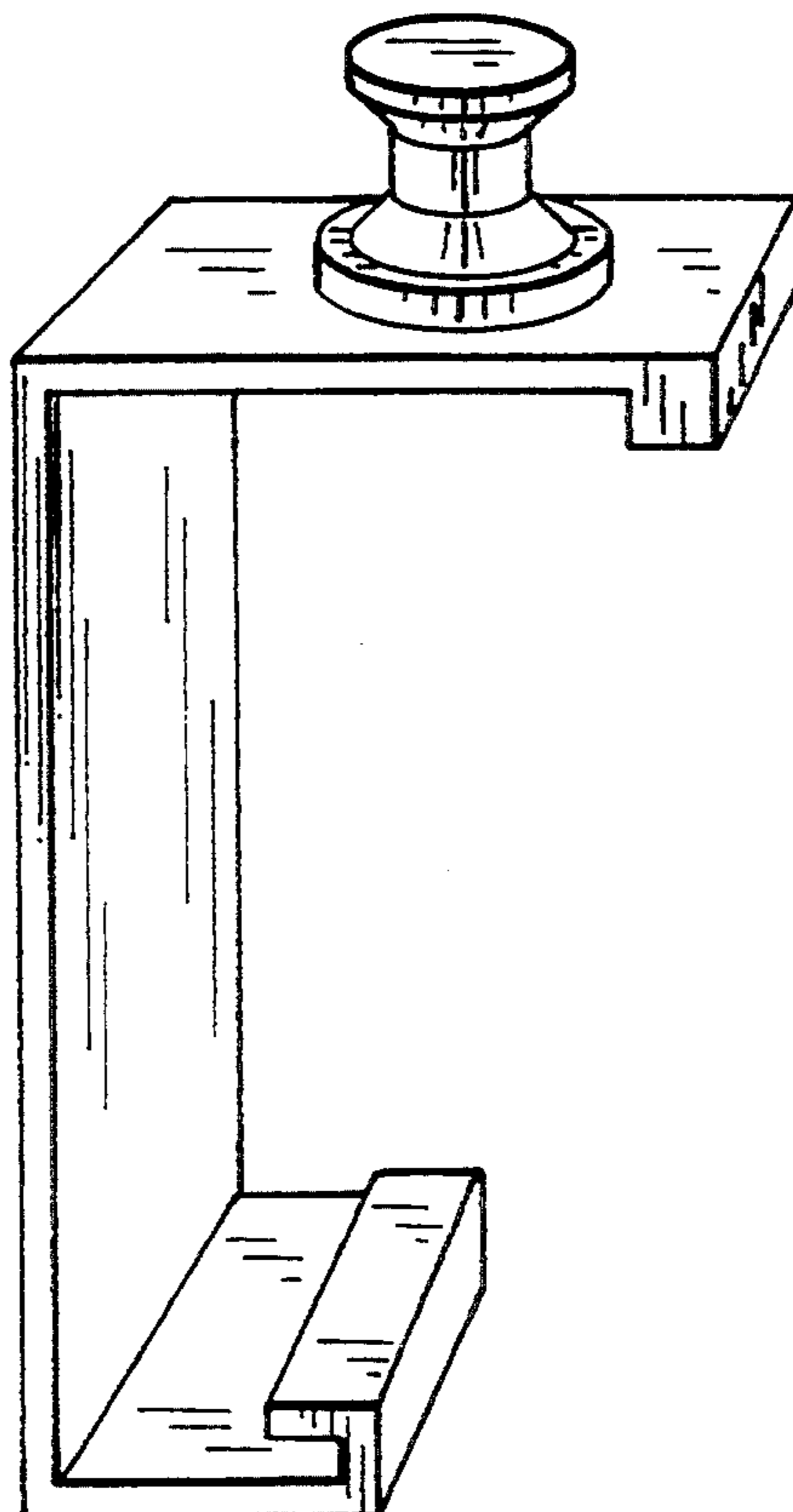

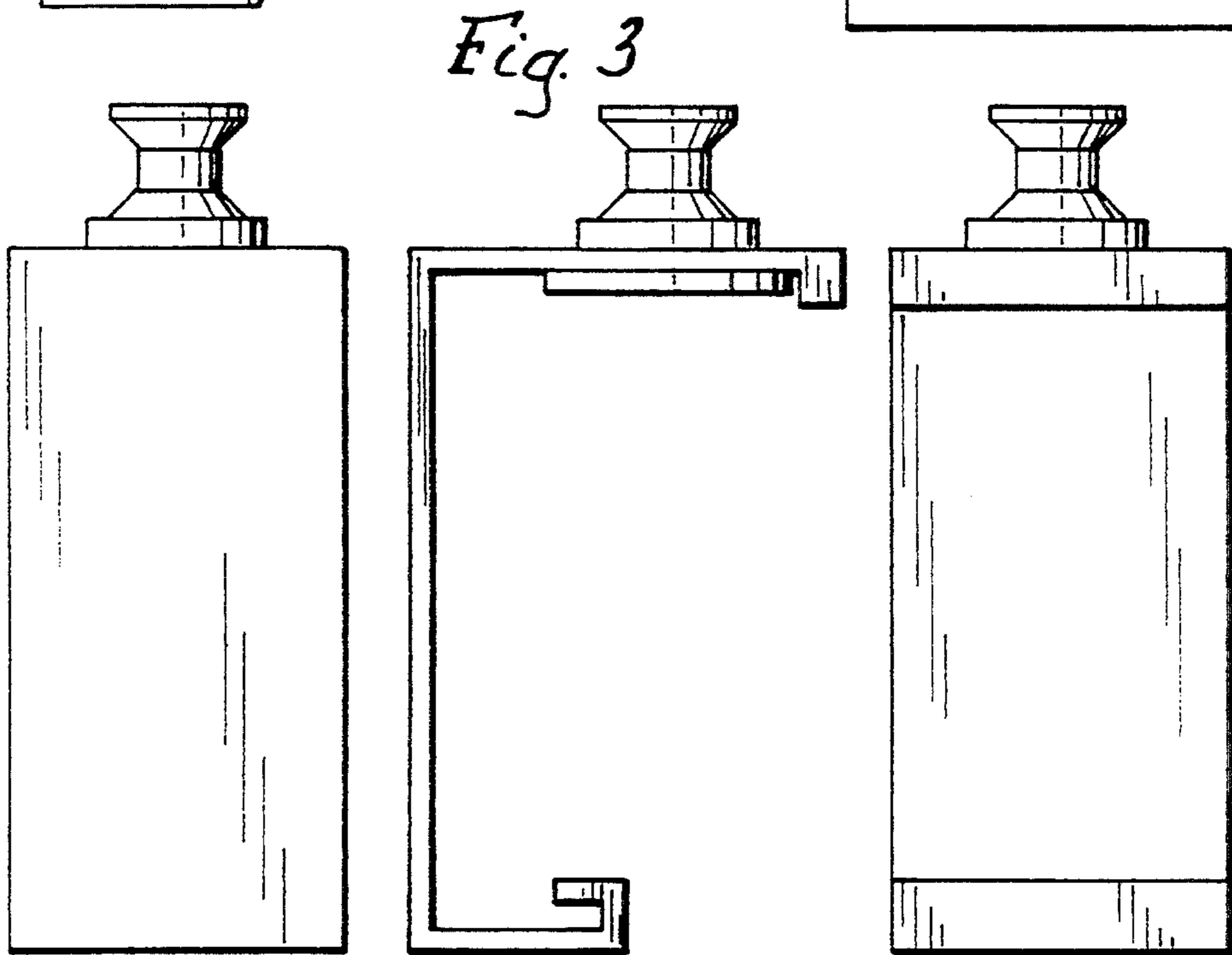
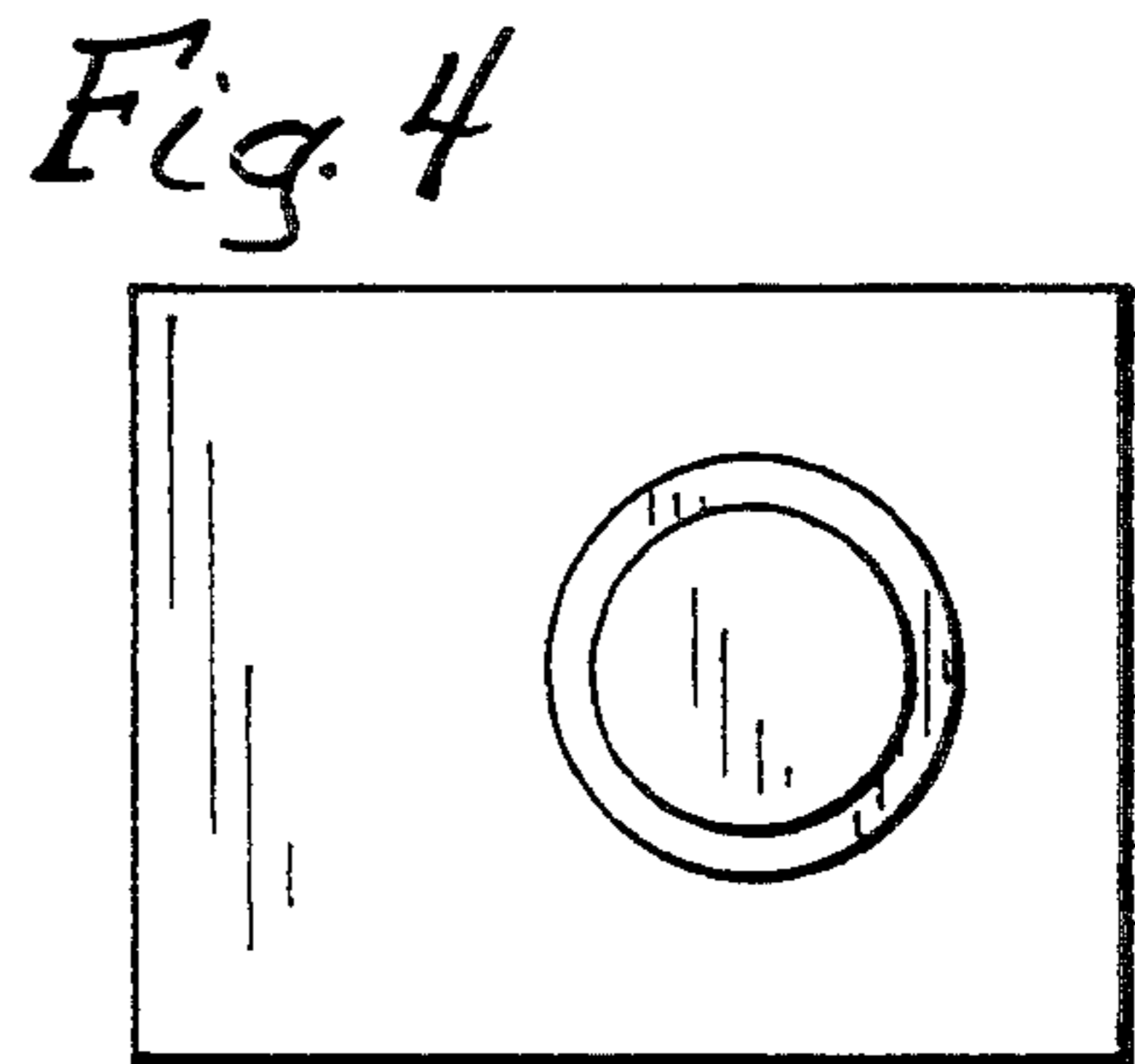
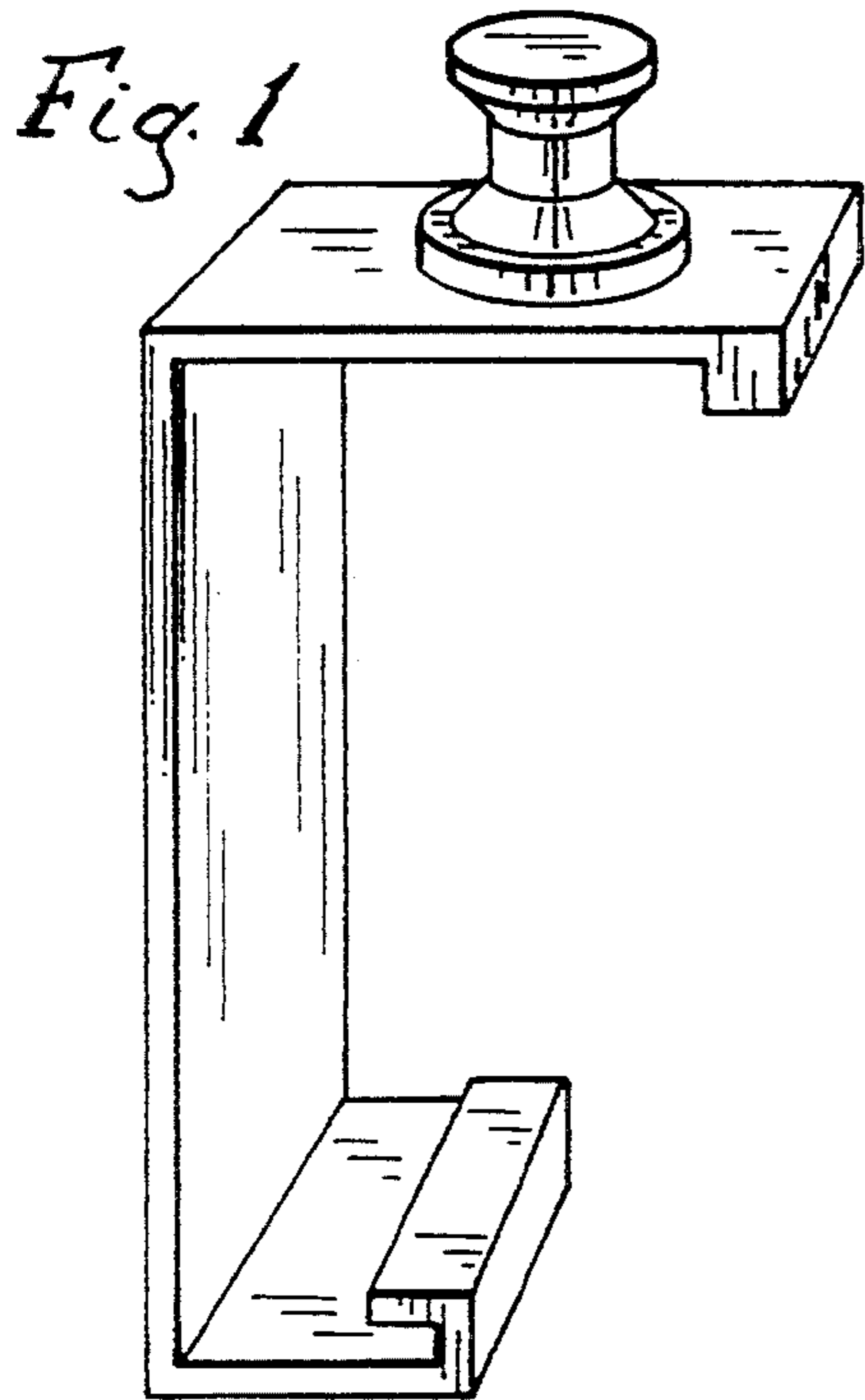
[57] **CLAIM**

The ornamental design for a detachable anchor for a pool cover, as shown.

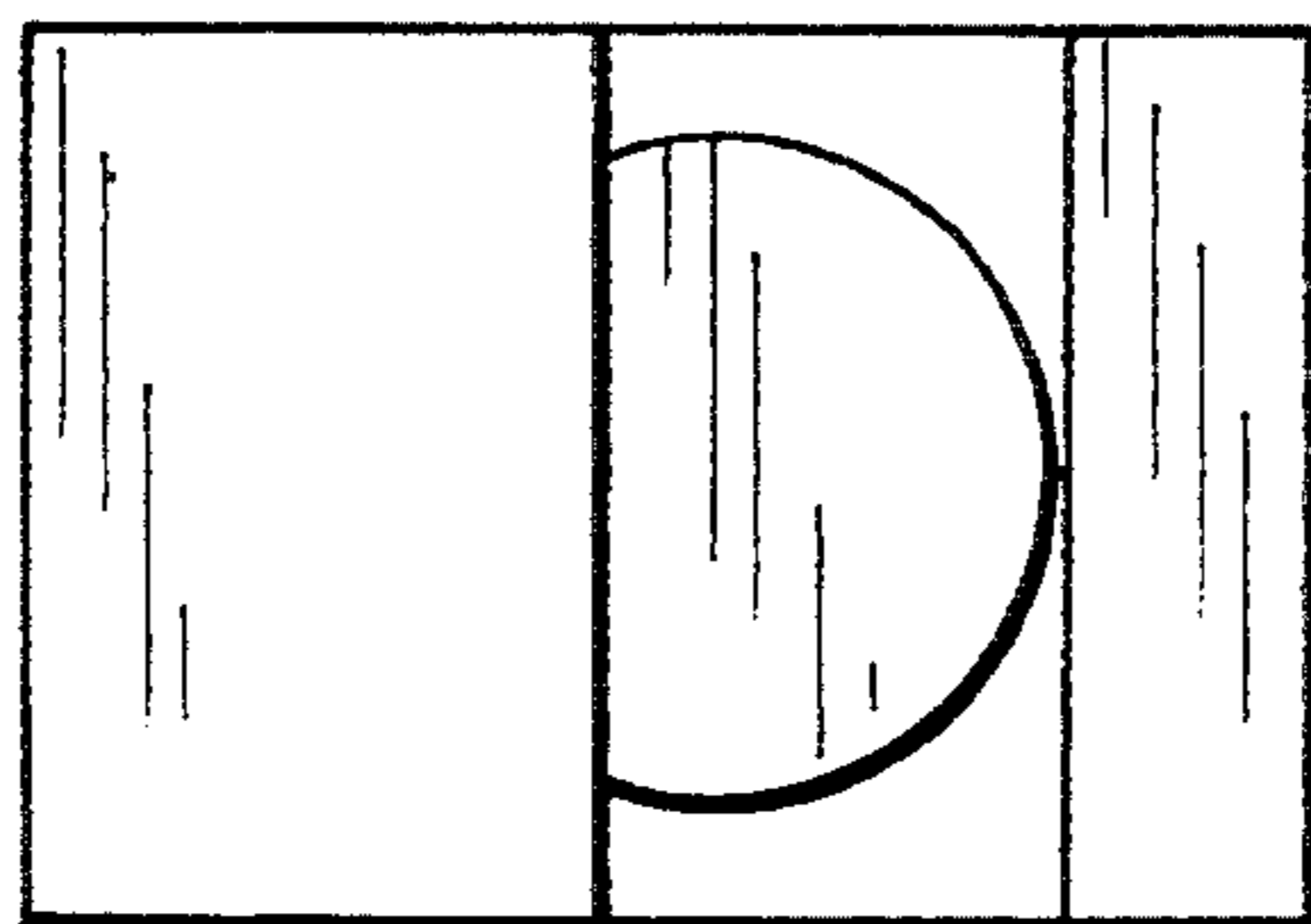
**DESCRIPTION**

FIG. 1 is a perspective view of a detachable anchor for a pool cover showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a side elevational view thereof, with the opposite side being a mirror image of that shown;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a rear elevational view thereof.
