[57] CLAIM

The ornamental design for a portable dispenser for generally spherical confectioneries, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the portable dispenser for generally spherical confectioneries showing our new design;
FIG. 2 is an enlarged front elevational view thereof;
FIG. 3 is a rear elevational view of FIG. 2;
FIG. 4 is a left side elevational view of FIG. 2, the unshown opposite side being a mirror image;
FIG. 5 is a top plan view of FIG. 2; and,
FIG. 6 is a bottom plan view of FIG. 2.
The broken line showing of a head in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

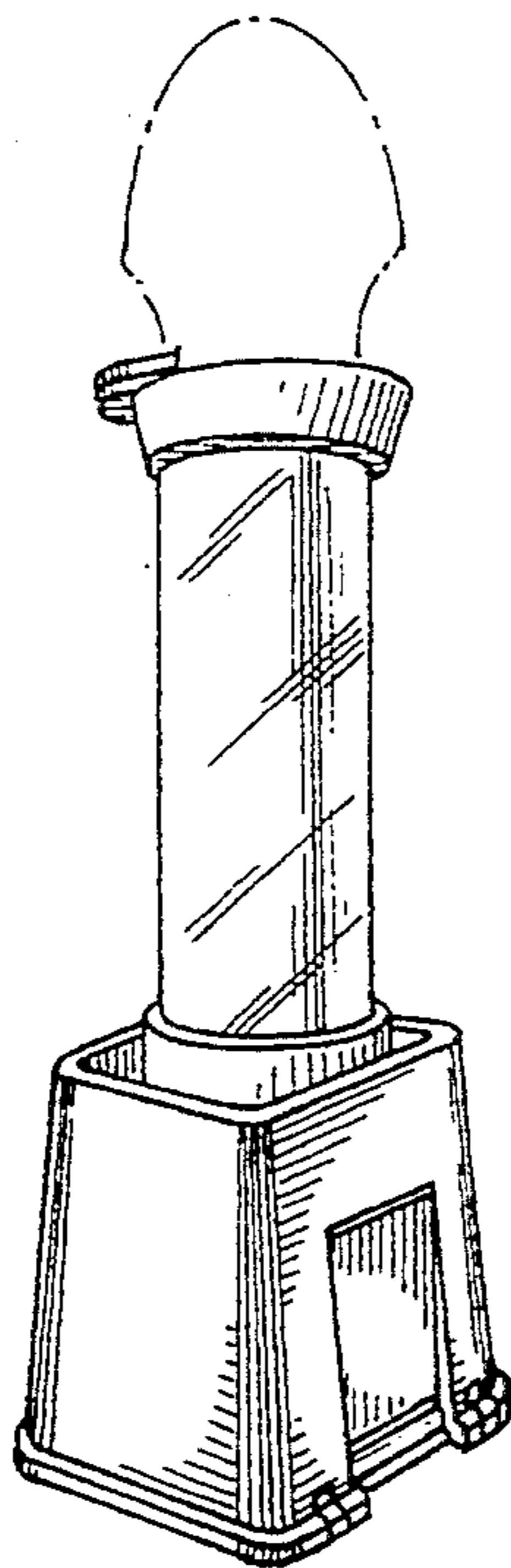

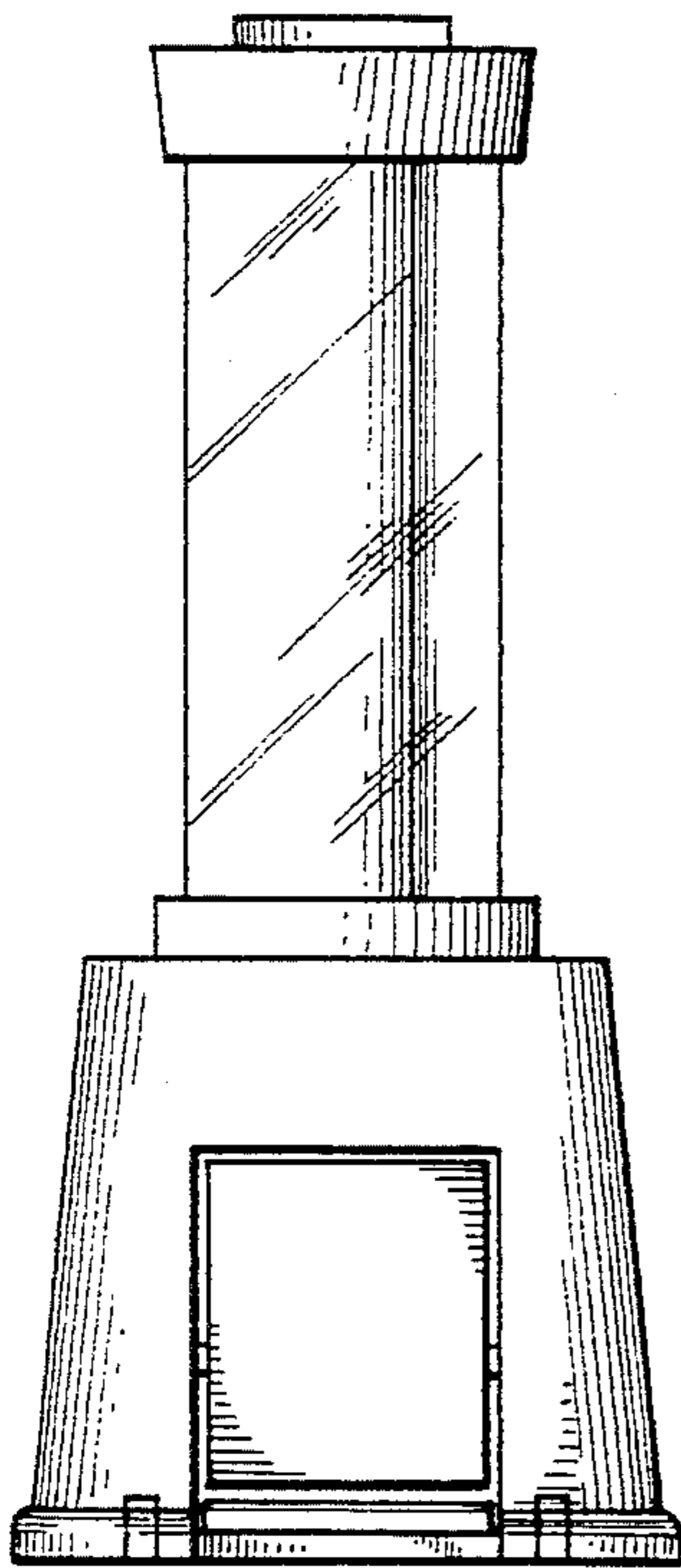

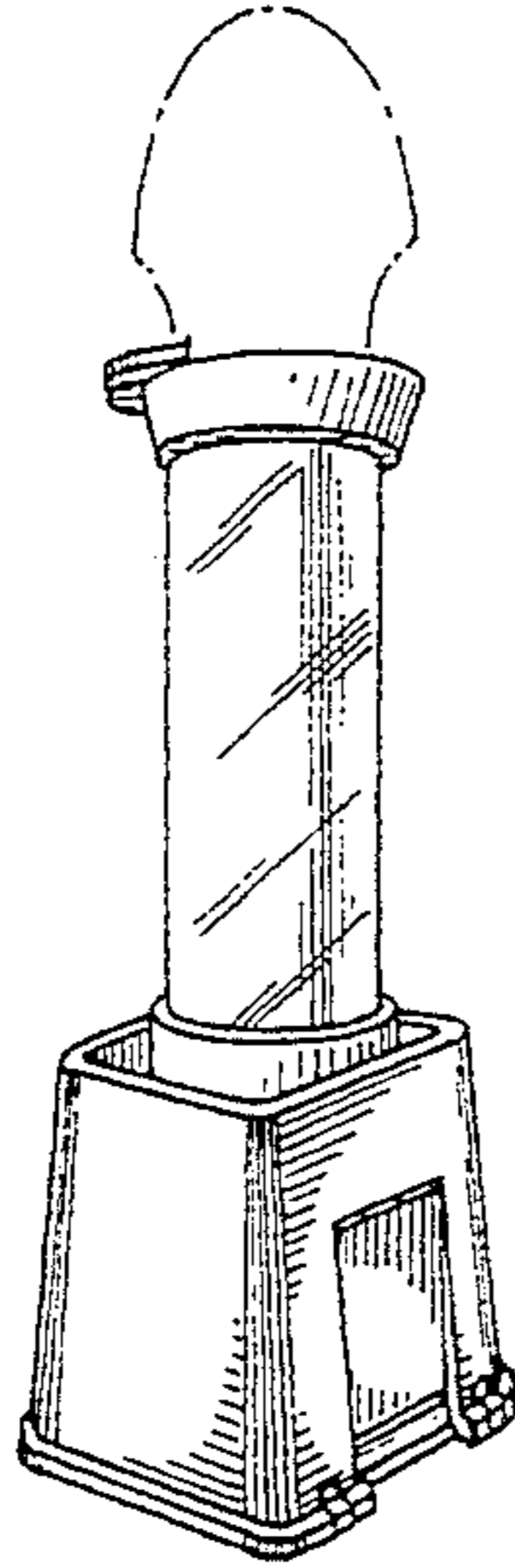

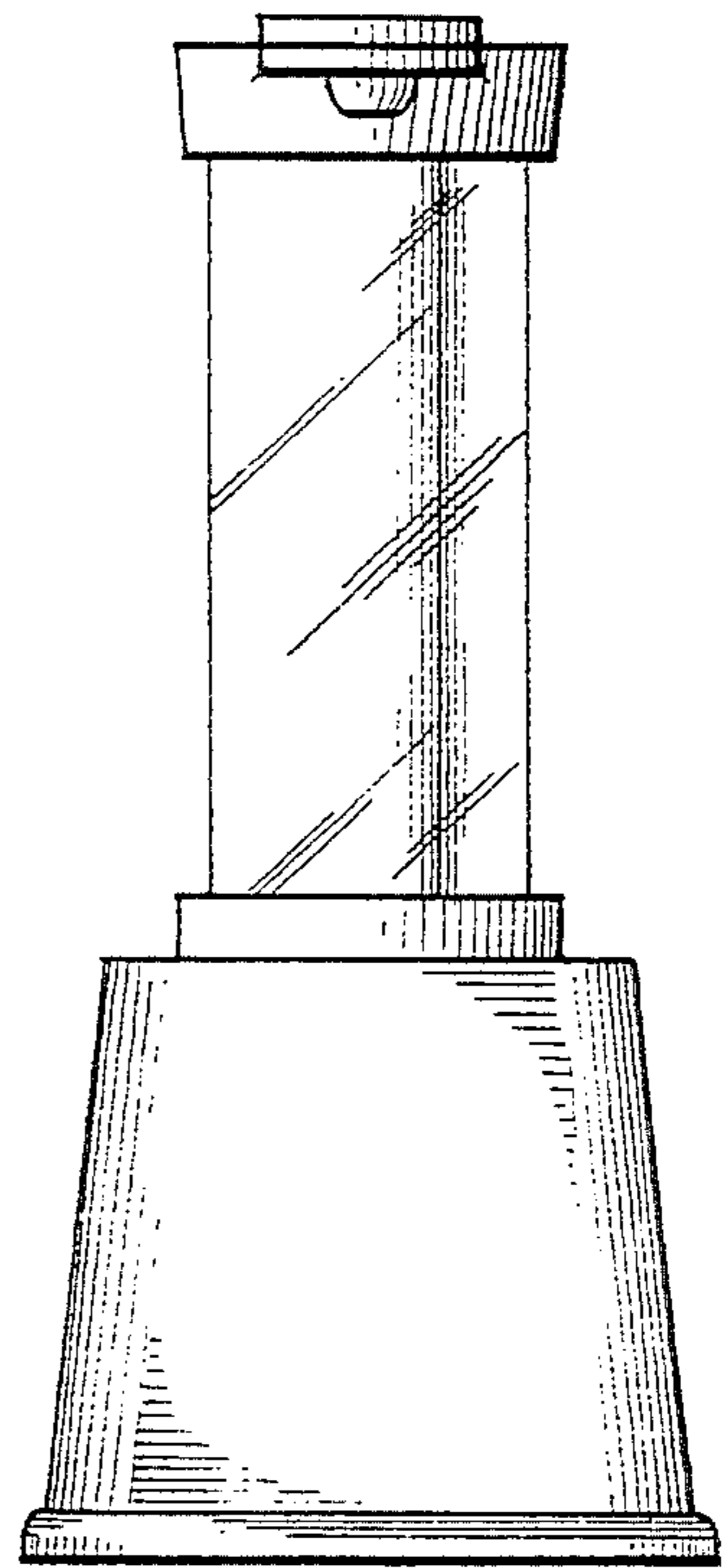

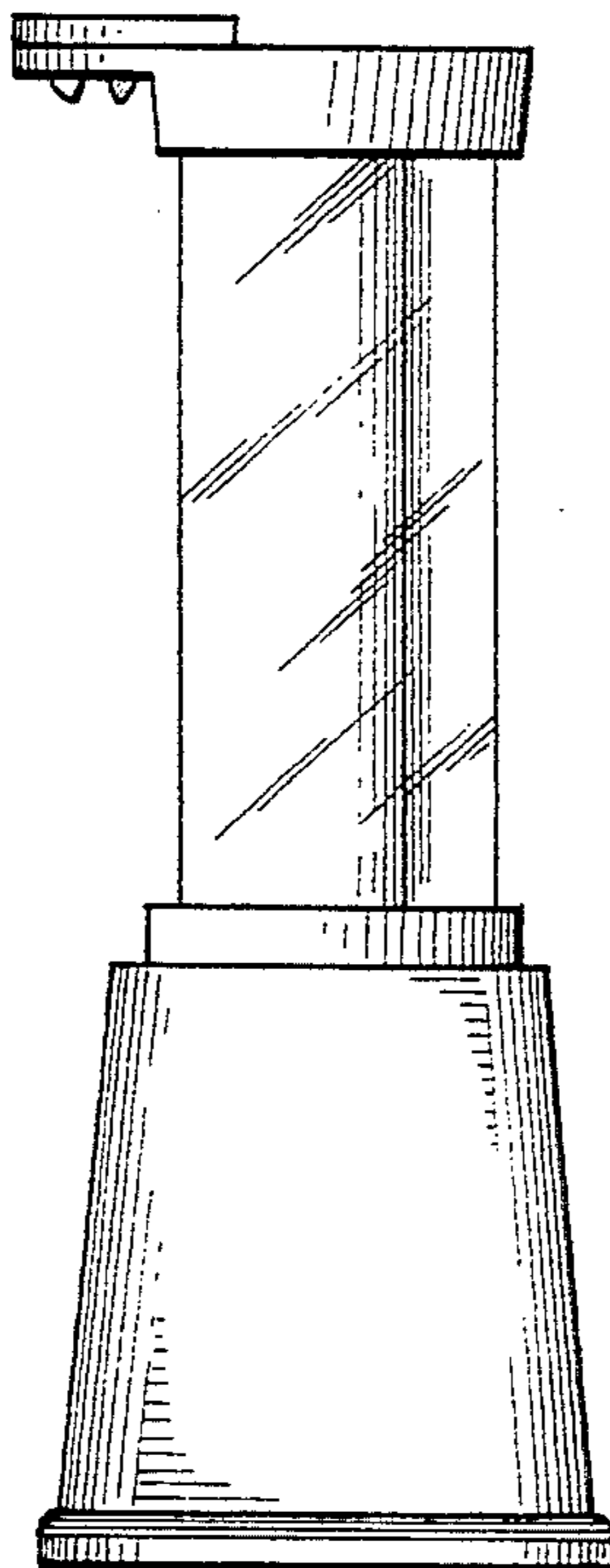

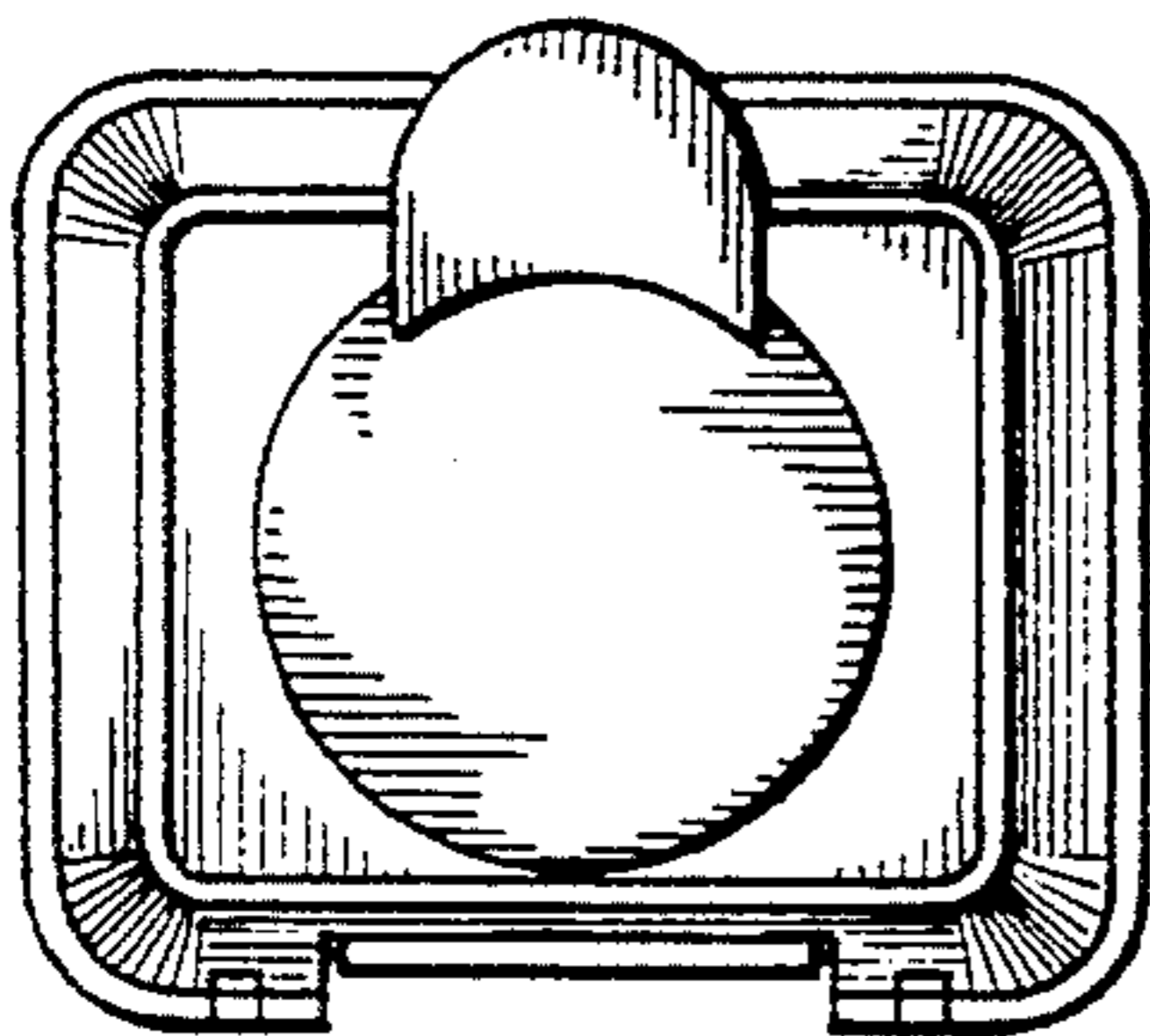
