FIG. 3 is a side view from the other side;

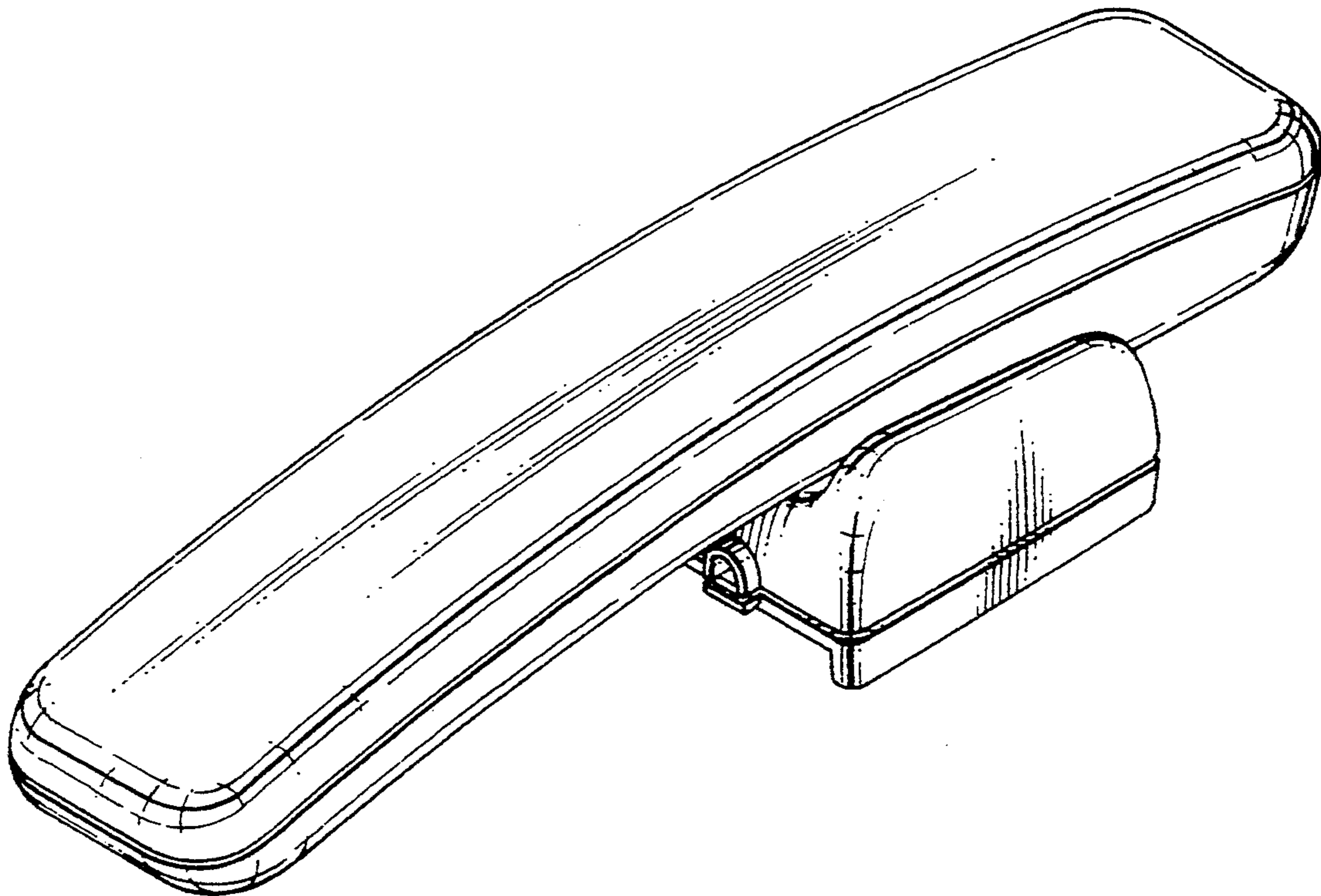
FIG. 4 is a side view from the other side (parts separated);

FIG. 8 is a rear view (parts separated).



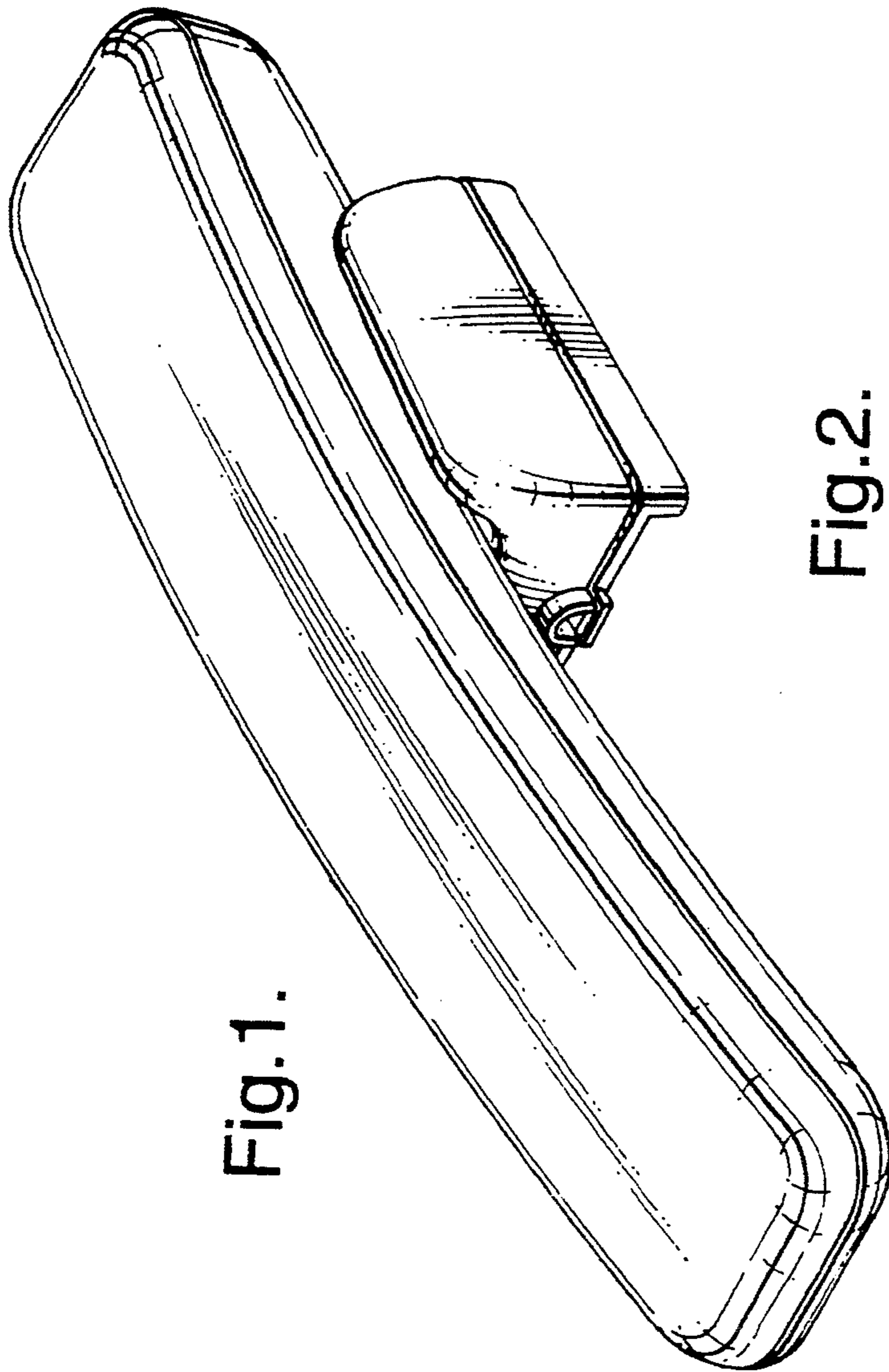

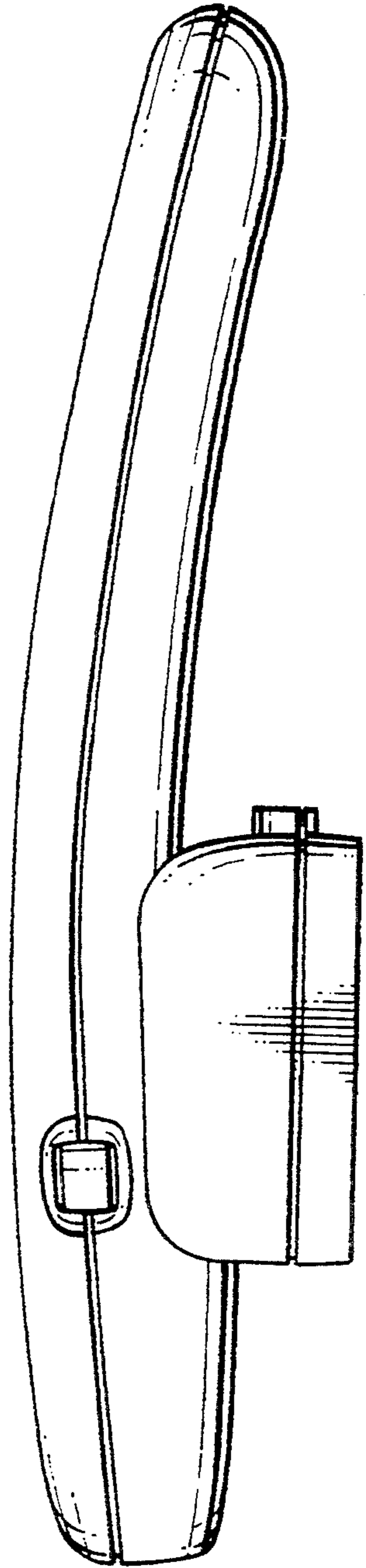

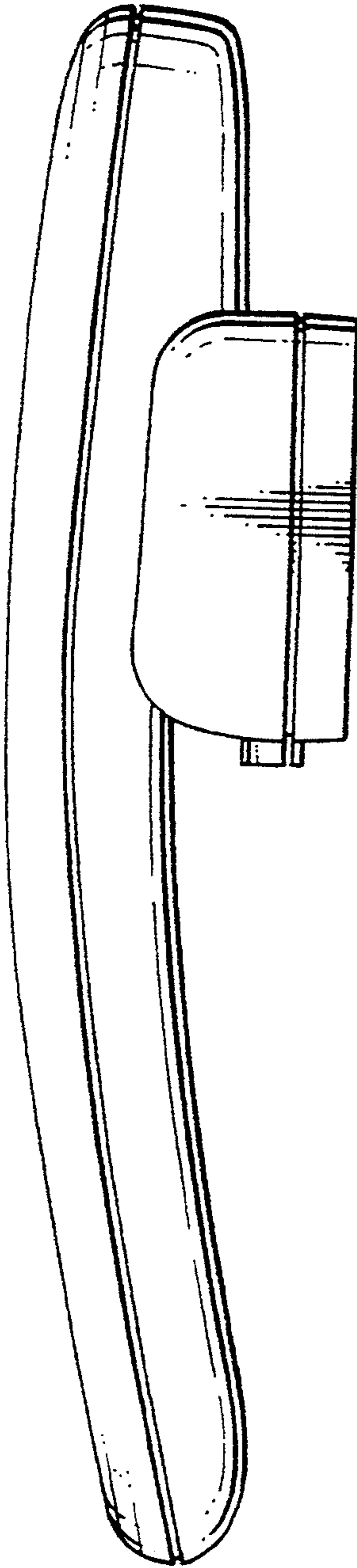
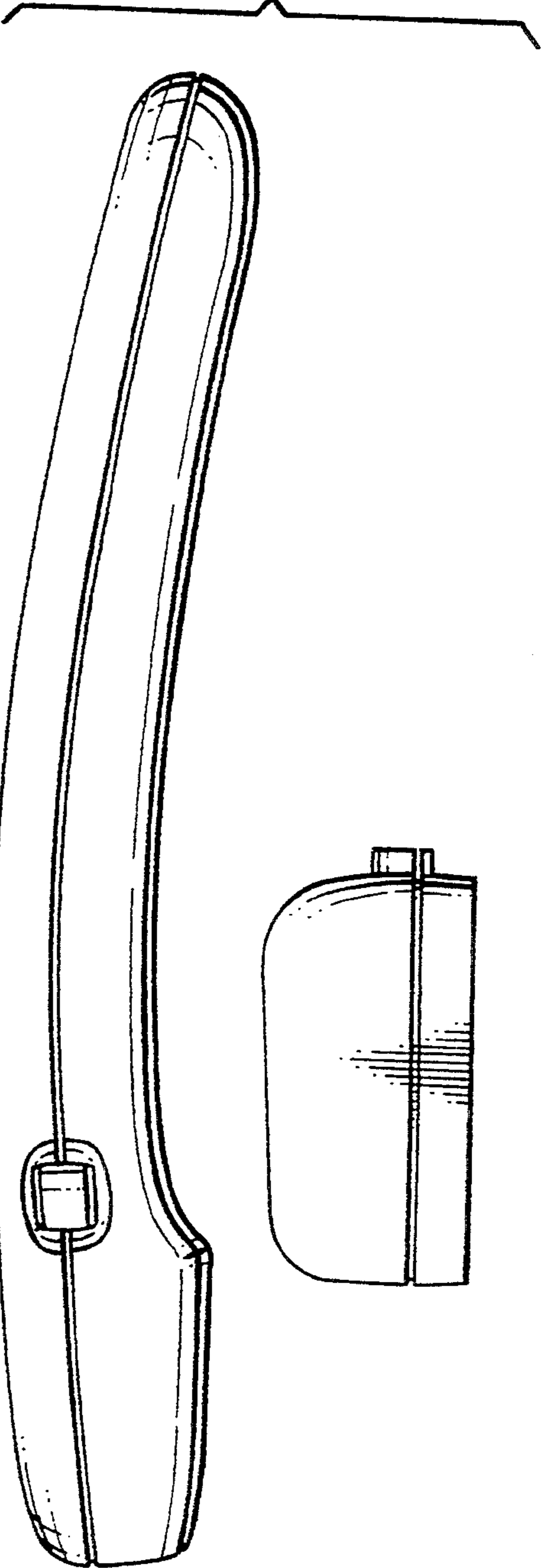

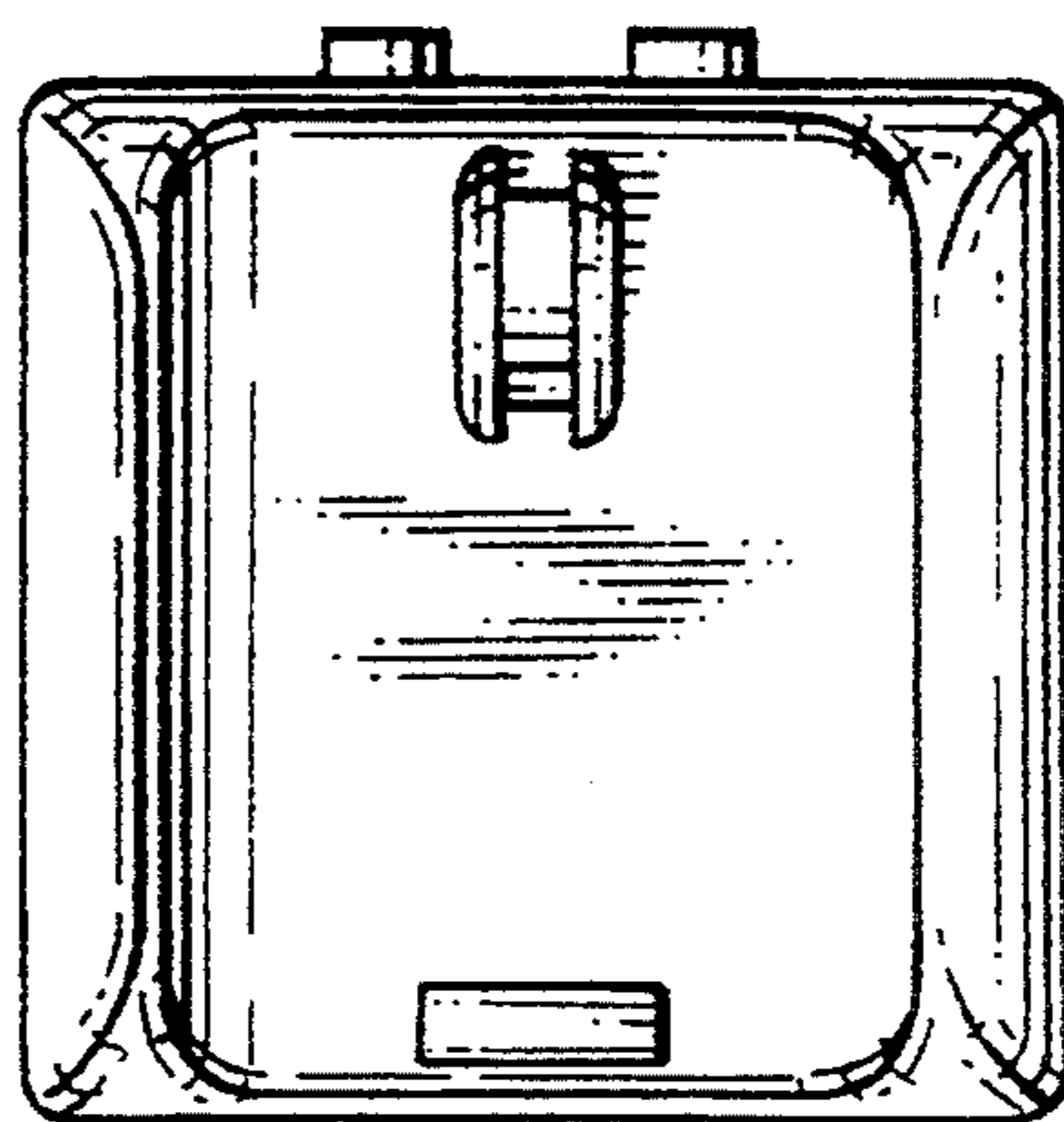
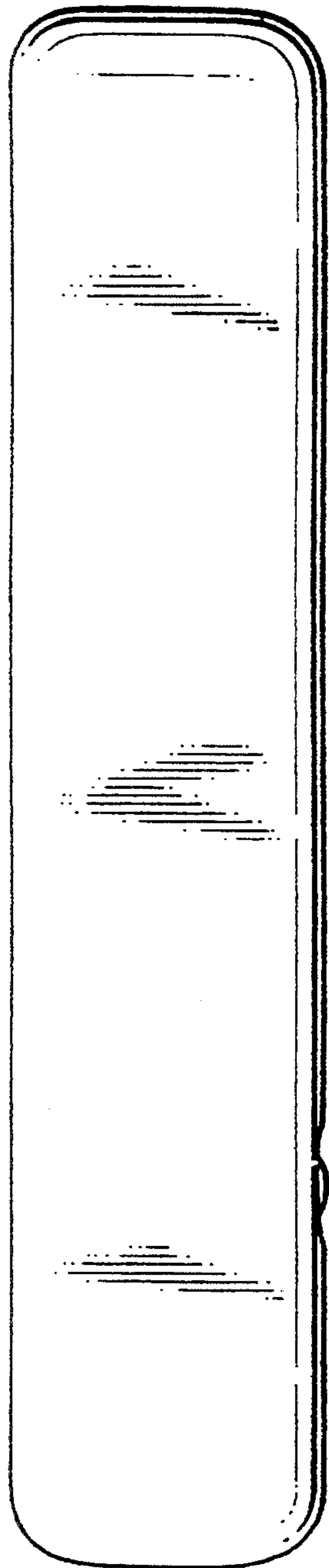

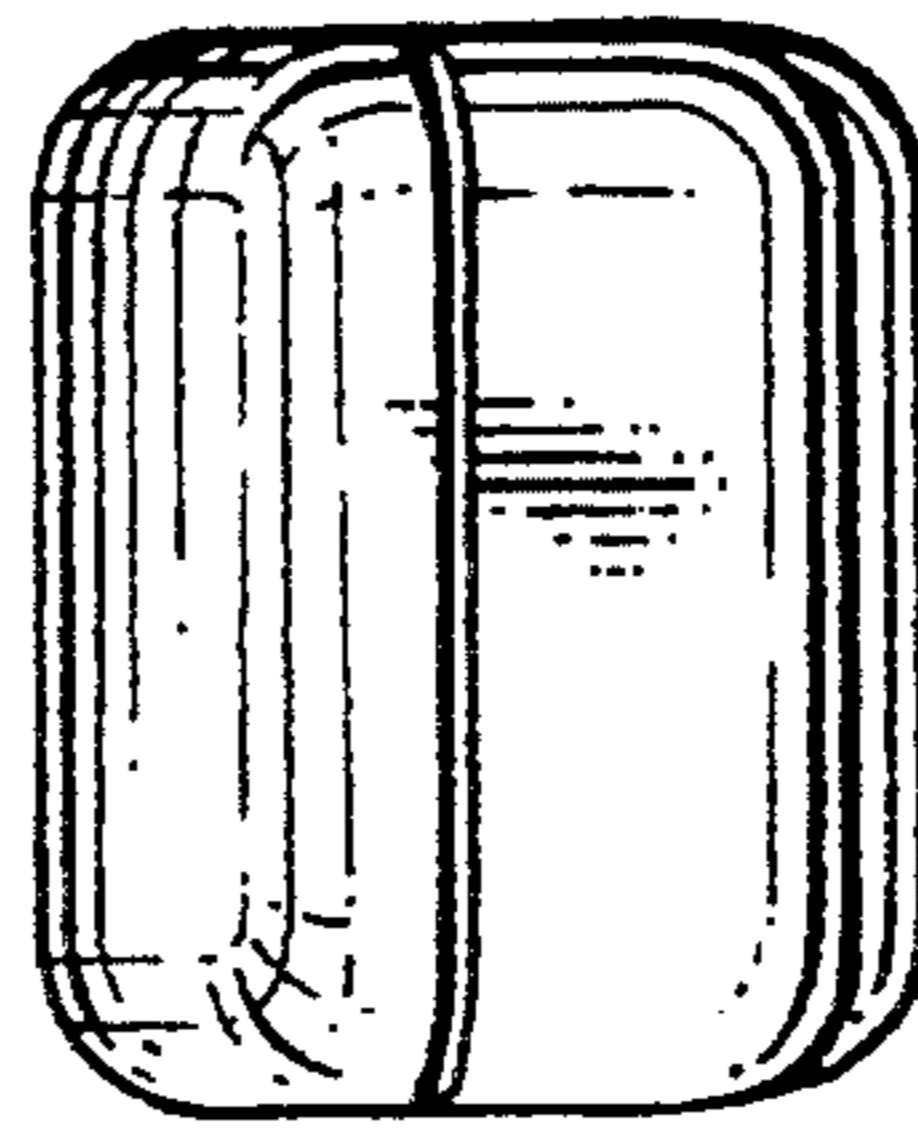
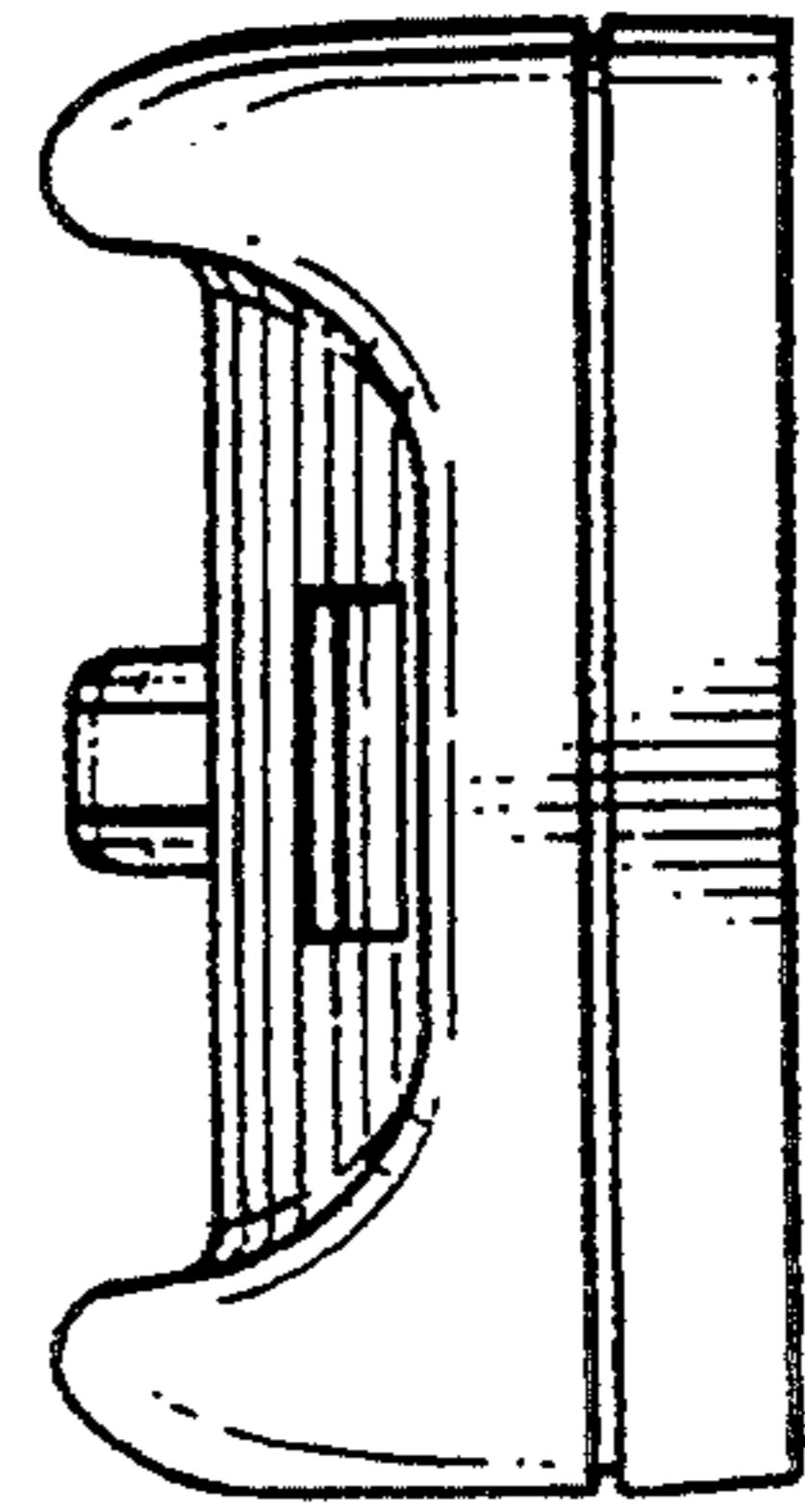

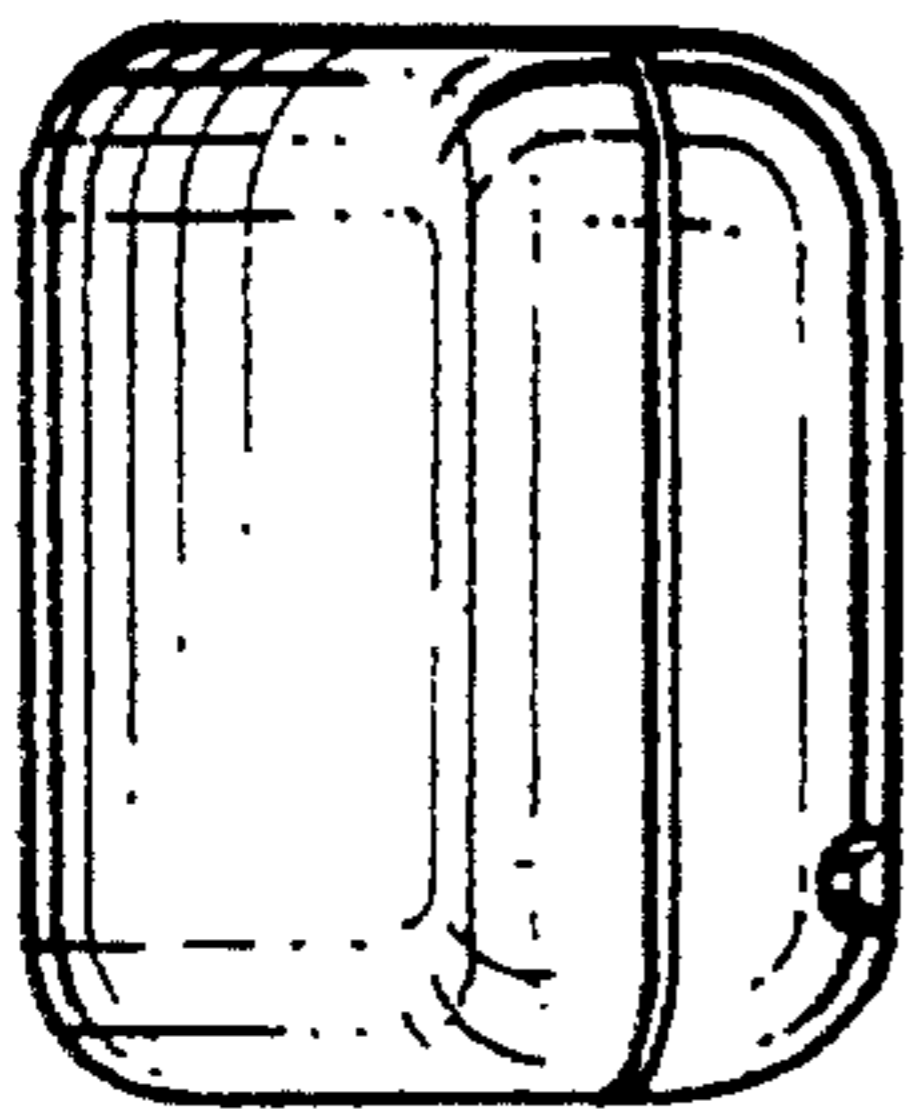

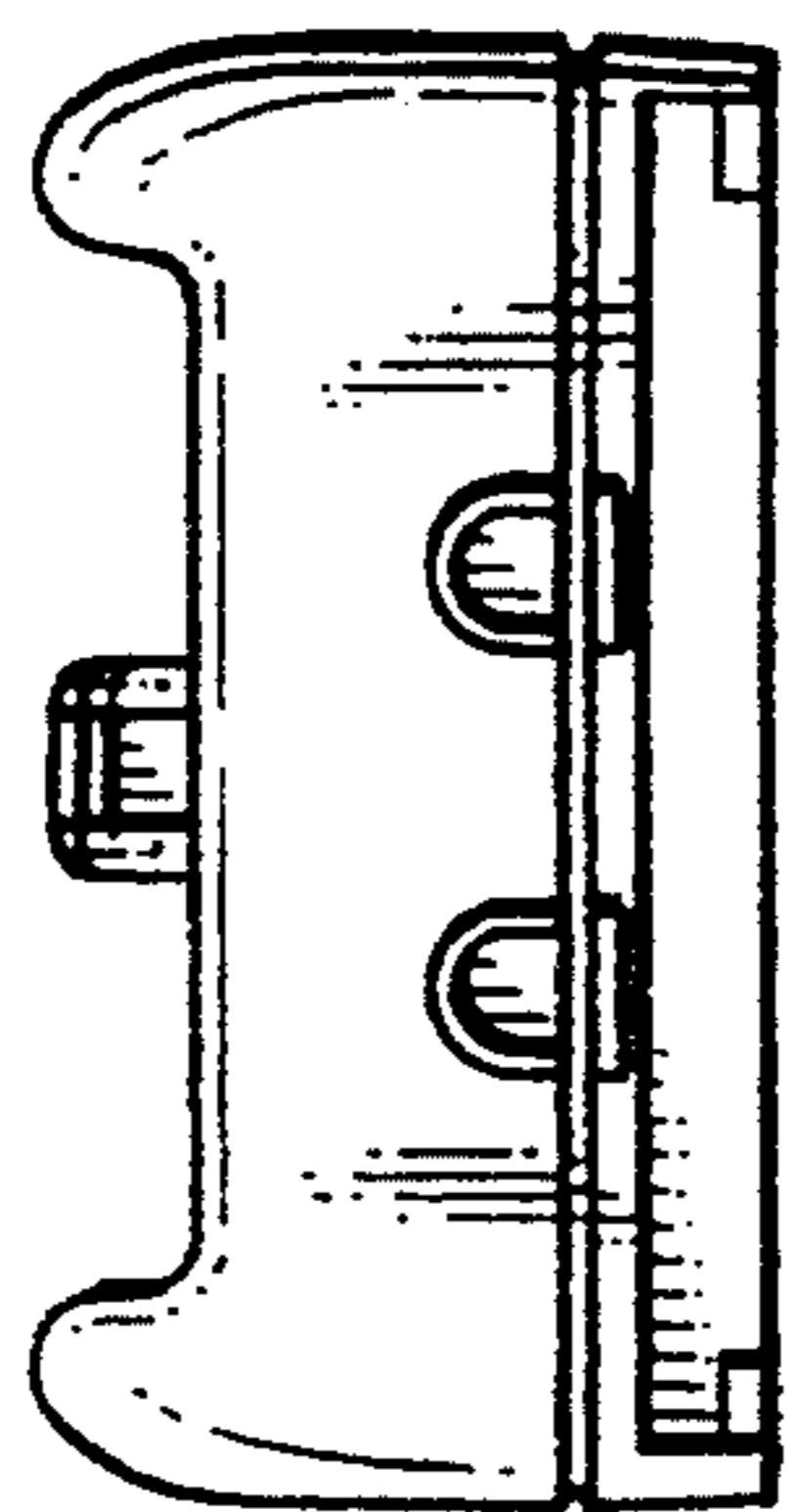
