FIG. 12 shows a top plan view thereof;

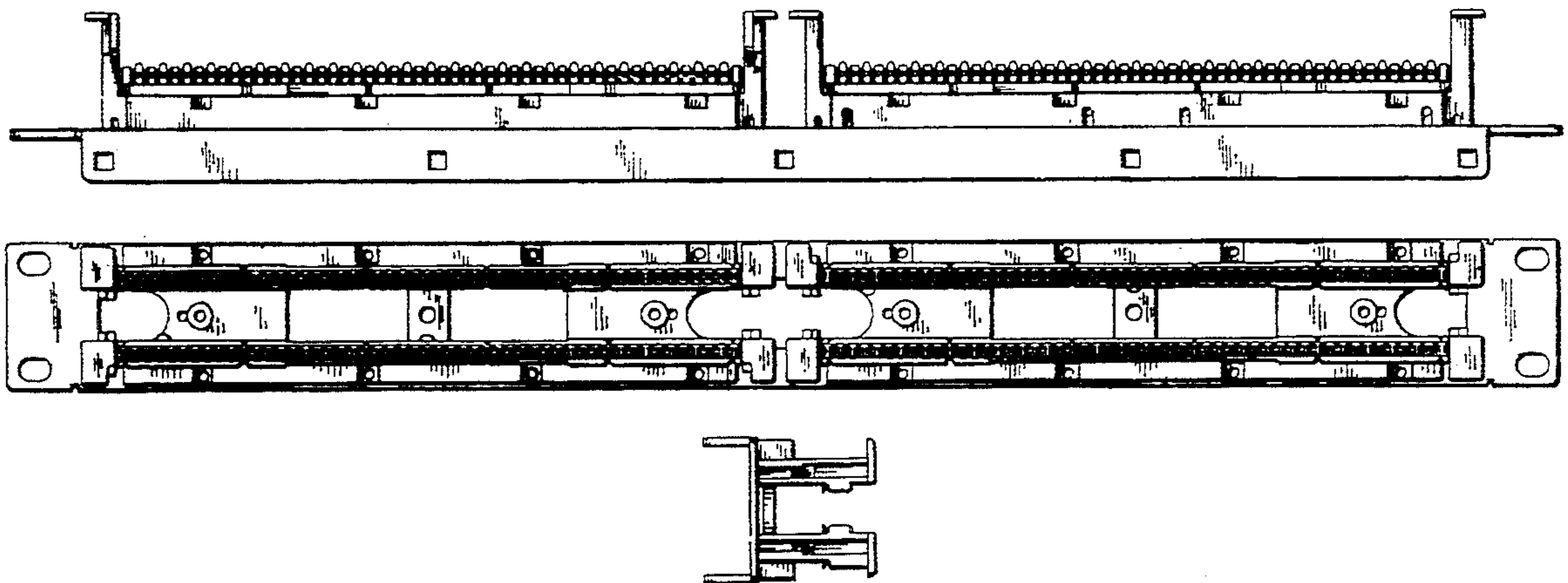
FIG. 13 shows a left end view thereof with the right end view thereof being a mirror image of FIG. 13;

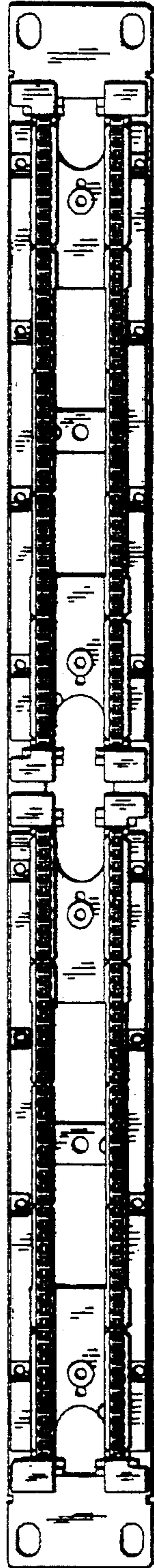

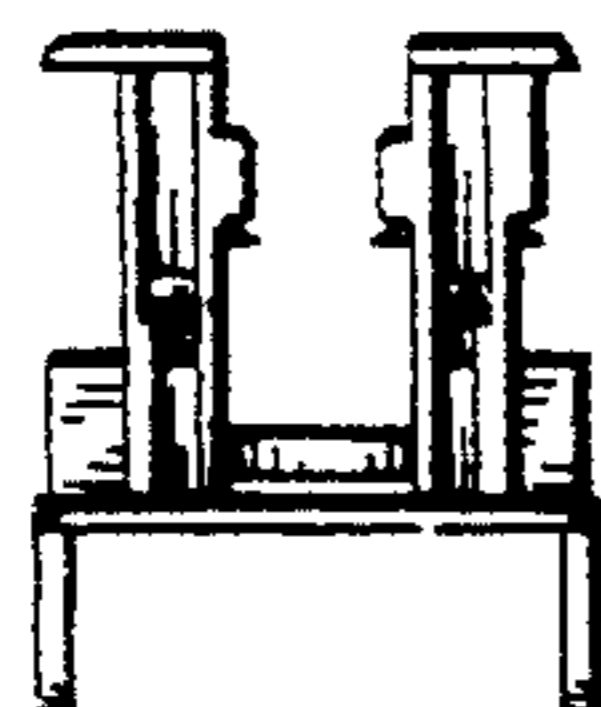

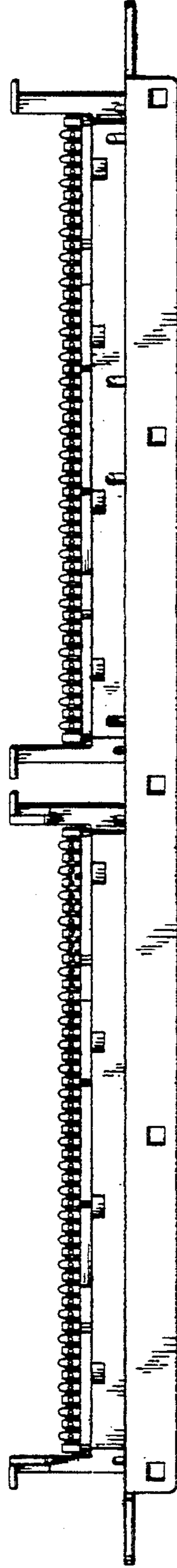

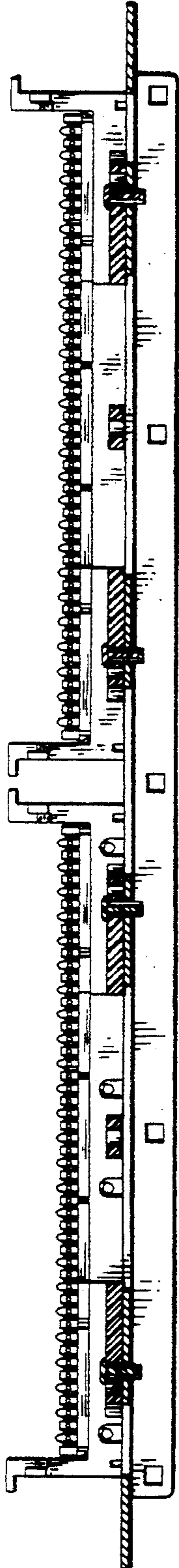

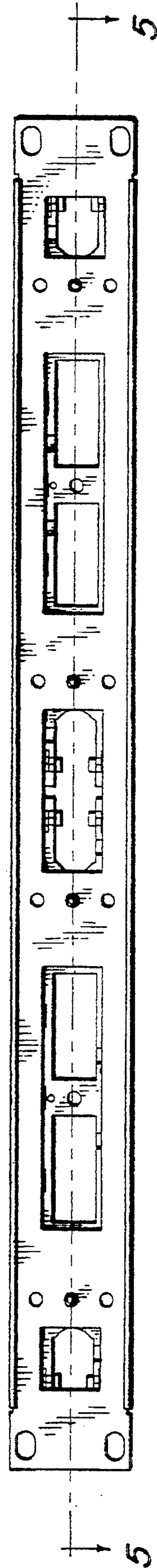

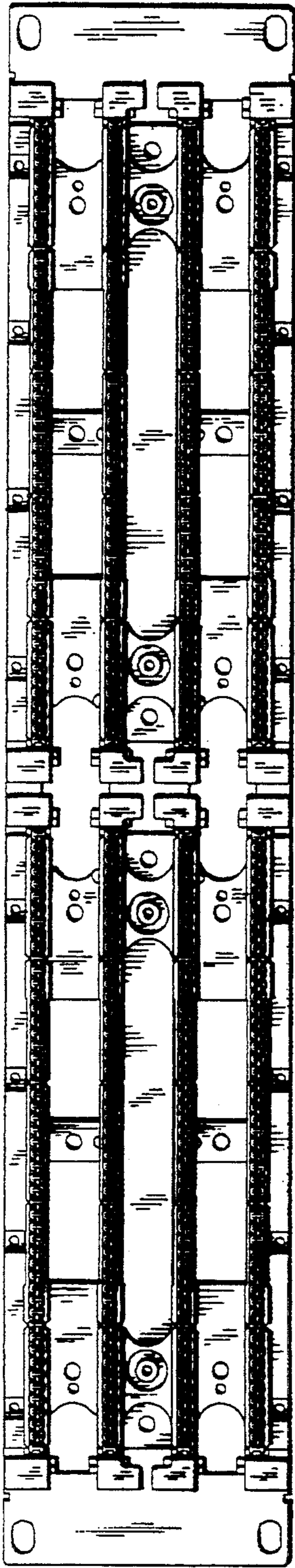

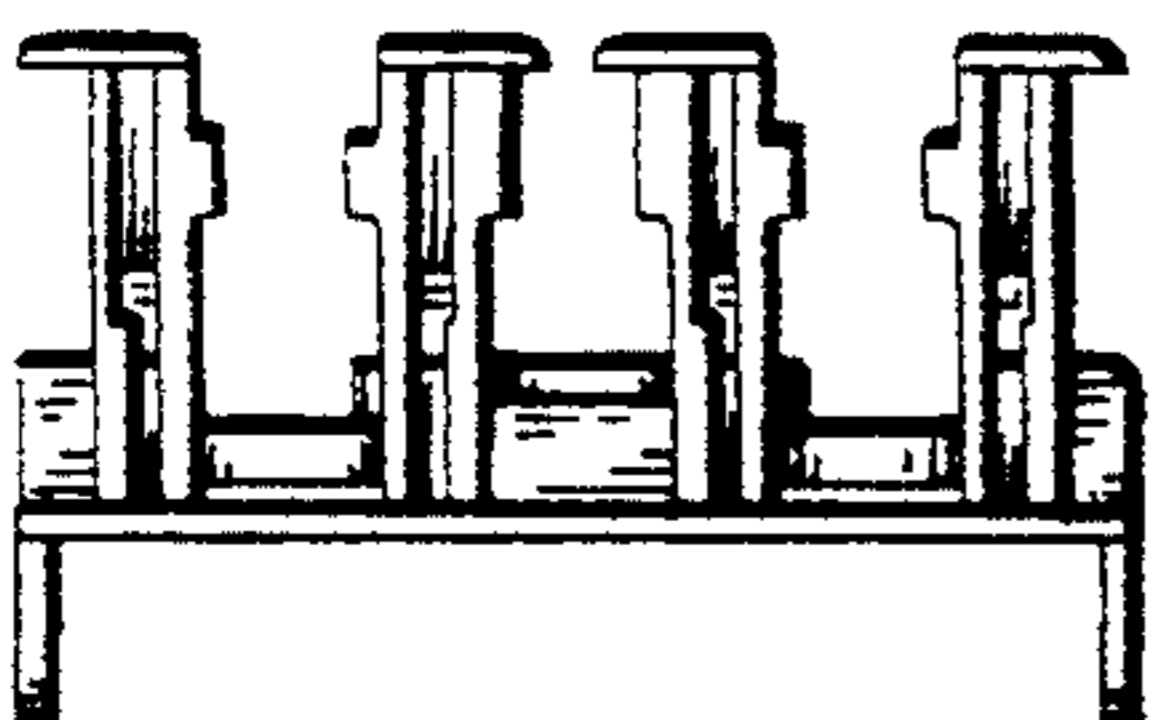

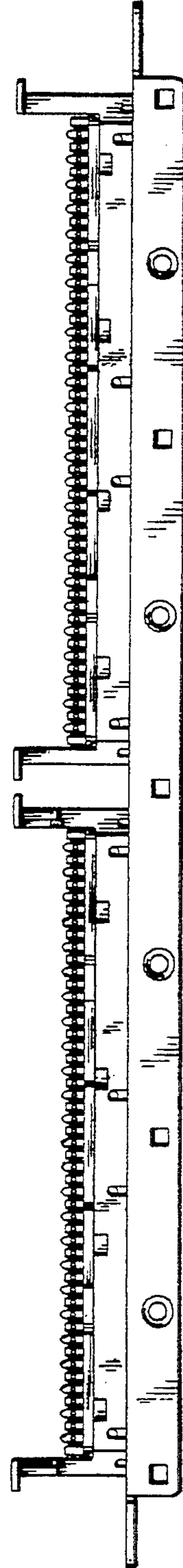

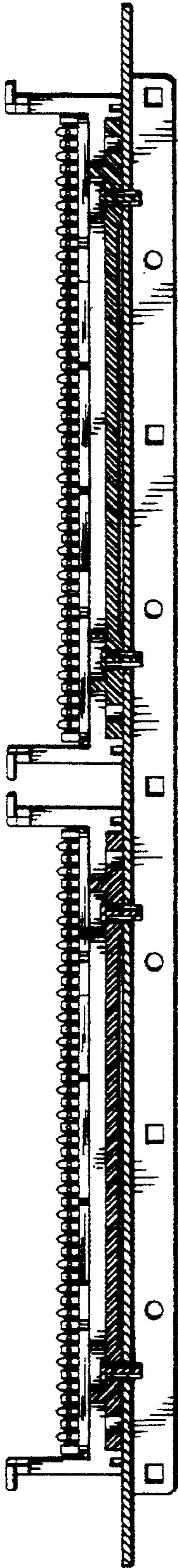

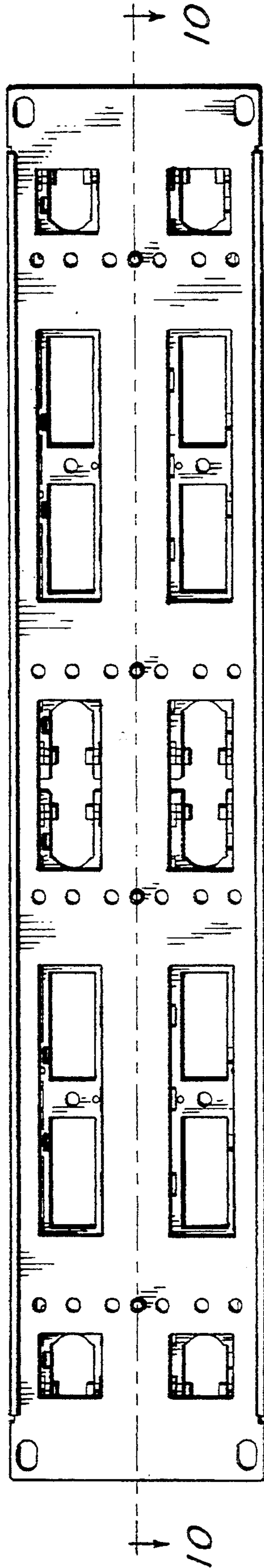

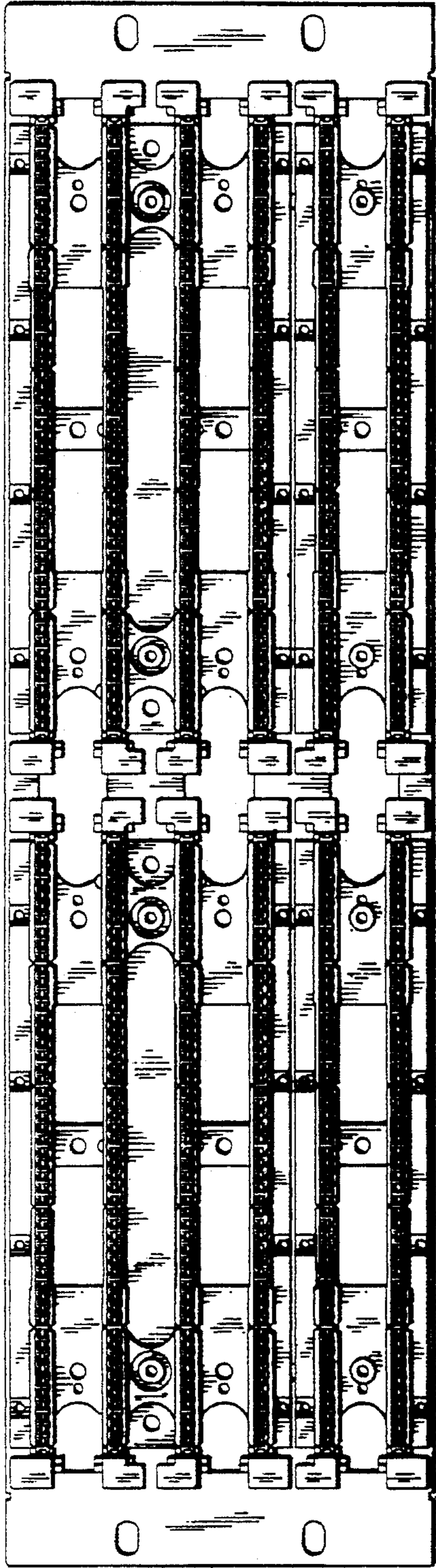

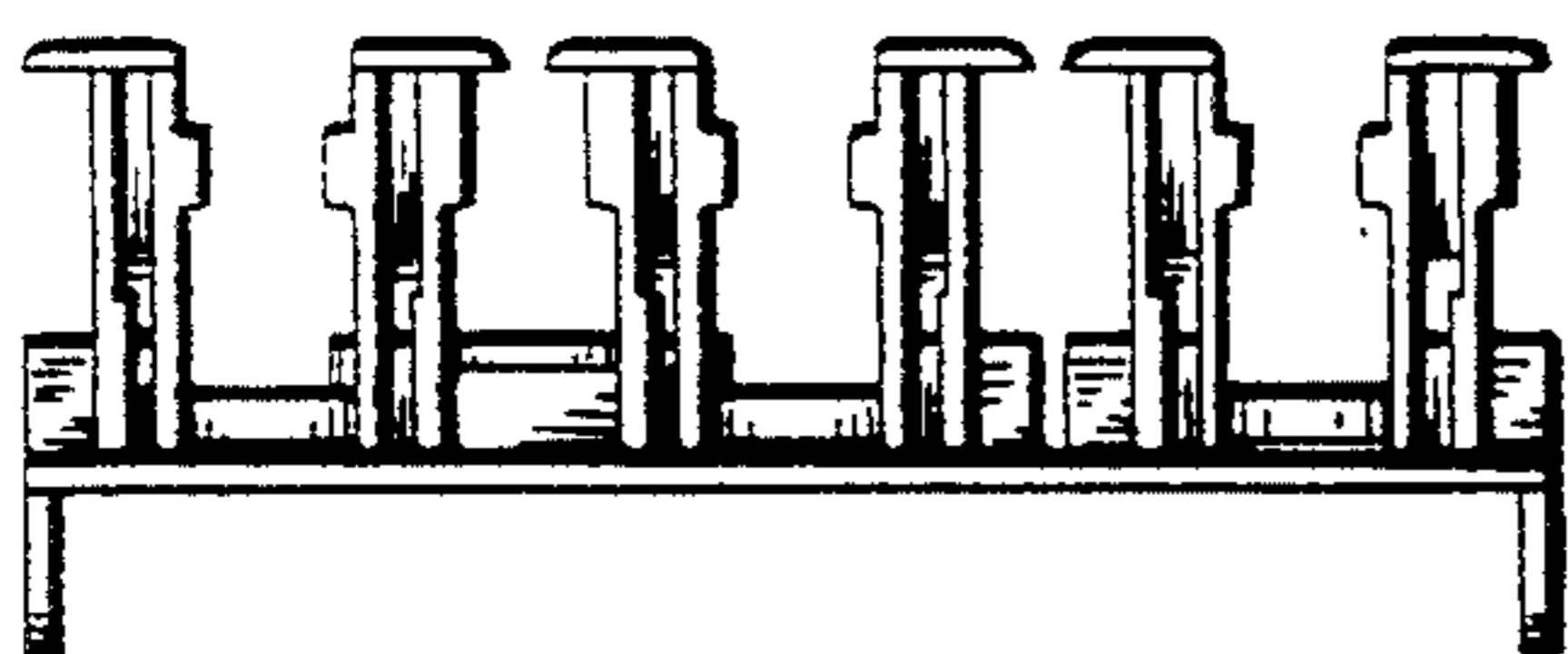

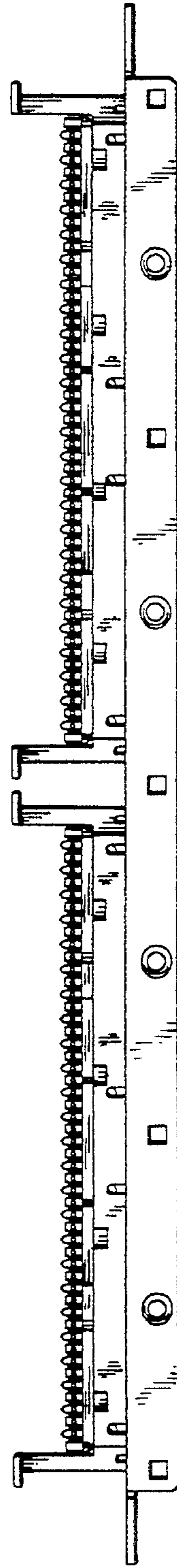

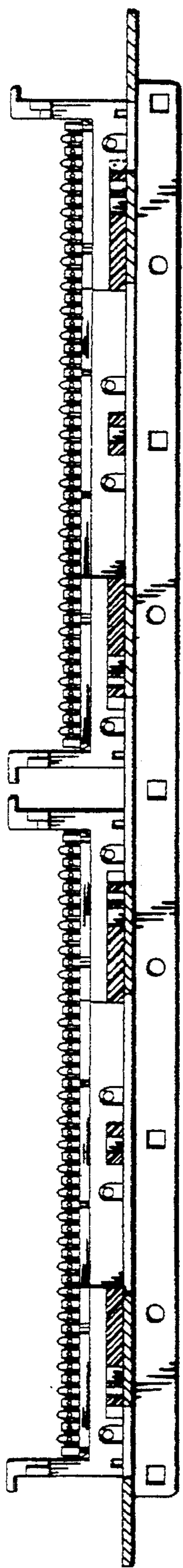

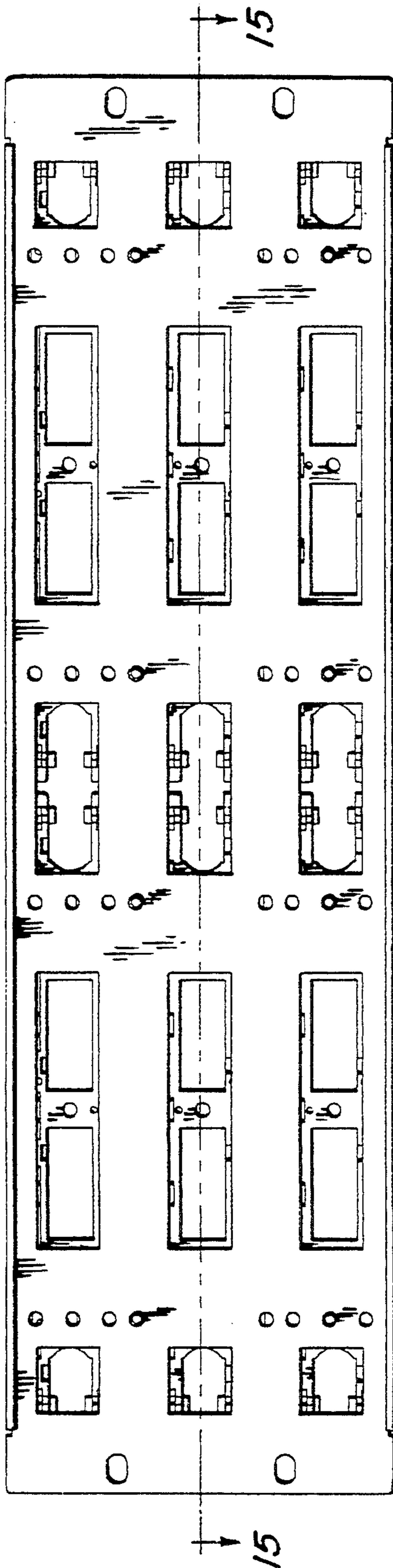
