FIG. 6 is a bottom plan view of the ground support for holding patio and beach umbrellas of FIG. 1.

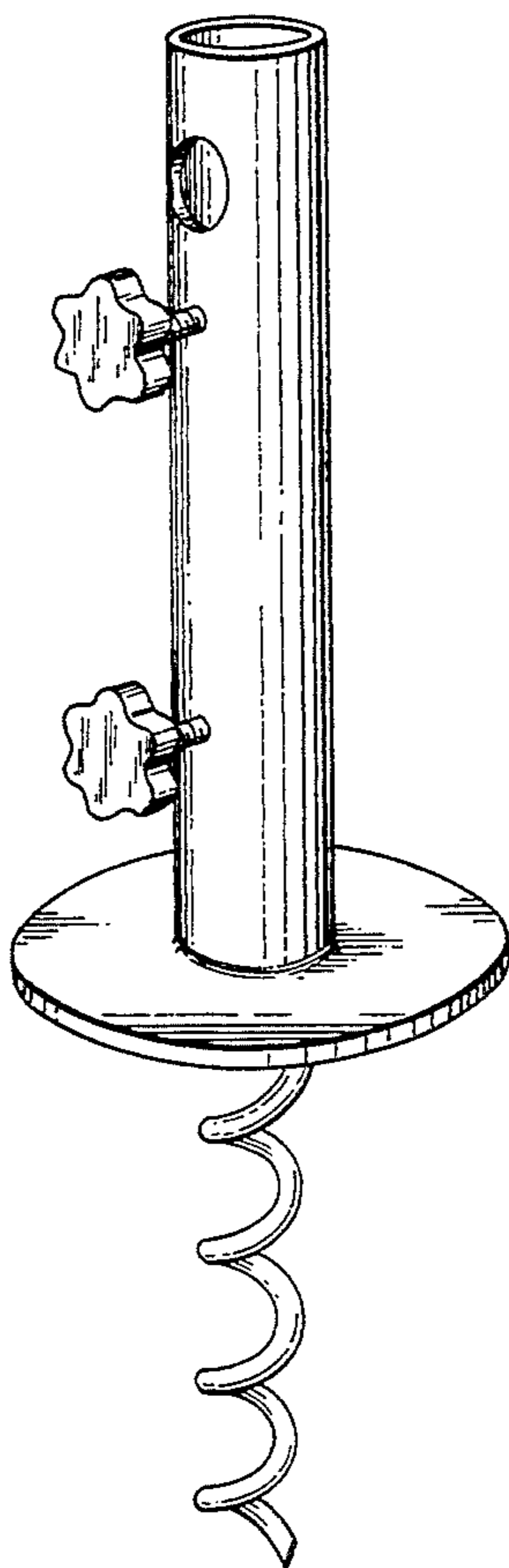

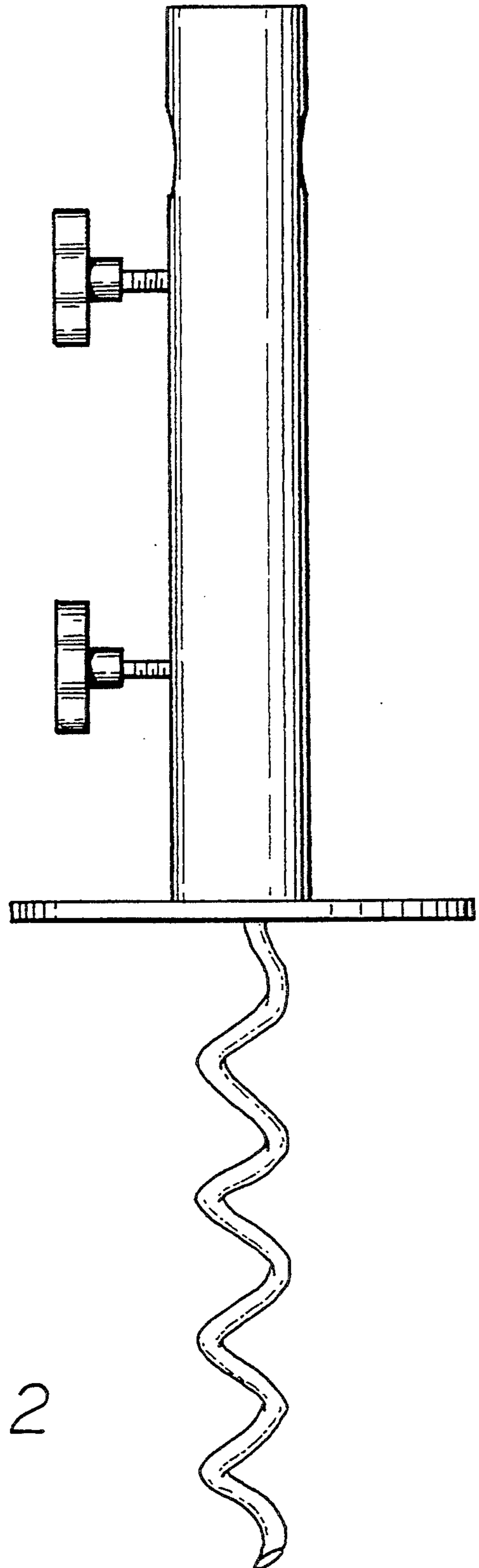
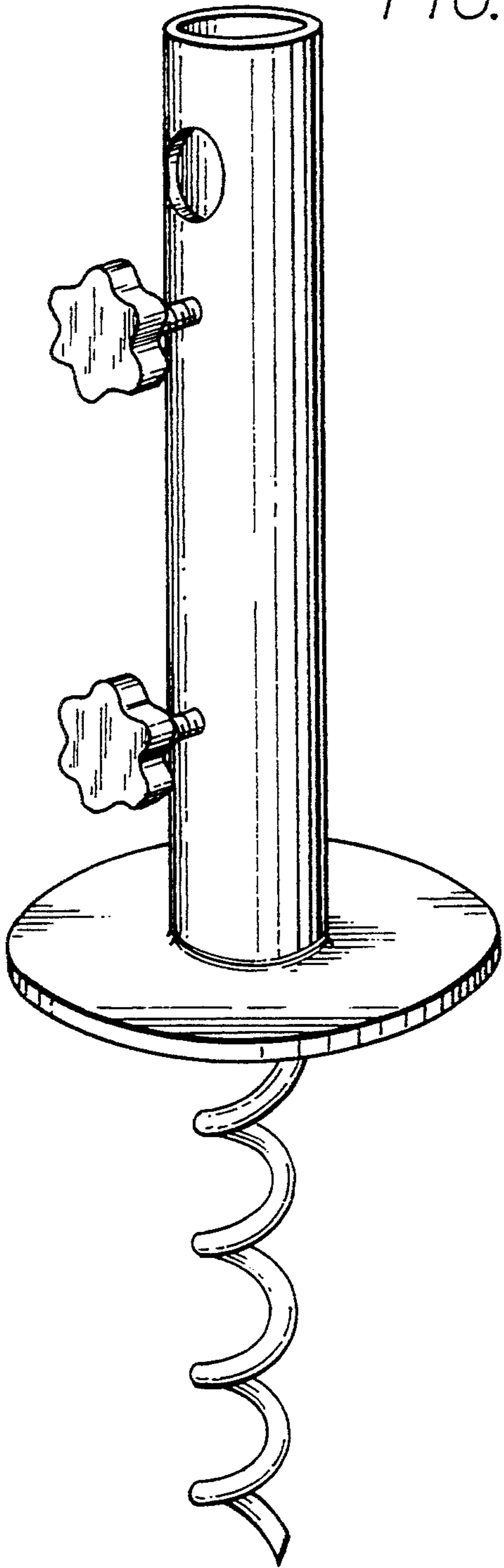

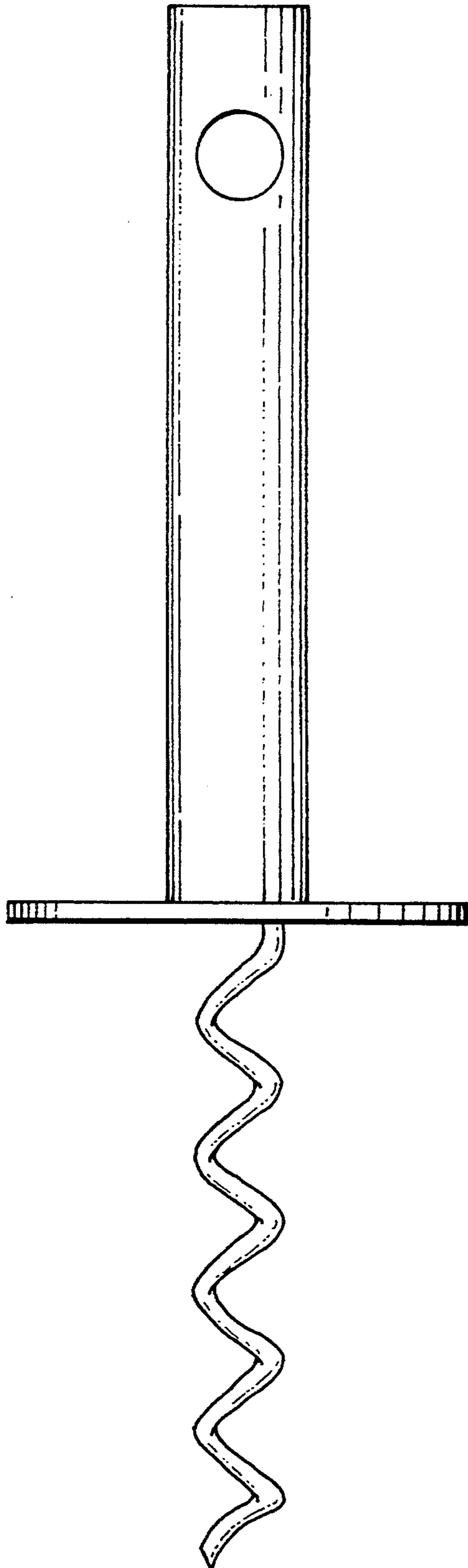

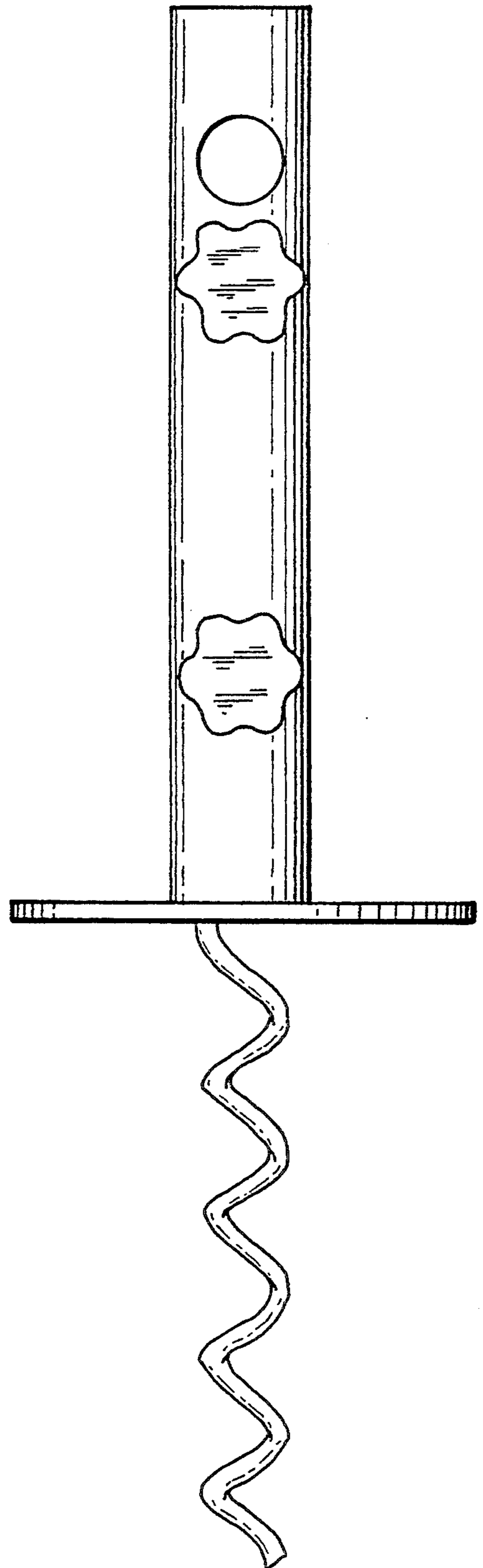

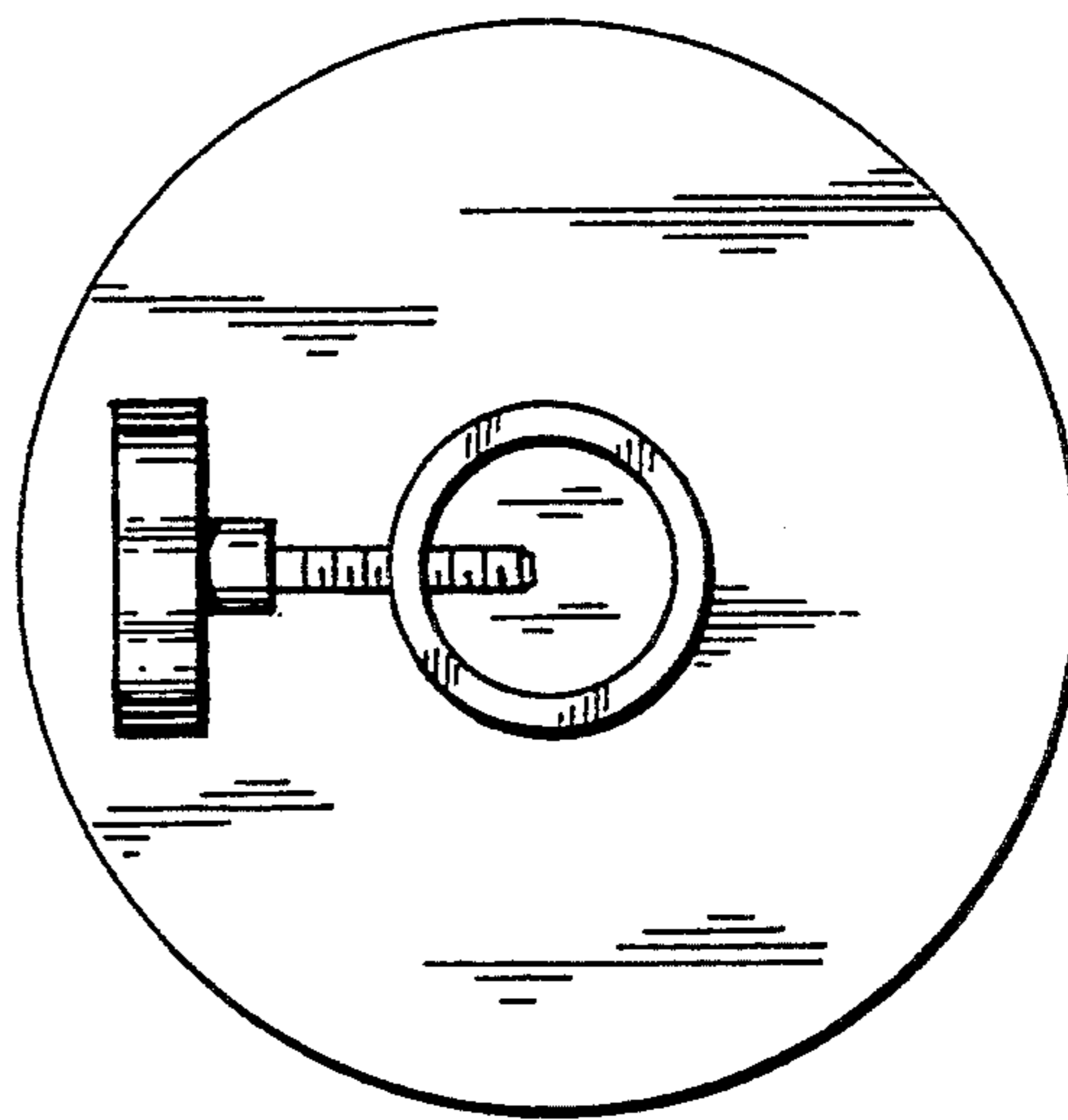
