**DESCRIPTION**

FIG. 1 is a perspective view of a cord reel;  
FIG. 2 is a left side view of the cord reel of FIG. 1;  
FIG. 3 is a front view of the cord reel of FIG. 1;  
FIG. 4 is a right side view of cord reel of FIG. 1;

FIG. 7 is a bottom view of the cord reel of FIG. 1.

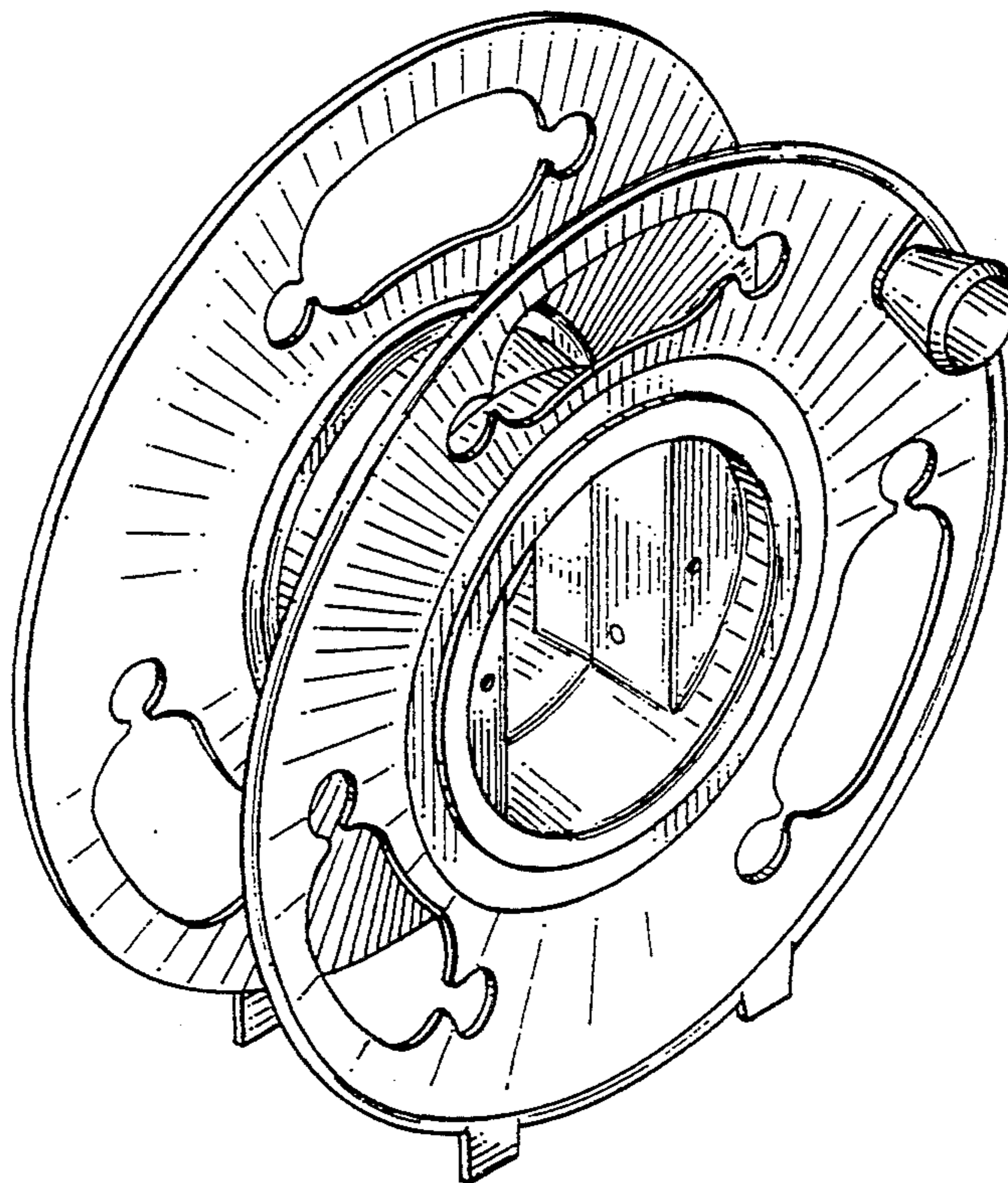

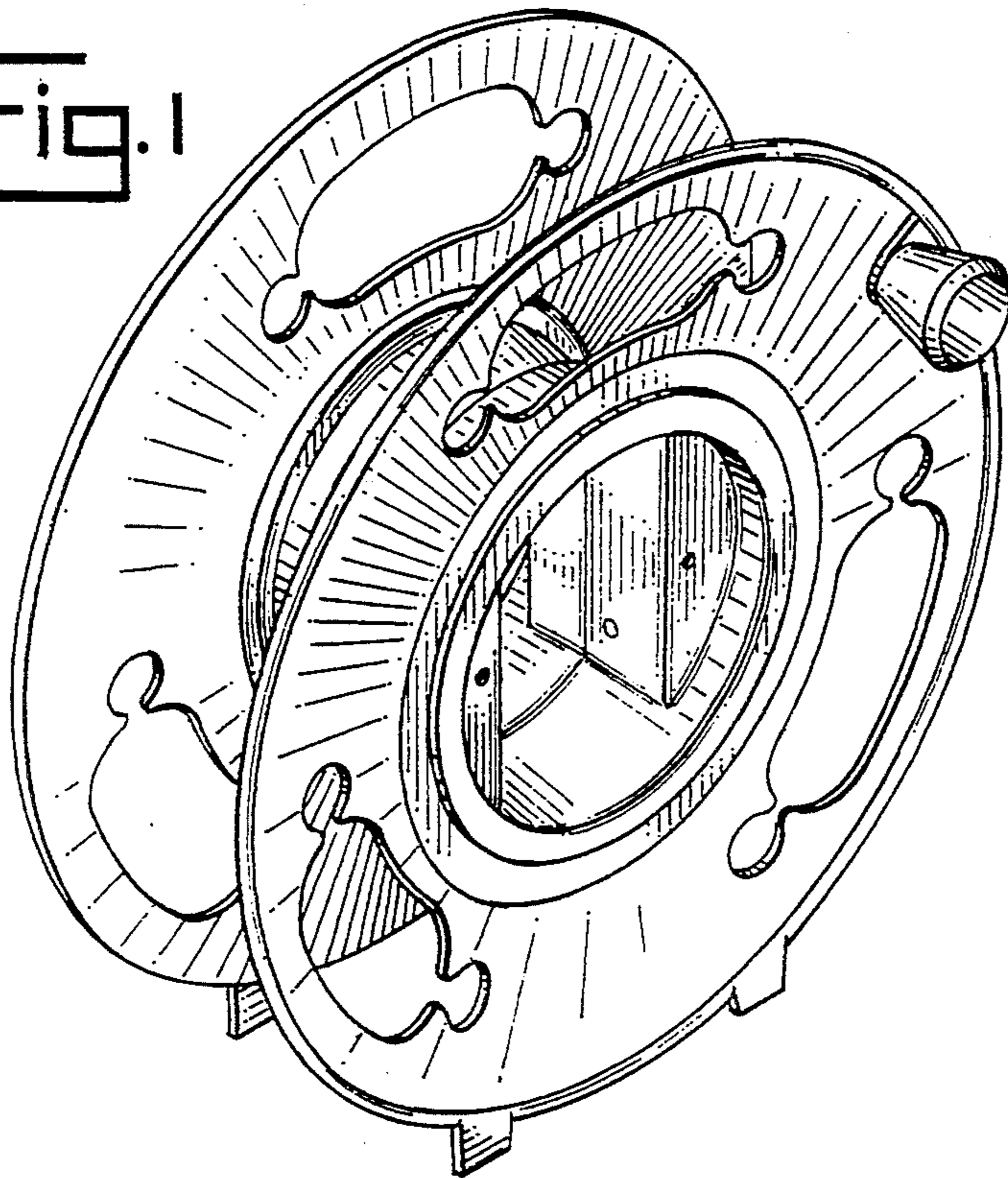

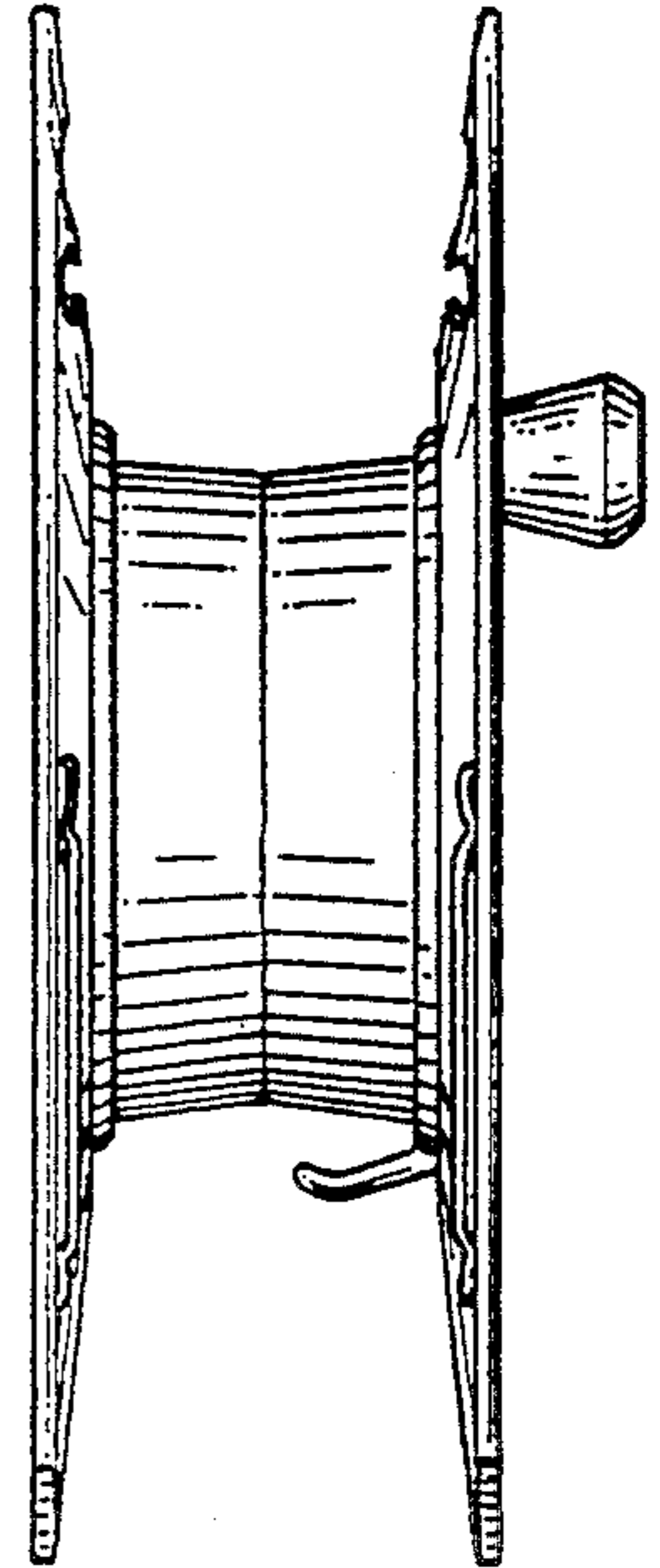

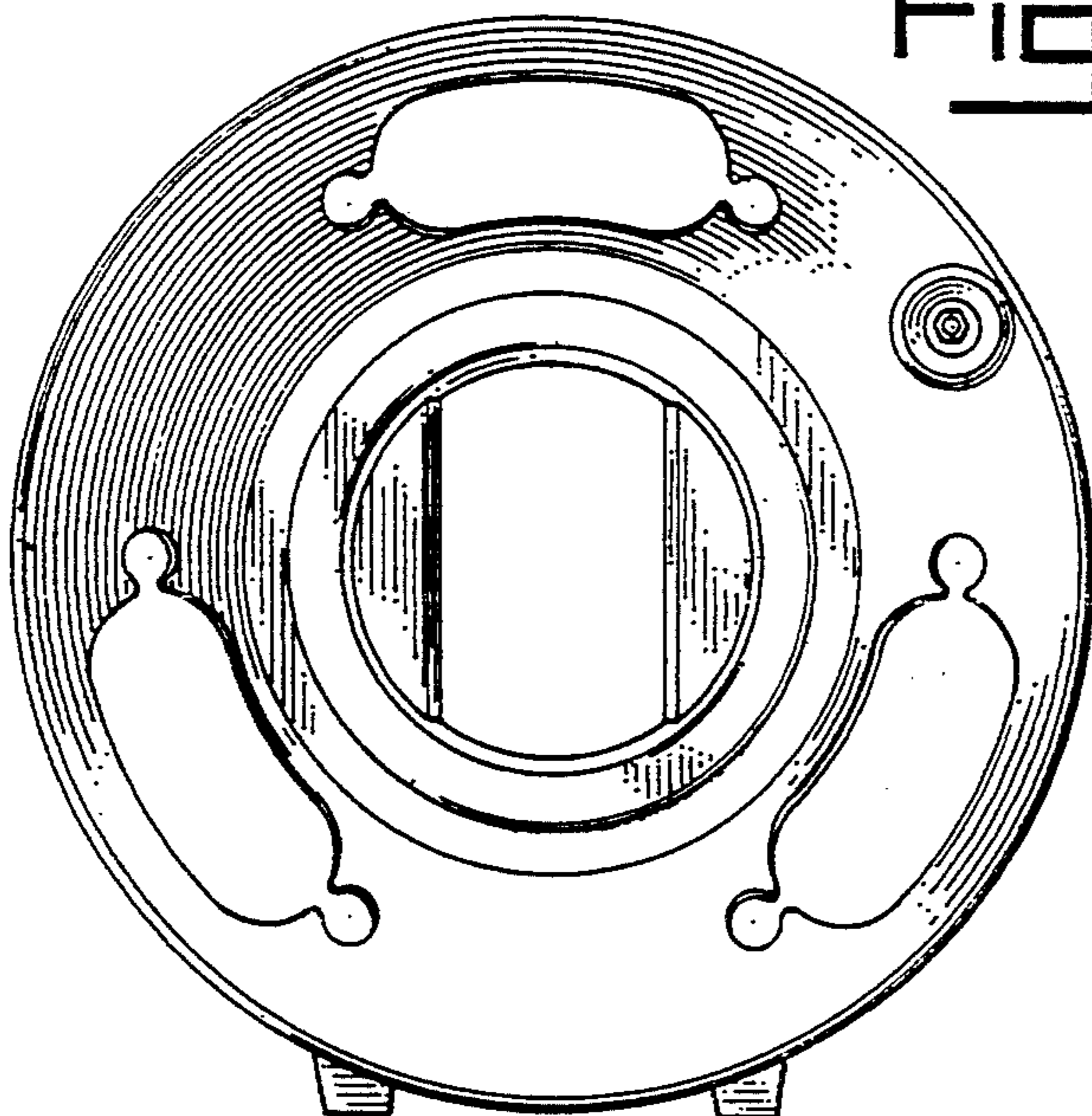

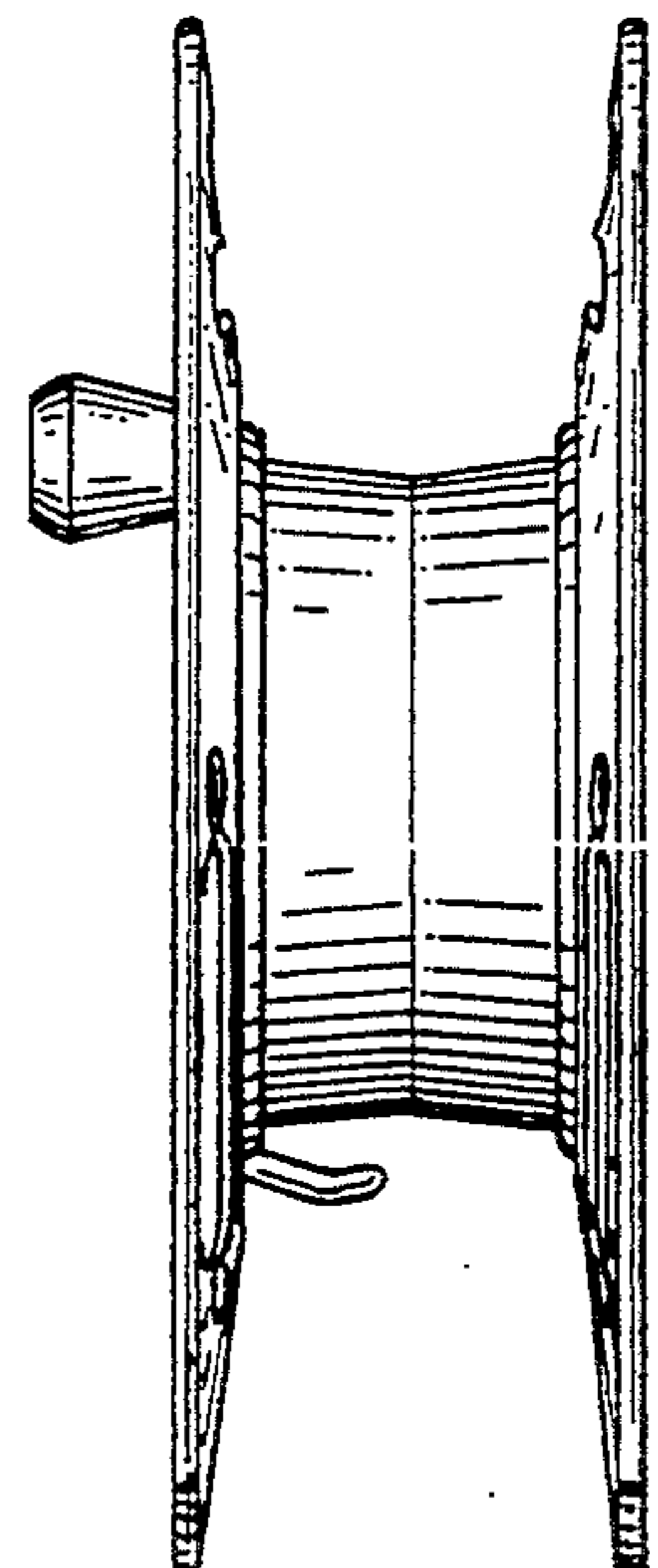

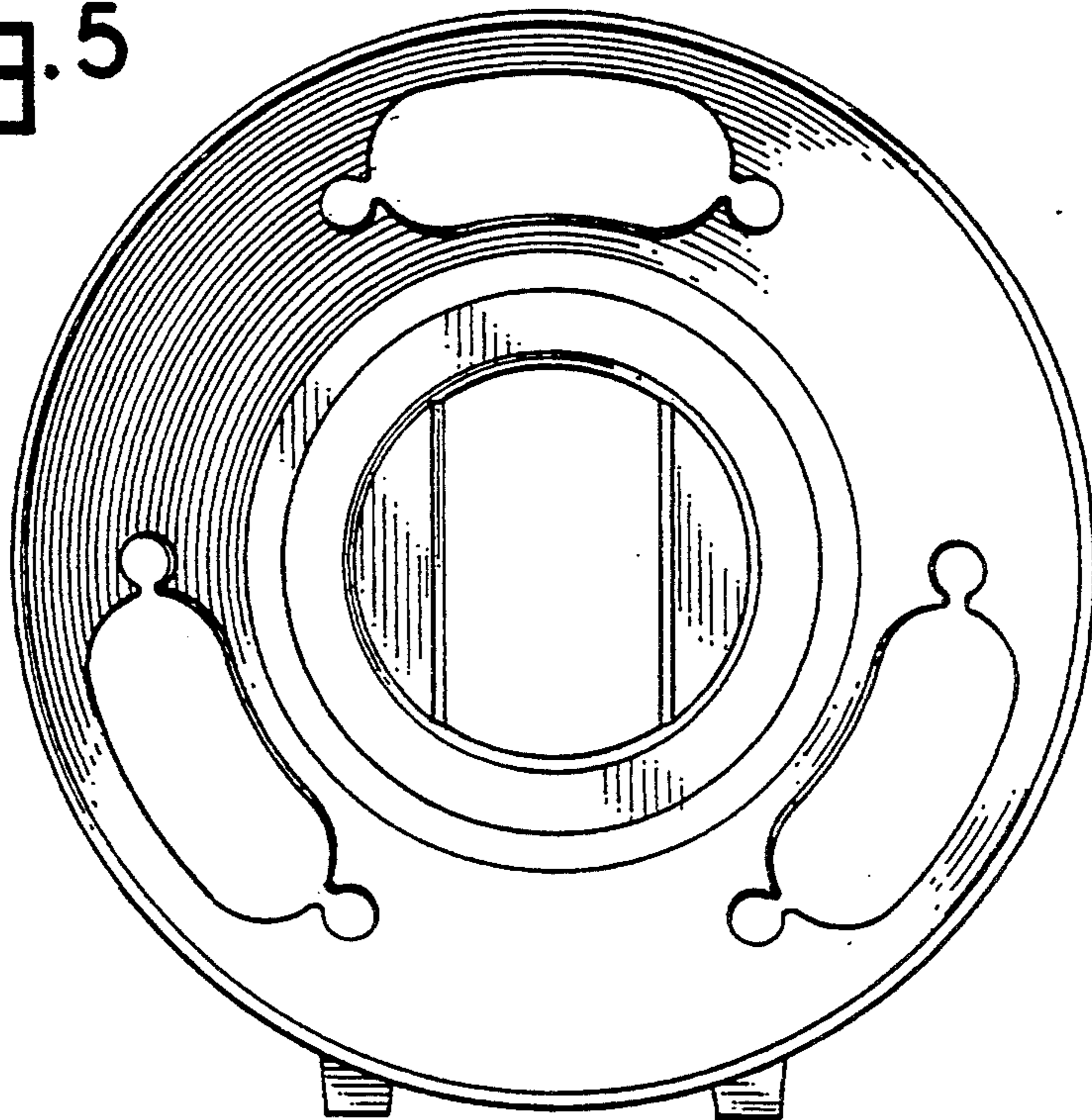

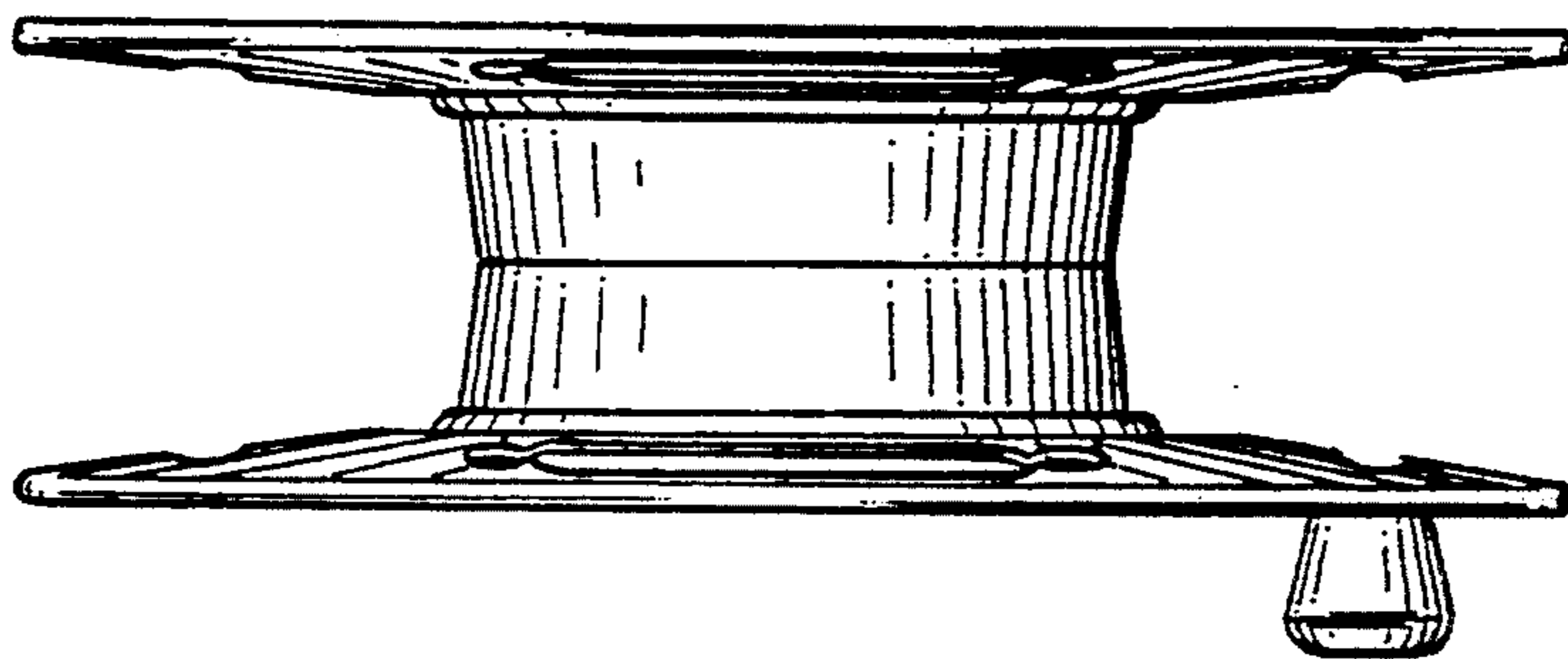
