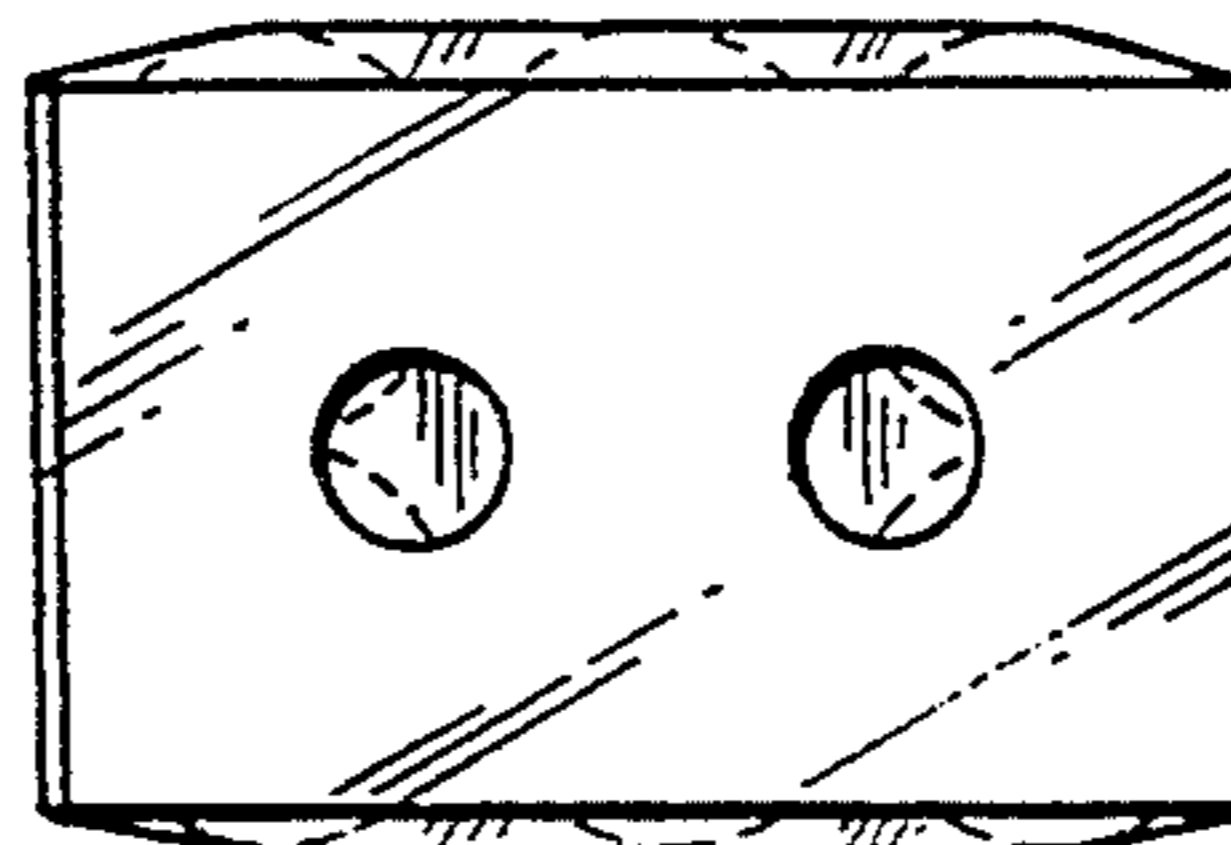
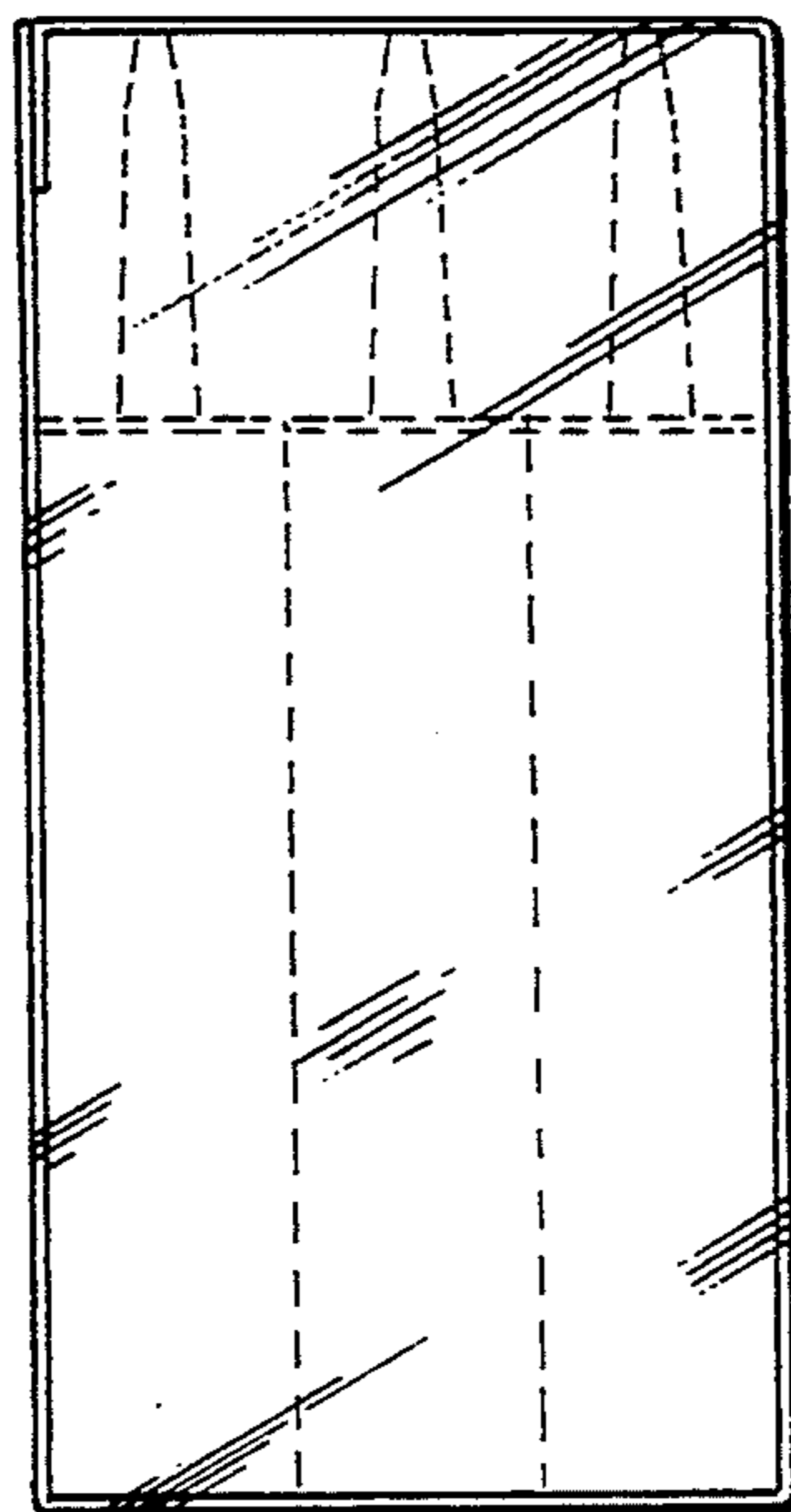

[57] **CLAIM**

The ornamental design for a display package for dispensing tubes, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a display package for dispensing tubes showing my new design; the rear elevational view being a mirror image thereof; FIG. 2 is a left side elevational view thereof, the right side elevational being a mirror image thereof; FIG. 3 is a bottom plan view thereof; and, FIG. 4 is a top plan view thereof. The broken line showing of caulking tubes is for illustrative purpose only and forms no part of the claim.



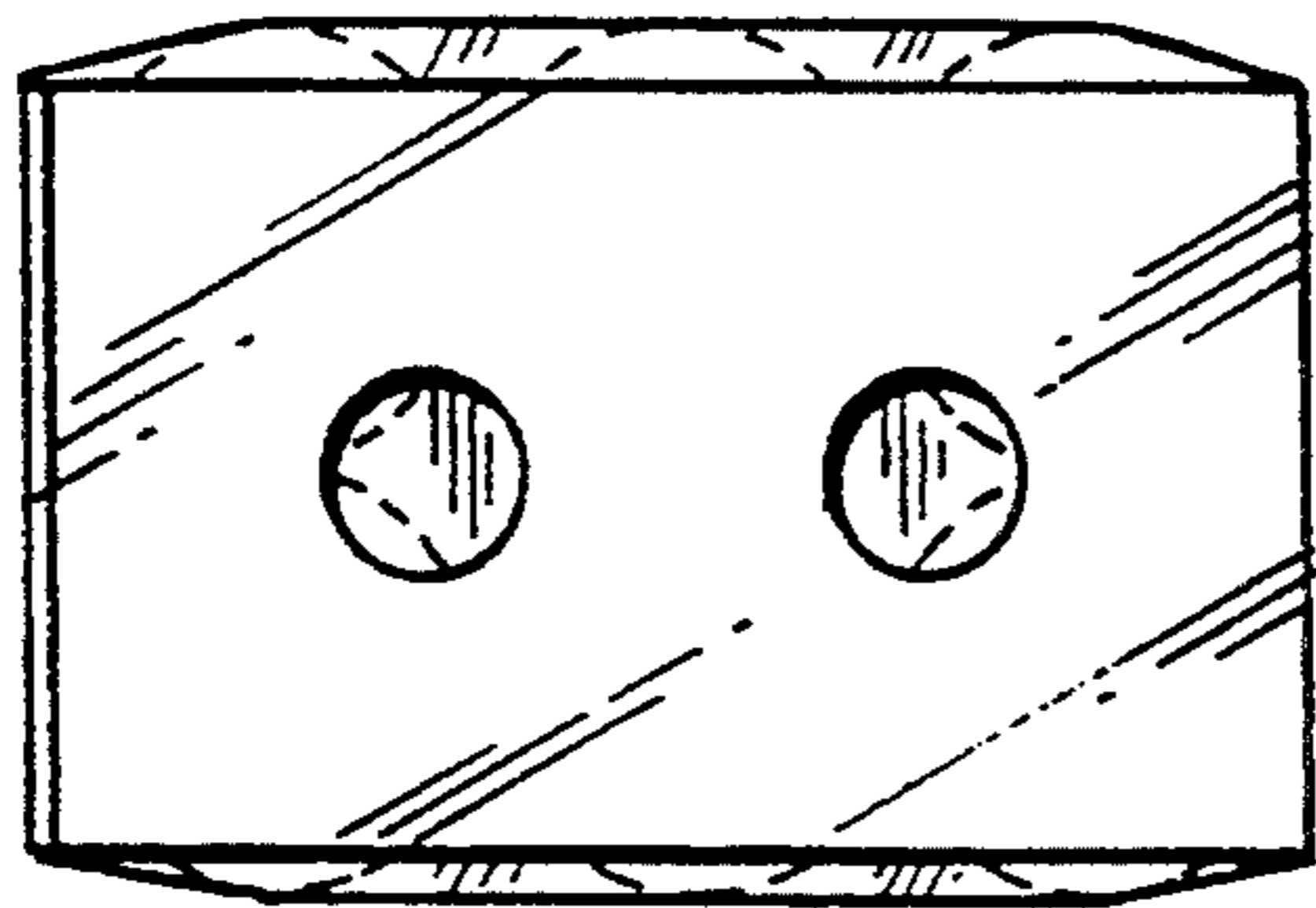

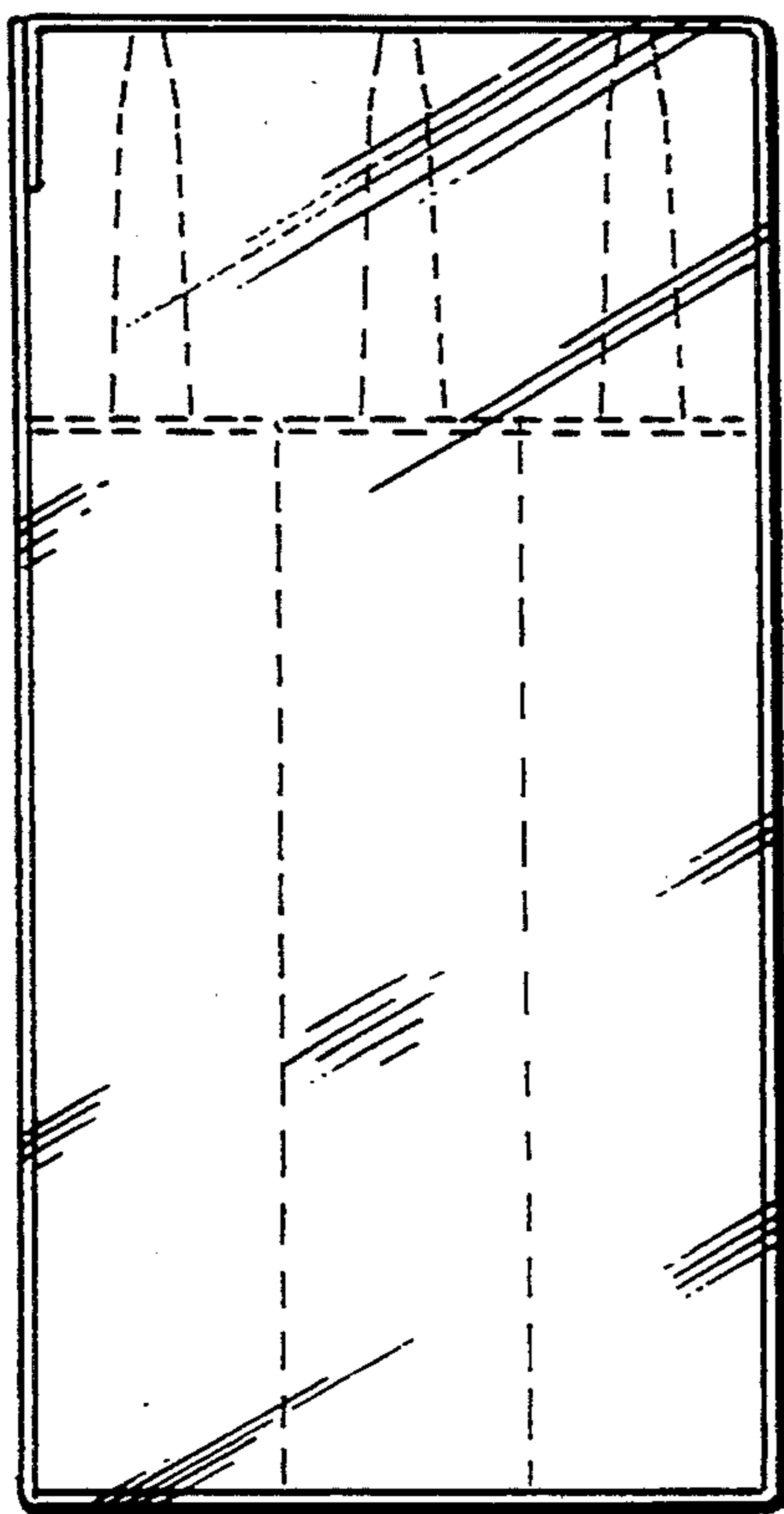

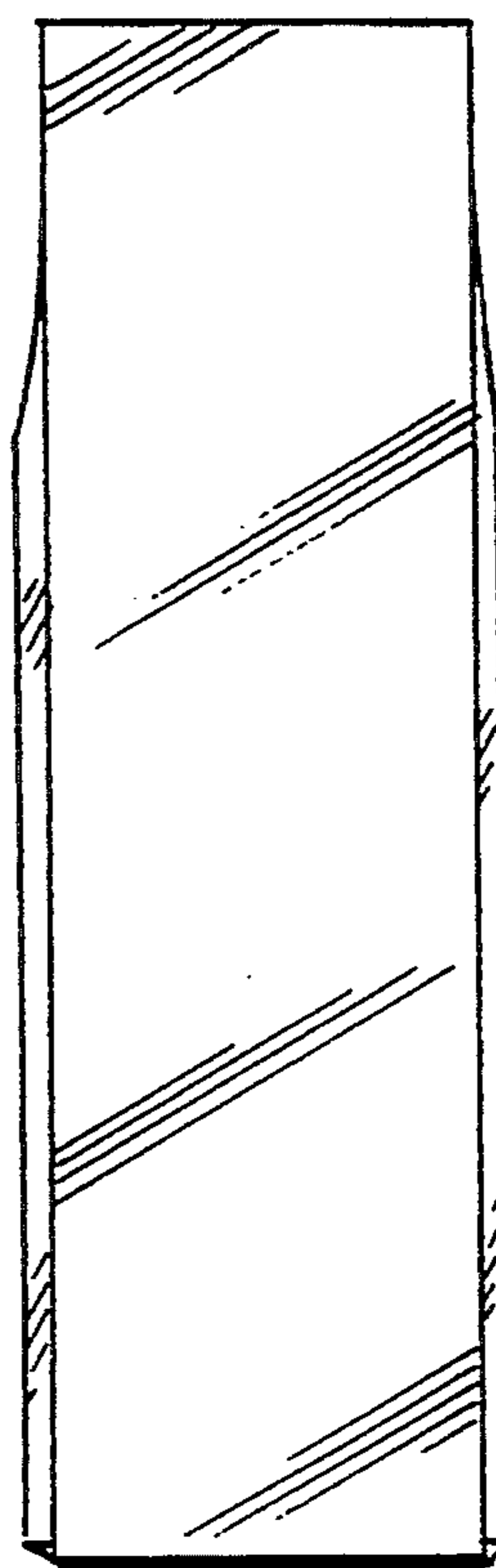

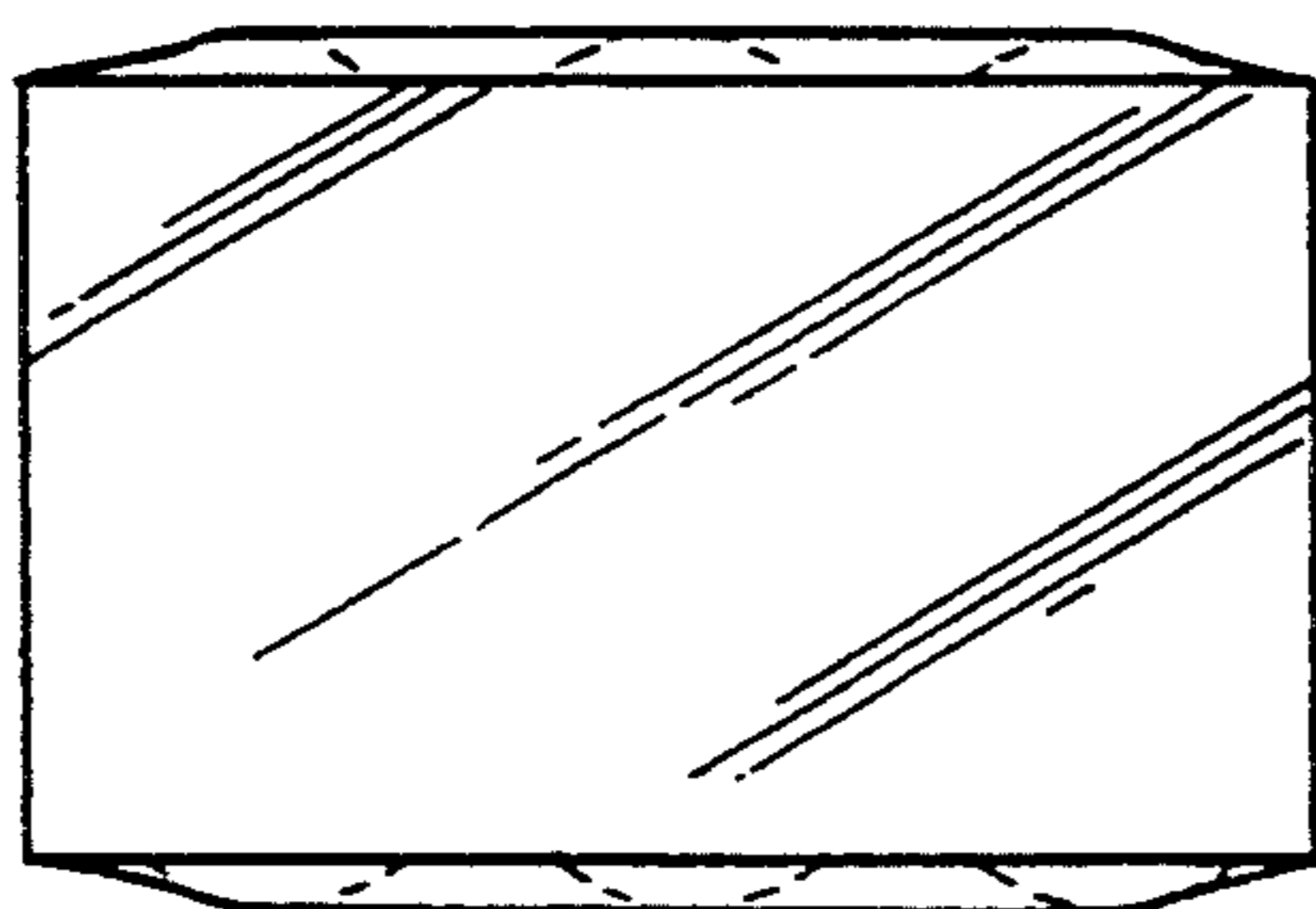
