The ornamental design for a paper towel holder, as shown and described.

DESCRIPTION

FIG. 1 is a top left front perspective view of a paper towel holder showing my new design. The broken lines are for illustrative purposes only and form no part of the claimed design;

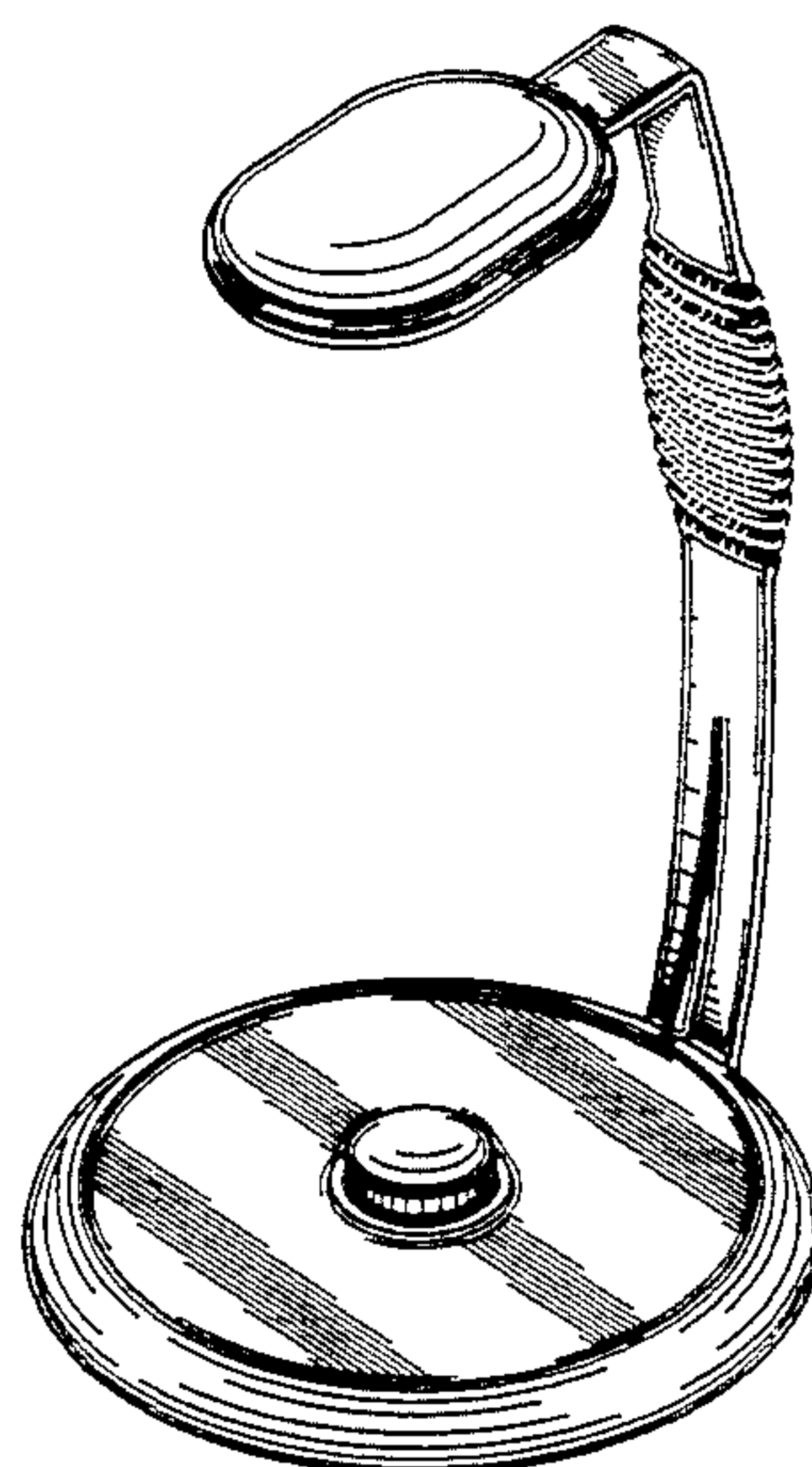
FIG. 2 is a right side elevational view thereof; the left side elevational view being a mirror image;

FIG. 6 is a top plan view thereof.



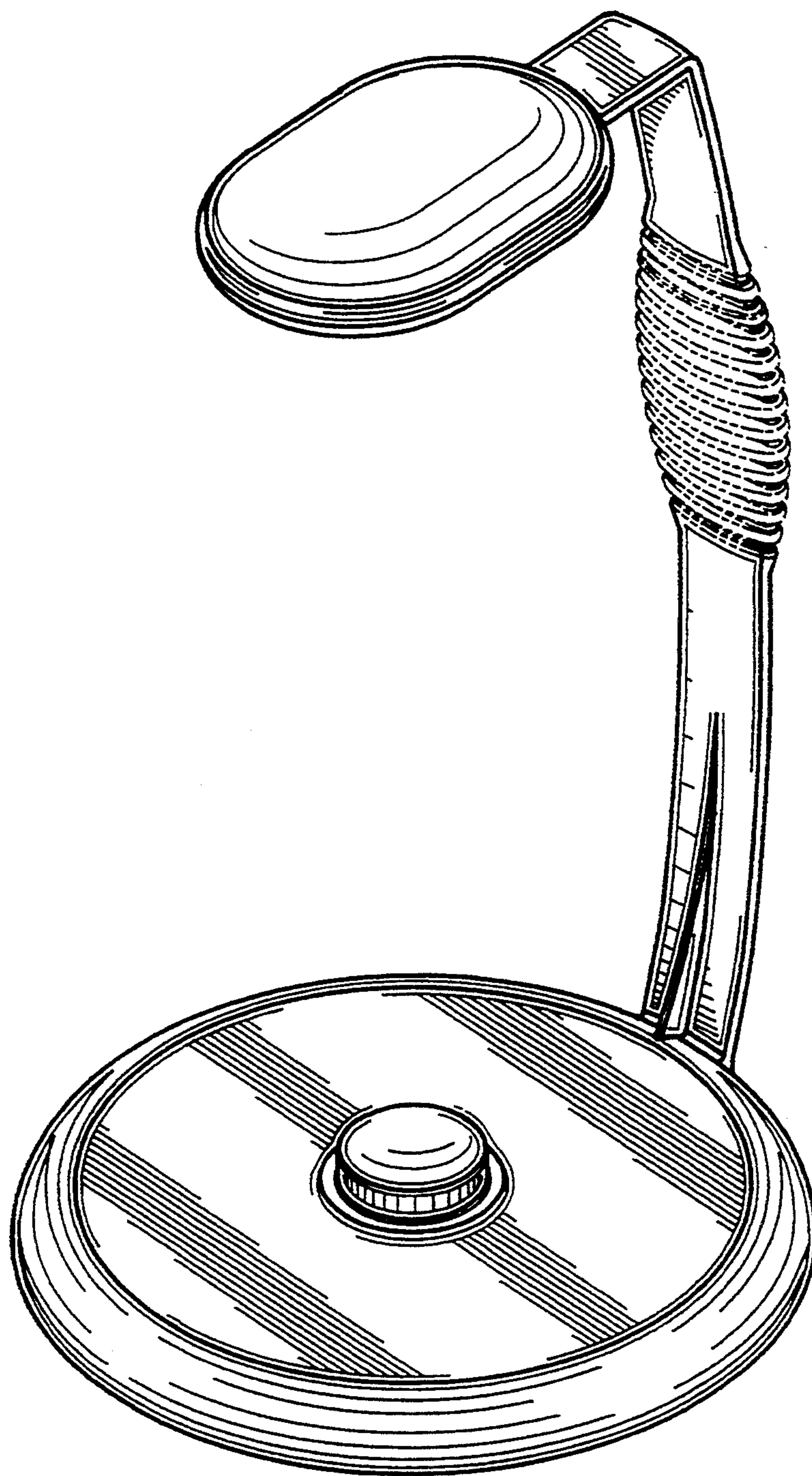

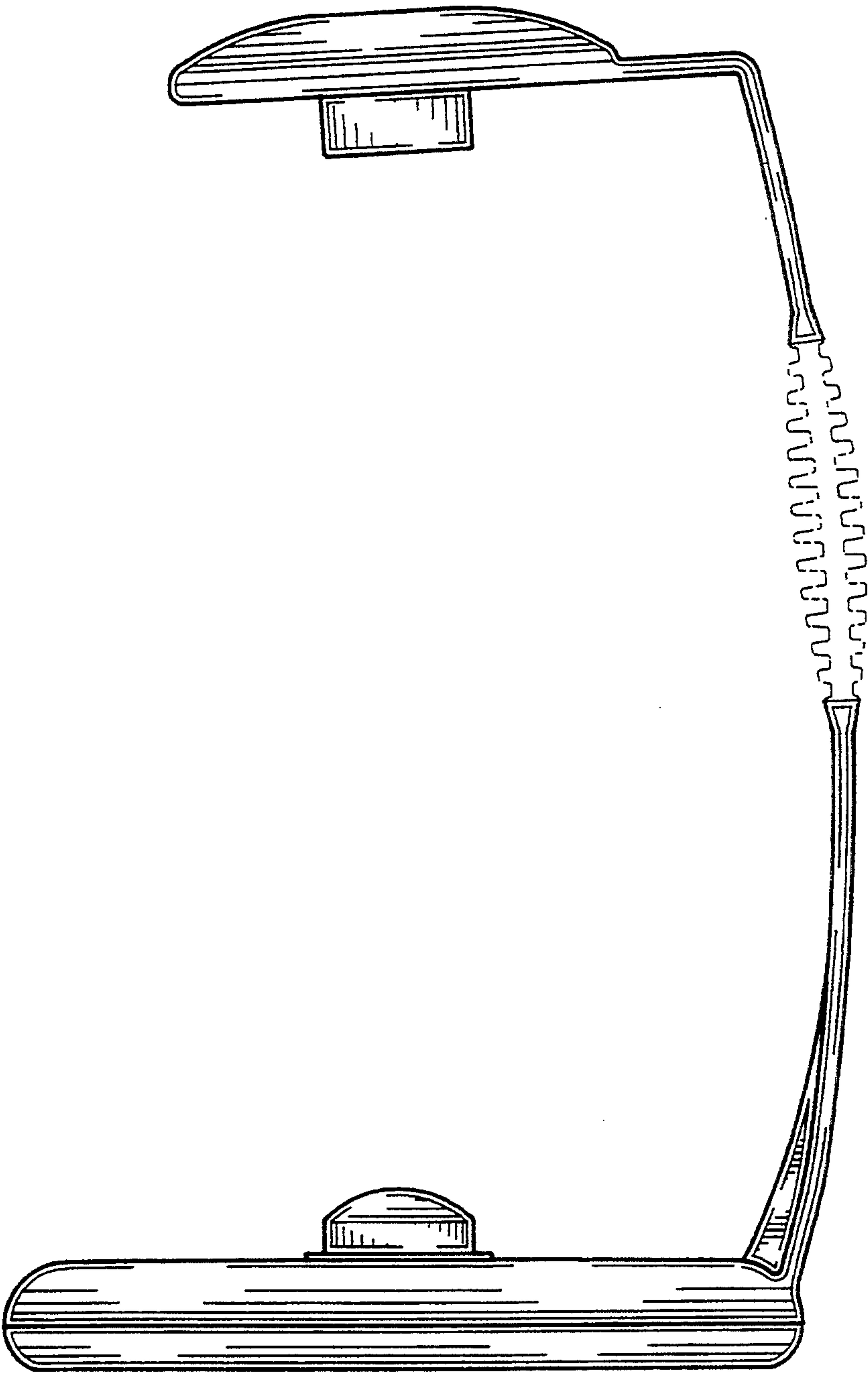

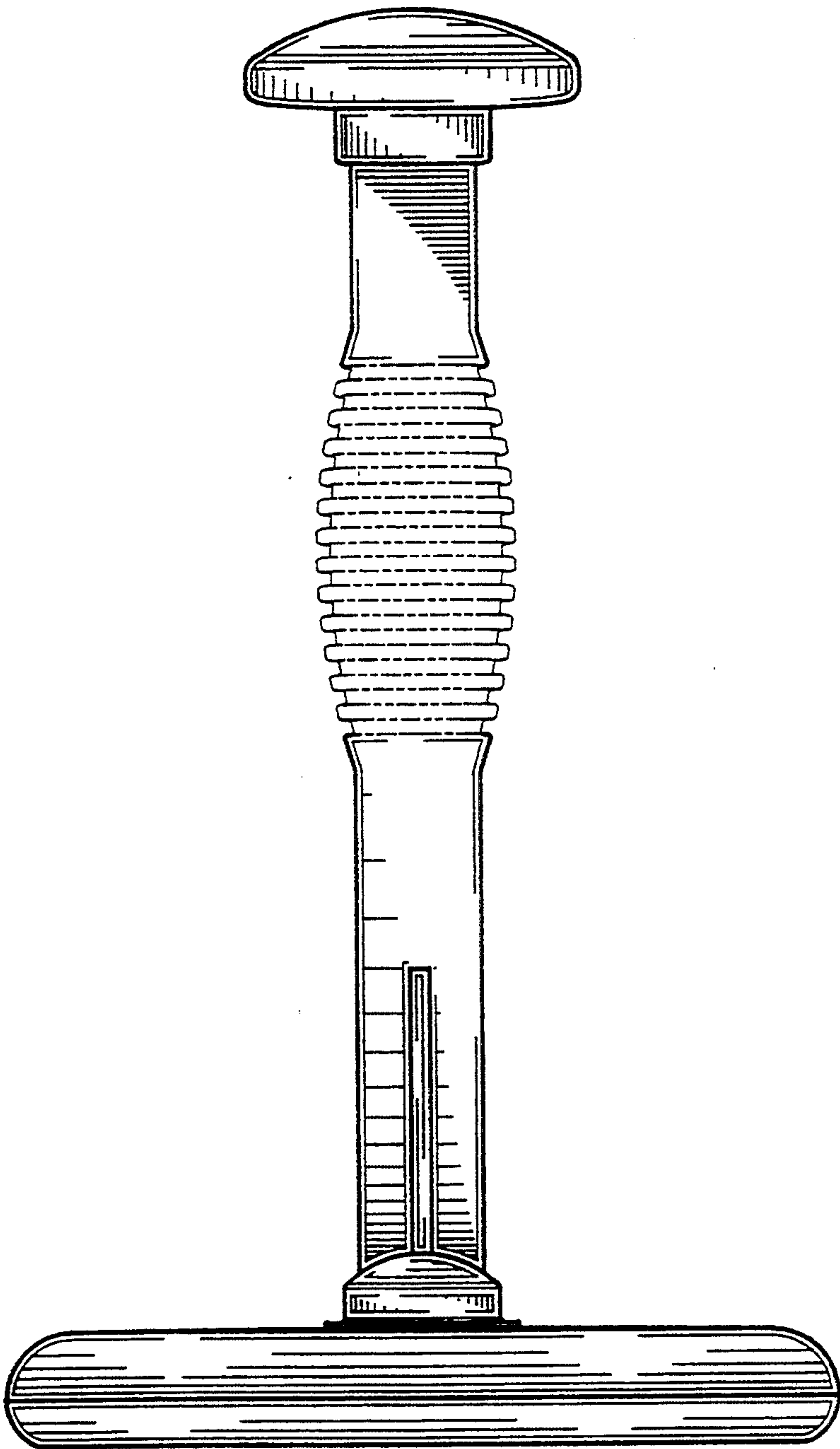

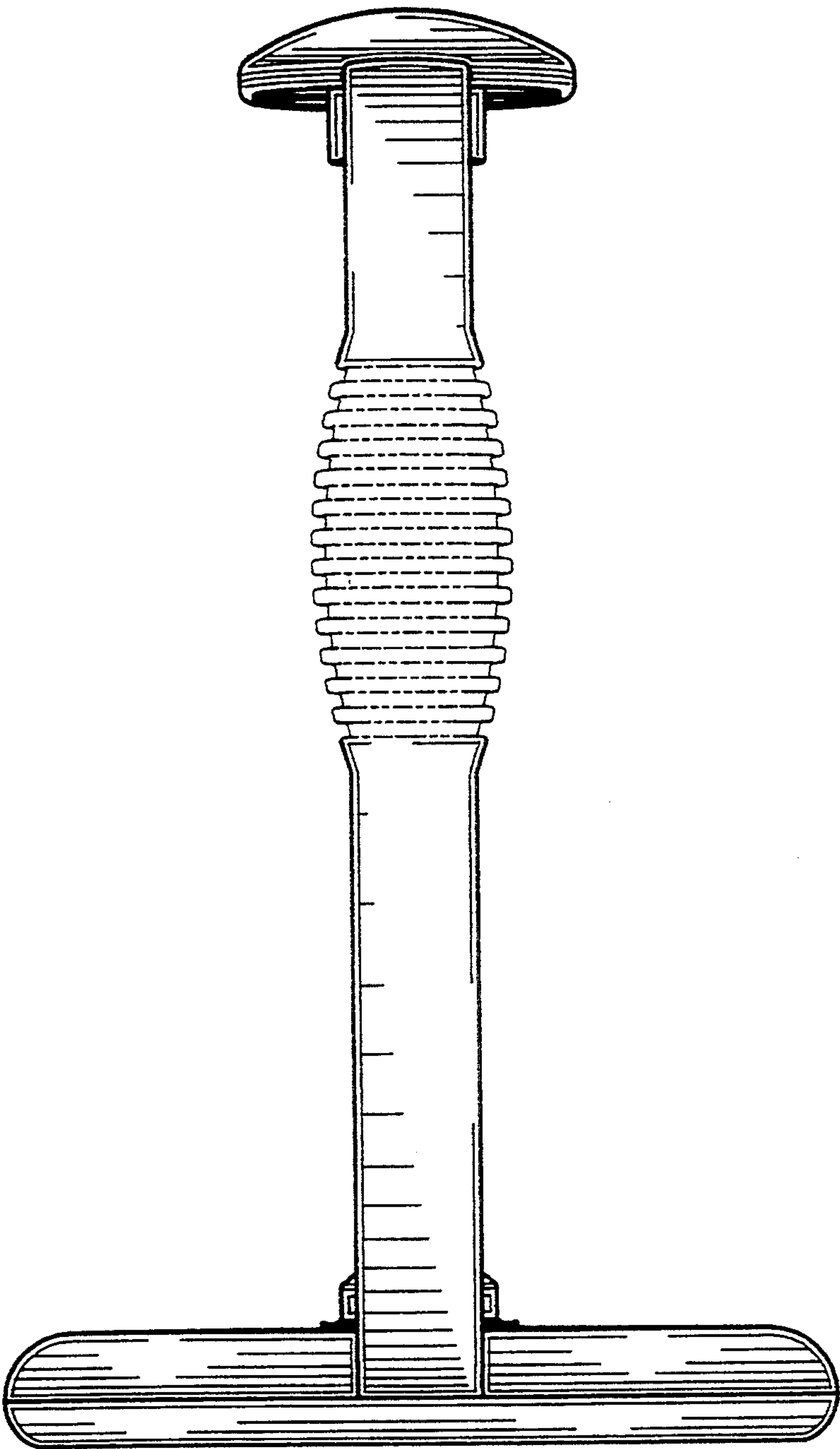

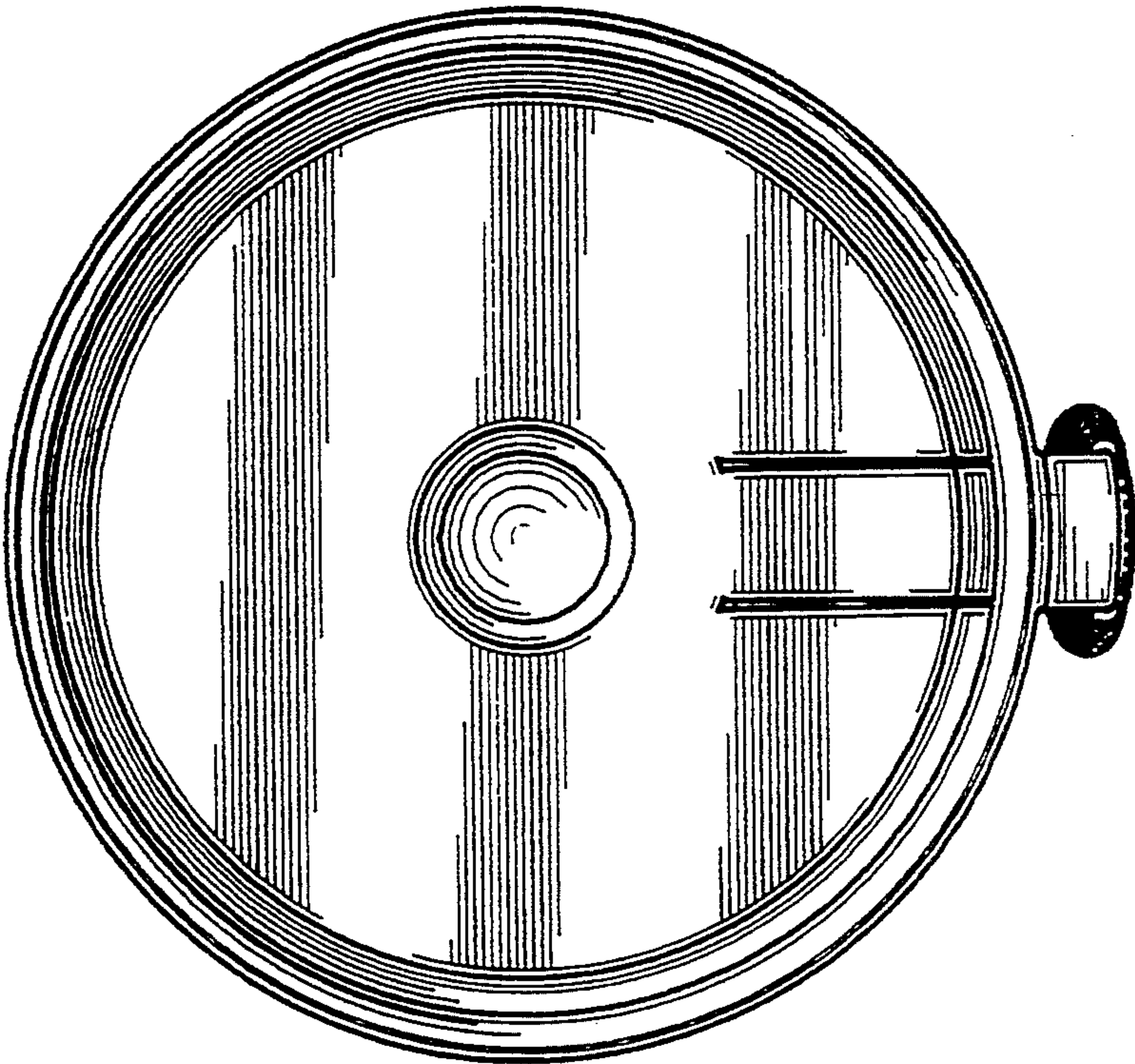

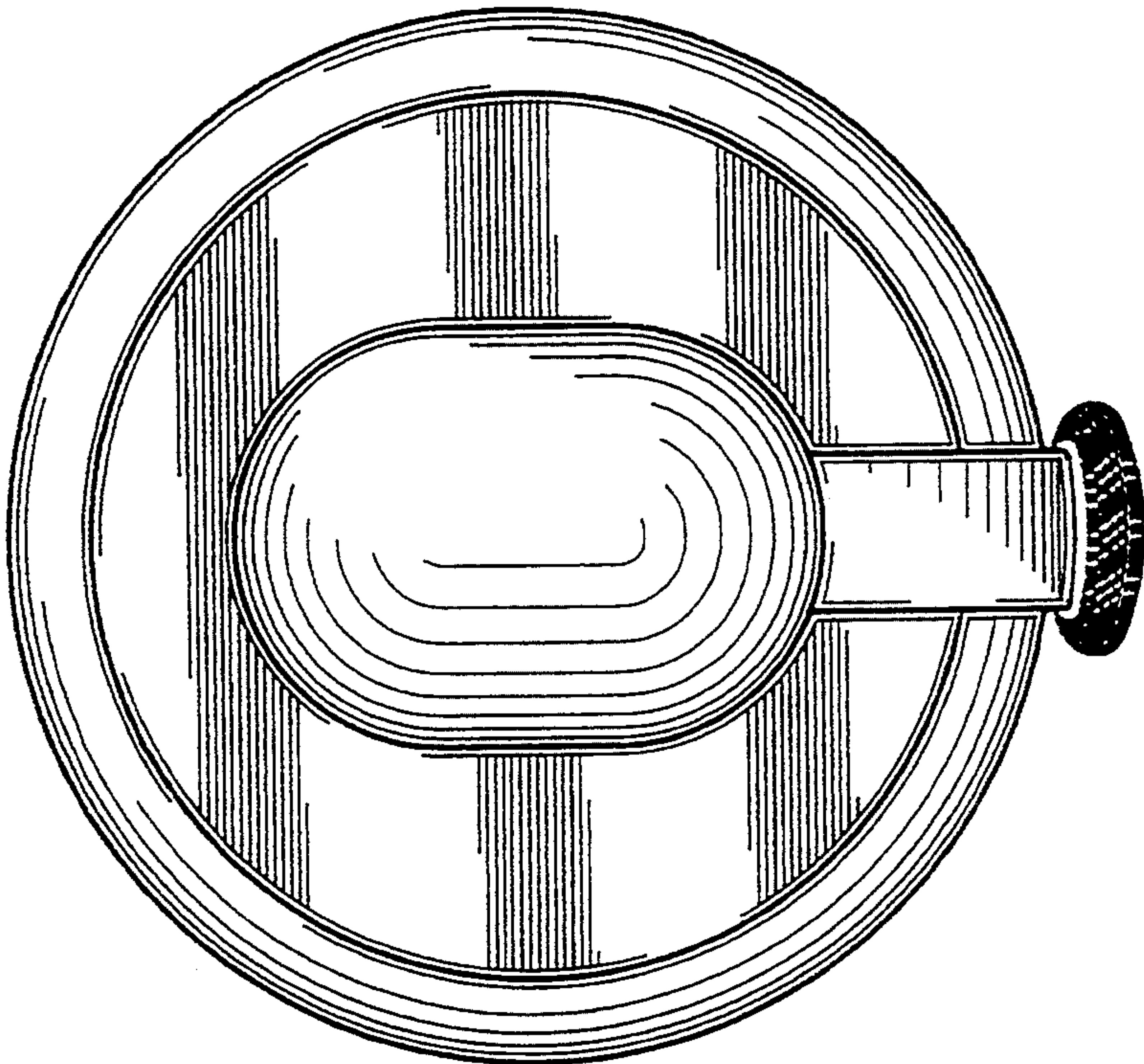
