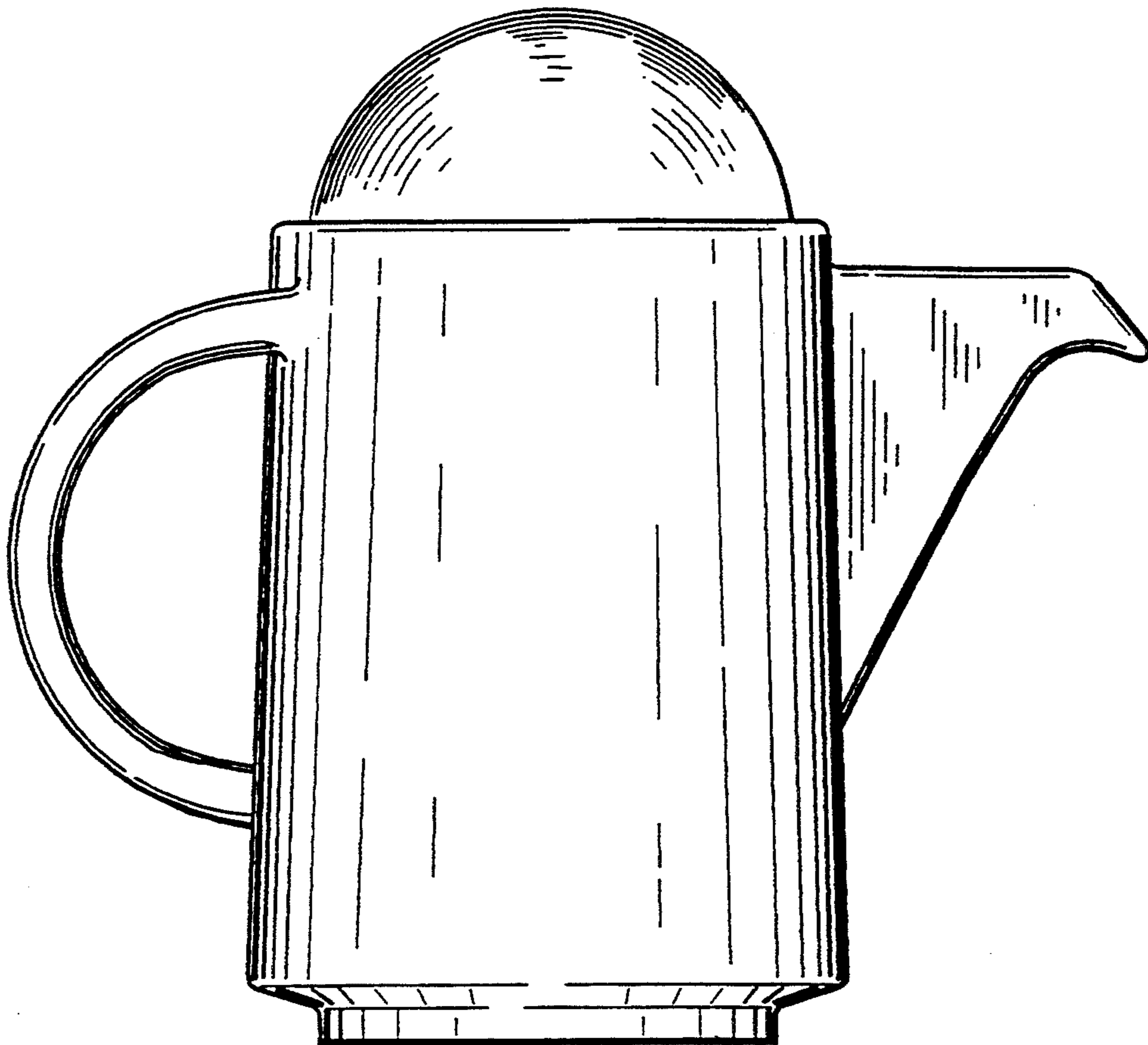

opposite side view being a mirror image.



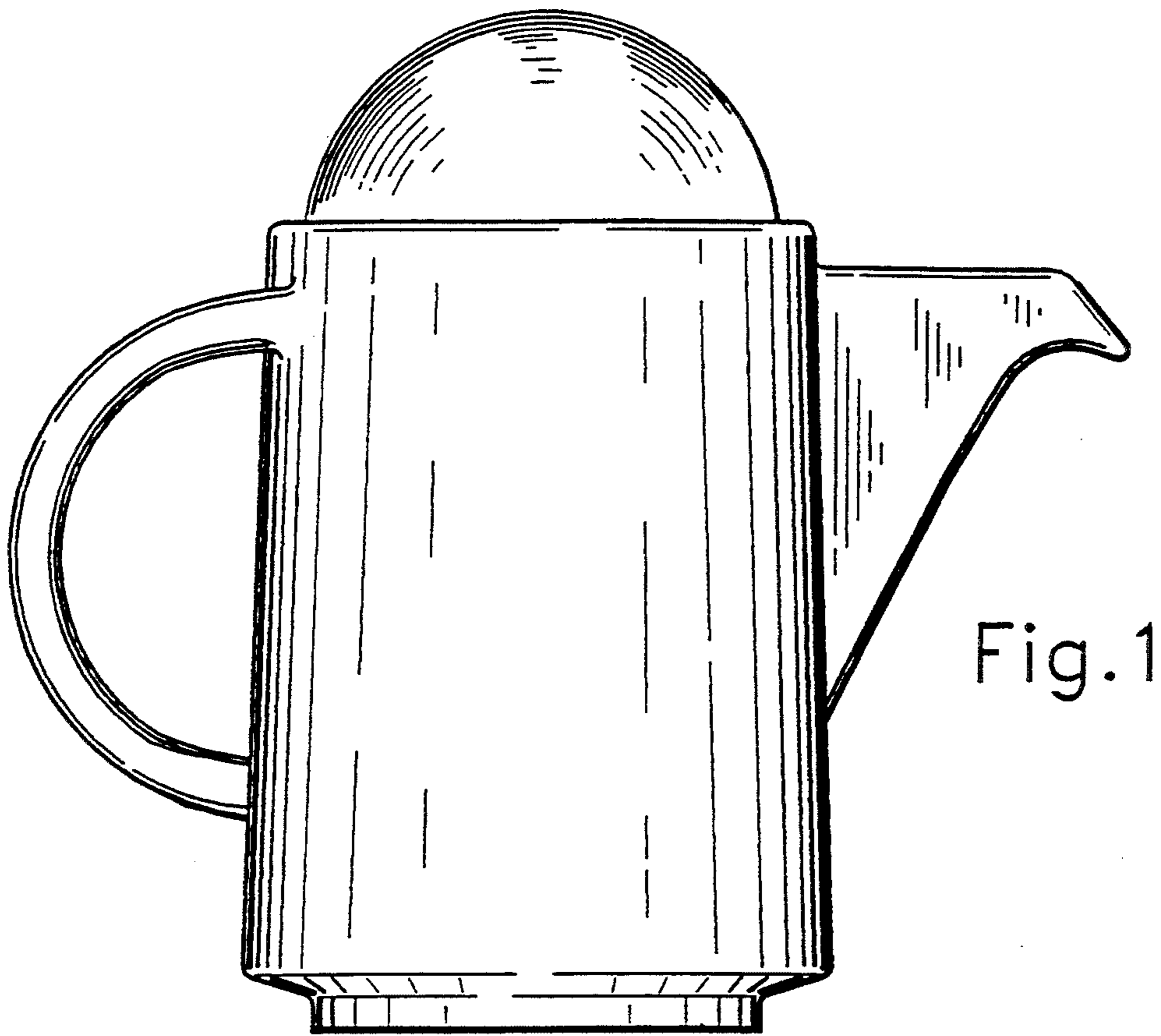

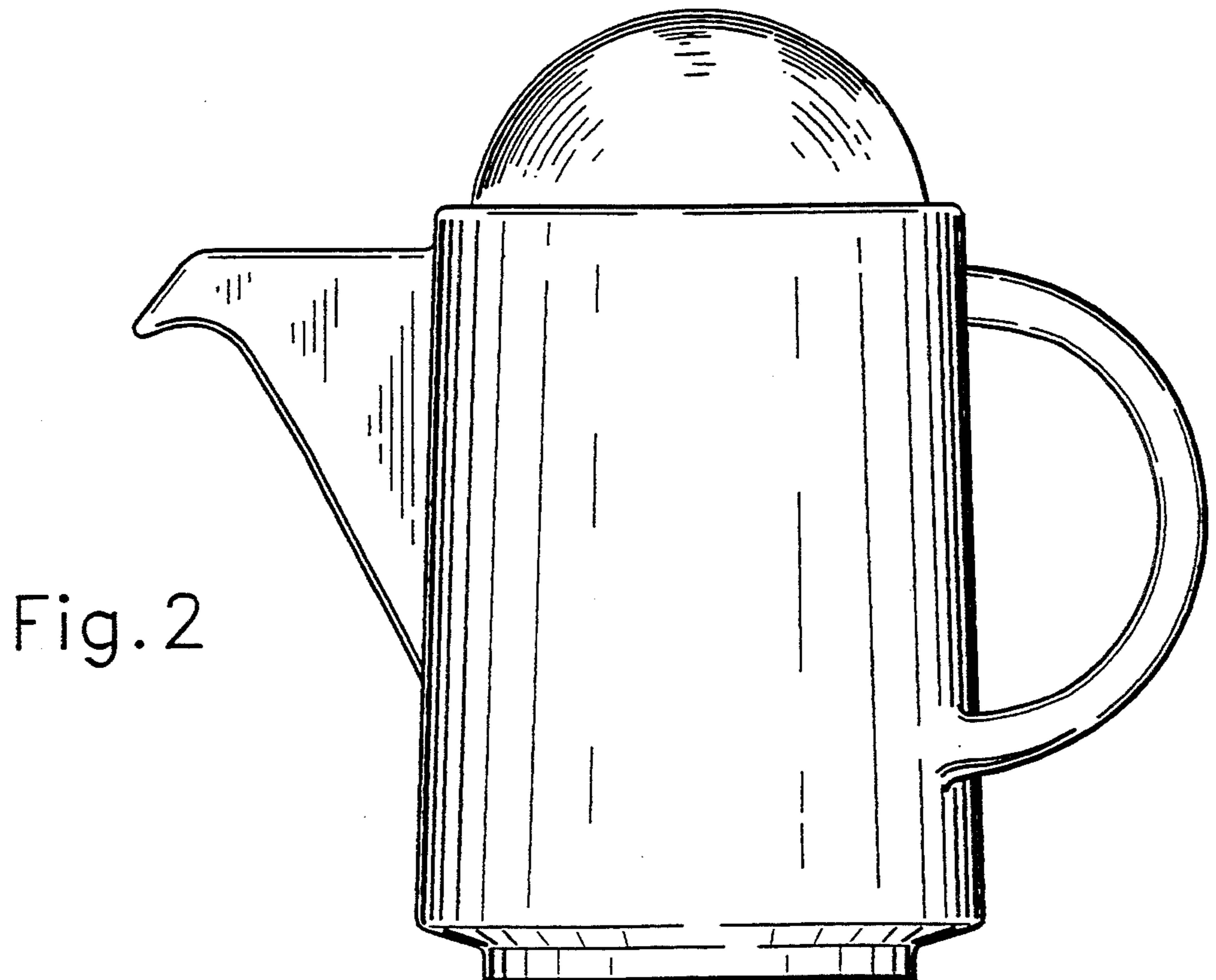

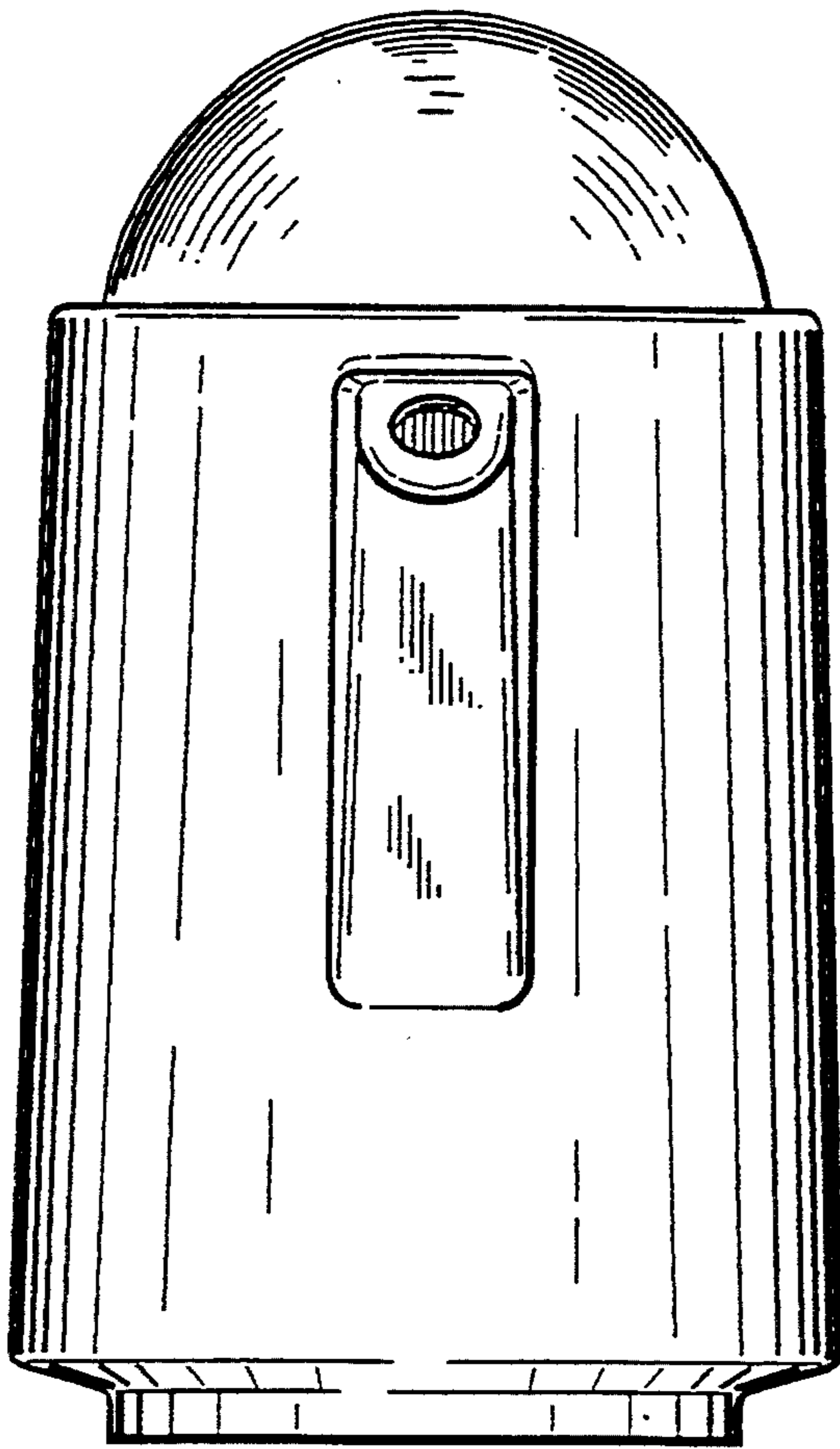

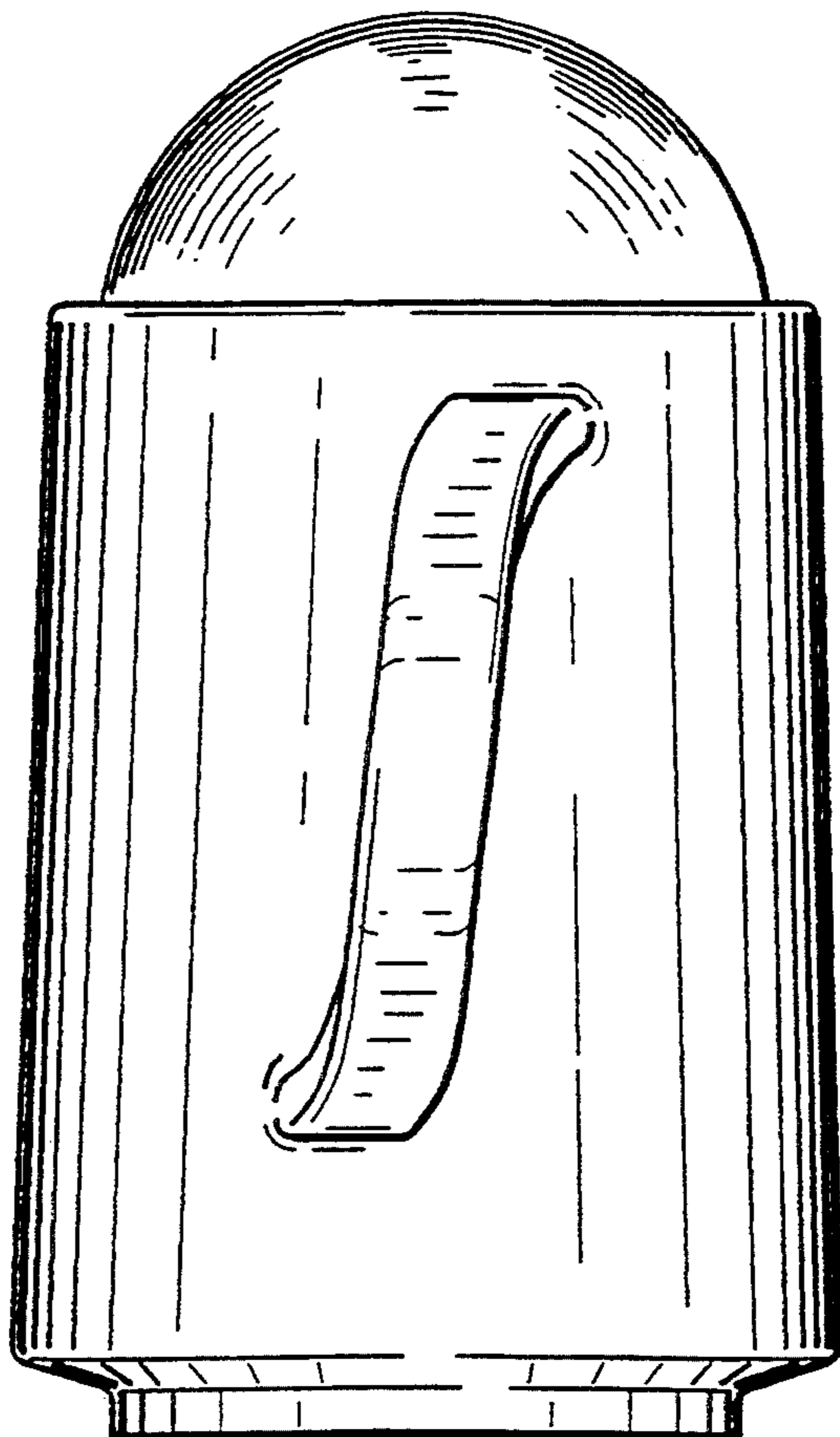

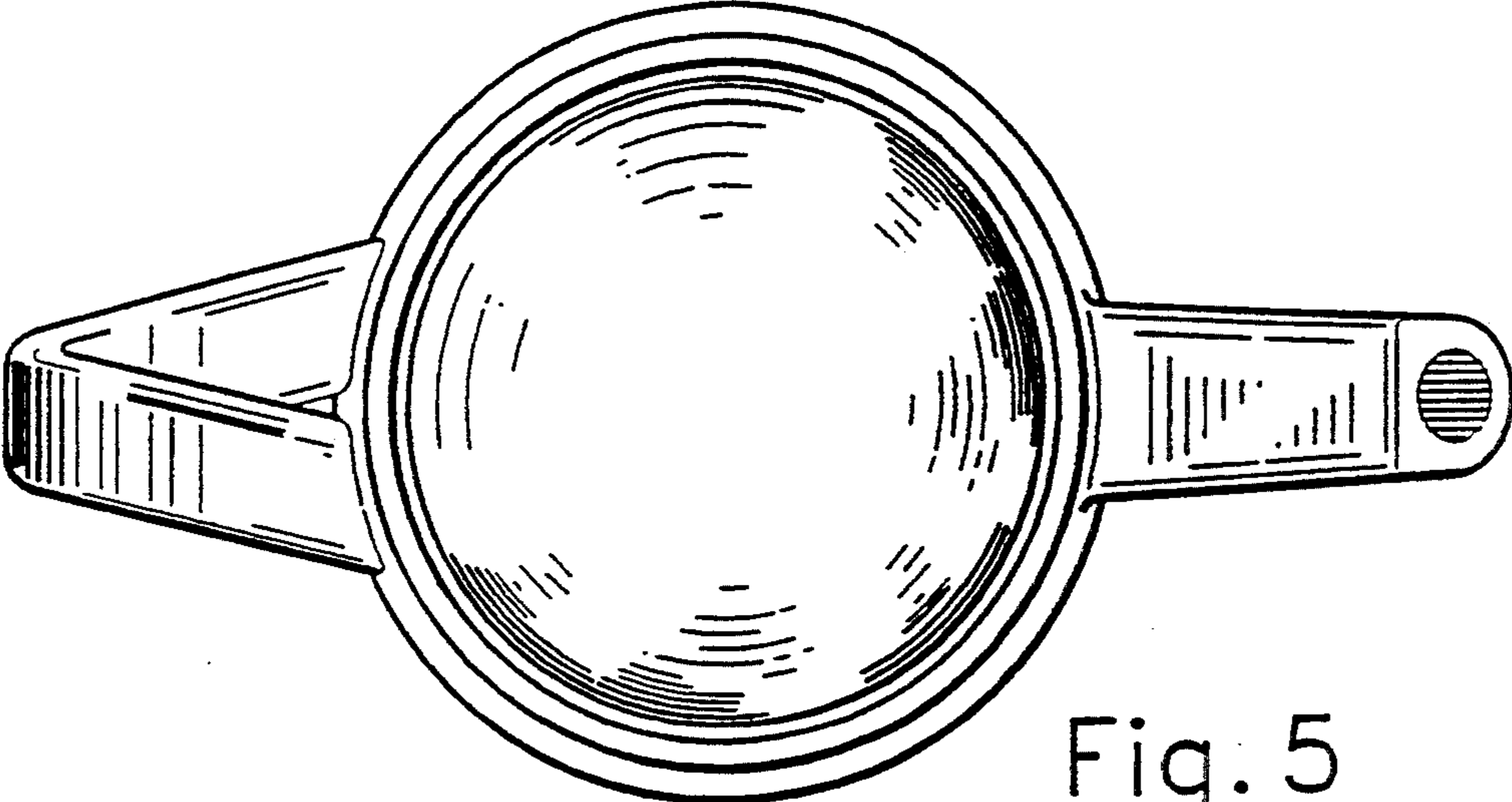

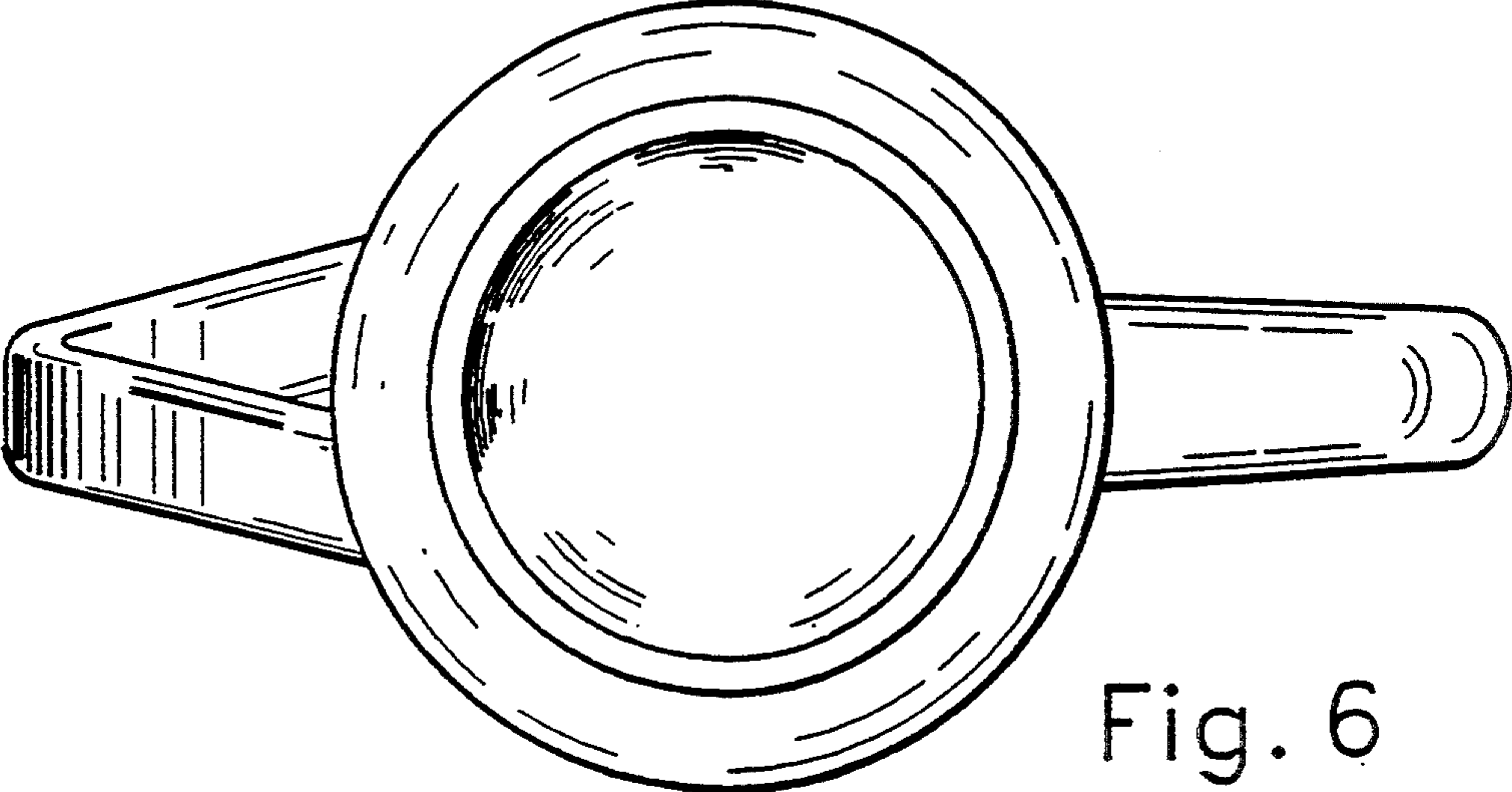

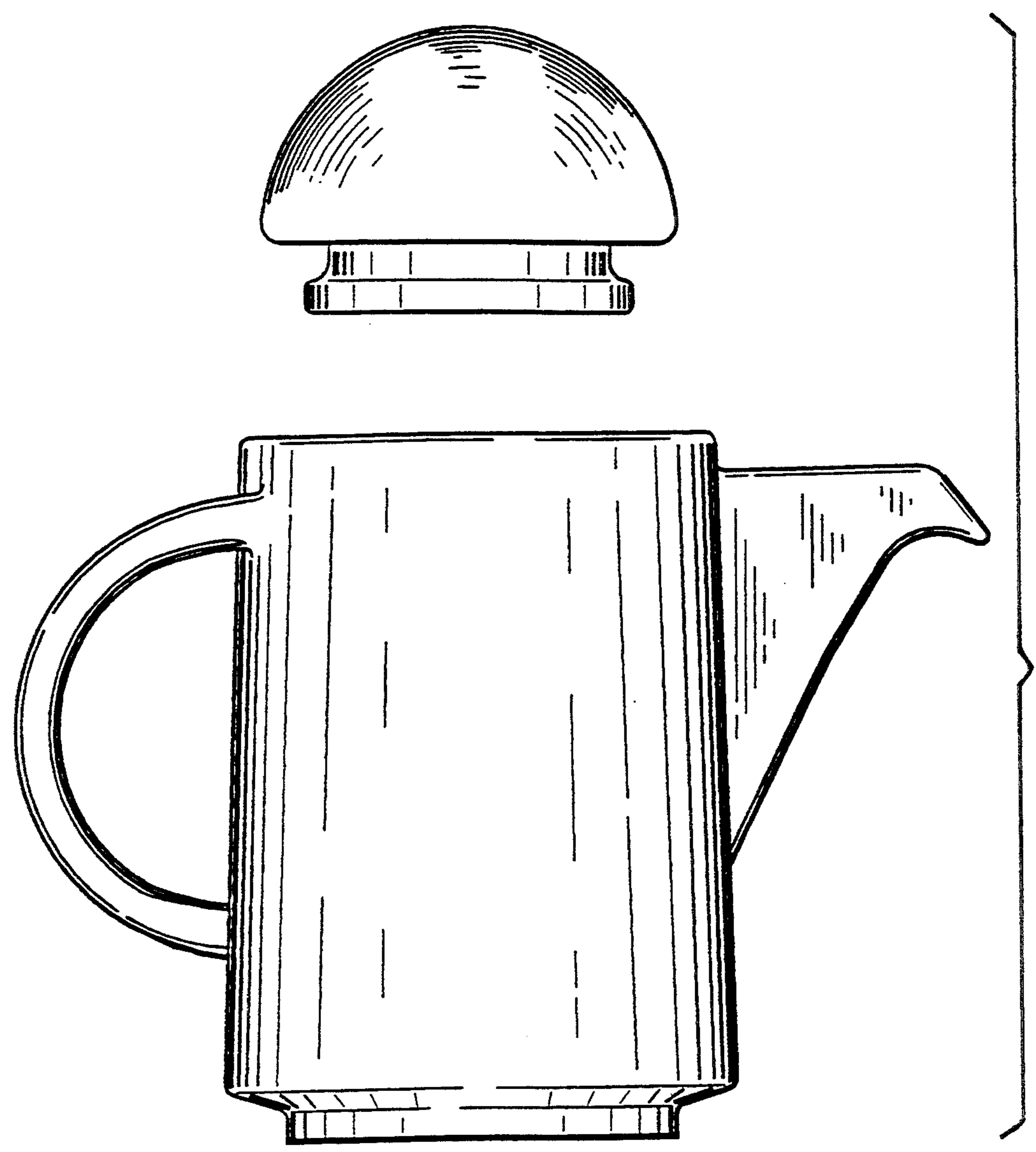
