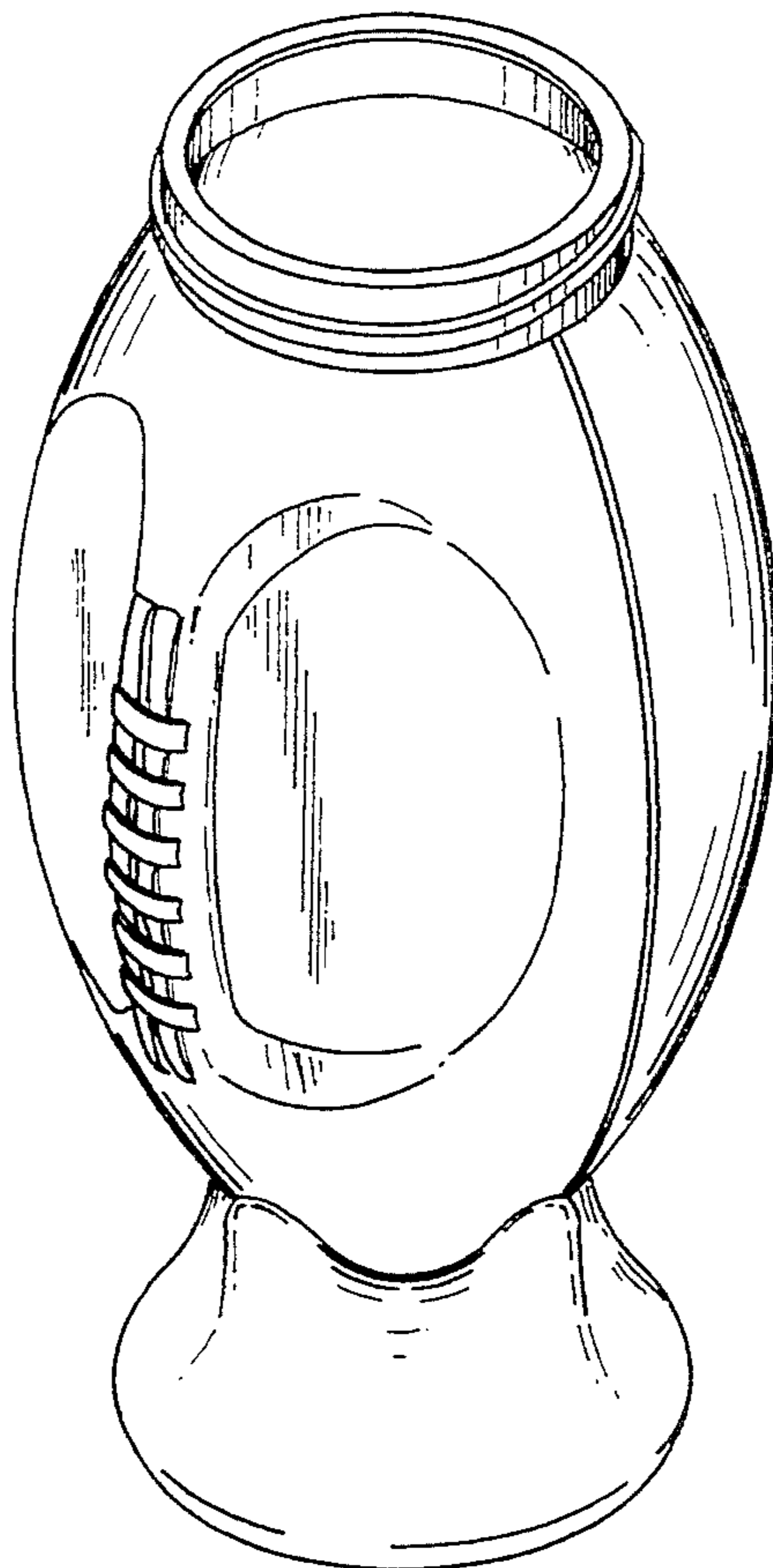

DESCRIPTION

FIG. 1 is an upper rear perspective view of the drink container of this invention;

 FIG. 7 is a bottom plan view thereof.



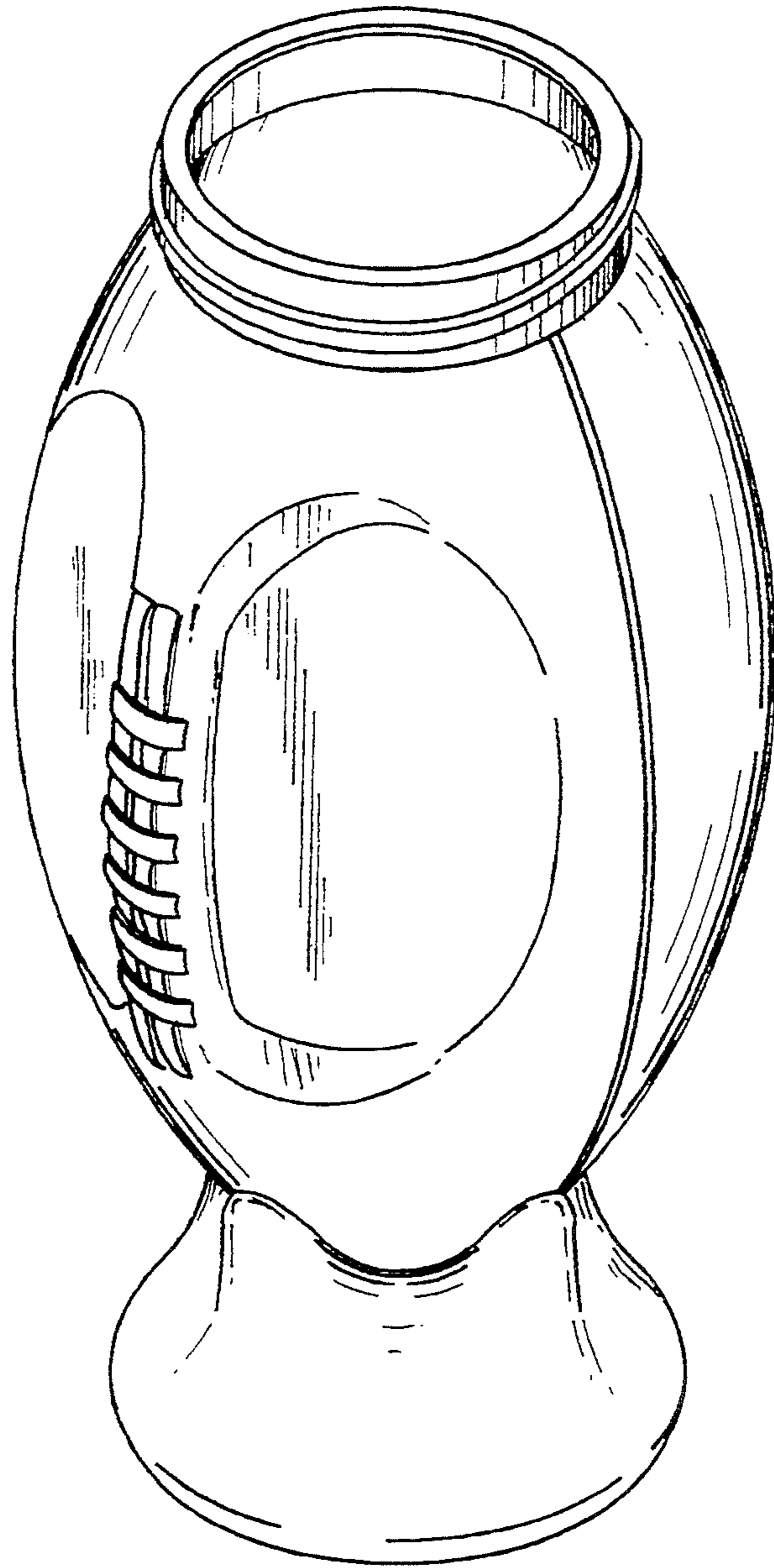

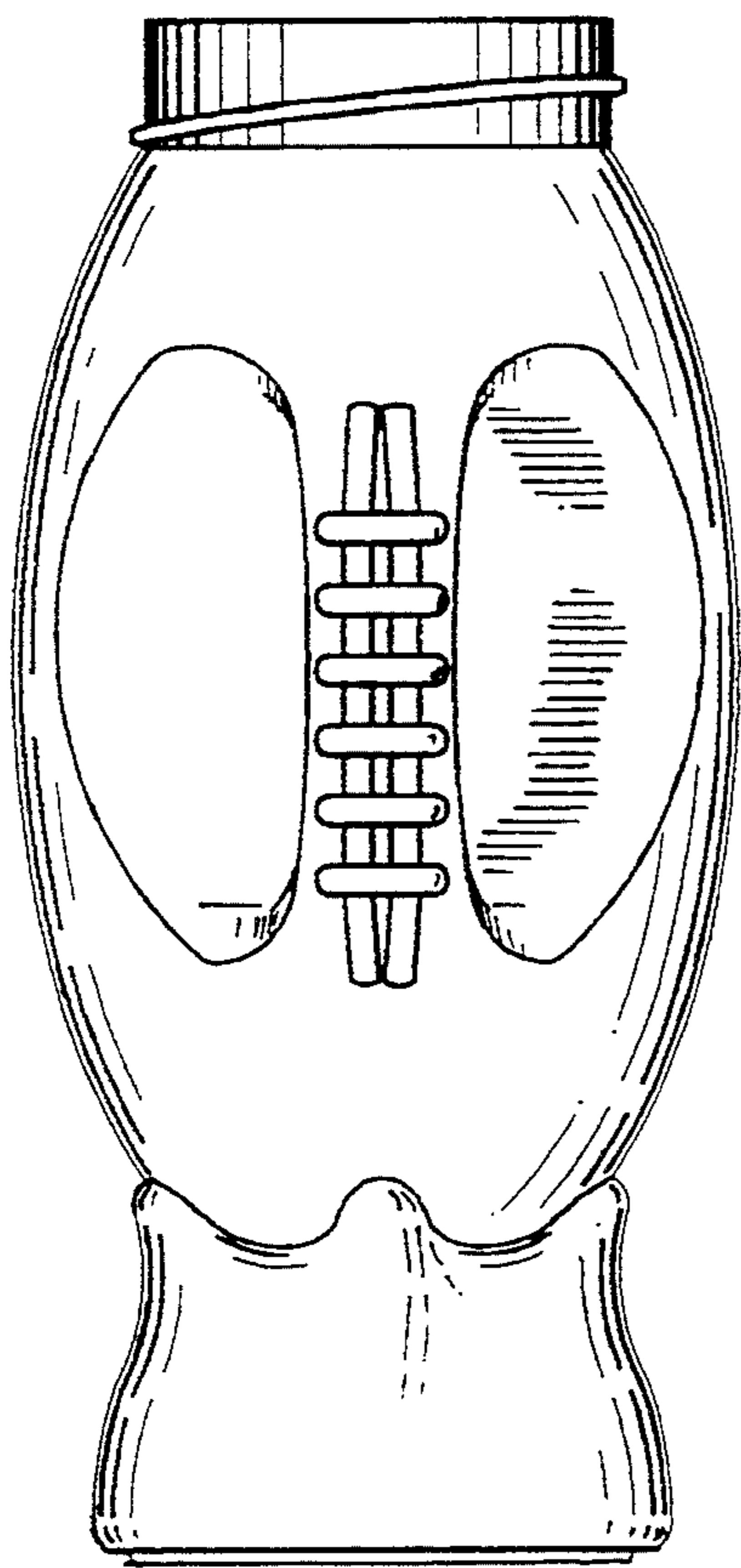

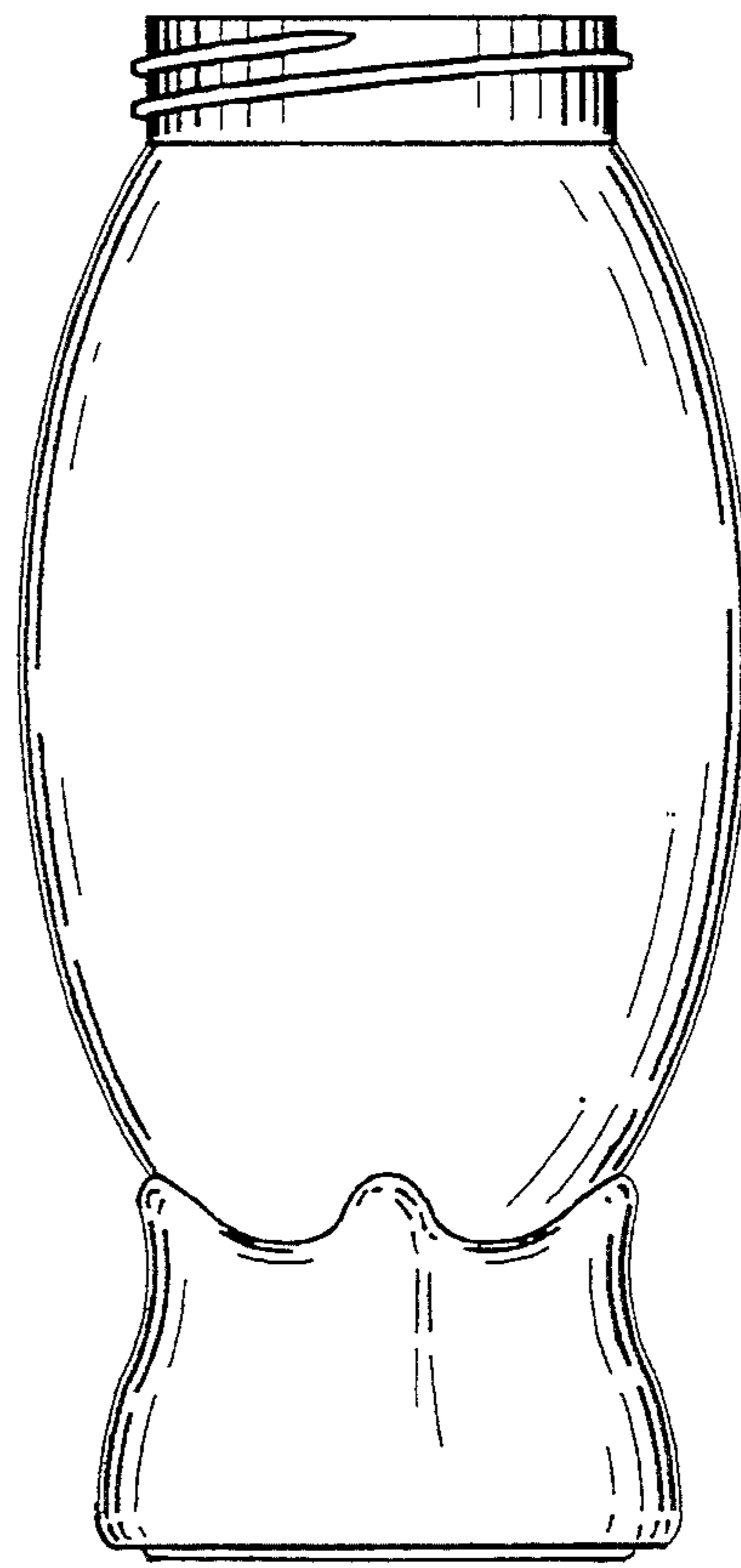

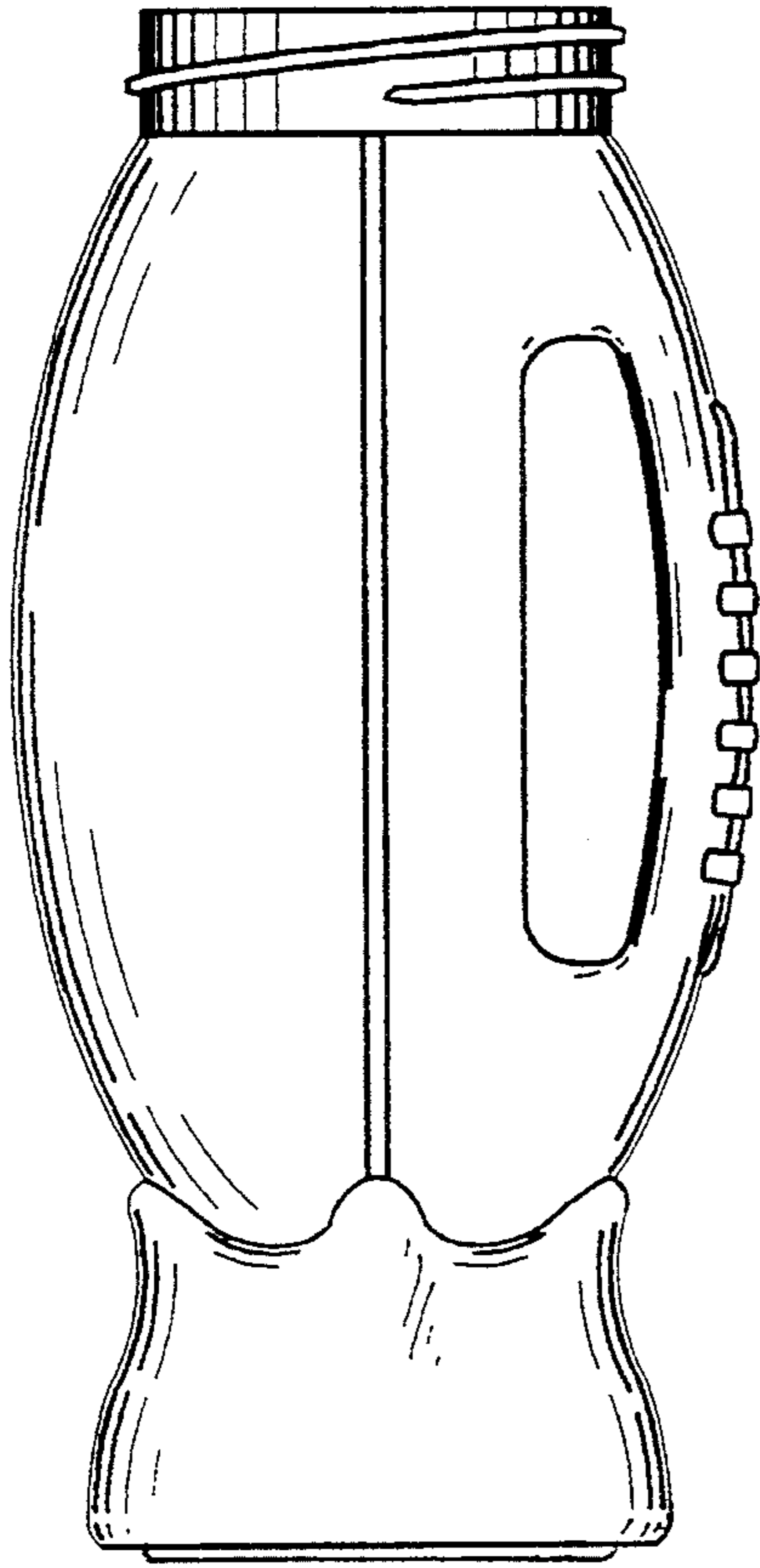

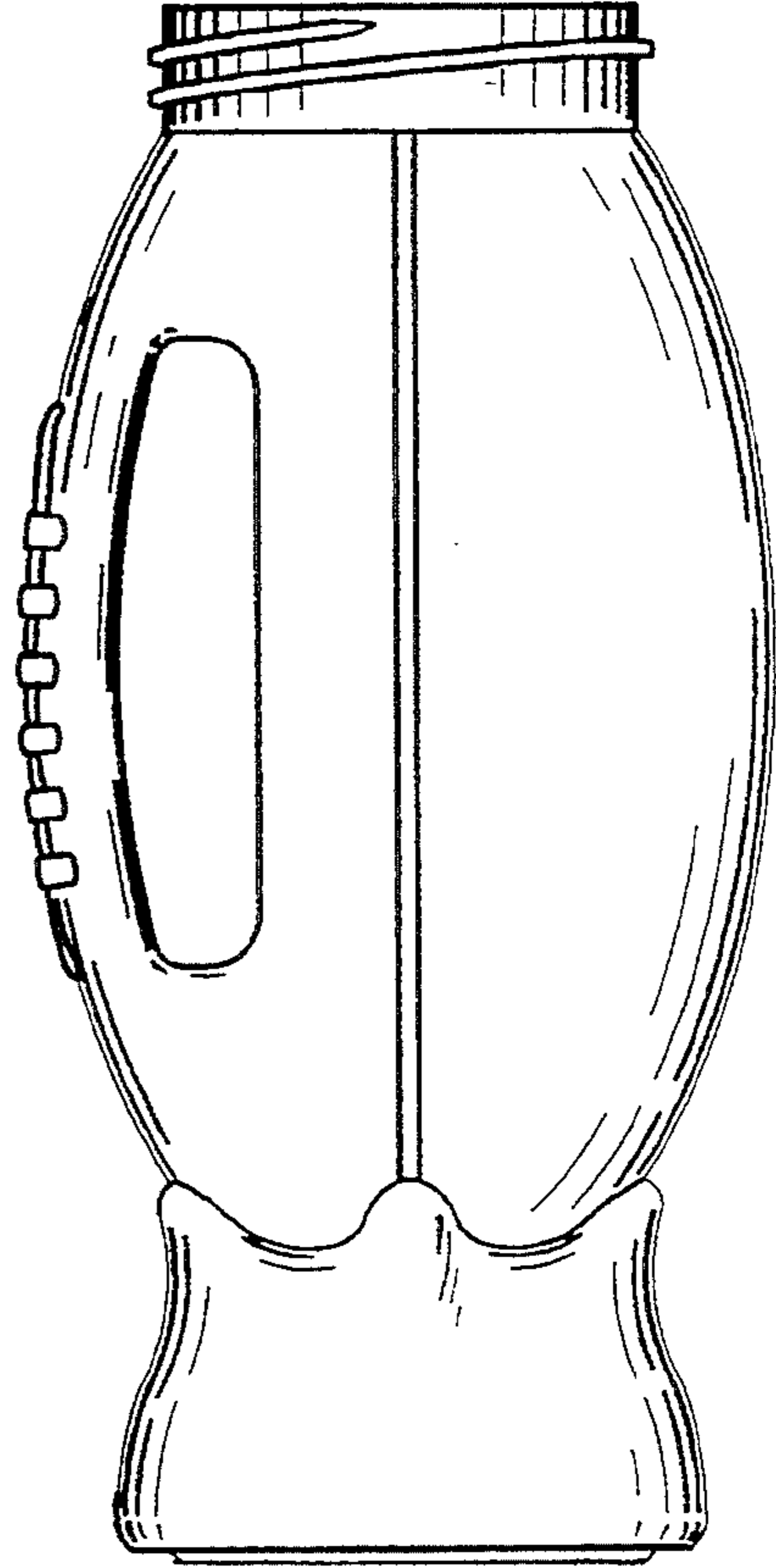

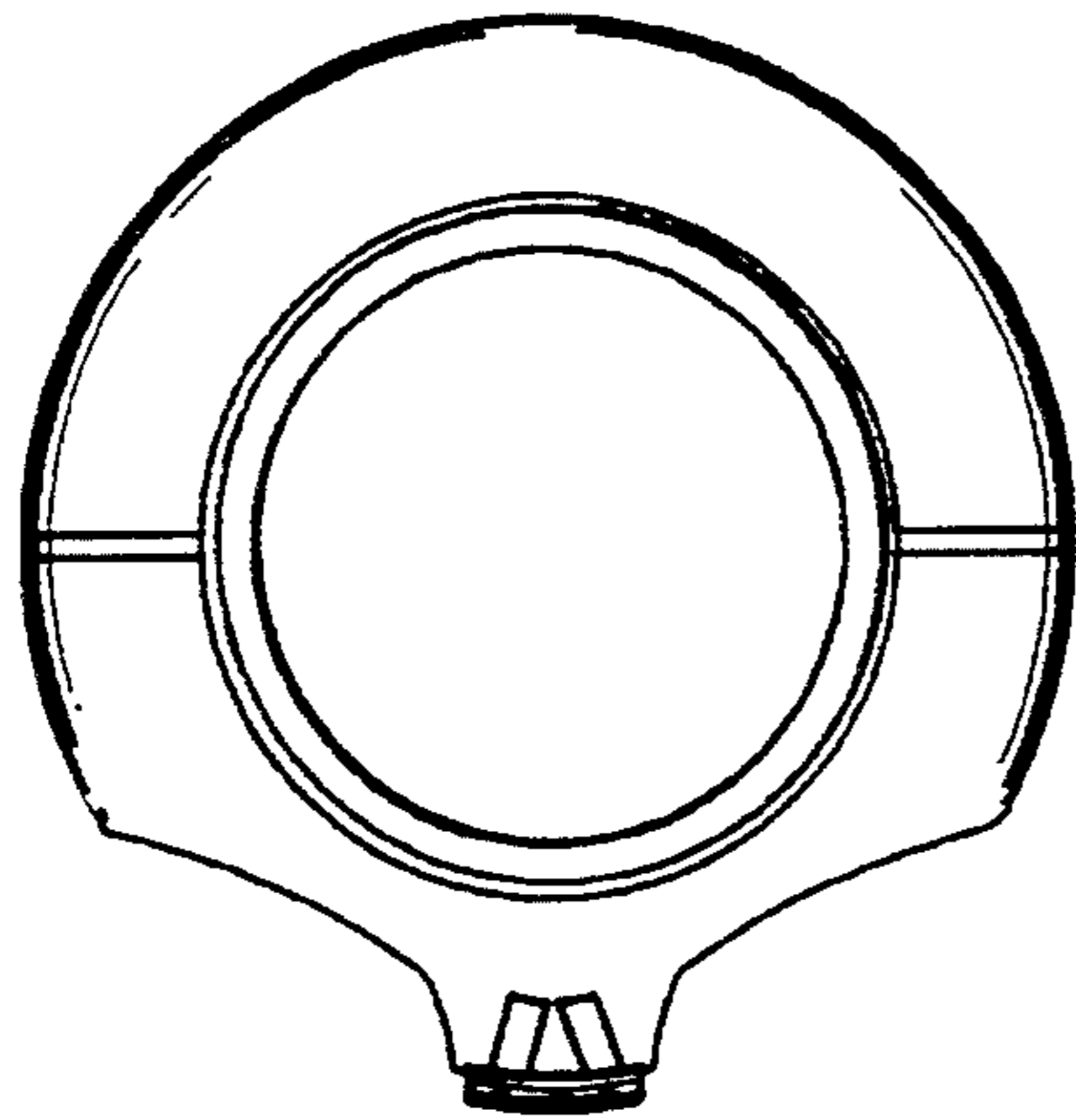

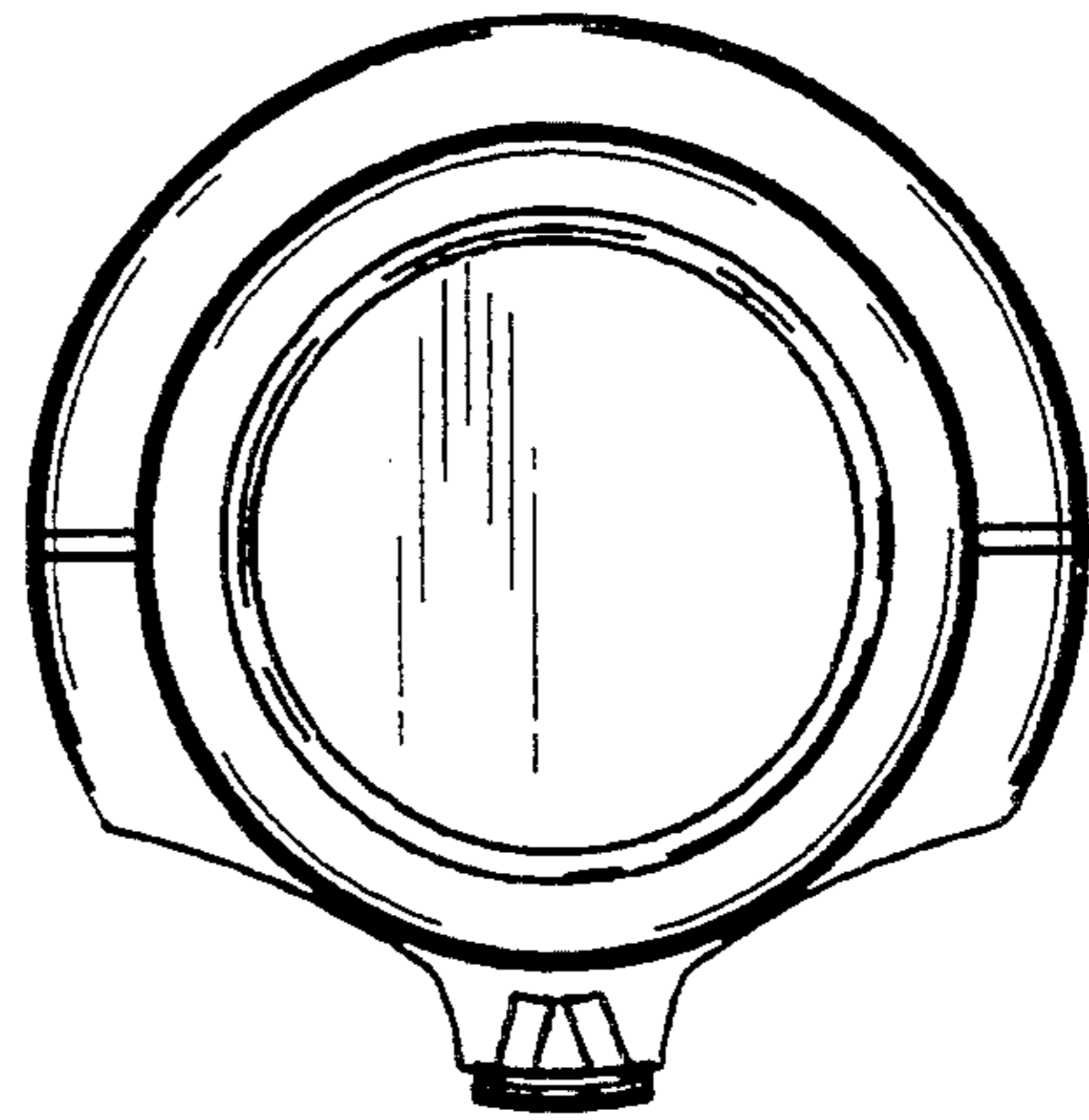
