[57] The ornamental design for a socket, as shown and described.

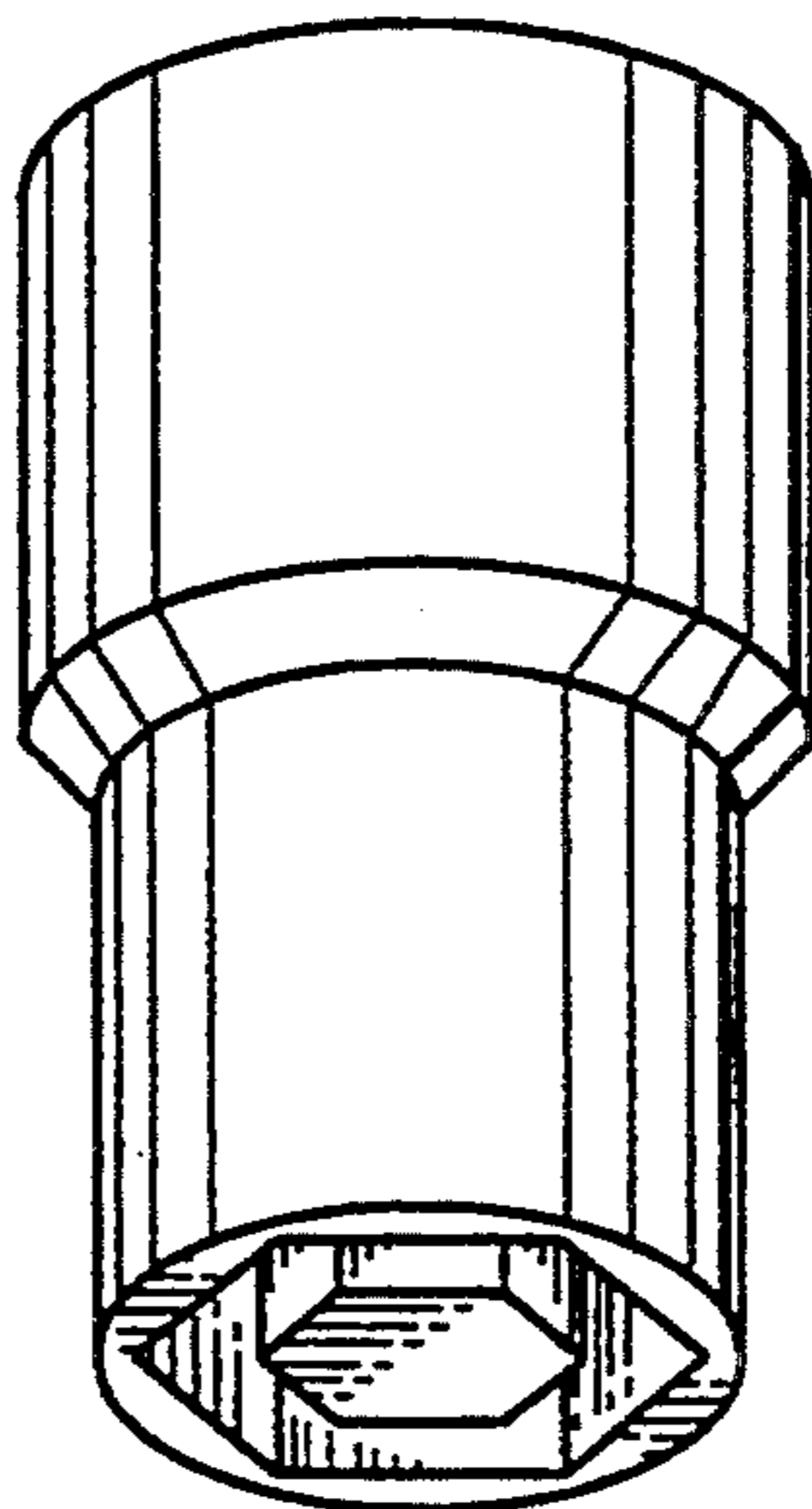
### DESCRIPTION

FIG. 1 is a perspective view of a socket in accordance with the present design;

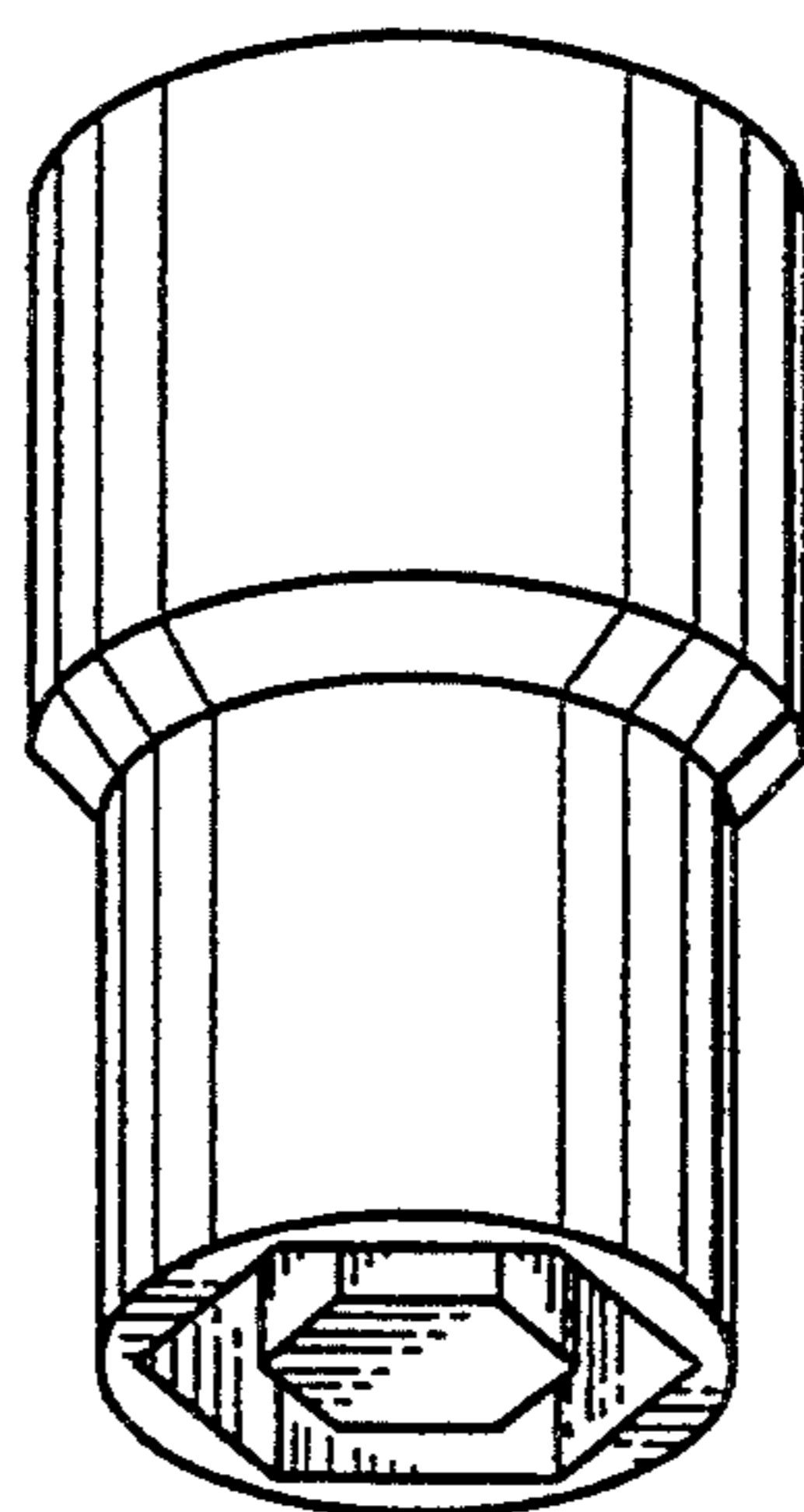
FIG. 2 is a top view of the socket illustrated in FIG. 1;

FIG. 3 is an elevational view of the socket illustrated in FIG. 1; and,

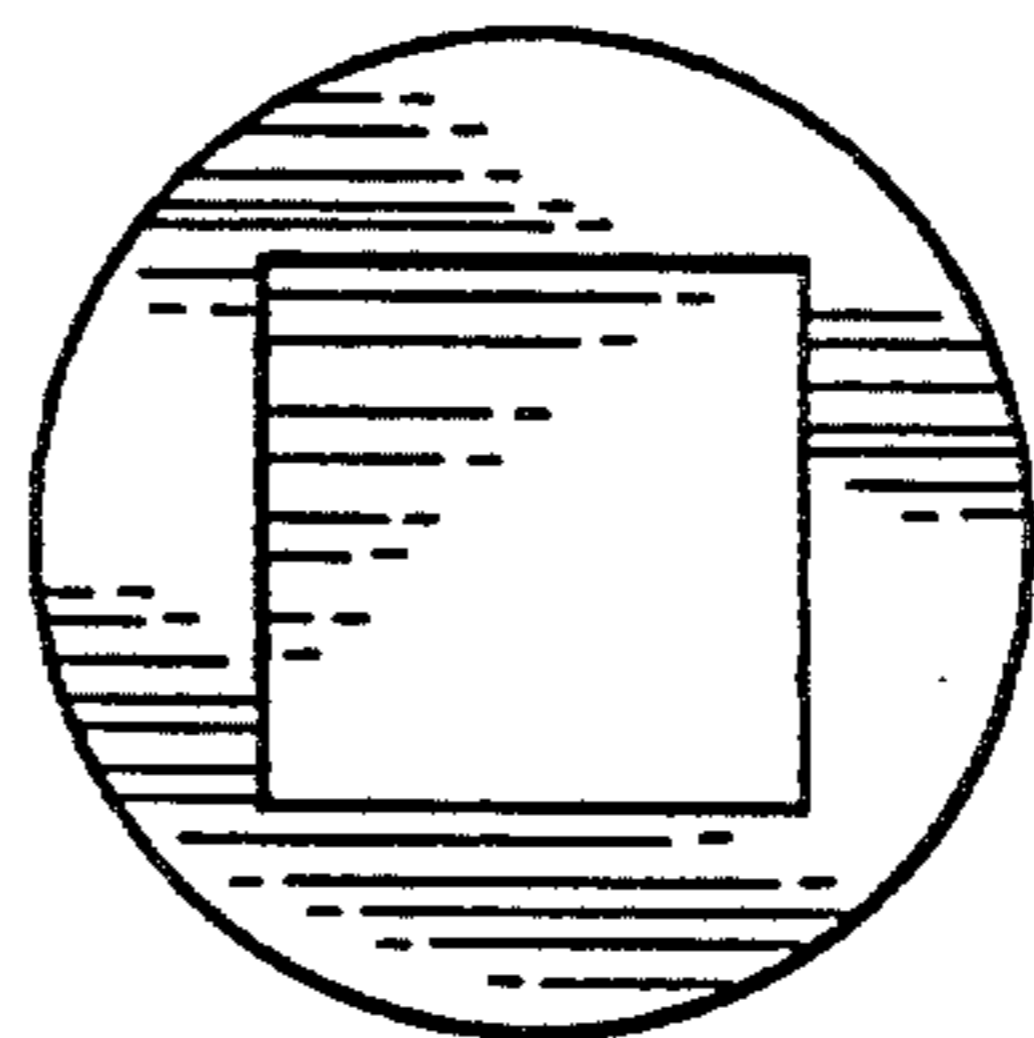
FIG. 4 is a bottom view of the socket illustrated in FIG. 1.



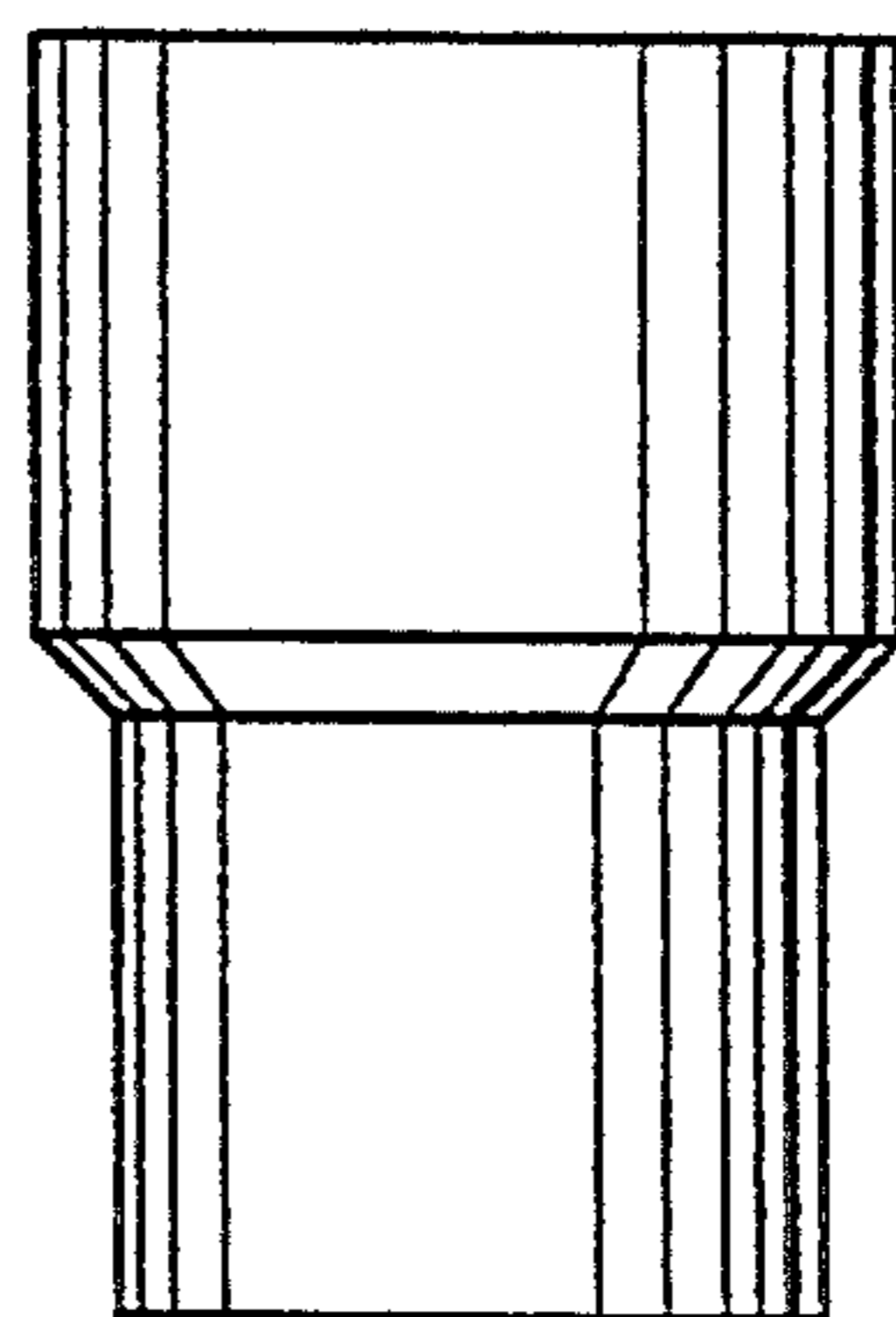
