[57] **CLAIM**

The ornamental design for a fastener for an electronic component, as shown and described.

DESCRIPTION

FIG. 1 is a front and upper left perspective view of a fastener for an electronic component showing our new design;
FIG. 2 is a rear and lower left perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is an underneath plan view thereof; and,
FIG. 9 is a front and upper left perspective view thereof shown in use. The broken line showing of the electronic component is included for the purpose of illustrating environmental elements only and forms no part of the claimed design.

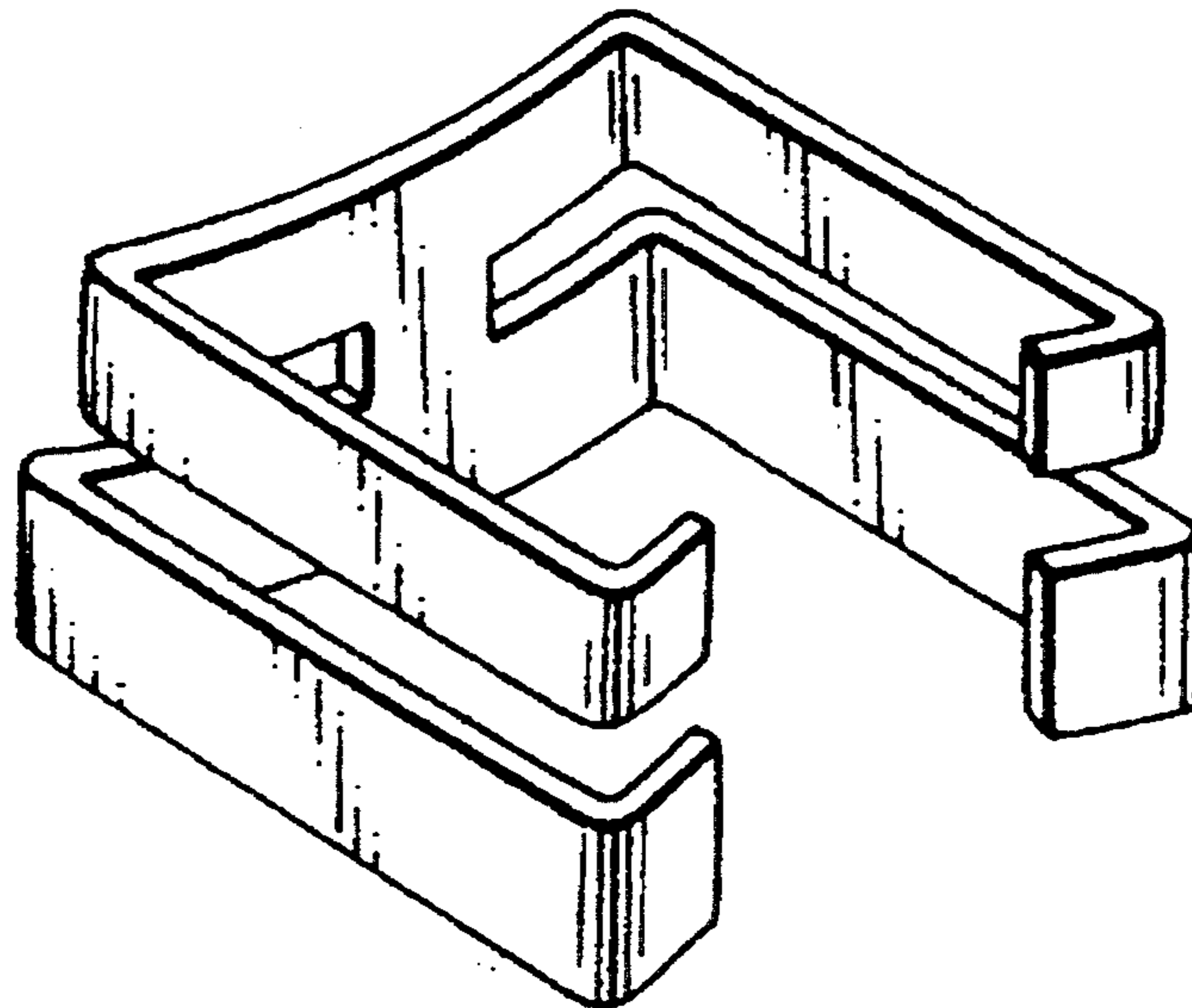

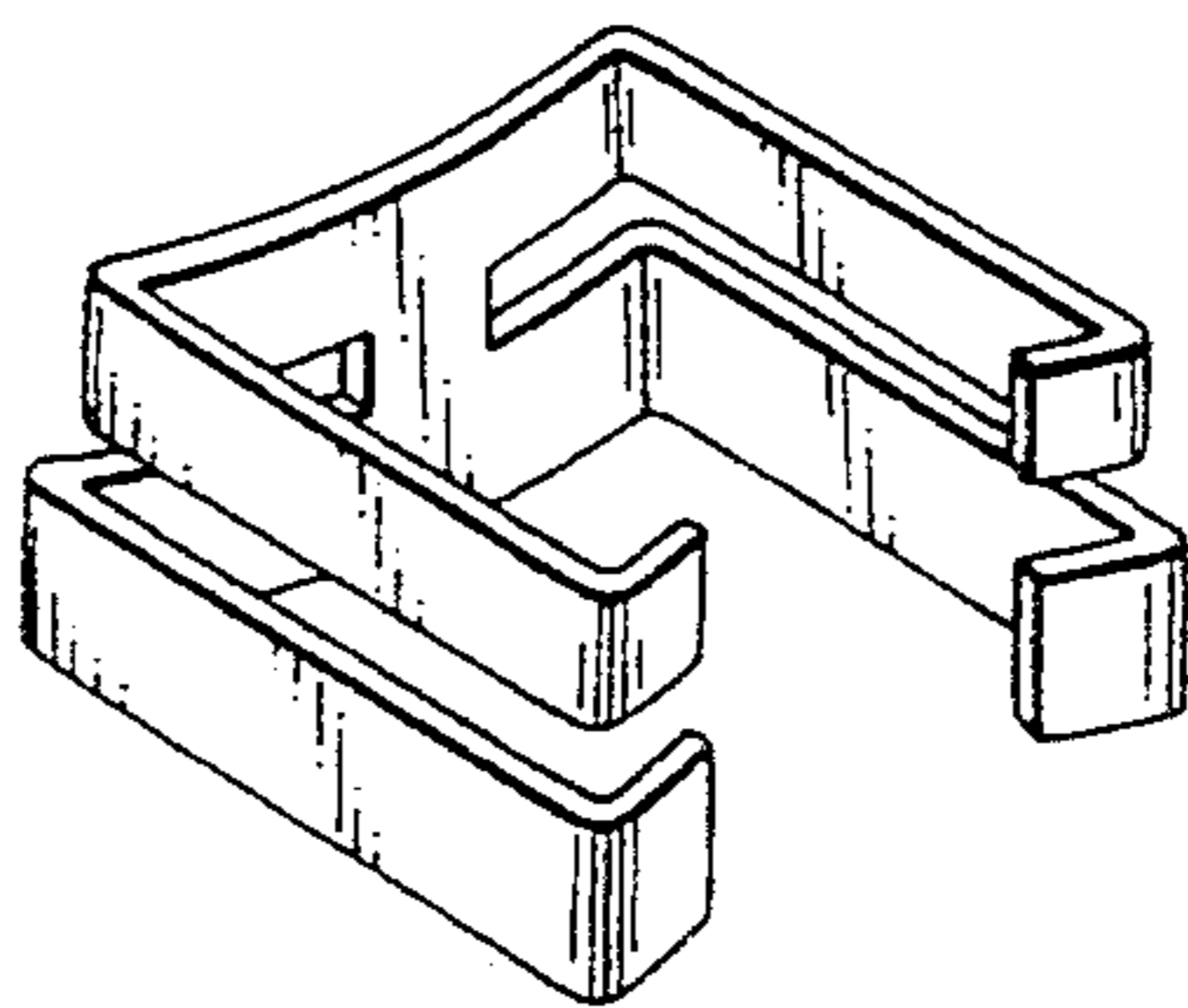

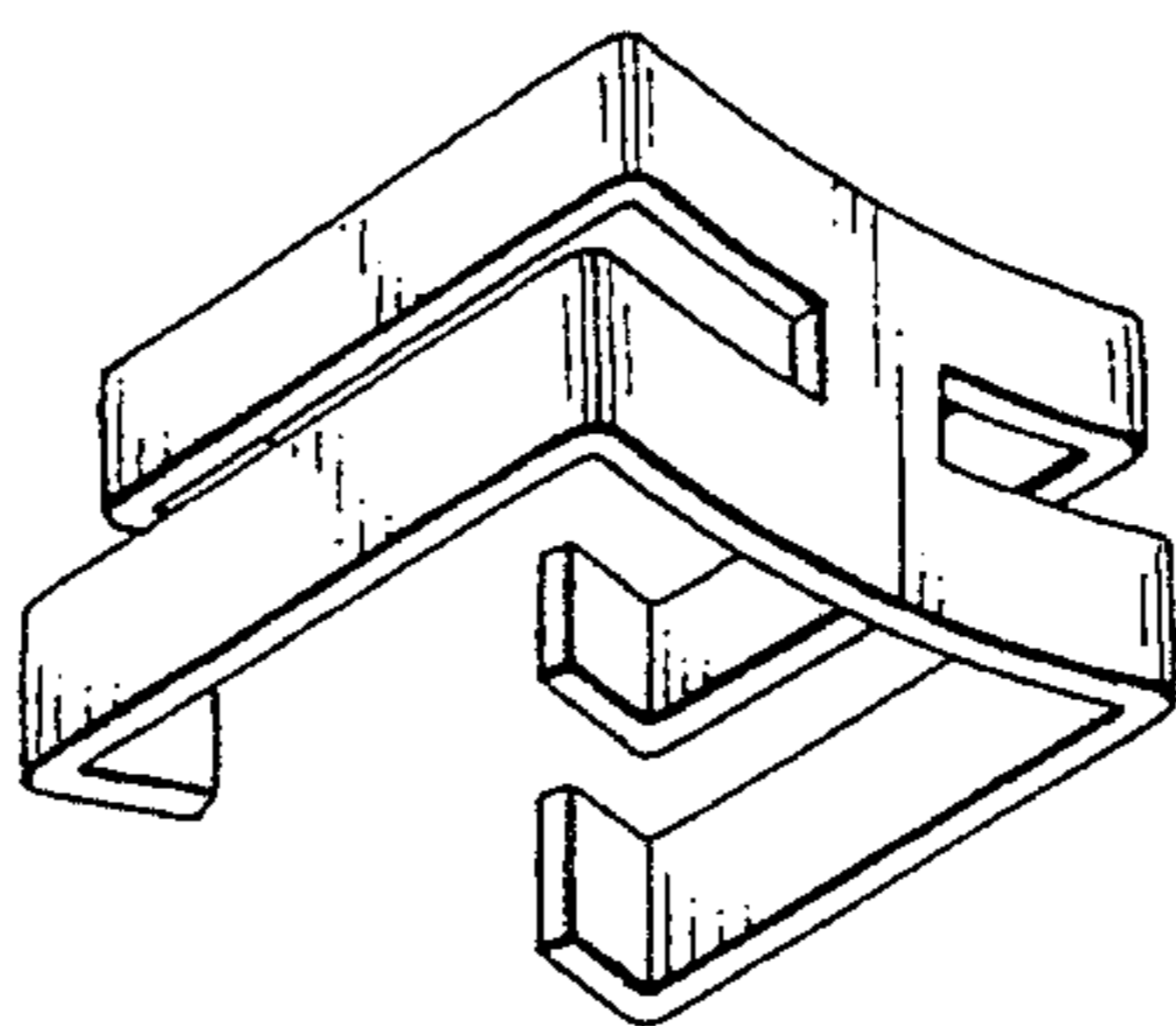

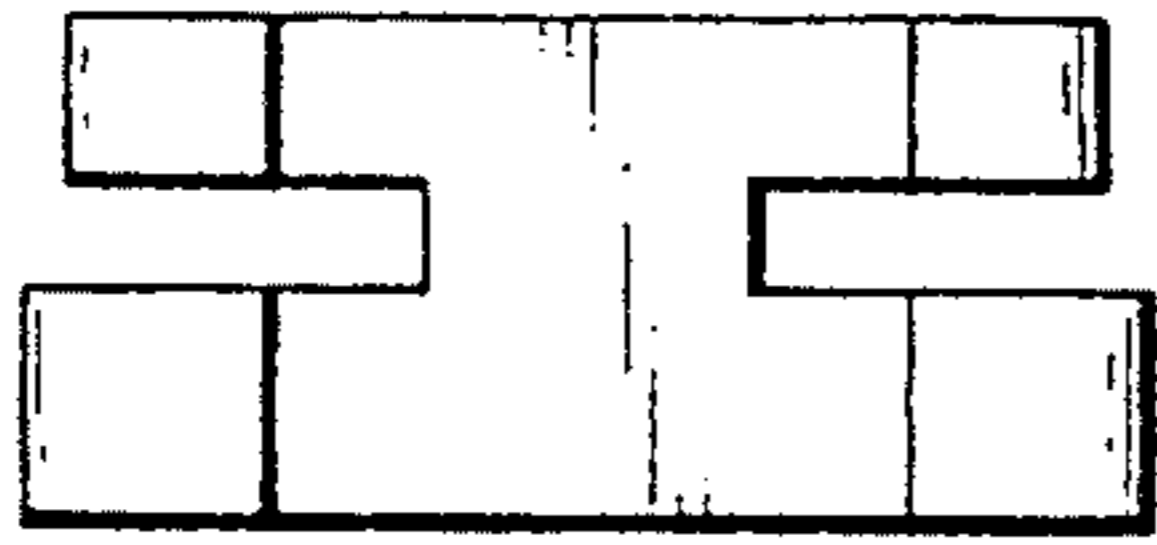

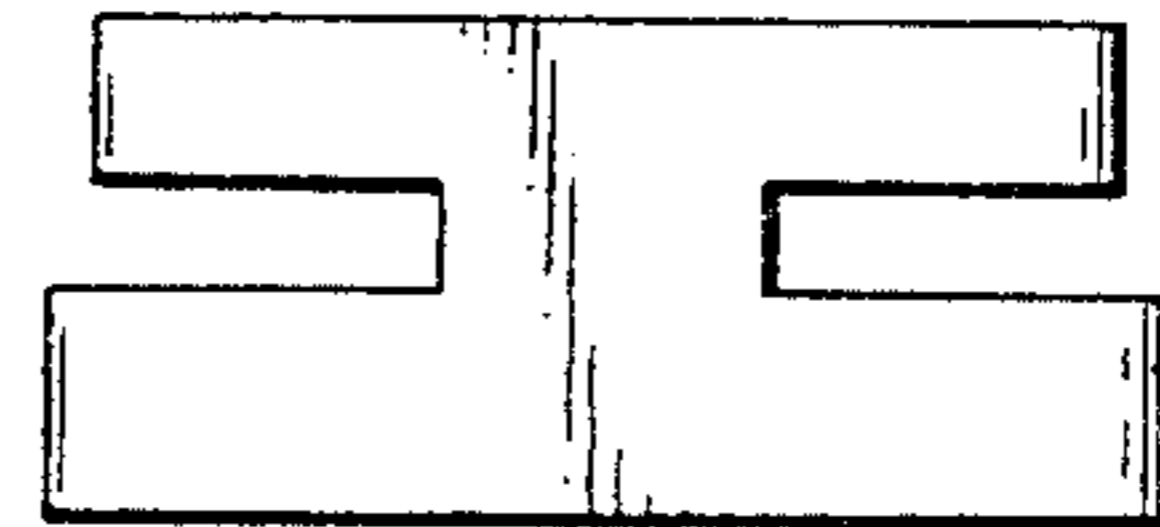

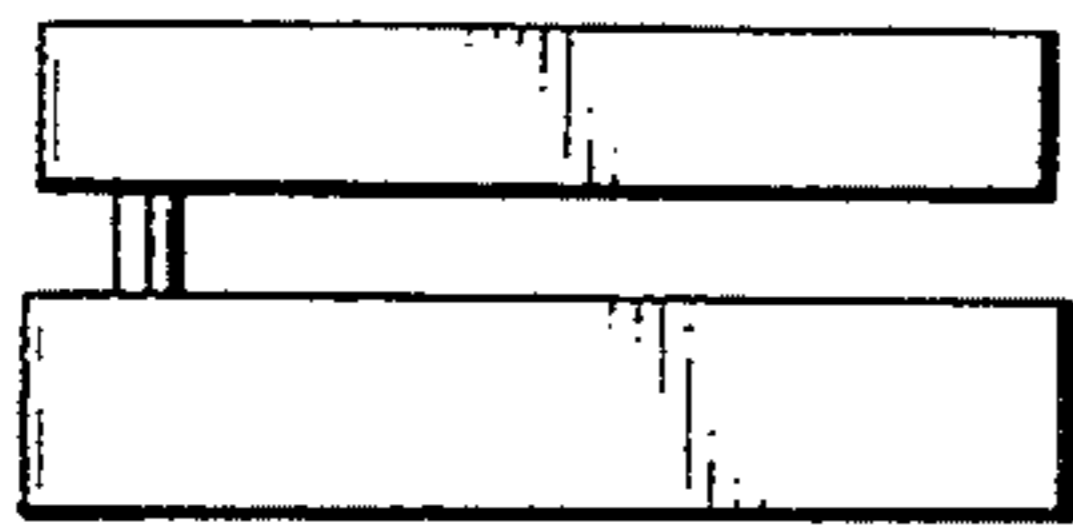

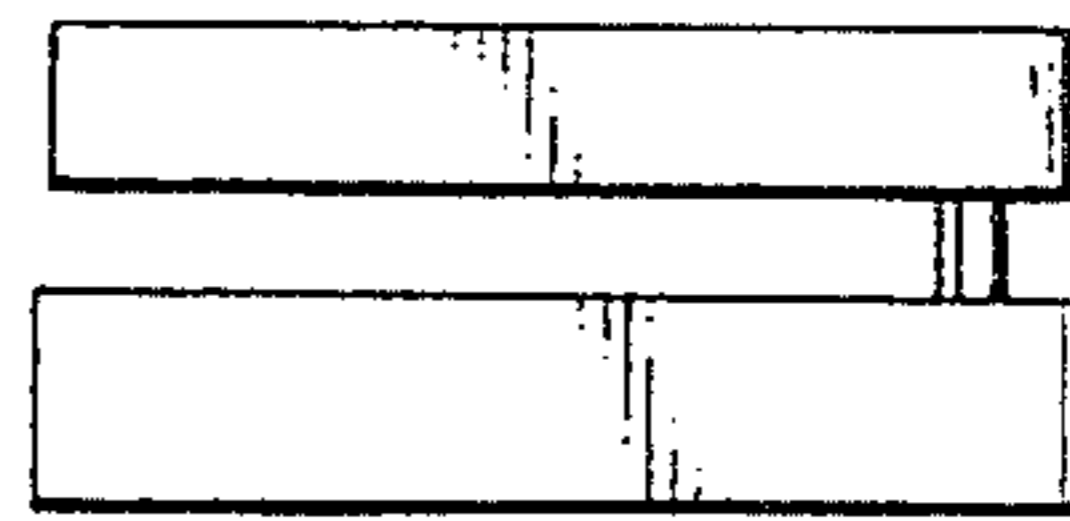

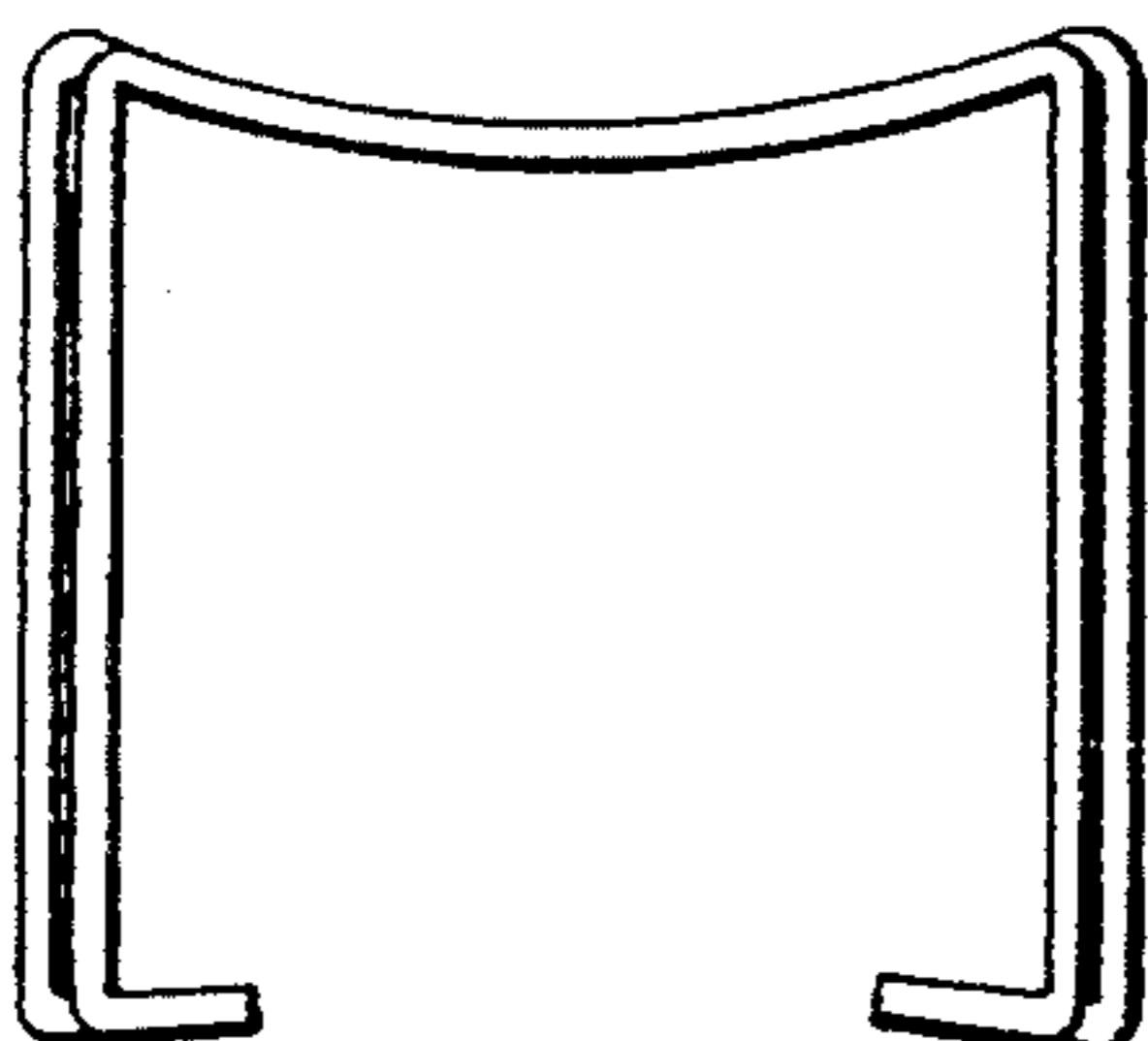

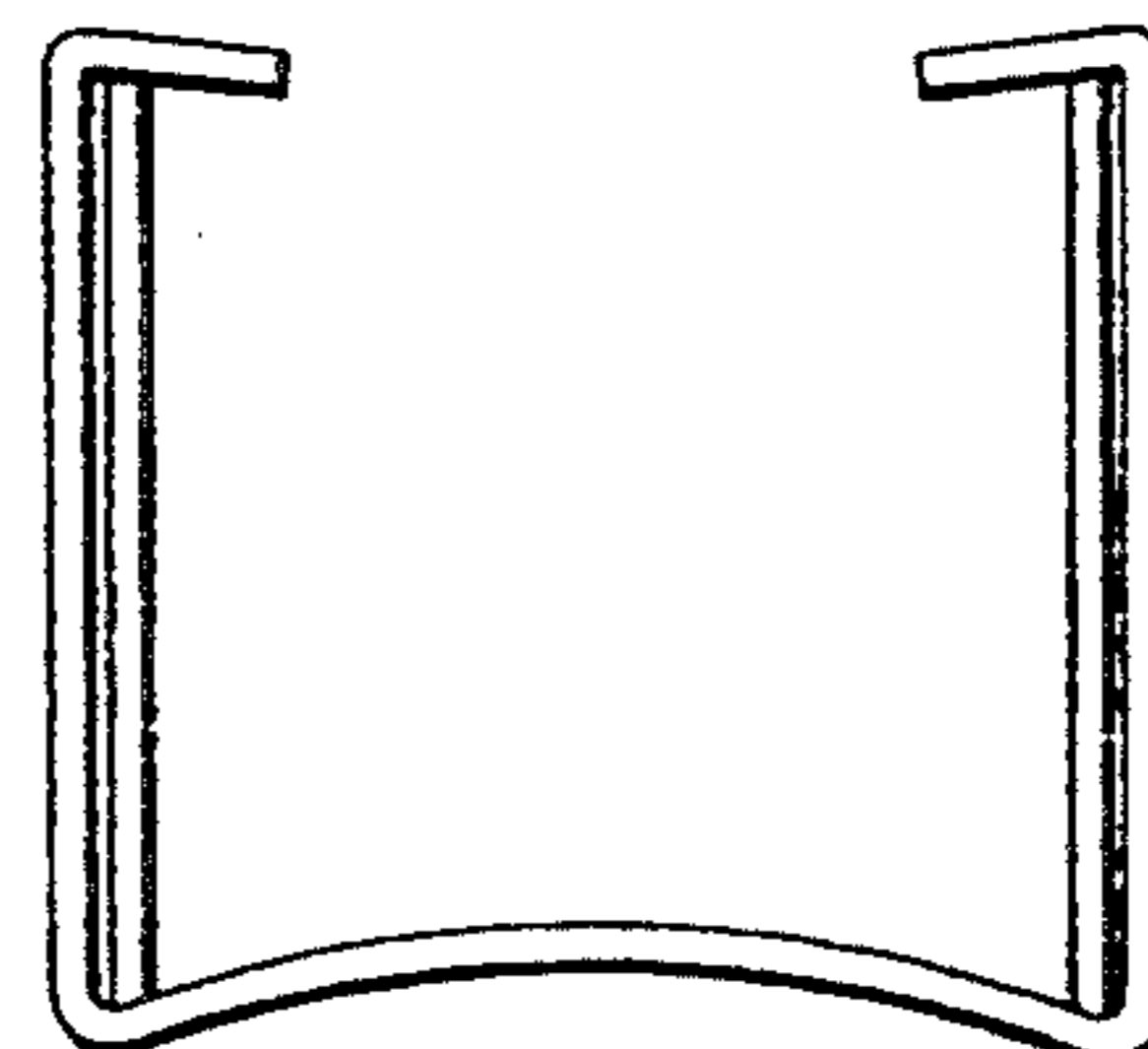
