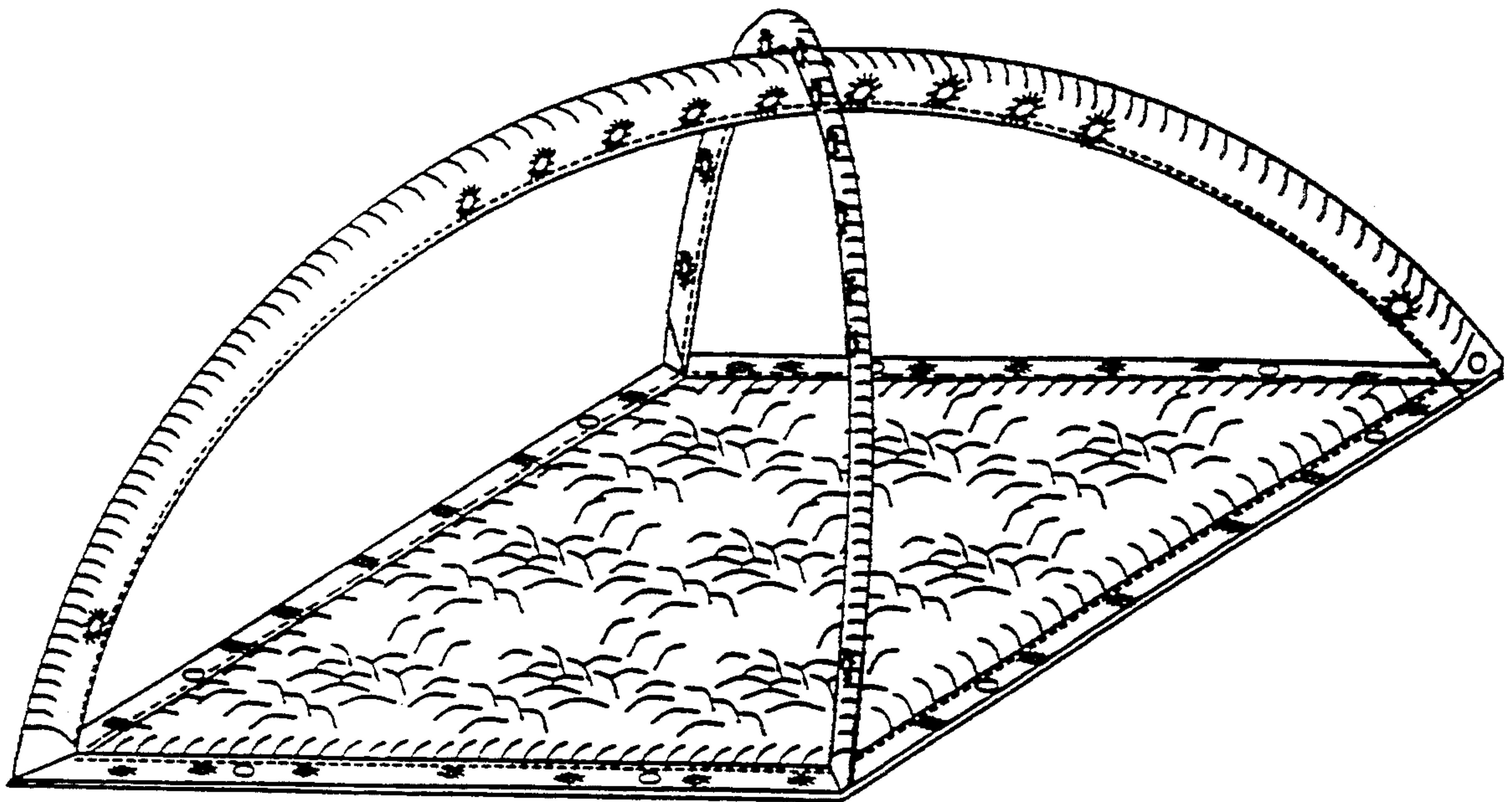

[57] **CLAIM**

The ornamental design for a baby's mattress, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the baby's mattress in the erected position thereof;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is one side view thereof;  
FIG. 6 is a second side view thereof;  
FIG. 7 is a front perspective view of the baby's mattress in the folded position thereof;  
FIG. 8 is a top view of FIG. 7;  
FIG. 9 is one side view of FIG. 7;  
FIG. 10 is a second side view of FIG. 7; and,  
FIG. 11 is a bottom view of FIG. 7.  
The cross-hatching represents conventional fabric and is understood to extend throughout the areas represented.  
The broken lines represent stitching.



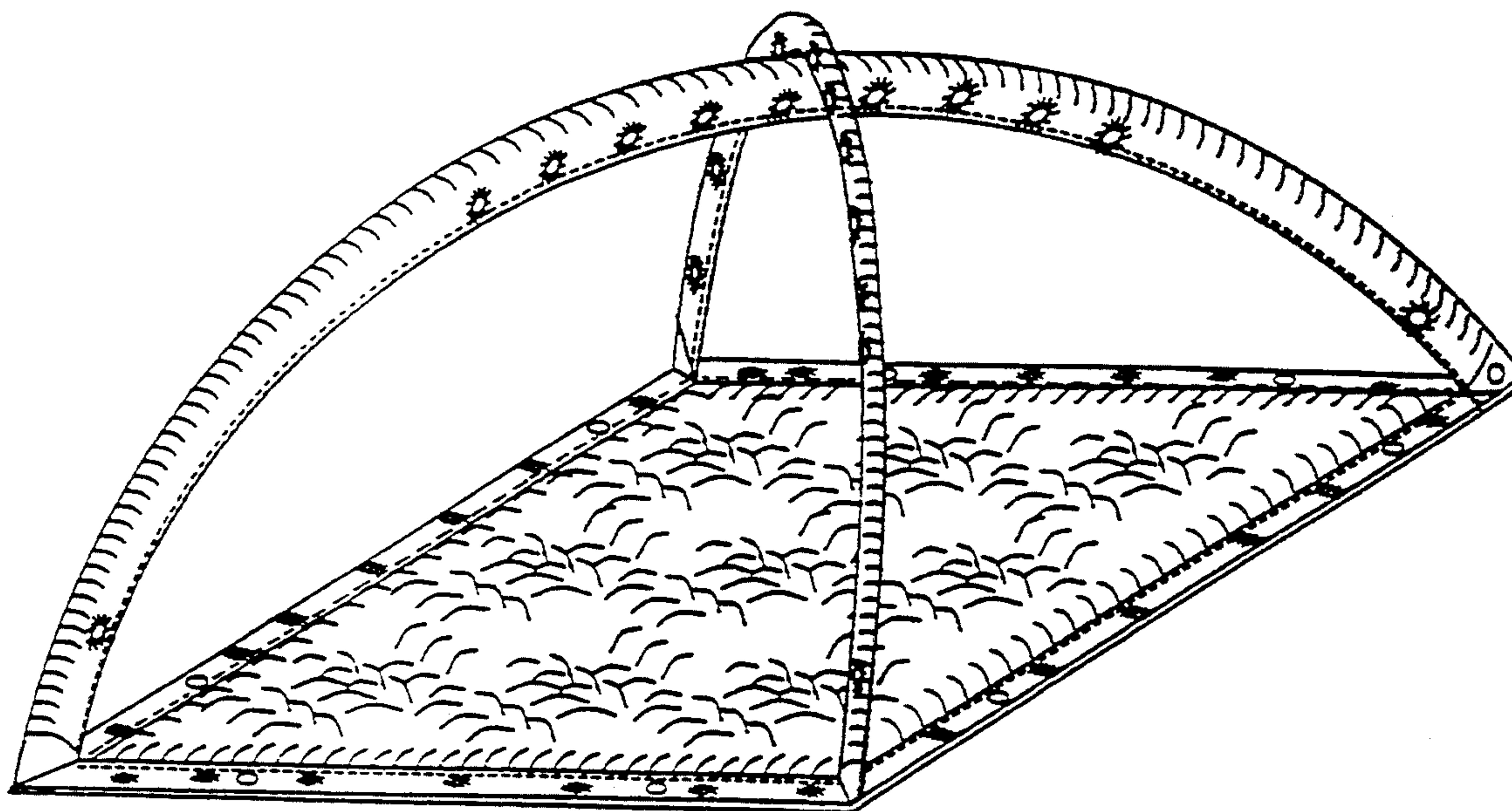

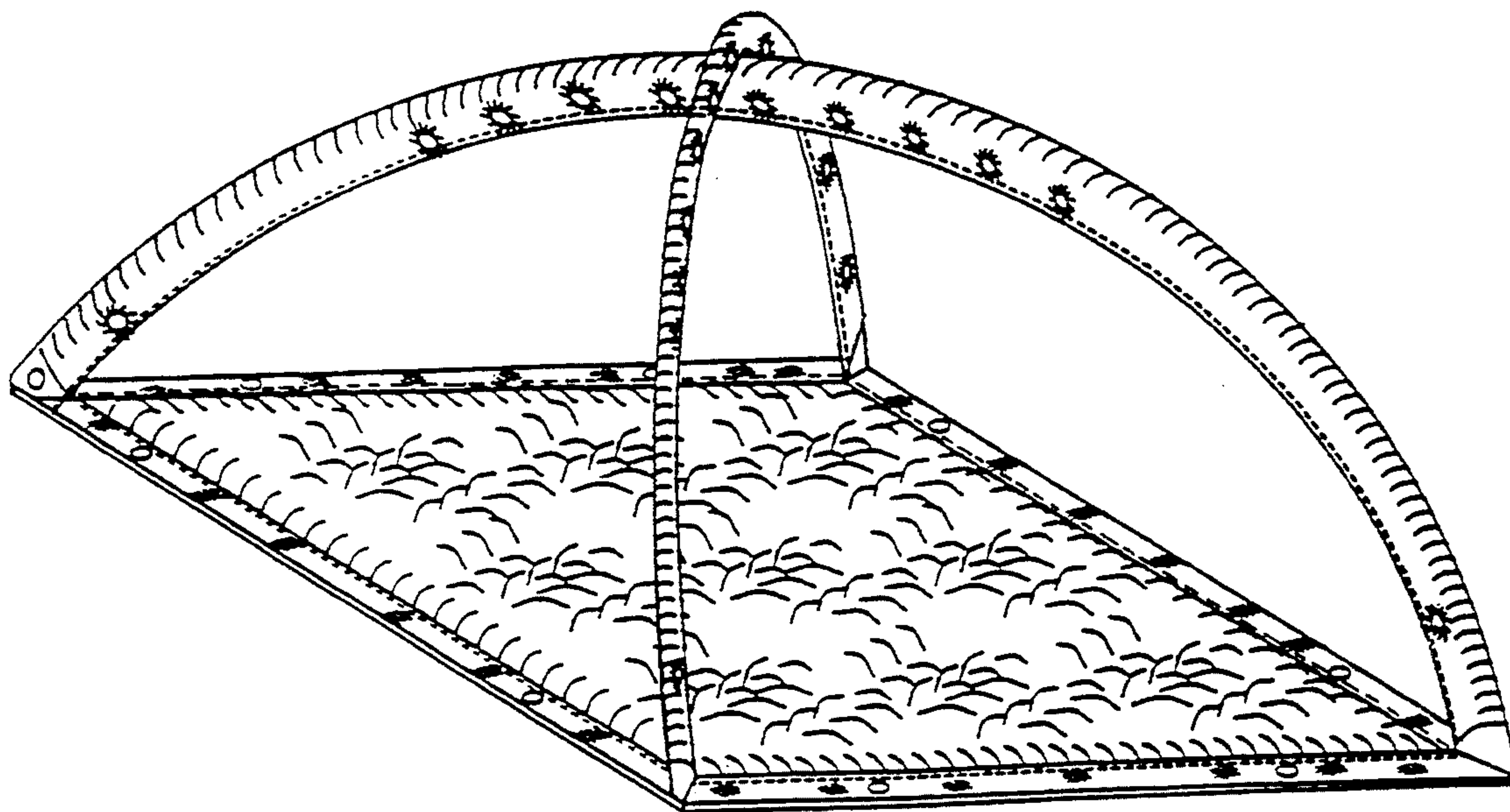

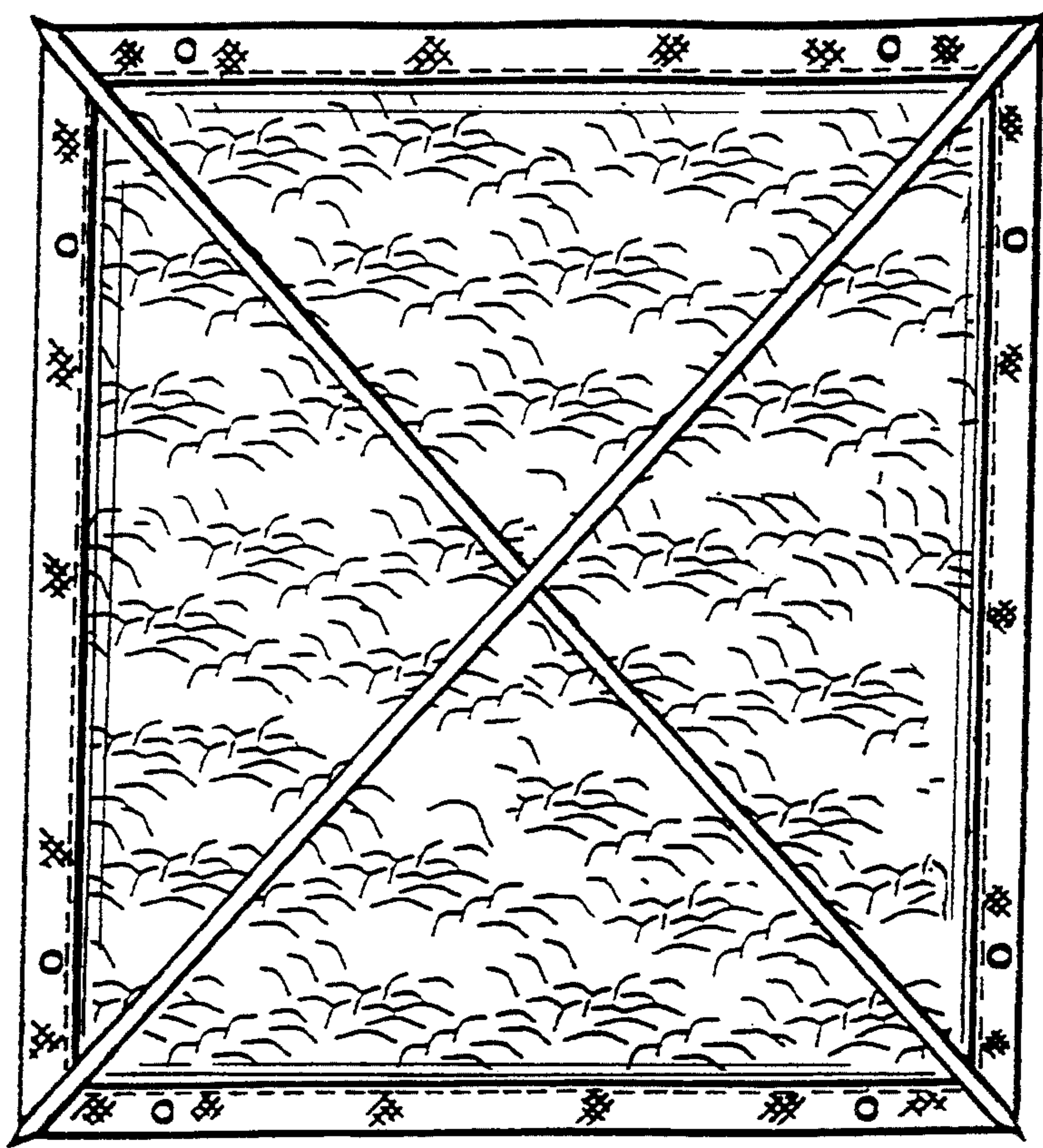

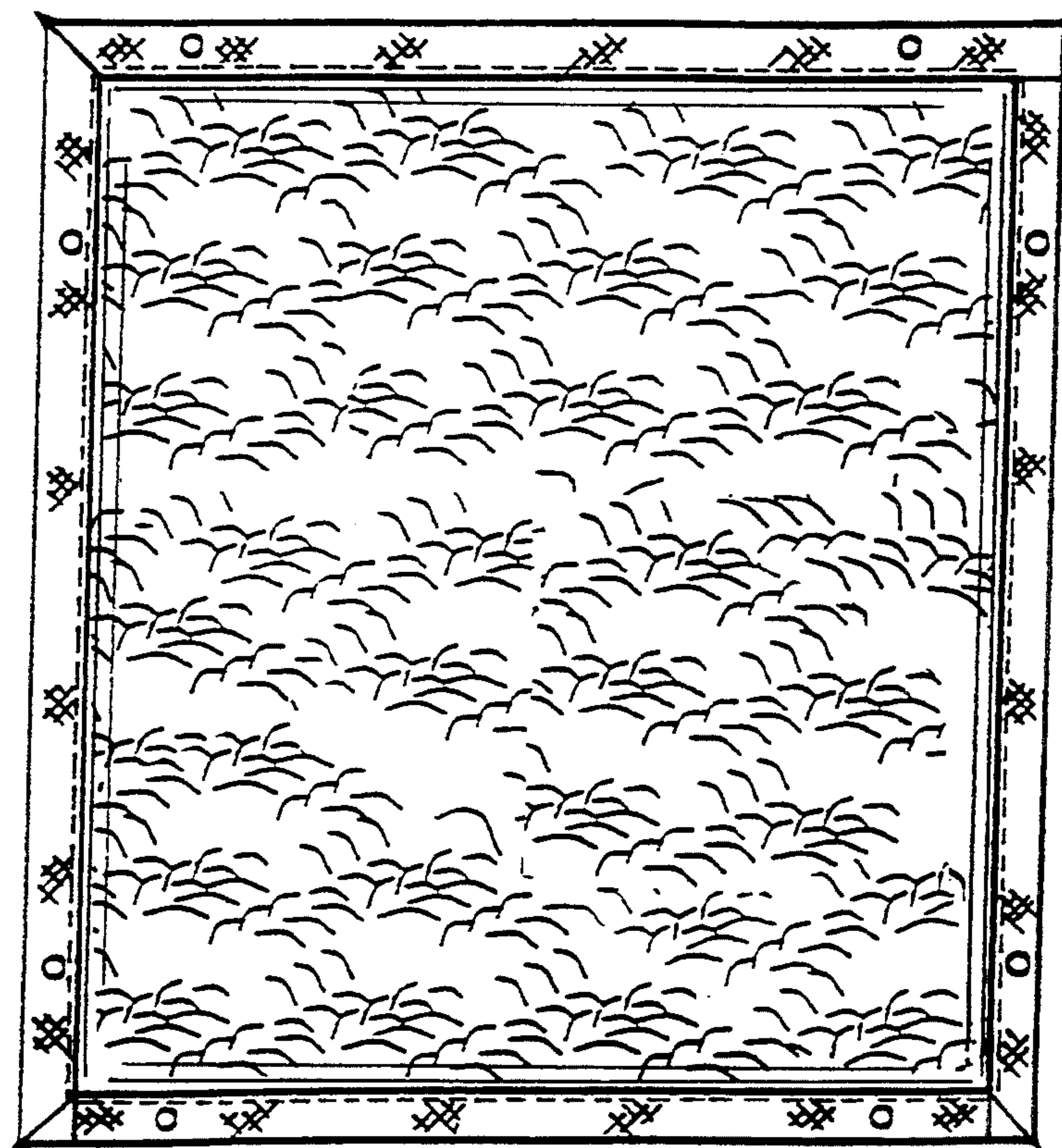

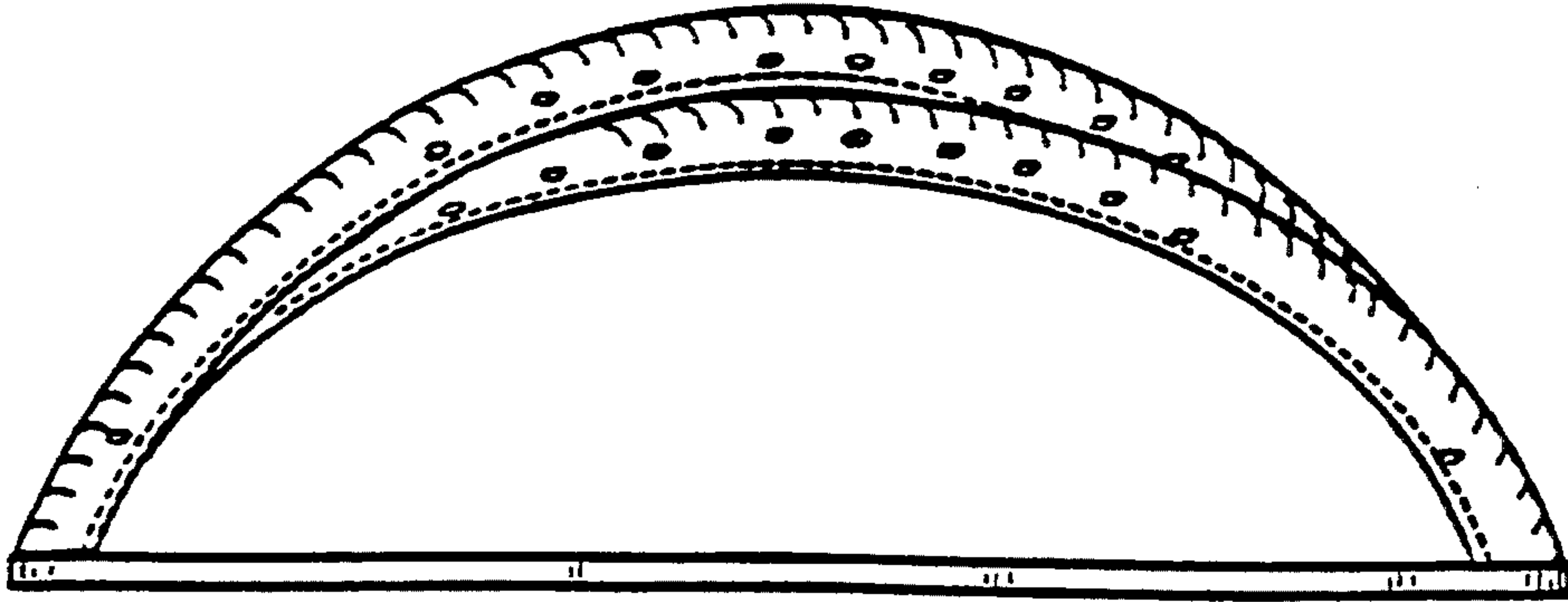

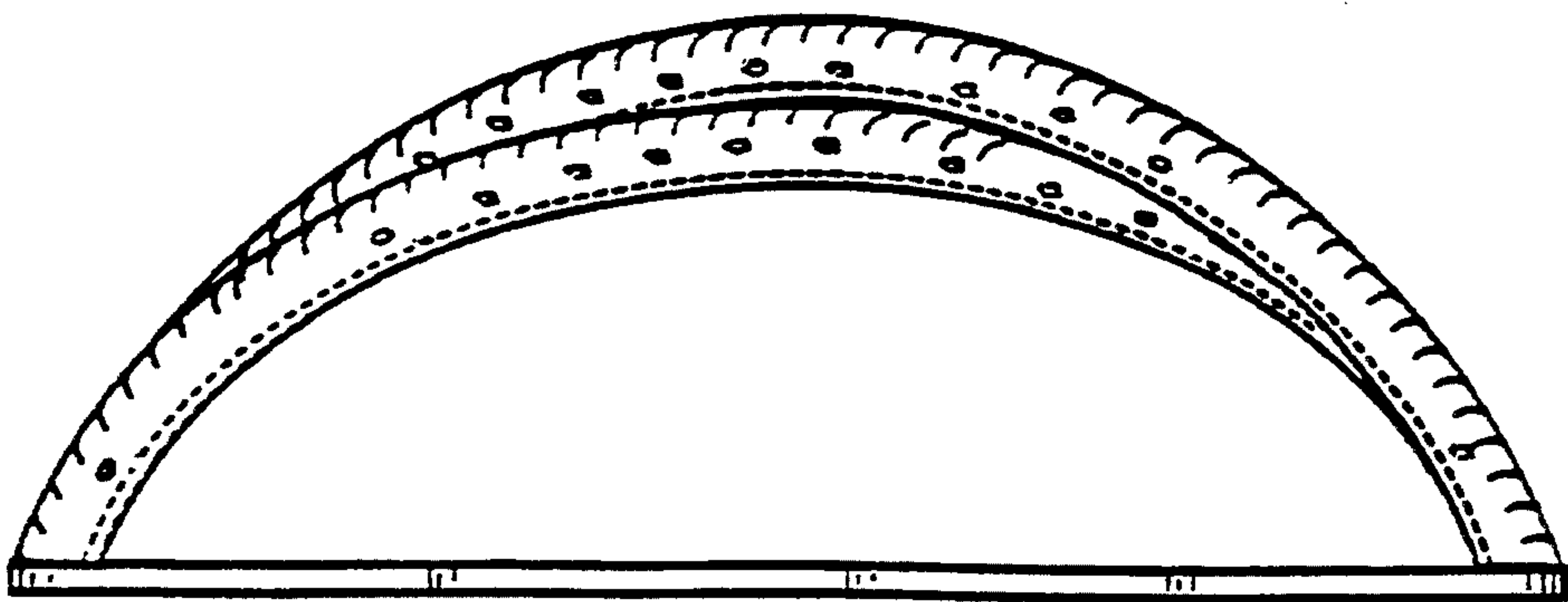

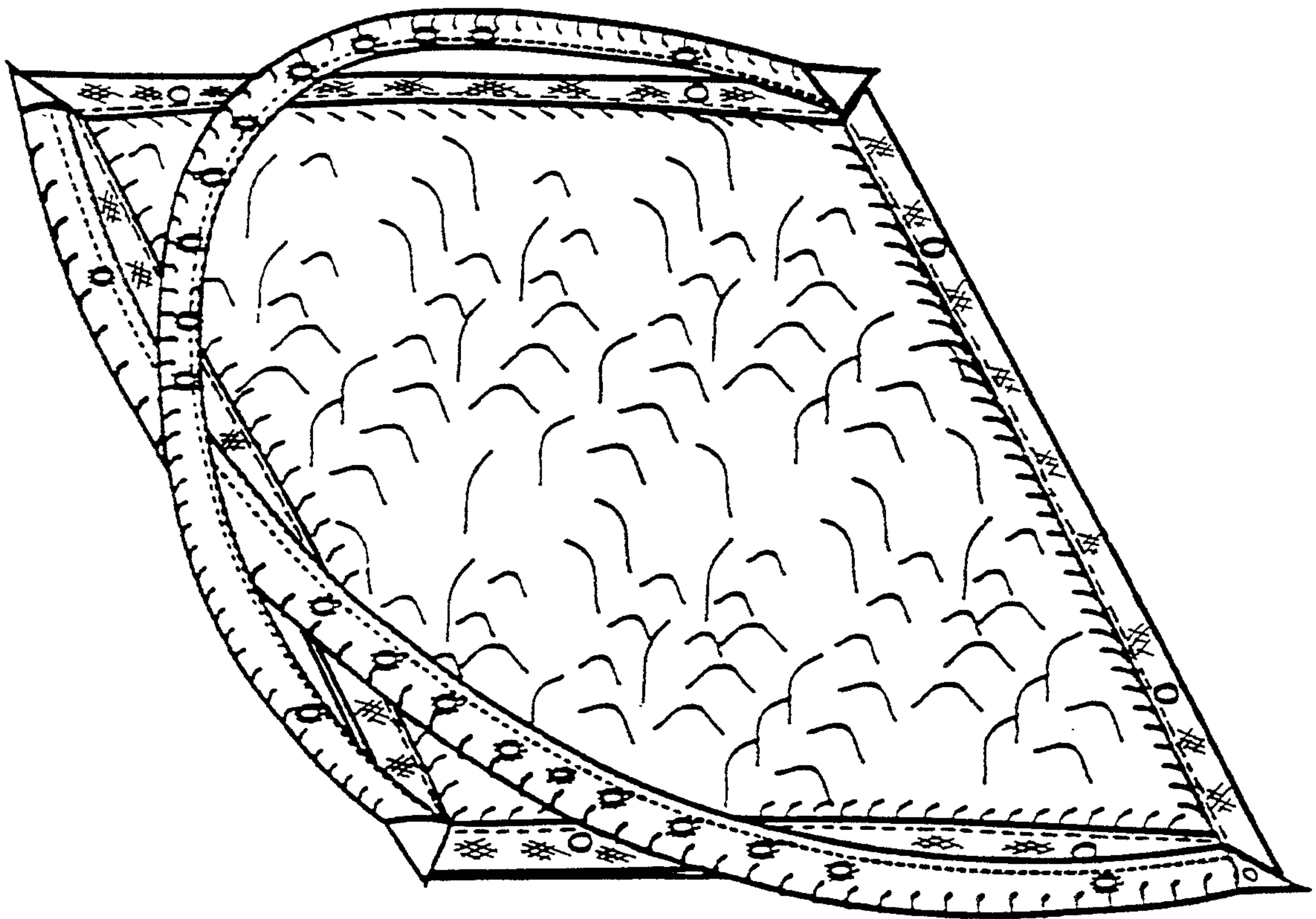

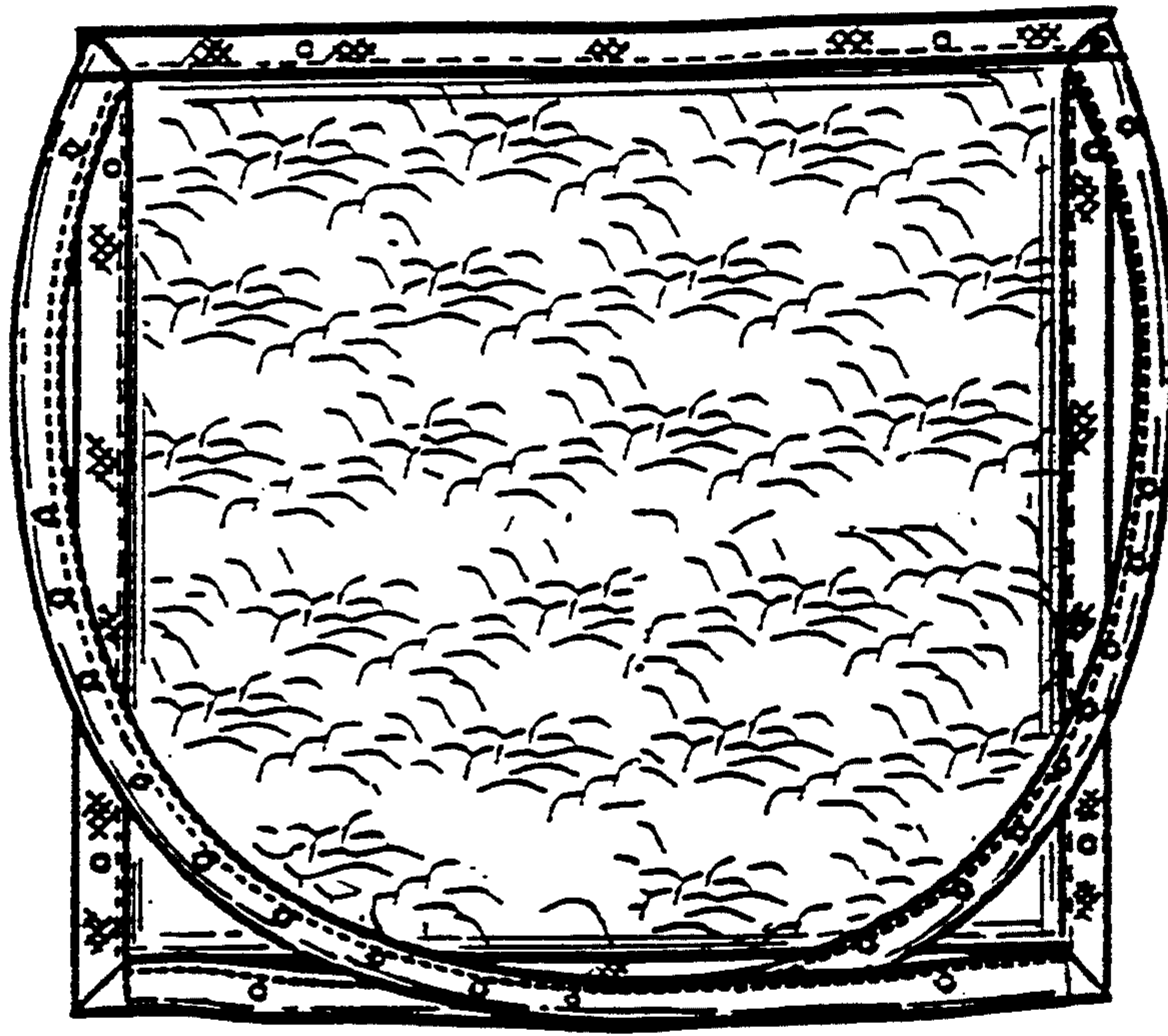

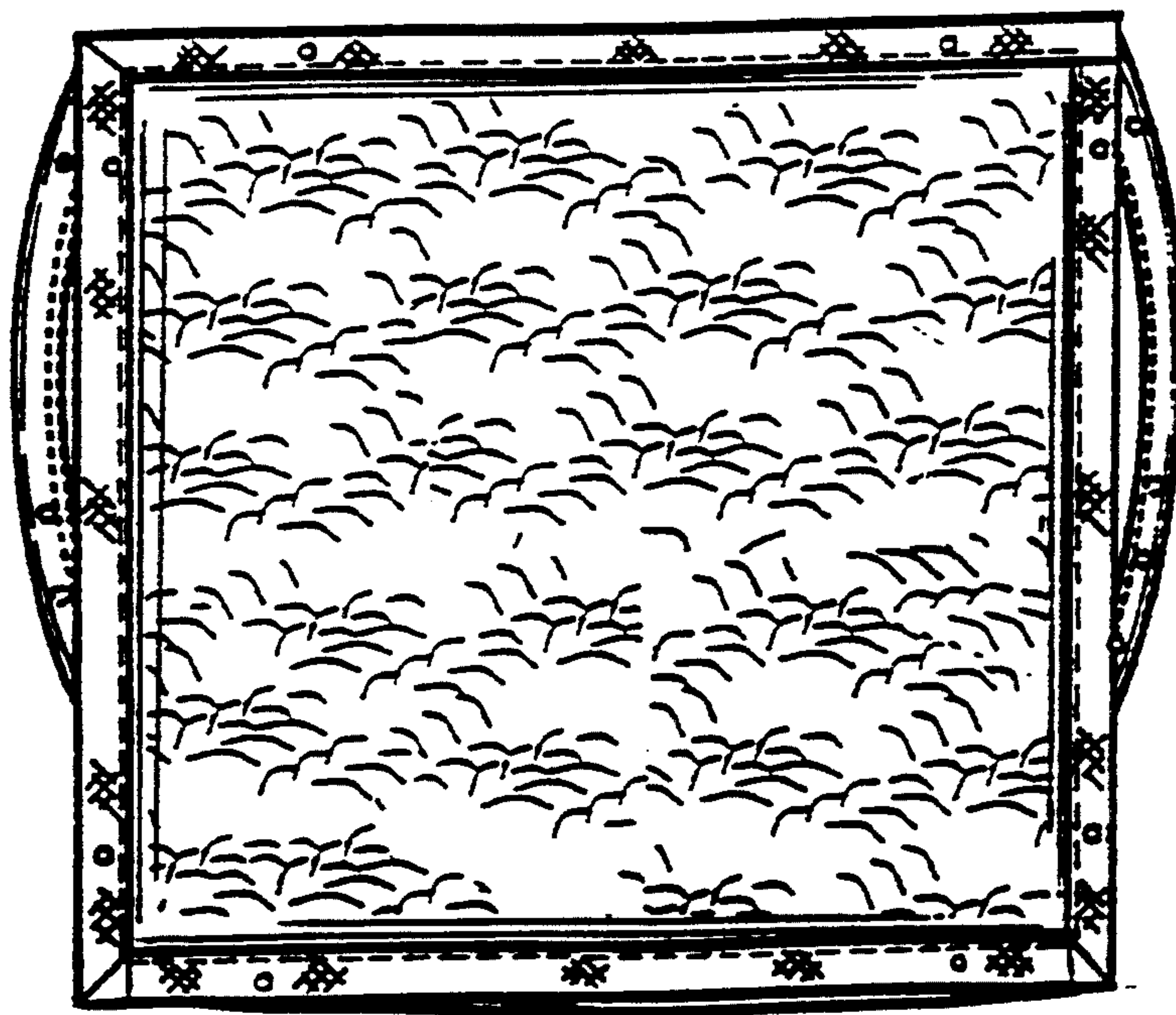
