The ornamental design for the fruit box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fruit box showing our new design;
FIG. 2 is a top plan view thereof; the bottom plan view being a mirror image thereof;
FIG. 3 is a front elevational view thereof; the rear elevational view being a mirror image thereof; and,
FIG. 4 is a left side elevational view thereof; the right side elevational view being a mirror image thereof.

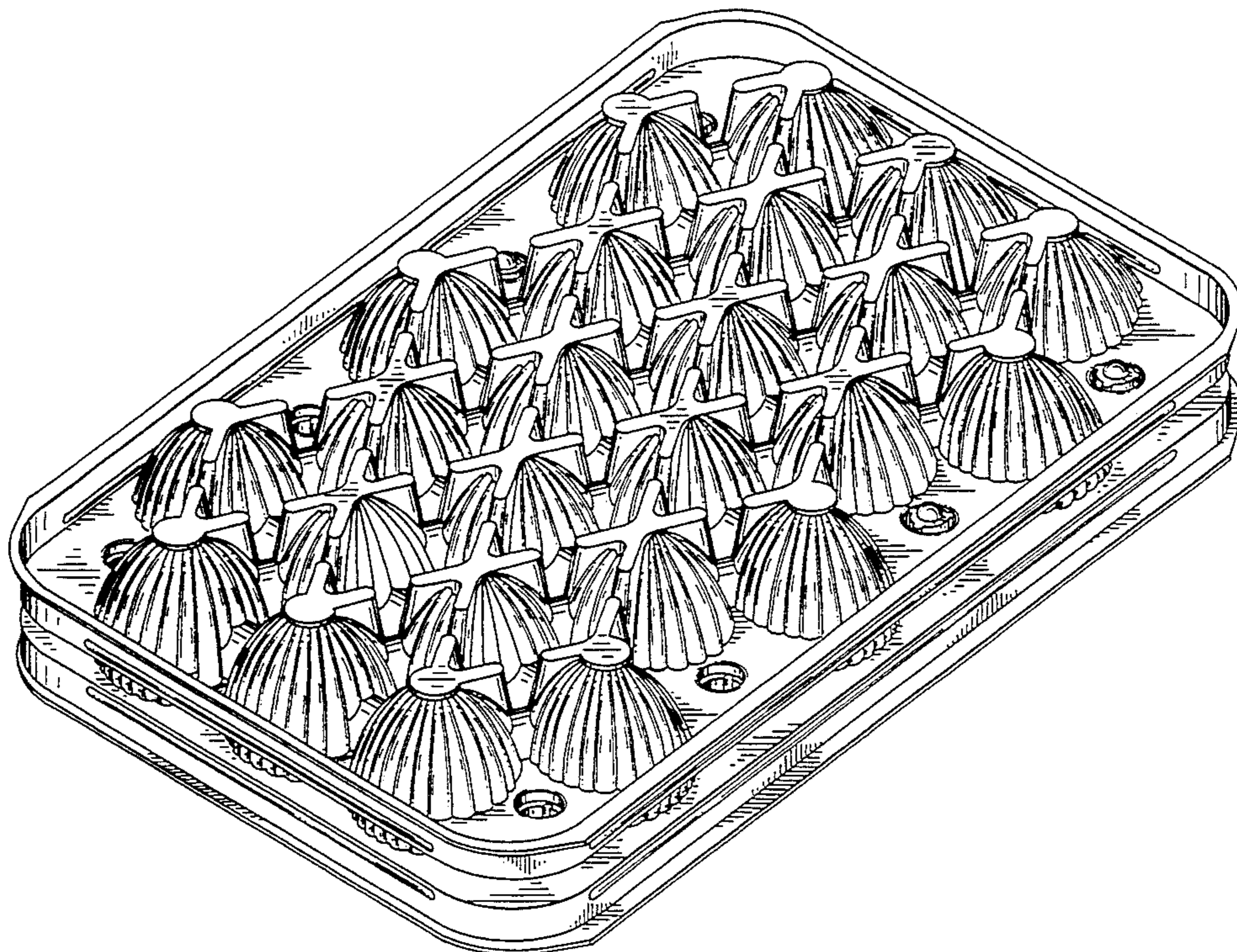
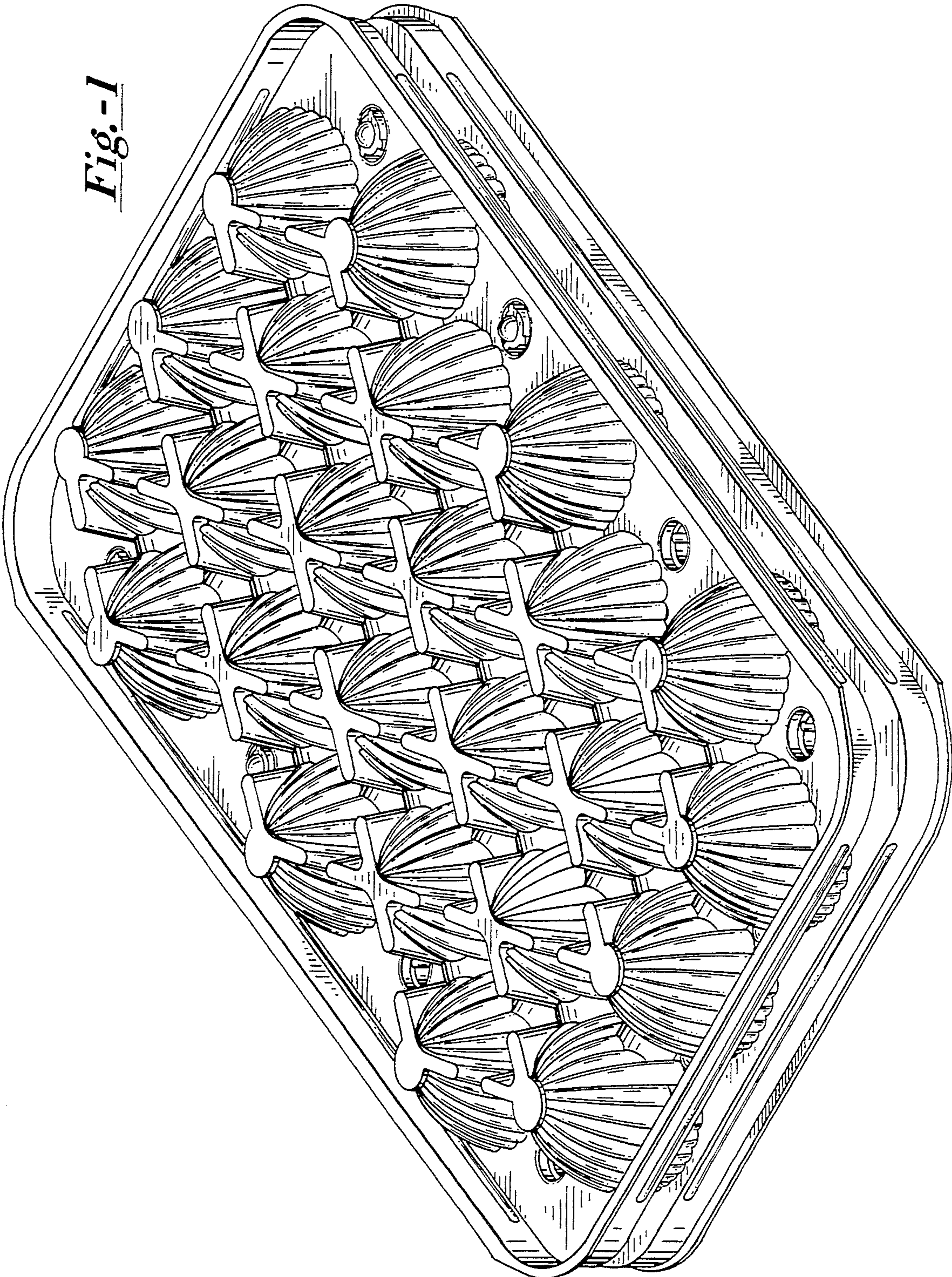

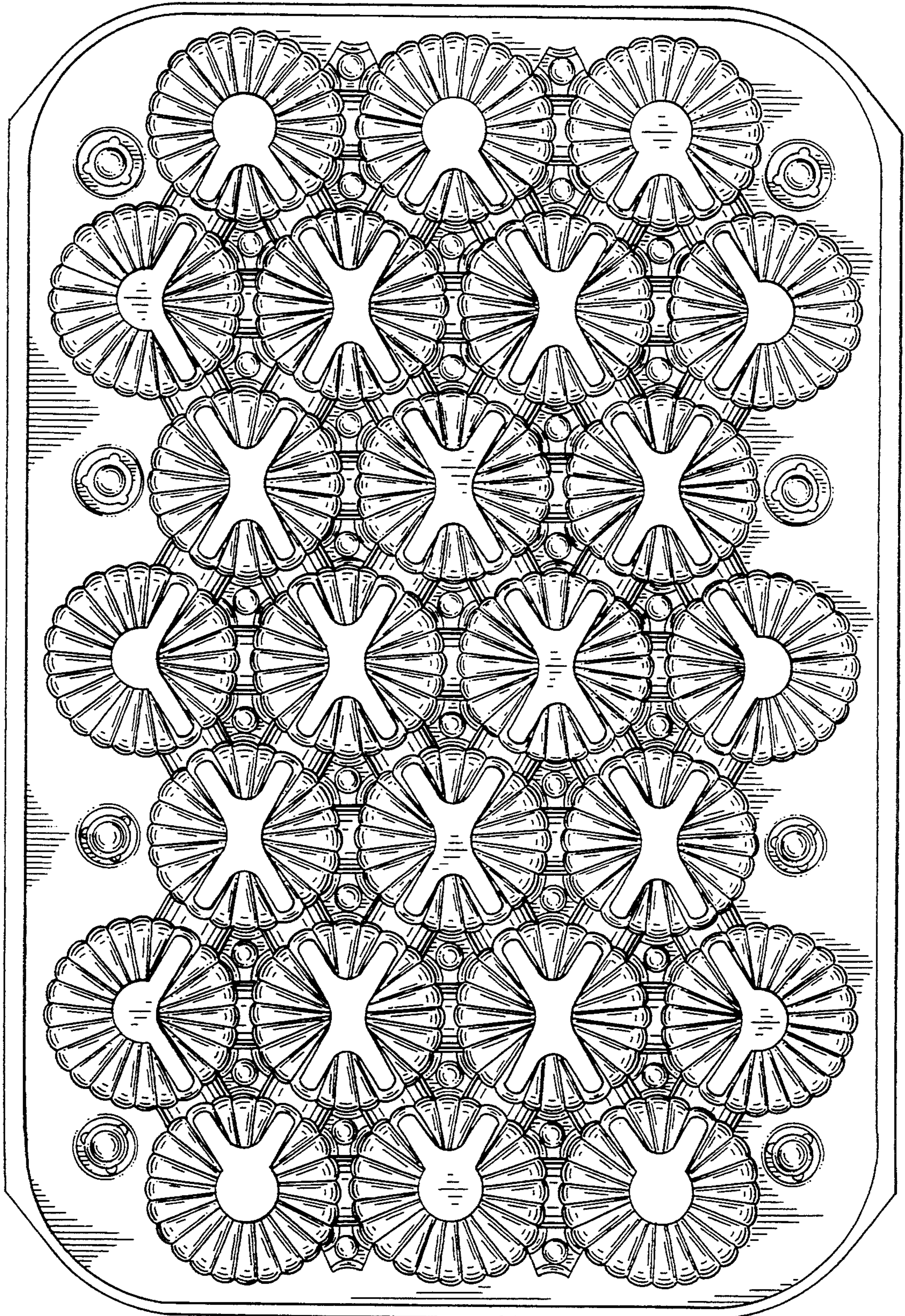

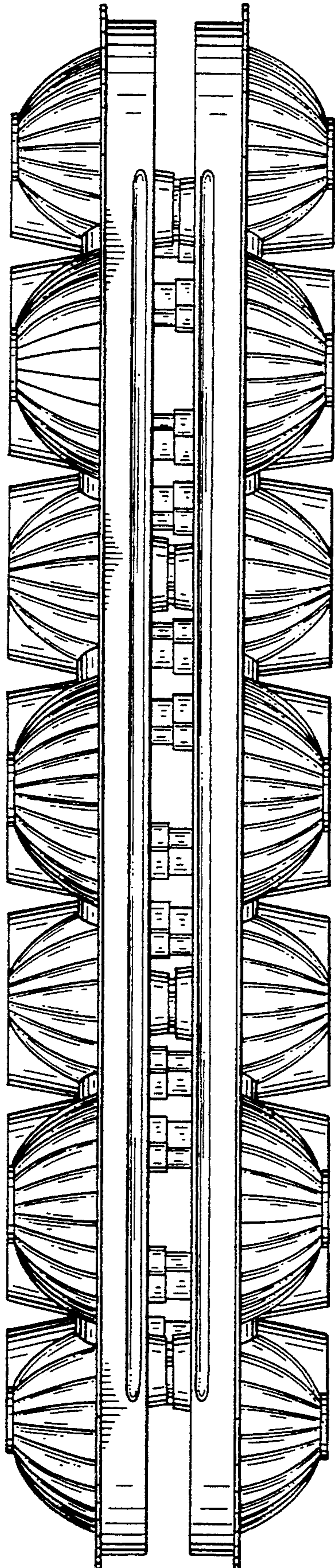
