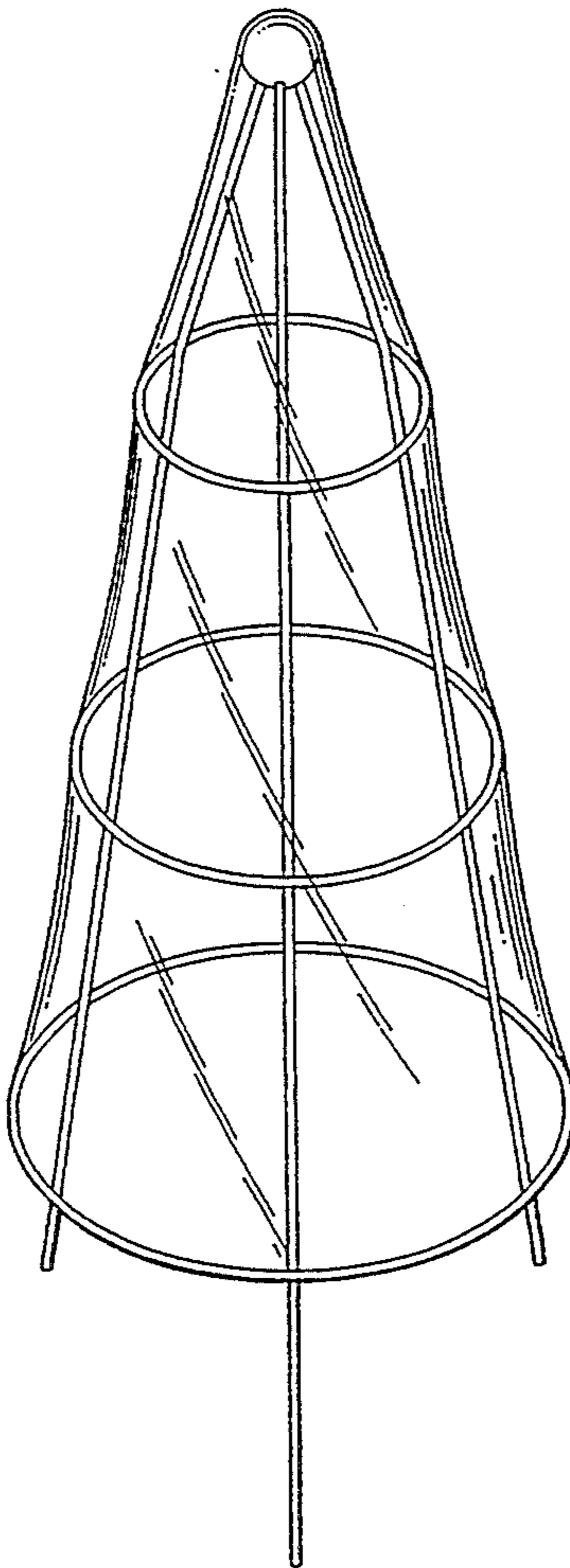

### DESCRIPTION

FIG. 1 is a perspective view, showing my new design;  
FIG. 2 is a front elevational view, the rear, right side,  
and left side being substantially a mirror image thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a perspective view of a modified embodiment  
thereof in an inverted position.



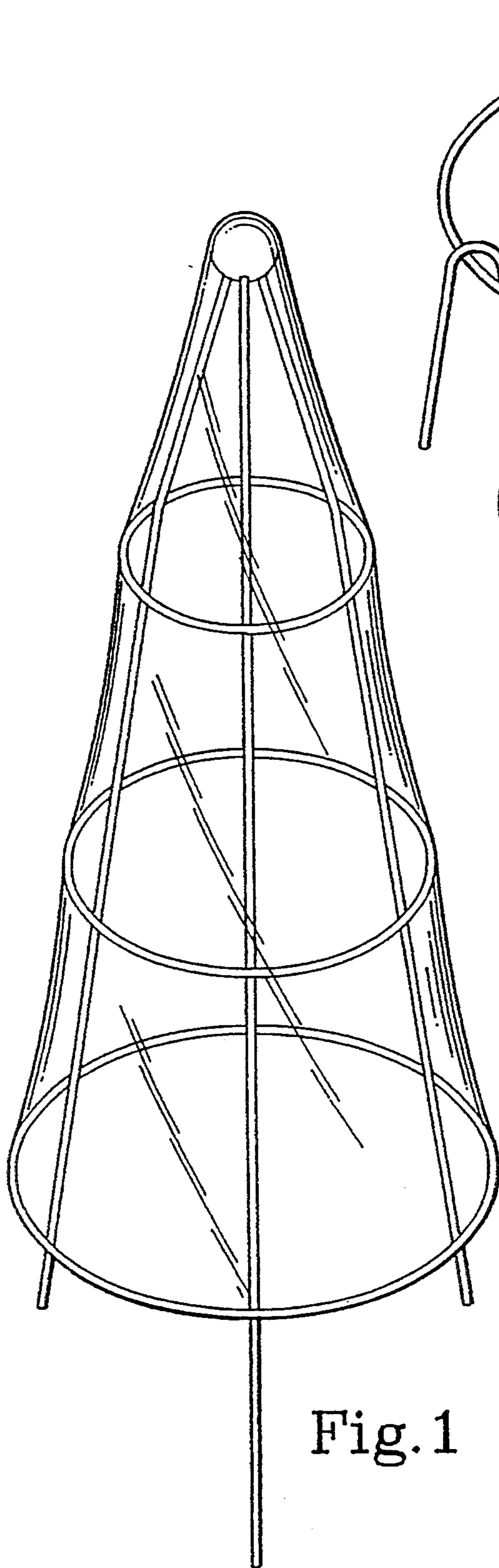

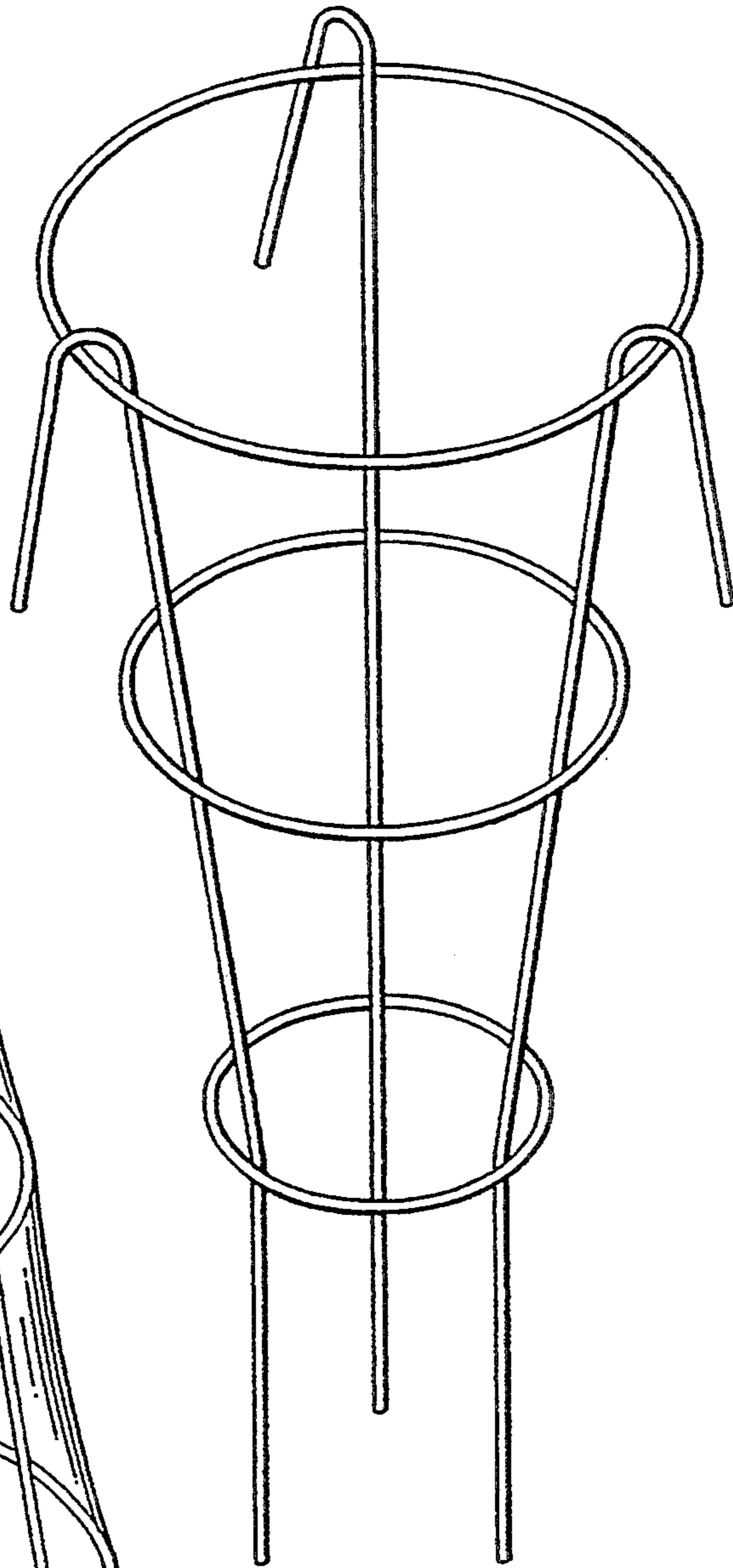

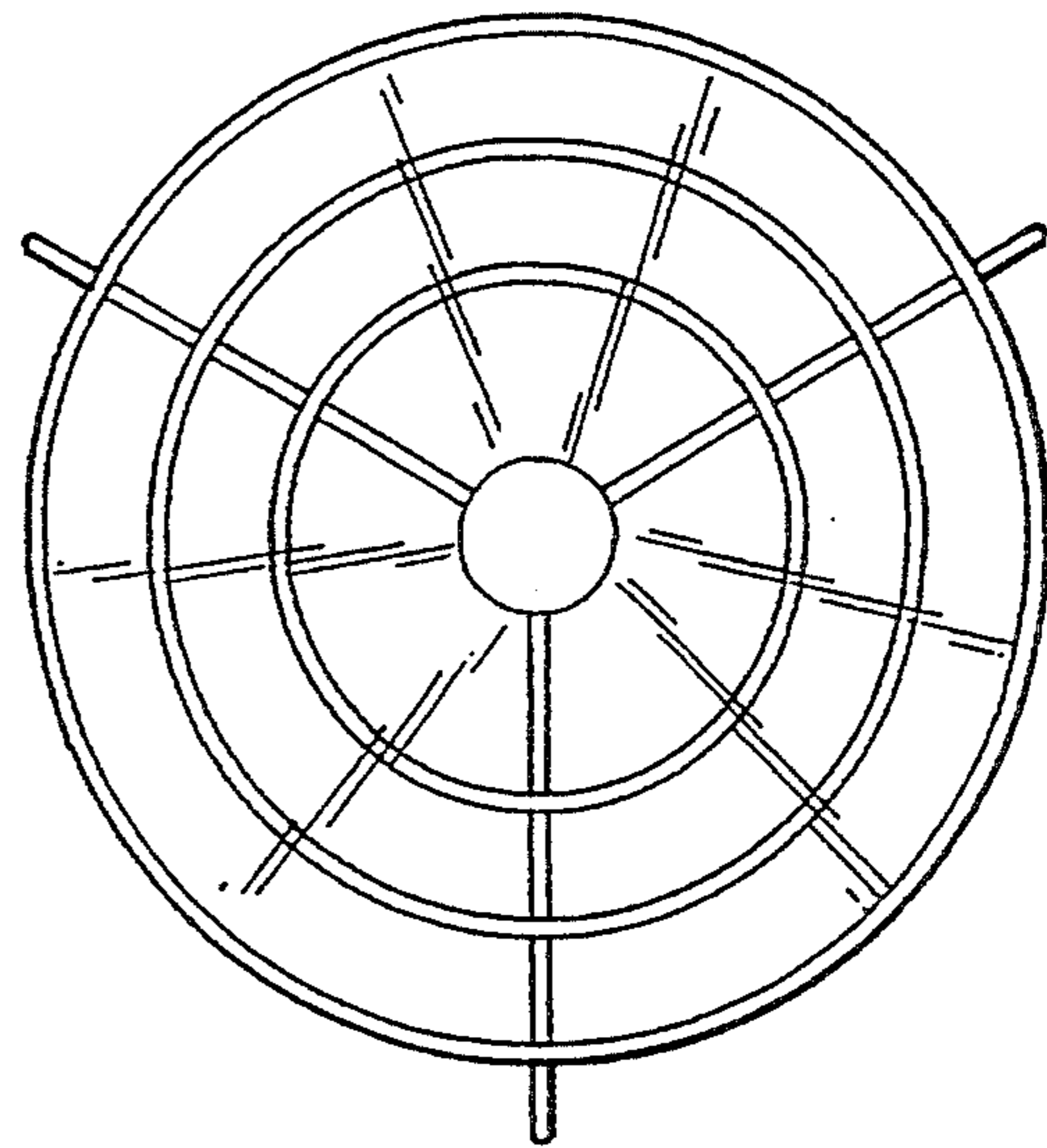
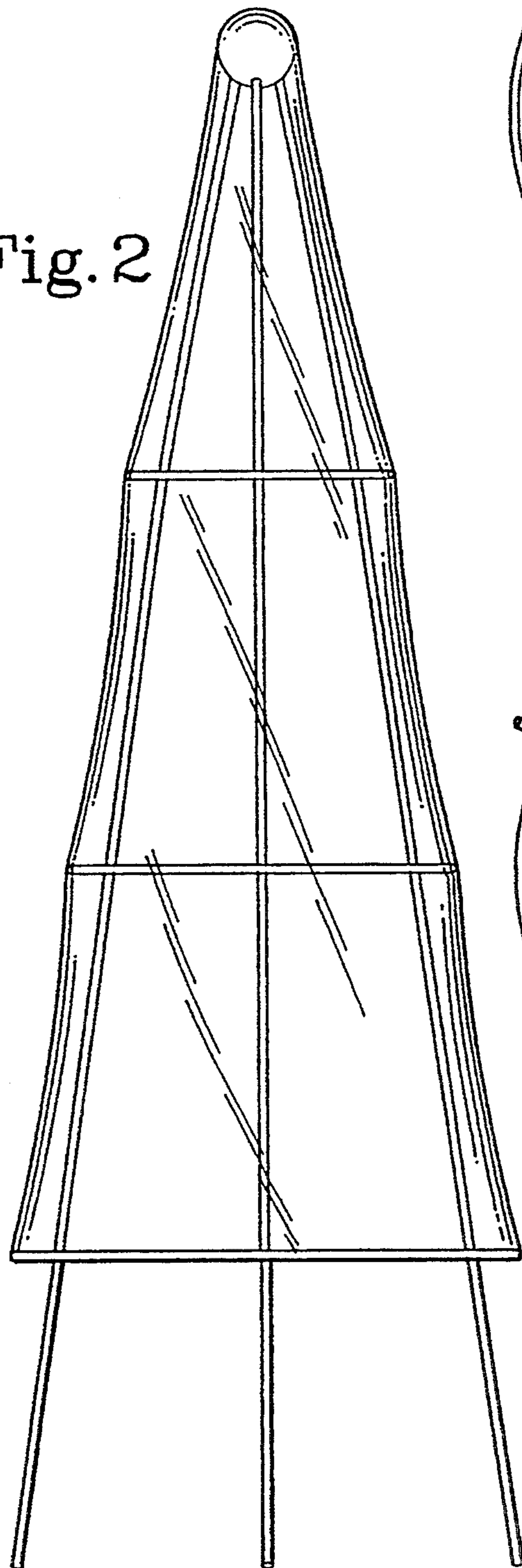

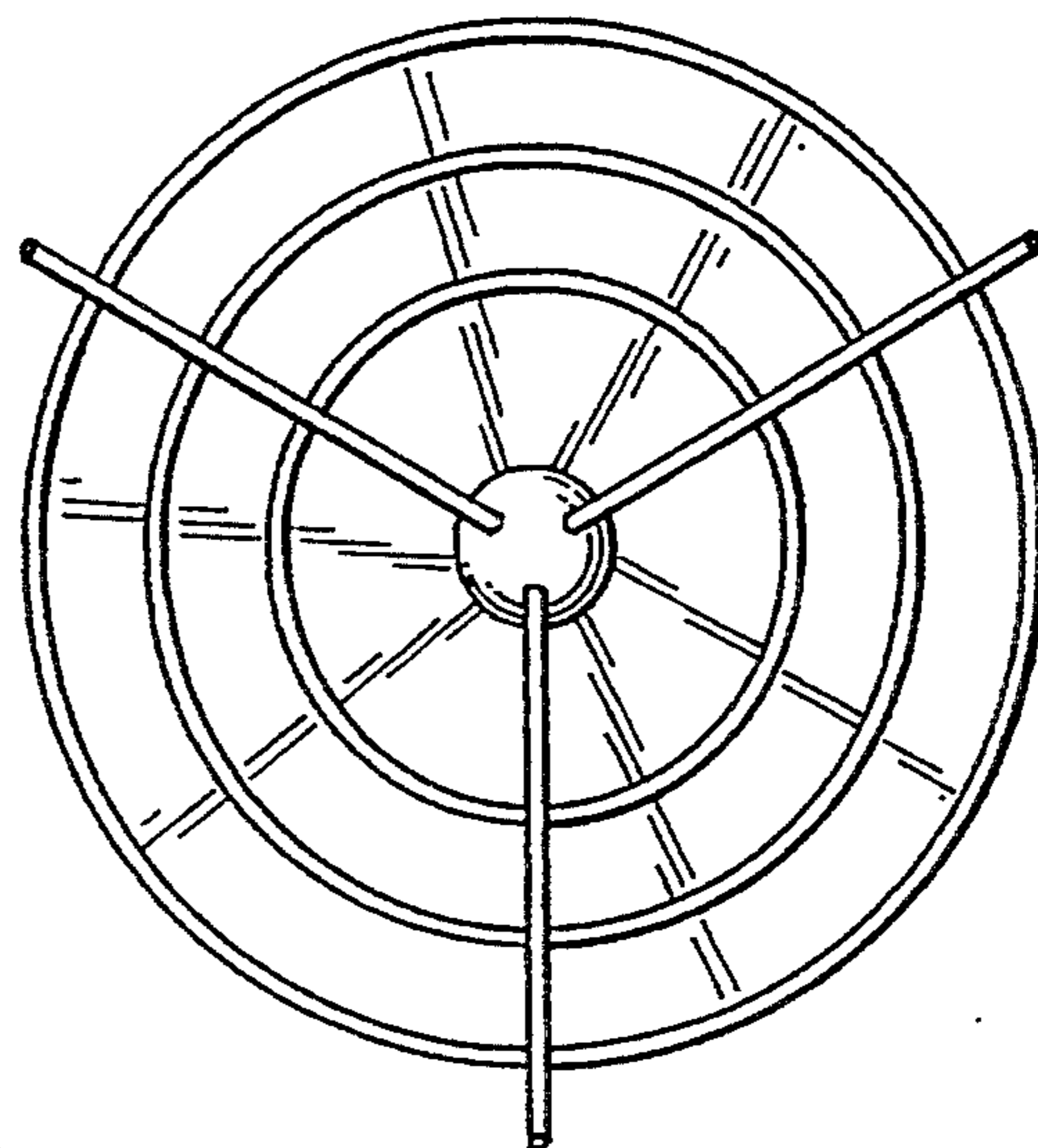
