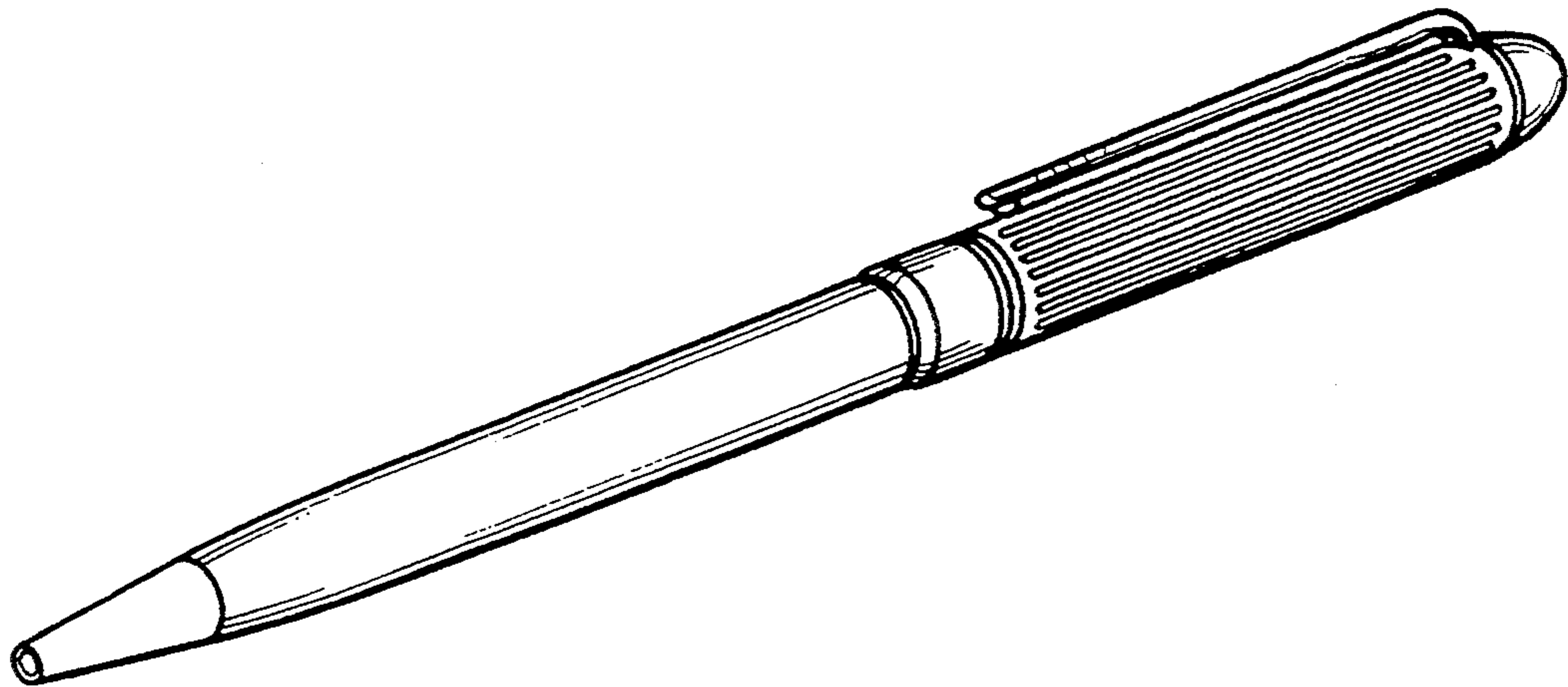

FIG. 4 is a side view of the writing instrument of the present invention as shown in FIG. 1.



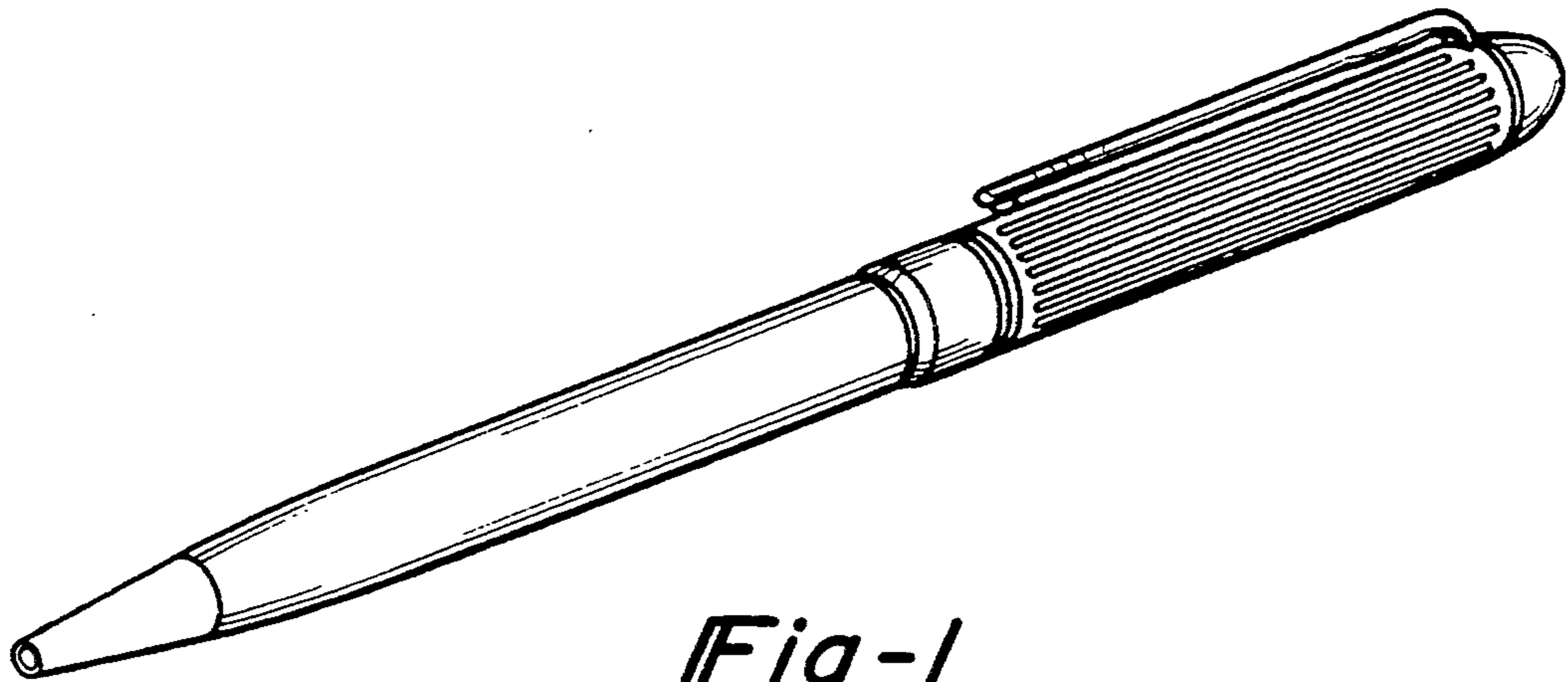
