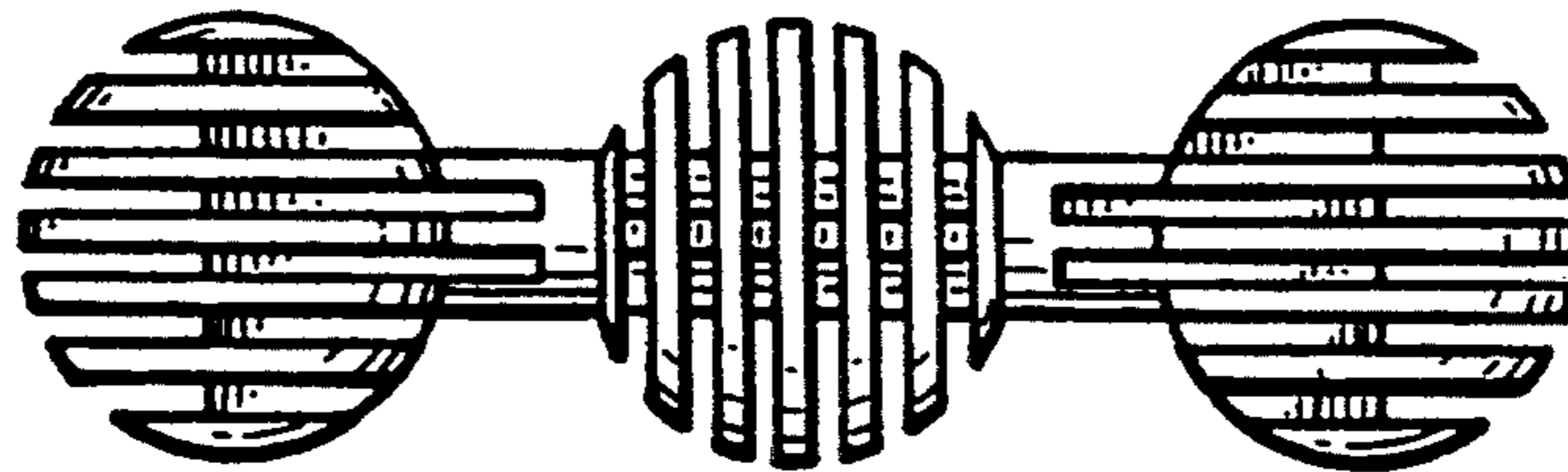

[57] CLAIM

The ornamental design for a toy construction element, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a toy construction element showing my new design, the bottom plan view being the same in appearance;
FIG. 2 is a side elevation view thereof, the opposite side being the same in appearance; and,
FIG. 3 is a front elevation view thereof, the opposite side being the same in appearance.



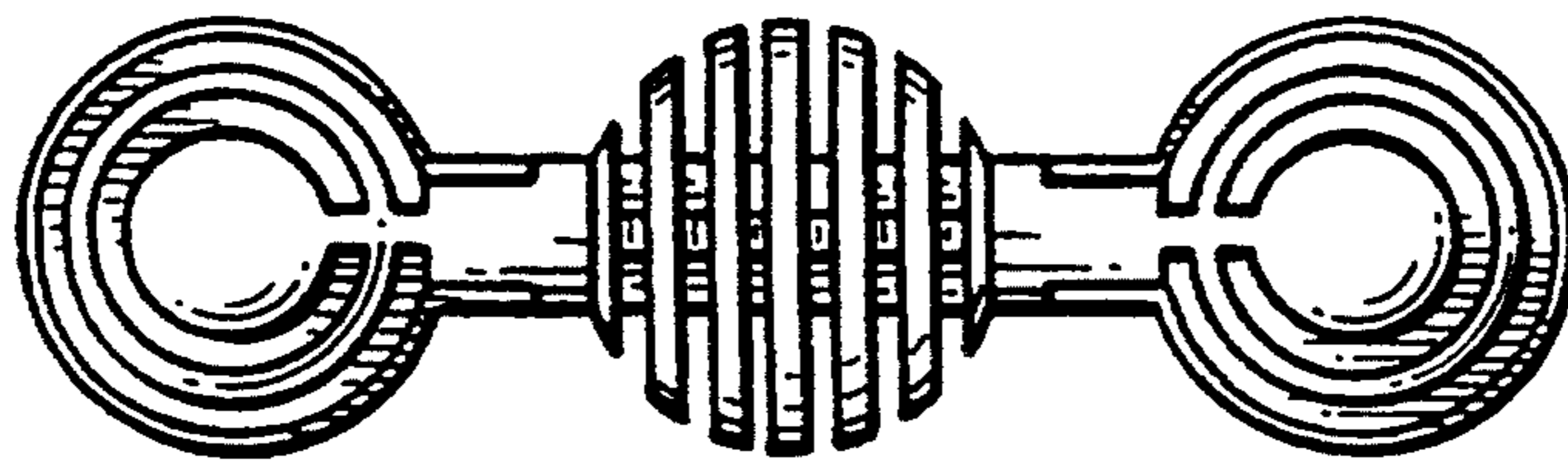

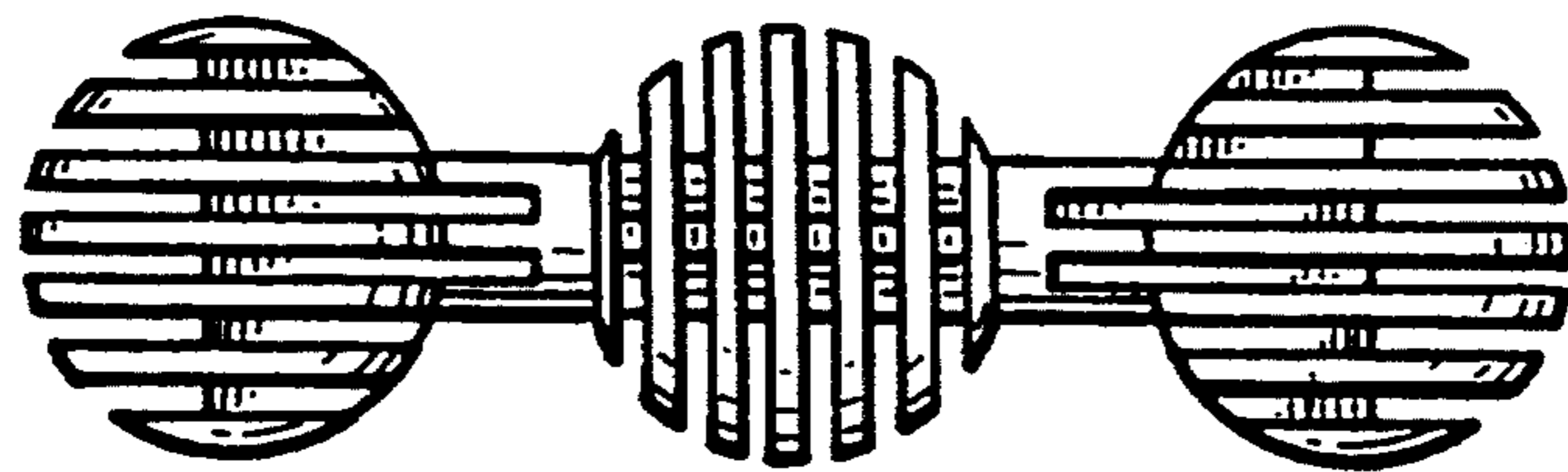

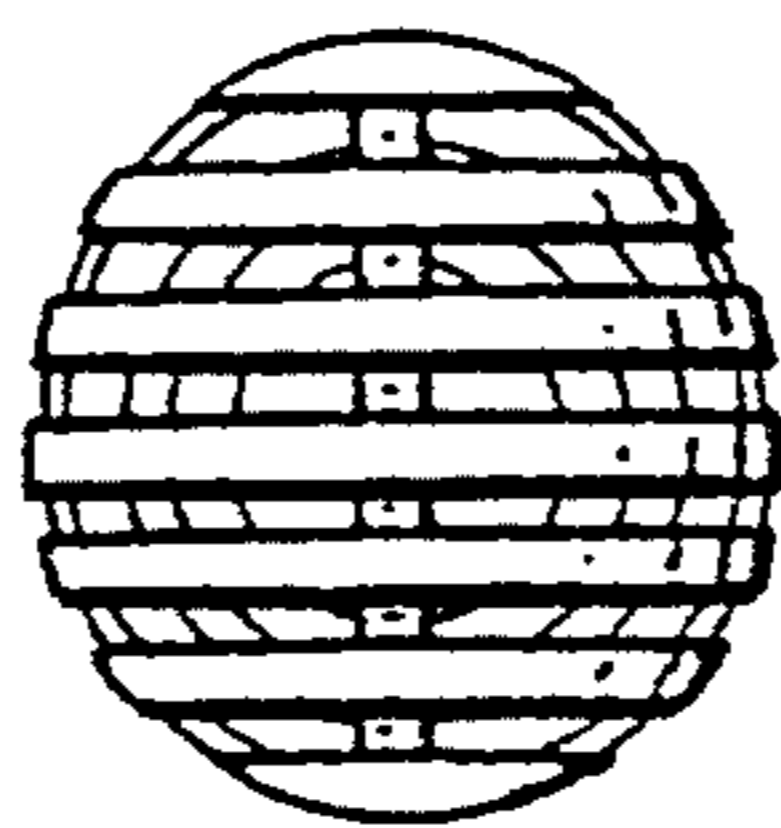
