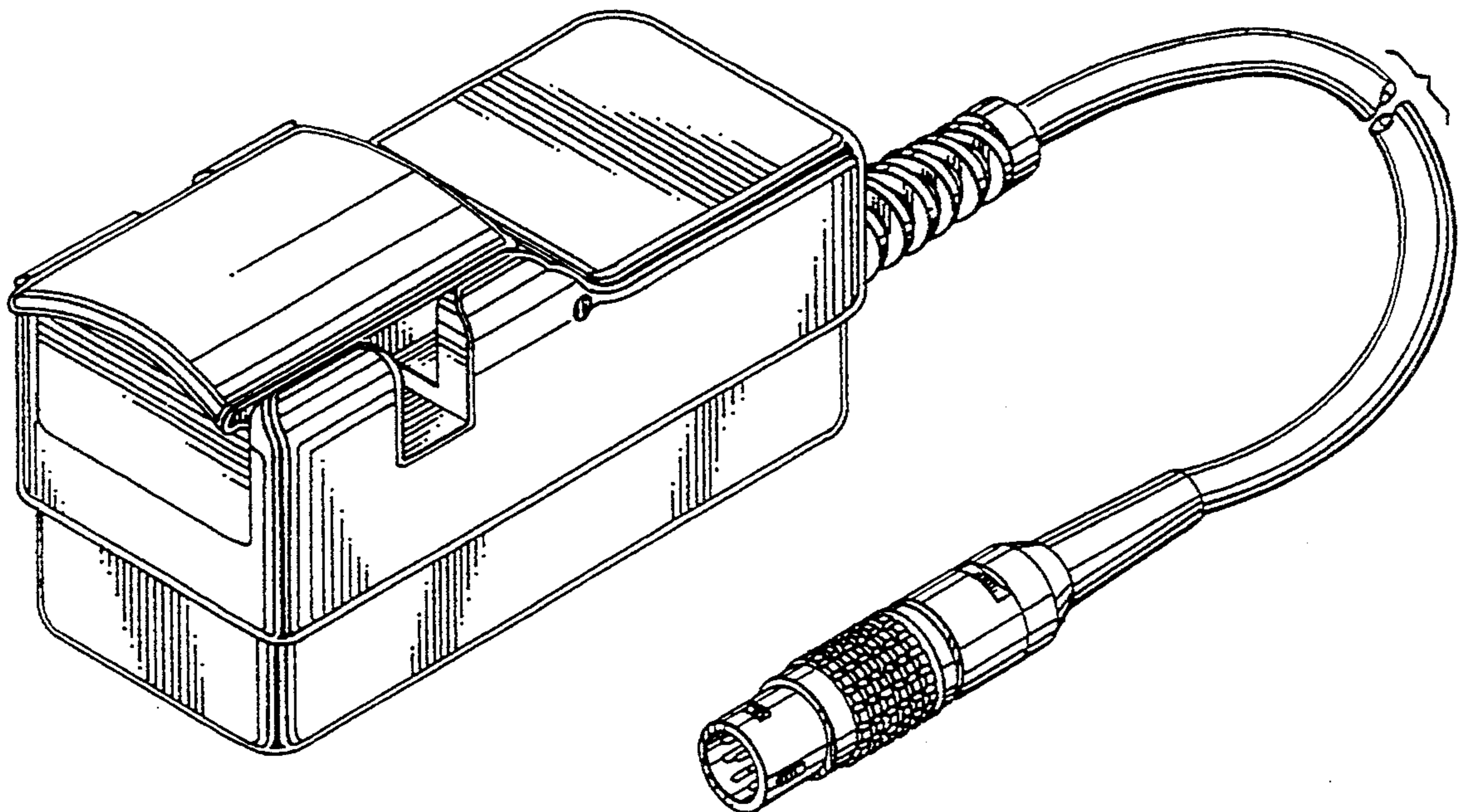

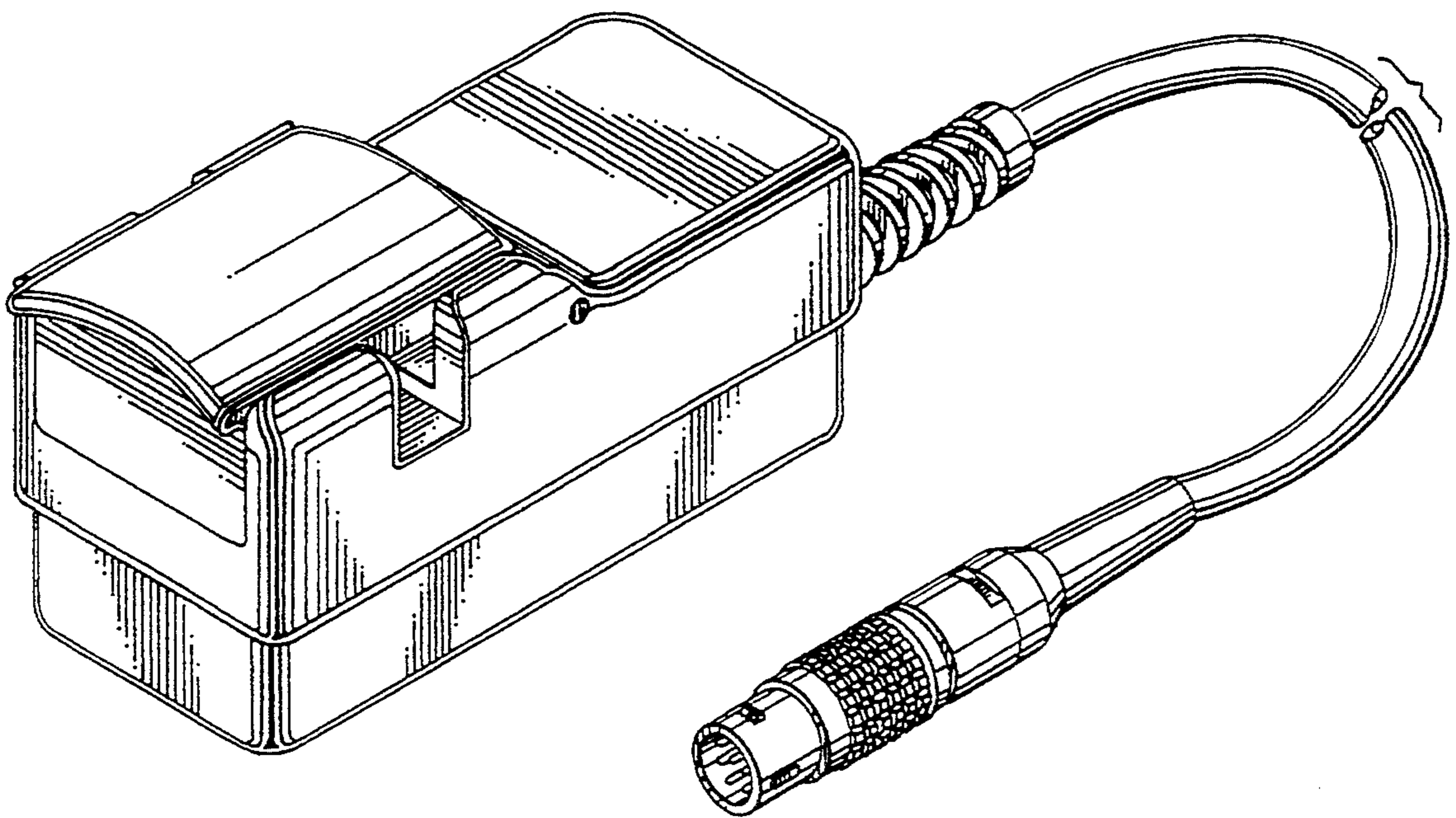
The ornamental design for a fluid flow transducer, as shown.

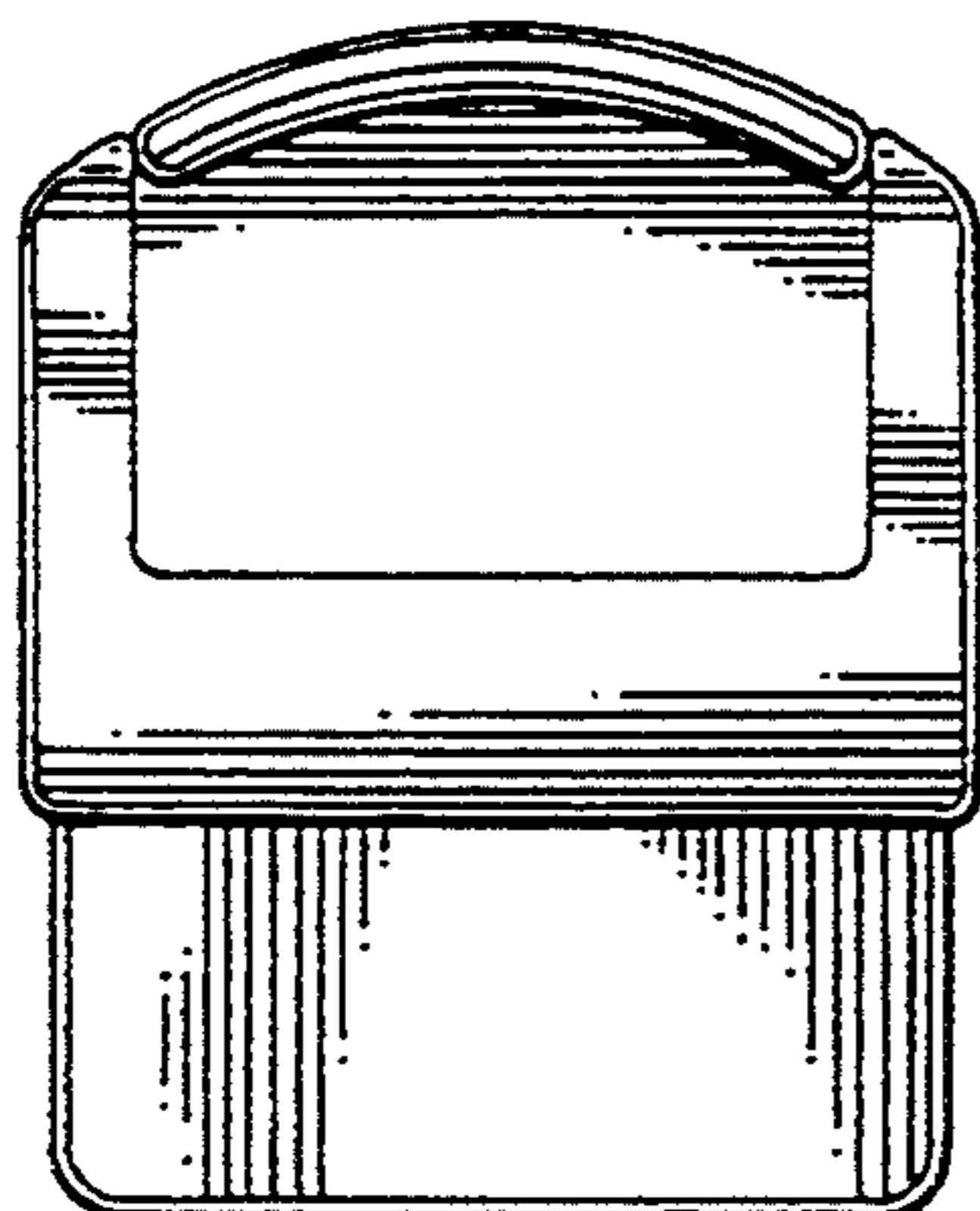
FIG. 1 is a perspective view thereof;

 FIG. 7 is a bottom plan view thereof.



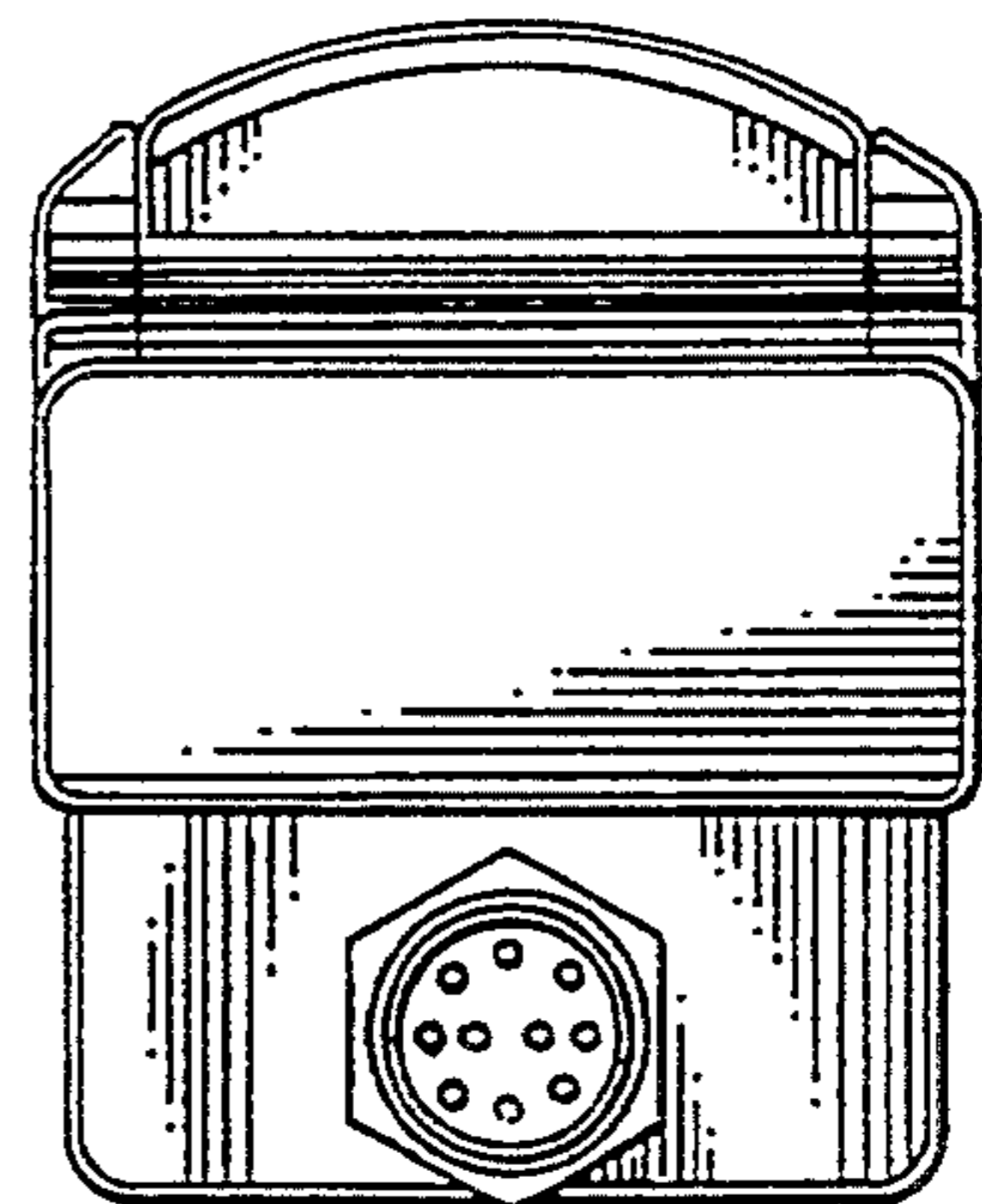

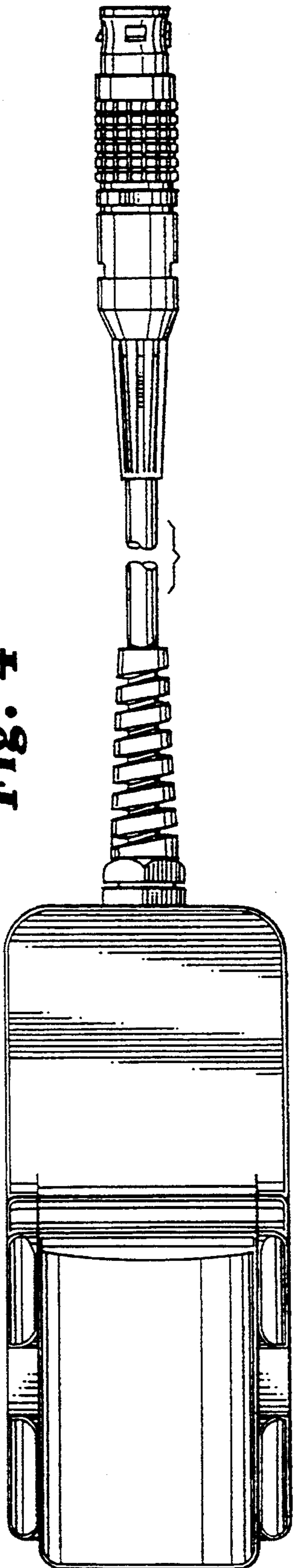

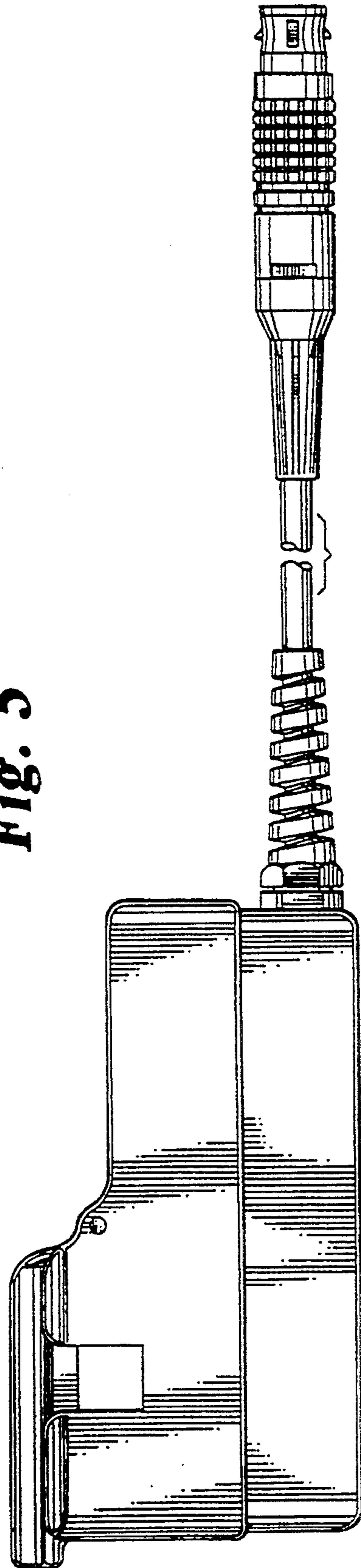

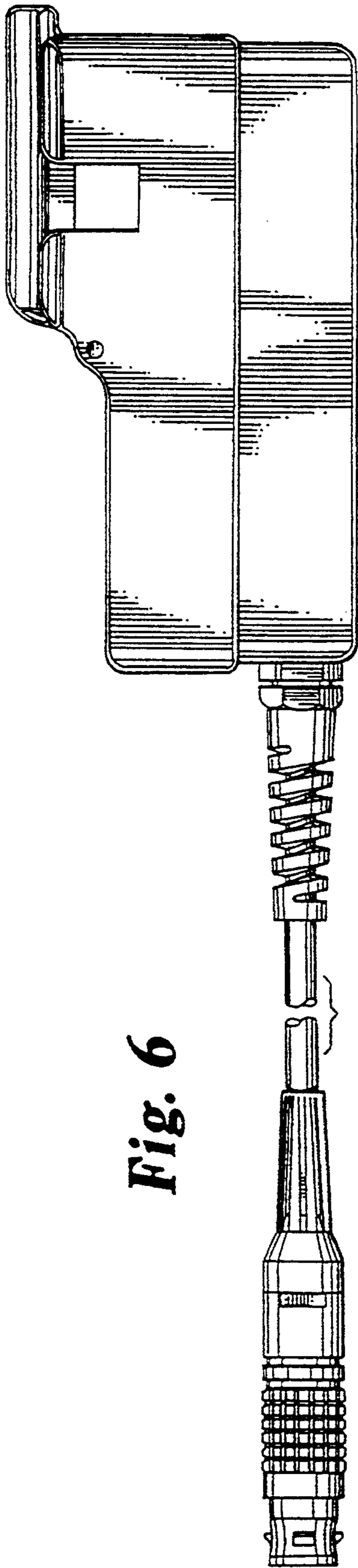
