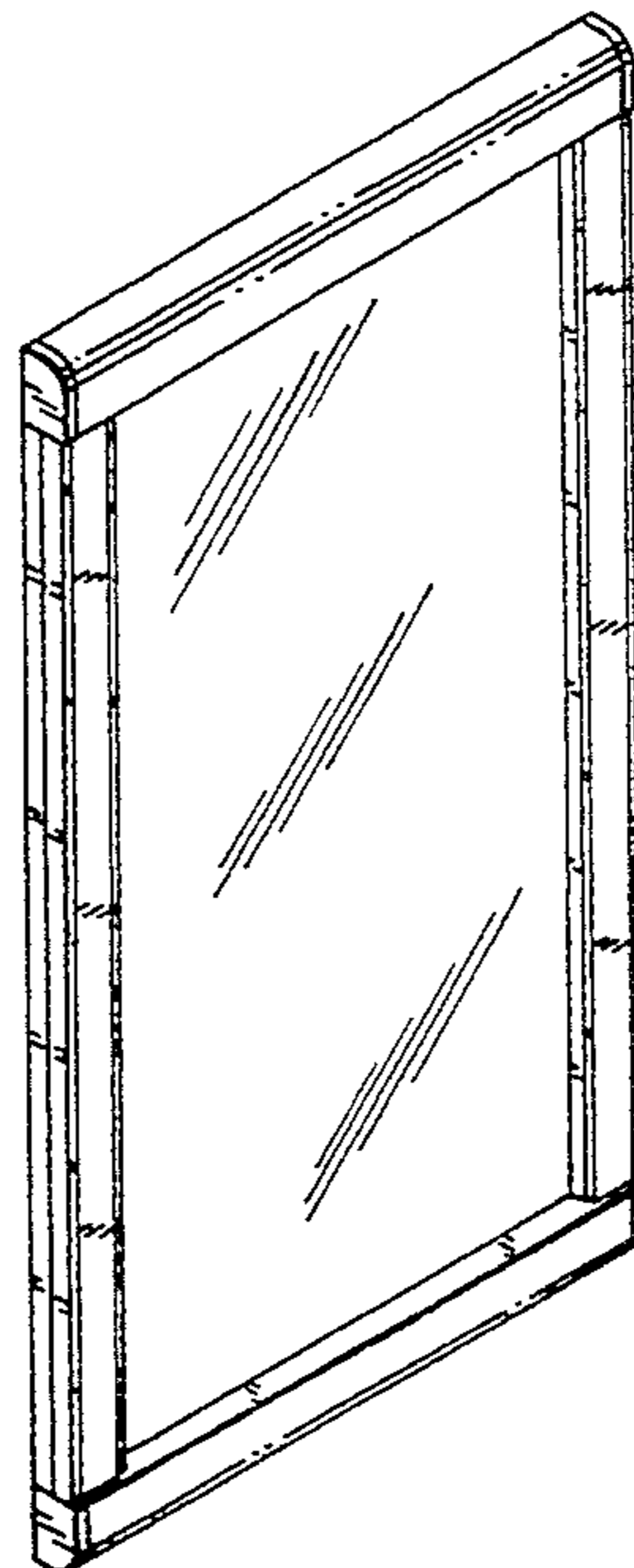
The ornamental design for a wall mounted sign frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the inventive wall mounted sign frame;
 FIG. 2 is a top plan view of the inventive wall mounted sign frame, with the bottom plan view being identical;
 FIG. 3 is a right side elevational view of inventive the wall mounted sign frame, with the left side elevational view being identical;
 FIG. 4 is a front plan view of the inventive wall mounted sign frame;
 FIG. 5 is a rear view of the inventive wall mounted sign frame;
 FIG. 6 is a left side elevational view of the inventive wall mounted sign frame;
 FIG. 7 is a bottom plan view of the inventive wall mounted sign frame; and,
 FIG. 8 is a cross-sectional view of the inventive wall mounted sign frame taken along line 8—8 in FIG. 4 and in the direction of the arrows.

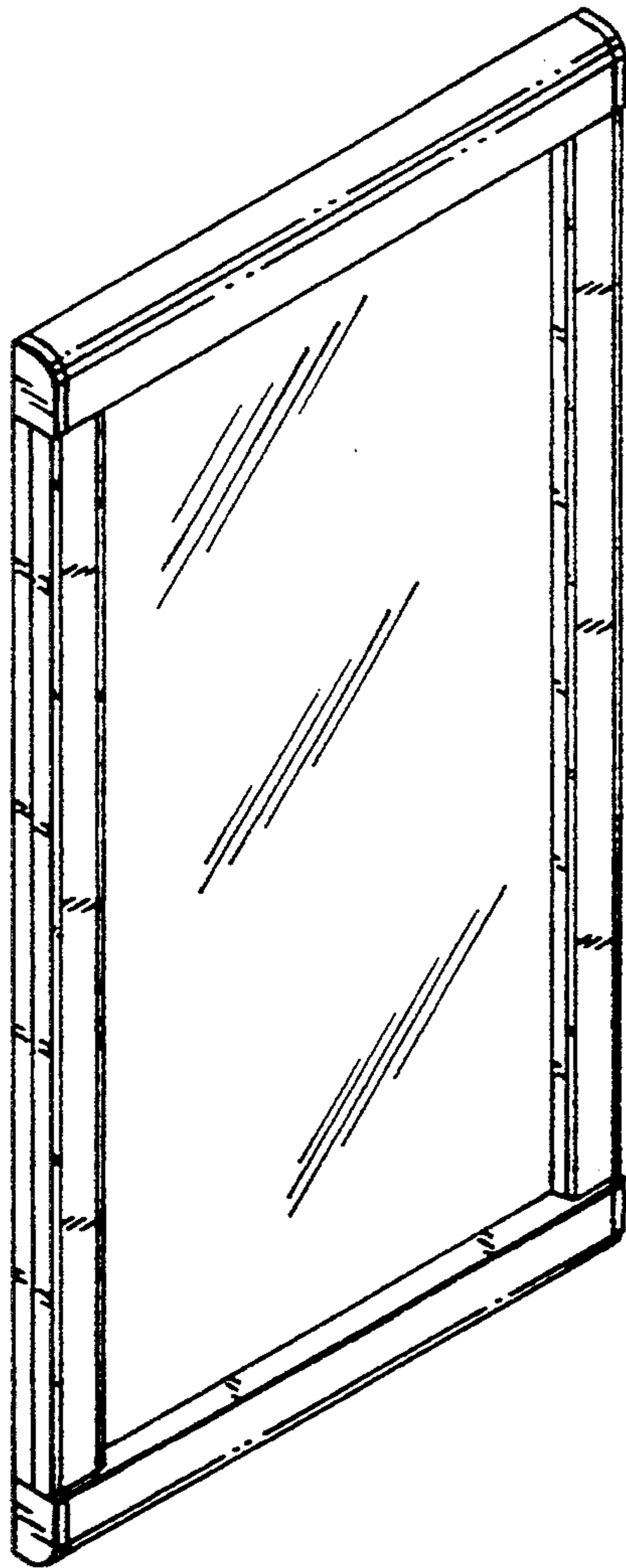

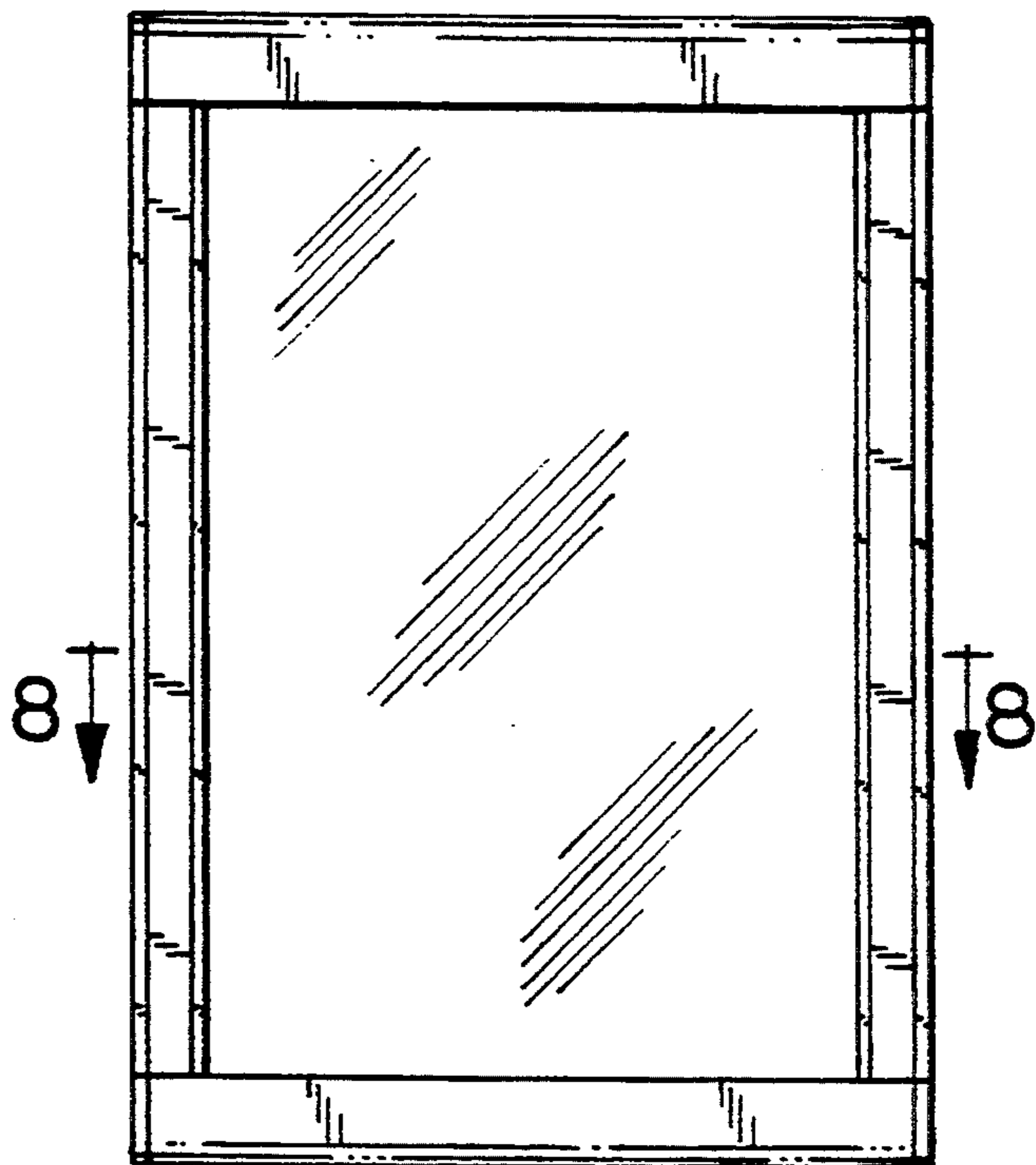

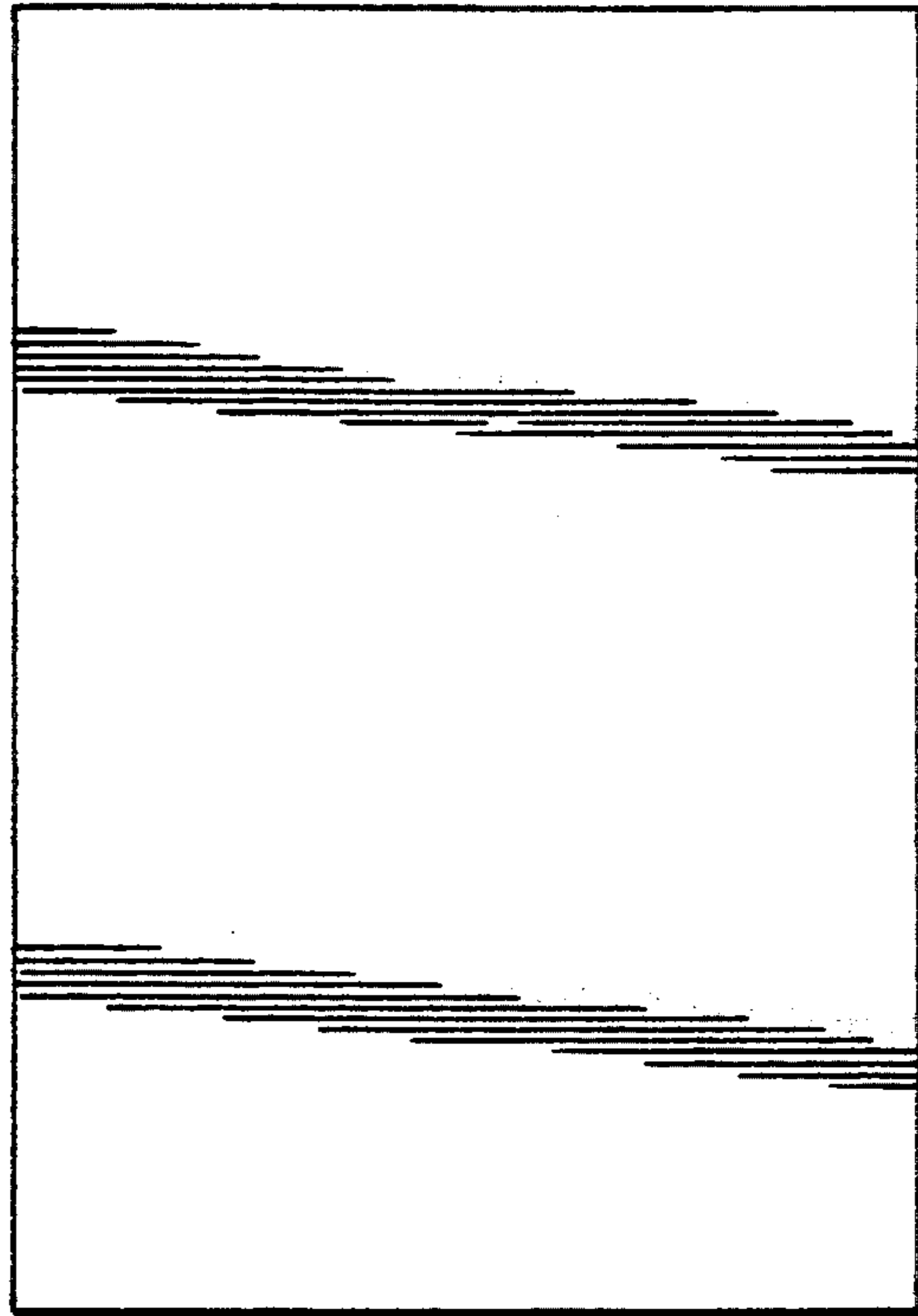

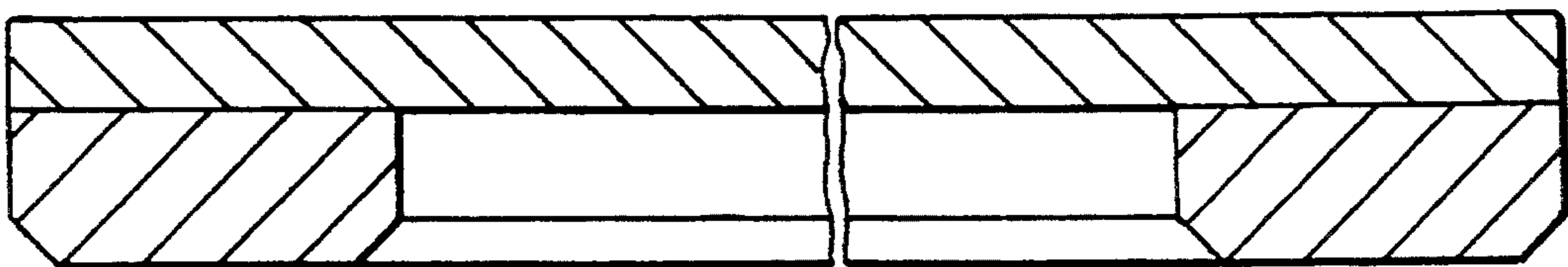
