The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a chair showing my new design;

FIG. 2 is a perspective view of a chair showing a second embodiment of my new design;

FIG. 3 is a front elevational view of the chair shown in FIG. 1;

FIG. 4 is a rear elevational view of the chair shown in FIG. 1;

FIG. 5 is a top plan view of the chair shown in FIG. 1;

FIG. 6 is a bottom plan view of the chair shown in FIG. 1;

FIG. 7 is a right side elevational view of the chair shown in FIG. 1;

FIG. 8 is a front elevational view of the chair shown in FIG. 2;

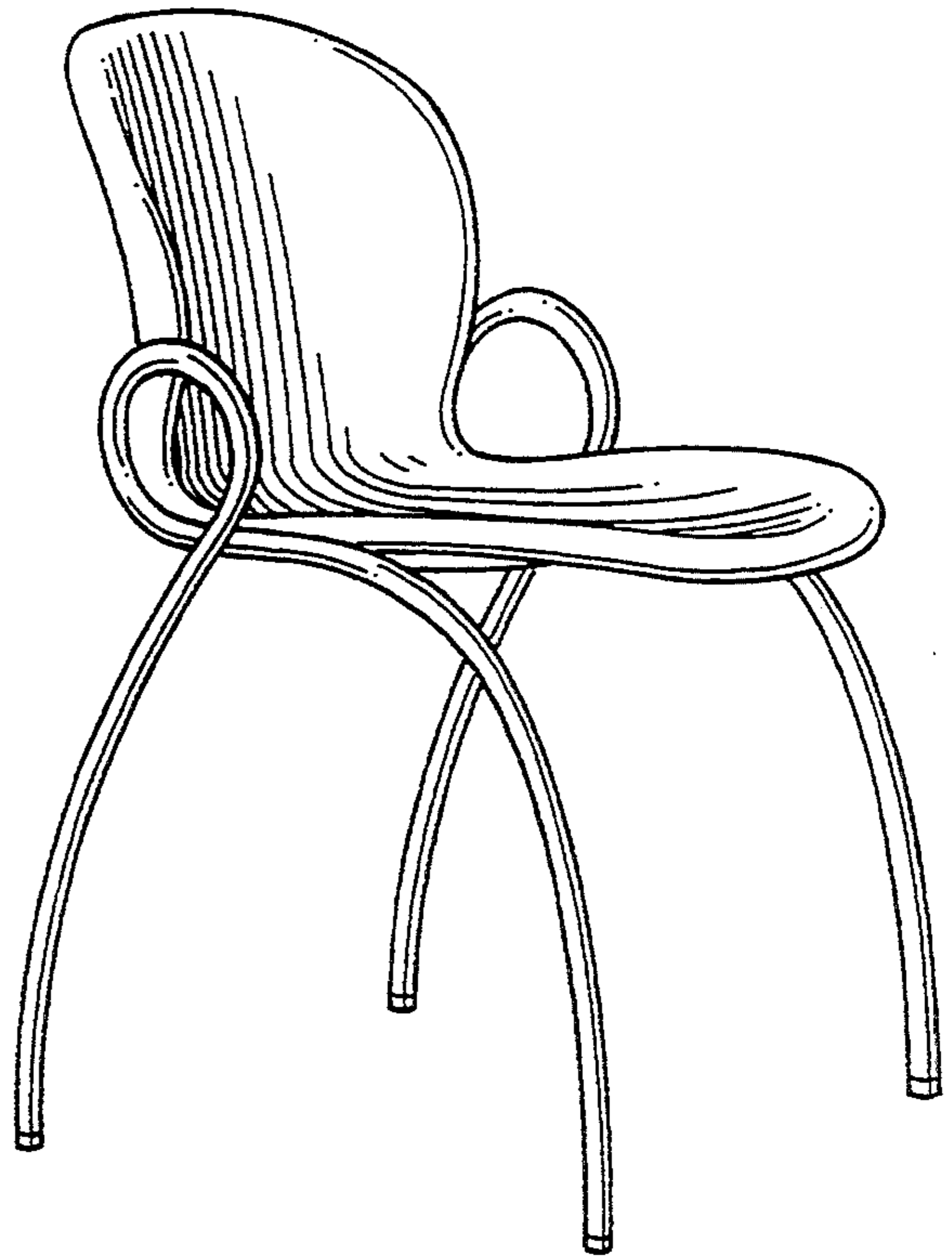
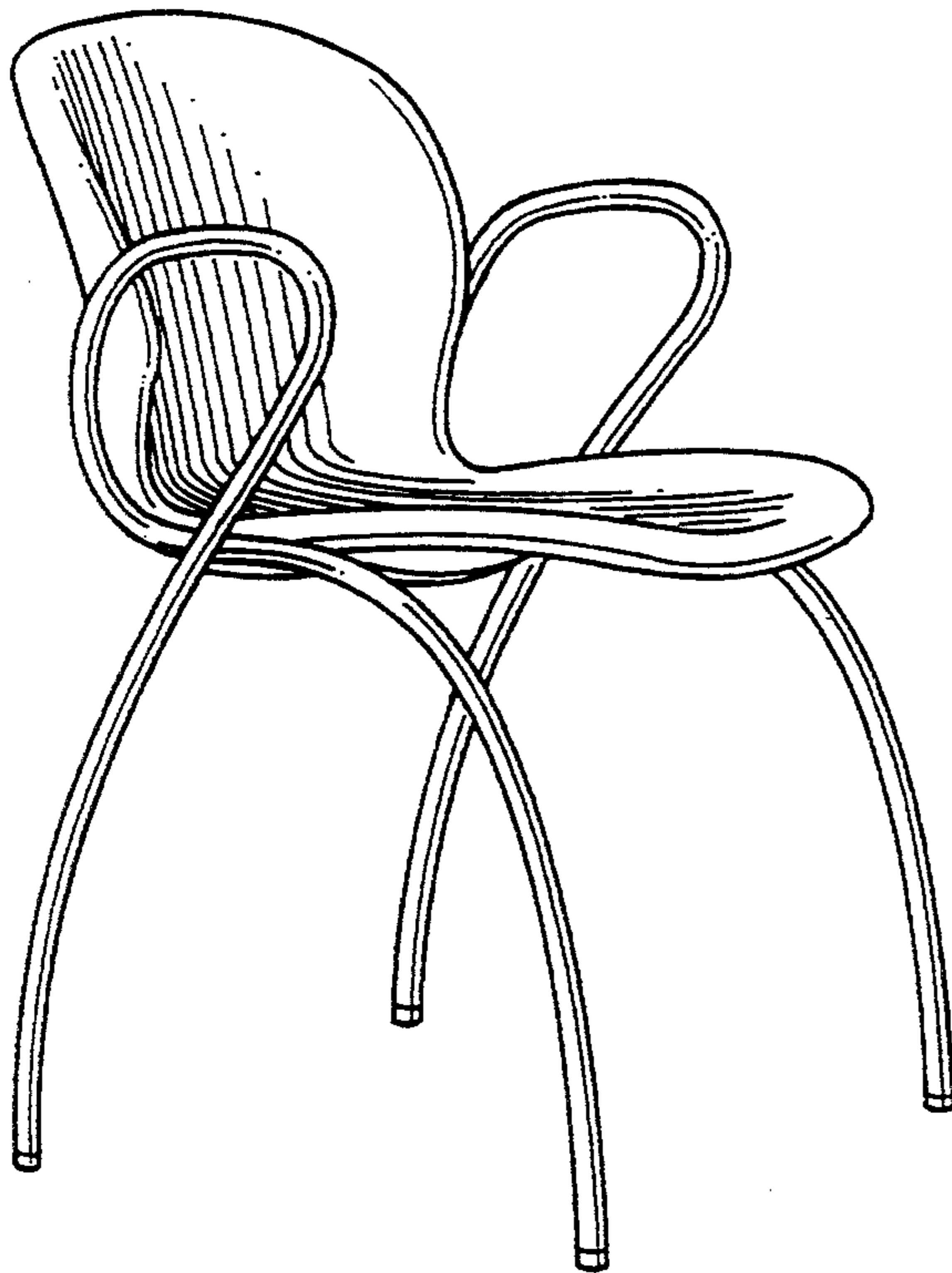
FIG. 9 is a rear elevational view of the chair shown in FIG. 2;

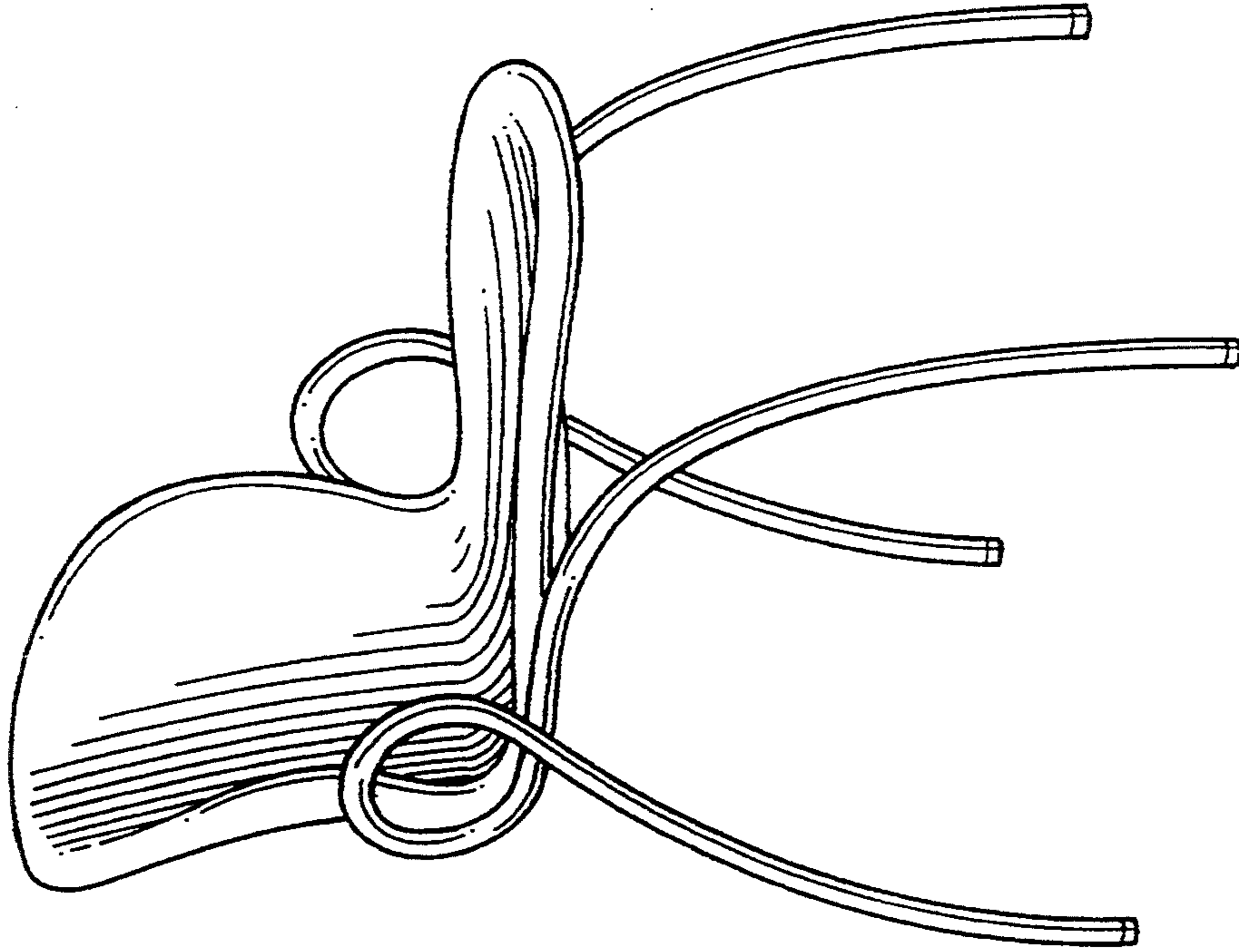

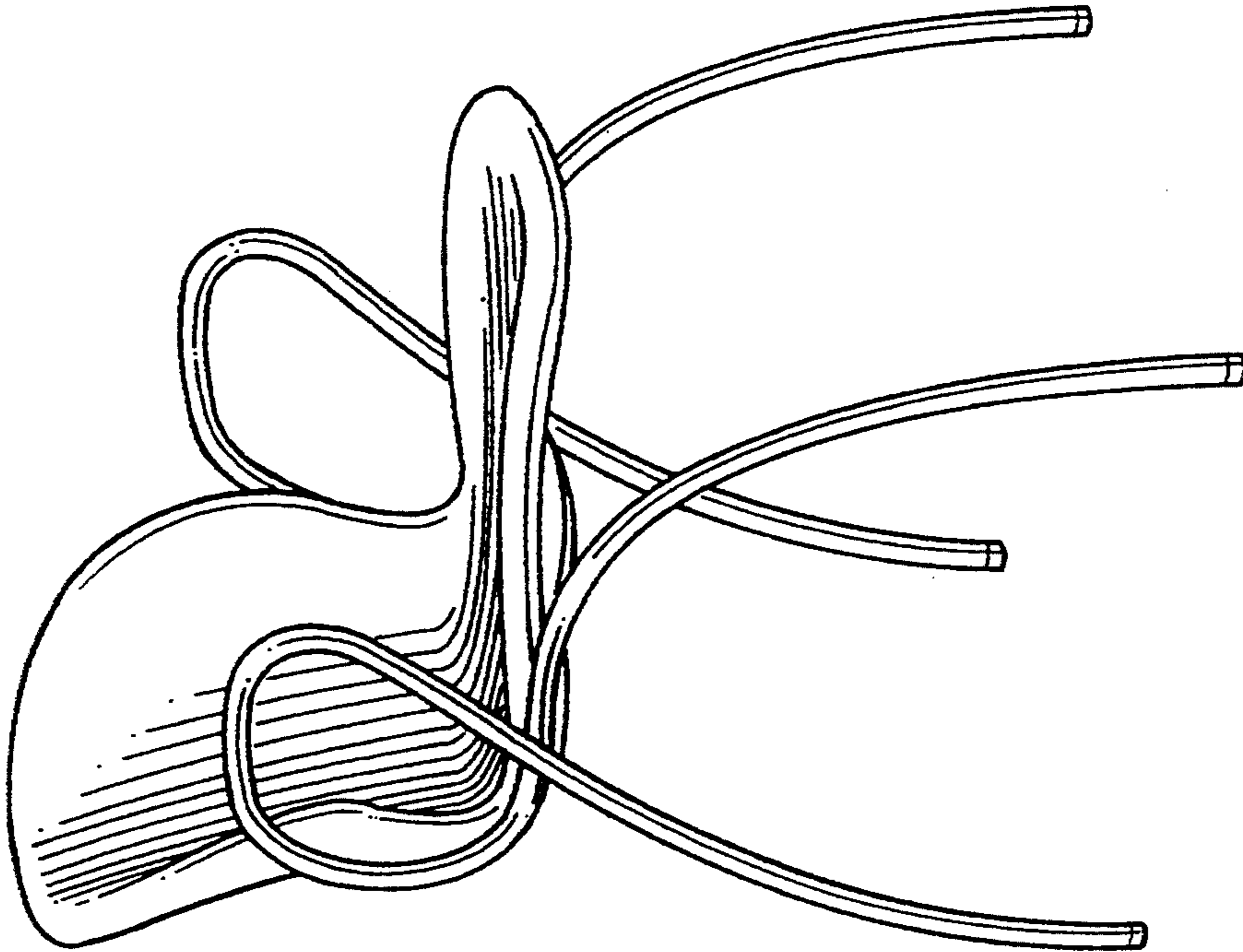

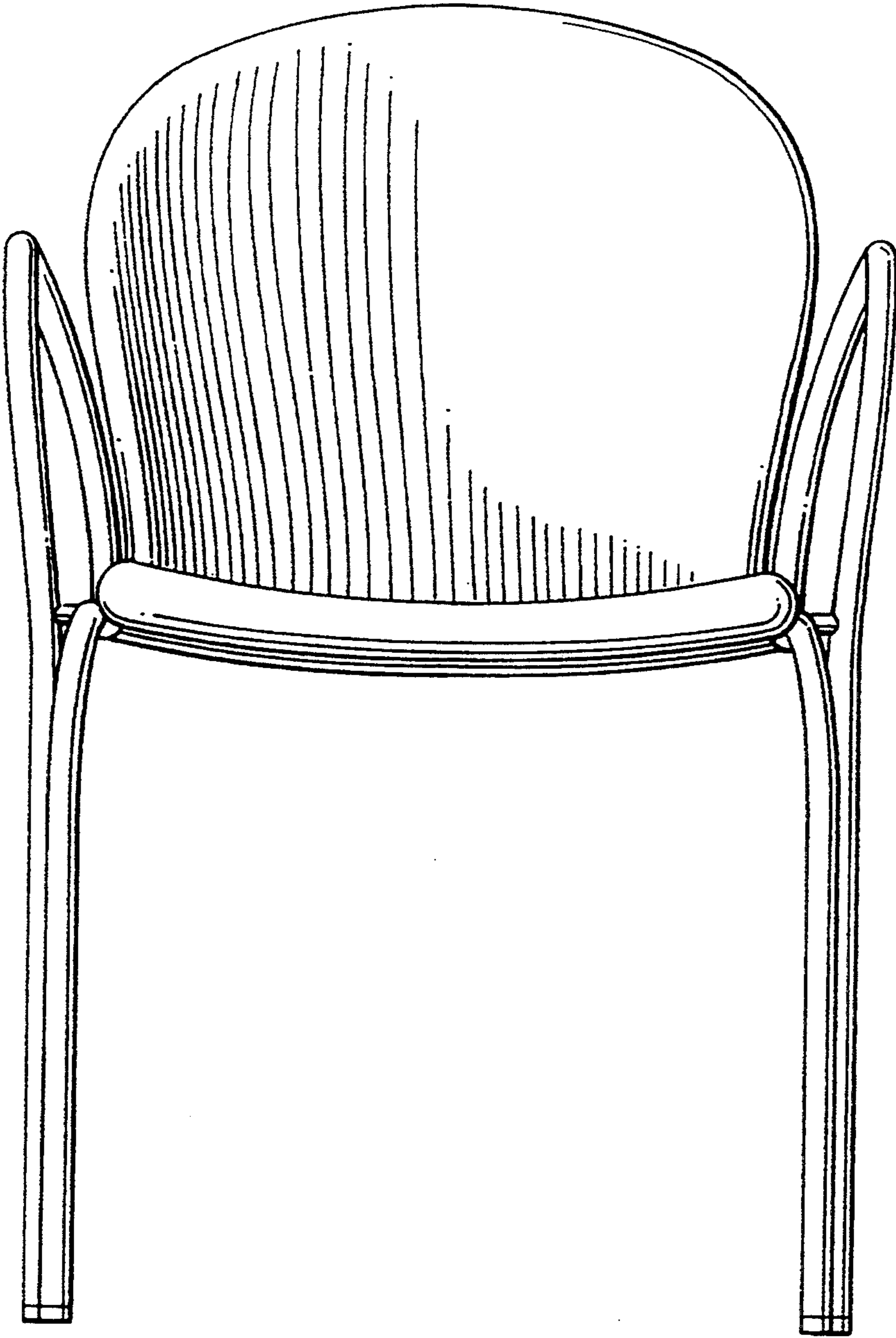

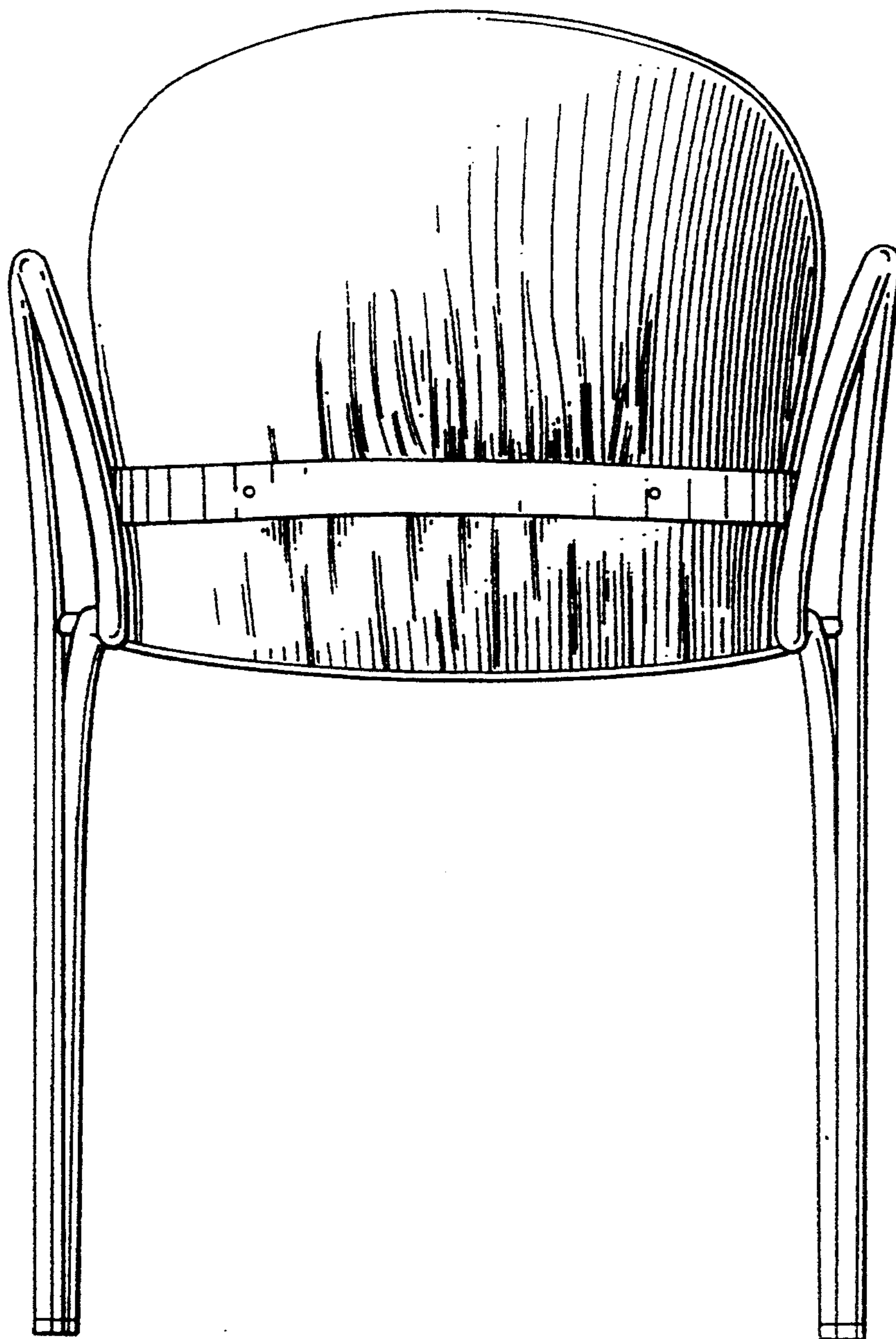

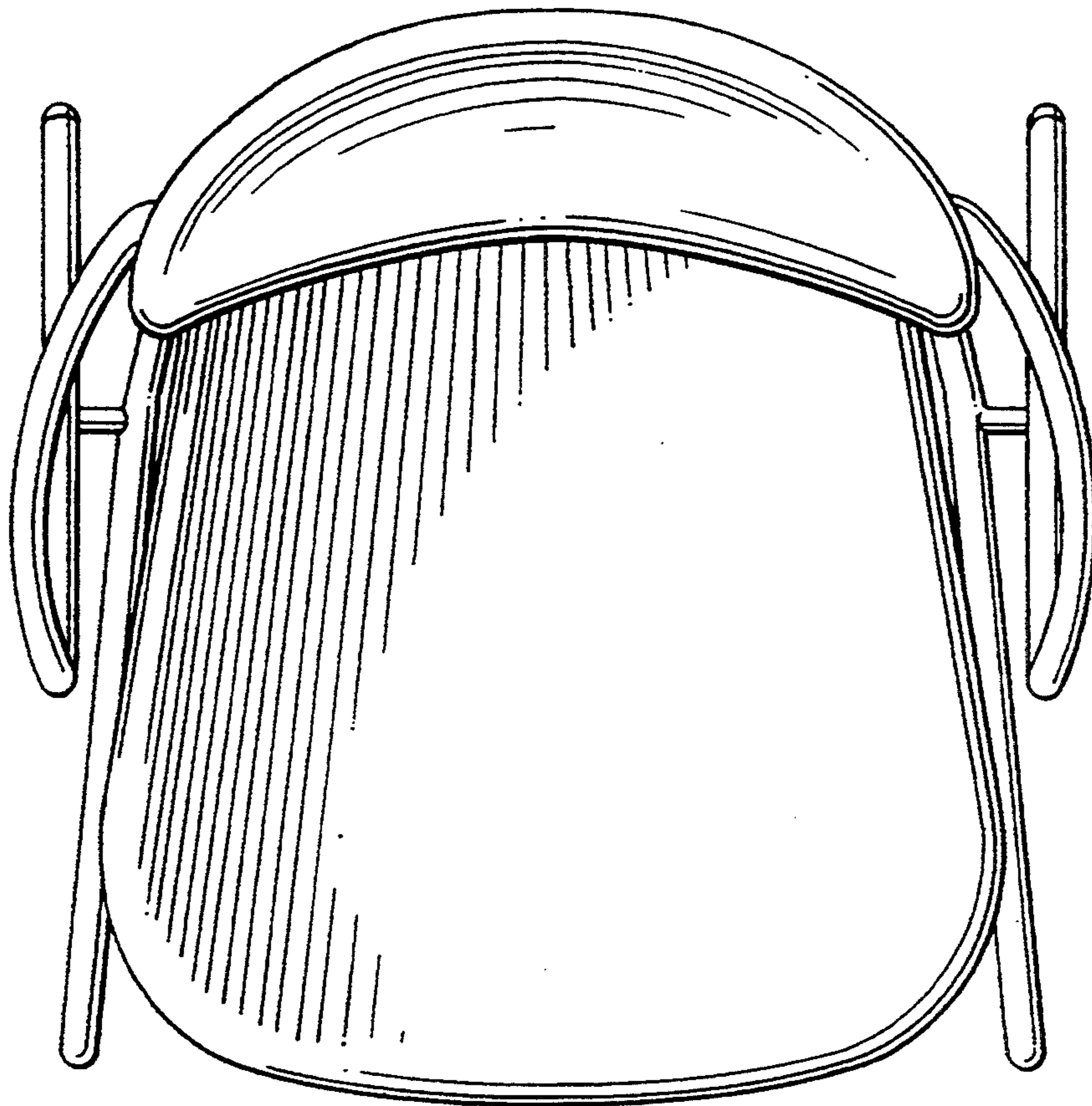

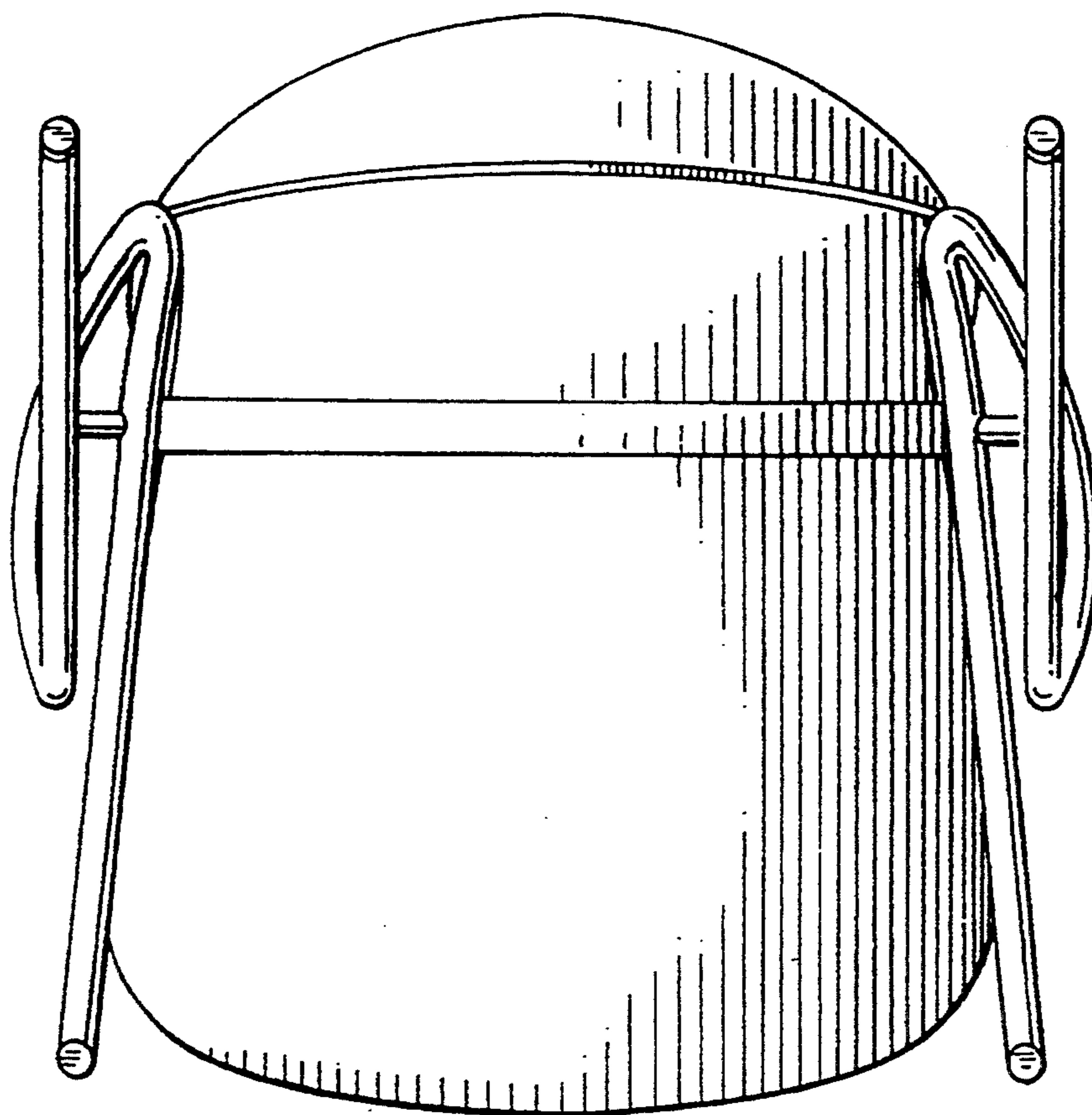

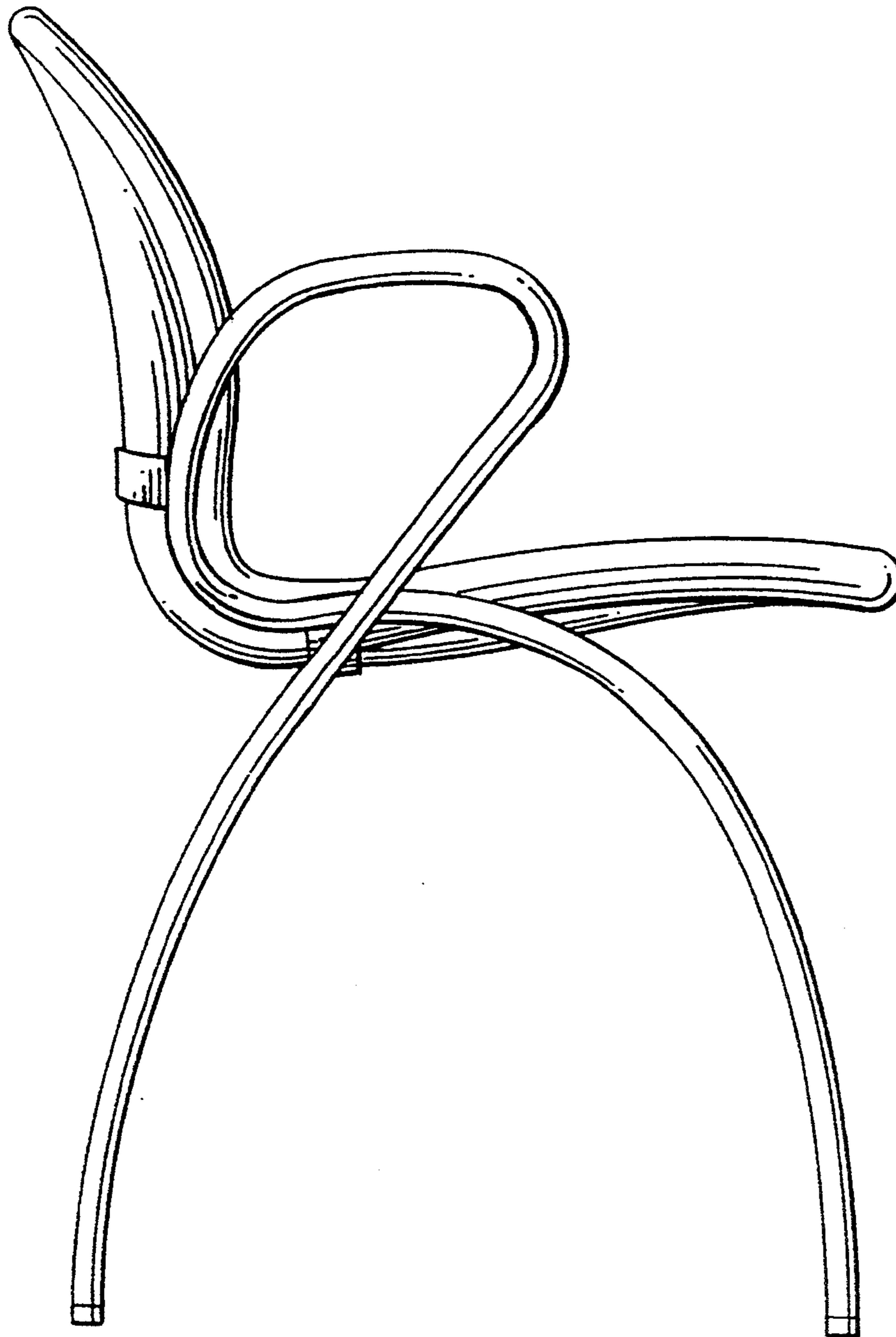

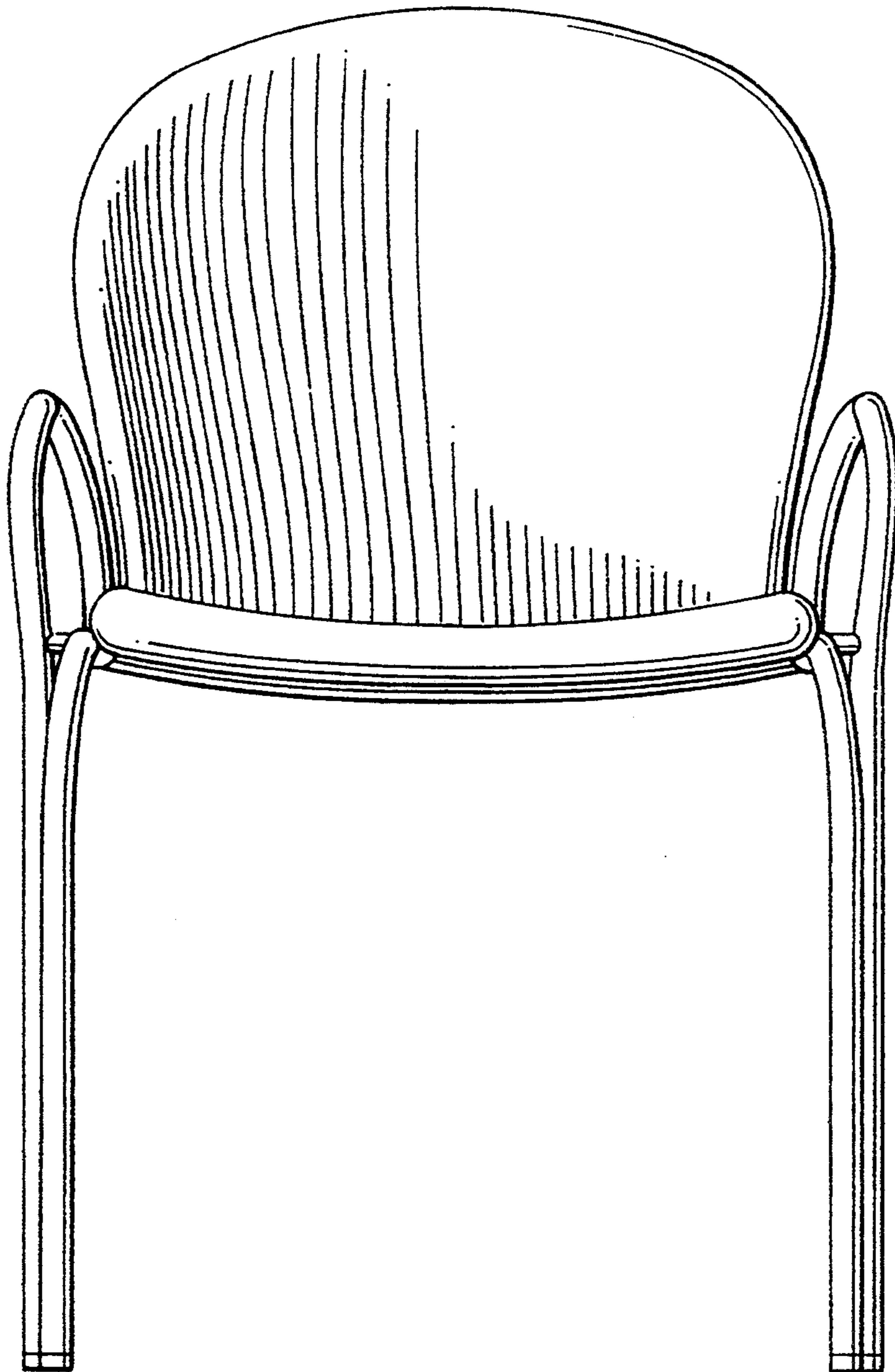

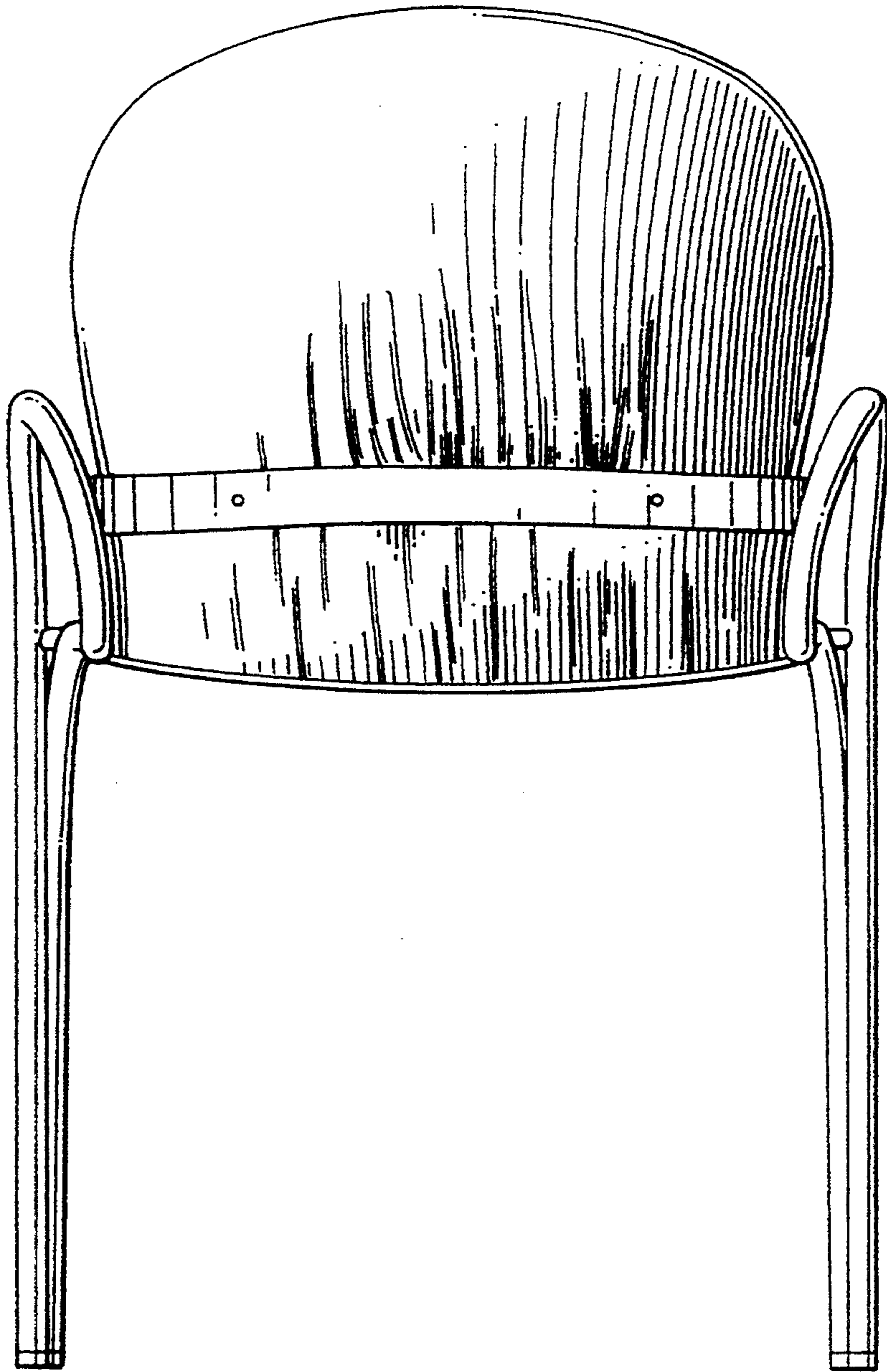

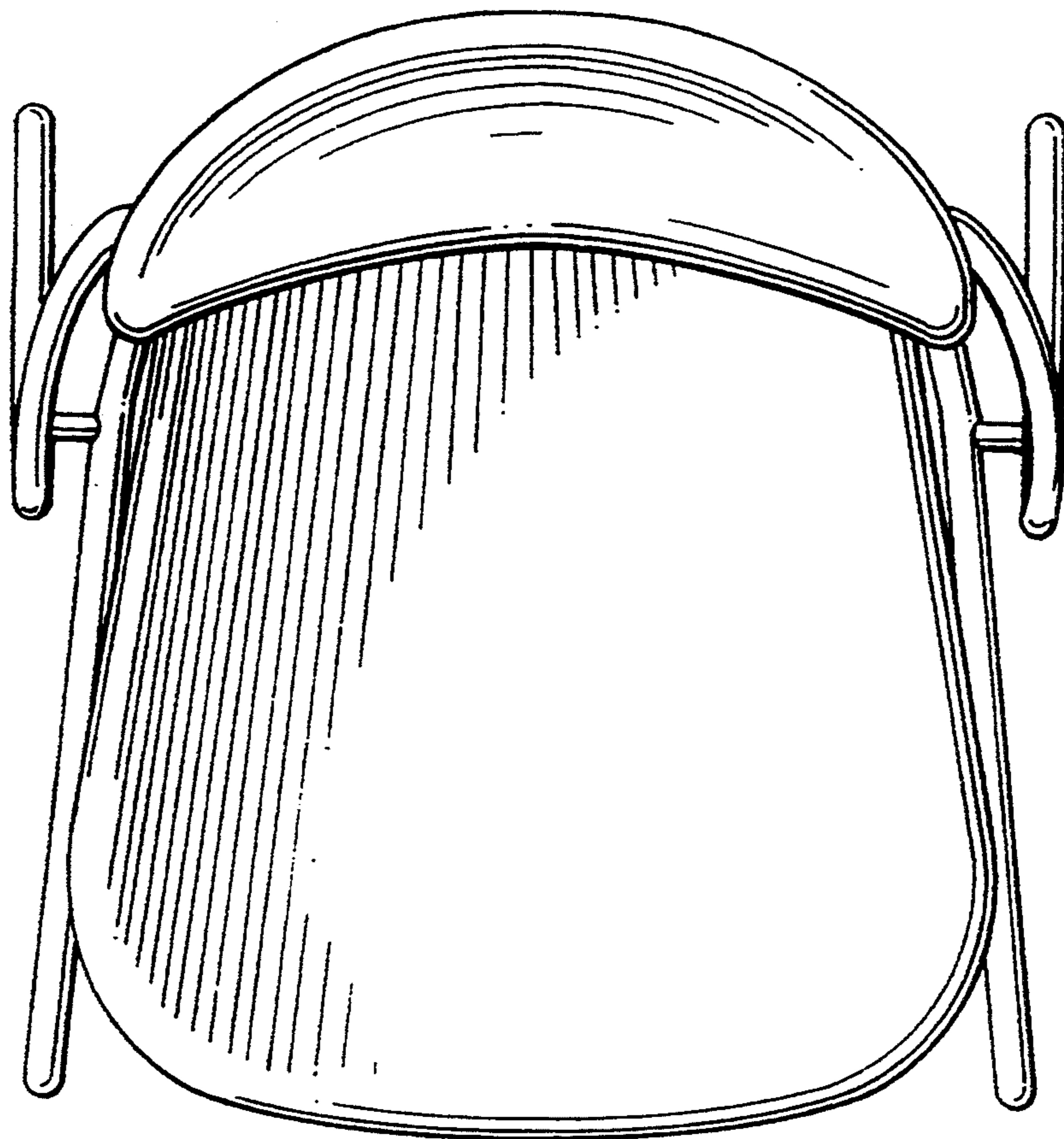

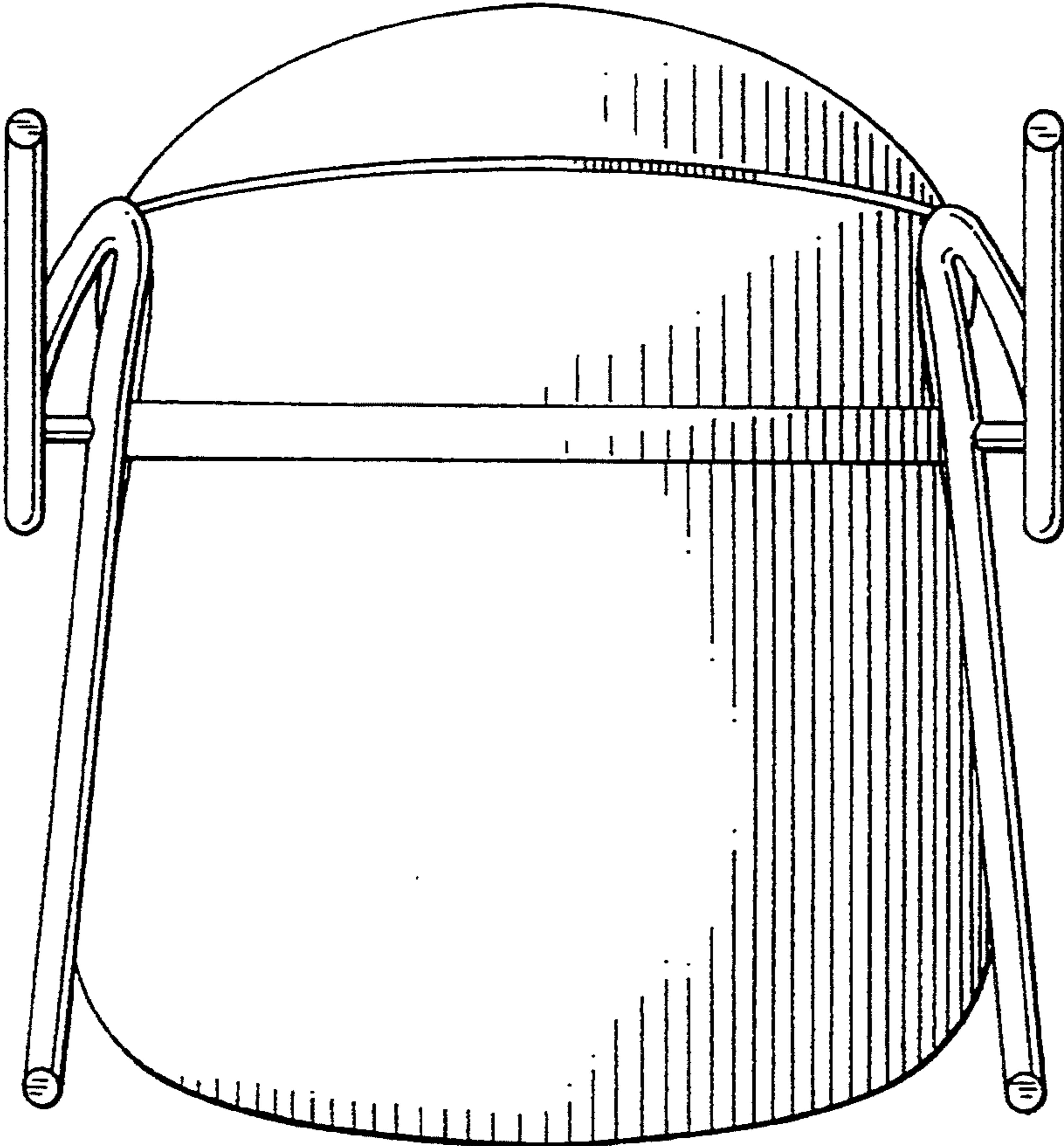

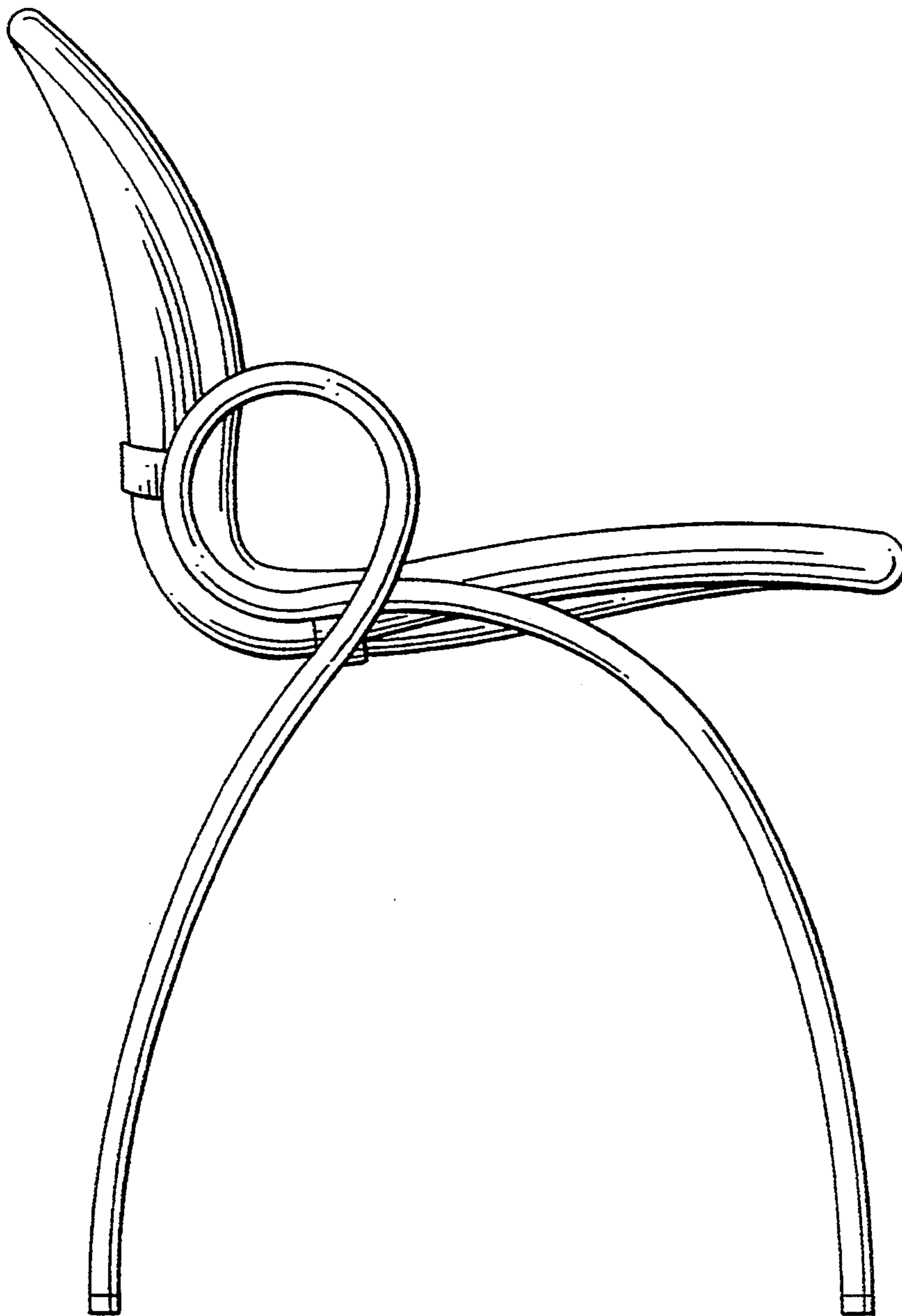
