[57] **CLAIM**

The ornamental design for a coffee brew cone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the coffee brew cone of the instant invention;  
FIG. 2 is a top plan view of the coffee brew cone of the instant invention;  
FIG. 3 is a bottom plan view of the coffee brew cone of the instant invention;  
FIG. 4 is an end view of the coffee brew cone of the instant invention rotated 90° from the position shown in FIG. 3;  
FIG. 5 is one side view of the coffee brew cone of the instant invention. The opposite view is the mirror image;  
FIG. 6 is the opposite end view of the coffee brew cone of the instant invention rotated 180° relative to FIG. 4; and,  
FIG. 7 is a sectional view of a coffee brew cone taken along the lines 7—7 of FIG. 2.
