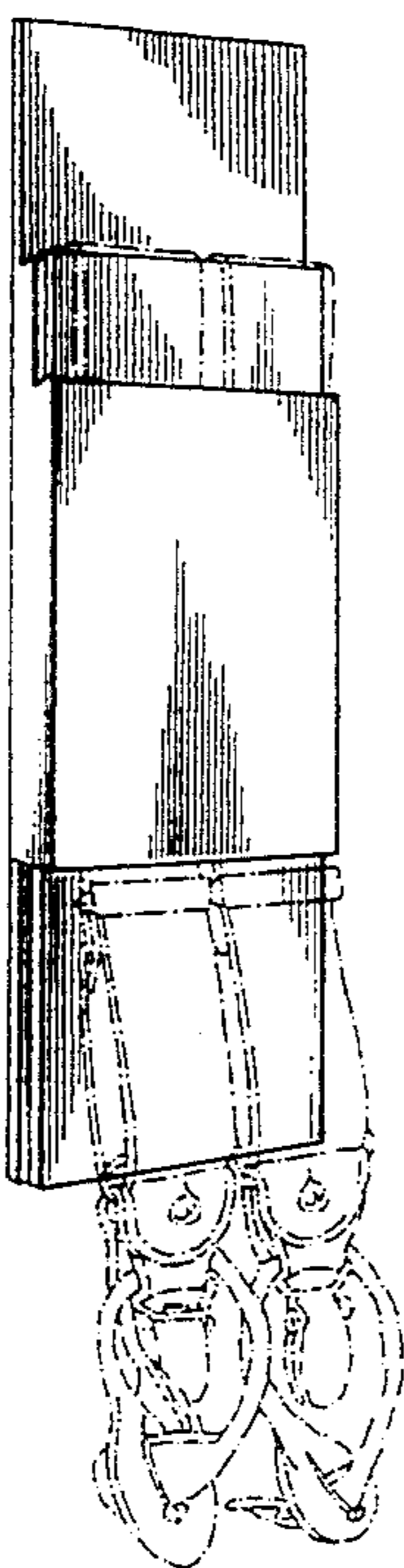

DESCRIPTION

FIG. 1 is a top plan view of a suspender package showing our new design;
 FIG. 2 is a bottom plan view of thereof;

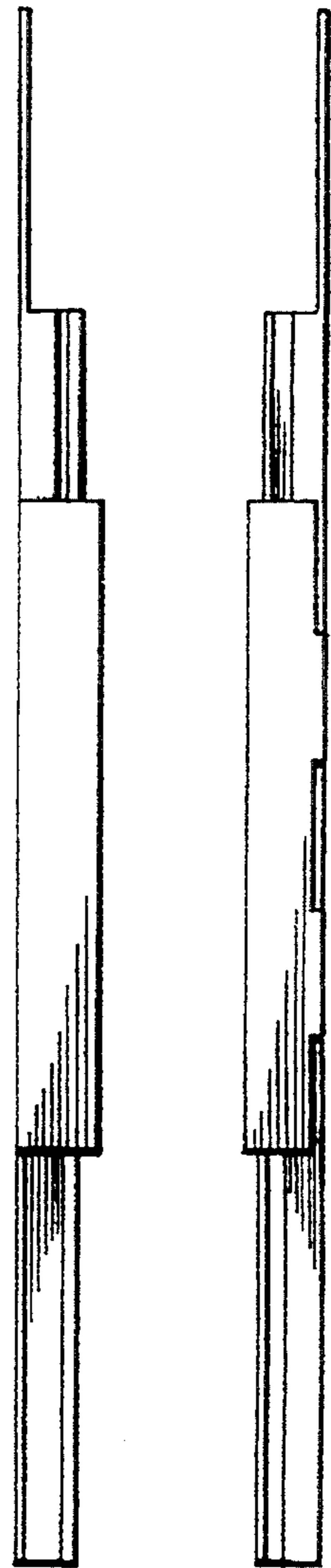


FIG. 3 FIG. 4

 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a front elevational view thereof;
 FIG. 6 is a rear elevational view thereof; and,
 FIG. 7 is a perspective view thereof from the top and left side.
 The broken line showing of articles in FIG. 7 is for illustrative purpose only and forms no part of the design.



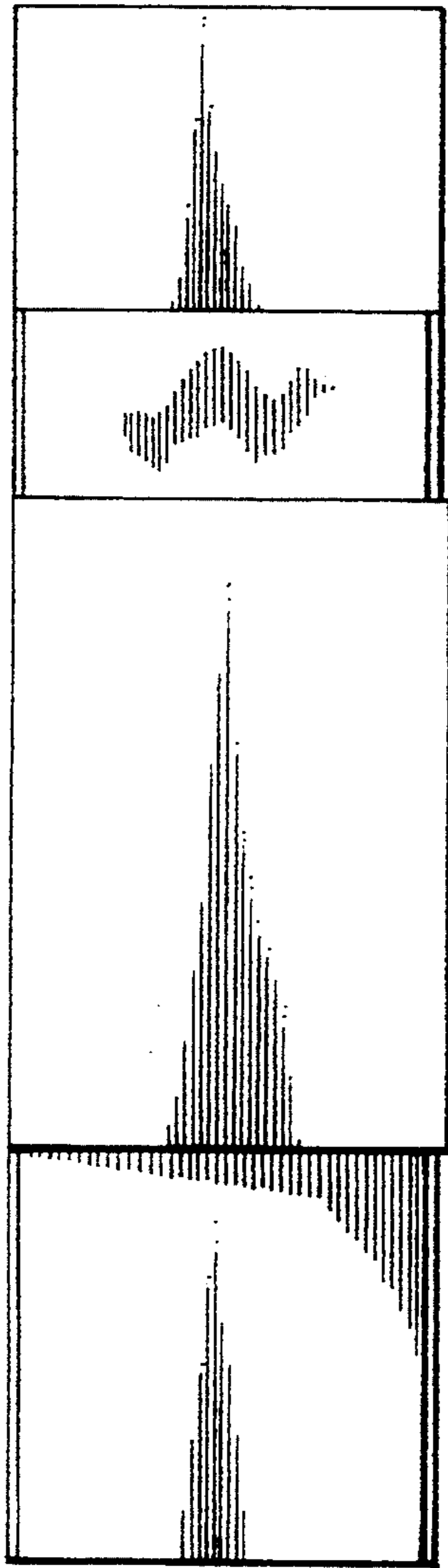

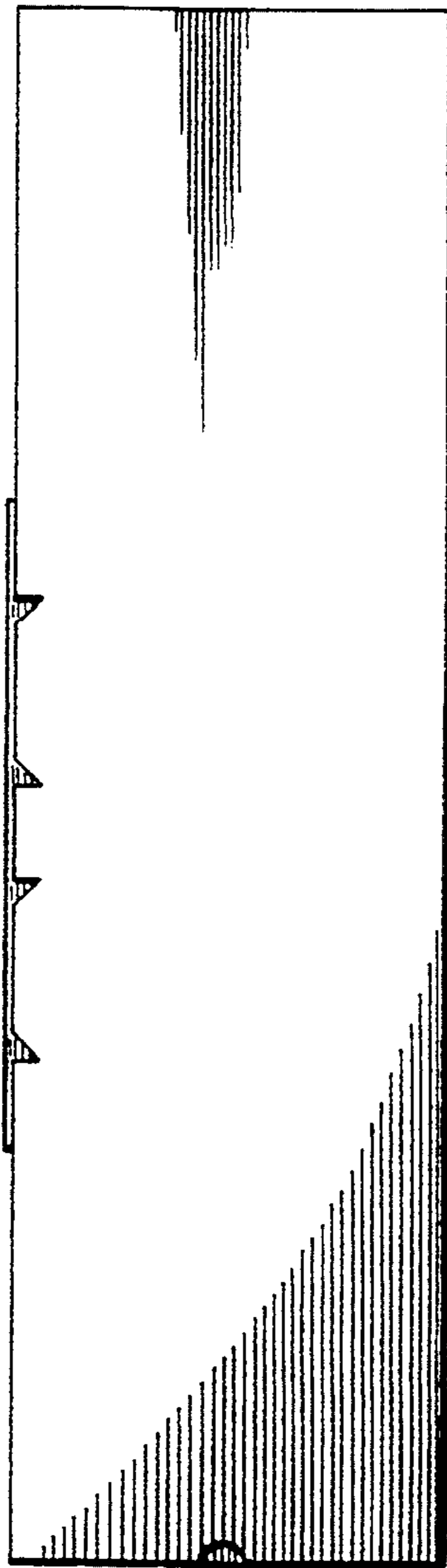

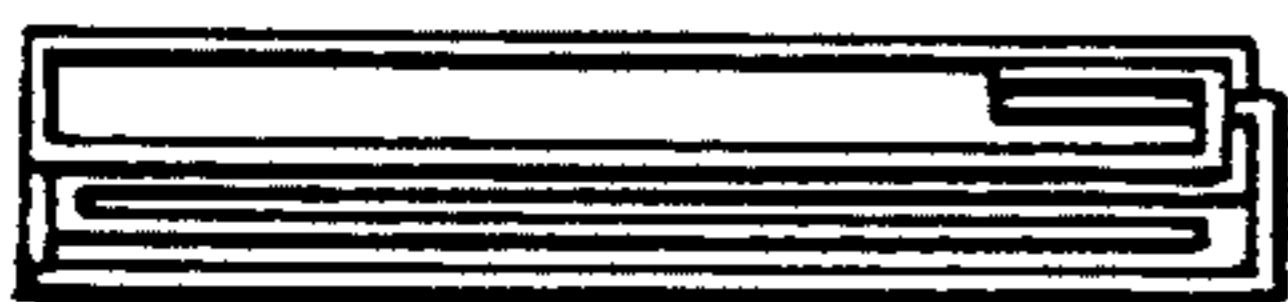

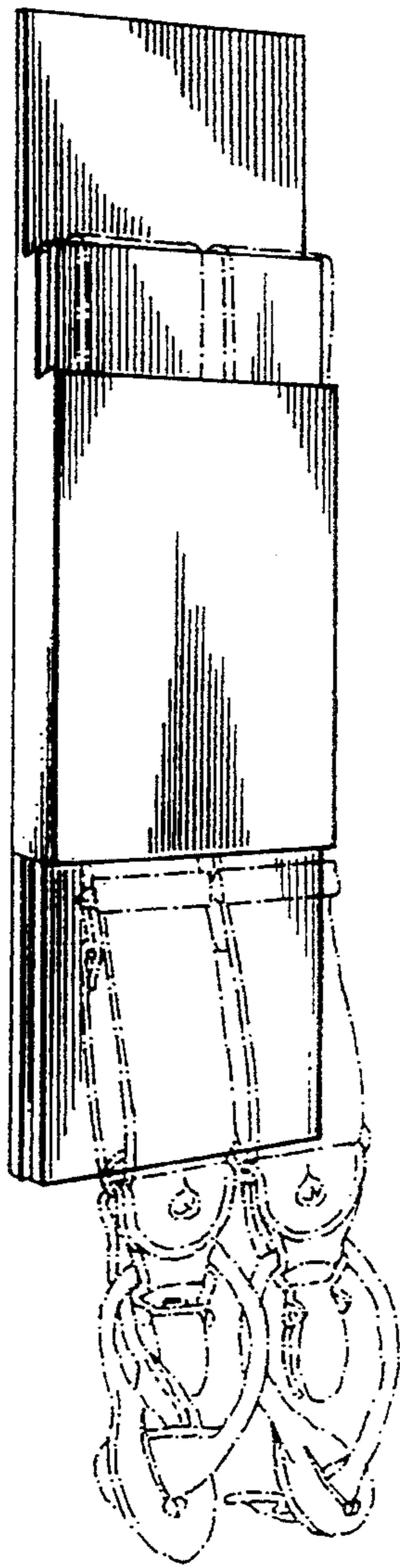
