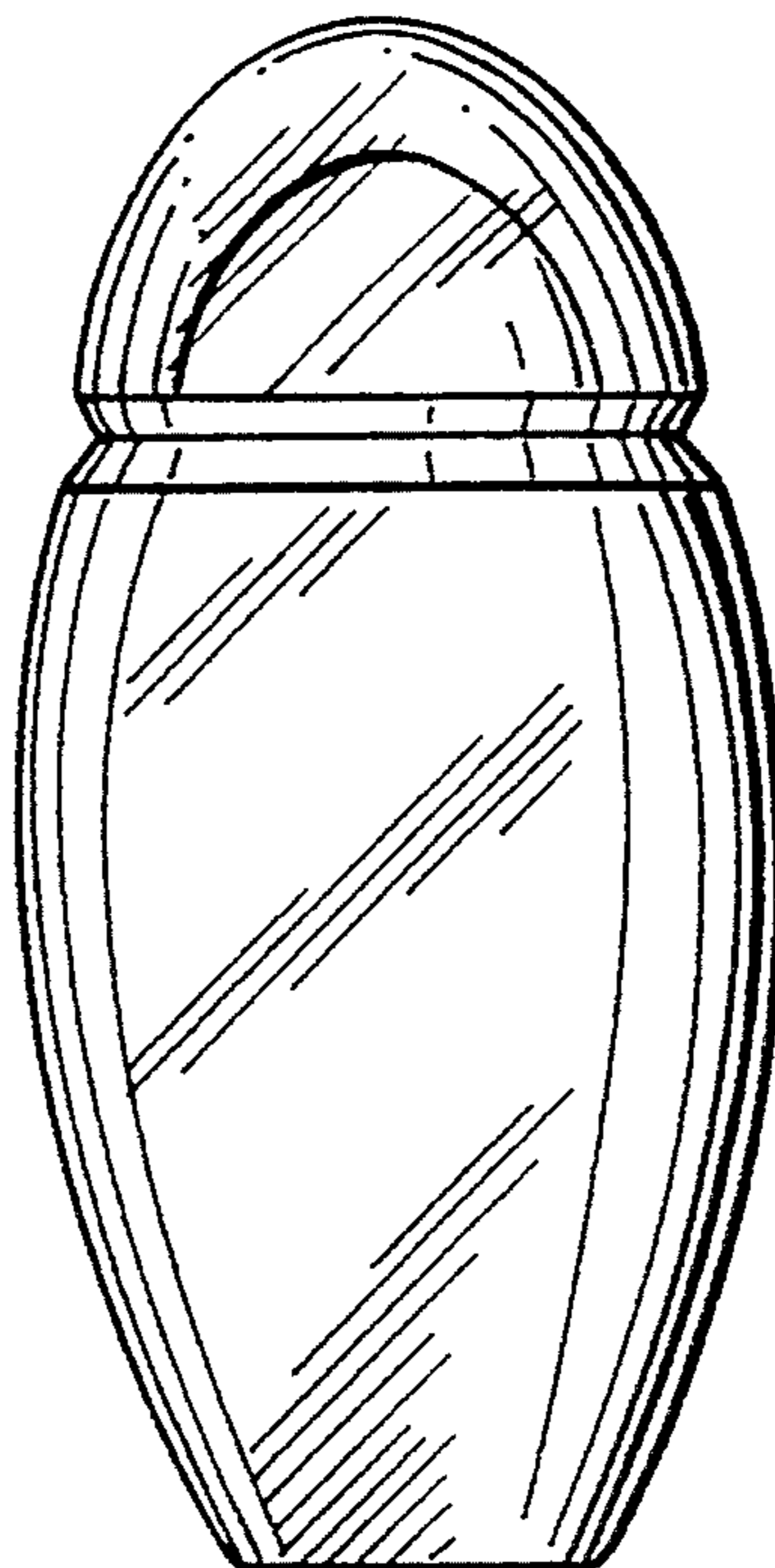

DESCRIPTION

FIG. 1 is a perspective view of the container;
 FIG. 2 is a front view thereof, the rear view being identical;

 FIG. 6 is a cross-sectional view thereof.



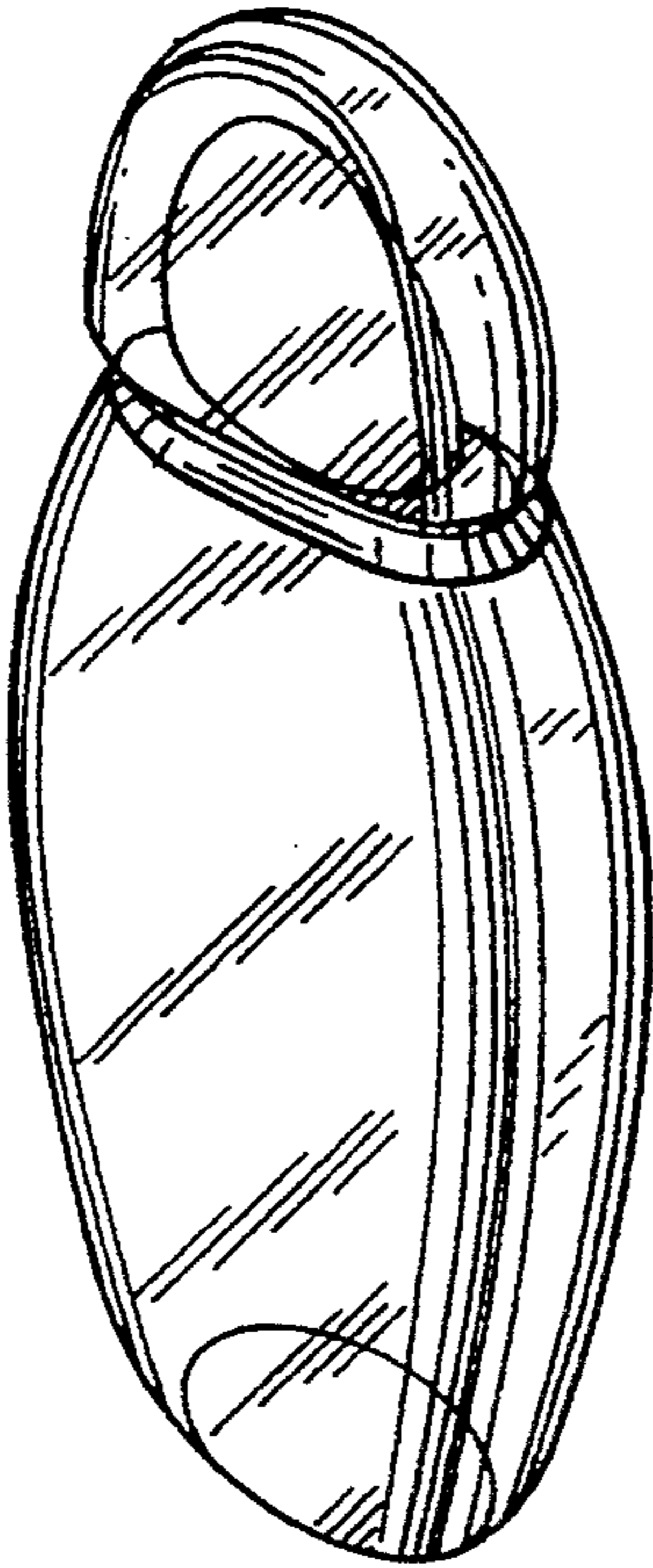

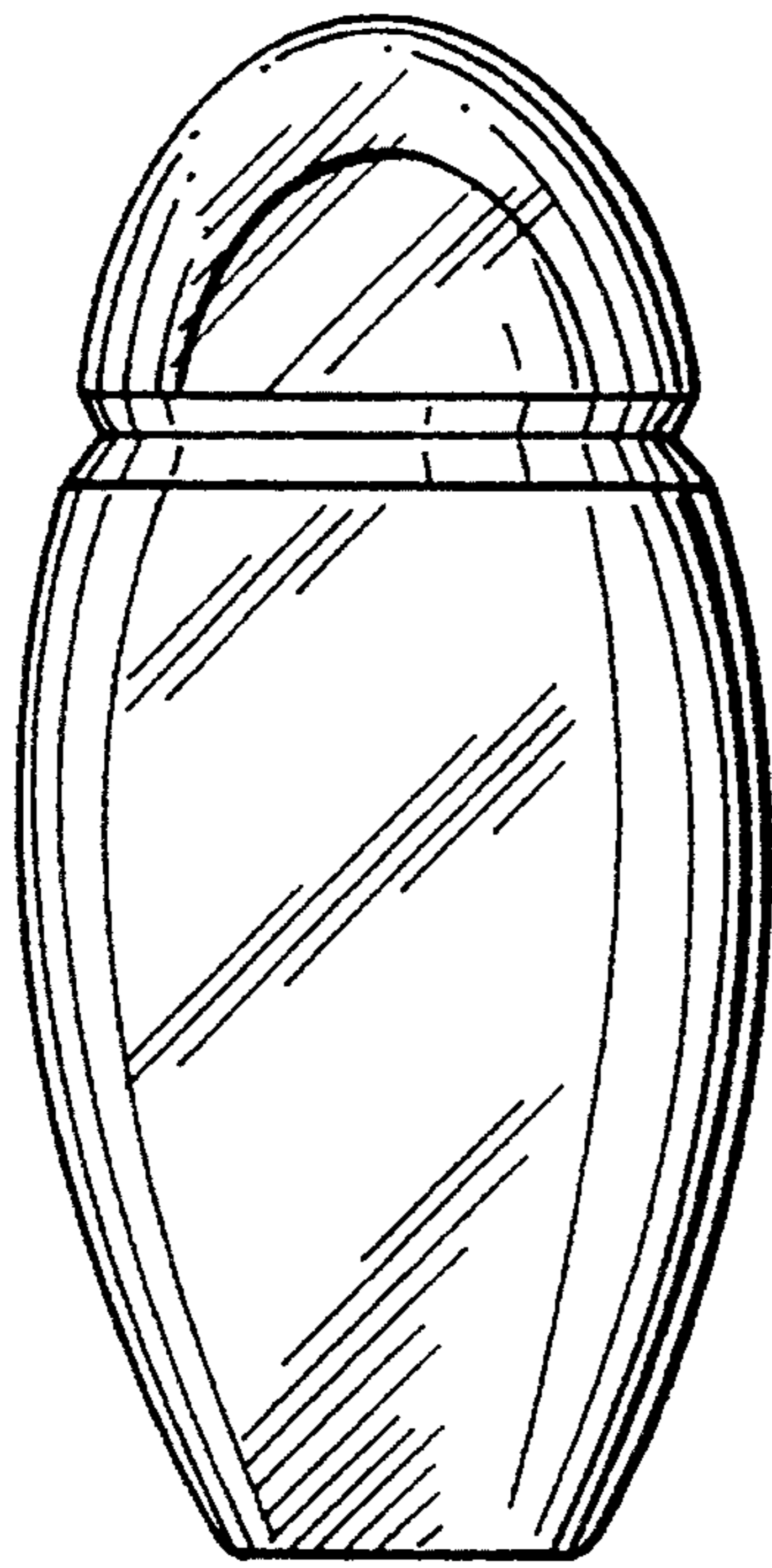

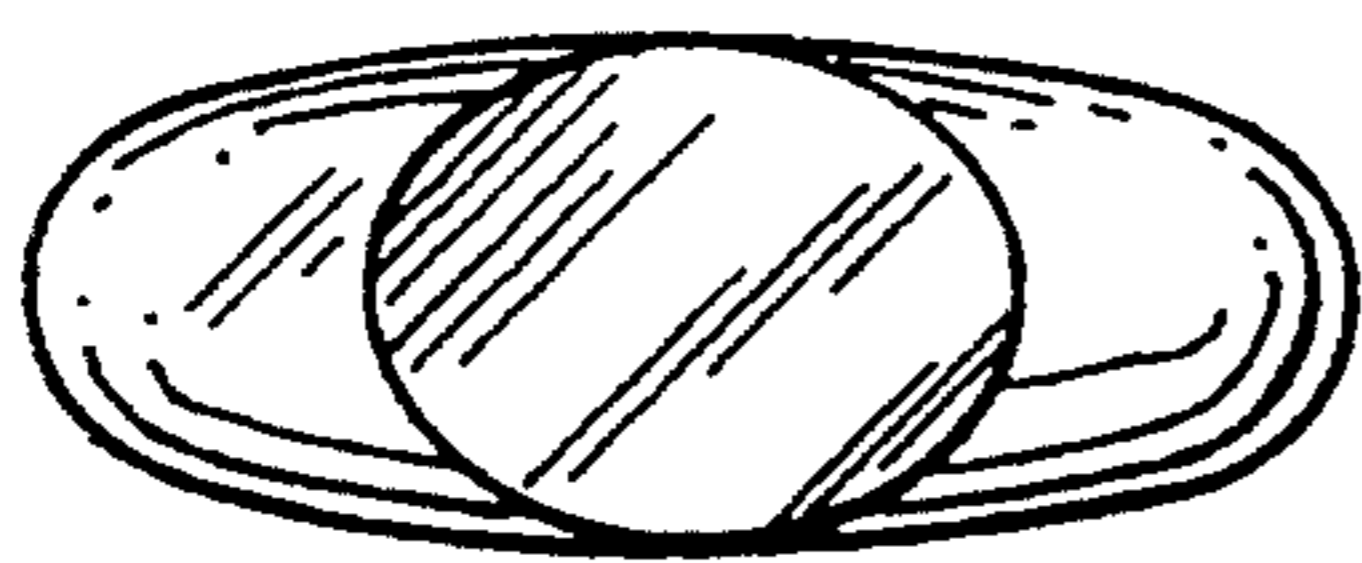

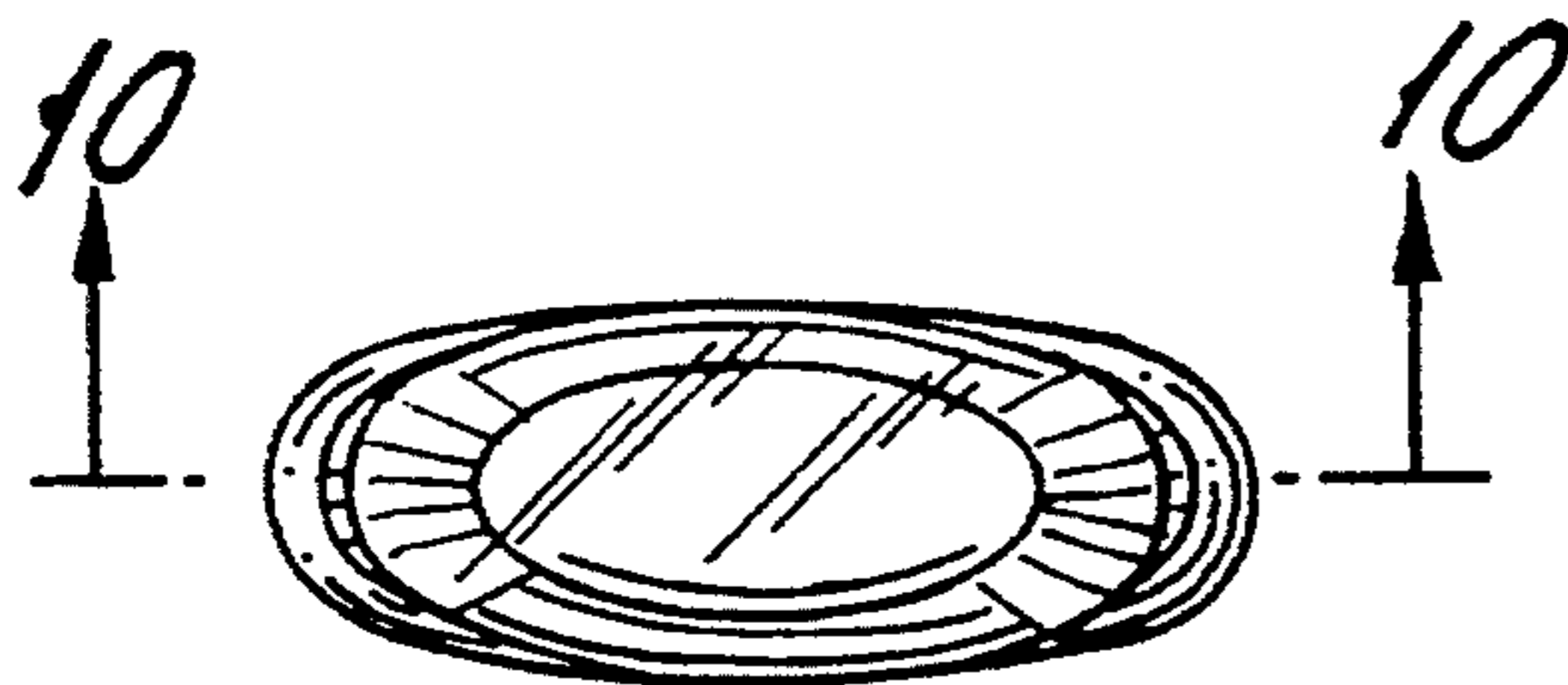

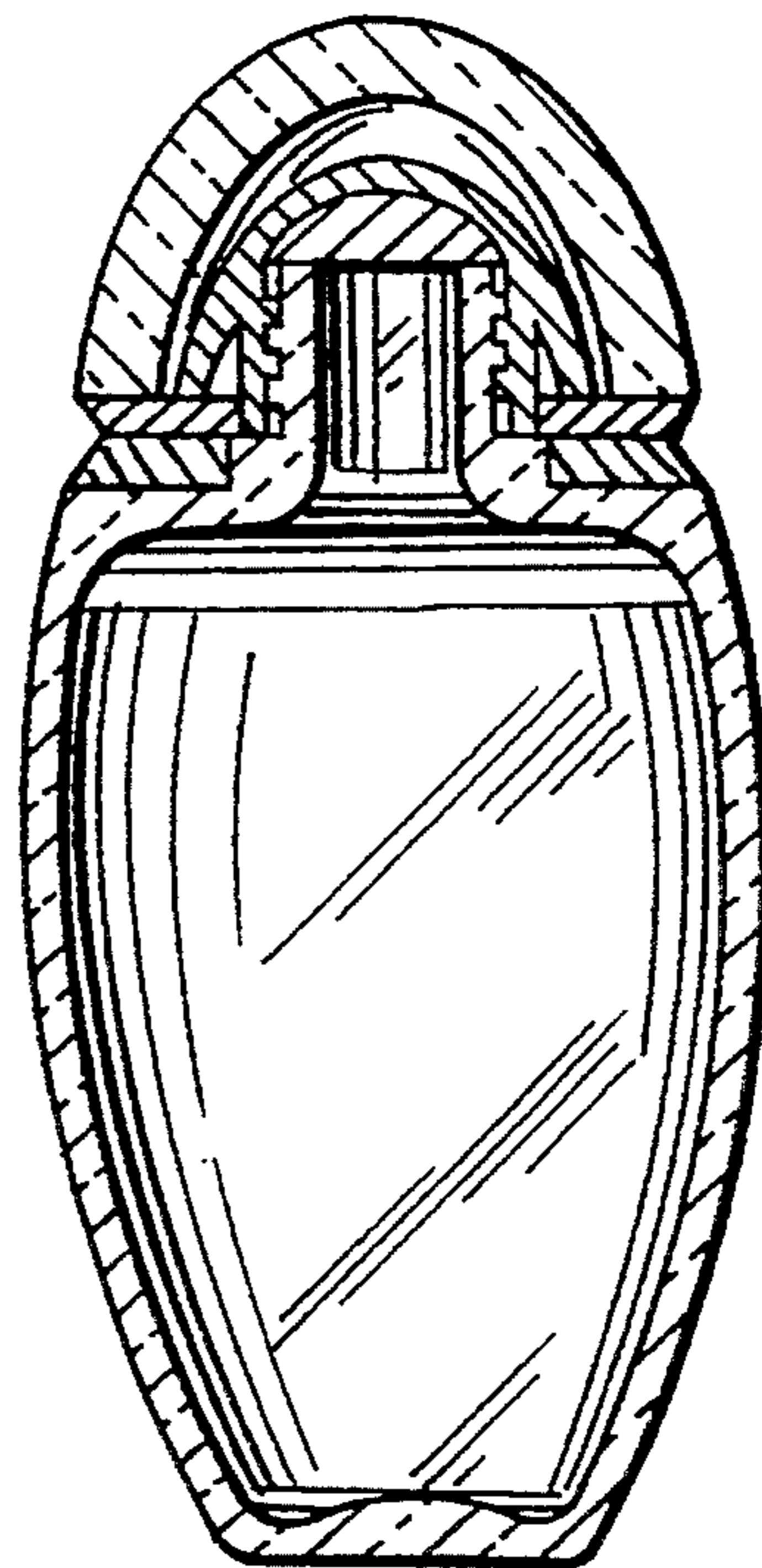
