**DESCRIPTION**

FIG. 1 is a perspective view of a turkey caller showing my new design;

FIG. 8 is a left side elevational view thereof.

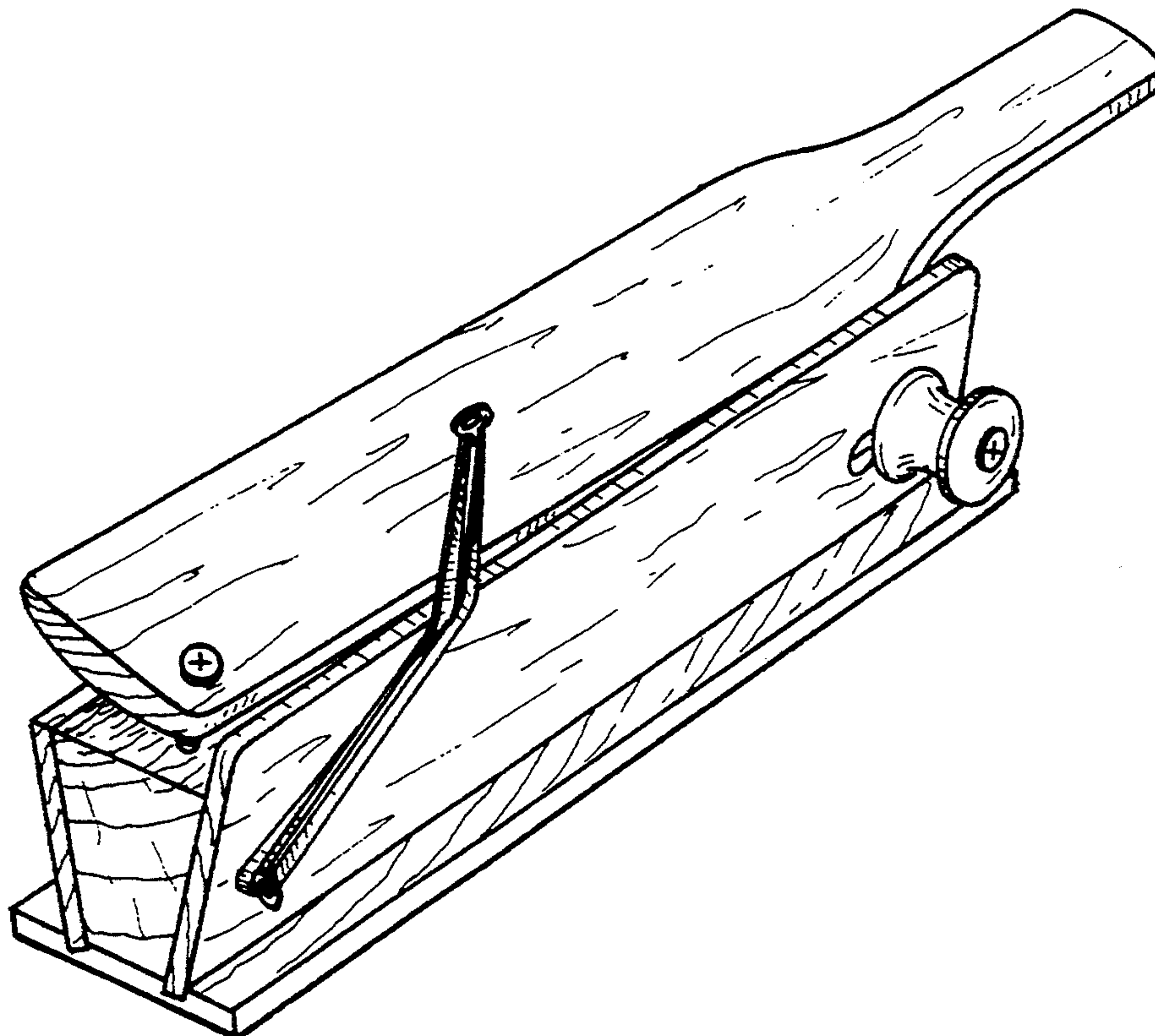

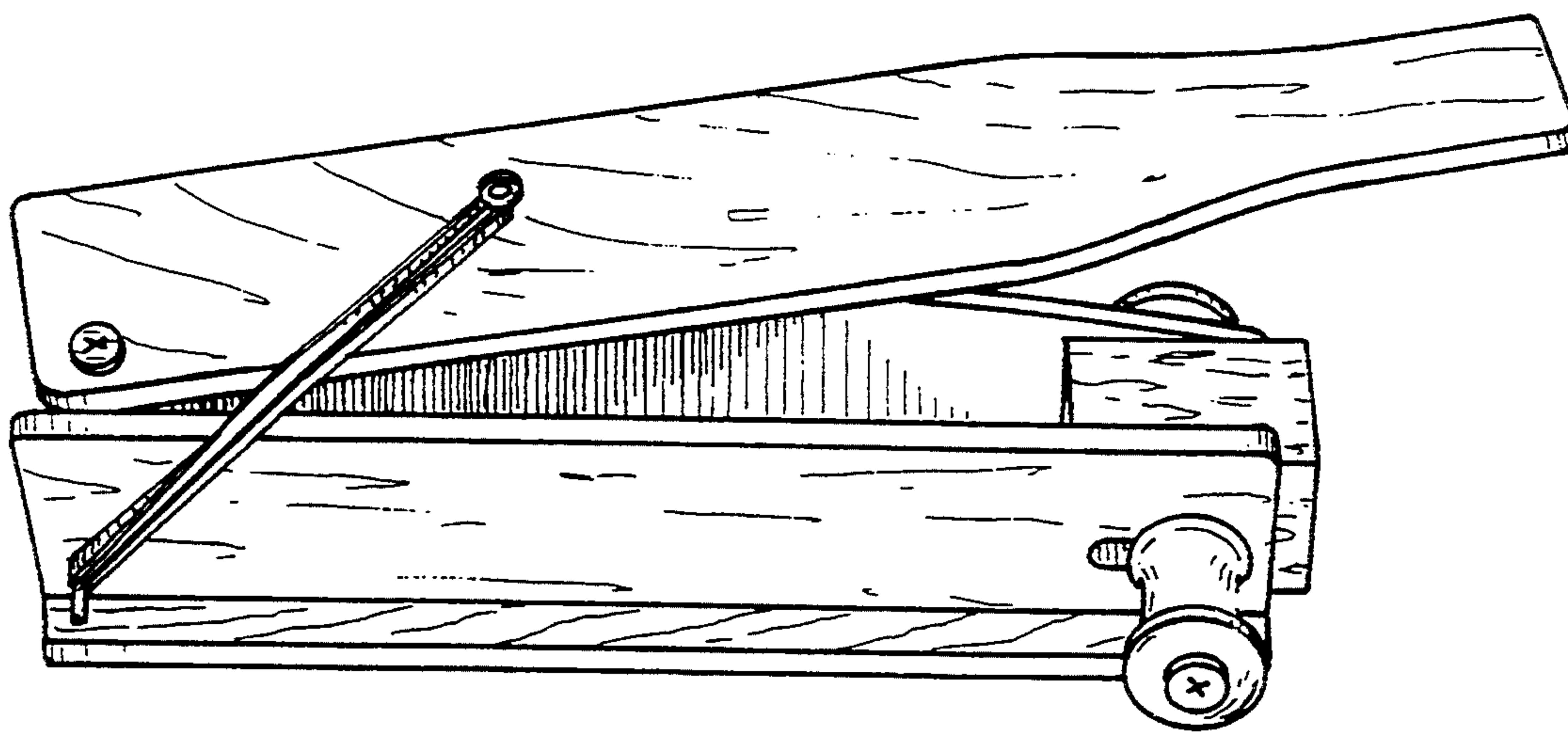
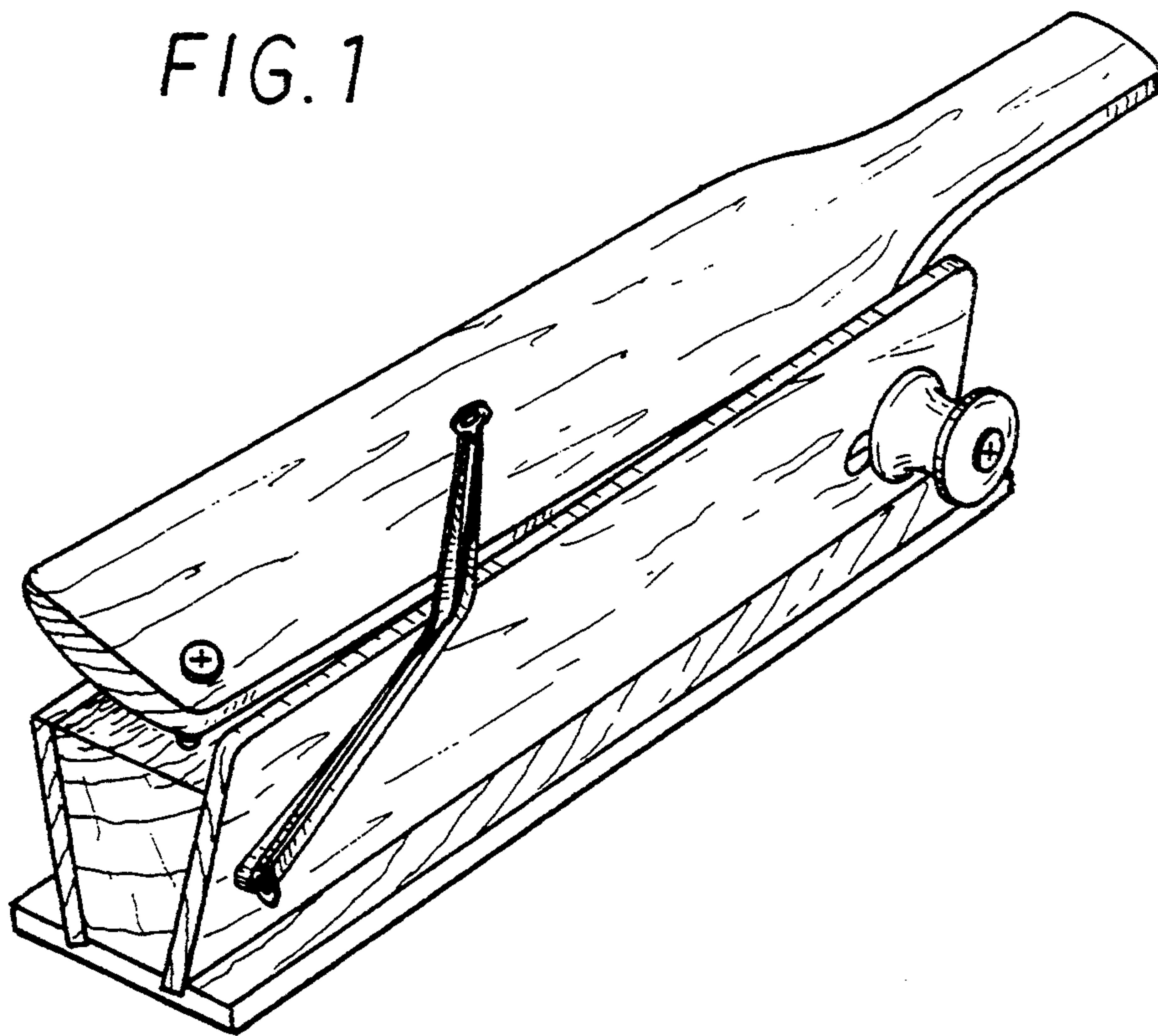

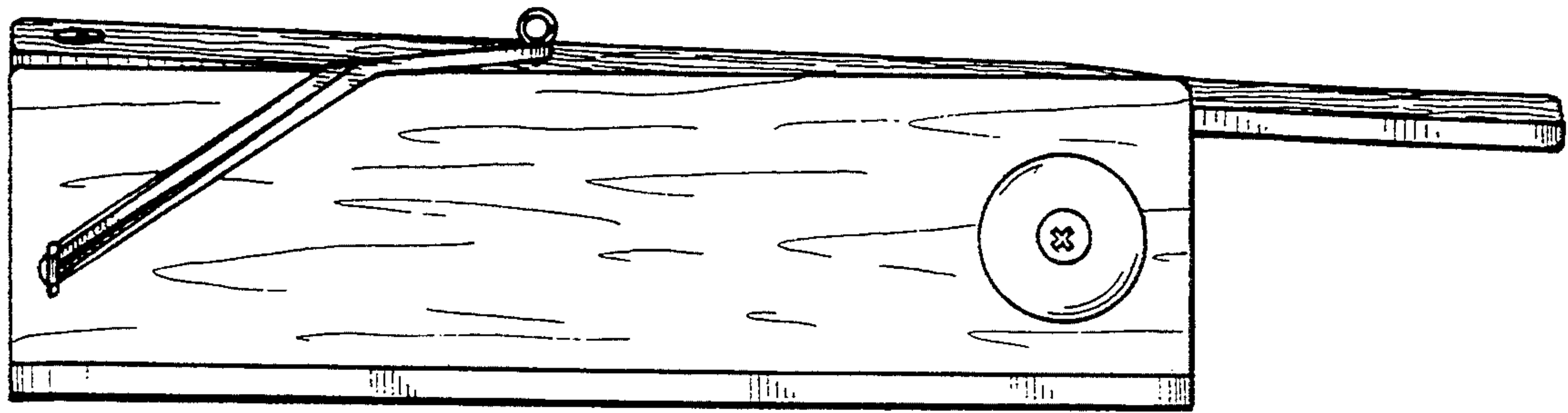

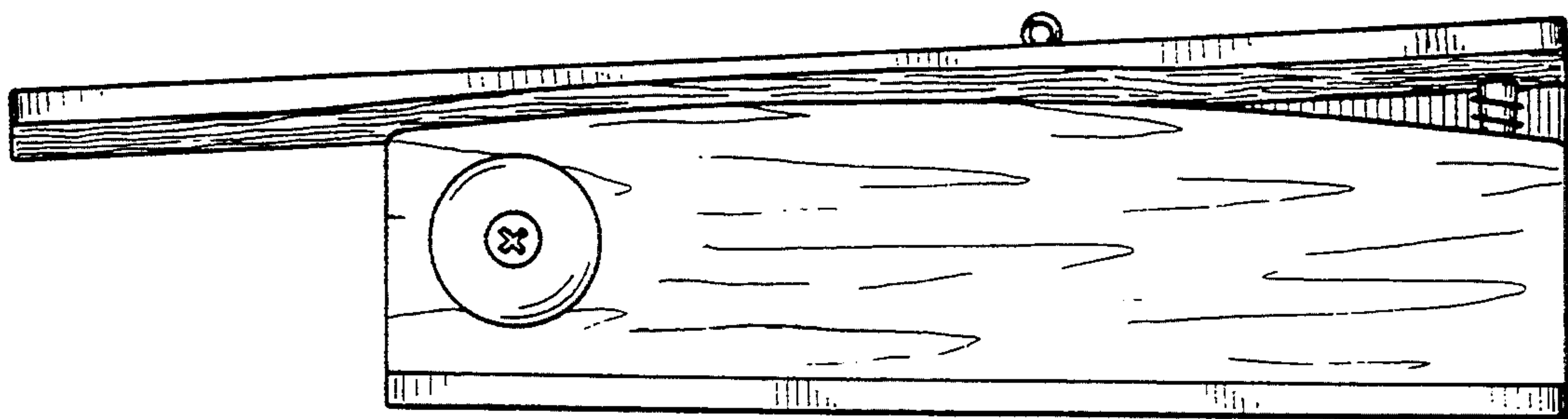

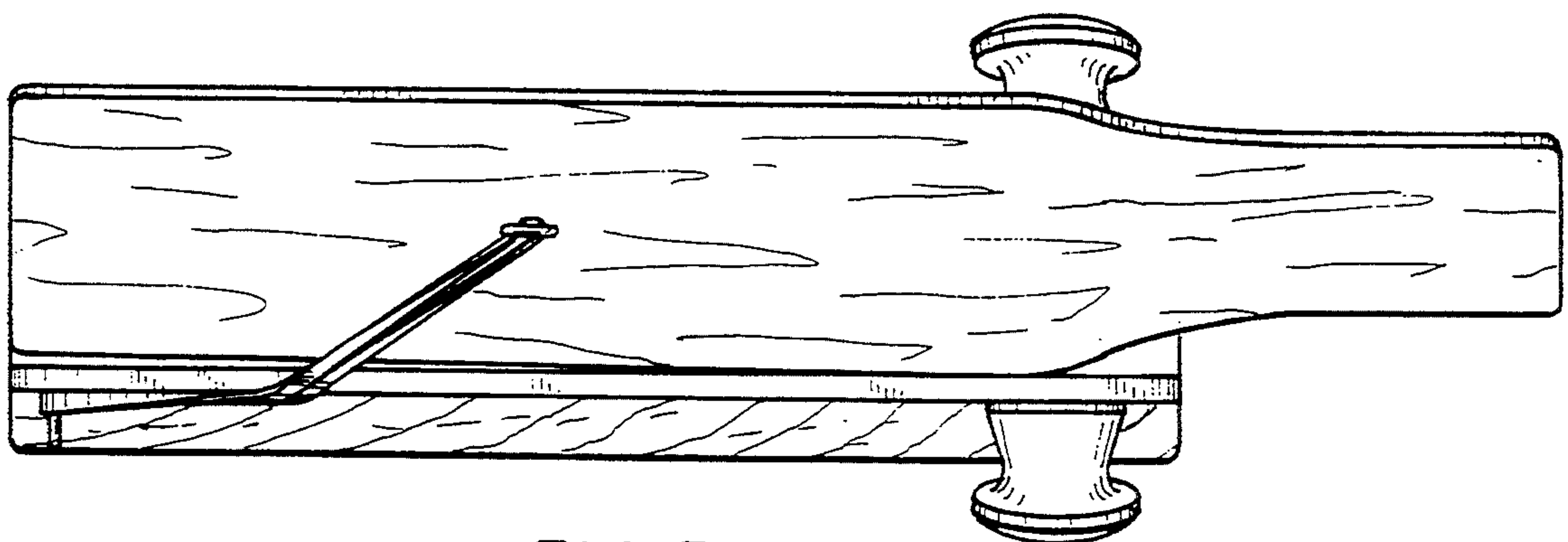

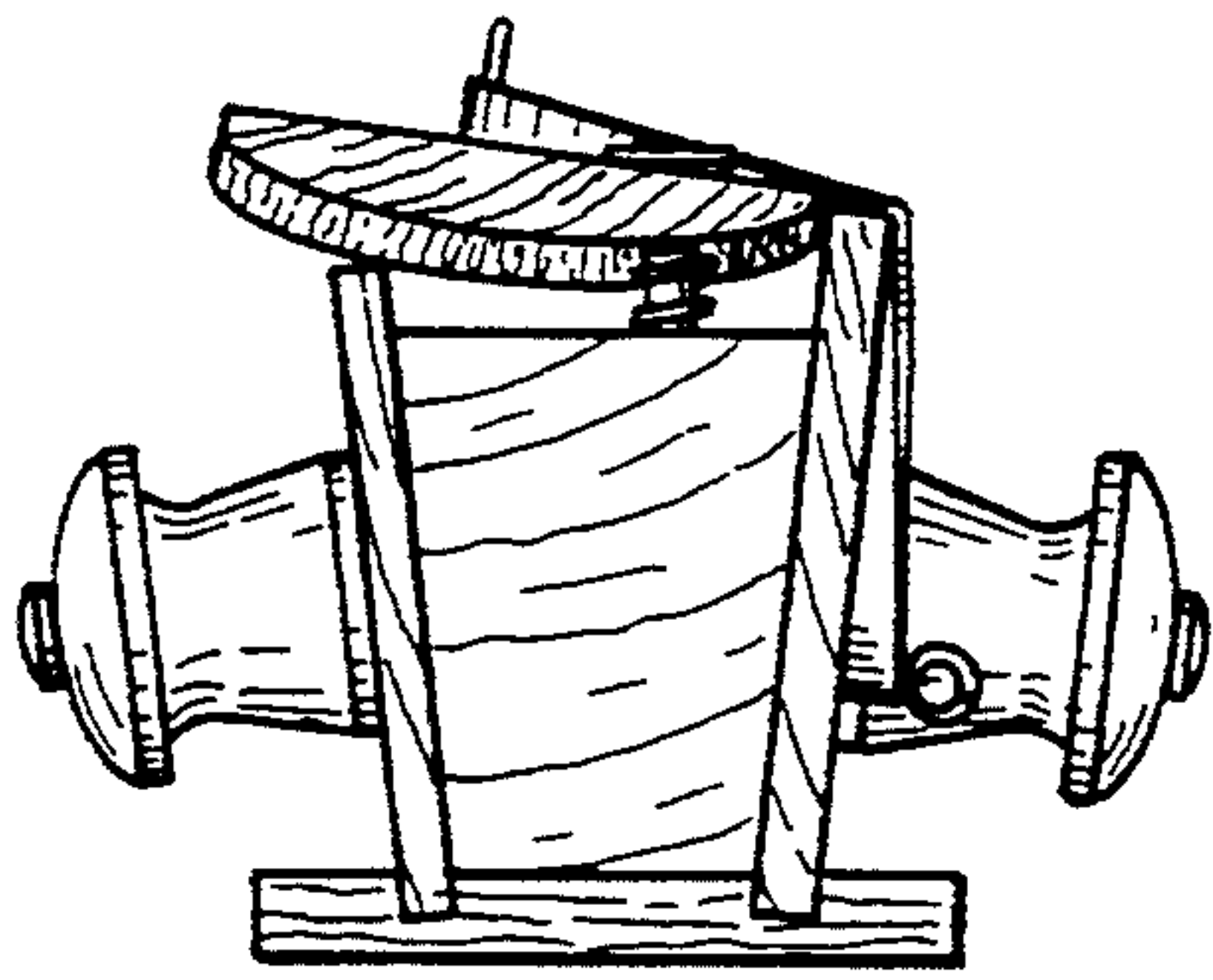
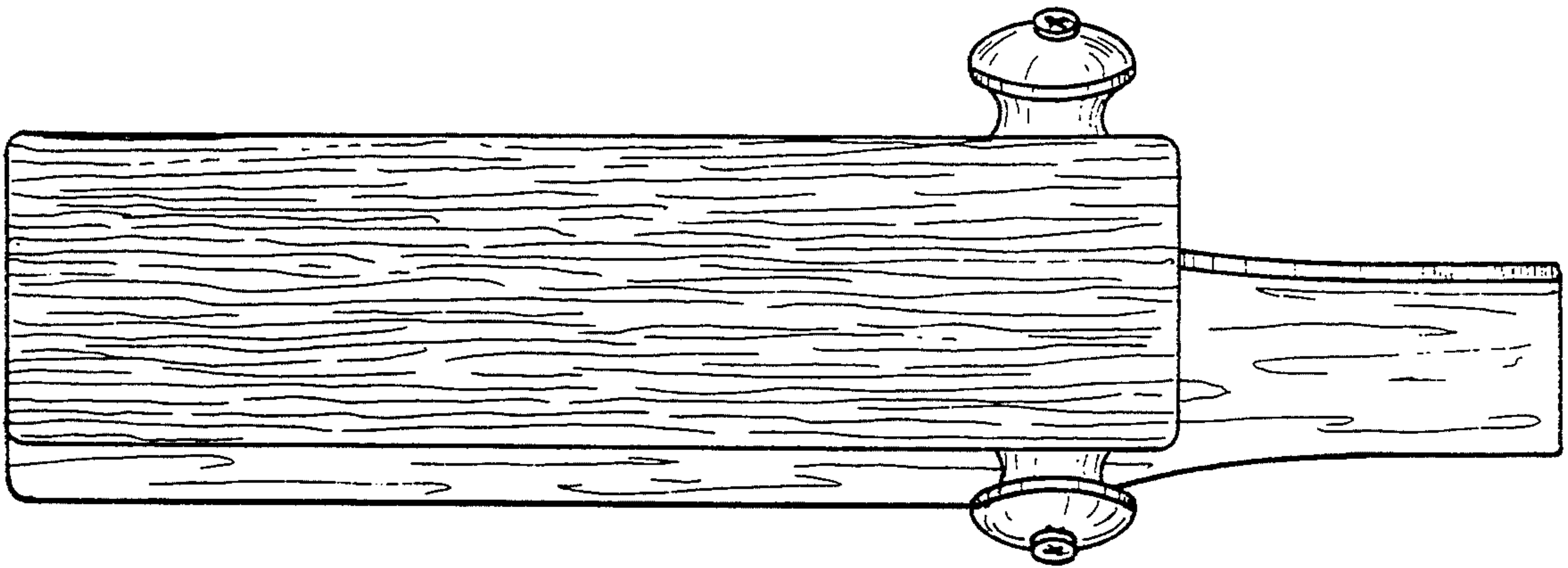

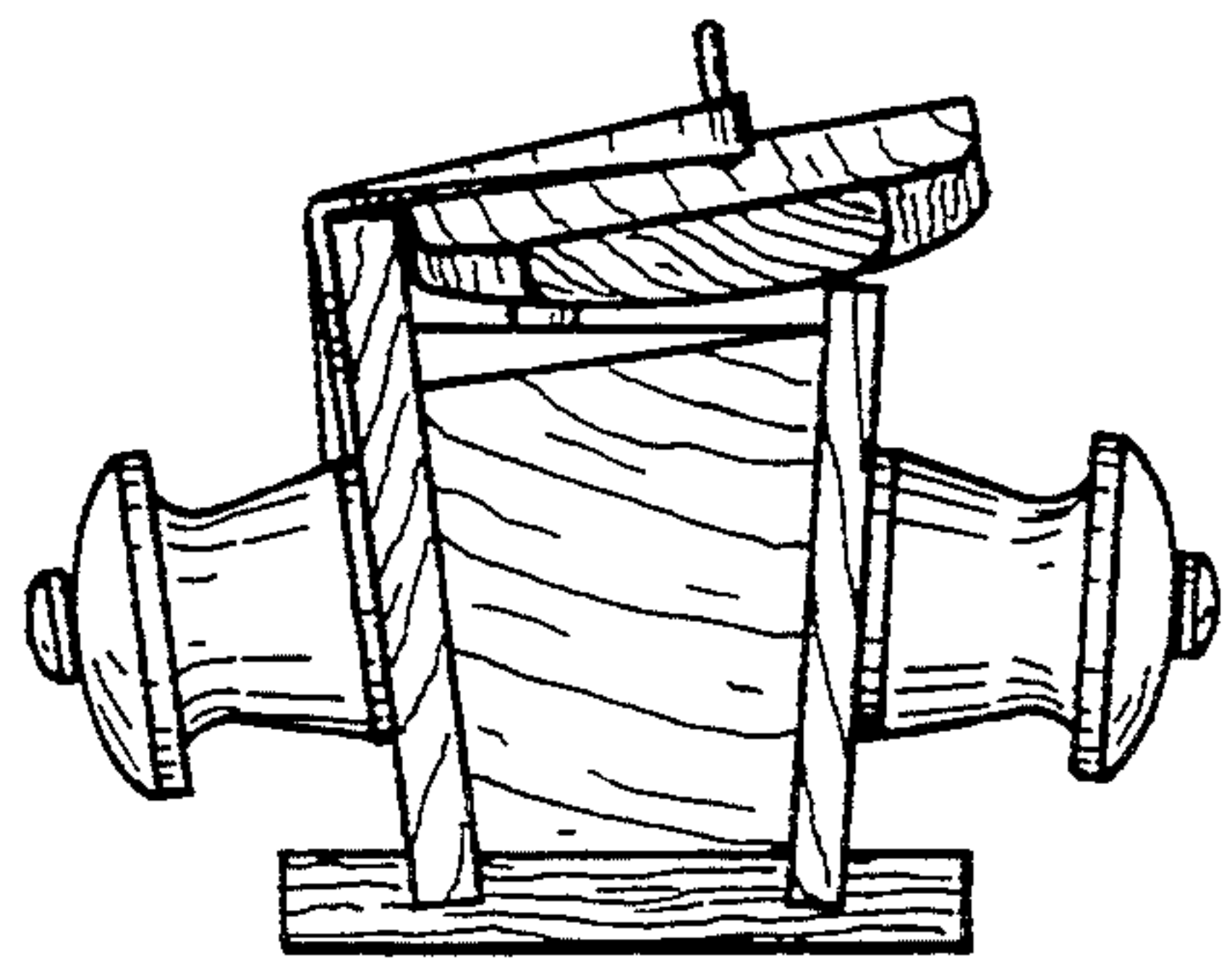
