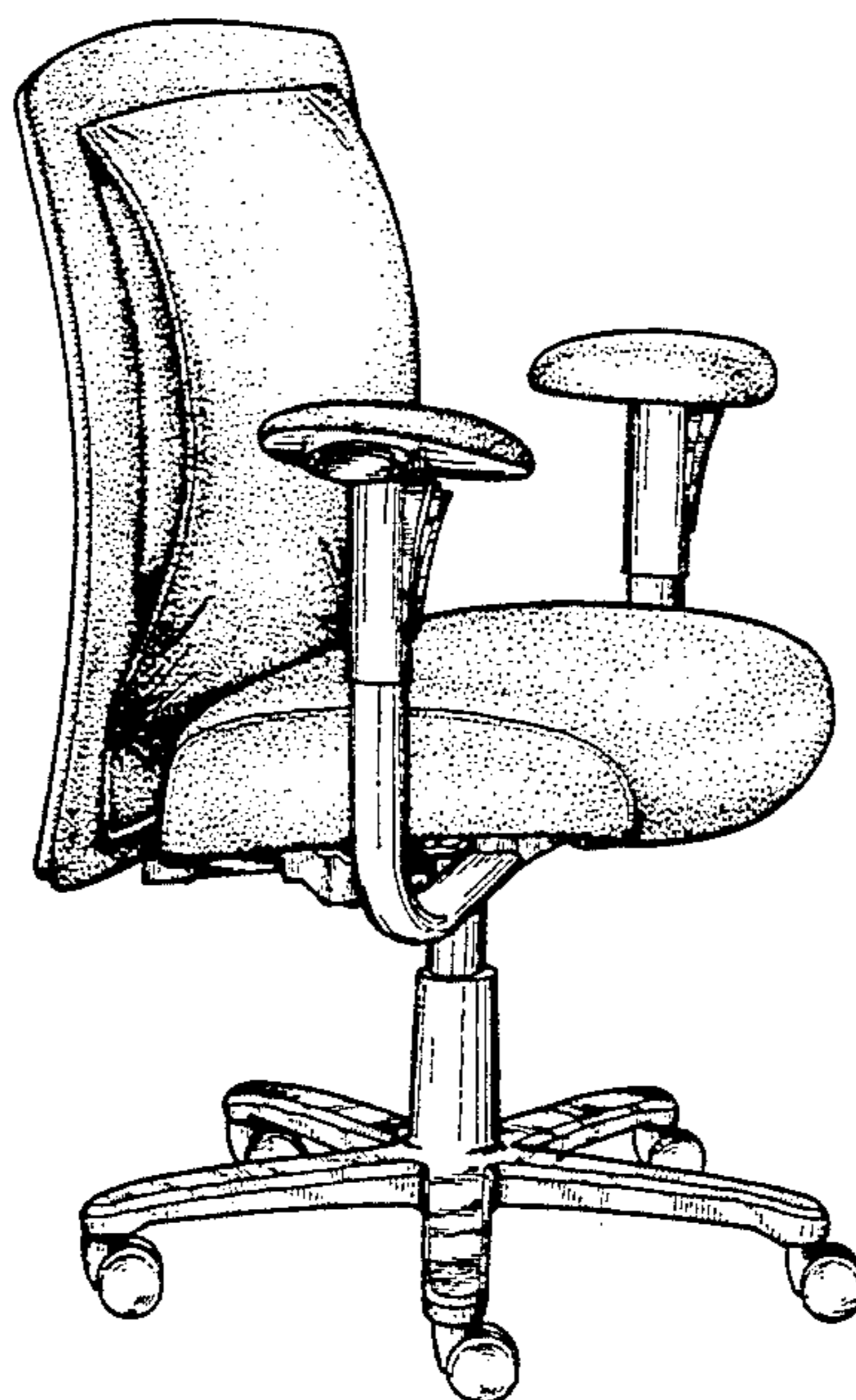

DESCRIPTION

FIG. 1 is a right, front perspective view of a chair showing my new design;
FIG. 2 is a left, front perspective view thereof;
FIG. 3 is a front view thereof;

FIG. 5 is a rear view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a left, rear perspective thereof;

FIG. 13 is a right, rear perspective of the alternative embodiment.



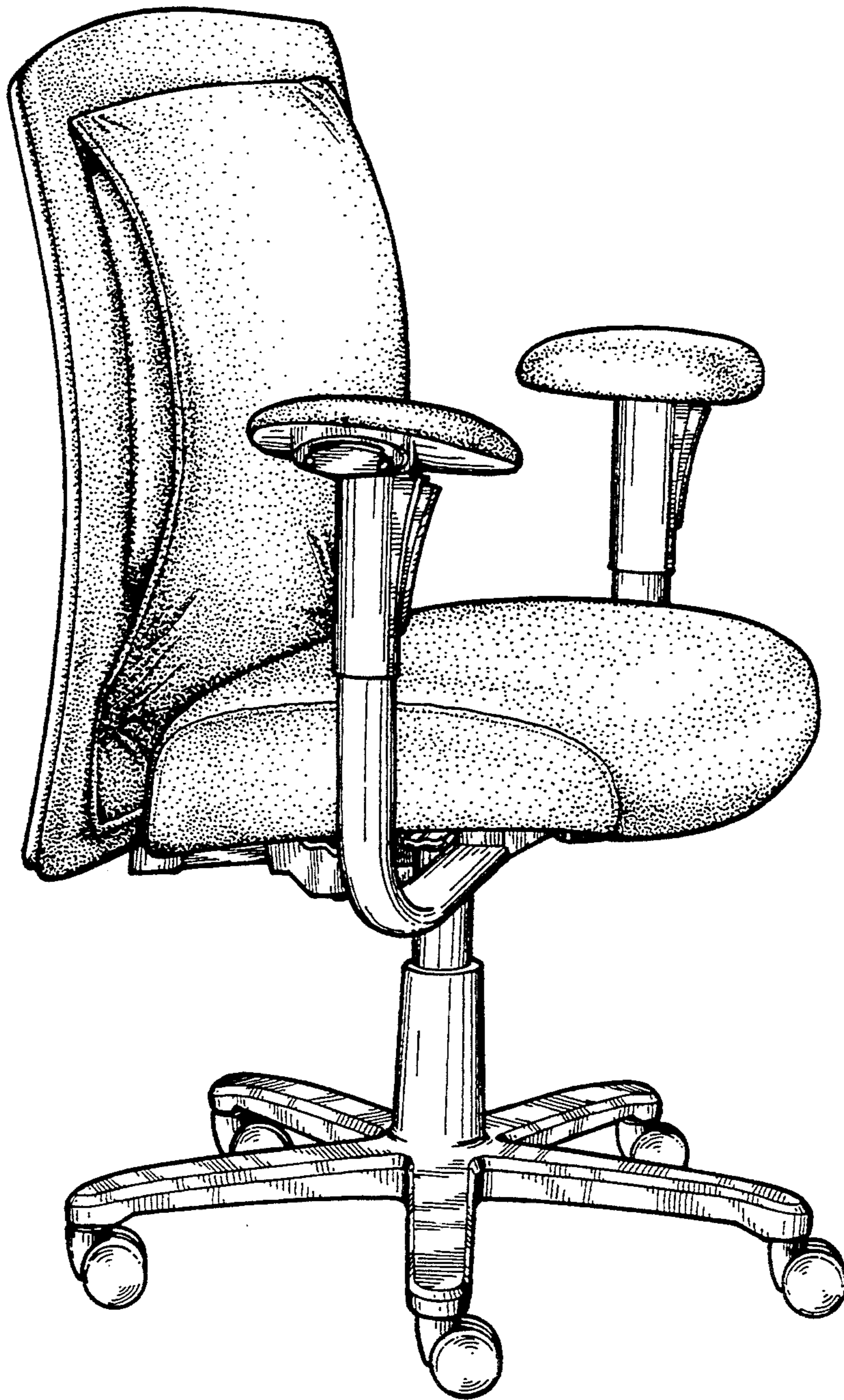

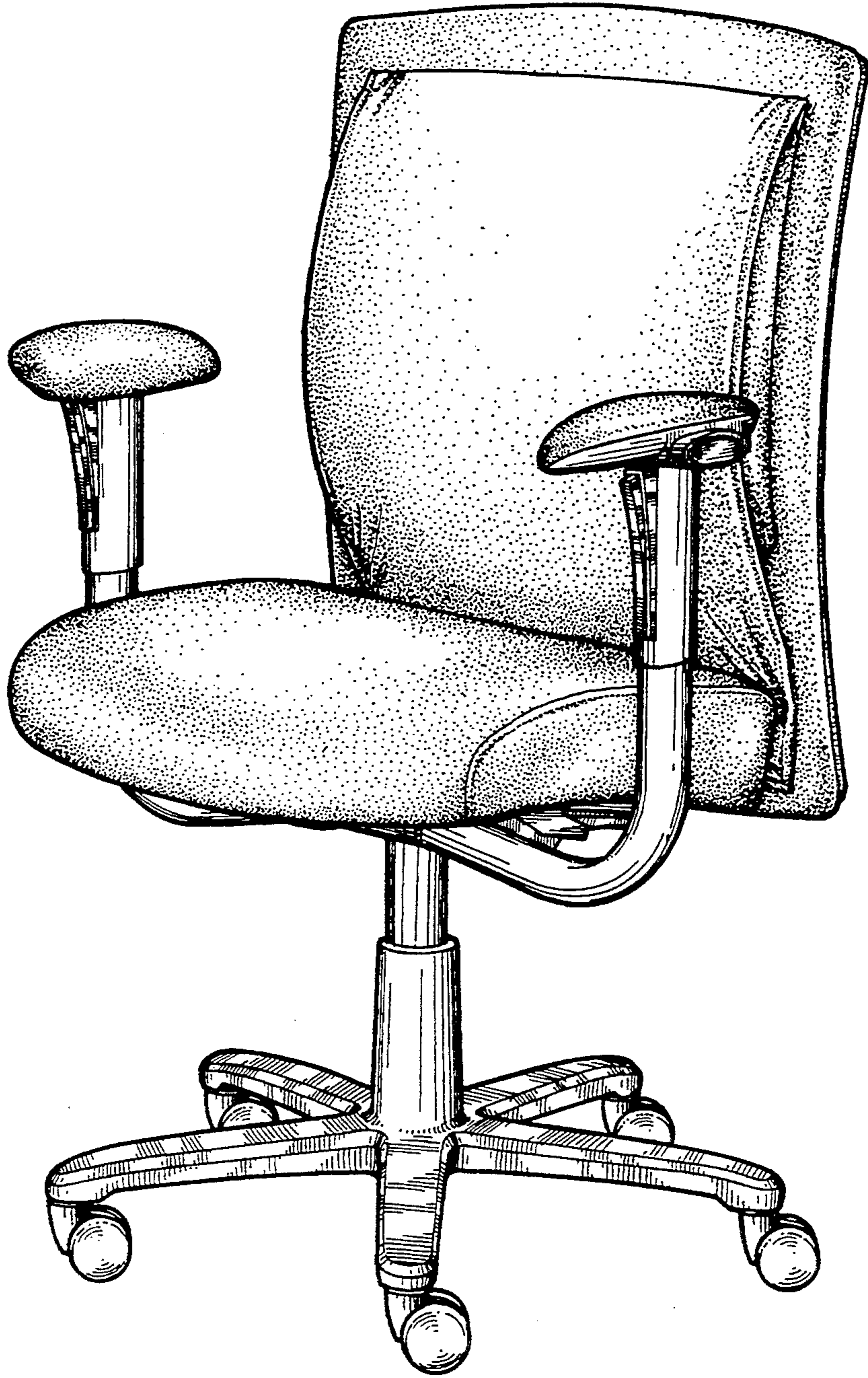

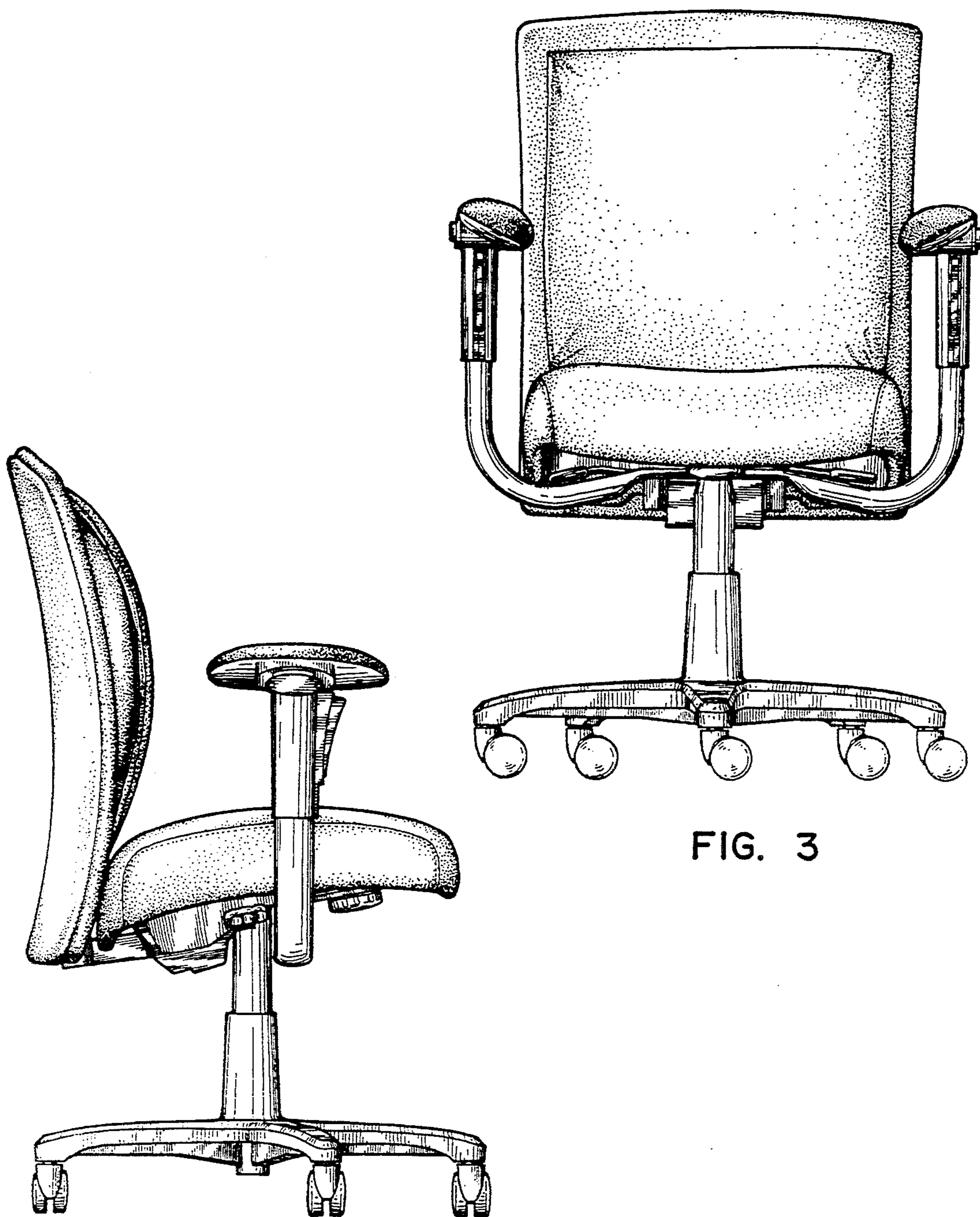

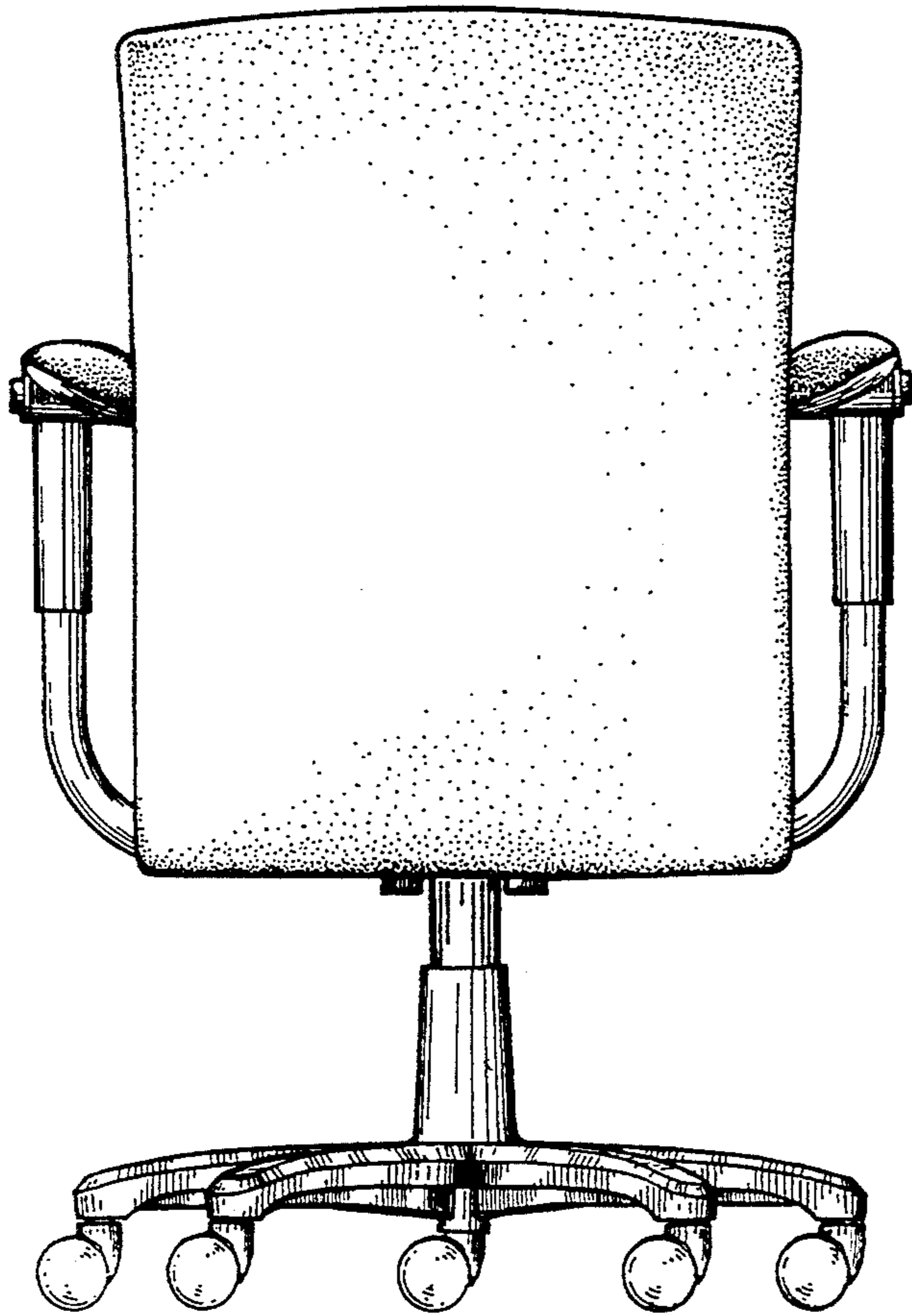

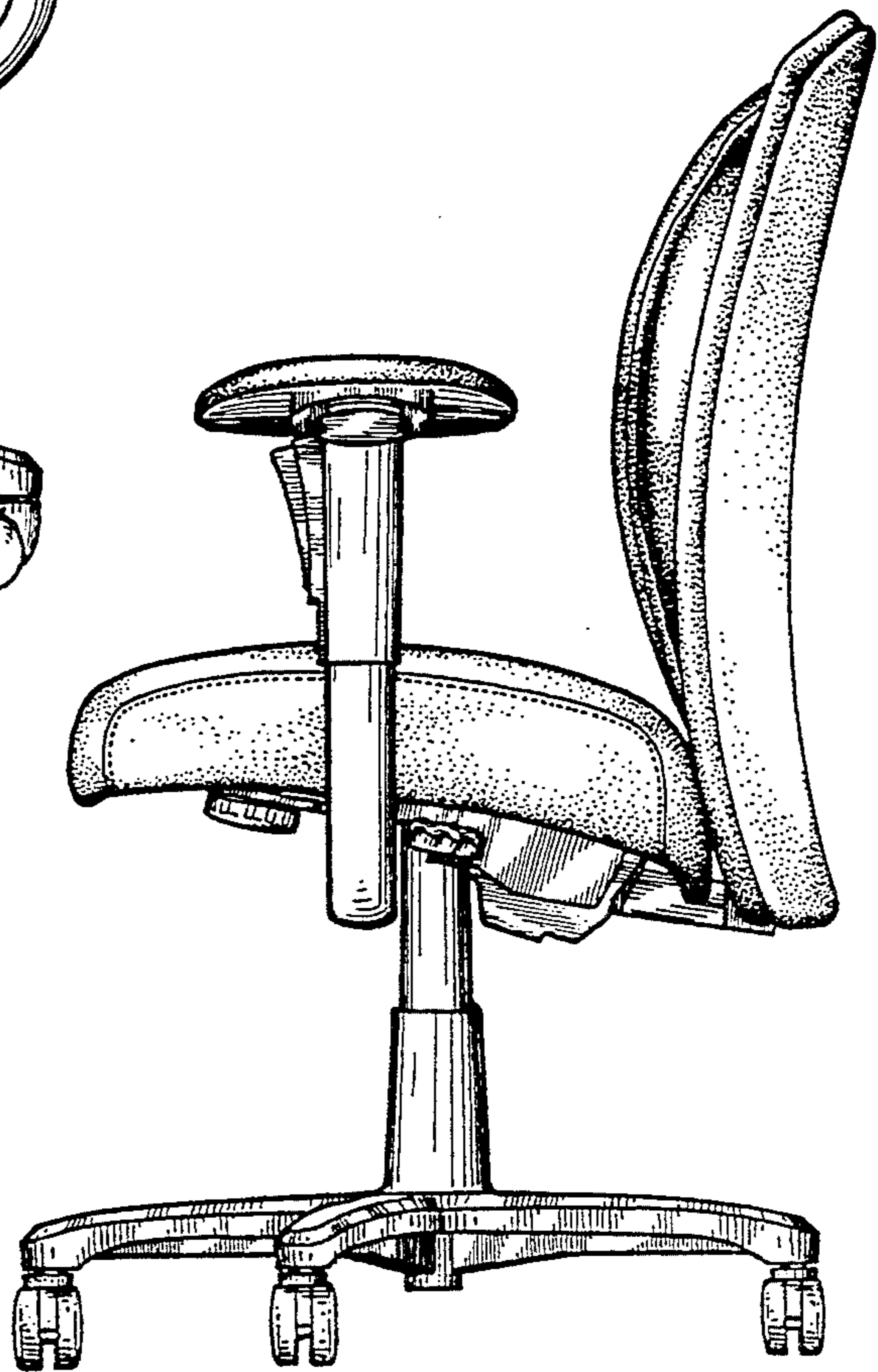

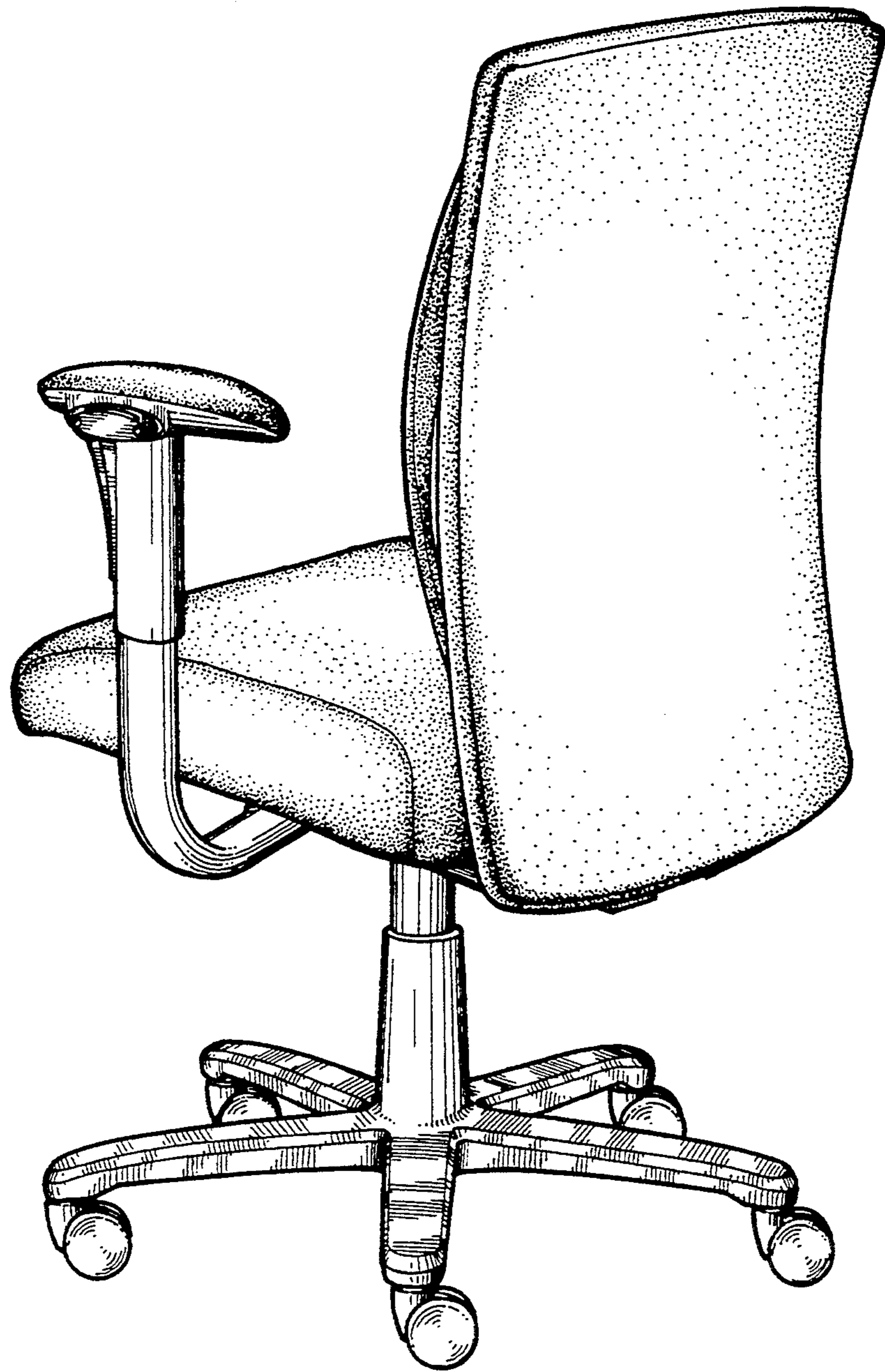

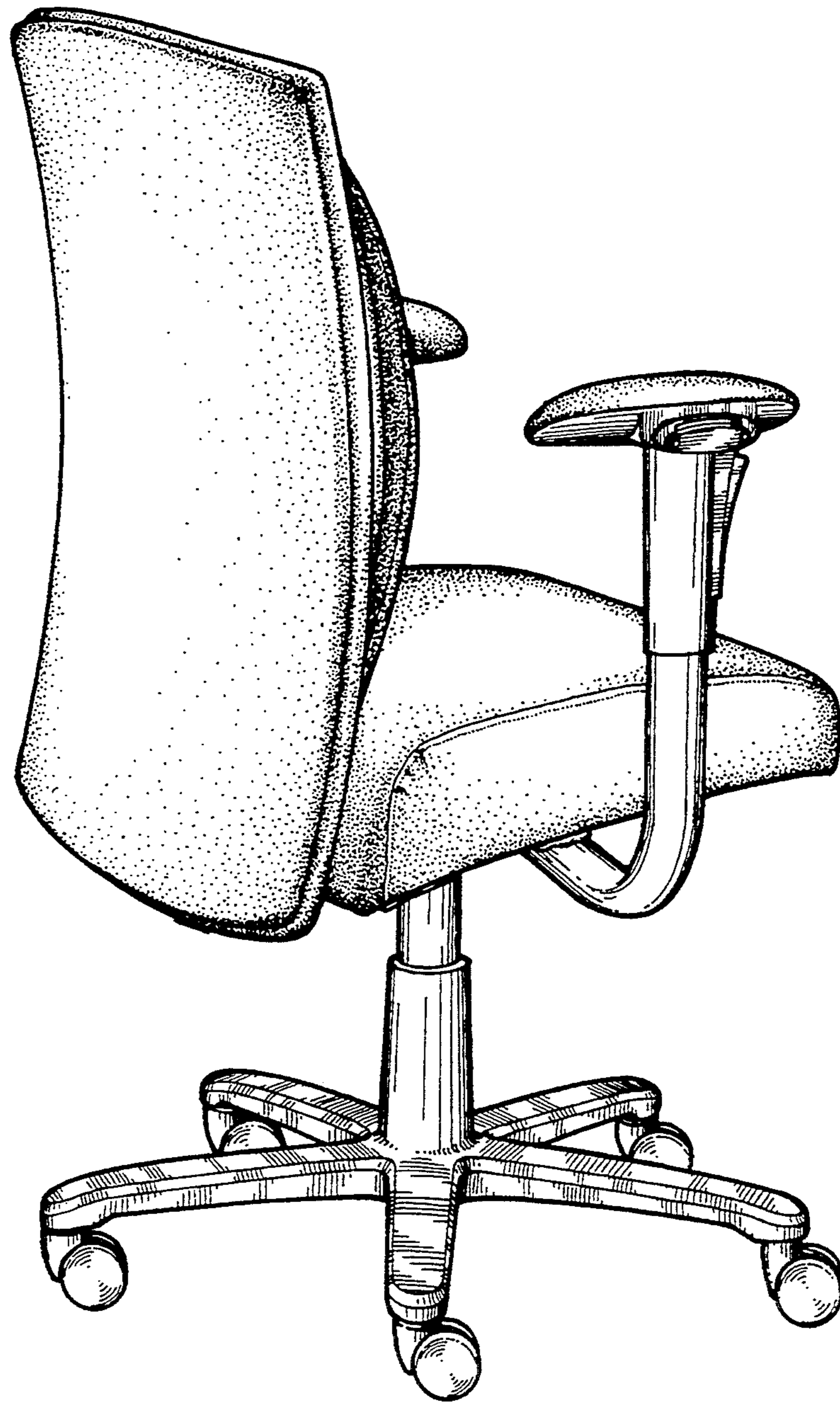

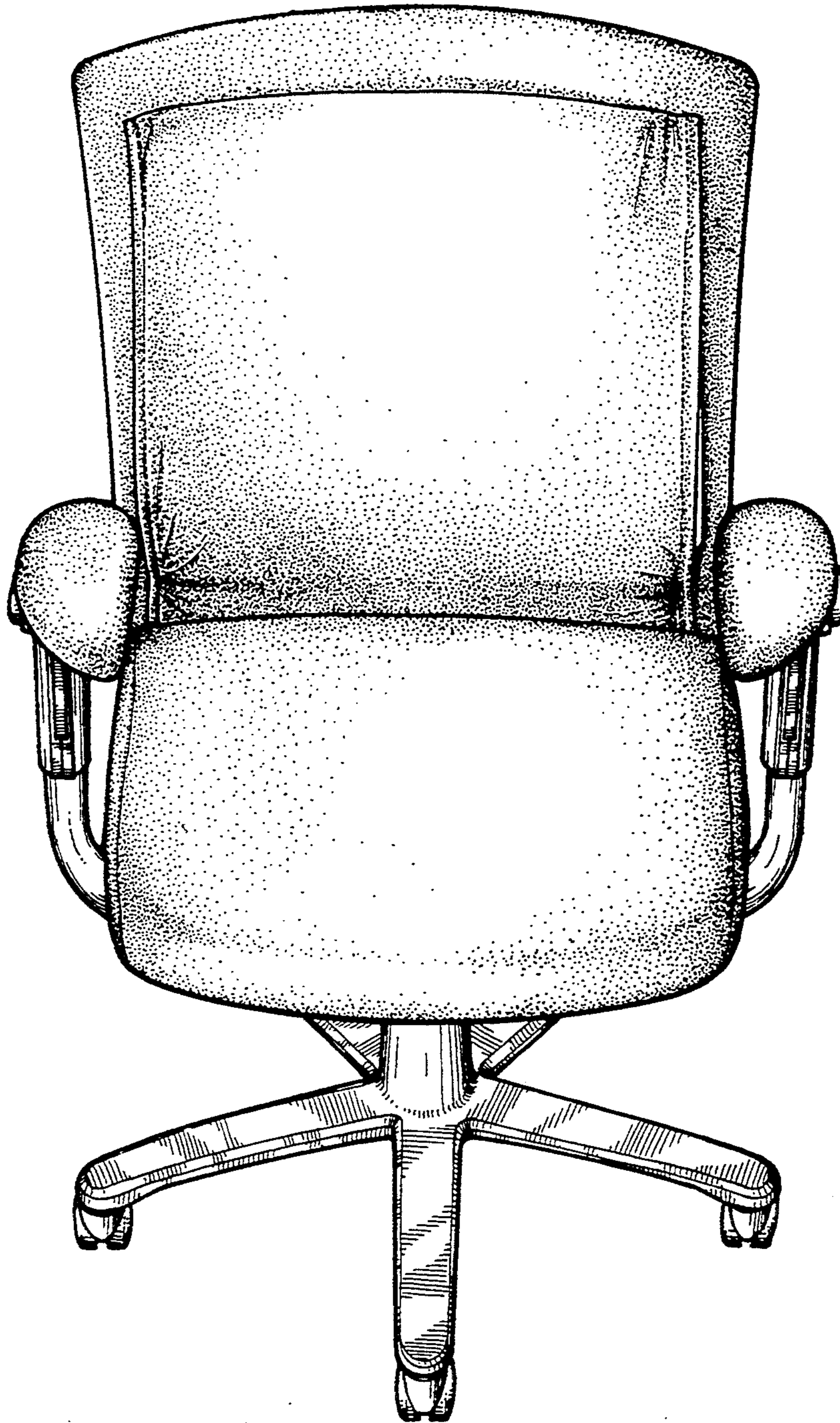

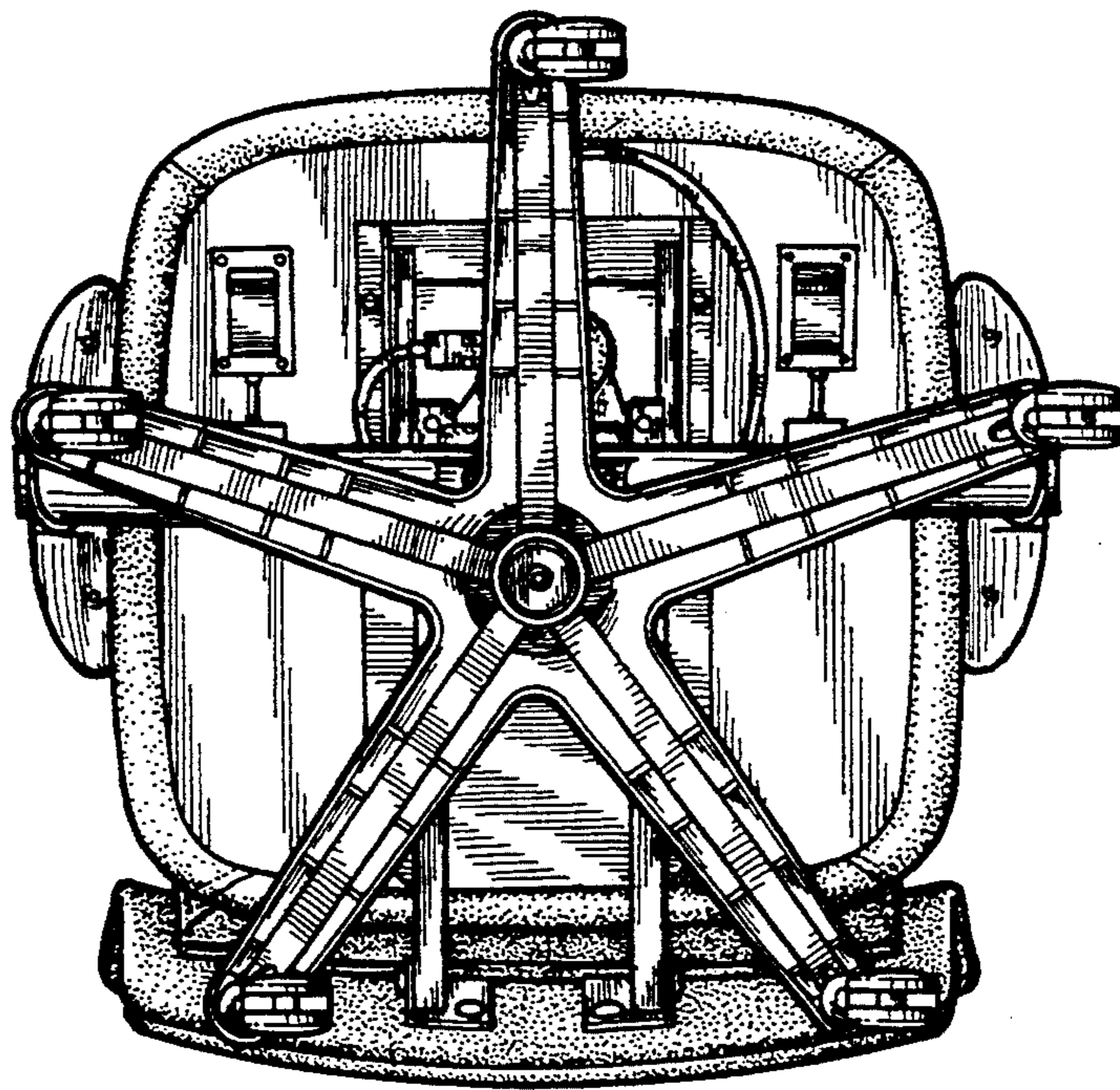

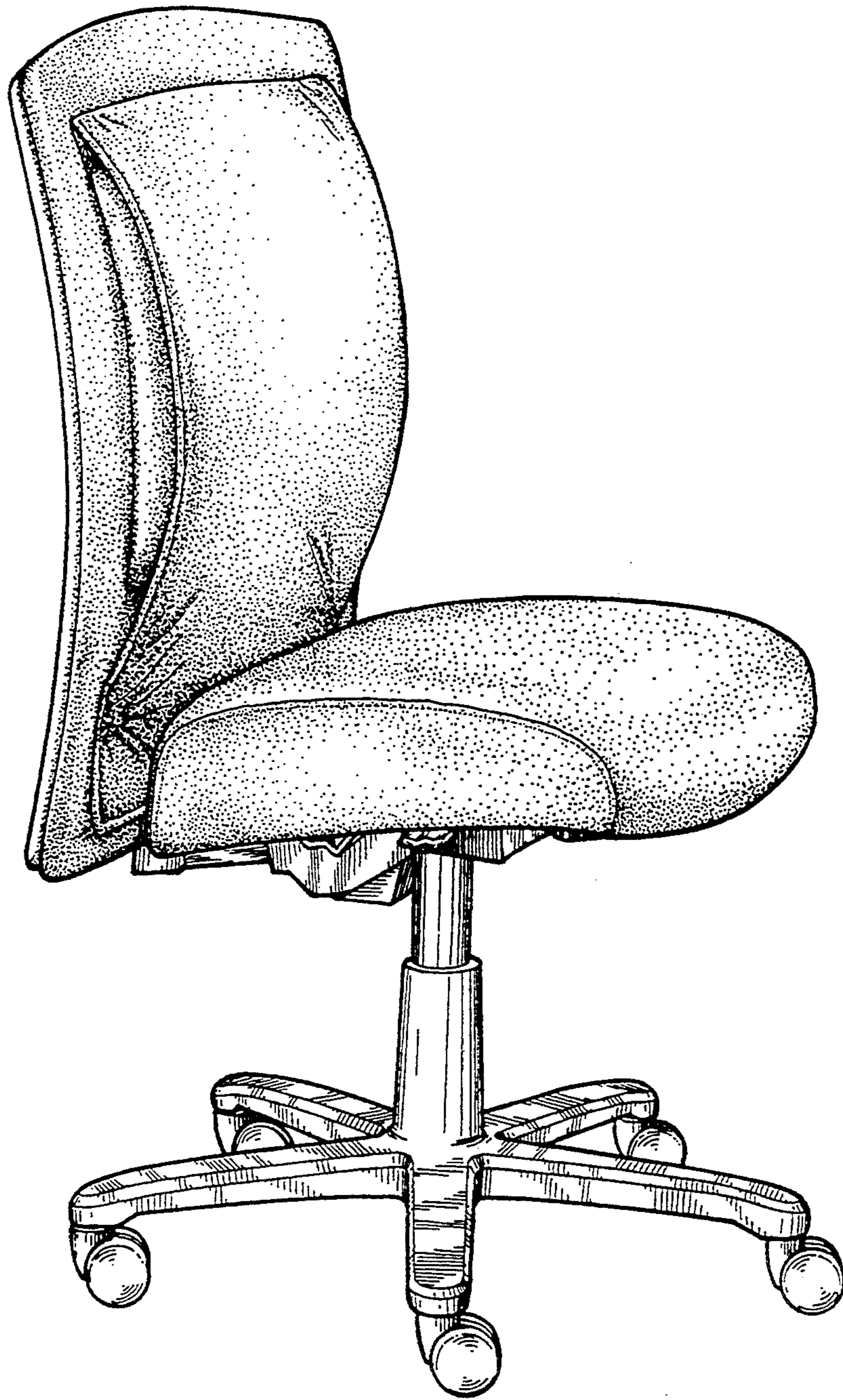

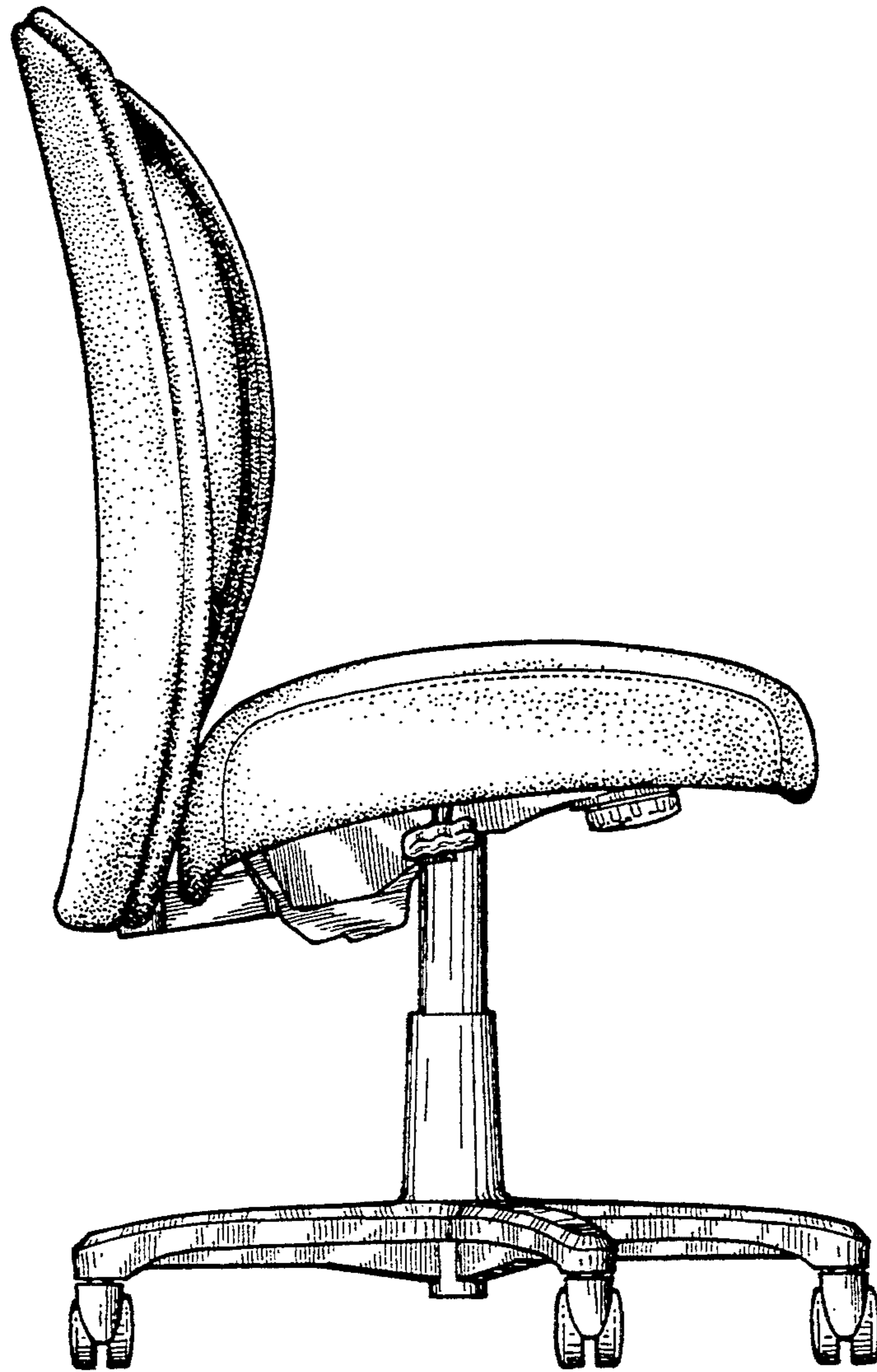

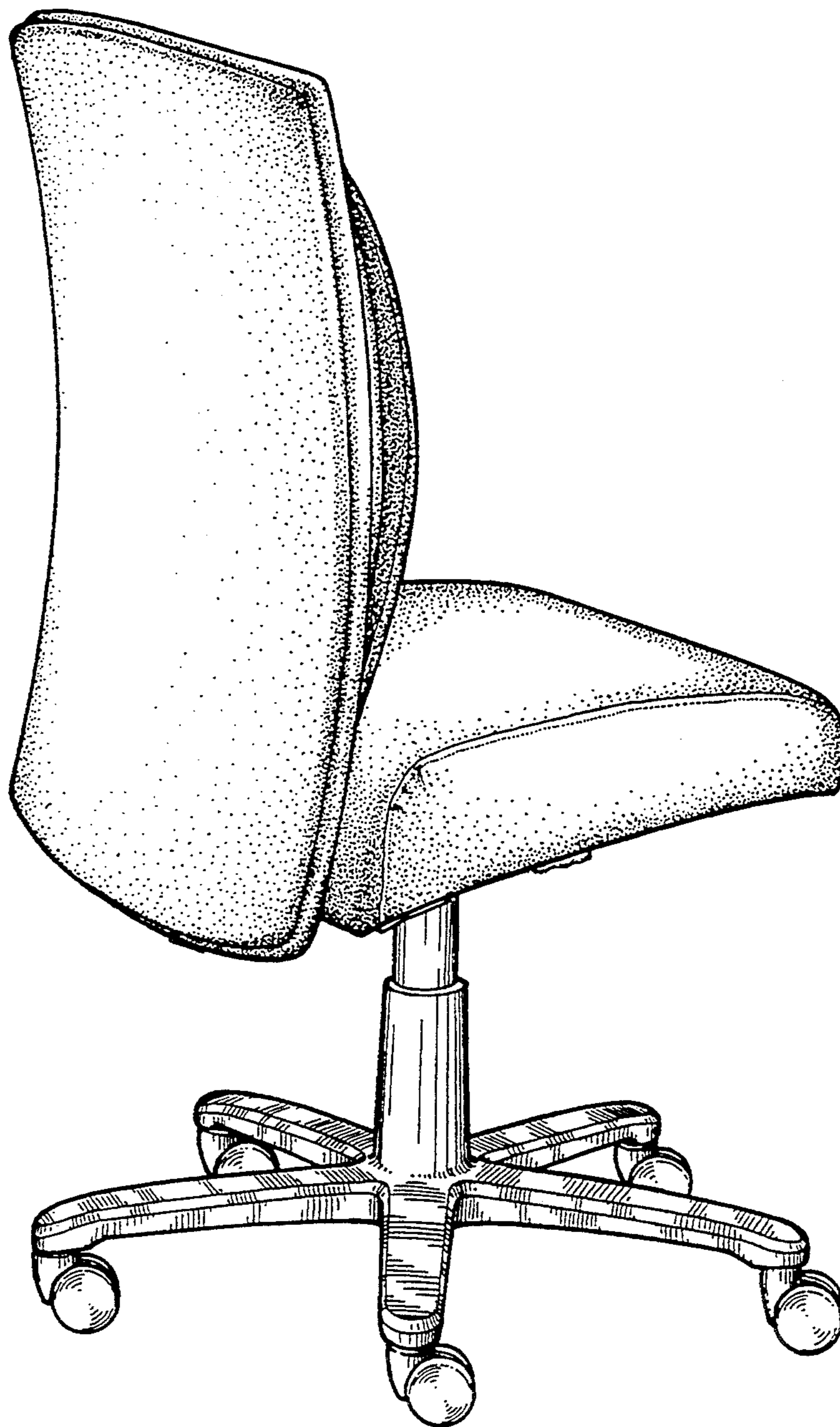
